W X Cen (W R 48c) { a possible type Ia Supernova progenitor?

ABSTRACT

We con m the orbital period of WX Cen WR 48c determ ined by D iaz & Steiner (1995) { DS95 { and re ned its value to $P_{orb} = 0.416$ 961 5 (22) d. The light curve of this object has a peak to peak variation of approximately 0.32 m agnitudes. It is non-sinusoidal in the sense that it has a V-shaped narrow m inimum, similar to the ones seen in V Sge, V 617 Sgr and in Compact B inary Supersoft Sources { CBSS.

M ost of the emission lines in the optical spectrum are due to Balmer, He II, C IV, N V, O V and O VI. An analysis of the He II Pickering series decrement shows that the system has signing cantamount of hydrogen. The emission lines of He II 4686A became weaker between the 1991 and 2000/2002 observations, indicating distinct levels of activity. The spectra of W X C en show variable absorption features in the Balmer lines with V = 2900 km s⁻¹ and in emission with V = 3500 km s⁻¹. These highly variable events rem ind the satellites in emission of CBSS.

We estimate the color excess as E (B V) = 0:63 on the basis of the observed di use interstellar band at 5780A. Given the distance-color excess relation in the direction of W X Cen, this implies a distance of 2:8 0:3 kpc. Interstellar absorption of the N a ID lines show components at 4:1 km s⁻¹, which corresponds to the velocity of the Coalsack, and three other components a 23:9, 32:0 and 39:0 km s⁻¹. These components are also seen with similar strengths in eld stars that have distances between 1.8 and 2.7 kpc. The intrinsic color of W X Cen is (B V)₀ = 0:2 and the absolute magnitude, M_V = 0:5.

Extended red wings in the strong emission lines are seen. A possible explanation is that the system has a spill-over stream similar to what is seen in V 617 Sgr. We predict that when observed in opposite phase, blue wings would be observed. A puzzling feature that remains to be explained is the highly variable red wing (V 700 km s⁻¹) of the O VIem ission lines as well as of the red wings of the H and He lines.

The velocity of the satellite-like feature is consistent with the idea that the central star is a white dwarfwith a mass of M 0.9M . With the high accretion rate under consideration, the star may become a SN Ia in a time-scale of 5 10^6 years.

1 IN TRODUCTION

W X Cen was initially identied by Eggen, Freeman & Sandage (1968) as a possible optical counterpart of the hard X-ray transient source Cen XR-2, although this identica-

tion was latter discarded. Because of its spectral characteristics, the object was then classi ed as a W olf-R ayet star of type W N 7 (van der Hucht et al. 1981), while Vogt (1989) classi ed it as a nova-like variable. D iaz & Steiner (1995) { D S95 { showed that it is a binary system with an orbital period of 10.0 hr. The photom etric orbital variation, determ ined by these authors, based on their spectroscopic observations, is approxim ately sinusoidal with an am plitude of 0:3 m ag. In spite of the period being relatively long (in the context of C ataclysm ic Variables) it was not possible to identify any spectral signature of the secondary star.

A distance of 1400 pc was determ ined from the NaID line equivalent width, and an E (B V) = 0.4 0.1 was suggested from the average of three distinct determ inations (4430A DIB and Na ID equivalent widths and He II 4686, 10124 A lines ratio). D oppler tom ography of W X C en produced by D S95 suggests that the gas of the secondary has norm al chem ical abundance, while the wind of the prim ary star is probably over-abundant in helium ($He^{++}/H = 0.56$). DS95 also showed that, if the prim ary component of W X Cen is a white dwarf, then the secondary should have a mass bellow and, therefore, be evolved. If, how ever, one assumes 0:35M the hypothesis that the secondary is a main sequence star, it would have $M_2 = 1.16M$, and the primary, a mass of $M_1 > 3:5M$ 0:5M .

Steiner & Diaz (1998) included W X Cen in a group of 4 galactic binaries de ned as the V Sge stars. The other three objects are V Sge (Herbig et al. 1965; Diaz 1999), V 617 Sgr (Steiner et al. 1999; Cieslinski, Diaz & Steiner 1999) and DICru (Veen, van Genderen & van der Hucht 2002). They are characterized by the presence of strong em ission lines of O VI and N V. Besides, He II is at least two times more intense than H . The V Sge stars are sim ilar to the C om pact Binary Supersoft Sources (CBSS), seen in the Magellanic C louds, but not that frequent in the Galaxy. CBSSs are interpreted as su ering hydrostatic hydrogen nuclear burning on the surface of a white dwarf. This burning is due to the high mass-transfer rate, a consequence of the fact that the system s have inverted m ass ratios (see K ahabka & van den Heuvel (1997) for a revision and references). Patterson et al. (1998) also considered the hypothesis of G alactic CBSS nature for the stars V Sqe, T Pyx and W X Cen, established on their extrem ely blue colors, high lum inosities, orbital light curves and highly excited em ission line spectra.

In an observational program to search for galactic W R stars, Shara et al. (1999) rediscovered W X C en as a new W N 3, when this star received the W R 48c designation. In our search for V Sge type stars, we selected W R 48c as a candidate, on the basis of spectroscopic criteria, for a detailed observational study. W e, then, realized that W R 48c was the already known star W X C en.

2 OBSERVATIONS

W e observed W X C en photom etrically for 9 nights on 2000 April and 2003 M ay and July with the Boller & Chivens 60 cm and Zeiss 60 cm telescopes at the Pico dos Dias Observatory { MCT/LNA { located in Brazopolis, Southeast Brazil (see Table 1). A thin back-illum inated EEV CCD 002-06 chip and a W right Instrum ents therm o-electrically cooled cam era were em ployed to obtain the im ages. The tim ing was provided by a Global Positioning System (GPS) receiver. The frameswere obtained through the Johnson V lter, with exposure tim es of 40, 50 and 80 seconds. W e also observed this star in white light with 2 seconds exposure time, for which we used the sam e CCD, operated in the fram e transferm ode, resulting in dead time between integrations of the order of m illiseconds. B ias and at eld exposures were obtained for correction of the stellar in ages. The in ages, except the ones obtained in fram e transfer m ode, present an overscan region used for the CCD's zero point correction. The data reduction was performed with the standard pro-

cedures, using $\mathbb{R} \mathbb{A} \mathbb{F}^{-1}$ routines. The star is located in a quite rich eld; we, therefore, carried out di erential PSF (Point Spread Function) photom etry of W X Cen and four comparison stars of the eld using the LCURVE package, written and kindly provided by M P.D iaz. It makes use of DAOPHOT routines to treat autom atically long time series data.

W e also observed the object with the C assegrain spectrograph coupled to the 1.6 m Boller & Chivens telescope at LNA on 2000 M arch. W e used a dispersion grating with 900 lines per mm, covering the spectral range from 3700A to 4950A to obtain spectra with exposure times of 10 m inutes (see Table 2). A thin back-illum inated SITe SI003A B 1024x1024 CCD was used as detector. B ias and dom e ateld exposures were obtained for correction of the CCD read-out noise and sensitivity. The width of the slit was adjusted to the conditions of the seeing. W e took exposures of calibration lamps after every third exposure of the star, in order to determ ine the wavelength calibration solution. The im age reductions, spectra extractions and wavelength calibrations were executed with IRAF standard routines.

An additional spectroscopic observation wasmade with the FEROS (Fiber-fed Extended Bench Optical Spectrograph - see K aufer et al. (1999)) spectrograph at the 1.52 m telescope of ESO (European Southern Observatory) in La Silla, Chile, on 2002 January 24. The FEROS spectrograph uses a bench m ounted E chelle grating with reception bers in the Cassegrain focus. It supplies a resolution of $R = 48\,000$, corresponding to 2.2 pixels of 15 m, and spectral coverage from 3600A to 9200A. A com pletely autom atic on-line reduction system is available and was adopted by us.

W e obtained a single spectrum with integration time of 30 m inutes.

3 DATA ANALYSIS

3.1 The optical light curve

The average light curve of W X C en (Fig. 1) displays a well de ned orbital m odulation with total am plitude of approximately 0.32 m agnitudes. It is asymmetric, and can not be adjusted by a simple sine wave. The maximum is wider and them inimum, narrower than the expected from a sine wave. The rise is also faster than the fall to the minimum. This light curve has a minimum with a shape that resembles the ones of V Sge and of V 617 Sgr as well as the galactic CBSS QR And. Superposed on it, there is a uctuation with time scale of tens of minutes. In addition to this fast uctuation, there is a variation with time – scale of one day and with approximately 0.08 m ag, as can be seen in the light curves of the nights of 2000 A pril 24, 25 and 26 (Fig. 2). Single are-like events with am plitude of 0.08 m agnitudes and lasting for about 30 m inutes are also seen (see Fig. 2).

W e searched the data for optical pulsations in the range

of 10 to 200 cycles day 1 . No periodic signal is seen but power excess with T 85 cycles day 1 (17 m in) is visible. This is to be compared to the 17{27 m in oscillations, seen in V 617 Sgr (Steiner et al. 1999) and to the 60 m in oscillations, seen in V Sge (Herbig et al. 1965). In addition, a power law signal with

is seen, where $= 1.85 \quad 0.04$. This is the classical signature for low frequency ickering.

In order to estim ate the inclination of the system, we will compare the light curve of W X C en with that of Q R And. From the observed am plitude of the light curve of Q R And, which varies from m = 0.25 m agnitudes (M eyer-H ofm eister et al. 1998) to m = 0.5 m agnitudes (M cG rath et al. 2001), an inclination of i = 55 was derived (M eyer-H ofm eister et al. 1998). As the observed light curve am plitude of W X C en is within the observed range for Q R And, and as the overall light curve shape and photom etric behavior are sim ilar, we will adopt i = 55 for W X C en as well.

3.2 Re ning the orbital period

The orbital radial velocity curve obtained from the He II 4686A line is shown in Fig. 3. The spectroscopic ephemeris associated to this radial velocity curve is

This ephem eris was calculated de ning the zero phase as the crossing from positive to negative values of the radial velocities when compared to the system is velocity, = 3km s¹.W e re ned the spectroscopic period from the value determ ined by D S95, as the num ber of orbital cycles elapsed from their zero phase tim ing to the present one is long enough, that is, 7870 cycles.

The ephemeris of the light curve minima is

The value of the photom etric period presented in this ephem eris was determ ined from the (O C) diagram shown in Fig. 4, which was in turn constructed from the measurem ents presented in Table 3. The orbital period derived from the radial velocities and from the photom etric m inim a are the same, within 1 con dence level. The delay between the spectroscopic ephem eris and what is expected from the photom etric one is about = 0.14 and is similar to what is reported in D S95.

3.3 The high-resolution spectrum

As the high resolution spectrum was obtained with a 1.5 m telescope, it is quite noisy. Even so, we can identify a number of lines and obtain pro le information (Table 4). The most intense hydrogen (H , H) and helium (4686A) lines present a structure with three peaks. O ne, near rest wavelength, at about + 10 km s¹, and two side peaks, with velocities of 180 km s¹ and + 240 km s¹ (see Table 5 and Fig. 5).

M ost of the lines can be idential with the transitions from the Balmer series, He II lines, C III, C IV, N III, N V, O III, O V and O VI (see Table 4). But there are a few

em ission lines that are not generally seen in the context of C ataclysm ic Variables or W R stars. We believe that they are spurious FEROS artifacts that appear in faint targets. There is no evidence of He I lines (see Table 4).

A nother in portant feature in the high-resolution spectrum is the very high velocity associated to the extended red wing seen in the strongest Balm er and H e II lines.

There are two additional points that deserve consideration. First, the high range of ionization of oxygen, which varies from 0 III to 0 VI (see Section 4.2). The second point is the absence of N IV em ission, besides its analog of 0 V being clearly present.

3.4 The m edium -resolution spectrum

In our medium -resolution spectra we see a unexpected phenom enon: on several occasions, absorptions are present in the Balm er lines blue wings, and this event is quite variable. Fig. 6 illustrates the average spectra with and without the presence of such absorptions. In Fig. 7 we show the ratio of the average spectrum with absorption to the average spectrum without absorption. We clearly see the phenom enon. The absorption occurs at 2880 km s¹ in H and 2840

km s¹ in H .W e see, at the same time, an emission in the bluest part of H , at the velocity of 3500 km s¹.Evidence of a weak emission at + 3500 km s¹ in H is also seen.

Signi cant long-term variability in the line intensities and line ratios seems to be visible in spectra from distinct epochs. In table 1 from Steiner & Diaz (1998) one can see the equivalent widths of H , H and He II 4686A as 61A , 15A and 37A . From our high-resolution spectra (Table 4), we have, respectively, 37.0A , 13.8A and 12.2A . Not only the lines seem to be much weaker but also the H /He II ratio is much higher. This can easily be seen by com paring Fig.6 with g.1 in Steiner & Diaz (1998). From ourm edium resolution spectra (Table 6), we can see that the intensity H /He II ratio is again reversed with respect to our high resolution spectrum , although H is even weaker.

The lines also seem to be signi cantly narrower in the observations of the years 2000 and 2002 when compared to the observations of 1991 (D S95). While in 1991 the FW HM of the emission lines was typically 1100 km s¹, the latest observations show FW HM of about 700 km s¹. Even considering that the data were obtained with distinct instruments and di erent resolution, this di erence seem s to

be signi cant. This suggests that in recent years the observations were m ade with the system in a less active state.

W e have com piled all the lines observed in this object so far. These lines are shown in Table A 1, in which we list the lines for sim ilar terms from the relevant CNO ionization species.

Fig. 8 shows the variation of the equivalent width as a function of time. It peaks at spectroscopic phase zero. This is quite similar to what has been reported for V 617 Sgr (Cieslinski, Diaz & Steiner 1999). The interpretation of this curve is quite straightforward: most of the eclipsed continuum comes from the heated surface of the secondary star (m ass donor) while the H e II line is em itted in a noneclipsed region (disc/wind/rim).

3.5 The Tem poral Variance Spectrum { TVS

In an attempt to exam ine the line variability in more detail we perform ed the Tem poral Variance Spectrum { TVS { analysis. In this procedure the tem poral variance is calculated, for each wavelength pixel, from the residuals of the continuum normalized spectra to the mean spectrum. For further details and discussions of this method, see Fullerton, Gies & Bolton (1996). The observed median resolution (Cassegrain) mean spectrum of W X Cen and the calculated TVS are shown in Figs. 9 and 10. A noticeable feature present in the N V 4603-19A and He II emission lines is the double-peaked line pro le, resulting not from a true line pro le variation { lpv { but from a radial velocity variation due to the binarity. This phenom enon is described in Fullerton, Gies & Bolton (1996) (see their g.1). In this case we expect = I K = FWHM, where is the TVS line variance and I is the related observed line intensity. The ratio = I is 14 per cent for H and 12 per cent for H e II 4686A. These values of =I are not an intrinsic property, but an artifact from the TVS analysis.

The TVS of W X C en also shows clear evidence of the

variable absorptions in the blue wings of the Balmer lines. There are two peaks, one with velocity of 2900 km s¹ and other with 3500 km s¹, which correspond to the absorption and em ission peaks near H , respectively (see Fig. 7). Besides, the O VI 3811/34A lines show strong variability in the red wings, with a displacement of approximately 700 km s¹ relative to the rest wavelength. The red wings of the Balmer and He II lines show strong variability that extends to velocities up to 1500 km s¹. This variability of the O VI lines, for instance, indicates that there are two em itting regions. One, with low variability, has norm al velocity and another, highly variable, has high and positive velocity.

4 D ISC U SSIO N

4.1 The hydrogen content

O ne way of analysing the presence/absence of hydrogen in a strong helium em itting spectrum is by comparing the He II 4859A + H to the geometric mean of the two adjacent transitions of the He II P ickering series. This criterion has been widely used, for instance, by Sm ith, Shara & M o at (1996) in de ning their three dimensional classication of W N stars. We de ne a P ickering parameter, p, such that

For a pure H e II spectrum one expects p = 1 (SSM 96). Any value of p larger than 1 would mean hydrogen in the object. In the case of W X C en, the measured value is about p = 31.

In case both hydrogen and helium lines were optically thin, it would be easy to determ ine the relative abundance between the two species. In this case (Conti, Leap & Perry 1983):

and the abundance would be N (H⁺)=N (H e⁺⁺) 2:1.

The largest uncertainty in this determ ination comes from the hypothesis that all of the involved lines are optically thin.

For the optically thick case, one gets (see Conti, Leap & Penry (1983))

which, for W X Cen, gives N (H⁺)=N (He⁺⁺) 45.W ith a high resolution spectrum as is the present case, however, we can determ ine the relative abundance using intensities at a given velocity in the prole, in which we can be reasonably secure that the lines are optically thin. For instance, if we use the intensity in the red wing that corresponds to, say, 300 km s¹, we may be in such a situation. De ning a parameter y (v), so that

where I4861A (v) is the intensity of the line at velocity v from the rest wavelength of H , I5411A (v + dv) is the intensity of the line at velocity v + dv from the He II 5411A rest wavelength. The H $^+$ =H e $^+$ abundance can be estim ated as

In the case of W X C en the parameter y was measured at v = 300 km s¹ while dv = 122 km s¹. We found N (H⁺)=N (H e⁺⁺) y 2:3. This is to be compared with the range found by D S95: N (H⁺)=N (H e⁺⁺) 1.7 to 7.

In the Smith, Shara & Mo at (1996) three dimensional classication scheme for W N stars, one could classify W X Cen spectroscopically as W N 3hpec, where the pec sufx indicates, like in DICru, the presence of strong O VI emission lines. It is clear, however, that we do not consider W X Cen as having W R nature.

4.2 CNO abundance

An unusual characteristic we observe in the spectrum of W X Cen is the large range of ionization degree. At the sam e tim e we see O VI em ission, we also see O V, O IV and O III (Table A1). This is very di erent from what is seen, for example, in W R stars. In these systems the wind and ionizing photons have sim ilar dilution factors and the ionization parameter is constant to a rst approximation. Yet in V Sagittae stars one expects a wind, accretion disc, hot spot, rim, spill-over and a secondary star. The range of ionization parameter in each of these regions can be very distinct. The expected range of ionization species in V Sge objects should, therefore, be larger than in W R stars. Herbig et al. (1965) also observed O III and O VI in V Sge.

Is the N /O ratio anom abus in W X Cen? W hydowe see O V but not the same transition in N IV? From the intensity ratios, we obtain N /O < 0.1. This is similar to P lanetary

N ebulae of type II or to the solar abundance but is quite distinct from W N stars (N /O $\,$ 20 to 50)

4.3 The distance to the system

D S95 m ade a distance determ ination on the basis of the di use interstellar band {D IB { at 4430A, interstellar N a D lines and the decrem ent of H e II lines and found a distance of about 1.4 kpc. To m easure the equivalent width of the 4430A band is di cult, given that it is hard to de ne the nearby continuum, and the N a D lines are saturated (Fig. 11). W e will, therefore, revisit this issue. Let's rst estim ate the interstellar extinction from the di use interstellar bands. The D IB s and reddening have been calibrated by m any authors. From H erbig (1975), we have

This is dimension from the relation in Allen (1973), used by D S95, by about a factor of 2.W e found W (4430A) = 1:7 (Table 6), and obtain E (B V) = 0:74.

The most reliable D IB for evaluating the interstellar extinction in the case of W X C en seems to be the 5780A feature. W e m easured an equivalent width of W = 0.56 0.01A. Som erville (1988) gives the following relation between its equivalent width and color excess

$$E(B V) = (W (5780A) + 46) = 940$$

where W is given in mA. In the case of W X C en we have E (B V) = 0.63 and we will adopt this as the color excess. This is about 50 per cent larger than the value estim ated by D S95.From a calibration of the color excess versus distance, obtained both for open clusters (D ias, Lepine & A lessi 2002) and eld stars (see Table A 2), we derive a distance of about 2.8 0.3 kpc.

The N a I lines for W X Cen and stars in its eld (Franco 2000) have velocities, in LSR, that are listed in Table 7.Four absorption systems can be identied and we will call these components from 1 to 4.

From the other stars in the eld of the Coalsack, observed by Franco (2000), one concludes that the distance to W X C en has to be well in excess of 800 pc. The numbers in Table 7, as well as the equivalent widths of the absorption components 2 and 3, suggest a distance of about 1.8 to 2.7 kpc which seem s to be consistent with the value derived above.

The absolute m agnitude is, then, of about M $_V = 0.5$ and color (B V) $_0 = 0.2$.

4.4 Spill-over; SN Ia precursor?

A som ewhat striking characteristic of the spectrum of W X C en are the red wings in the emission lines, seen in the high resolution spectrum, extending to about + 1300 km s¹. This is similar to what was observed by C ieslinski, D iaz & Steiner (1999) in V 617 Sgr. In the D oppler diagram presented by these authors, after subtracting the symmetric prole, one can notice a high velocity component extending to V 800 to 1000 km s¹, both in V_x and in V_y. In addition there is a strong emission concentrated at V_x 200 km s¹. Steiner et al. (1999) explained these characteristics by assuming that the 200 km s¹ component is due

to the high disc rim, sim ilar to the ones observed in CB-SSs (M eyer-H ofm eister, Schandl & M eyer 1997). The high velocity component was explained in V 617 Sgr as a consequence of spill-over gas, following ballistic trajectories and closely approaching the white dwarf. Such a conguration would explain the red wing characteristic if the high resolution spectrum was taken at a phase immediately before the photometric m inimum. This is indeed the case. The central exposure of the high resolution spectrum was at photom etric phase 0.787. We predict that at opposite phase the wing should be to the blue. This phenomenon is also likely to be variable as there is no hint of such a component in the D oppler diagram presented in D S95.

A puzzling feature still remains unexplained. The TVS spectrum shows a highly variable component in the highly ionized species O VI. This component is seen at V $\,$ 700 km s^1. This component is also seen in the TVS red wings of H $\,$ and He II 4686A . We have no explanation for this.

The satellite-like events at the Balmer lines, being interpreted as due to ejected gas, are consistent with the idea that the compact star is a white dwarf. W ith an orbital inclination of i = 55, and observed velocity of 3500 km s¹, we derive the intrinsic velocity of the "jet" as V = 6100 km s¹. This corresponds to the escape velocity of a white dwarf with a mass of M 0.9M. W ith the high accretion rate (dM₁=dt 10⁷ M year¹) required in order to have surface nuclear burning (K ahabka & van den Heuvel1997), this white dwarf may reach the Chandrasekhar lim it and become a SN Ia on a time-scale of 5 10⁶ years.

CBSSs have been considered as possible candidates to SN Ia precursors (Hachisu et al. 1999). These authors have shown a channel to SN Ia by evolving a helium rich Supersoft X-ray binary. Hachisu & Kato (2003) also showed that V Sge may become a SN Ia.

5 CONCLUSIONS

The main conclusions of this paper are:

term ined by DS95 and rened its value to $P_{orb} = 0.4169615(22) d$, based on spectroscopic observations.

(ii) The light curve has total am plitude of approxim ately 0.32 m agnitudes and is non-sinusoidal in the sense of having a narrow, V -shaped, m inim um . The object presents ickering with time-scales of tens of m inutes. N ight-to-night variations of about 0.08 m ag are also observed.

(iii) W e identied most of the emission lines as due to Balmer, H e II, C IV , N V , O III, O V , O V I.

(iv) The object shows absorption satellites in the Balmer lines with V = 2900 km s¹ and in emission with V = 3500 km s¹. These highly variable events remind the satellites in emission in CBSS.

(v) The analysis of the emission lines show that the He II 4686A line became weaker between 1991 and 2000/2002 observations. At the same time the emission lines were narrower, suggesting that in 2000/03 the system was in a less active state than in 1991.

(vi) The object presents red-shifted em ission in high ion-ization species. Extended red wing em ission is also seen in the strongest lines. The O VI lines show strong variability with velocity of about 700 km s 1 .

(vii) An analysis of the H e II P ickering series decrement shows that the system has signicant amount of hydrogen, with an abundance, by number, between 2.1 and 4.5.

(viii) W e estim ate the color excess as E (B V) = 0.63 on the basis of the observed D IB at 5780A. Given the distancecolor excess relation in the direction of W X C en, this in plies a distance of 2.8 0.3 kpc. Interstellar absorption of the N a I D lines show components at 4.1 km s¹, which corresponds to the velocity of the C oalsack, and three other components a 23.9, 32.0 and 39.0 km s¹. These components are also seen with sim ilar strengths in eld stars that have distances between 1.8 and 2.7 kpc. The intrinsic B V color index of W X C en is (B V)₀ = 0.2 and the absolute m agnitude, M_V = 0.5.

(ix) A possible explanation for the extended wings in the strong emission lines is that the system has a spill-over stream similar to what is seen in V 617 Sgr.W e predict that when observed in opposite phase, blue wings would be observed.

(x) The velocity of the satellites is consistent with the idea that the central star is a white dwarf with a mass of M 0.9M . With the high accretion rate, it may become a SN Ia in a time-scale of 5 10^6 years.
