THE EFFECT OF GRAVITATIONAL-WAVE RECOIL ON THE DEMOGRAPHY OF MASSIVE BLACK HOLES

ABSTRACT

The coalescence of massive black hole (MBH) binaries following galaxy mergers is one of the main sources of low-frequency gravitational radiation. A higher-order relativistic phenomenon, the recoil as a result of the non-zero net linear momentum carried away by gravitational waves, may have interesting consequences for the demography of MBHs at the centers of galaxies. We study the dynamics of recoiling MBHs and its observational consequences. The \gravitational rocket" may: i) deplete MBHs from late-type spirals, dwarf galaxies, and stellar clusters; ii) produce o -nuclear quasars, including unusual radio morphologies during the recoil of a radio-loud source; and iii) give rise to a population of interstellar and intergalactic MBHs.

1. INTRODUCTION

The rst massive black holes likely form ed at high redshifts (z > 10) at the centers of low-mass (10^6 M) dark matter concentrations. These black holes evolve into the population of bright quasars observed at z < 6 and eventually grow into the supermassive remnants that are ubiquitous at the centers of galaxies in the nearby universe. In popular cold dark matter (CDM) cosm ogonies, dark matter halos and their associated galaxies undergo many mergers as mass is assembled from high redshift to the present. The merging { driven by dynamical friction against the dark matter { of two comparable-mass halo+MBH systems will drag in the satellite hole towards the center of the more massive progenitor, leading to the form ation of a bound MBH binary with separation of

pc. If stellar dynam ical and/or gas processes drive the binary su ciently close (< 0:01 pc), gravitational radiation will eventually dom in ate angular momentum and energy losses and cause the two MBHs to coalesce. Such catastrophic events are one of the prim ary m otivations for low-frequency, space-based, gravitational wave detectors such as the planned Laser Interferom eter Space Antenna (LISA). For unequal mass pairs, gravitational waves also remove net linear momentum from the binary and impart a \kick" velocity to the center of m ass of the system . The dom inant recoil e ect arises from the interference between the mass-quadrupole and mass-octupole or current-quadrupole contributions (Peres 1962; Bekenstein 1973). To date, the outcom e of this \gravitational rocket" rem ains uncertain, as fully general relativistic num erical com putations of radiation reaction e ects during the coalescence of two K errholes are not available. For su ciently asymmetric con gurations, recoil velocities may exceed a few hundred kilom eters per second and lead to a signi cant displacem ent of the MBH from the center of its host galaxy. In the shallow potential wells of small-m ass halos at high redshifts, recoil velocities m ay be so large in the late stage of black hole-black hole coalescence to reach galactic escape velocities (M adau et al. 2004). If it is not ejected from the host altogether (giving origin to a population of intergalactic M BHs), the hole will return to the nucleus via dynam ical friction.

In this Letter we address the dynam ics of recoiling holes in galaxy cores, discuss the implications of coalescenceinduced kicks for the dem ography of M BHs, and consider the prospects for directly detecting the observational signatures of gravitational-wave recoil. W hile preparing this work for submission, we learned of an independent study by M erritt et al. (2004) of the consequences of the gravitational rocket.

2. DYNAM ICS OF RECOILING BLACK HOLES

G ravitation radiation recoil is a strong eld e ect that depends on the lack of symmetry in the binary system. The lighter hole in a quasi-circular inspiraling orbit moves faster than the heavier one, and its gravitational radiation is more \forward beam ed". This gives a net momentum ejection in the direction of motion of the lighter mass, and the binary recoils in the opposite direction (W isem an 1992). A ccording to quasi-N ew tonian calculations (F itchett 1983), at the transition from the inspiral to \plunge" phase, the center of mass of a compact binary of totalm ass $M = m_1 + m_2$ (with the convention $m_1 < m_2$) recoils with a velocity

where the function $f(q = m_1 = m_2) = q^2 (1 = q) = (1 + q)^5$ reaches a maximum value $f_{max} = 0.0179$ for q = 1=2.6, and r_{isco} is the radius of the innerm ost stable circular orbit, which moves inwards for a comparable mass system relative to its test-mass limit (e.g. Buonanno & Damour

2000). By symmetry, the recoil vanishes for equal-mass nonrotating holes. Fitchett & Detweiler (1984) extended Fitchett's work to perturbation theory and estim ated kick velocities > 100 km s¹. M ore recent perturbation theory calculations by Favata, Hughes, & Holz (2004) nd that the recoil velocity can readily reach 100 200 km s¹, 500 km s¹. Num erical relbut is unlikely to exceed ativistic calculations of radiation recoil from highly distorted Schwarzschild holes yields maximum kick velocities in excess of 400 km s¹ (Brandt & Anninos 1999). Because of the strong dependence of the rocket e ect on the radius of the nal prior-to-plunging orbit, larger kicks are expected for prograde inspiral into rapidly rotating MBHs. M oreover, in the case of K err holes, recoil is signi cant even for holes of equalm ass (Favata et al. 2004) and can be directed out of the plane of the orbit (Redmount & Rees 1989).

W hat is the dynam ics of a recoiling M BH in the gravitational potential of its host galaxy? As the M BH (w ith m ass M $_{\rm BH}$) recoils from the nucleus, stars bound to the hole are displaced with it, so that the total ejected m ass is M $_{\rm tot} = M _{\rm BH} + M _{\rm cusp}$, where the bound stellar cusp has a m ass M $_{\rm cusp}$ M $_{\rm BH}$ for v_{CM} , while M $_{\rm cusp}$ rapidly decreases for v_{CM} > . As a rst approximation let us assume that the hole + stellar cusp is on a radial orbit in a spherical potential (e.g., an early-type galaxy or the bulge of a spiral). Its orbit is then governed by

where x = v = 2, M (r) describes the mass prole of the galaxy, (r) is the density pro le of stars with 1D velocity dispersion , and the second term represents dynam ical friction against the stellar background (e.g. Binney & Trem aine 1987; hereafter BT).W e approxim ate the stellar density as an isotherm alsohere, in which case the dynam ical friction time scales with radius as t_{DF} / r^2 , while the 'residence' time for a radial orbit scales as t r=v / r. Thus most of the decay of the MBH's orbit by friction takes place at sm all radii in the galactic nucleus, where it is reasonable to assume that the gravitational potential is dom inated by stars. Stars within the gravitational sphere of in uence of the hole, R $_{\rm B\,H}$ $GM_{BH} = 2$, are bound to it and do not contribute to dynam ical friction. W e therefore truncate the stellar density inside a core ra- R_{BH} , so that (r) = 2 = [2 G (r² + R_{BH}^{2})] and dius M (r) = 2^{2} r[1 (R_{BH} = r) arctg (r = R_{BH})]=G.Flattening of the inner stellar density pro le is also produced physically during the decay of the initial MBH binary, when dynam ical friction and three-body interactions transfer energy from the binary to stars in the nucleus of the galaxy (e.g., M ilosavljevic & M erritt 2001).

The C oulom b logarithm ln in equation (2) is approximately given by ln $[b_{m ax}=b_{m in}]$, where $b_{m ax}$ and $b_{m in}$ are the maximum and minimum in pact parameters for stars that contribute to dynamical friction (BT); $b_{m in}$ is typically taken to be R_{BH} (BT; M aoz 1993). In the case of a uniform medium, $b_{m ax}$ is comparable to the size of the system (galaxy), so that $b_{m ax}$ $b_{m in}$. For our problem, how ever, the decay of the hole's orbit occurs in the inner nuclear re-

gions where the stellar density peaks, i.e. at radius R_{BH} , so that $b_{m ax} R_{BH}$ $b_{m in}$ and ln 1. M aoz (1993) has given a more careful derivation of dynam ical friction in an inhom ogeneous medium; the C outlom b logarithm is replaced (see his eq. 4.4) by ln ! $R_{R m ax} R_{BH}$ (r)dr=(_0r), where $R_{m ax}$ is the size of the stellar system and _0 is the central stellar density. For our problem this integral is

Figure 1 shows the orbit of a 3 10° M MBH moving with initial recoil velocity of v_{CM} = 200;300; and 400 km s¹ in an isotherm alsphere of dispersion = 75 km s¹ (reasonable for a Milky Way-type host) and radius R_{max} $p_{BH}^{R_{BH}}$. The escape speed from such a sphere is $v_{esc}(0) = \frac{P}{2j j(r=0)} = 2 \ln^{1-2} (R_{max}=R_{BH}).$ We x the hole mass using the M $_{\rm B\,H}$ relation of Tremaine et al. (2002): $M_{BH} = 1.5 \ 10^{6} \ \frac{4}{200} M$, so that $R_{BH} = 1.5^{2}$ so that $15 \frac{2}{200}$ pc, where 200 is the velocity dispersion in R_{вн} units of 200 km s 1 . As Figure 1 shows, the timescale for the recoiling hole to return to the center of its host galaxy depends very sensitively on the magnitude of the kick it receives, ranging from 10° years for $v_{CM} = 200$ km s⁻¹ to more than 10^9 years for $v_{CM} = 400$ km s¹. Because the friction takes place prim arily at sm all radii, the decay time is sensitive to the inner stellar density. For example, if we increase the core radius of the isotherm al sphere by a factor of 2, the decay times increase by a factor of

3. G iven uncertainties in the recoil velocity, this uncertainty in the decay time will not signi cantly modify our conclusions.

The num erical results in Figure 1 can be understood analytically as follows. In the absence of dynam ical friction, energy is conserved, and an ejected MBH will reach its apocenter at

where the exponential dependence arises because the potential is logarithm ic. During each passage through the galactic nucleus, however, the hole loses a fraction f of its orbital energy because of dynam ical friction; this fraction can be estim ated by comparing the DF timescale at

 $R_{B\,H}$ to the transit time across this region, $R_{B\,H} = v_{C\,M}$, which yields f $(=v_{C\,M})^4$. It takes f 1 orbits through the nucleus for the MBH to return to the center of the galaxy, and so the decay time can be roughly estimated by t_{decay} f $^1R_a = v_{C\,M}$. Since both f and R_a depend primarily on $v_{C\,M} =$, this estimate shows that the decay time of the hole back to the center is determined primarily by $v_{C\,M} =$ for radial orbits. Thus, the results in Figure 1 can be scaled to other parameters, e.g. the decay times in Figure 1 apply reasonably accurately to = 50 km s 1 , so long as $v_{C\,M}$ is rescaled to $v_{C\,M} = 266;200;and 133\,km$ s 1 (from top to bottom).

The above analysis assumes that the MBH remains on a purely radial orbit. It is, how ever, likely that the recoiling hole will gain angularm on entum upon leaving the nucleus (e.g. if the galactic potential is triaxial): this will modify the timescale for the orbital decay. Detailed estimates of the decay time in this case are uncertain. We can roughly bracket the e ect by considering the MBH on a circular orbit with an energy (1=2)M $_{\rm BH} v_{\rm CM}^2$; for an isotherm alpotential, the radius of such an orbit is $R_a = \frac{1}{2}$, where R_a is the apocenter radius for a radial orbit (shown in Figure 1 and estimated in eq. [3]). The decay time is then given by the standard dynamical friction timescale (BT)

where we have used the M $_{\rm B\,H}$ relation to eliminate the hole mass in favor of . Note that the decay time is now determ ined by dynam ical friction at large radii, rather than sm all radii, and so h 10 is probably more appropriate. For $v_{\rm C\,M}$ the decay time predicted by equation (4) is comparable to that for radial orbits (a few crossing times; see Fig. 1) while it can be signi cantly longer for large $v_{\rm C\,M}$ = (large apocenter distances).

3. M BH B NAR ES N HERARCHICAL CLUSTER NG COSMOLOG ES

In hierarchical clustering scenarios, M BH \rightarrow M BH binaries are likely products of galaxy major mergers only. When two halo+M BH systems of (total) mass M and M_s < M merge, the 'satellite' (less massive) progenitor will sink to the center of the more massive pre-existing system by dynam ical friction against the dark matter; for an isotherm al sphere the Chandrasekhar dynam ical friction timescale is

(Lacey & Cole 1993), where vir is the density contrast at virialization, H is the Hubble parameter, and the term contains the dependence of this time escale on the orbital parameters. A fler including the increase in the orbital decay timescale due to tidal stripping of the satellite (Colpiet al. 1999), it is possible to show that satellites will merge with the central galaxy on timescales shorter than the Hubble

time only in the case of m a jorm ergers, $M_s = M^{>} 0.3 = 0.5$. In m inor m ergers tidal stripping m ay have the satellite MBH wandering in the halo, too far from the center of the rem nant for the form ation of a black hole binary.

M a jor m ergers are frequent at early times, so a signicant number of binary MBH systems is expected to form then. It is still unclear whether halo major mergers necessarily lead to the coalescence of their MBHs, or whether the binaries \stall" before the backreaction from gravitational waves becomes important (Begelman, Blandford, & Rees 1980). A number of plausible mechanisms that may help avoid such stalling have been suggested in the recent literature (e.g., G ould & Rix 2000; Zhao, Haehnelt, & Rees 2001; A mitage & Natarajan 2002; Yu 2002; Chatterjee, Hemquist, & Loeb 2003).

Figure 2 shows the mean number of major mergers per unit redshift bin experienced by all halos with masses > 10^{10} M that are progenitors of a z = 0 parent halo of m ass M₀ = 10^{12} ; 3 10^{12} , and 10^{13} M . We have tracked backwards in time the merger history of parent halos with a Monte Carlo algorithm based on the extended Press-Schechter form alism (Volonteri, Haardt, & Madau 2003). For the most massive parent halos this quantity peaks in the redshift range 2-3, the epoch when the observed space density of optically-selected quasar also reaches a maximum (Kau mann & Haehnelt 2000). Hydrodynam ic sim ulations of major mergers have shown that a signi cant fraction of the gas in interacting galaxies falls to the center of the merged system (Mihos & Hernquist 1994): the cold gas may be eventually driven into the very inner regions, fueling an accretion episode and the growth of the nuclear M BH. W e will discuss below the possibility that gravitational-wave recoil may thus give rise to o -nuclear active galactic nuclei (AGN).

4. IMPLICATIONS

< 50 75 km s¹, typical kick ve-For galaxies with locities of a few hundred km s¹ are su cient to unbind the hole or displace it su ciently from the nucleus that the decay time due to dynam ical friction is comparable to the Hubble time (Fig. 1). This implies that MBHs with masses $M_{BH} < 10^6 M$ (using the M_{BH} relation) m ay be com parably rare in their late-type spiral or dwarfgalaxy hosts. Interestingly, there are very few observational constraints on the presence of MBHs in such galaxies, though Filippenko & Ho (2003) argued for a 10°M MBH for the Seyfert galaxy in the late type (bulgeless) spiralNGC 4395, and Barth et al. (2004) reached a sim ilar conclusion for the dwarf Seyfert 1 Galaxy POX 52. It is in portant to stress that even if galaxies do not currently harbor a central MBH, they may have done so in the past. Thus the absence of MBHs in shallow potential wells would not necessarily imply ine cient MBH formation (e.g., Haiman, Madau, & Loeb 1999), but could instead be due to recoil during MBH coalescence. Note also that the low-m ass black holes that are preferentially a ected by gravitational recoil are also those that are expected to dom inate the LISA gravitational wave signal from MBH-MBH coalescence. If ejection of such MBHs is com m on, this m ay decrease the num ber of sources detected by LISA .

Galaxy mergers are a leading mechanism for supplying fuel to MBHs (e.g., Barnes & Hemquist 1991), and so a natural in plication of gravitational recoil is the possibility of o -nuclear quasar activity.² Since the lifetime of m erger-driven activity is of order the Salpeter tim escale $t_{s} = 4:5$ 10 yr, o -nuclear AGN are most likely to be found in relatively small potential wells. This is because, $10^{\circ}M$ MBH in a = 200 km s¹ galaxy, for (say) a the decay timescale due to dynamical friction is $< 10^6$ yr t_s even for a kick velocity of $v_{CM} = 300$ km s¹, and the

displacement from the nucleus is quite small, $< R_{BH}$ 10 pc. By contrast a decay tim escale com parable to te and is plausible for MBHs with M_{BH} 10° 10[°]M 200 km s¹. Since the merger rate for progeni-Vсм tor halos hosting such MBHs peaks at z 2 3 (Fig. 2), we predict that a signi cant fraction of m oderate- to high-redshift, bw mass AGN could be o -nuclear. Most currently detected AGN at high redshift are the rare

 10^{10} M holes hosted by massive halos, for which 10 recoil is probably not in portant. At early tim es, how ever, theoretical models of the evolution of the quasar population in hierarchical structure form ation scenarios predict a large num ber of fainter, low -M BH sources (e.g., Haim an & Loeb 1998; Haim an et al. 1999; Volonteriet al. 2003).

The e ects of gravitational recoil m ay be particularly

prom inent in radio observations of AGN.Merritt & Ekers (2002) argued that MBH coalescence might im print itself on the morphology of radio galaxies by changing the spin axis of the MBH and thus the direction of the radio jet. G ravitational recoilm ay have a com parably in portant effect by displacing the radio-bud AGN from the nucleus of the galaxy. This could manifest itself as a at spectrum radio core displaced from the optical nucleus of the galaxy, along with a jet or lobe still sym metric about the nucleus. R adio observations also have the obvious advantages that contam ination from the host galaxy is less important (relative to optical quasars) and VLBI interferom etry allows precise localization of the radio em ission.

Gravitational recoil may also be relevant for understanding the origin of o -nuclear ultralum inous X -ray sources in nearby galaxies (see, e.g., Colbert & Mushotzky 1999). One interpretation of such sources is that they are intermediatem assblack holes (IMBHs) with M 10⁹ M accreting near the Eddington limit. Miller & Hamilton (2002) suggest that such interm ediate-m ass holes could form in globular clusters by repeated black hole m ergers. The gravitational rocket will, how ever, probably prevent substantial growth via mergers in the shallow potential well of a globular cluster, since even mergers with mass 0:1 can lead to kick velocities in exratios as sm all as cess of the escape velocity of the cluster. It should be noted that an IMBH could still form via stellar (rather than com pact object) m ergers during the core-collapse of young star clusters (e.g., Gurkan et al. 2004).

Finally, we draw attention to the fact that the gravitational rocket does not necessarily lim it the ability of MBHs to grow via gas accretion from rare less massive seeds, such as IM BH s produced by the collapse of P opulation III stars atz 20 (Madau & Rees 2001). This is because seed holes that are as rare as (say) the 3.5 peaks of the prim ordial density eld will evolve largely in isolation, as the merging of two (m ini) halos both hosting a black hole is a rare event at these very early epochs. A signi cant number of MBH binary systems may form only later, when the fraction of halos hosting MBHs is larger. By then the typical host will be further down the merger hierarchy (more massive) and the e ect of radiation recoil less disruptive (M adau et al.2004).
