High resolution spectroscopy of Brown Dwarfs in Taurus

Abstract. We present high resolution optical spectroscopy of three candidate members of the Taurus-Auriga star forming region. Based on the spectral type, the strength, prole and width of the H line, the detected lithium at 6708 A, the location of these objects in a H-R diagram and the comparison with similar objects belonging to young stellar associations, we determ ine that they are bona demembers of the SFR, with about 3 M yr, have masses at or below the substellar limit and, at least in one case, there is active accretion from a circum (sub)stellar disk. This result suggests that high mass brown dwarfs go through a Classical TTauri phase and form like stars, from colapse and fragmentation of a molecular cloud.

1. Introduction

B rown dwarfs, objects unable to fuse hydrogen in an stable manner (i.e., with masses below at about 0.072 M Bara e et al. 1998), pose an important problem to the theory of stellar form ation. Several form ation m echanism s have been proposed, including form ation like a star (from collapse and fragm entation of a molecular cloud, Padoan P., & Nordlund 2004) to a planet-like process (from a circum stellar disk) or as stellar \em bryos", ejected from multiple systems before they are able to accrete enough matter (Reipurth & Clarke 2001; Bate et al. 2002). These proposed mechanisms have di erent implication in their form ation, their evolution and their properties. In particular, if brown dwarfs are created like stars, it seems that they should go through an phase of active accretion from a circum (sub)stellar disk, such as low mass stars do (Shu et al: 1987). A ctually, since the last couple of years, different groups have presented indirect and direct evidences of active accretion in a handful of young brown dwarfs belonging to several nearby star form ing regions (SFR), open clusters and moving groups (Fern andez & Comeron 2001; Muench et al. 2001; Natta & Testi 2001; Natta et al. 2001, 2002; Testiet al. 2002; Jayawardhana et al. 2002ab, 2003ab; Muzerolle et al. 2003; Barrado y Navascu es et al. 2002, 2003, 2004; Barrado y Navascu es & Mart n 2003; M ohanty & Basri 2003; M ohanty, Jayaw ardhana & Barrado y Navascu es 2003; Com er on et al. 2003)

In this paper, we enlarge the sample by collecting high resolution spectroscopy of three proposed m embers of the Taurus-Auriga SFR, located at 140 pc and about 1-3 M yr

(for an update on Taurus, see Luhm an et al. 2003 and references therein).

2.0 bservations

Our Taunus targets were selected from Briceno et al. (2002). In that paper, a new sam ple of nine m id-to late-M candidate m embers were presented, based on Ic and z' photom etry (plus 2M ASS near IR data) and low resolution spectroscopy. We have collected high resolution spectra of a third of them {the high m ass brown dwarfs, whose spectral type is between M 5.75 and M 7.5{ with the M agellan I 6.5m telescope and the M IK E echelle spectrograph on 2002, D ec 11-14th. A lthough three objects are a sm all number, they represent a signi cant fraction of the high m ass brown dwarfs belonging to this association discovered so far (about 12 in the quoted spectral range). Therefore, they can provide som e hints about their form ation m echanism.

A dditional details about the observations can be found in Barrado y N avascu es, Stau er & Jayaw ardhana (2004), where we analyze a sample of very low mass stars and brown dwarfs belonging to the 5 M yr cluster associated to the 0 rionis star. In order to optimize the signal-tonoise, we binned the data during the read-out to two by two pixels in the spatial and the spectral direction, respectively, yielding a spectral resolution of R = 25,000 (0.25A), with a 0.75 arcsec slit. The spectral range of our spectra is 4500{7250 A.

3. Analysis and D iscussion

3.1. Spectral types

Spectral types were derived by comparing with several spectral tem plates, by using the order around 7050 A, corresponding to a T iO band, following M ohanty et al. (2004), since this range is very sensitive to e ective tem - perature. Errors can be estim ated as half a subclass. O ur values are very close to those obtained by B ricero et al. (2002) from low resolution spectra (see Table 1).

32.0 n the lithium abundance, age, and m ass

We have detected lithium 6707.8 A in two out of the three targets (KPNO-Tau-05 and KPNO-Tau-08, Figure 1). The spectrum of KPNO-Tau-03 has worse quality.W ith some caveats, the visual inspection indicates that this feature is also present. Note that Briceno et al. (2002) states that they detected lithium with their low resolution spectrum (at higher signal-to-noise ratio). This element is easily destroyed in the stellar interior, being its surface abundance dependent on mass and age (as well as other second order parameters). In fact, brown dwarfs which are more massive than about 0.060 M do deplete lithium in a time scale of few tens of m illion years (D'Antona & Mazzitelli 1994; Burrows et al. 1997; Bara e et al. 1998). The Taurus-Auriga complex has an age between 1 and 3 M yr. Since our three candidate m em bers have spectral types between M 6 and M 7, they should have m asses equal or larger than 0.06 M, according to Bara e et al. (1998). Therefore, the detection of this alkali clearly indicates that these objects are in the pre-M ain Sequence (PMS). M oreover, from the statistical point of view, the likelihood of having three late-M, PMS interloper whose spectral and photom etric properties coincide with the Taurus sequence

is negligible. Therefore, we have to conclude that they, indeed, belong to the association.

Figure 2 displays values of the lithium equivalent width (W) measured for our targets (large asterisks), pre-main sequence members of the 5 Myr Sigma Orionis cluster (Zapatero O sorio et al. 2002, solid squares), and stellar and substellar m em bers of IC 2391 {53 M yr{ and the Pleiades {125 Myr{ from Barrado y Navascues et al. (1999, 2004), Soderblom et al. (1993), Garc a-Lopez et al. (1994), Jones et al. 1996, Stau er et al. (1998) and Je ries et al. (1999). The solid line describe the maximum W (Li) measured in cluster stars. The long-dashed curve is an update version of the criterion used by M art n (1997) and Mart n & Magazzu (1999) to distinguish between W eak-line and post-T Tauri stars. Finally, the dotted and short dashed lines correspond to the Zapatero O sorio et al. (2002) curves of growth for Log q=4.0 and 4.5 and an abundance of A (Li)=3.1 (i.e., $\cos m$ ic abundance).We have labeled in the plot di erent sections. The W (Li) for KPNO-Tau-5 is lower than the measured values in the other two Taurus objects. This fact might be due

to the presence of optical veiling, about r(6700) = 0.2, although we do not think this is the case. On one hand, no other sign of accretion has been found in this object (see next section). M oreover, this equivalent width is com patible with the dispersion found in Sigma O rionis and the {undepleted-values characteristic of cluster brown dwarfs. For the other two objects, no veiling seems to be present either. In the lithium equivalent width dispersion is real both in Taurus and Sigm a O rion is cluster (the same e ect is present in the Lambda Orionis association, Barrado y Navascu es, Stau er & Jayawardhana 2004), it might im ply diferences in the surface abundances due to additional m ixing mechanisms in the stellar and substellar interior, di erent to pure convection (such as those proposed in solar m ass stars), di erences in the structure due to di erent stellar and substellar parameters (such as fast rotation in the case of pre-M ain sequence stars, M art n & C laret 1996), or to induced e ects related to activity and/or rotation over the spectral feature itself or the surrounding continuum (see the discusion in Barrado y Navascu es et al. 2001 and references therein).

As a sum mary, based on these data, mainly from the detection of lithium and accretion when present (see next section), we can conclude that these three objects are young and, indeed, belong to the Taurus region. In the case of KPNO-Tau-5, due to its spectral type $(M \ 7)$ its substellar nature is well established. The other two are located at the substellar borderline and their nature is not so make the stablished due to uncertainties in the models and the spectral type determination.

Once membership to the stellar association has been proved, we have derived the bolom etric magnitudes from Ic and K s, the distance modulus (m M)₀= 5.731 (140 pc, Kenyon, Dobrzycka & Hartmann 1994), the reddening derived by Bricero et al. (2002) and the bolom etric corrections by Comeron et al. (2000) and T inney et al. (1993) for these two bands (Ic and K s, respectively). Masses were computed based on models by Bara e et al. (1998). E ective temperatures were obtained using several scales, namely Luhman (1999) for intermediate gravity and Leggett (2000, 2001). A llthem easured and derived values are listed in Table 1.

Figure 3 displays a HR diagram. The isochrones and evolutionary tracks {solid and dashed lines, respectively{ are from B ara e et al. (1998). A sterisks and open stars correspond to bolom etric lum inosities obtained from Ic and K s, respectively. For this particular diagram, we m ade use of the e ective temperature scale by Luhm an (1999). O ther temperature scales, such as that from Leggett et al. (2001), would shift the location of these three objects (two of them are almost on top of each other, the sm allshift in Te is arbitrary) to the right handside, m aking them younger and less m assive. Note, how ever, that Luhm an' scale has been tunned speci cally for the m odel we are using here. In any case, regardless the election of m odels (alternative m odels are, for instance, Burrows et al. 1997; D'Antona & M azzitelli 1994, 1997, 1998; Chabrier et al. 2000; Bara e et al. 2002), bolom etric

corrections and e ective tem perature scale, these m em bers are at or below the substellar frontier and have an age of about 3 M yr.

3.3. Near infrared photom etry, H emission and accretion

N one of our three targets seems to have neither the presence of forbidden lines, characteristics of out ows, nor near infrared infrared excesses, coming from an accretion disk.Figure 4 compares the colors (Ic J) and (H Ks), and includes the loci for dwarfs {Bessell & Brett 1988; K inkpatrick et al. 2000; Leggett et al. 2001) { and C lassical TTauri stars (M eyer et al. 1997, Barrado y N avascu es et al. 2003) and Classical Tauristars from Orion (Herbig & Bell 1988). As can be seen, the Taurus ob jects have photom etric properties {data from 2MASS{ sim ilar to those M S stars of similar spectral type and, as stated in the previous paragraph, no near IR excess is seen. This fact, by itself, cannot prove or disprove the presence of a circum (sub)stellar disk, since a hole can be present or the disk tem perature can be very cold. M oreover, the IR excess might depend on the orientation of the disk. See, for example, the case of LS-RC rA 1, M 6.5 brown dwarf belonging to RCrA dark cloud (Barrado y Navascues, M ohanty & Jayaw ardhana 2004). A dditional observations and longer wavelengths {m ore sensitive to cooler disksboth from ground-based telescopes and space-borne instrum ents such as those in Spitzer Space Telescope, can help to shed som e light in this issue.

Burrows et al. 1997; D'Antona & Mazzitelli 1994, 1997, We have detected and measured H in emission for 1998; Chabrier et al. 2000; Bara e et al. 2002), bolom etric these three objects. The pro les of this feature are dis-

played in Figure 5. Note the possible asymmetry in KPNO-Tau-8, the double peak in KPNO-Tau-5 and KPNO-Tau-3, and the width of the line (310 km/s), typical of accreting brown dwarfs (W hite & Basri 2003; Jayawardhana et al. 2003). In fact, this last object is

above the criterion de ned by Barrado y Navascu es & M art n (2003) which discrim inate between accreting and non accreting objects, as Figure 6 clearly indicates. W e note, how ever, that this criterion depends on low resolution spectroscopy, which norm ally yields larger equivalent widths compared with higher resolution data. In this diagram, we have included C lassical and W eak-line T Tauristars belonging to Taurus as solid and open circles. M embers without classi cation are included as crosses. O ur three targets appear as large asterisks. O verlapping squares and big circles denote those m embers with forbidden emission lines and near-infrared excesses, respectively. This large W (H) agree with the fact that we also detect H eI6678 A, another accretor indicator (see Figure 1).

A ctive accretion in at least one Taurus member whose mass is close or below the substellar limit is important for several reasons. First, although the sample studied in this paper is very small, it suggests that a signi cant fraction of the very low mass stars and high mass brown dwarfs might harbor an accretion disk. Second, the new data amass additional evidence for accretion in the substellar domain. To the best of our know ledge, there are only three papers dealing with high resolution spectra in Taurus brown dwarfs (W hite & Basri 2003; M uzerolle et al. 2003; and Jayawardhana et al. 2003). The rst work

found three accretors in a sample of ten very low mass stars and brown dwarfs, although the less massive, a M 6.5 (GM Tau), has a mass just above the substellar lim it. The second paper includes four objects whose spectral type is M 6 or M 7. None of them seem to undergo active accretion based on the width of H , although the authors claim that one of them , namely MHO-5, is accreting based on the detection of forbidden lines of oxygen at 6300 and 6363 A and Call IRT. M oreover, three out of the four were observed at m oderate resolution, including M HO -5 (R 8000). Regarding the later study, the four M 7-M 7.75 brown dwarfs discussed there, with masses (again, using Bara e et al. 1998 m oddown to 0.05 M els), do not show accretion either. M uzerolle et al. (2003) also analyzed seven Taurus m em bers w hose spectral types are M 4.75{M 5.75 (just above or at the substellar borderline). Three out of these seven are accreting, based on the width of H and other spectral indicators. Therefore, up to date, our study presents the only brown dwarf belonging to Taurus (kpno-tau-03), at the substellar lim it, which has been proved to be accreting.

In conjunction with the studies quoted in the previous paragraph, our results indicate that about 10% of the Taurus brown dwarfs (one out of 11) is actively accreting. This fraction is much smaller than the accretion occurrence in low mass stars in the association or the estimate for the substellar dom ain (about 50%) based purely on the strength of H measured in low resolution spectra (Barrado y Navascu es & Mart n 2003). The statistical criterion de ned in this last work is based on the saturation of the activity, as measured in several young open clusters (namely IC 2391, Alpha Per and the Pleiades, with ages ranging from about 50 to 125 M yr). The discrepancy in the fraction of accreting brown dwarfs might im ply that there is an additional source of ux in H line or that the accreting criterion based on the H width at 10% of the maximum intensity, as de ned by Jayawardhana et al. (2003), i.e. 200 km /s, is too restrictive.

The detection of accretion in substellar objects indicates that they undergo a phase similar to Classical TTauri stars (for a review, see Bertout 1989 or Appenzeller & M undt 1989). A handful of other brown dwarfs belonging to other young stellar association, with ages ranging from 1 to 10 M yr, have been observed with high resolution spectroscopy and the presence of accretion con med. In at least one, LS-RCrA 1 (Fern andez & Comeron 2001; Barrado y Navascues, Mohanty & Jayawardhana 2004), out ows have been seen, by means of the detection of intense, narrow forbidden lines. In a previous paper we have named them Classical Tauri substellar analogs (CTTSA). Therefore, we can conclude, at least in the case of high mass brown dwarfs (M as 0.072{ 0.04 M), that they are form ed as low m ass stars, by fragm entation and collapse of the originalm olecular cloud. Of course, additional studies are needed to con m this prelim inary conclusion, in particular high resolution im aging in the near and mid-infrared, as well as in the optical. Narrow band im aging m ight show whether these ob-

jects present out ows similar to those observed in some Classical TTauristars.

4.Summary

We have collected high resolution spectroscopy for the members of the Taurus-Auriga SFR. They have M 6-M 7 spectral types with m oderate to intense H emission, with pro les that, at least in one case, can be classi ed as typical of an accretor. We detect lithium too, which indicate that they are in the pre-main sequence (more strictly, the equivalent width imposes a maximum age of about 30 M yr, based on Bara e et al. 1998). M oreover, at least one, possibly two of them, are accreting material, as shown by the H pro le, providing an additional, stronger constrain to the age, about 10 M yr. Therefore, a minimum of a10% (one out of eleven) of the high mass brown dwarfs known in the cluster show accretion (i.e., circum substelalr disks). Note, how ever, that these objects do not have nearinfrared excess and do not show forbidden lines, although HeI6678 A, another signpost of accretion, appears in the spectrum of one of them, possibly in the other two. Since the likelihood of having a stellar association younger than 30 M yr in the sam e line-of-sight as Taurus, we can safely conclude that these objects belong to this SFR. Based on the new spectral types and m agnitudes in the optical and infrared, we derived masses around the substellar lim its and an age close to 3 M yr. Finally, the detection of accretion in the substellar dom ain provides another clue about the form ation m echanism of high m ass brown dw arfs, suggesting that they form as stars, by fragm entation and collapse of a m olecular cloud.
