## ABSTRACT

W e consider the stability of a con guration consisting of a verticalm agnetic eld in a planar ow on elliptical stream lines in idealhydrom agnetics. In the absence of a $m$ agnetic eld the elliptical ow is universally unstable (the \elliptical instability"). We nd this universal instability persists in the presence ofm agnetic elds of arbitrary strength, although the grow thrate decreases som ew hat. We also nd further instabilities due to the presence of the $m$ agnetic eld. O ne of these, a destabilization of A lfven waves, requires the $m$ agnetic param eter to exceed a certain critical value. A second, involving a m ixing of hydrodynam ic and $m$ agnetic $m$ odes, occurs for all $m$ agnetic- eld strengths. These instabilities $m$ ay be im portant in tidally distorted or otherw ise ellipticaldisks. A disk of nite thickness is stable if the $m$ agnetic eldstrength exceeds a critical value, sim ilar to the eldstrength which suppresses the $m$ agnetorotational instability.

## 1. Introduction

The problem of $m$ om entum transport in accretion disks is $w$ idely believed to require hydrodynam ic or hydrom agnetic turbulence for its resolution. The origin of this turbulence $m$ ay be sought in the instability of lam inar solutions of the equations of hydrom agnetics, solutions that are com patible w ith the geom etry of accretion disks. The recent history of these $e$ orts has taken the form of rst recognizing such an instability $m$ echanism, and then trying to inconporate that $m$ echanicsm into realistic disk $m$ odels.

The m agnetorotational instability (MRI) m echanism, originally discovered by Velikhov (1959) and Chandrasekhar (1960) and rst applied to accretion disks in Balbus \& H aw ley (1991), is of this kind (see Balbus \& $H$ aw ley (1998) for a review ). It appears in rotating, m agnetized system s in which the speci c angularm om entum increases outw ard and in which the $m$ agnetic eld is weak enough that rotationale ects are not overw helm ed by m agnetic tension.

A second $m$ echanism, that of the ellipticalinstability considered by G oodm an (1993) and others (Lubow, P ringle, and K ersw ell 1993; R yu and G oodm an 1994; R yu, G oodm an, and V ishniac 1996), is also consistent w ith the accretion-disk setting. T his instability $m$ echanism has been reviewed by K erswell (2002). In the setting considered by G oodm an et. al, it appears to require a secondary in order to enforce departure from rotational sym metry of the stream lines via a tidal potential. This is certainly appropriate for binary system s but it is likely that, even in the absence of a secondary, the lam inar m otion in the plane of the disk would not be accurately circular, so the elliptical-instability $m$ echanism would appear to be a candidate of considerable generality. It does not require a magnetic eld. O ne of the conclusions of the present paper is that it further persists in the presence of a $m$ agnetic eld. In the idealized setting of the present problem, the latter $m$ ay be of arbitrarily large strength. H ow ever, we also argue that in the setting of a disk geom etry, there $m$ ay indeed be a lim it on the eld strength.

In this paperwe therefore investigate the interaction of a verticalm agnetic eld with ow on elliptical stream lines, on the ground that both $m$ agnetic elds and noncircular stream lines are likely ingredients in accretion-disk settings. There are sim ilarities with and di erences from previous work on e ect ofm agnetic elds on the elliptical instability (K ersw ell 1994), which are discussed in x 6 .

## 2. Form ulation

W e consider ow on elliptical stream lines together with a m agnetic eld and investigate linear stability theory. The underlying equations are the Euler equations of uid dynam ics

W e shall assum e that dív $u=0$ and div $B=0$ and that the $u$ id is unbounded.
It is easy to chedk that the follow ing steady elds represent a solution of the preceding system :

Here and $B$ are constants, and a constant $m$ ay also be added to the pressure term. $M$ ore general exact solutions of the combined uid/m agnetic equations exist in an unbounded dom ain (C raik 1988); the case in hand is probably the sim plest of these.

### 2.1. The perturbed system

Let $u$; $B ; p$ be replaced by $U+u ; B+b ; P+p$ in equations $(1,2)$ above, and linearize. $T$ he resulting pertunbation equations are

Thus in solving this system we need to im pose the conditions that these inner products are zero initially; this will thereafter $m$ aintain the incom pressibility conditions (7).

The incom pressibility condition provides an altemative way of nding $v_{3}$ and $w_{3}$ once the equations for $v_{1} ; v_{2} ; w_{1} ; w_{2}$ have been solved, provided that $k_{3} \in 0$ : The only cases for which $k_{3}$ can vanish are those for which the combinations $k_{1} v_{1}+k_{2} v_{2}$ and $k_{1} w_{1}+k_{2} w_{2}$ are also found to vanish on solving the four-dim ensional system above. It is not di cult to show that there can be no instability associated with such a solution (see in particular the equivalent system (20) below ). A coordingly, we henceforth consider only perturbations w ith vertical wave num ber $k_{3} \in 0$ :

### 2.2. C hange of variables

W e change to new variables to facilitate subsequent calculations ${ }^{1}$.

### 2.3. G eneral C onsiderations

The coe cients of the $m$ atrix $D$ depend on the phase angle appearing in the expressions (12) above for the wave vector $k$. For purposes of studying stability, we $m$ ay set
$=0^{2}$. This is easily seen by $m$ aking the substitution $t^{0}=t$, which elim inates from the equation. For the rem ainder of this work we take $=0$ :

The system (20) presents a F loquet problem (cf. Yakubovich and Starzhinsii (1975)): the stability of the chosen steady solution $U$; B depends on whether there are solutions of this system that grow exponentially with time. This is settled by nding the F loquet multiplier $m$ atrix M. The latter is de ned as follow s. Let (t) be the fundam entalm atrix solution of equation (20) that reduces to the identity at $t=0$. Then, since the periodicity of $D$ is 2 , $\mathrm{M}=(2)$ : If any eigenvalue of M hasmodulus exceeding one, this im plies that there is indeed an exponentially grow ing solution.

It is fam iliar in conservative problem s that

P roposition 1 W henever is an eigenvalue of the F loquet m atrix, so also are its inverse ${ }^{1}$ and its com plex conjugate ${ }^{-}$.

The rst statem ent of this proposition is a typically a consequence of canonical H am iltonian structure, the second a consequence of the reality of the underlying problem. H ow ever, the system (20) is not canonical, and the $m$ atrix appearing in it is not real. W e can nevertheless establish these fam iliar properties of the eigenvalues directly from the system (20), as follow s. $T$ he tim e-reversal invariance of the physicalproblem is re ected in the existence of reversing sym m etry $R=$ diag ( $1 ; 1 ; 1 ; 1$ ) of the $m$ atrix $D$ above: $R D(t)=D(t) R$, implying that whenever c ( t ) is a solution so also is R c ( t ). Since the solutions of the $F$ loquet problem have the structure $c(t)=p(t) \exp (t)$, there must also be a solution $p(t) \exp (t): B u t$ the eigenvalues of the $F$ loquet $m$ ultiplier $m$ atrix $M$ are the values $=\exp (2 \quad$ ). This show $s$ that if is an eigenvalue of $M$, so also is $\exp (2)={ }^{1}$.

Sim ilarly, under m atrix transform ation $S=\operatorname{diag}(1 ; 1 ; 1 ; 1)$, D goes to its com plex conjugate. This show s that $M=S \bar{M} S^{1}$, i.e., that $M$ and its conjugate have the sam e eigenvalues.

Im m ediate consequences of $P$ roposition 1 are the follow ing: rst, in the stable case, eigenvalues of $M$ lie on the unit circle; second, if, as param eters change, an eigenvalue is

[^1]at the onset of instability, it m ust have multiplicity two (or higher). The latter conclusion is because, in the complex -plane, the dangerous eigenvalue must leave the unit circle sim ultaneously w th ${ }^{-1}$, which lies along the sam e ray as and therefore coincides with it when they both lie on the unit circle. T hus a necessary condition for the onset of linear instability is a resonance where tw o F loquet m ultipliers coincide.

### 2.4. P aram eters

T here are three dim ensionless param eters that gure in this problem. W e call them ; ; and :

Thus represents the departure of the stream lines of the unperturbed ow from axialsym$m$ etry. In these equations $k_{0}=\overline{2+k_{3}^{2}}$ and represents the length of the $w$ ave vector if $=0$. The magnetic param eter depends not only on the strength of the unperturbed $m$ agnetic eld but also on the wavelength of the perturbation.

In them atrix $D$ above, them agnetic eld enters through the param eterm $=k_{3} B$ (which is a $m$ easure of the $m$ agnetic tension force), and we shall continue to use this notation for the present, on the understanding that $m=$. It is also clear that we can use E rather than to $m$ easure the departure from rotational sym $m$ etry, and we shall do this in som e cases.

## 3. A nalysis

$T$ he $F$ loquet $m$ atrix is
M (; ; ) = (2 ; ; ; ) :

O ne could $m$ ap out the stability and instability regions in the param eter space num erically by integrating the system (20) system atically for $m$ any values of these param eters. $W$ e in fact do this for a selection of param eter values in $x 4$ below. H ow ever, in this and the follow ing section we present the outlines and results of an asym ptotic analysis based on regarding as a sm all param eter (details are presented in the A ppendioes). This is $m$ ore revealing than the num erical reults on their ow. It is also of considerable im portance in interpreting the num erical results, and is quite accurate even for values of that are not very sm all (cf. Figure 1 below ). The caloulation proceeds in tw o steps; nding $M$, and calculating its eigenvalues.

### 3.1. The F loquet M atrix

The asym ptotic analysis is facilitated by the circum stance that, if we put $=0$, the coe cient m atrix D o (say) of equation (21) becom es constant. We nd the eigenvalues and eigenvectors ofD 0 in A ppendix A.1. There are two com plex conjugate pairs ofm odes. O ne pair reduces to the ordinary hydrodynam ic $m$ odes in the lim it ! 0 . The second pair are $m$ agnetic $m$ odes $w$ ith zero frequency at $=0$. In the weak eld lim it, the ratio ofm agnetic to kinetic energy is $O\left({ }^{2}=4\right)$ for the $m$ odi ed hydrodynam ic $m$ odes and $O\left(4={ }^{2}\right)$ for the $m$ agnetic $m$ odes. If 1 , the kinetic and $m$ agnetic energies are near equipartition for both types ofm ode.

W e now tum to a brief description of the asym ptotic (or perturbation) procedure. In what follow s the param eter $w$ illbe held $x e d$ so, to sim plify the notation, we suppress the dependence of the F loquet m atrix on this param eter: $\mathrm{M}=\mathrm{M}(;)=(2$; $) . \mathrm{W}$ e shall need the Taylor expansion

The reason for allow ing variations with aswell as variationswith is that the region in the plane where instability occurs is typically a wedge with apex at a point (; ) = ( $0 ; 0$ ) and boundaries $=0^{+}$, where the slopes + and are to be found. (cf. F igure 1 below ). W ewill therefore consider of the form

where $m$ ay be regarded as a xed param eter to be chosen later. This will lead us to the widest of wedges in the plane, of width $O()$, exchuding other wedges of width $0\left({ }^{m}\right)$ w th m 2. These higher-order wedges typically occupy a tiny fraction of the param eter space (see Figure 4 below ). A s a result of the representation (24) we may write

### 3.2. The characteristic polynom ial

D enote by

the characteristic polynom ialofthe F loquetm ultiplierm atrix M ( ) and its rootsby 1 ; 2; A necessary condition for stability is that each root lie on the unit circle. To explore the onset of instability for various param eter valhes, we shall obtain the characteristic polynom ial $p$ in the form

and exploit our know ledge of the roots of $p_{0}$ to obtain the roots of $p(;)$ in the form of a Puiseux expansion in (H ille 1972)).

The nature of this expansion depends on the multiplicities of the roots $f{ }_{k} g$ of $p_{0}$, the characteristic polynom ial of the unpertunbed F loquet m atrix $\mathrm{M}_{0}$. These roots are given by the expressions $k=\exp 2 k$ where the $f k g$ are the eigenvalues of the $m$ atrix $D_{0}$ given in A ppendix A. 1 (equation A 3) ; they are alldistinct. H ow ever, it is possible for the m ultipliers f ${ }_{k} g$ to be repeated even when, as in the present case, the $f_{k}{ }^{2}$ are distinct: if ${ }_{k} \quad{ }_{1}=i k$ for an integer $k \in 0$, then $k=1$.

A necessary condition for the onset of instability is that there be a double (or higher) root of the characteristic equation, and we henœforth restrict consideration to the case of double roots ${ }^{3}$. For de niteness, we suppose $2=1$.Then the P uiseux expansion takes the form

The two values of $1=2$ give the generic expressions for the change in a double eigenvalue, yielding a pair of roots branching from the double root ${ }_{1}$. However, if $p_{1}\left({ }_{1}\right)=0$; this expression is inadequate and one $m$ ust proceed to the next term in order to determ ine the e ect of the perturbation on the stability. Under the present assum ptions, it is indeed the case that $p_{1}$ vanishes at ${ }_{1}$, as we show in A ppendix A $3^{4}$.

In the case at hand, the com $m$ on value of 1 and 2 lies on the unit circle. In order for the perturbed values of the $F$ loquet multipliers to lie o the unit circle (and therefore im ply instability), it is easy to verify that it is necessary and su cient that ${ }_{1}={ }_{1}$ have a nonvanishing real part. 4. $N$ um erical results

In this section we present a selection of num erical results. These are obtained by integrating the system (20) to obtain the fiundam entalm atrix solution ( $t$; ; ; ) and evaluating it at $t=2$ to get the $F$ loquet $m$ atrix $M$ (; ; ;). For xed , the eigenvalue ofm axim um $m$ odulus is found as a function of $E$ (rather than ) and, and the regions of the $E$ plane where this $m$ axim um m odulus exceeds one are distinguished. W e have carried this out to $\mathrm{E}=1: 6(=0: 4875)$ in the gures although there is no lim itation on the size of E , or of , in this $m$ ethod.

In $F$ igure 1, we have taken the $m$ agnetic param eter equal to zero in the left-hand panel, so this represents the purely hydrodynam ic case studied originally by Bayly (1986) and P ierrehum bert (1986) and subsequently by others. For > 0, a m ixed m ode of interaction involving both hydrodynam ic and hydrom agnetic $m$ odes com es into existence, and this is show $n$ in the right-hand panel ofF igure 1, where $=1$. $T$ his is too sm all for the rem aining leading-order instability to appear. That rem aining instability, which represents a resonant interaction betw een tw o $m$ odes that ow e their existence to the presence of the $m$ agnetic eld, is indicated in F igure 2 for a m agnetic param eter $=2$ (right-hand panel), slightly greater than the $m$ inim um value ( $\overline{\mathrm{P}}$ ) for the existence of this instability.

The asym ptotic form ulas im ply that the $m$ axim al grow thrate (or equivalently the $m$ axim al instability increm ent ) for each of the wedges of instability tends to a xed value as the $m$ agnetic param eter increases. This is illustrated in $F$ igure 3. H ow ever, the asym ptotic form ulas for the grow thrates are less accurate than those for the stability boundaries, for the larger values of E .

In identifying these tongues, we have $m$ ade repeated use of the asym ptotic form ulas presented earlier. The num erical procedure also picks up some further tongues, related to higher-order resonances, that are exchuded by the procedure leading to the asym ptotic form ulas. These we have m ostly ignored on the ground that they are too weak and occupy too sm all a region of the param eter space to be signi cant, but we show one such resonance tongue for two values of in $F$ igure 4

## 5. U pper bound on eldstrength

The results of $\times x 3.3$ and 4 show that $m$ agnetoelliptic instability occurs in vertically unbounded system s whatever the eldstrength, and that the grow th rates are relatively insensitive to the $m$ agnetic eldstrength param eter. The loci of instability in the ( $E$; ) plane, how ever, do depend on . As ! 1 , the resonant, in all three cases, scales as ${ }^{1}$ and the $m$ agnetic tension param eterm ! 1.This is a consequence of the resonant character of the instability. Since the $m$ ode frequency $m$ ust be close to the rotational frequency, the A liven frequency m cannot be too large. A s B ! $1, \mathrm{k}_{3} \mathrm{~m}$ ust approach zero.

In a system of nite vertical thickness $H, k_{3}$ cannot drop below $=H$, where is a factor of order unity. Therefore, if $\mathrm{v}_{\mathrm{A}}$ exceeds $\mathrm{H}=$, we expect the m agnetoelliptic instability to be suppressed. A precise upper bound on $v_{A}$ follows from eqn. (A 3) and application of the resonance conditions; equations (37), (39), and (41). In C ases 1 and 2, instability requires $\stackrel{m}{P}^{2}{ }_{3}$ 1. C ase 3 requires $m^{2} \quad$ 3. Therefore, $m$ agnetoelliptic instability requires X $\overline{3} \mathrm{H}=$ (there is a correction of order due to the nite bandw idth). The corresponding eldstrength is com parable to them axim um value of the eld at which them agnetorotational instability can operate (Balbus \& H aw ley 1998).

## 6. D iscussion

W e have explored the e ect of a uniform, vertical magnetic eld on the stability of planar, incom pressible ow with elliptical stream lines in an unbounded medium, in the approxim ation of ideal $m$ agnetohydrodynam ics. In the absence of $m$ agnetic elds, ow s w ith elliptical stream lines having ellipticity param eter [see equation (22)] are known to be unstable to perturbations with wavevectors that are transverse to the plane of the ow (the \elliptical instability"). O ur rst conclusion is that this elliptical instability persists in the presence of a verticalm agnetic eld: the latter decreases the maxim um grow thrate but fails to suppress the instability, no $m$ atter how large the $m$ agnetic- eld param eter becom es. It can be com pared w th the conclusion of $K$ ersw ell (1994) that a toroidal magnetic eld has a stabilizing in uence. K erswell's analysis holds for sm all only and shows that the grow thrate decreases w ith $m$ agnetic eld in that lim it. O ur result, which holds for a vertical $m$ agnetic eld, show s a sim ilar trend for $s m$ all values of the $m$ agnetic- eld param eter, but this trend never results in com plete stabilization of the elliptical instability $w$ ith increasing magnetic eld.

A second conclusion is that there are further instabilities associated w ith the presence of the $m$ agnetic eld. O ne of these, for which the eigenvector is a $m$ ixture of hydrodynam ic
and $m$ agnetic $m$ odes, occurs for all values of the $m$ agnetic eld param eter. A nother, for which the eigenvector is a combination of $m$ agnetic $m$ odes only, sets in for values of the $m$ agnetic- eld param eter exceeding a certain threshold value ( $>{ }^{3} \overline{3}$ ). In all three of these instabilities, for large $m$ agnetic elds, the wave vector $m$ akes only a sm all angle w ith the plane of the unperturbed ow, re ecting the fam iliar tendency for dynam ics to becom e nearly 2 -dim ensional in a strong, well ordered $m$ agnetic eld. This is re ected in Figure 2, which shows that as increases, the unstable wedges are pushed to sm aller . A though the unstable fraction of the ( $\mathcal{E}$; ) plane decreases with increasing (except for a very slight $m$ axim um at 2.18 , re ecting the onset of instability betw een $m$ agnetic $m$ odes), the separation between the unstable wedges also decreases. W hile the nonlinear evolution of the unstable system is beyond the scope of this work, the destabilization of a nearly continuous swath of param eter space $m$ ay have consequences for the interactions between unstable m odes. In all three cases, the m axim um instability increm ent tends to $=2$, ie., the $m$ axim um grow thrate of the unstable $m$ odes tends, in dim ensional units, to $=4$.

A ll three of these instabilities $m$ ay be relevant in accretion-disk settings. In system $s$ of nite thickness H, how ever, the instability is suppressed if the A lfven speed $\mathrm{v}_{\mathrm{A}}$ exceeds a critical value of order H. M agnetorotational instabilities are quenched at approxim ately the sam e eldstrength (Balbus \& $H$ aw ley 1998). The grow th rate ofm agnetoelliptical instabilities is sm aller than that ofm agnetorotational instabilities by a factor oforder , and thus they are not necessarily the prim ary instability in $m$ agnetized disks. They $m$ ay well play a secondary role by breaking up eddies or vortioes generated by other m echanism s.
$M$ agnetoelliptic instabilities $m$ ay also occur in the inner parts of barred galaxies, in which the gas ow is slightly elliptical and them agnetic eld, at least in the M iky W ay, has a vertical com ponent (M orris and Serabyn 1996). In such settings, the instabilities could be a source of turbulence, possibly a ecting the m ass supply to a central com pact ob ject.
