Variable Faint Optical Sources D iscovered by Comparing POSS and SDSS Catalogs

ABSTRACT

W e present a study of variable faint optical sources discovered by comparing the Sban D igital Sky Survey (SD SS) and the Palom ar O bærvatory Sky Survey (PO SS) catalogs. W e use SD SS m easurements to photom etrically recalibrate several publicly available PO SS catalogs (U SN O -A 2.0, U SN O -B 1.0, G SC 2.2 and D PO SS). A piecewise recalibration of the PO SS data in 100 arcm in² patches (one SD SS eld) generally results in an improvement of photom etric accuracy (m s) by nearly a factor of two, compared to the original data. In addition to the smaller core width of the error distribution, the tails of the distribution become much steeper after the recalibration. These improvements are mostly due to the very dense grid of calibration stars provided by SD SS, which recti es the intrinsic inhom ogeneities of Schmidt plates. W e indicates the PO SS I m agnitudes can be improved to 0.15 m ag accuracy, and PO SS II m agnitudes

to 0.10 m ag accuracy. The sm allest nalerrors are obtained with the GSC 2.2 catalog for which they approach 0.07 m ag at the bright end.

We use the recalibrated catalogs for the $2,000 \text{ deg}^2$ of sky in the SD SS D ata R elease 1 to construct a catalog of 60,000 sources variable on time scales 10-50 years. We nd that at least 1% of faint optical sources appear variable at the > 0.2 m ag level, and that about 10% of the variable population are quasars, although they represent only 0.25% of all point sources in the adopted

ux-lim ited sample. A series of statistical tests based on the morphology of SD SS color-m agnitude and color-color diagram s, as well as visual com parison of in ages and comparison with repeated SDSS observations, demonstrate the robustness of the selection m ethods. C andidate variable sources are correctly identi ed in m ore than 95% of cases, and the fraction of true variables am ong the selected candidates is as high as 73%. We quantify the distribution of variable sources in the SD SS color-color diagram s, and the variability characteristics of quasars. The observed long-term variability (structure function) is smaller than predicted by the extrapolation of the power-law measured for short time scales using repeated SD SS in aging (0.35 vs. 0.60 m ag for SD SS-PO SS I, and 0.24 vs. 0.35 m ag for SD SS-PO SS II, m s). This tum-over in structure function suggests that the characteristic time scale for quasar variability is of the order one year. The long-term (> 1 year) quasar variability decreases with lum inosity and rest-fram e wavelength similarly to the short-term (< 1 year) behavior. We also dem onstrate that candidate RR Lyrae stars trace the sam e halo structures, such as the Sqr dwarf tidal stream , that were discovered using repeated SD SS observations. We utilize the POSS-SDSS selected candidates to constrain the halo structure in the parts of sky for which repeated SD SS observations do not exist.

1. Introduction

The time domain represents another dimension, in addition to spectral and spatial, in the exploration of celestial objects. Despite the importance of variability phenomena, the properties of optically faint variable sources are by and large unknown. There are about 10^9 stars brighter than V = 20 in the sky, and at least 3% of them are expected to be variable

at a few percent level (Eyer, 1999). However, the overwhelm ing majority are not recognized as variables even at the brightest magnitudes: 90% of variable stars with V < 12 remain to be discovered (Paczynski, 2000). Paczynski (1996) lists striking examples of the serious incompleteness in the available samples of variable stars: eclipsing binaries of A lgol type, and contact binaries (W UM a stars) are incomplete fainter than V 12, and RS CVn type binaries are complete only to V 5. Another vivid example of serious selection e ects is the sky distribution of RR Lyrae stars: objects listed in the 4th G eneral C atalogue of Variable Stars (the main resource for variable stars) are distributed in isolated square patches with the size and shape of the Schm idt plates used to discover them.

The discrepancy between the utility of variable stars and the available observational data has prom pted several contem porary projects aim ed at regular monitoring of the optical sky. The current state-of-the-art also greatly bene ted from past and present m icrolensing searches (Paczy nski, 2001). Som e of the more prom inent surveys in terms of the sky coverage, depth, and cadence are:

The Faint Sky Variability Survey (Huber, Howell, Everett & G root, 2002) is a very deep (V < 24) B V I survey of 23 deg² of sky, containing about 80,000 sources

The QUEST Survey (V ivas et al. 2001) monitors 600 deg of sky to a lim it of V = 21.

ROTSE (A kerlof et al. 2003) monitors the entire observable sky twice a night to a $\lim it of V = 15.5$.

OGLE (m ost recently OGLE III; U dalski et al. 2002) monitors 100 deg towards the Galactic bulge to a limit of I = 20. Due to a very high stellar density towards the bulge, OGLE II has detected over 200,000 variable stars (W o zniak et al. 2002).

These and other surveys have demonstrated that in addition to variable stars, there are many other exciting photom etrically variable objects in the sky. For example, ROTSE I detected an optical ash generated by a gamma ray burst at a redshift of 1.6, the most lum inous optical source ever measured (V = 9, $M_V = 36$:4, Vestrand et al. 2002). The detection of such optical ashes may place strong constraints on the physical mechanisms responsible for gamma ray bursts. Similarly, the variability of quasars o ers signi cant clues for the origin of their emission (e.g. Trevese, K ron & Bunone, 2001).

Recognizing the outstanding importance of variable objects, the last Decadal Survey Report highly recommended a major new initiative for studying the variable sky, the Large Synoptic Survey Telescope (LSST). The LSST¹¹ will o er an unprecedented view of the faint variable sky: according to the current designs it will scan the entire accessible sky every three nights to a limit of V 24. Compared to any other survey currently available, the data from LSST will be revolutionary. Yet, at least half a decade or more will elapse before the rst photons are detected by the LSST. Meanwhile, the already available P alom ar D igital Sky Surveys (POSS I and POSS II, for references see Appendix A) and ongoing Sloan D igital Sky Survey (see Section 2.2) can be used to study the properties of faint (r 20) optical sources, and here we present such a study.

The comparison of the POSS and SDSS surveys allows studies of the long term variability with time scales of up to half a century. By necessity, such studies are based on a small number of observations of the same objects to constrain the ensemble properties of a sample of sources, as opposed to studying well-sampled light curves for a small number of objects. The lack of detailed information for individual objects is compensated in some ways by the large sample size. In addition, the 5-band accurate SDSS photom etry can be used for very detailed source classic cation; e.g. separation of quasars and stars (R ichards et al. 2002), spectral classic cation of stars to within 1-2 spectral subtypes (Lenz et al. 1998, F inlator et al. 2000, H aw ley et al. 2002), and even remarkably e cient color selection (thanks to accurate u band photom etry) of the low-m etallicity G and K giants (Helm i et al. 2002) and horizontal branch stars (Y anny et al. 2000, Ivezic 2003a).

However, when using only a few epochs of observations, the robustness of variability detection critically depends on the stability of the photom etric errors. W hile the SD SS photom etric errors are sm all (0.02) and well behaved (Ivezic et al. 2003b), older photographic PO SS data can have large errors (tenths of m ag) due to intrinsic inhom ogeneities of Schm idt plates and the lack of a su cient number of calibration stars. This problem can be alleviated to some extent by using photom etric measurements of stars in the SD SS to recalibrate PO SS catalogs. In Section 2 we describe such a recalibration method and demonstrate that photom etric errors in the PO SS catalogs can be decreased by a factor of 2 (m s), with a signi cant improvement in the behavior of the error distribution tails. In Section 3, we use SD SS data and recalibrate PO SS catalogs to select variable objects in 2000 deg² of sky from the SD SS D ata R elease 1 (A baza jian et al. 2003). In the sam e section we discuss tests which demonstrate the robustness of the selection algorithm, and quantify the distribution of variable sources in the SD SS color-color diagrams. The M ilky W ay halo structure traced by selected candidate RR Lyrae stars is discussed in Section 4, and in Section 5 we analyze the variability of quasars. O ur main results are

summarized in Section 6.

2. The Photom etric R ecalibration of POSS C atalogs using SDSS M easurem ents

2.1. The Input POSS Catalogs

We utilize several publicly available POSS catalogs: USNO-A2.0, USNO-B1.0, GSC2.2 and DPOSS.A description of each catalog and references are listed in Appendix A. Here we brie y mention that all four catalogs utilize the same POSS I and POSS II Schmidt plates. However, the scanning and calibration procedures are dimenst, and the source parameters, such as magnitudes, reported in dimenst catalogs in general are not the same for the same sources detected on the same plates. USNO-A2.0 reports O and E magnitudes, hereafter O_a and E_a to distinguish them from O and E magnitudes reported in the USNO-B1.0 catalog. The latter catalog also lists J, F and N magnitudes. The GSC2.2 catalog lists J and F magnitudes, hereafter J_g and F_g to distinguish them from J and F magnitudes reported in the USNO-B1.0 catalog. The DPOSS catalog is also based on photographic J;F and N, but they are calibrated and reported as G;R and I magnitudes.

The completeness of the USNO-B1.0 catalog, measured using SDSS data, is discussed by Munn et al. (2004). Our analysis of other catalogs con m s their result that, in general, POSS catalogs are 95% complete at magnitudes brighter than 19{20 (depending on a particular band/catalog), and have faint limits (which we de ne as the magnitude where fewer than 50% of SDSS sources are found in a POSS catalog) at m 20:5 21.

2.2. Sloan Digital Sky Survey

The SD SS is a digital photom etric and spectroscopic survey which will cover up to one quarter of the Celestial Sphere in the North Galactic cap, and produce a smaller area (225 deg^2) but much deeper survey in the Southern Galactic hem isphere¹² (York et al. 2000, Stoughton et al. 2002, A baza jian et al. 2003). The ux densities of detected objects are measured almost simultaneously in ve bands (u, g, r, i, and z) with elective wavelengths of 3540 A, 4760 A, 6280 A, 7690 A, and 9250 A (Fukugita et al. 1996, G unn et al. 1998, Smith et al. 2002, Hogg et al. 2002). The completeness of SD SS catalogs for point sources

is 99.3% at the bright end (Ivezic et al. 2001), and drops to 95% at limiting magnitudes³³ of 22.1, 22.4, 22.1, 21.2, and 20.3 (the SD SS saturation limit is 14 in the r band, and som ewhat brighter in other bands). All magnitudes are given on the AB system (O ke & G unn 1983, for additional discussion regarding the SD SS photom etric system see Fukugita et al. 1996 and Fan 1999). The survey sky coverage of about steradians (10,000 deg²) will result in photom etric measurem ents to the above detection limits for about 100 m illion stars and a similar num ber of galaxies. A strom etric positions are accurate to about 0.1 arcsec per coordinate for sources brighter than r 20.5^m (Pier et al. 2003), and the morphological inform ation from the images allows robust star-galaxy separation to r 21.5^m (Lupton et al. 2003). M ore technical details may be found in Stoughton et al. (2002), and on the SD SS web site (http://www.sdss.org).

In this work we use the SD SS D at a R elease 1, which provides data for 2099 deg² of the sky. The equatorial A ito projection of this area can be found at the SD SS web site (also F ig. 5 in Ivezic et al. 2003a).

2.3. Photom etric Transform ations Between POSS and SDSS System s

We chose to synthesize m agnitudes in the POSS bands using SDSS measurements, and then recalibrate POSS catalogs using their original bands. The alternative of recalibrating POSS catalogs directly to the SDSS system is less desirable because colors at the POSS epoch are poorly known, and this may have an elect on the photom etric accuracy for variable sources. Following M onet et al. (2003), we adopt the following form to de ne synthetic POSS magnitudes, m_{SDSS} , calculated from SDSS photom etry:

$$m_{SDSS} = m + b \operatorname{color} + c \tag{1}$$

where m = g;r;g;r;i and color = g r, g r, g r, r i for 0;E;J;F, and N, respectively (e.g. $O_{SDSS} = g + b(g r) + c$). Utilizing data for about 300 deg² of sky (SD SS runs 752 and 756), we derived the best-t values of coe cients b and c for each band and the POSS catalog. We used only \good" sources de ned as:

 Sources must be unresolved in SD SS data (note that the SD SS star-galaxy separation is robust to at least r 21:5, which is signil cantly fainter than the faint lim it of the resulting sample).

- 2. Sources must be isolated in SDSS data. This condition ensures that the USNO/GSC/DPOSS photom etry is not a ected by di cult to measure, blended objects
- 3. Sources must not be saturated in g or r band in the SDSS data (roughly equivalent to $g_r > 14^m$), and must have g < 19.
- 4. The USNO/GSC/DPOSS and SDSS positions must agree to better than $2^{\circ\circ}$. This limit corresponds to a 5 cut on astrometric errors (Pier et al. 2003).
- 5. The sources must have g > 0.7 (measured by SDSS) to avoid highly variable quasars (see Section 5).

The best-t values of coe cients b and c, and the residual m s scatter (which is a good m easure of the m ean photom etric accuracy of the POSS catalogs) are listed in Table 1. Note that J and F m agnitudes from the GSC 2.2 catalog have the sm allest residual scatter, while the O and E m agnitudes have the largest scatter.

Sim ilar values for b and c coe cients were derived for the USNO-B1.0 m agnitudes by M onet et al. (2003). We have veri ed that adopting their transform ations results in only slightly larger residual scatter for the other three catalogs. Thus, in order to prevent proliferation of various SDSS-POSS transform ations, we adopt their transform ations, which we list below for completeness, in the rest of this work (for DPOSS G and R m agnitudes¹⁴, we use coe cients listed in Table 1).

2.4. The Recalibration M ethod

The set basic premise of the recalibration method employed here is that the SDSS photom etric errors are negligible compared to errors in the POSS catalogs { the SDSS photom etric errors are 0.02 m ag, as demonstrated by repeated scans (Ivezic et al. 2003b), while the errors in the POSS catalogs are 0.1 m ag or larger. The second premise is that not more than a few percent of faint stars vary by more than a few percent, in agreement with the available data and models (Eyer 1999). The third assumption is that systematic errors are a signi cant contribution to photom etric errors in the POSS catalog, and thus can be calibrated out using a dense grid of calibration stars provided by SDSS. We demonstrate empirically that indeed the accuracy of POSS-based photom etry can be improved by about a factor of 2 in all analyzed catalogs.

The recalibration of the POSS catalogs is performed in two steps. In the rst step the subsamples of \good" objects (see Section 2.3) are grouped by Schmidt plate and SDSS elds. One SDSS eld has an area of 0.034 deg; this is su ciently large to include enough calibration stars (typically 50-200), and yet su ciently sm all that the response of the Schmidt plates is nearly constant, as shown by Lattanzi & Bucciarelli (1991). To avoid edge e ects, we use a running window with the width of 3 SDSS elds (0.45, see the next section form ore details).

For each of the vePOSS magnitudes, we minimize p^{P} (m $_{recalib}$ m $_{SDSS}$)² using the least-square method, where

and m = 0; E; J; F; N (m_{SDSS} are de ned by eq. 2). This step removes systematic m agnitude errors due to local non-linearities of the plate, color-term dependence and zero-point o sets¹⁵. In the second step, we use all the \good" sources from a given Schmidt plate (36 deg²) to correct the dependence of the $m_{recalib}$ m_{SDSS} residuals on m agnitude (using median m_{recalib} m_{SDSS} in 1 m ag wide bins, and linear interpolation between the bin centers). Such residuals are typically larger at the faint end, and are probably caused by incorrect sky estimates in the POSS catalogs.

2.4.1. The Optim al Recalibration Scale

As advocated by Lattanzi & Bucciarelli (1991), the characteristic scale for inhom ogeneities in Schm idt plates is about 0.5. We tested their result by recalibrating POSS-II J band plates by varying the calibration window width. Fig. 1 shows the nal errors as a function of that width for three plates. As expected, the decrease of calibration window width decreases photom etric errors all the way to practical limit of 0.5 set by the minimum number of required calibration stars. The gure demonstrates that in provement in accuracy by decreasing the window width from 0.5-1 to 0 is only 0.01 m ag, thus con ming the result of Lattanzi & Bucciarelli. Note that when extrapolating curves to zero window width, plates show varying photom etric accuracy, re-ecting di-erent intrinsic properties.

The plate-dependent system atic photom etric errors in POSS catalogs are illustrated in Figs. 2{4 (the behavior for USNO-B1.0 catalog is sim ilar). The large jumps in photom etric errors at the boundaries of 6 degree wide Schm idt plates are obvious, and suggest that the photom etric recalibration of POSS data is mandatory when searching for variable sources that vary less than a few tenths of a magnitude.

2.5. A nalysis of the R ecalibration R esults

2.5.1. Recalibration Results for the USNO Catalogs

The results of two recalibration steps, described in the previous section, are illustrated for the USNO-A2.0 catalog in Fig. 5. As evident from the middle panels, the step results in smaller scatter between SDSS and recalibrated POSS magnitudes, but the magnitude dependence of their di erences remains appreciable. This dependence is removed in the second recalibration step, as discernible from the bottom panels.

The recalibration procedure generally results in about a factor of 2 improvement in the root-mean-square (mms) scatter between SDSS-based synthetic POSS magnitudes and the measured POSS magnitudes. Fig. 6 compares the POSS-SDSS magnitude dimences before (thin lines) and after (thick lines) calibration, for 0 and E bands, on a linear and logarithmic scale. As evident, the recalibration not only results in a smaller rms scatter, but also signine cantly clips the tails. Both elects are of crucial importance when selecting variable objects.

The corresponding results for the U SNO - B1.0 catalog are shown in Figs. 7 and 8. We note that the original O and E m agnitudes have somewhat smaller errors in the U SNO - A2.0

catalog, but the USNO-B1.0 m agnitudes are m arginally better after recalibration.

2.5.2. Recalibration Results for the GSC2.2 and DPOSS Catalogs

The main di erence between the recalibration of G SC 2.2 and other catalogs is the lack of plate information¹⁶ which prevented the second recalibration step. Nevertheless, Figs. 9 and 10 show that for the G SC 2.2 catalog the magnitude dependence of the di erences between SD SS and recalibrated PO SS magnitudes is minor. The results for the DPO SS catalog are shown in Figs. 11 and 12.

2.5.3. Summary of Recalibration Results

A sum m ary comparison of the original and recalibrated m agnitudes is shown in Fig.13. The rm s values of m agnitude di erences before and after the recalibration for all the catalogs and bands are listed in Table 2. The nal errors for the POSS II m agnitudes are generally sm aller (0.10 m ag) than for the POSS I m agnitudes (0.15 m ag), both evaluated for stars brighter than g = 19. The sm allest nal errors are obtained with the GSC 2.2 catalog for which they approach 0.07 m ag at the bright end.

3. Prelim inary Analysis of the POSS-SDSS Catalogs of Variable Sources

The comparison of the SD SS photom etric catalog with photom etrically recalibrated PO SS catalogs can yield a large number of variable sources. Various methods can be employed to produce such a list of candidate variables, depending on whether each band/catalog is considered separately or not, on the cuto values form agnitude di erences, the sample faint limit, etc. The DPOSS catalog is the main catalog used in the subsequent analysis (while the smallest nal errors are produced with the GSC 2.2 catalog, its public version is not as deep as the DPOSS catalog). For the POSS I survey we chose the USNO-A 2.0 catalog (the other option is USNO-B 1.0; the photom etric errors after recalibration are similar for both USNO catalogs) because it is distributed as a part of the SD SS D ata Release 1 (A baza jian et al. 2003).

The criteria for selecting candidate variable sources are described in the next section, and a series of tests for estimating the selection reliability are described in the subsequent section.

3.1. Selection Criteria

W hen selecting candidate variable sources we consider each POSS band individually for two reasons. First, sometimes POSS observations of the same sky regions were not obtained at the same time, and treating each epoch separately increases the selection completeness for sources variable on short time scales. Second, additional constraints that combine di erent bands (e.g. \a source must vary in both 0 and E band") can be easily imposed after the initial single-band based selection. We consider only isolated point sources detected by both POSS and SDSS. An initial attempt to isolate orphaned sources detected by only one survey was impeded by the large number of false positives due to problem s with POSS plates, and is postponed for future analysis.

For each catalog and band we de ne the faint magnitude limit, m_{faint} , minimum ux variation, $m = jn_{SDSS}$ $m_{POSS}j$ and its minimum signi cance, = m = . For the photom etric error, , we take the rms scatter for all the stars in a given calibration patch and in 0.5 m ag wide magnitude bins (using a linear interpolation of binned errors as a function of magnitude). The adopted values of selection parameters for each catalog are listed in Table 3, as well as the number of selected candidate variable sources. In general, the m condition controls the selection at the bright end, while the condition limits the sam ple at the faint end. Thus, the selection e ciency is roughly independent of magnitude until about 1–1.5 m ag above the adopted faint limit, m_{faint} , when it starts decreasing. We nd that typically 15–20% of selected candidates simultaneously satisfy conditions in two bands from a given catalog.

These particular selection criteria were adopted after a trial and error procedure which utilized tests described in the next section. We chose to err on the conservative side and increase catalog robustness at the expense of its completeness, since the small number of epochs already introduced substantial incom pleteness. Hence, the fraction of variable sources reported here is only a lower lim it.

3.2. Tests of the Selection R eliability

G iven the selection criteria described in the previous section, it is necessary for subsequent analysis to estimate the completeness and e ciency of the resulting samples. The selection completeness, the fraction of true variable sources in the analyzed sky region and observed magnitude range selected by the algorithm, is certainly low because the selection is based on variations in only one bandpass, and a fairly large mouto compared to the typical am plitudes of variable sources (e.g. most RR Lyrae stars and quasars have peak-to-peak amplitudes < 1 m ag). For example, Ivezic et al. (2000) used two-epoch SD SS m easurem ents to select candidate RR Lyrae stars and obtained com pleteness of 50% for a m cuto of 0.15 m ag. W ith larger m cuto s adopted here, the expected selection com pleteness for RR Lyrae stars is about 20% (see Section 4 for a direct m easurem ent). The completeness for other types of variable source depends on the shape and am plitudes of their light curves and is hard to estimate, but for most sources is similarly low. W hile such a low completeness cannot be avoided with the available data, its stability across the sky can be controlled. Such a stability is demonstrated by the lack of features in the distribution of quasars selected by variability, as well as by the recovery of known structures in the distribution of RR Lyrae stars, as discussed below .

The selection e ciency, the fraction of true variable sources in the selected sample, may severely impact the analysis if not su ciently large. We demonstrate using a series of tests that the selection e ciency is indeed very large (73%) and thus allows a robust analysis of variable faint optical sources.

The main diagnostic for the robustness of the adopted selection criteria is the distribution of selected candidates in SD SS color-magnitude and color-color space. Were the selection a random process, the selected candidates would have the same distribution as the whole sample. However, we not that the samples of candidate variables have a signi cantly di erent distribution, as detailed below. The most robust and quantitative test for estimating selection reliability is a comparison with repeated SD SS in aging observations, though applicable to only a small fraction (10%) of the sky area discussed here where such SD SS observations exist. A nother powerful test for candidates with large suspected ux variation $\gtrless 0.5$ m ag) is a simple visual comparison of PO SS and SD SS im ages. While we found a number of spurious candidates using this method, their fraction is not large enough to signi cantly a ect our results.

3.2.1. The Distribution of Candidate Variable Sources in SDSS Color-color Diagram s

The position of a source in SD SS color-m agnitude and color-color diagram s is a good proxy for its classi cation. The distribution of selected candidate variables with g < 19 (using the DPO SS catalog, and restrictive selection criteria, entries 7 and 8 from Table 3) in representative diagram s is shown in Fig. 14 (the measured magnitudes are corrected for interstellar extinction using the map from Schlegel, Finkbeiner & Davis 1998). The top row is shown for reference and displays a sample of random ly selected SD SS point sources with the same ux limits as used for selecting variable sources. The middle and bottom rows compare the distributions of this reference sample, shown as contours, to the distributions of candidate variable sources, shown as dots.

The distributions of candidate variable sources and those of the reference sample are di erent, demonstrating that the candidate variables are not random ly selected from the whole sample. The most obvious di erence between the distributions is a much higher fraction of quasars (recognized by their UV excess, u g < 0.6) in the variable sample (quasars are known to be variable on long time scales discussed here, see x5). Another notable di erence is a presence of RR Lyrae stars (u g = 1.2, g = r = 0) among the candidate variables. Thus, known variable sources indeed dom inate the selected candidates.

In order to quantify these di erences, as well as those in other parts of the color-color diagram, we divide color-color diagram s into seven characteristic regions, each dom inated by a particular type of source (form ore details about the distribution of point sources in SD SS color-color diagram s see Lenz et al. 1998, Fan 1999, F inlator et al. 2001, and R ichards et al. 2002). The fractions of variable and all sources in each region are listed in Table 4. Notably, the fraction of variable sources which are found in region II, representative of num erous low-redshift quasars, is 35 times higher than for the reference sam ple^{17} . The corresponding fraction for region V II (which includes high-redshift quasars and, possibly, variable stars) is even higher (150), but the statistics are less robust due to a sm aller num ber of sources. A nother quantitative representation of the color di erences introduced by the variability requirement is shown for u g color in Fig. 15. These, and other di erences listed in Table 4, dem onstrate that the sam ple of selected candidate variables is not dom inated by spurious objects.

The fraction of selected candidate variables across the sky is stable, and, in particular, does not depend on the stellar number density, nor shows jumps at the boundaries of

Schm idt plates. Figure 16 illustrates this stability for a 2.5 deg. wide strip centered on the Celestial Equator, where the fraction of candidate variables remains 0.8% (not corrected for unknown selection incom pleteness), despite the stellar counts varying by a factor of 3 (a slight increase at RA 230 is caused by RR Lyrae in the Sgr dwarf tidal stream, see Section 4).

3.2.2. The Comparison with Repeated SDSS Im aging Observations

The analysis presented in the previous section shows that the selected candidate variables are not dom inated by spurious sources. Here we obtain a quantitative estim ate of the selection e ciency using repeated SD SS in aging data. For about 10% of the sky area analyzed here (the SD SS southern equatorial strip, see York et al. 2000), there exist between 6 and 9 epochs of SD SS in aging, obtained over a period of four years. Both due to a larger number of epochs and to more accurate photom etry (0.02 m ag, for details see Ivezic et al. 2003b), these data have a much higher com pleteness and e ciency for discovering variable sources than the photographic/SD SS presented here. We select variable sources from repeated SD SS scans by requiring an rm s variability larger than 0.03 m ag in the g band. This selection results in a negligible fraction of spurious candidates (< 1%), a high com pleteness (for example, more than 90% for RR Lyrae stars), and is also sensitive to long-period variables and quasar variability. About 7% of point sources brighter than g = 19 pass the adopted selection cut (for details see Ivezic et al. 2004, in prep).

U sing the SD SS-D PO SS G-band candidates selected by relaxed criteria (see entry 5 in Table 3), we nd that repeated SD SS scans (at least 6 epochs) exist for 955 sources. About half of these (49%) are con m ed as variable by SD SS data. The SD SS-PO SS candidate variables not con m ed as variables by multi-epoch SD SS data tend to be at the faint end and have sm aller SD SS-PO SS magnitude di erences than the con m ed variables. Thus, the sample e ciency can be further increased by a more restrictive selection requiring g < 19 and other cuts listed as entry 7 in Table 3. This selection results in 51 SD SS-D PO SS candidate variables with multi-epoch SD SS data; 73% are con m ed as variable. The distributions of con m ed and spurious SD SS-D PO SS variables in SD SS color-color diagram s are com pared in Fig. 17. It is not surprising that m ost of the spurious SD SS-D PO SS variables are found in the stellar locus, because for a given contam ination fraction (which is not expected to be a strong function of color) m ost of the contam inants com e from the m ost populated part of the diagram . Repeating this analysis separately for sources from inside and outside the stellar locus, we nd that the fraction of true variable sources am ong the selected candidates from the locus it is as

high as 94%. A sum ing that no more than 10% of sources from the locus are truly variable, the form er fraction in plies that the decision to tag a source as a candidate variable is correct in more than 95% of cases (for g < 19).

3.2.3. The Large-am plitude Variables and Visual Comparison of Im ages

The presum ed large amplitude variables (> 1 m ag) m ay be m ore likely to be spurious (e.g. due to various defects on photographic plates). This possibility cannot be robustly tested using m ethods from the previous section due to insu cient number of sources. On the other hand, presum ed variations with such a large amplitude can be tested by the visual comparison of SD SS and PO SS in ages. The distribution of 70 SD SS-D PO SS candidates with 0:7 < G < 1 and 24 candidates with 1 < G < 3 in SD SS color-color diagram s is shown in Fig. 18. As evident, their distribution does not follow the distribution for the reference sample, indicating that they are not dom inated by spurious candidates. W e have visually inspected PO SS and SD SS in ages for these 94 candidates and found that only

30 m ay have been a ected by nearby bright stars. A dditional visual inspection of large am plitude variables selected using the USNO-A2.0 catalog recovered a spectacular case shown in the top panel in Fig. 19. A fter analyzing the plate print, as well as the brightness pro les, we concluded that the two bright POSS sources were an artefact¹⁸ (probably caused by splattered liquid on the POSS plate). W hile this is a disappointing outcom e, it, nevertheless, vividly demonstrates the ability of the selection m ethod to recognize di erences between POSS and SDSS data. Another example of a spurious candidate is shown in the bottom panel in Fig. 19. Due to a nearby star, which happened to be a large proper m otion object, the candidate's POSS photom etry was noticeably a ected, while the m ore accurate SDSS photom etry reported a single object with a correct m agnitude.

D espite these pitfalls, the SD SS-PO SS com parison does yield true large am plitude variables. For example, one of the sources with an SD SS-PO SS magnitude di erence of 2 m ag is in the region multiply observed by SD SS (12 epochs). The available SD SS data demonstrate that it is a long-period variable with a peak-to-peak am plitude exceeding 5 m ag (Ivezic et al. 2004, in prep). This star, and another example of a large-am plitude variable, are shown in Fig. 20.

4. The M ilky W ay H alo Structure Traced by C and idate R R Lyrae Stars

As recently shown (Ivezic et al. 2000, V ivas et al. 2001, Ivezic et al. 2003cd), faint RR Lyrae stars have a very clum py distribution on the sky (most prominent features are associated with the Sgr dwarf tidal stream). This substructure of ers a test of the spatial hom ogeneity of the selection algorithm : the known clum ps ought to be recovered to some extent by the candidate RR Lyrae stars selected here, if the selection algorithm is robust. Furtherm ore, if such robustness can be dem onstrated, the SD SS-PO SS candidates can be utilized to quantify the halo substructure in the areas of sky for which multi-epoch SD SS data do not exist.

4.1. The u g C olor D istribution of C and idate R R Lyrae Stars

Before proceeding with the analysis of spatial distributions of candidate RR Lyrae stars, we test their selection robustness using a method introduced¹⁹ by Ivezic et al. (2000). RR Lyrae stars have somewhat redder u g color (0.2 mag) than stars with similar e ective tem perature (i.e. g r color) that are not on the horizontal giant branch. Since the u band ux is not used in the selection of variable objects (all POSS bands are redder than the SD SS u band), this o set is a robust indication that the candidate variables are dom inated by true RR Lyrae stars. Fig. 21 com pares the u g color distribution for candidate variable objects to the distribution for all sources in a narrow q r range (0 to 0.05, designed to exclude the main stellar locus). As evident, the selected candidates g color than the full sample, in agreem ent with the color distribution of have redder u RR Lyrae selected using light-curves obtained by the QUEST survey (Ivezic et al. 2003a). The di erence is more pronounced for the selection in blue bands (because the variability am plitude decreases with wavelength), and som ewhat more pronounced for the GSC catalog than for the DPOSS catalog. The counts of selected candidates are consistent with the conclusion from the previous section that the decision to tag a source as a candidate variable is correct in more than 95% of cases.

We determ ined the selection completeness for RR Lyrae stars using a complete sample of 162 RR Lyrae stars discovered by the QUEST survey and discussed by Ivezic et al. (2003a). We nd that 32 (20%) of these stars are recovered by the relaxed DPOSS G band selected sample.

4.2. The Spatial D istribution of C and idate R R Lyrae Stars

U sing the relaxed DPOSS G-band selected sample (GSC-based selection performs better, but the public catalog is not deep enough to probe the outer halo), we isolate 628 RR Lyrae candidates by adopting color boundaries from Ivezic et al. (2003a). The magnitude-position distribution of 350 candidates within 5 deg. from the Celestial E quator is shown in Fig. 22. The sample completeness is fairly uniform for r < 19 and decreases with r towards the selection faint limit of r = 19.5 (corresponding to 60 kpc). The clumps easily discernible at ($_{2000}$,r) (210,19.2) and at (30,17) are associated with the Sgr dwarf tidal stream. The clumps at (180,17) and at (330,17) have also been previously reported (V ivas et al. 2001, Ivezic et al. 2003c). The recovery of these known structures suggests that the clump at (235, 15.5), which has not been previously reported, is a robust detection. A nother previously unrecognized clump is detected around $_{2000}$ 240 and $_{2000}$ 50 (see Fig. 23). The signi cance of these new ly recognized structures will be placed in a broader context of other available data elsewhere (Ivezic et al., 2004, in prep.).

5. The Long-term Variability of Quasars

The optical continuum variability of quasars has been recognized since their rst optical identi cation (M atthews & Sandage 1963), and it has been proposed and utilized as an e cient m ethod for their discovery (van den Bergh, Herbst, Pritchet 1973; Hawkins 1983; Hawkins & Veron 1995; Ivezic et al. 2003e). The observed characteristics of the variability of quasars are frequently used to constrain the origin of their emission (e.g. Kawaguchi et al. 1998, and references therein; M artini & Schneider 2003).

Recently, signi cant progress in the description of quasar variability has been m ade by employing SD SS data (de Vries, Becker & W hite 2003, hereafter dVBW ; Vanden Berk et al. 2004, hereafter VB). The size and quality of the sam ple analyzed by VB (two-epoch photom etry for 25,000 spectroscopically con m ed quasars) allowed them to constrain how quasar variability in the rest fram e optical/UV regim e depends upon rest fram e tim e lag, lum inosity, rest wavelength, redshift, the presence of radio and X-ray em ission, and the presence of broad absorption line out ow s. However, the tim e lags probed by the available SD SS data (up to 3 years) are too short to detect deviations of the structure function (the root-m ean-square scatter of m easured m agnitudes, see Eq. 1 in dVBW) from a sim ple power-law that are expected for long tim e lags (C id Fernandes, Sodre, & V ieira da Silva 2000, and references therein).

The much longer time lags between POSS and SDSS (50 years in the observer's

fram e) o er the possibility of detecting such deviations, despite larger photom etric errors for the POSS catalogs, and to study the long-term characteristics of quasar variability. U sing a recalibration approach similar to the one described here (except that only elds around known quasars were recalibrated), dVBW studied long-term variability for 3,791 quasars from the SDSS Early D ata R elease (Stoughton et al. 2002). Here we have assembled a larger sample of SDSS quasars (17,000, Schneider et al. 2003), which allows us to constrain the overall shape of the m_{SDSS} m_{POSS} distribution and not only its root-m ean-square scatter, as discussed in the next section. The dependence of the long-term quasar variability on lum inosity, rest-fram e wavelength, and tim e lag is analyzed in the subsequent section.

5.1. The D istribution of SD SS-POSS M agnitude D i erences for Q uasars

A nalysis of the multi-epoch SD SS in aging data suggests that the distribution of m for quasars is better described by an exponential distribution than by a Gaussian distribution, for all bands (ugriz) and time scales probed (up to 4 years time lag in the observer's frame). This result is independent of whether the data are binned by wavelength and time lag in the rest or observer's frame (Ivezic et al. 2004, hereafter IO4, in prep). Here we investigate whether this result can be reproduced for much longer time lags using SD SS-PO SS measurements.

Fig. 24 shows the magnitude di erence distributions for stars and spectroscopically con med quasars with redshifts in the range 0.3 < z < 2.4, measured using GSC, DPOSS, and USNO-A2.0 catalogs. The distributions for quasars are marked by triangles, and those for a control sample of stars with the same magnitude distribution²⁰ are marked by solid circles.

The dashed lines in Fig. 24 show exponential distributions that have the same rm s scatter as the data (the rm s for each distribution are shown in the panels, and also listed in Table 5), and the dot-dashed lines show G aussian distributions, both convolved with a G aussian of the same width as the distribution of magnitude di erences for stars. W hile the data presented here do not constrain the tails of the m distributions as well as multi-epoch SD SS data (due to larger photom etric errors), the obtained magnitude distributions are

consistent with the inferences made using multi-epoch SDSS data. Typically, 1% of the sample is outside the 3 boundaries, a fraction about a ve times larger than expected for a Gaussian distribution. While form ally signicant, it is possible that the remaining calibration problem swith POSS catalogs have contributed to this deviation from a perfect

Gaussian distribution. In any case, the deviations are su ciently small for the rm swidth

to be an e cient statistic for describing the observed distributions.

These observed rm s values, listed in Table 5, are 1 (0.05-0.10 m ag) sm aller than the values obtained by dVBW. The photom etric errors (i.e. structure function for stars) displayed in Fig. 8 from dVBW correspond to the sm aller of the two curves shown in their Fig. 4. A dopting the other curve decreases the estim ate of the quasar variability as m easured by dVBW, and thus decreases the discrepancy with our results to a <1 level. It is noteworthy that the m agnitude di erence distributions for stars shown in Fig. 24 have sm aller rm s values than do the structure functions for stars shown in Fig. 4 from dVBW (our values correspond to log(SF) -0.65 or less). Thus, it is plausible that the remaining slight discrepancy is due to som ewhat di erent procedures used to recalibrate PO SS catalogs.

5.2. The Turn-over in the Structure Function

The extrapolation of the power-law dependence of the quasar m s variability on time m easured at short time scales using repeated SD SS in aging (IO4) predicts that the quasar m s variability m easured using SD SS and PO SS I should be of the order 0.60 m ag, and 0.35 m ag for SD SS-PO SS II. Since the m easured values (see Table 5) are sm aller than these extrapolated values, they present strong evidence for a turn-over in the quasar structure function.

Fig. 25 shows the dependence of structure function on rest-fram e time lag, in the range 2000{3000 A, for two data sets: SD SS-SD SS for short time lags (sm all sym bols, IO4; note that the variability inferred from repeated imaging scans is fully consistent with the results presented by VB, that were based on a comparison of imaging and spectrophotom etric m agnitudes), and SD SS-PO SS for long time lags (large sym bols). The extrapolation of the power law measured for short time scales (dashed line) clearly overestim ates the amplitude of the structure function reported here. We t the observed dependence of structure function on rest-fram e time lag using the follow ing functional form

The best t parameters are D = 0.32 0.03, = (390 80) days, and = 0.55 0.05.

This best-t is shown in Fig. 25 by the dot-dashed line. We conclude that the characteristic time scale for optical variability of quasars is of the order 1 year in the rest frame. We postpone a more detailed analysis to a forthcom ing paper.

5.3. The Dependence of Long-term Variability on Lum inosity, Rest-fram e W avelength and Time Lag

The distribution of time di erences in the observer's frame for SD SS-PO SS variability measurements is strongly bimodal (10 years for SD SS-PO SS II and 50 years for SD SS-PO SS I comparison). However, the distribution of time lags measured in the quasar rest-frame is more uniform due to a wide distribution of redshifts (the 1 + z e ect; for a discussion, see dVBW). The same e ect also widens and attens the distribution of rest-frame wavelengths. For the data discussed here, the rest-frame time lags span the range 1,200-13,500 days, and the rest-frame wavelength is limited to the range 1,400-4,800 A (using the bluest two bands in each survey).

In this section we investigate whether the correlations of variability with lum inosity and rest-fram e wavelength observed for short time lags (VB, IO4) are valid for long time lags. In particular, we exam ine whether the decrease of variability with lum inosity and wavelength, and increase with time, are observed for large time lags.

The dependence of variability on num erous relevant parameters complicates the analysis, and has resulted in many condicting results in the literature (for a sum many see G iveon et al. 1999). Furthermore, many of these parameters are highly correlated in ux-limited quasar samples due to steep quasar \counts" (the dimensional apparent magnitude distribution). Nevertheless, the sample considered here is su ciently large that some of these degeneracies can be lifted by simple binning, similarly to the analysis described by VB.

The top left panel in Fig. 26 shows the distribution of 7,279 quasars with i < 19, $G_{SDSS} < 19$, and redshifts in the range 0.3 < z < 2.4, in the redshift vs. i band absolute m agnitude plane (M_i, computed using the W MAP cosm ological parameters, _m = 0.27,

= 0:73, h = 0:71, and K-corrected using F / $^{0.5}$). Their distribution in the M $_{\rm i}$ vs. rest-fram e wavelength plane is shown in the top right panel (the two overlapping distributions arise from the two POSS bands used in this analysis, O and E for POSS I, and G and R for POSS II).

We decouple the variability dependence on absolute magnitude and rest-frame wavelength by computing the structure function for objects selected in narrow bins, shown in the top right panel in Fig. 26 by short-dashed lines (two bins with nearly constant M_i) and long-dashed lines (three bins with nearly constant). The symbols in each strip are used to mark the corresponding histograms in the lower four panels. The dependence of the structure function on rest-frame time lag is essentially the same as its dependence on rest-frame wavelength because the ratio of these two quantities is nearly constant (t_{RF} C $_{RF}$), with C 0.8 days/A for SD SS-PO SS II data, and C 3.2 days/A for SD SS-PO SS I data (that is, $_{RF}$ in the two lower right panels in Fig. 26 is nearly equal to t_{RF} =C).

The middle left panel shows the dependence of the structure function (com puted using the de nition from dVBW, and corrected for measurement errors) on M_i for SDSS-POSS II m agnitude di erences. The DPOSS bands (we used G and R bands in this analysis) produce consistent results, which agree well with the correlation SF / 1+ 0.024 M_i (shown by the line), inferred by IO4 from repeated SDSS in aging scans.²¹ The middle right panel shows the dependence of the structure function on the rest-frame wavelength. The data are fully consistent with a constant value, shown by the dashed line (0.24 m ag, m edian of all the points). This behavior is in contrast with the relationship SF / ^{0:3}, derived from repeated SDSS II sample between rest-frame wavelength and time lag | the increase of variability with time for the rest-frame time lags probed (1300-3400 days) o sets its decrease with rest-frame wavelength.

This e ect is expected to be much weaker in SD SS-PO SS I data due to a turn-over in the quasar structure function discussed in the previous section. Indeed, as the bottom two panels demonstrate, while the dependence of variability on M_i is still reproduced (albeit with larger errors), the variation of structure function with wavelength is consistent with SF / $^{0:3}$. Note that we did not correct the data points for the system atic residual dependence on rest-fram e wavelength in the two bottom left panels (the correction is 0.03 m ag for the two edge bins, relative to the middle one), and on absolute m agnitude in the two bottom right panels (relative o set between the two bins is 0.02 m ag). We conclude that there is no evidence that the dependence of the structure function on lum inosity and rest-fram e wavelength is di erent for long time lags discussed here (4-40 years in the rest fram e) than for shorter time lags (VB, IO4). A more detailed analysis of these data is postponed to a future publication.

6. Discussion

W e present a direct com parison of photom etric m easurem ents available in public POSS catalogs. The most accurate photom etry is provided by the GSC22 catalog. The results of photom etric recalibration based on a dense grid of calibration stars m easured by the SDSS demonstrate that errors in POSS photom etry can be reduced by about a factor of two. POSS Im agnitudes can be brought to 0.15 m ag accuracy, and POSS II m agnitudes to 0.10 m ag accuracy. W hile these apparently irreducible errors are considerably larger than those delivered by m odern CCD data (0.02), the POSS catalogs are, nevertheless, invaluable for studying sources variable on long time scales. A particular success of the recalibration m ethod is that the resulting error distribution for POSS photom etry is nearly G aussian, which greatly helps in the design of robust algorithm s for selecting candidate variable sources.

We designed and tested algorithms for selecting candidate variable sources using POSS and SDSS photom etric measurements. The algorithm's decision to tag a source as a candidate variable is correct in more than 95% of cases. The selection criteria can be tuned up to result in samples that contain no more than 30% of spurious candidates.

This is the study that examined the distribution of sources variable on long time scales in SDSS color-color diagrams. Even with the fairly large cuto s for selecting candidate variables (0.20-0.35 m ag), we not that at least 1% of faint optical sources appear variable. About 10% of the variable population are quasars, although they represent only 0.25% of all point sources (for g < 19).

Using a sample of 17,000 spectroscopically con med quasars, we demonstrate that the power-law increase of the quasar variability (structure function, m s) with time lag observed for short time lags cannot be extrapolated beyond a few years in the rest frame $\{$ such extrapolation predicts a variability level signi cantly larger than measured (0.35 vs. 0.60 m ag for SD SS-PO SS I, and 0.24 vs. 0.35 m ag for SD SS-PO SS II). The implied turn-over in structure function indicates that the characteristic time scale for optical variability of quasars is of the order 1 year in the rest fram e. The long-term (> 1 year) quasar variability decreases with lum inosity and rest-fram e wavelength similarly to the short-term (< 1 year) behavior.

A particularly valuable result of com paring POSS and SDSS catalogs is the selection of candidate RR Lyrae stars, which are excellent probes of the M ilky W ay's halo structure. W e dem onstrated that the known halo substructures are recovered by the selected candidates, and discovered several new features. This m ethod will eventually yield several thousand RR Lyrae candidates.

Our study also revealed some limitations of the POSS catalogs. In particular, we had to limit our search for variable sources to only isolated point sources detected by both POSS and SDSS. Attempts to nd sources detected by only one survey, or variable sources that are blended with another nearby source, were unsuccessful due to overwhelm ingly large num bers of false positives.

D espite these shortcom ings, the assem bled catalogs of candidate variable sources o er a good starting point for further analysis and follow -up observations. For exam ple, light curves and spectra for selected candidates could be obtained even with telescopes of m odest size. Such additional data would help im prove candidates' classi cation beyond inform ation provided by SD SS colors. A nother potentially interesting research direction is positional cross-correlation with catalogs obtained at other wavelengths (e.g. RO SAT, 2M A SS, IRAS). For exam ple, long-period variables such as M ira and other AG B stars are typically strong infrared em itters, and thus could be e-ciently separated from the rest of candidate variables.

This study once again dem onstrates the importance of maintaining a careful archive of astronom ical observations; the data may be valuable long after the acquisition technology becomes obsolete.

Appendix A: An Overview of POSS Catalogs U sed in This W ork

USNO catalogs

USNO-A2.0 is a catalog of 526,280,881 stars, based on a re-reduction of the Precision Measuring Machine (PMM) scans of Palom ar Observatory Sky Survey I (POSS-I; Minkowski & Abel 1963) O and E plates, the UK Science Research Council SRC -J survey plates, and the European Southern Observatory ESO -R survey plates. For eld centers with > 30, data com e from POSS-Iplates, while data for eld centers with < 35 com e from SRC-J and ESO-R plates. USNO-A2.0 catalog uses the ICRF as realized by the USNO ACT catalog (Urban et al. 1997), and in addition to source coordinates, it lists the blue (O) and red (E) m agnitudes for each object. The USNO-B catalog (M onet et al. 2003), currently released in version 1.0, is the next in a sequence of catalogs produced²² by the USNO team . It is an all-sky catalog with positions, proper motions, magnitudes in di erent optical bands (O, E, J, F, N), and star/non-star estimator for aprox. 1 billion objects. Beside the st epoch surveys (POSS-I, ESO-R, SRC-J), it also utilizes the second epoch surveys: POSS-II for eld centers with > 30, and SES (South Equatorial Survey) for < 35 (Reid et al. 1991). It is fairly complete to V = 21, with the claim ed astrometric accuracy of $0.2^{\circ\circ}$ (J2000), photom etric accuracy of 0.3 m ag, and 85% accuracy for distinguishing stars from non-stellar ob jects.

The Guide Star Catalog

The GSC II (M cLean et al. 2000) is an all-sky catalog based on scans of the photographic plates obtained by the Palom ar and UK Schmidt telescopes. Schmidt plates for both the Northern (POSS-II) and Southern (SES) hem isphere surveys were digitized on the GAMMA scanning machines. Positions, magnitudes, and classi cations are produced for all objects on each plate and the data is stored in the COM PASS database. The GSC 22 catalog is an all-sky, magnitude-selected export of calibrated source parameters from the COM PASS database, com plete to F = 18.5 m ag and J = 19.5 m ag. It uses 1000 objects per plate for astrometric calibration, resulting in errors in the range $0.2\{0.25 \text{ m}$ ag. The number of unique objects exported is approximately 456 m illion²³.

Digital Palom ar Observatory Sky Survey (DPOSS)

The Digital Palom ar Observatory Sky Survey (DPOSS; Djorgovski et al. 1998) is a digital version of the Second Palom ar Observatory Sky Survey (POSS-II), based on the plate scans done at ST ScI, CCD calibrations done at Palom ar, and processing done at Caltech. DPOSS consists of the original in age database (3 TB of pixel data) and the derived catalogs and m etadata, prim arily the Palom ar-N orris Sky C atalog (PNSC). DPOSS is a survey of the northern sky (> 3), in 3 bands (photographic J;F;N, calibrated to g; r; i; note that we use upper case letters for DPOSS m agnitudes to distinguish them from SD SS m agnitudes), with typical limiting m agnitudes G 21 21:5,R 21, and I 19:5 mag. A courate star-galaxy classi cation is available for all objects to 1:5 m ag above 1 the detection $\lim it^{24}$. The initial data release covers the high G alactic latitudes. The nal catalog is expected to contain about 50 m illion galaxies and a billion stars.
