ON THE NATURE OF THE UNIDENTIFIED MEV GAMMA-RAY SOURCE GRO J1411-64

ABSTRACT

A recent analysis of COMPTEL data has revealed the existence of an unidenti ed and variable gam m aray source, designated GRO J1411-64, at M eV energies in the galactic plane (Zhang et al. 2002). W e discuss the possibility that such a source can be produced in the accreting neutron star system 2S 1417-624 through the bom bardm ent of the accretion disk by relativistic protons accelerated in the m agnetosphere by the Cheng-Ruderm an m echanism.

Key words: Gamma ray sources: unidenti ed; neutron stars; X-ray binaries.

1. INTRODUCTION

In a recent communication, Zhang et al. (2002) have reported the discovery of a new source near the galactic plane in the COMPTEL data of the Compton G amma-RayObservatory (CGRO). The source is detected at 7.2 level in a combination of 7 viewing periods (VP) of the satellite, during 1995. The total e ective exposure during Phases 1 to 5 of CGRO was ofmore than 35 days. The new source is clearly variable in the 1-3 M eV band on timescales of months. The maximum ux in this energy range is 20 10 ⁵ ph cm ² s ¹ (0:3 Crab). The spectrum can be represented by a simple power law with a photon index = $2:61^{+0:33}_{-0:30}$.

The clear variability of the source indicates that it should be a compact object. Zhang et al. (2002) have searched for possible counterparts within the error location contours of the COMPTEL detection. There are several interesting objects in this region of the sky, including two high-velocity clouds (HVC), two radio pulsars, two W olffRayet (WR) stars, one transient black hole binary, and a Be/X -ray transient source. The variability and the soft MeV spectrum of the source rules out the pulsars, which are typically non-variable and hard sources, and strongly constrain the presum ed em ission region in the HVC. The W R stars are potential M eV em itters if they are colliding wind binaries. Benaglia & Romero (2003) discuss in detail how these kind of stars can generate MeV sources when they are in binary systems. In the present case, however, there is no evidence for binarity. Variable M eV em ission from m icroquasars has also been recently discussed by Romero et al. (2002) in connection to Cygnus X-1, and remains as an open possibility for GRO J1411-64 (see also the microquasar models discussed by Romero et al. in these proceedings). Here, we will focus on the possible gam m a-ray em ission from accreting neutron star system s like 2S 1417-624, which is the Be/X -ray transient source within the COMPTEL error location contours, in an attempt to establish whether this is a likely counterpart.

2. GAMMA-RAY PRODUCTION IN ACCRETING NEUTRON STARS

Be/X -ray transients are binary systems form ed by a massive Be star and a magnetized neutron star in an eccentric orbit. Be stars are rapidly rotating objects with strong equatorial winds. The neutron star can accrete directly from the circum stellar Be wind to form a transient accretion disk during a periastron passage. Such disks have been found in systems slike A 0535+26 through the detection of quasi-periodic oscillations in the power spectrum of the X-ray ux (e.g. Finger et al. 1996a). The parameters that characterize the disk will change as the neutron star m oves along the orbit. Eventually, at som e distance that will depend on the speci c system considered, there m ight be a change in the accretion regime from disk accretion to B ondi-H oyle accretion.

O noe formed, the accretion disk can penetrate the magnetosphere of the rotating neutron star (G osh & Lam b 1979). This penetration creates a broad transition region between the unperturbed disc ow and the co-rotating magnetospheric ow. In this transition zone, at the inner radius R_0 the angular velocity is still Keplerian. Between R_0 and the co-rotation radius R_{co} there is a thin boundary layer where the angular velocity departs from the Keplerian value. At

electrom agnetic cascades in the disk. The emerging gam m a-rays, on the other side of the disk, can be also degraded in the X-ray photosphere to M eV energies before reaching the observer.

 $R_{\rm co}$ the disc is disrupted by the magnetic pressure and the matter is channeled by the magnetic eld lines to the neutron star polar cap, where it in pacts producing hard X -ray em ission.

Cheng & Ruderm an (1989, 1991) have studied the m agnetosphere of accreting neutron stars when the disk rotates faster than the star, showing that three de nite regions are form ed: 1. A region coupled to the star by the magnetic eld lines that do not penetrate the disk, 2. An equatorial region linked to the disk by the eld attached to it, and 3. A gap entirely empty of plasm a separating both regions. In this gap E B 🗧 0 and a strong potential drop V is established (see Fig. 1 for a sketch of the situation). For typical parameters in Be/X-ray binaries, 10 13^{13} V (R om ero et al. 2001). Protons V entering into the gap from the stellar co-rotating region will be accelerated to multi-TeV energies and directed to the accretion disk by the eld lines, where they will impact producing and ⁰ in pp interactions with the disk material. These pions will decay inside the disk producing electron-positron pairs, high-energy (TeV) photons, and neutrinos. The neutrinos will escape from the system (see Anchordoquiet al. 2003 for estimates of the neutrino ux), but the pairs and the gam m a-rays initiate electrom agnetic cascades that will degrade the energy of the gam ma-ray photons to form a standard cascade spectrum with a cut-o at MeV energies. The leptons in the disk will lose energy by inverse C om pton (IC) interactions with the therm al X-ray photons,

by synchrotron radiation in the eld that penetrates the disk, and by relativistic B rem sstrahlung in the ions of the accreting gas. The details of the cascade developm ent will be determ ined by the relative ratios of the cooling times am ong all these processes and the opacities for the produced photons in the speci c cases.

3. THE SYSTEM 2S 1417-64

The X-ray source 2S 1417-64 was discovered by Apparao et al. (1980) using the SAS-3 satellite. Fourier analysis of these data revealed the presence of pulsations with a period of 17:63 sec. Observations with the Einstein satellite and optical telescopes led to the detection of a Be star companion (Grindlay et al. 1984). The distance to the system is not well determined due to the uncertainties in the spectral type; it might be in the range 1.4{11.1 kpc. The source was detected by BATSE (Finger et al. 1996b) and by RXTE (Inam et al. 2004). Large outbursts followed by a series of m in ibursts were reported, a behavior sim ilar to what is observed in A 0535+26. The orbital period and the eccentricity of the system are P = 42:19 days and e = 0:446, respectively (Inam et al. 2004). The X-ray data are consistent with the form ation of a transient accretion disk during the outbursts. The larger outbursts last about two orbital periods, starting immediately after the periastron passage. During these outbursts the circum stellar disk of the Be star should expand in such a way that it can provide matter to the neutron star to form a transient accretion disk when the periastron interaction occurs. The density of the circum stellar disk dim in ishes during the m in i-outbursts, in such a way that the accretion rate is smaller and the accreting material is replenished with each passage until the disk retracts completely. The soft, unpulsed X -ray em ission is originated in the therm al disk, whereas the pulsed hard X -rays are from matter in pacting onto the neutron star polar cap.

4. SPECIFIC MODELS

In order to study the gamma-ray production in 2S 1417-62 during the accretion disk phase, we adopt the following values for the basic parameters of the system : $M_{NS} = 1:4 M$, $R_{NS} = 10^{6} \text{ cm}$, $B = 10^{12}$ = 0.2, which correspond to the neutron G, and starm ass, radius, surface dipole magnetic eld, and screening factor of the eld in the disk (= 0 corresponds to a perfectly diam agnetic disk), respectively. W ith these param eters and the X-ray history of the m a proutburst reported by Finger et al. (1996b) we calculate the structure of the accretion disk (Shakura & Sunyaev 1973, Gosh & Lam b 1979) and the magnetosphere (Cheng & Ruderm an 1991) as a function of time. Since the distance to the source is unknown, we calculated three di erent models corresponding to peak lum inosities of the major outbursts of 10^{37} ,

Models with screening factor $\eta = 0.2$

 $5 \ 10^{36}$ and 10^{36} erg s 1 . For each model we then estim ated the proton current in pacting onto the accretion disk surface, taking into account photo-pion and curvature radiation losses during the acceleration process (the proton losses resulted negligible in all models). Then we calculated, for di erent times of the outburst, the averaged pair cascades initiated in the disk and the opacities for the propagation of the emerging gam ma-ray photons in the am bient X ray elds once they escape from the disk. These results are brie y discussed in the next section.

5. RESULTS

In Fig. 2 we show the main parameters that characterize the accretion disk along the evolution of a major outburst. The di erent curves in each plot correspond to models with di erent peak lum inosities, namely $L_{peak} = 1, 0.5$, and 0.1, in units of 10^{37} erg s¹. In Fig. 3 we show the evolution of the photon density inside the disk and the energy of the gap-accelerated protons that impact onto the disk surface. These protons have energies in the ranges 110{350 TeV and 10{70 TeV for the most and least lum inous models, respectively. A nother panel of the gure shows the optical depth of the disk to proton propagation. It is clear that the disk is always opaque to the relativistic protons. The gam ma-ray

lum inosity produced by ⁰-decays can be as high as $5 \ 10^{35}$ erg s ¹ for the model with $L_{peak} = 1$. The energy of these gam marrays will be in the range 20{60 TeV. The disk is mostly opaque to the propagation of these photons. The models with disks of smaller column densities are partially transparent. The emerging very high energy gam marray ux (see last panel of the gure) can be detected in all cases by the new generation of imaging Cherenkov telescopes, for reasonable distances. The source, of course, should be observed during a major outburst.

Those gam ma-rays that are absorbed in the disk by photon-photon pair creation initiate electrom agnetic cascades. Cascades are also initiated by the e - pairs injected through the decay of . The rst generation of pairs mainly cools by synchrotron and B rem sstrahlung radiation. In Fig. 4 we show the ratio of synchrotron to B rem sstrahlung cooling times for these particles. Since the medium is still opaque to the second generation gam ma-rays, there willbe a second, and then a third generation of e -pairs, that will cool mainly by relativistic B rem sstrahlung. The gam ma-rays that escape from the opposite side of the accretion disk willbe injected into the X-ray photon

eld of the disk where they will be absorbed initiating an IC cascade that will degrade their energy to the soft M eV band. In Fig. 5 we show the opacity of the X-ray eld as a function of energy for t = 0, in the case of $L_{peak} = 1$. This eld is the addition of the soft blackbody disk component plus a hard X -

ray component from the pulsar's polar cap that we have modeled as a power-law with index = 1 and an exponential cut-o at kT = 200 keV. It can be seen that the G eV em ission is completely suppressed. This leads to the absence of an EGRET source in this case. Only in the model with $L_{peak} = 0:1$ the G eV gam ma-rays can escape, and this only when the disk is close to its minimum luminosity.

The M eV photons can always escape from the system. This emission will be variable because of the evolution of all relevant parameters along the orbit. The nal cascade spectrum will be soft, with an index 2:5 and a high-energy cut-o around $2m_e^2c^4=hE_{\rm ph}i$, where hE phi is the mean photon energy of the ambient elds (see A haronian et al. 1985 for further details on cascades in accretion disks).

W e see, then, that several characteristics of the M eV gam m a-ray source can be explained under the assumption that 2S 1417-64 is the counterpart: soft M eV spectrum, variability, and absence of EGRET detection. However, there are other features of the m odel that are di cult to reconcile with the observational data: correlation with the X-ray variability (which is expected at M eV energies, contrary to what happens at G eV energies) and a ratio f = $L_X = L > 1$. In fact, for all models we expect

f 10, instead of the observed f 1. The value of f m ight be m odi ed by a di erent assumption of the magnetic eld in the neutron star, but the dependence is not strong.

6. CONCLUSIONS

Integral observations are crucial to establish the nature of the enigm atic source GRO J1411-64. Our m odels for the accreting neutron star 2S 1417-62 indicate that it m ight be a variable M eV source with a total gam m a-ray lum inosity of 10^{36} erg s 1 when the accretion disk is fully formed in models with a disk lum inosity of 10³⁷ erg s¹ (a weaker source is predicted by the other cases studied here). W hether the MeV ux can be detected depends on the distance to the source, which is unknown. If the suggested existence of anti-correlation between the M eV and the X-ray radiation is con med (Zhang et al. 2002), 2S 1417-62 m ight be ruled out as counterpart since this anti-correlation should exist only with the em ission above 100 M eV, due to opacity e ects in the photosphere. In all cases a signi cant TeV source is expected. Depending on the disk density this source can be highly variable or roughly steady during a major outbursts. In some models the TeV emission is anti-correlated with the X-ray lum inosity, as it is shown in the last panel of Fig. 3. Sources of this kind might be detectable with modern Cherenkov telescopes (Cheng et al. 1991).
