Abstract

We propose a new mechanism for magnetic eld generation from in ation, by which strong magnetic elds can be generated on cosm ological scales. These elds may be observable by cosm ic microwave background radition measurements, and may have a dynamical impact on structure formation. The mechanism is based on the observation that a light nearly minimally coupled charged scalar may be responsible for the creation of a negative photon mass-squared (provided the scalar eld coupling to the curvature scalar is small but negative), which in turn results in abundant photon production { and thus in grow ing magnetic elds { during in ation.

I. COSMOLOGICALMAGNETIC FIELDS

There is a growing evidence that magnetic elds permeate intergalactic medium [1, 2, 3, 4]. The galactic dynamom echanism [5] represents the standard explanation, according to which small seed elds in protogalaxies are magnied to a microgauss strength correlated on kiloparsec scales observed today in many galaxies. Yet the dynamo does poorly as regards to explaning the observed cluster elds, which are typically correlated over several kiloparsecs and can reach 10 microgauss strength. On larger scales the eld strength drops quite dramatically, and it is characterized by a negative spectral index between 1:6 and

2 4], consistent with the Kolm ogorov spectrum of turbulence.

The seed eld that fuels the dynam o, which am pli es the galactic (and possibly cluster) elds, has either prim ordial origin, or it was created by the B ierm ann battery mechanism, operative at the time of structure and galaxy form ation, when the Universe was about one billion years old [6, 7, 8]. The B ierm ann battery mechanism is operative in the presence of oblique shocks, which generate nonideal uid that violates proportionality between the gradients of pressure and energy density. Such a uid can produce the vorticity required for generation of seed elds, whose strength is typically of the order 10²⁰ gauss. While in the protogalactic environments these seed elds may be su ciently strong to fuel the galactic dynam o mechanism, whether they can be used to explain the observed cluster elds is a highly controversial question. Moreover, these elds may be insu ciently strong to explain the galactic elds observed in a couple of galaxies at higher redshifts [1, 2].

The quest for the elds correlated on much larger scales has so far been unsuccessful. A notable exception is the result of [9], where a local eld of about 10 8 gauss correlated on m egaparsec scale is quoted. If established, the existence of extragalactic elds would point at a prim ordial origin. Perhaps the most promising method for detecting prim ordial elds correlated over supragalactic scales is through their in pact on the cosm ic microw ave background radiation (CMBR) [10, 11], and possibly through their dynam ical in uence on large scale structure and galaxy form ation. The current upper bounds from the CMBR are of the order 10 9 gauss, while the bounds from structure form ation are som ewhat weaker. Fields stronger than about 10 5 gauss at the tim e of galaxy form ation (which correspond to about 10 9 gauss com oving eld strength) are dynam ically relevant.

In this Letter we propose a novel mechanism for generation of large scale magnetic elds

during cosm obgical in ation. O urm echanism is based on a model with a ratherm inim alset of assumptions: W e study the dynam ics of (one-bop) quantum scalar electrodynam ics [12, 13, 14, 15, 16] in cosm ological space-times, which can be naturally embedded into the Standard M odel (where the role of the scalars is played by the charged components of the Higgs eld), or into supersymmetric extensions of the Standard M odel (the charged scalars are the sypersymmetric partners of the Standard M odel ferm ions).

II. SCENARIO

We assume a standard model of the Universe, in which a period of in ation is followed by radiation and matter eras. The background space-time during in ation can be accurately approximated by the de Sitter metric, $g = a^2$ (= diag[1;1;1;1]) with the scale factor a = 1 = (H) (for $<_{H} = 1 = H$), where denotes conformal time, and H the in ationary Hubble parameter. A fler in ation the Universe undergoes a sudden transition to radiation domination, in which a = H (for $>_{H}$). When in ation lasts a su ciently long time, such that a de Sitter invariant solution is established, the dynamics of photons that couple to light scalar particles, which in turn couple nearly minimally to gravity, can be described by the Proca Lagrangian [12]

where $= e^2=4$ is the ne structure constant, $R = 12H^2$ is the curvature scalar of de Sitter space, m is the scalar mass and describes the coupling of the scalar eld to R. When $0 < m^2$ H² and 1=12 < 0, both s and m² can be negative. We emphasise that there is nothing patological about this lim it. Indeed, the de Sitter invariant (Feynman) scalar propagator i $_F$ (x;x⁰) G_F (y) in D = 4 reads [12]

where $y(x;x^0)$ ad $H^2 x^2(x;x^0)$ denotes the de Sitter invariant length, and $x^2(x;x^0) = (j \ ^0j \ i \ ^3) + kx \ x^0k^2$, ! 0^t, such that a negative smalls introduces negative, but nite, correlations, which are at the heart of the mechanism discussed in this Letter.

The Lagrangean (1) was derived in [12] by expanding in powers of jsj 1 the one-loop (order) nonlocal electric action written in the Schwinger-Keldysh formalism. In [12] we proved that, when written in the generalized Lorentz gauge ($a^2 = 0$ at the order 0 (; s⁻¹), the electric action reduces to the Proca theory (1).

Due to spatial hom ogeneity, the general solution for the photon eld of the Proca equation can be conveniently written as a superposition of spatial plane waves A $(x) = "(\tilde{k};)e^{j\tilde{k}}$, where $" = ("_0; ")$. Then $"_0$ is nondynam ical and just traces the spatial components. The spatial componets correspond to the three physical degrees of freedom, and can be decom – posed into longitudinal $"_{L,\tilde{k}}$ \tilde{k} $(\tilde{k}$ $") \in and$ transverse part $"_{T,\tilde{k}}$ $"_{L,\tilde{k}}$. III. VAN ISH ING CONDUCTIVITY

W hen conducitivity in radiation era is negligibly small, a smooth m atching of the in ationary epoch solution (5) to the radiation era m odes

This result is used below to calculate the magnetic eld spectrum in radiation era. Since matter era is a conform al space-time, the elds (as well as their spectra) in matter era are inherited from the radiation era elds (10).

IV. LARGE CONDUCTIVITY

An opposite extrem e is a sudden increase of conductivity in radiation era, which occurs for example in the case of a rapid therm alisation after in ation, resulting in a large (therm al) conductivity. To leading logarithm (squared) in the coupling constant, the evolution of the photon eld is then governed by the Bodeker-Langevin equation [19]

where T denotes the equivalent tem perature (average energy of the plasm a excitations). The factor a^3 , which multiplies ^T in Eq. (13), can be inferred from the fact that the transverse components of the current density are given by $j^T = E^T + T$, and from the transform ation properties of the conductivity and the electric eld. Eq. (13) can be easily integrated,

V. MAGNETIC FIELD SPECTRUM

W hen suitably averaged over a physical scale $\gamma_{ph} = a \gamma$, the magnetic eld operator can be de ned as

W hen conductivity is vanishingly small, the spectrum in radiation era can be calculated by inserting Eqs. $(10\{12)$ into (20). The result is (when a 1)

such that on superhorizon scales k 1 the spectrum (21) $P_B / k^{5/2}$, and on subhorizon scales the spectrum is oscillatory, with the envelope scaling as $P_B / k^{3/2}$. This spectrum is shown in gure 1 on a log-log plot. Note that scale invariance is reached for $_{at} = 5=2$ (superhorizon scales) $_{at} = 3=2$ (subhorizon scales).

In the limit of a large conductivity, the magnetic eld spectrum can be split into the contribution from thermal excitations, and the primordial contribution. A new scale arises in Eq. (17), associated with the momentum

which we refer to as the conductivity scale. The therm alspectrum can be inferred from (17): In the ultraviolet P_B^{th} / k^3 (k k), while in the infrared P_B^{th} / k^5 (k k), in plying that therm alexcitations give rise to elds of negligible strength on cosm obgical scales (see [17]). The primordial contribution to the spectrum can be obtained from Eqs. (11), (17) and (20),

such that the spectrum is exponentially cut-o when k > k. The at spectrum is reached for $_{at} = 5=2$ for k < k. This spectrum is shown in gure 2 on a log-log plot. Since typically in radiation era T H =a (a 1), k_{gh} k =a H (t) = H =a², in plying that a rapid grow th in conductivity after in ation freezes out large scales magnetic elds and destroys the small scales elds (electric eld spectrum is completely destroyed), such that no oscillations are present on subhorizon scales. Thus, the absence or presence of subhorizon oscillations, and observation of a conductivity scale, can be testing grounds for the conductivity history during radiation era.

VI. DISCUSSION

The spectrum (21) can be thought of as a function of the scalar coupling to gravity and its mass m, which are fundamental parameters characterizing a scalar eld. To illustrate

this point m ore precisely, we show the spectral index n = 3 2 characterizing the spectrum envelope of P_B / k^n in Eq. (21) on subhorizon scales, k=a > H (t) (or $B \cdot B^2 i^{1-2} / \cdot n^{-2}$ (n \in 0), $B \cdot / ln$ (') (n = 0) in Eq. (20)). Between $=_{crit}$ $m^2 = (12H^2)$ and $=_3$ (=) $m^2 = (12H^2)$, n = 3, equal to that of therm all spectrum. Above $>_3$, n drops, reaching an asymptotic value n ! $n_1 = 2$ when ! 1. The spectral index on superhorizon scales is obtained simply by replacing n + 2 ! n = 5 2. When compared with the vacuum spectrum, P_B^{vac} / k^4 (k < H), a spectrum with n 2 (2;3) exhibits an enhancement of magnetic elds on subhorizon scales, which is due to a conversion of the electric energy (which is enhanced during in ation) into them agnetic energy during radiation era. The conversion is e cient provided radiation era is characterised by a low conductivity. This mechanism was used in Refs. [12, 13, 14, 15, 16, 17, 18] to argue that a spectrum $B \cdot / \cdot {}^1$ can be obtained from in ation, which could be su cient to seed the galactic dynam o mechanism .

When 2 (1; $_{crit}$) however, gauge elds exhibit instability and are enhanced during in ation, such that the spectral index of subhorizon modes drops from n = 2 when ! 1, to at spectrum (n = 0), when

to n < 0, when 2 ($_{at}$; $_{crit}$). A negative spectral index n 2 would imply a growth in magnetic eld energy during in ation, resulting in a divergent magnetic (and electric) eld energy, as it can be inferred from Eqs. (21), (23) and (20), with W = 1. A proper study of this case would require an inclusion of backreaction of the electrom agnetic eld on the background space-time, which is beyond the scope of this Letter. A spectral index n > 2 on subhorizon scales (or n > 0 on superhorizon scales), results in an acceptable magnetic eld spectrum on cosm ological scales, whose dynam ical in pact on CMBR and large scale structure form ation should be considered.

Spectrum normalization today can be determined from magnetic eld strength at a comoving scale corresponding to the Hubble scale at the end of in ation (k = H). At the comoving in ation scale $_{\rm H}^{*}$ 3 m 10¹⁶ parsec (corresponding to H 10⁷ Hz 10³ GeV) the eld strength is about B_H 10¹² 10¹¹ gauss [20]. Therefore, if the spectrum is (almost) at, the magnetic eld is potentially observable by the next generation of CMBR experiments (PLANCK satellite), as well as of importance for the dynamics of large scale

structures of the Universe.
