# The D am ping W ing of the G unn-Peterson A bsorption and Lym an-A lpha Em itters in the Pre-Reionization Era

# ABSTRACT

We use a numerical simulation of cosm obgical reionization to estimate the likelihood of detecting Lyman- emitting galaxies during the pre-reionization era. We show that it is possible to nd galaxies even at z 9 that are barely a ected by the dumping wing of the Gunn-Peterson absorption from the neutral IGM outside of their H II regions. The damping wing becomes rapidly more signi cant at z > 9, but even at z > 10 is it not inconceivable (although quite hard) to see a Lyman- emission line from a star-forming galaxy.

#### 1. Introduction

A recent landslide in the num ber of detections ofhigh redshift Lym an- em itters (Dey et al. 1998; Hu, Cowie, & M dM ahon 1998; W eym ann et al. 1998; Hu, M dM ahon, & Cow ie 1999; Stem & Spinrad, 1999; Ellis et al. 2001; A jiki et al. 2002; Hu et al. 2002; K odaira et al. 2003; Taniguchi et al. 2003; R hoads et al. 2003; M aier et al. 2003; C uby et al. 2003; Bunker et al. 2003; Hu et al. 2004; Pello et al. 2004; K neib et al. 2004) o ersa unique probe of the ionization history of the universe during cosm ological reionization. As observations of Lym an- absorption in the spectra of high redshift quasars (D provskiet al. 2001; Becker et al. 2001; Fan et a. 2002, 2003; W hite et al. 2003; Songaila 2004) unambiguously indicate that the universe was reionized shortly before z = 6 (G nedin 2002), the observations of Lym an- at z > 6 directly probe the pre-reionization era.

Speci cally, since the damping wing of the Gunn-Peterson absorption (Gunn & Peterson 1965) of the neutral IGM will a ect the Lym an-

em ission line if the H II region around the em itting galaxy is not large enough (M iralda-E scude 1998;H aim an 2002), the observations of high redshift Lym an- em itters tell us som ething about the distribution and sizes of cosm ological H II regions although, to understand what speci c constraints the observations place is a horrendously di cult task<sup>4</sup>.

However, the very fact of discovering a highredshift Lym an- em itterm av potentially be used to constraint the ionization history of the universe. For example, Pello et al. (2004) report a tentative discovery of a z = 10 galaxy. Is it possible to see a Lym an- em itting galaxy at such a high redshift? Loeb et al. (2004) used this fact to put som e prelim inary constraints on the ionization state of the IGM around that galaxy. W hile a real situation is likely to be more complicated because of the variety of reasons (H II regions are typically highly asymm etric because I-fronts propagate much faster across underdense voids then across dense lam ents; bright galaxies are biased, so it is likely that more than one galaxy is located inside a single H II region; Lym an- em itters can also be located inside H II regions of lum i-

nous quasars, which are often m any times larger than H II regions of galaxies, etc), it is interesting to investigate how likely it is to nd a high redshift galaxy una ected by the dam ping wing of the G unn-P eterson absorption from the surrounding IGM.

## 2. Star Form ation M odeling

In order to construct a model for the Gunn-Peterson absorption in the pre-reionization era, we use a num erical simulation of cosm ological reionization similar to the one described in G nedin (2000). The new simulation, however, incorporates a signi cantly more accurate method for following the time-dependent and spatiallyinhom ogeneous radiative transfer using the O ptically Thin Variable Eddington Tensor (O TVET) approximation of G nedin & A bel (2001).

The simulation assumes a at cosmology with the values of cosmological parameters as measured by the W MAP satellite (Spergelet al. 2003)<sup>5</sup>. The size of the simulation volume is 8h <sup>1</sup> M pc in commoving units, and the comoving spatial resolution of the simulation is 2h <sup>1</sup> kpc. The simulation included 128<sup>3</sup> dark matter particles (with mass of 2:6  $10^7$ M), an equal number of baryonic cells on a quasi-Lagrangian moving mesh, and about 3 million stellar particles that formed continuously during the simulation. Only PopII stars are included in the simulation as sources of ionizing radiation.

The simulation was adjusted to reproduce the observed evolution of the mean transmitted ux in the Lym an-line between z = 5 and z = 6.4 (W hite et al. 2003; Songaila 2004). W e, therefore, can be condent that the evolution of the IGM is treated correctly in the simulation at least at z = 6.

G iven a simulation, we identify all star-form ing galaxies using the DENMAX halo nding algorithm of Bertschinger & Gelb (1991). For each galaxy, we generate 100 lines of sight that originate at the galaxy location and go along random ly chosen directions. We then generate an absorption spectrum along each line of sight following the standard procedure. For the computational

e ciency, we use Liu et al. (2001) approximation for the Voigt pro le.

Figure 1 illustrates the distribution of the baryon number density and neutral hydrogen num ber density along 3 random lines of sight originating at the location of the most lum inous galaxy at z = 9. The H II region around the central galaxies is easily visible. Because the brightest galaxies are highly clustered, smaller galaxies and other dense structures are often located within the H II regions of brighter ones. For example, in the top panel, an overdensity of the order of 10 is located within the H II region of the central galaxy. This overdensity is the outer part of a sm aller galaxy, and is, therefore, signi cantly more neutral than the rest of the H II region (in fact, more neutralthan simple ionization equilibrium would predict, due to shadowing and time-dependent ionization). This neutral spike is su cient to produce large dam ping wing absorption at the location of the galaxy and make the Lyman- of the central galaxy unobservable. Two bottom panels, however, show di erent, \clean" lines of sight that are not obscured by neighbors and produce lower absorption by the dam ping wing of the neutral IG M

outside the H II region. This illustrates that the e ect of the dam ping wing of the G unn-P eterson absorption strongly depends on the direction of the line of sight: the same Lym an- em itting galaxy m ay be observable or non-observable depending on the direction of view ing.

A signi cant complication, however, for the evaluation of the strength of the Lym an- em ission line from the central galaxy is the galaxy itself. Synthetic Lyman- spectra from simulation are often treated as absorption spectra, when, in reality, they are scattering spectra. For gas along a line of sight well outside the source of em ission this is an appropriate approximation, since scattering o the direction of viewing removes the photons that could be observed, and, thus, appears as e ective absorption. This is not true for the source of em ission, since photons that were originally em itted in directions di erent from the line of sight are scattered into the direction of viewing. Thus, without the proper line radiative transfer treatment (which is not included in our simulation), it is not possible to accurately predict shapes of the Lyman- emission lines from simulated galaxies. Leaving such treatment for future work, in this paper we are concerned only with an-orderofm agnitude estim ate of the e ect that dam ping wings of the neutral gas outside H II regions have on Lym an- em ission lines.

In order to obtain such an estimate, we adopt a following simple procedure. We assume that the Lyman- emission line from a typical galaxy has a width of the order of 150 200 km/s. Thus, we exclude all Lyman- absorption within a specied velocity distance  $v_o$  from the system ic velocity of a simulated galaxy (because within this distance we should treat the Lyman- as scattering and not as absorption). A lso, since the signi cant suppression of Lyman- emission at the system ic velocity may still make the red wing of the emission line visible, we choose the Lyman- optical depth at

150 km /s as a quantity that roughly characterizes the dam ping wing absorption of the Lym anem ission line. Typical Lym an- em ission lines have gaussian widths of the order of 60 80 km /s, so 150 km /s roughly corresponds to 2 to the red of the line system ic velocity. In this paper we use a range of values for  $v_0$  to estim ate the sensitivity of our results to that som ew hat arbitrary param eter.

W ith this approach, we can calculate the Lym an- optical depth at  $150 \, \text{km}$  /s for each of 100 lines of sight for each of the simulated galaxy. Thus, there are 100 values of the damping wing absorption optical depth  $_{Ly}$ , or, equivalently, the ux decrement  $F_{Ly}$  = exp( $_{Ly}$ ), for each galaxy. These 100 values are not all the same, of course, so we can use them to approximately characterize the probability that a given galaxy (labeled by its star form ation rate) has a given value of the Lym an- ux decrement.

### 3. Results

As a test of our approach, we show in Figure 2 the values for the Lym an- ux decrement above which 3% and 10% of all galaxies lie - for example, solid lines indicate that for 3% of all galaxies the decrease in ux at 150 km/s is not more than a factor of 10. The two values for the parameter  $v_o$  are used – the di erence between black and gray lines roughly indicates the uncertainty of our estimate.

An interesting feature of Fig. 2 is the lack of dependence of the ux decrem ent on the star form ation rate. Naively, one would expect that galaxies with lower star form ation rates create sm aller H II regions around them , and, therefore, should exhibit higher suppression of their Lym an- em ission lines - clearly at odds with our result. How ever, this naive argum entm isses an im portant fact that high redshift galaxies are highly clustered, so it is likely for a faint galaxy to be located close to a bright galaxy, within the bright galaxy H II region. In order to test that this e ect is responsible for the lack of dependence of the ux decrem ent on the star form ation rate, we compute the ux decrem ent versus the star form ation rate for the sub-sample of isolated galaxies. We de ne a galaxy to be isolated if it does not contain a galaxy with a higher star form ation rate within a sphere of prede ned radius risol. Short-dashed and dotted lines in in Fig. 2 show the ux decrement for the top 10% of all galaxies (an analog of the longdashed line) for sub-samples of isolated galaxies with  $r_{isol} = 100 \text{ kpc}$  and 300 kpc (in physical units) respectively. A s one can see, isolated galaxies exhibit a strong dependence on the star form ation rate for rates above about 0:1M =yr. At even lower star form ation rates a di erent e ect takes over: since the star form ation in dwarf galaxies is highly episodic (c.f. Ricotti, Gnedin, & Shull 2003), the instantaneous value of the star form ation rate and the size of an H II region cease to correlate.

The redshift dependence of the Lym an- ux decrement is shown in Figure 3. As once can see, our estimates become highly uncertain at z 10 - at these redshifts full radiative transfer in Lym an-

line is required to make an accurate prediction for the e ect of the dam ping wing on the prole of the Lym an- em ission line. At low er redshifts, how ever, our estimates are more precise.

#### 4. D iscussion

Som ew hat unexpectedly, even at as high a redshift as z 9, one percent of all Lym an- em itters should have their em ission lines barely a ected by

the dam ping wing. At higher redshifts the dam ping wing quickly becomes more signi cant, but nding Lym an- em itters at z > 10 should still be possible, although they must be quite rare.

The reason for this rapid transition is quite sim – ple: as the universe expands, H II regions increase in size, so at each m om ent there exists a characteristic scale for the size distribution of H II regions (say, a typical size of an H II region around an L galaxy). At the same time, the damping wing of the G unn-P eterson absorption introduces another spatial scale (about z = 0.01 or proper distance of 200 kpc at z 10; M iralda-E scide 1998). Thus, when typical H II regions around bright galaxies exceed this scale, a substantial fraction of all Lym an- em itters becom es observable.

It is important to emphasize here that our estim ate is likely only a lower lim it: because of the nite size of the computational box, we miss the brightest galaxies which create the largest H II regions (although the size of the simulation box was selected so as to make this e ect not signi cant at z > 6). In addition, our simulation does not include quasars, which can create H II regions several times that of galaxies. High redshift quasars are rare (there should be only about 2 SLOAN quasars in the whole observable universe between redshifts 9 and 10, Fan et al. 2001), so that e ect is most likely not large too, but without a detailed simulation we cannot estimate it, so we treat our results as a lower limit.
