# Interpreting the C olour- M agnitude D iagram s of O pen S tar C lusters through $N$ um erical Sim ulations

#### Abstract

W e present detailed com parisons.betw een high quality observationalcolour-m agnitude diagram s (CM D s) of open star clusters and synthetic CM D s based on M onteC arlo nu$m$ erical sim ulations. The com parisons account for all of the $m$ ain param eters which determ ine the shape of the CM D for a stellar population. For the four clusters studied, NGC 6819,NGC 2099 (M37),NGC 2168 (M35) and NGC 2323 (M50), we derive reddening, distance, age, binary fraction, star form ation rate and indicative m etallicity by com paring the locations and density of points in the observed CM D s to the sim ulated CM D s.W e estim ate the uncertainties related to stellar evolution theories by adopting various sets of stellar m odels for all of the synthetic CM D s and discuss which stellar m odels provide the theoreticalCM D s that best reproduce the observations.

## 1 IN TRODUCTION

Theoretical isochrones are com $m$ only $t$ to the $m$ a jor observational sequences of star clusters in order to both better understand the underlying physics of stellar evolution and to determ ine properties of the clusters, i.e., the age. If the $m$ etallicity, reddening and distance to the cluster are well constradried-firm -independent techn tques, the compartsonns typically-involve matching- the-nt orphology of the- turm -oand location of the red giant stars to predictions. R ecently, the newer $m$ ethod of using synthetic colour-m agnitude diagram s to com pare w ith observational data has proven to be m uch m ore in form ative and rew arding Apparicio et al 1990; Tosi et al 1991; Skillm an \& G allart 2002). These $M$ onteC arlo sim ulations allow modelling of several additional param eters which dictate the distribution of points in the CMD, such as stochastic star form ation (SF) processes, binary fraction, photom etric spread, m ain-sequence thickness, data incom pleteness and sm all num ber statistics. C onsequently, the results not only provide a m easure of the properties of the cluster, but can also constrain the star for$m$ ation history ( SFH ) and the initialm ass function ( $\mathbb{M} F$ ). Furtherm ore, by com paring the sim ulations based on several di erent sets of evolutionary tracks, we can constrain which models use the best prescription of param eters (such as treatm ent of overshooting, $m$ ixing length, etc...).

[^0]geneous sam ple of open clusters aim ed at studying the for$m$ ation and evolution of the $G$ alactic disk (B ragaglia 2003, and references therein). G alactic open chusters are indeed particularly well suited to this purpose, since they span a range of ages from a few m illion to severalbillion years and can be observed in various regions of the $G$ alactic disk characterised by di erent star form ation histories. T hey can be used to study both the present day disk structure and its tem poral evolution (Janes \& Phelps 1994, Friel 1995, Tosi 2000, B ellazziniet al. 2003). O ld open clusters o er a unique opportun ity to trace the w hole kinem aticaland chem icalh istory of our disk, if collected in populous and representative sam ples and accurately and hom ogeneously analysed (see e.g., T warog, A shm an, \& A nthony-T warog 1997; C arraro, N g, \& P ortinari 1998) .

Here we apply the synthetic CMD m ethod to NGC 6819, NG C 2099, N G C 2168 and NGC 2323 to derive their age, reddening, distance $m$ odulus and (approxim ate) $m$ etallicity hom ogeneously to the B ragaglia (2003) cluster sam ple. The m ethod also allow s us to determ ine other features of these clusters, such as the existence (or lack thereof) of a signi cant fraction of unresolved binary system $s$, the original totalm ass of form ed stars and the possible evaporation of som e of the low er $m$ ass stars.

The organisation of the paper is as follow S , brie y sum $m$ arises the data and the reduction procedures. Further details are given in JSK I. In whe present a sum mary of our $m$ ain results which relate to this work from the published papers in the CFHT Open Star C luster Survey. x sets up the num erical sim ulations and presents details on how the synthetic CMD s were created. Next, we com pare the CM D s and the corresponding lum inosity functions from the observations w ith the sim ulations on a cluster-by-cluster
 the study in XTV.'.

## 2 THEOBSERVATIONALDATA

A $n$ absolute requirem ent in using di erent data sets to $m$ ake detailed com parisons betw een observations and m odels is that of hom ogeneity. To truly understand the variations in the di erent $m$ odels param eters, we $m$ ust $m$ in im ize system atic errors. T herefore, we desire a rich data set of open clusters, all reduced using the sam e approach, calibrated consistently, and w ith well determ ined incom pleteness factors. The richest clusters from the CFHT O pen Star C luster Survey, NGC 6819, NGC 2099 (M 37), NGC 2168 (M35) and NGC 2323 (M50) perfectly $m$ eet these requirem ents. T he data were all im aged during an excellent three night observing run w ith the C anada-France-H aw aii Telescope (CFHT) on 1999 O ctober, using the CFH 12K cam era. T he optical detector is a high resolution ( $110^{8}$ pixels) CCD m osaic cam era which projects to an aerial coverage of $42^{\circ} \quad 28^{\circ}$ on the sky.

M ost clusters were observed w ith exposure tim es su cient to reach the $m$ agnitude of the coolest $w h$ ite $d w$ arfs and of the faintest $M$-type stars on the $m$ ain sequence. $W$ e also com plem ented the deep photom etry w ith shorter exposures to cover the brighter tum-o and evolved stars. T he individual im ages were registered and co-added (where necessary) using the FITS Large Im ages P rocessing Softw are (FLIPS)
(J.C . C uillandre, 2000, P rivate C om m unication) . D etails of th is procedure, as well as the pre-processing of the data are provided in $x 3$ of JSK I.
$T$ he actualphotom etry of the sources in the im ages was $m$ easured using Point-Spread Function Extractor (P SFex), a highly autom ated program which willbe integrated in the code of a future SE xtractor version (Bertin \& A mouts 1995; E. Bertin 2000, private com m unication).W e used a separate PSF on each CCD of the m osaic. Included in the PSF are polynom ialbasis functions which can $m$ ap the variations of the PSF across the CCD. PSFex is discussed further in x 4 of JSK I.
$D$ ata for each of the clusters were taken in the B and V lters, and calibrated in the Johnson photom etric system using $m$ u elds (Landolt 1992). T he nalaveraged uncertainties in the zero-point term s were m easured to be 0.018 m agnitudes, uncertainties in the airm ass coe cients w ere 0.015 m agnitudes in $V$ and 0.007 m agnitudes in B . C olour coe cients, as well as aim ass term s , were sim ilar to nom inalCFH T expectations. D etails of the calibration of instrum ental magnitudes to realm agnitudes are provided in x5 and Tables 2 and 3 of JSK I.

T he resulting, calibrated C M D s for the open clusters exhibit unprecedented long, clearm ain sequences ranging from the brightest cluster $m$ em bers to the lim iting $m$ agnitude in each case ( 236 V 6 25) . A sum $m$ ary of the observational log for each cluster (exposure tim e, seeing, airm ass, etc...) is presented in Table 1.

## 3 FIRST RESULTS: ISOCHRONEFITTING

Figure 1 presents the nal calibrated CMD s for each of the four open clusters, $w$ ith the best $t$ theoretical isochrones as determ ined in our previous published analysis of these clusters (see JSK II, JSK III, JSK IV for details). T hese rich clusters are clearly delineated from the background G alactic disk stars. T hem ain sequences are very tight and show several features which are predicted by stellar evolutionary theory (see x5). For this, we used a new grid ofm odelisochrones calcu lated by the group at the Rom e o bservatory according to the prescription described in $\bar{V}$ entura et al. (1998i). T hese m odels adopt convective core-overshooting by m eans of an exponential decay of the turbulent velocity out of the form al convective borders xed by Schwarzschild's criterion; a free param eter which gives the e-folding distance of the exponential decay is set to $=0.03$ (Ventura et al. 1998). The convective ux hasbeen evaluated according to the Full Spectrum ofT undulence (FST) theory prescriptions lC anuta I\& M azzitelli 1992). T he theoretical isochrones were transform ed into the observational plane by $m$ aking use of the B essel, C astelli \& P letz (1998) conversions. T he low er main sequence ( M . 0.7 M _ ) was calcu lated by adopting N extG en atm osphere models (H auschildt, A llard \& Baron 1999) . For M _- 0.47 M (or Te_ 3500 K ) the transfom ations of H auschildt, A llard \& B aron (1999) in B V are not very reliable and so the faint end of the isochrones term inate at th is m ass. T hese m odels w illbe referred to as FST from here on.

### 3.1 P ublished R esults \{ N G C 6819

The tight, very rich, $m$ ain sequence and tum-o consist of over 2900 cluster stars to our lim iting magnitude. M ainsequence tting of the un-evolved cluster stars $w$ ith the $H$ yades star cluster yields a distance $m$ odulus of $(m \quad M) V$ $=12.300 .12(\mathrm{~d}=2500 \mathrm{pc})$, for a reddening of $\mathrm{E}(\mathrm{B} V)=$ 0.10 . T hese values are consistent $w$ ith a theoretical isoch rone of age 2.5 G yrs. D etailed star counts in concentric annuliout to large angular radii set constraints on the cluster radius, $R=9: 5 \quad 1: 0$, and clearly indicates $m$ ass segregation in the cluster. T he global clusterm ass function is found to be quite at, $x=0.15$ ( $x=1.35$, Salpeter). A large population of white dwarf stars is found in the cluster and is currently being investigated spectroscopically.

### 3.2 P ublished R esults \{ N G C 2099 (M 37)

T he cluster CM D show s extrem ely well populated and very tightly constrained $m$ ain sequence, tum-o, and red giant populations. T he photom etry for this cluster is faint enough (V 24.5) to detect the end of the white dwarf cooling sequence. Therefore, the white dw arfs are used as chronom eters to age the cluster providing an independent age (566
${ }_{176}^{154}$ M yrs) from the $m$ ain-sequence tum-o plus red giant clump $t$ ( 520 M yrs). W e also derive the reddening $\left(E\left(\begin{array}{ll}B & V\end{array}\right)=021 \quad 0.03\right)$ and distance $\left(\begin{array}{ll}\left(\begin{array}{ll}m & M\end{array}\right)_{V}=11.55\end{array}\right.$
0.13 ) to NGC 2099 by m atching m ain-sequence features in the cluster to a _ ducialm ain-sequence for the $H$ yades (de B ruijne, H oogerw erf \& de Zeeuw 20011), after correcting for sm all m etallicity di erences. T he cluster lum inosity and $m$ ass functions indicate som e evidence for $m$ ass segregation w ith in the boundary of the cluster.

$F$ igure 1. Isochrone ts for each cluster are show $n$ with corresponding ages. A llm odels are Solarm etallicity $w$ ith the exception of $\mathrm{N} C$ 2168 , for which $Z=0.012$. For the lower $m$ ain sequence, we were not able to com pute non-grey atm ospheres for this $m$ etallicity. $W$ e therefore overplot the low er m ain sequence from a Solar m etallicity m odel (bottom -left).

### 3.3 P ublished R esults \{ N G C 2168 (M 35)

NGC 2168 is a well studied nearby ( $\left.d=912 \quad \begin{array}{ll}70 & \mathrm{pc}\end{array}\right)$ young cluster ( 180 M yrs) show ing a well de ned m ain sequence. The reddening of the cluster, $E(B \quad V)=020$, and them etallicity, $Z=0.012$, were adopted from the literature Sarrazine et al 2000'; 'B arrado y N avascues, D eliyann is \&' Stau er 2001, The cluster is found to contain 1000 stars above our lim iting $m$ agnitude $w$ ith a global m ass function slope very sim ilar to a Salpeter value ( $x=129$ ). There is $m$ ild evidence for $m$ ass segregation in the cluster. W hite dw arfstars are found and can potentially set very im portant constraints on the high-m ass end of the white dw arf in itialnalm ass relationship considering they m ust have evolved from quite $m$ assive progenitors.

### 3.4 P ublished R esults \{ N G C 2323 (M 50)

N G C 2323 is one of the youngest clusters in the CFHT O pen C luster Survey ( 130 M yrs), and show s a m ain sequence extending over 14 m agnitudes in the V , B V plane. The clusterhashad very few photographic/photoelectric studies, and
prior to oure orts, no previously known CCD analysis. This is surprising considering the rich stellar population ( 2100 stars above ourm agnitude lim it) and the relatively low distancem odulus ( $\left.\left(\begin{array}{ll}(\mathrm{m}\end{array}\right)=10.00 \quad 0.17\right)$. The chuster show s clear evidence ofm ass segregation, an im portant result considering the dynam ical age is only 1.3 the cluster age.

## 4 SYNTHETIC COLOUR-MAGNITUDE D IA GRAMS

A ge, reddening and distances for the four chusters have been re-derived applying the synthetic CM D m ethod (Tosiet al. 1991) to the em piricalCM D s described above. T he best values of the param eters are found by selecting the values that provide synthetic CM D s w ith m orphology, num ber of stars in the various evolutionary phases and lum inosity functions in better agreem ent $w$ ith the em pirical ones. T he $m$ ethod has already been succesfilly applied to severalclusters (B ragaglia 2003 and references therein).

The synthetic CM D s are constructed via M onteC arlo extractions of (m ass, age) pairs, according to an assum ed

IM F, SF law, and time interval of the SF activity. Each extracted synthetic star is placed in the CM D by suitable interpolations on the adopted stellar evolution tracks and adopting the B esselet al. (1998) tables for photom etric conversion in the Johnson-C ousins photom etric system. The absolute $m$ agnitude is converted to a provisional apparent $m$ agnitude by applying (arbitrary) reddening and distance $m$ odulus. $T$ he synthetic stars extracted for any $m$ agnitude and photom etric band are assigned the photom etric error derived for the actual stars of the sam e apparent $m$ agnitude. $T$ hen, they are random ly retained or rejected on the basis of the incom pleteness factors of the actual data, derived from extensive arti cial star tests.

O nce the num ber of ob jects populating the whole synthetic CMD (or portions of it) equals that of the observed one, the procedure is stopped, yielding the quantitative level of the SF rate consistent w ith the observationaldata, for the prescribed $\mathbb{I M} F$ and SF law. To evaluate the goodness of the m odelpredictions, we com pare them with: the observational lum inosity functions, the overall $m$ orphology of the CM D, the stellar m agnitude and colour distributions, the num ber of ob jects in particular phases (e.g., on the red giant branch, in the clum $p$, on the blue loops, etc.). A m odel can be considered satisfactory only if it reproduces all of the features of the em piricalCM D s and hum inosity functions. G iven the uncertainties a ecting both the photom etry and the theoretical param eters (stellar evolution tracks included), the $m$ ethod cannot provide strictly unique results; how ever, it allows us to signi cantly reduce the range of acceptable param eters.

In th is w ay we derive the age, reddening, distance of the cluster, and indicate the $m$ etallicity of the stellar evolution m odels in better agreem ent $w$ ith the data. In principle, the latter should be indicative of the clusterm etallicity, but th is depends signi cantly on som e of the stellar m odel assum ptions, such as opacities.

To estim ate if, and how many, unresolved binary system s could be present in the cluster, the synthetic CMD s have been com puted both assum ing that all the cluster stars are single ob jects and that an (arbitrary) fraction of them are $m$ em bers of binary system $s w$ ith random $m$ ass ratio. A gain, the com parison of the resulting $m$ ain-sequence $m$ orphology and thickness w ith the observed ones allows us to derive inform ation on the $m$ ost likely fraction of binaries.

W e also in fer the astration m ass of the cluster (i.e., the totalm ass that went in allof the stars form ed in the cluster), according to the adopted IM F.T he m ethod here also allow s us to derive the best IM F as long as the observed m ass range of $m$ ain-sequence stars is su ciently large and the $m$ ain sequence is su ciently tight. H ow ever, the high background contam ination a ecting the system $s$ exam ined here and the lack of su ciently reliable extemal blank elds, m ake the derivation too unsafe to discuss it here. O ther factors (see below), such as the actual size of the photom etric errors also prevents us from com paring the $\mathbb{I M} F$ in any signi cant detail.

5 OBSERVAT IONSVS THEORY -
COLOUR-MAGNITUDEDIAGRAMSAND LUM IN OSITY FUNCTIONS

To test the e ect of di erent input physics on the derived age, reddening and distance $m$ odulus, we have run the sim ulations w ith three di erent sets of stellar evolutionary tracks. The adopted sets were chosen because they assum e di erent prescriptions for the treatm ent of convection and range from no overshooting to rather high overshooting from convective regions. D espite these di erences, they are all able to well reproduce the observed CM D s of both star clusters and nearby galaxies. T hey are thus suitable to evaluate the intrinsic uncertainties still related to stellar evolution models. W e use the FST tracks of Ventura et al. (199d) w ith high ( $=0.03$ ) and $m$ oderate ( $=0.02$ ) overshooting; the BBC 94 tracks of the $P$ adova group B ressan et al 1993; Fagotto et al. 1994), w ith overshooting; and the FRANEC tracks (Dom inguez et al. 1999) w ith no overshooting. For those cases where the m etallicities are not well constrained, we allow di erent values in our com parisons. In com pleteness factors and photom etric errors are taken from the original papers in the CFHT O pen StarC hister Survey series (JSK II, JSK III and JSK IV ) and folded into the num erical sim ulations.

A $1 l \mathrm{~m}$ odels assum $e$ that the star form ation activity has lasted 5 M yr (i.e., approxim ately an instantaneous burst) and that the stars w ere form ed follow ing a single slope ( $x=$ 1.35) Salpeter's IM F over the whole m ass range covered by the adopted tracks ( 0.6 \{ 100 M ).
$F$ igures 2, 4, 6 and 8 show for each cluster the synthetic m odels in better agreem ent w th the data for each adopted set of stellar tracks, as w ell as the chuster observationalC M D on the sam e scale. In all of these gures the CMD s in the top row are the synthetic ones, those in the second row are the sam e synthetic ones but overlapped with the stars of the equal area ducialblank eld, and the bottom CMD is the em pirical one. Figures 3,5,7 and 9 com pare the em pirical hum inosity functions w ith those predicted by the best synthetic m odels. U ltim ately, the best $m$ odels have been selected by visually com paring features betw een the synthetic $m$ odels and the observations, such as the location and density ofpoints on the CM D. H ow ever, w e have also attem pted to con m our results by using both the two-dim ensional K olm ogorov-Sm imov test on the CMD and ${ }^{2}$ tests on the lum inosity and colour functions. In the cases of well constrained eld contam ination, such as behind NGC 6819 and NGC 2099, the tests con $m$ our choices of best synthetic m odels. For the other two clusters, the tests do not help discrim inate between best choice of $m$ odels and we strictly use conclusions based on the visual location of points. A lso, these statistical tests are particularly not well suited for these com parisons because of the insigni cant weight given to the sm allnum berofstars in key evolutionary stages which $m$ ust be $t$ by the synthetic $m$ odels (such as the red giant clum $p$ ).

### 5.1 N G C 6819

N G C 6819 is the richest cluster in th is w ork. T he cluster eld contains 10510 bona de stars (i.e., w ith stellarity param eter $>0.5)$ while the blank eld of sam e area contains 8504 bona

de stars. T he synthetic C M D s are therefore com puted w ith 2000 ob jects (a fraction ofw hich are assum ed to bem em bers ofbinary system s ).

A $l l$ of the tracks used to sim ulate the N G C 6819 CM D are Solar $m$ etallicity $m$ odels as the cluster $m$ etallicity has been constrained to this value through the high resolution analysis of Bragaglia et al. (20011). Figure 2 shows that the three sets of m odels provide slightly di erent ages (and hence, reddening and distances), which strictly depend on the assum ed am ount of overshooting: the higher the overshooting, the older the age. This is of course due to higher overshooting $m$ odels having higher stellar lum inosities, thus allow ing lower $m$ ass stars to reach the desired lum inosity. $T$ he variations in the ages seen in the $m$ odels also stress the im portance of deriving uncertainties on cluster param eters by using di erent sets of tracks.

The FST m odels w ith $=0.03$ (left) lead to param eters virtually identical to those found in JSK II. A better estim ate of the age is found to be $2.30 \quad 0.15$ G yrs, distance modulus ( $\mathrm{m} \quad \mathrm{M}$ ) $=12.0$, and reddening $\mathrm{E}(\mathrm{B} \quad \mathrm{V})=0.10$. The FRANEC m odels (right) suggest younger ages, due to their lack of overshooting, 1.6-1.8 G yrs, and therefore need
a slightly higher reddening $(\mathrm{E}(\mathrm{B} \mathrm{V})=0.15)$ to reproduce the colours. T he B BC 94 m odels ( $m$ iddle), w ith interm ediate overshooting, favor an interm ediate age of 2.0 G yrs, w ith $E(B \quad V)=0.12$ and $(m \quad M)=122$.

N one of these m odels are found to perfectly reproduce all of the observed features in the NGC 6819 CMD. For example, the FST m odels predict a m ain-sequence slope steeper than the observed one and the two diverge at the faint end. These $m$ odels also tend to place the red giant clum $p$ excessively tow ards the red, probably due to the fact that the models don't include mass loss. The FRANEC $m$ odels better reproduce the $m$ ain-sequence distribution but present a tum-o with a hook that is too pronounced, a likely consequence of the young age. G iven the high eld contam ination, how ever, th is feature is not particularly evident in the com bined CMD s of the second row. A sm aller cluster core CMD show s the hook prom inently. The FRANEC m odels also overpopulate the lower red giant branch. This is visible even despite the fact that this region of the CM D is plenty of contam inating ob jects. T he B BC 94 m odels provide the best $t$ to the data CM D, despite a m ain-sequence slope which is slightly too steep. M ost of these discrepan cies

(2004) studying the open chister N G C 6939 w ith the sam em ethod, assum ing a reddening dependence on the stellar colour as adopted by T w arog et al. (1997) m akes the synthetic $m$ ain sequences even steeper and, hence, $m$ ore inconsistent w ith the data.

A nother evident result that we nd for all of the clusters studied here, is that the observed $m$ ain-sequence spread cannot be reproduced if one assum es photom etric errors as sm all as those listed in our photom etry catalogue. To test the actual size of the photom etric errors we revert back to the arti cial star tests presented in JSK II. A plot of the $\mathrm{V}_{\text {in }}$ $V_{\text {out }}$ distribution tells us that, in fact, the errors quoted agree w ith the arti cial star tests. T he synthetic CM D s how ever, require that either the errors are larger, at least 0.01 m agnitude even in the brighter bins, or there is som e physical cause for the observed spread (i.e., di erential redden ing or $m$ etallicity spread). A spread due to binaries is m odelled and therefore ruled out as a cause for this discrepency. T he apparent spread could be caused by sm allo sets in the calibration of the di erent CCD s of the m osaic, but intemal $m$ etallicity spread in the chuster or sm all di erential reddening cannot be excluded. W e are currently investigating this possibility in another project (R.S.French et al. 2003, private com $m$ unication). For now, we have increased the errors to 0.01 m agnitude for stars brighter than $\mathrm{V}=19$ and doubled them forfainterbins $(=0.01$ at $V=21$, $=0.04 \mathrm{at} \mathrm{V}$ $=23$ ). Em pirically, this is the m in im um size required to obtain a m ain-sequence spread com parable w ith the observed one.

A ll of the shown cases in $F$ igure 2 assum e that $20 \%$ of the stars are in binary system $s w$ ith random $m$ ass ratio. $W$ e also tested sim ulations w ith $30 \%$ binaries and found $m$ inor di erences. G iven the high eld contam ination, it is di cult to understand which fraction and assum ption of them ass ratio is the best case. It could entirely be true that the fraction is actually sm aller if the $m$ ass ratio is m ore skew ed tow ards equalm asses. M odels w ithout binaries are not shown as they am plify the problem of the $m$ ain-sequence $w$ idth (the predicted one is too tight) and do not correctly reproduce the stellar distribution on the red side of the $m$ ain sequence.
$F$ igure 3 show sthe em pirical lum inosity function of the 10510 cluster eld stars (em pty circles) com pared to the hu$m$ inosity functions resulting from the sum of the 2000 synthetic stars off igure 2 w ith the 8504 stars of the blank eld.

T he agreem ent is excellent, except for the slight underesti$m$ ate of the clum $p$ stars of the FST m odels.

A clear result of our study is that all of the synthetic CMDs for NGC 6819 show overpopulated faint m ain sequences $(V>20)$, both for single and binary stars. $T$ his is a clear signature of low m ass stellar evaporation (or at least segregation outw ards of our cluster boundary, $9: 5$ ). A s we showed in JSK II, the $m$ ass function of this cluster steadily $m$ arches to atter values, and becom es inverted in the outem ost annuli. Therefore, the observations provide the answ er to this overabundance. H ow ever the e ect is not seen in the lum inosity function com parisons, which are in excellent agreem ent w th the observed one. $T$ his suggests either that the faint $m$ agnitude lum inosity function is dom inated by
eld contam ination or that the apparent over-concentration of the synthetic $m$ ain sequences is actually an artifact of the residual underestim ate of the photom etric errors.

A ssum ing a single slope Salpeter $\mathbb{I M} F$, the $m$ ass of gas that form ed the stars of the surveyed area of N G C 6819 betw een 0.6 and 100 M is ' $4: 2 \quad 10^{3} \mathrm{M} \quad$ w ith the BBC 94 m odels, $4: 0 \quad 10^{3} \mathrm{M}$ and $4: 9 \quad 10^{3} \mathrm{M} \quad \mathrm{w}$ ith the FST and the FRANEC m odels, respectively. H ence, di erent stellarm odels do not provide the sam e answ er for a global param eter such as the star form ation either. T he di erences are again related to the adopted input physics and to the am ount of assum ed overshooting in the stellar m odels. Less overshooting im plies higher $m$ asses for the observed living stars, i.e. shorter lifetim es, which, convolved w ith the negative slope of the $\mathbb{I M} F$, leads to a higher total astrated $m$ ass.

### 5.2 N G C 2099

The cluster eld contains 12194 bona de stars, while the blank eld extrapolated to the cluster area contains 10576 stars. H ence, the synthetic CM D s have been com puted w ith 1618 ob jects.

In JSK III, we assum ed the cluster m etallicity of N G C 2099 to be Solar, based on the isochrone tting results of M erm illod et al. (1996) as well as our ow n best guess from the t.A m ore recent study, Nilakshi\& Sagar (2001), prefer a subsolar $Z=0.008 \mathrm{~m}$ etallicity, again based on isochrone tting. T herefore, one goal is to constrain the m etallicity of the cluster based on synthetic CM D comparisons. So, forth is cluster we use the the FST tracks of Nentura et al. (1998) w th $=0.03, Z=0.02$ and $Z=0.006_{1}$ the BBC 94 tracks of the $P$ adova group $w$ ith $Z=0.02$ (B ressan et al 1993) and $Z=0.008$ (Fagotto et al. 1994'), and the FRANEC tracks

 0.006 .

For the FST, the synthetic sequences using Solarm etallicity $m$ odels look im pressively consistent w ith the observed CMD in all the $m$ inim al details. How ever, the tum-o and clum $p$ shape are not very good: the sequence after the tumo is too long and curved and the clum p is a bit short and faint. It is also very di cult to single out the best age, as anything between 520 and 700 M yrs doesn't signi cantly change the im portant CM D features (clum pmorphology and lum inosity, shape of tum-o , etc...), all looking reasonable. The clum $p$ becom es too faint below 500 M yrs, indicating that this is a lower age lim it and too blue beyond 800 M yrs indicating an upper lim it. The best $t$ resulting param eters for these tracks are therefore age $=620 \quad 60 \mathrm{M}$ yrs, $\mathrm{E}(\mathrm{B} V)=0.21 \quad 0.02$, and $(\mathrm{m} M)=10.70 \quad 0.20 . \mathrm{The}$ BBC $94 \mathrm{Z}=0.02$ tracks excellently reproduce allof them ain sequence and clum $p$ features, but have long post tum-o sequences, as we saw in the FST m odels. For Solarm etallicity, these tracks are in better agreem ent with the data than the FST m odels. The age is also better constrained, thanks to a higher sensitivity of the various features: age $=590 \quad 10$

Myrs, $E(B \quad V)=0.18 \quad 0.01$, and $(m \quad M)=10.50$ 0.10. TheFRANEC $Z=0.02$ tracks provide the best agree$m$ ent $w$ ith the observed upper $m$ ain sequence and tum-o features. H ow ever, the resulting clum $p$ is too vertical and overpopulated. P art of the latter problem is due to the fact that their m ain sequence is not as deep as the others, because the m in im um m ass available to $u s$ is 0.7 M , instead of 0.6 M as for the FST and Padova m odels. The code therefore can not distribute the required 1618 faint stars in these bins and, inevitably, puts a larger num ber of brighter stars according to a Salpeter $\mathbb{I M} F$. The resulting best $t$ param eters in the FRANEC m odels are age $=590 \quad 10 \mathrm{M}$ yrs, $\mathrm{E}(\mathrm{B} \quad \mathrm{V})=0.16 \quad 0.02$, and ( $\mathrm{m} \quad \mathrm{M}$ ) $=10.31 \quad 0.10$.

Figure 4 presents the low er m etallicity synthetic CM D s for NGC 2099. For the Z $=0.006$ FST m odels (left), the length of the sequence just after the tum-o shortens and becom esm ore vertical, thusbetter reproducing the observed m onphology. The clum p m orphology also in proves, thanks to a slightly larger extension. H ow ever, the agreem ent in the $m$ ain-sequence $m$ orphology is no longer as excellent as the higher $m$ etallicity case, but still quite good. It $m$ ay well be that interm ediate $m$ etallicity tracks would work even better.

Therefore, overall the synthetic CM D s from the FST tracks prefer the low er m etallicity, w ith param eters: age $=520$ $40 \mathrm{M} y r s, \mathrm{E}(\mathrm{B} V)=0.36 \quad 0.01$, (m M ) $=10.40 \quad 0.10$. T he BBC 94 low er m etallicity tracks ( $m$ iddle), $Z=0.008$, are the best $m$ odels for this cluster. T hey reproduce all of the $m$ ain-sequence features and also have a better shaped tum-o than $w$ ith the Solar $m$ etallicity models. A m inor inconsistency is seen in the location of the clum $p$, which is slightly too vertical, but this is a m inor detail. T he age is less well de ned, w ith nal best param eters age $=430$
30 M yrs, $\mathrm{E}(\mathrm{B} \mathrm{V})=0.360 .03$, ( m M ) $=10.50$. The low er m etallicity FRANEC tracks (right) can be ruled out as both the $Z=0.01$ and $Z=0.006 \mathrm{~m}$ odels show extrem ely extended clum ps (real blue loops) which are inconsistent $w$ th the observed clum $p$ for any reasonable age. A lso, the lifetim es in that phase favor the stars to reside on the blue side of the clum p (vertical), adding further inconsistency to the colour and shape.

W e have also perfom ed several tests on the fraction of binary stars in NGC 2099. At rst glance, the em pirical CMD doesn't show any evidence of binaries, but we have found a posteriori that, w ithout including them in the synthetic CM D s, both the tum-o m onphology and the colour distribution on the red side of the $m$ ain sequence are not well reproduced. O ur best guess is that binaries are around 15-20\% of the cluster stars and allof the results that we have discussed above assum $e$ this fraction ( $20 \%$ ) w ith a random m ass ratio.
$F$ igure 5 show sthe em pirical lum inosity function of the 12194 cluster eld stars (em pty circles) com pared to the lu$m$ inosity functions resulting from the sum of the 1618 synthetic stars off igure 4 (subsolarm etallicity) w ith the 10576 stars of the extrapolated blank eld. The predicted lum inosity functions are consistent $w$ ith the data, but the agree$m$ ent at the brightest $m$ agnitudes is not exceptional. The very good $m$ atch at the faintest $m$ agnitudes show $s$ that the extrapolation of the num ber of stars observed in the blank eld to the larger area covered by the cluster is correct.

The general ts of the data to synthetic CMDs favor the low er m etallicity m odels for N G C 2099, thus requiring a higher reddening. T hese are found to better reproduce the shape of the upper $m$ ain sequence and tum-o . N otice that age and modulus derived here do not coincide $w$ th those derived JSK III w ith the sam e stellar tracks. T he di erence in age is probably due to the fact that w ith the isochrone tting $m$ ethod one sim ply ts a curve to the points, whereas w ith the synthetic CMD s one has to reproduce the points
them selves, including $m$ orphology and quantity. The di erence in m odulus is, presum ably, sim ply the consequence of the age di erence.

A ssum ing a single slope Salpeter IM F , the m ass of gas that form ed the stars of the surveyed area of NGC 2099 betw een 0.6 and 100 M is' $2: 610^{3} \mathrm{M} \quad \mathrm{w}$ th the B BC 94 m odels, 2:5 $10^{3} \mathrm{M}$ and 3:1 $10^{3} \mathrm{M} \quad \mathrm{w}$ th the FST and the FRANEC m odels, respectively.

### 5.3 N G C 2168

The cluster eld contains 9298 bona de stars. O ur previous work on NGC 2168 (JSK IV) su ered due to the large size of the cluster $\left(\mathrm{R}>20^{\circ}\right.$ ). A very sm allblank eld was constructed from the outer edges of the CFH 12K CCD mosaic. In fact, som e cluster $m$ em bers surely resided $w$ ith in the blank eld, and therefore the chuster lum inosity function could have been underestim ated. U sing synthetic CM D s, we nd that we can only reproduce the observed stellar distribution in the CMD and the lum inosity function if we use 500-600 stars down to $V=19 . \mathrm{U}$ sing the blank eld from the outer edges of the CCD subtracts o too $m$ any stars and forces a poor agreem ent betw een the theory and the observations. This con m sour in itialsuspicion that the cluster is larger than our aerial coverage. T he synthetic CM D s show n here contain 550 stars brighter than $\mathrm{V}=19$.

For the synthetic CM D com parisons, we again use both Solar and subsolar metallicity models from each of FST, BBC 94, and FRANEC.W e imm ediately nd that the subsolar m etallicity models provide a m uch nicer agreem ent to the observations than Solar m etallicity models. T he Solar m etallicity m odels not only predict an insu cient num ber ofm ain-sequence stars just below the tum-o , they also contain very vertical upperm ain sequences. B esides, for ages as old as 180 M yrs the tum-o s are slightly too faint, while for younger ages, < 120 M yrs, the tum-o has the proper hum inosity but is severely underpopulated when com pared to the observations. F lattening the IM F did not help the overall $t$.

Figure 6 show s the best synthetic C M D s for N G C 2168 . For the FST tracks (left), the m odels w ith maxim um overshooting ( $=0.03$ ) and low m etallicity ( $Z=0.006$ ) reproduce the data very nicely. T hese require a best $t$ distance m odulus slightly sm aller $\left.\left(\begin{array}{ll}(m \quad M\end{array}\right)=9.6\right)$ and a reddening slightly larger ( $E(B \quad V)=022$ ) than found in JSK IV .T he di erences can be m ost likely attributed to the low er m etallicity (JSK IV uses $Z=0.012$ ) that we chose in these com -

parisons. The best age for this model is 200 M yrs, slightly older than what JSK IV found ( 180 M yrs). The absence of a population of post $m$ ain-sequence stars coupled $w$ th the insensitivity of the tum-o lum inosity and m orphology w ith age in these $m$ odels allow sfor a nice agreem ent betw een the theory and data w ith ages down to 120 M yrs.

The agreem ent is found to be not as good if we use the sam e m etallicity FST m odels w ith slightly low er overshooting, $=0.02$. At an age of 180 M yrs the tum-o is too faint, how ever, w th younger ages ( 150 M yrs) we overpopulate the post $m$ ain-sequence stars (ve are seen). At 120 M yrs, the tum-o is too bright, hence this age is too young.

The BBC 94 m odels for NGC 2168 are shown in the m iddle panel of $F$ igure 6. The $Z=0.08$ tracks are found to excellently reproduce both the CMD morphology and the num ber of stars in the di erent phases. $T$ he $m$ ain-sequence curves are best tted using $E(B \quad V)=020$ and ( $\mathrm{m} \quad \mathrm{M}$ ) = 9.8. The best age estim ate is found to be 180 M yrs. A n age of 150 M yrs doesn't provide any post $m$ ain-sequence stars whereas an age of 200 M yrs is too old as it predicts too m any clum p stars. The FRANEC m odels (right) predict too many post $m$ ain-sequence stars for both adopted $m$ etallicities, $Z=$
0.01 and $Z=0.02$. A s sum $m$ arised in JSK IV ,m any studies of NGC 2168 exist in the literature $w$ ith none nding $m$ ore than a few clum p stars. TheFRANEC models would require a very young age ( 110 M yrs) to $t$ the post $m$ ain-sequence phases and this would in tum force a poor agreem ent in the tum-o region. The best $t \mathrm{~m}$ odelis, arguably, the one $w$ ith age $=110 \mathrm{M}$ yrs, $\mathrm{E}(\mathrm{B} \mathrm{V})=022$, and $(\mathrm{m} \mathrm{M})=9.8$.

O urbest estim ate for the NGC 2168 binary fraction is found to be $30 \%$. This fraction puts a consistent num ber of stars, and sparse regions, on the red side of the cluster m ain-sequence in the synthetic CMD s. AllCMD s shown in $F$ igure 6 contain this binary fraction.

C om paring the resulting best synthetic CMD sw ith the observed one, it is clear that the predicted $m$ ain sequence is too tight and slightly underpopulated at faint $m$ agnitudes ( $V>15$ ). As addressed earlier in 45.1 , the tightness is a question of photom etric errors, possible di erential reddening, orm etallicity spreads w ith in the cluster. T he undenpopulation in this case is $m$ ost likely related to the uncertain $m$ ethod we have used to infer the num ber of cluster $m$ em bers. $M$ any tests that we have done indicate that we cannot attribute $m$ ore stars to the cluster w ithout getting too

$m$ any bright stars, both on the $m$ ain sequence and in subsequent evolutionary phases. W e also note here that $\mathrm{V}=19$ is the lim iting $m$ agnitude of the num erical sim ulations for th is cluster. This is related to the availability of photom etric conversion tables (Bessellet al. 199\%) for the adopted $m$ etal licities. $W$ ith that said, 正 is rem arkable how well the overall shape of the upperm ain sequence is reproduced. T he 'kinks' and slope changes all fall in the correct place as dictated by the observations. $T$ h is allow s us to accurately determ ine the best $t$ param eters for NGC 2168. Interestingly, the best $t$ synthetic CM D for th is cluster, the B BC 94 m odel, provides an identical reddening, distance, and age to what we found using the FST isochrone in JSK IV.TheFST synthetic CM D derived param eters are also in excellent agreem ent w ith our observations considering that the $m$ etallicities are slightly di erent.
$F$ igure 7 show sthe em pirical lum inosity function of the 9298 cluster eld stars (em pty circles) com pared to the lu$m$ inosity functions resulting from the sum of the synthetic stars of $F$ igure 6 w th the 8748 stars resulting by random ly m ultiplying the 1150 ob jects of the supposed blank eld for an area norm alisation factor. C learly, a m a jor side e ect of the lack of an appropriate extemal eld is that the com parison of the lum inosity functions becom es only a m atter of self-consistency and cannot be used for any consideration on $m$ ass segregation/evaporation. A s m entioned above, the lum inosity functions agree w ith the data only w ith 500-600 cluster $m$ em bers. O ne $m$ ay think to im prove the situation by steepening signi cantly the $\mathbb{M}$ F (thus allow ing form ore stars in the fainter $m$ ain sequence, $w$ ithout adding bright ones), but we consider it highly dangerous to m odeify the $\mathbb{M}$ F w ithout a good eld subtraction. W e stress that observations of a deep B V eld o set from the centre of NGC 2168 by at least one degree w ould be very useful.

A ssum ing a single slope Salpeter $\mathbb{I M} F$, the $m$ ass of gas that form ed the stars of the surveyed area of NGC 2168 betw een 0.6 and 100 M is ' $8: 5 \quad 10^{2} \mathrm{M} \quad \mathrm{w}$ ith the BBC 94 m odels, 7:8 $10^{2} \mathrm{M}$ and 9:6 $10^{2} \mathrm{M} \quad \mathrm{w}$ ith the FST and the FRANEC m odels, respectively.

### 5.4 N G C 2323

The cluster eld contains 11115 bona de stars. Taking into account that 1) theblank eld contains 5142 stars but covers an area 1.8 tim es sm aller than the cluster eld, 2) the $m$ ass of the available stellar models don't allow synthetic stars fainter that V 18, the synthetic CM D s have been in itially
com puted with 565 ob jects brighter than $V=18$. A posteriori, we have how ever found that in this w ay we predict hu$m$ inosity functions clearly overestim ating the bright portion (w here the cluster dom inates) and underestim ating the faint portion (where eld contam ination dom inates). W e em pirically nd that good lum inosity functions are obtained only if the cluster contains 285 m em bers brighter than $\mathrm{V}=18$, suggesting that the previously used blank eld underesti$m$ ated the actual contam ination. A gain observations of an extemal eld of appropriate size w ould be crucial for a safer derivation of som e of the cluster properties.

For the youngest cluster in this work, NGC 2323, the $m$ etallicity is know $n$ to be Solar and in fact, we nd that the Solar m etallicity tracks provide the best agreem ent to the data in thiswork. Them ost di cult param eter to $t$ in NGC 2323 is the cluster age. A lthough ages can be constrained from the tum-o m orphology, the hum inosity of the red giant clum $p$ is an altemative tool. NGC 2323 only show stwo bright, red ob jects which are potential post $m$ ain-sequence candidates. H ow ever, since these two ob jects do not have any $m$ em bership probability from the literature, we can not trust them as cluster $m$ em bers. Furtherm ore, the tum-o itself is not heavily popu lated preventing an accurate deter$m$ ination of its hum inosity. A s w e'll see below, we nd that $m$ odels $w$ th a range of young ages are equally consistent w ith the observed distribution.

Figure 8 presents our best synthetic CMD s for NGC 2323. All of the show $n$ cases are for Solar $m$ etallicity and assum e a $30 \%$ binary fraction $w$ ith random $m$ ass ratio.

The FST m odels (left) are found to perfectly reproduce them ajority of the observed features. The agreem ent is also found to be independent of the adopted overshooting ( $=$ 0.02 or $=0.03$ ). A lthough the age is slightly higher (by 20 $\mathrm{M} y r s)$ in the higher overshooting case, the reddening, distancem odulus and goodness of $t$ are the sam e. O urbest param eters are therefore age $=130 \mathrm{M}$ yrs, $\mathrm{E}(\mathrm{B} V)=022$, and $(\mathrm{m} ~ \mathrm{M})=10.0$ for $=0.03$. H ow ever, ages betw een 120 and 180 M yrs are equally likely. W e have chosen 130 M yrs as th is age predicts a post $m$ ain-sequence star w here a real star ( m em ber or not) is indeed located on the CM D. Therefore, the results from this work for the FST m odels are identical to the param eters found in JSK IV . T he B B C 94 stellar tracks also perfectly reproduce features on the CM D of this cluster. For $E(B \quad V)=022$, the best $t$ distance $m$ odulus is found to be ( m M ) = 102 . In practice, all ages betw een 80 and 150 M yrs t the data equally well. W e've again chosen 120 M yrs as the best age as it predicts a post $m$ ain-sequence star

in the correct location as dictated by the potential red giant in the data. The FRANEC m odels (right) predict a larger num ber of post $m$ ain-sequence stars than the FST and BBC m odels. T his is therefore inconsistent w ith the observational data. For Solarm etallicity, the best com prom ise betw een the num ber of post $m$ ain-sequence stars, the tum-o hum inosity, and the shape of the upper $m$ ain sequence is found for an age of 110 M yrs. $T$ he tum-o is still too faint, how ever, younger ages produce very vertical and blue upper $m$ ain sequences. The best $t$ reddening is $E(B \quad V)=0.22$ and the distance is $(m \quad M)=10.0$. Since the results from these latter com parisons w ere not very satisfactory, we also tried a low er $m$ etallicity, $Z=0.01$. The results are very sim ilar, $w$ ith an overproduction of post $m$ ain-sequence stars and a w orse shape to the upper $m$ ain sequence.
$F$ igure 9 show $s$ the em pirical lum inosity function of the 11115 cluster eld stars (em pty circles) com pared to the lu$m$ inosity functions resulting from the sum of the synthetic stars of $F$ igure 8 w th the 10576 stars of the extrapolated blank eld. As already discussed for NGC 2168, the lack of an appropriate estim ate of the back/foreground stars doesn't allow for a critical analysis of the lum inosity func-
tion. W e can see, how ever, from $F$ igure 8, that w ithin the uncertainties, the selected m odels reproduce quite w ell the observed lum inosity function.

A ssum ing a single slope Salpeter $\mathbb{I M} F$, the $m$ ass of gas that form ed the stars of the surveyed area of NGC 2323 between 0.6 and 100 M is ' $4: 8 \quad 10^{2} \mathrm{M} \quad$ w th the B BC 94 m odels, $4: 3 \quad 10^{2} \mathrm{M}$ and 5:0 $10^{2} \mathrm{M} \quad \mathrm{w}$ ith the FST and the FRANEC m odels, respectively.

## 6 D ISCUSSIO N

Table 2 sum $m$ arises the results described in the previous section and includes other inform ation about the four clusters studied here. W e recall that stellar $m$ odels that include overshooting from convective regions im ply older ages than m odels $w$ ithout overshooting. T his explains why our ages resulting from the FST tracks w ith $=0.03$ are system atically older than those obtained w ith the B B C 94 m odels and much older than those obtained with the FRANEC ones. It is interesting to notice that while the FST m odels w ith higher overshooting reproduce the data better than those

w th $=0.02$, the B B C 94 m odels appear to be those in better overall agreem ent, in spite of having a form al overshooting som ew hat lower than the FST $=0.03 \mathrm{~m}$ odels. T his indicates that what counts in the predictions of stellar evolution m odels is the com bination of the $m$ any param eters and input physics. W e nd that in general the BBC 94 m odels better reproduce both the $m$ orphological features and the num bers of stars in the various evolutionary phases of the observed clusters.

T he excellent delineation of the various $m$ ain-sequence curves and kinks allows us to put fairly stringent lim its on both the reddening and the distance m odulus of each cluster, independent of the age. Table 2 show $s$ in fact that the variation of the values of these tw o quantities resulting from di erent sets of stellar tracks is quite sm all. This clearly helps to better de ne the age as well.

A s discussed for the case of NGC 6819, the synthetic $m$ ain sequences of all the four clusters are tighter than the observed $m$ ain sequences when the form al photom etric errors of the survey catalogues are assum ed. To reproduce the observed width, the synthetic CM D s require either photom etric errors of at least 0.01 m agn itude even in the brighter bins or som e other factors such as an intemal m etallicity spread or di erential reddening.

The synthetic CMD tests clearly indicate that NGC 2168 is larger than previously thought and that our outer CCD blank eld is not adequate. A sim ilar problem, although to a lesser degree, m ay also exist in the NGC 2323 data set. Future deep photom etry of these clusters should include separate blank eld observations. Indeed, in spite of the great depth and excellent accuracy of our photom etry, which allows us to m easure the faintest, least $m$ assive stars of each cluster, the lack of appropriate decontam ination elds hasprevented us from safely deriving their present $m$ ass functions and, consequently, their $\mathbb{I M} F$, m ass segregation, and evaporation status.

The synthetic CM D s have allowed us to infer the astrated $m$ ass of each cluster. $W$ e nd that although this does depend on the adopted set of stellar evolutionary tracks, it only varies $w$ thin a factor 12 from the $m$ inim um to the $m$ axim um value obtained w ith the stellarm odels considered here. W e have chosen to sim ply apply Salpeter's single slope $\mathbb{I M} F$ for this exercise. W e note, how ever, that increasing evidence suggests that the slope is $m$ ost likely di erent (steeper for $m$ ore $m$ assive stars, atter for less $m$ assive ones, e.g., K roupa 2002) beyond the range ofm asses, 2 10M , originally analysed by Salpeter (1955). A though this sim plistic
assum ption introduces a system atic error in our estim ates, it is not a large concem as we are not providing absolute values of star form ation rates but rather just com paring relative rates for the four clusters.

G iven the angular size of the observed eld of view for each cluster (see Table 2), the actual area surveyed obviously depends on the adopted distance to the chister. W e have assum ed both the instrinsic distance $m$ odulus and the astrated $m$ ass resulting from the best synthetic CMD com parisons, the B BC 94 m odels. $T$ his corresponds to a distance from the Sun of 2754 pc for NGC 6819, 1259 pc for NGC 2099, 912 pc for NGC 2168, and 1096 pc for NGC 2323. T he surveyed areas are then $182,81,56$ and $72 \mathrm{pc}^{2}$, respectively. T he corresponding astrated m ass per unit area is then $23.1,32.1$, 152 and $6.7 \mathrm{M} \mathrm{pc}^{2}$, equivalent to star form ation rates of $4: 6 \quad 10^{6} ; 6: 4 \quad 10^{6} ; 3: 0 \quad 10^{6}$, and $1: 3 \quad 10^{6} \mathrm{M} \mathrm{yr}^{1} \mathrm{pc}^{2}$, respectively. T hese values refer only to stars $w$ ith $m$ asses included in the adopted sets of evolutionary tracks, nam ely from 0.6 to 100 M . To derive total astrated m asses and star form ation rates, one should extrapolate down to 0.1 M , follow ing the preferred $\mathbb{M}$ F. In practice, extrapolating Salpeter's $\mathbb{I M} F$ down to 0.1 M , we m ust $m$ ultiply by a factor 2.05 the astrated $m$ asses and the rates. If, at the other extrem e, we prefer to assum e the positive slope +0.44 below 0.6 M suggested by G ould, B ahcall \& F lynn (1997), then the above values $m$ ust be m ultiplied only by 127 .
$T$ here is a signi cant di erence ( $m$ ore than a factor of four) in the star form ation rates of our four clusters, the m ost active having been NGC 2099 and the least active NGC 2323, w ith no apparent relation w ith G alactic location. These rates are $2\{3$ orders of $m$ agnitude higher than the average star form ation rate of eld stars in the Solar neighbourhood, (2 10) $10{ }^{9} \mathrm{M} \mathrm{yr}^{1} \mathrm{pc}^{2}$ (e.g. T immes, W oosley \& W eaver 1995), and are com parable to those of the m ost active dw arf irregular and blue com pact galaxies (e.g.T osi2003 and references therein).T he survival factor of the stars form ed in any chuster clearly depends both on age and on evaporation and N G C 6819 tums out to be the only one of the four clusters having su ered a reduction from the num ber of form ed stars to that of the stars still alive and present in the studied area.

## 7 CONCLUSIONS

W e re-derive key param eters for the four very rich open star clusters, NGC 6819, NG C 2099, NG C 2168, and NGC 2323. The param eters are $m$ easured by com paring high quality,

deep em pirical colour-m agnitude diagram swith M onteC arlo sim ulations. The combination of com paring the $m$ orphology and num ber of stars in various evolutionary phases and cluster lum inosity functions allow s us to provide tight constraints on the reddening, distance, age and binary fraction for each cluster. In cases w here the cluster m etallicity is not certain, sim ulations w ith di erent abundances are also com pared. In all cases the data are better reproduced when a fraction of unresolved binary system s betw een 20 and 30\% is assum ed. A sum $m$ ary of the results is given in Table 2 .

The synthetic CM D s and LF s are generally found to be in excellent agreem ent $w$ ith the observationaldata. This circum stance, com bined w ith the fact that di erent sets of stel-
lar evolution tracks provide di erent values for the cluster param eters, con m s how im portant it is to use m ore than one set ofm odels to estim ate the theoretical uncertainties. It also show s that a hom ogeneous approach is crucial to derive reliable overall chuster properties, such as age-m etallicity relations. In fact, cluster dating based on di erent stellarm odels $m$ ay lead not only to di erent absolute ages, but also to di erent age ranking, w ith signi cant draw backs on the interpretation of the cluster properties in term $s$ of $G$ alactic evolution.

Som e discrepancies, such as the thickness of the $m$ ain sequences vis a vis the size of the photom etric errors, and the possibility that cluster stars $m$ ay be contam inating our
blank eld (particularly in the case of NGC 2168) are identi ed and discussed.

For each cluster, we also $m$ easure the astration $m$ ass (i.e., the total mass that went in all of the stars form ed in the cluster) according to a single slope Salpeter $\mathbb{I M}$ F. From this, we calculate the star form ation rate betw een 0.1 \{ 100 M to be $9: 4 \quad 10^{6} ; 1: 3 \quad 10^{5} ; 6: 2 \quad 10^{6}$, and $2: 7$ $10{ }^{6} \mathrm{M}$ yr ${ }^{1} \mathrm{pc}^{2}$ for NGC 6819, NGC 2099, NGC 2168, and NGC 2323 respectively. These rates would be a factor 1.6 lower if the $\mathbb{I M}$ F below 0.6 M has a slope of +0.44 , as inferred by Gould et al. (1997) from HST data, rather than Salpeter. The true value $m$ ay in fact lie som ew here in between these two $\mathbb{M}$ Fs, as recently discussed e.g., by Chabrier (2003). In principle our data are deep enough to allow for a direct derivation of the cluster IM F ; how ever, the four clusters are heavily contam inated by fore/background stars and the lack of appropriate decontam ination elds has prevented us from a safe analysis of the star counts at the fainter $m$ agnitudes. T he need of appropriate photom etry in nearby elds is em phasised, also for the punpose of adequate studies of the clusters $m$ ass segregation/evaporation.
