Cosm ological B lack H oles as Seeds of Voids in G alaxy D istribution

A bstract. Deep surveys indicate a bubbly structure of cosm obgical large scale which should be the result of evolution of prim ordial density perturbations. Severalm odels have been proposed to explain origin and dynam ics of such features but, tillnow, no exhaustive and fully consistent theory has been found. We discuss a model where cosm obgical black holes, deriving from prim ordial perturbations, are the seeds for large-scale-structure voids. We give details of dynam ics and accretion of the system voids-cosm obgical black holes from the epochs (z ' 10^3) till now inding that void of 40h ¹M pc of diam eter and under-density of 0.9 will to the observations without con icting with the hom ogeneity and isotropy of cosm ic m icrow ave background radiation.

K ey words: cosm ology, large scale structure, dark m atter, black hole

1. Introduction

The existence of voids has been evident after the discovery by Kirshner et al. of a large void with diameter of 60 Mpc in Bootes (Kirshner, Oem ler, Schechter & Shectman, 1981). Systematic surveys have shown the existence of many regions with similar characteristics. Computer analysis of galaxy distribution gives evidence that voids occupy about 50% of the volume of

the universe (e.g. see ElAd & Piran, 1997) or, according to a more recent paper (Hoyle F. & Vogeley, 2002), about 40% of the volume of the universe.

Today, there is a large agreem ent on the issue that voids are not just empty regions of space, but that they are regions with a very low density of lum inous matter.

As observed by Peebles (Peebles, 2001), the low dispersion of velocities of galaxies indicates that m ost ofm atter m ust be inside the voids, not only if the density parameter (for the m atter component) is $_{m} = 1$ but also in the case $_{m}$ 1. In any case, recent observations (de Bernardis et al., 2000; Perlm utter et al., 1999; Schim dt et al., 1998) indicate that the total value of density parameter is $_{m} + = 1$ where $_{m}$ ' 0.3 and ' 0.7. In this case is the contribution due to the whole content of unclustered m atter which can be cosm ological constant, som e kind of scalar eld (C aldwell, D ave & Steinhardt, 1998; de R it is et al., 2000; R ubano & Barrow, 2001; C apozziello, 2002) or, in general, "dark energy".

It is worthwhile to stress that the visual inspection of galaxy distribution suggests nothing else but the absence of large amount of lum inous matter in wide regions.Furtherm ore, it is not clear whether the voids are spherical regions approximately empty or under-dense regions with arbitrary shapes. Several de nitions of voids have been proposed, but a general agreem ent on their real nature has not been reached yet (Schmidt, Ryden & Mellott, 2001).

The Swiss-Cheese cosm ological model, initially proposed by Einstein and Straus (Einstein & Straus, 1945; Einstein & Straus, 1946), appears suitable for the description of the cosm ological voids. In a recent paper (Stomaiolo, 2002), it was proposed an approach for the form ation of the cosm ological voids in the fram ework of such model. It was shown that voids are the consequence of the collapse of extrem ely large wavelength perturbations into low-density black holes and of the com oving expansion of m atter surrounding the collapsed perturbations.

As a result, it was claimed that in the center of each void there is a black hole whose mass M compensates the mass which the void would have if it were completely led with matter having a cosm ological density.

In Stomaiolo, 2002, the voids are empty regions of the universe which grow com ovingly with the cosm ological expansion. In that case, the presence of cosm ic background radiation was neglected.

In this paper, we analyze the physical mechanism capable of explaining the structure of voids in presence of baryonic matter, cosm ic background radiation (CBR) with central black holes acting as seeds. The layout of the paper is the following: in Sect 2, we will present the cosm ological black hole (CBH) model in the fram ework of the Friedmann-Lem aître-Robertson-W alker (FLRW) cosm ology. Sect 3 is devoted to the discussion of the e ects of interaction between the CBR and CBH. A mechanism for the form ation of an under-density regime void is analyzed in Sect.4, while the matching with observations, which allows to determ ine the initial time of voids form ation and the mass function of CBHs, is studied in Sect.5. The discussion of results and conclusions are given in Sect.6.

2. The CBH modeland Cosm ology

The cosm ologicalm odelproposed in Stomaiolo, 2002 is an E instein-Straus universe which is embedded in a FLRW metric. A central spherical black hole with mass

is present in all the voids.

In Eq. (1), the param eter

represents the fraction of density due to all these black holes with respect to the total density of the universe; $_{c} = 1.88 \quad 10^{29} \text{ g cm}^{-3} \text{h}^{2}$ is the today critical density of the universe.

All the voids are assumed to be spherical.

A black hole form swhen a body of mass M collapses entirely within a sphere of radius

This statem ent is equivalent to say that its density satis es the relation,

C onversely, Eq.(4) relates to any density a corresponding Schwarzschild radius. In other words, any space-like sphere of matter, with uniform density and radius equal to R_s (), is a black hole.

From Eqs.(1) and (3), we determ ine the mass M and the corresponding Schwarzschild radius and consequently, from Eq.(4) the mass density of the central black hole. For example, a black hole in the center of a 50h 1 M pc diameter void would have a mass 1.8 10^{16} M corresponding to a Schwarzschild radius 1:7 kpc and a density of 2:34 10^{-16} gcm 3 .

The above value of density is the one reached by the collapsing matter when it crossed the Schwarzschild radius. It suggests that the process of formation of a CBH started with large wavelength perturbations at cosm obgical densities of the order of 10¹⁹g=cm³ i.e for 1 + z 10³. A coording to the in ationary scenario, we only need to suppose that the in ation occurred during a time long enough to provide such perturbations ¹.

¹ The Oppenheim er-Snyder m odel (Oppenheim er & Snyder, 1939) describes the spherical sym m etric collapse at zero pressure.

It is important to note that, since the Einstein-Strausmodel assumes spherical symmetry, the perturbation does not experience the cosm ic expansion during its collapse.

For this reason, we can assume that the totalm ass of perturbation

The Schwarzschild radius of the spherical perturbation is equal to

W e can distinguish two cases. The case in which the relation

is satis ed. The perturbation is in linear regime and, according to the evolution equations of a universe with perfect uid equation of state, it is frozen when $_i$ is larger than the Hubble radius (Mukhanov, Feldman & Brandenberger, 1992). A fier crossing the Hubble horizon, it collapses and becomes a black hole when

the perturbation evolves as shown in Stomaiolo, 2002.D uring the contraction, it becomes unavoidably a black hole if the nal density is very low and the internal pressure and temperature cannot raise to values large enough to prevent the collapse. This is true also when the perturbation enters in a non-linear regime. In addition, any possible centrifugal barrier can be reduced to values smaller than the Schwarzschild radius (Loeb, 1993) by the interaction of collapsing matter with the cosm ic background radiation. A coording to the Einstein-Straus model, after the form ation of black hole, the matter around it expands in a comoving way leading to the form ation of an empty region between it and the rest of the universe. As the central black hole cannot be seen, the whole region appears as a void to an external observer.

A CBH can be detected through its lensing properties, since it behaves like a Schwarzschild gravitational lens. A coording to our hypothesis, a CBH sits in the center of a void and the Einstein angle is (Schneider, Ehlers & Falco, 1992)

where R_V is the radius of the void, D_s is the distance of the source from the observer, D_{ds} is the distance of the source from the CBH, and D_d is the distance of the CBH from

the observer, all these quantities are expressed in M pc. For a 50 M pc void of diam eter, with the center placed at a distance of 80 M pc from the Sun and with the source at the opposite edge of the void, we expect a de ection angle

On the other hand, Zeklovich and Sazhin point out in (Zeklovich & Sazhin, 1987), that generally static structures can raise the tem perature of the cosm ic background radiation by an am ount proportional to the Hubble parameter and the gravitational time delay. By considering the Swiss-Cheese model case, they indicate the gravitation of tem perature T=T 10⁻¹⁰ for a giant galaxy (M = 4 10^{12} M). Since this result is proportional to the mass, it follows that it corresponds to a uctuation of tem perature T=T 10⁻⁵ for a large CBH with mass (M 10^{17} M), which does not contradict the recent Boom erang and W MAP measurements (de Bernardis et al., 2000; Teqm ark et al., 2003).

An interesting feauture of voids with central CBH is derived starting from a Swiss-Cheese model based on an Einstein-de Sitter cosmology. To this aim, let us consider the energy balance in Newtonian terms for a galaxy with mass m sitting on the edge of a void i.e at a distance $r = r_e a(t)$ where r_e is a covariant radius. We have

As the void is comovingly expanding, we can impose v = H $r_{\rm e}a\left(t\right)$. The mass M $_v$ inside the void is

From this relation, we see that, E = 0 if $_{tot} = _{int}$, i.e. the expansion velocity of a galaxy on the edge of a void coincides with the escape velocity². On the other hand, a galaxy on the edge of a void is gravitationally bounded with a CBH, if $_{int} > _{tot}$. In this paper, we shall adopt as de nition of edge of a void the spherical region where the galaxies have energy E = 0.

These considerations can be immediately extended to the case in which the spatial curvature is diment from zero (i.e. to Friedmann models diment from the considered E instein-de Sitter one). This simply implies that

In this case, the value of E depends also on $K = a^2$.

3. Interaction between CBR and CBH

So far we have considered the E instein-Straus Sw iss-cheese m odel in a universe lled only with m atter. In this section, we shall show how the interaction with CBR will lead to an accretion of CBH. Since the pressure of radiation is di erent from zero, the radiation itself m ay cross the edge of the voids regardless the E instein-Straus junction conditions (E instein & Straus, 1945; E instein & Straus, 1946). As we consider this physical process during the m atter epoch, we can neglect the contribution of radiation to the black hole form ation.

A CBH absorbs energy from CBR according to the law (Custodio & Horvath, 2002)

where $_{g}$ (M) = (27 G²=c⁴)M² is the gravitational cross section of CBH and $F_{rad} = _{rad}c$ is the radiation ux of CBR.

In a matter dom inated universe, (dust), the evolution of radiation density is given by

Therefore, it is evident that the BH accretion is proportional to its initial mass.

4.Under-density inside the voids

From the point of view of density, voids are under-dense regions of space depleted of galaxies with respect to the external background. W e can estimate the amount of such an under-density in the fram ework of our CBH-void model.

Taking into account the accretion process in the void, we cannot neglect the fact that, as the void increases in volume, a certain amount of galaxies enter in the void contributing to the total mass inside the void. This implies that the accretion of mass inside the void, given by (17), has to be corrected as

Factor 2 can be justied in the following way.

If we consider any mass increment in Eq.(11), it is easy to observe that the mass of galaxies entering in the void is equal to the mass increment of the black hole, if one takes into account the conservation equation for $_{tot}$. In rst approximation, one can double the righthand side of Eq.(17). To be rigorous, one should consider a delay e ect, since gravity does not propagates instantaneously. D ue to this fact, it would be correct to deal with this problem under the standard of the General Relativity. How ever, it is possible to show that the delay e ect can be neglected, at least in rst approximation.

To nd the density of galaxies und which enter to expanding voids, one has to subtract the accreted m ass of CBH, obtained from Eq.(23), to the total nalaccretion m ass, given by Eq.(26), (in the approximation $t_i = t_0$)

where and V can be retrieved from the respective values found in the catalogs (E LA d & P iran, 1997). On the other side we can also determ ine the initial m asses of the CBHs just after their form ation. This can be expressed by the form ula

5.M atching with the observations

Using the data of the volume and the under-density of voids given in the catalog of El-Ad and Piran (El-Ad & Piran, 1997) which deduced their data from SSRS2 (da Costa et al., 1988; da Costa et al., 1994) and IRAS (Fisher et al., 1995) observations, we found the following initial times and corresponding initial and nalmasses according to formulas (30, 31, 27).

D ynam ics deduced from our model is consistent with observations and seems to conm the gravitational origin of voids. In this approach, the role of dark matter has to be revised since most of the mass (about one half) of the structure is concentred in the central CBH. In this picture, it is only the density contrast between voids and background which drives dynamics. CBHs are just the remnant of primordial collapsed perturbations while voids, or precisely the edges of voids, are the result of perturbations which wavelength following the cosmic expansion. The whole system, also if expanding and interacting with CBR, remains in equilibrium.

6.D iscussion and Conclusions

In this paper, we have developed a model where $\cos m$ ological black holes are seeds for large scale structure voids. Such systems come out from the evolution of primordial perturbations and result as stable structures from (z ' 10^3) up to now. They enlarge till diam eters of about 40h ¹M pc and the under-density of voids is of the order 0.9 with respect to the background. The whole structure is a sort of honeycom bs where m ost of galaxies (i.e. lum inous matter) are located on the edge of voids while m ost of dynam ical m ass is sited in the central black hole. The edge is de ned by a natural equilibrium condition on the energy due to the balance of gravitational pull of the central black hole.

black hole and the cosm ic expansion. The cosm ic background radiation contributes to the accretion of black hole owing inside the void but its hom ogeneity and isotropy is not a ected in agreement with data. The picture which emerge agrees with optical and IRAS observation (E LAd & Piran, 1997) giving a 50% of the volume led by voids with the above characteristics. The presence of central black holes seems to con m the gravitational origin of the voids and stabilizes the system against cosm ic expansion preventing its evaporation.

It is interesting to note that the order of m agnitude observed for the m asses of CBH concides with the one of the G reat Attractor (Fairall, 1997). It is very tempting for us to identify the G reat Attractor as a CBH and to use the m odel described in this paper for explaining the large scale m otions observed for the galaxies surrounding it.

However, the main problem with observations of cosmic velocity elds (Faber, Courteau, Dekel, Dressler, Kollatt, W illick & Yahil, 1994) is that the voids are, in general, the contrary to G reat Attractor, and large scale structure around the voids do not show velocity elds converging toward the voids, but toward the visible clusters and superclusters around the voids. This apparent shortcom ing, in the fram ew ork of our m odel (see also Stomaiolo, 2002), can be overcom e by the Birko theorem which states that the stationary solutions are also static if the spherical symmetry is restored. So, a fraction of galaxies is attracted by clusters and superclusters "outside" the void while another fraction has no dynamics since it has been already attracted "inside" the void. This fact could be interpreted as an early selection due to a competitive mechanism between CBHs and externalm atter contained into clusters and superclusters.

However, if the Swiss-Cheese model were always valid such a selection would have never been achieved; instead, in a more realistic situation, the model holds only approximately so then we have to expect galaxies inside and outside the void due to the deviations from sphericity and to the perturbations of the CBH mass.

Furtherm ore, as observed in D avis & Peebles, 1983 and Peebles, 2001, the sm all relative velocity dispersion shows that, if $_{\rm M}$ = 1, then m ost of the m ass has to be contained into the voids. The same authors conjecture that this must be true even when $_{\rm M}$ is sm aller than 1 as predicted by several CDM simulations.
