Abstract. One of the goals of the ground-based support program for the corot and mons/r mer satellite m issions is to characterize suitable target stars for the part of the m issions dedicated to asteroseism ology. We present the detailed abundance analysis of nine of the potential corot m ain targets using the sem i-autom atic software vwa. For two additional corot targets we could not perform the analysis due to the high rotational velocity of these stars. For ve stars with low rotational velocity we have also performed abundance analysis by a classical equivalent width m ethod in order to test the reliability of the vwa software. The agreement between the di erent m ethods is good. We not that it is necessary to measure abundances extracted from each line relative to the abundances found from a spectrum of the Sun in order to remove system atic errors. We have constrained the global atm ospheric parameters  $T_{\rm e}$ , log g, and [Fe/H] to within 70 100 K, 0.1 0.2 dex, and 0.1 dex for ve stars which are slow rotators (v sin i < 15 km s <sup>1</sup>). For m ost of the stars stars we nd good agreement with the parameters found from line depth ratios, H lines, Strom gren indices, previous spectroscopic studies, and also log g determ ined from the hipparcos parallaxes. For the fast rotators (v sin i > 60 km s <sup>1</sup>) it is not possible to constrain the atm ospheric param eters.

# 1. Introduction

corot (COnvection, RO tation, and planetary Transits) is a small space m ission, dedicated to asteroseism ology and the search for exo-planets (Baglin et al. 2001). Am ong the targets of the asteroseism ology part of the m ission, a few bright stars w ill be m onitored continuously over a period of 150 days. These bright targets w ill be chosen from a list of a dozen F & G-type stars, located in the continuous view ing zone of the instrum ent. The nalchoice of targets needs to be made early in the project, as it will impact on some technical aspects of the mission. A precise and reliable know ledge of the candidate targets is required, in order to optimize this nalchoice.

Am ong the inform ation which needs to be gathered on the candidate targets, fundam ental param eters like effective tem perature, surface gravity, and m etallicity will play a major role in the selection of targets for corot. Projected rotation velocities, as well as detailed abundances of the main chemical elements will also be taken into account in the selection process. bfT hus, the aim of this study is to obtain im proved values for the fundam en-

talparam eters and abundances of individual elements for the corot m ain targets.

This information on the targets will subsequently be used for the selected stars, in conjunction with asteroseismological data obtained by corot, to provide additional constraints for the modelling of the interior and the atm ospheres of these stars.

In Sect.2 we sum m arize the spectroscopic observations and data reduction, in Sect. 3 we discuss the determ ination of the fundam ental param eters from spectroscopy, photom etry and hipparcos parallaxes and we sum m arize previous spectroscopic studies of the target stars. In Sect. 4 we describe the three di erent m ethods we have used for abundance analysis. In Sect. 5 we discuss how we constrain the fundam ental atm ospheric param eters using abundance results for a grid of m odels. In Sect. 6 we discuss the abundances we have determ ined. Lastly, we give our conclusions in Sect. 7.

# 2. Spectroscopic observations

W e have obtained spectra of each one of the 11 candidate m ain targets of corot, using the elodie spectrograph attached to the 1.93m telescope at O bservatoire de H aute-P rovence (OHP). elodie is a ber-fed cross-dispersed E chelle spectrograph, providing a com plete spectral coverage of the 3800{6800 A region, at a resolution of R =  $45\,000$  (B aranne et al. 1996). Table 1 gives the log of the observations for the spectra used in this analysis.

# 2.1.Data reduction

W e used the on-line inter-tacos reduction package available at O H P (B aranne et al. 1996). This software performs bias and background light subtraction, spectral order becalization, and nally extracts spectral orders using the optim alextraction procedure (H orne 1986). The high spatial frequency instrum ental response is corrected by dividing the stellar spectra by the spectrum of a at-ekl km p. W avelength calibration is provided by spectra of a Th/A r km p, using a two-dim ensional C hebychev polynom ial t-ting to the centroid locations of the Th/A r lines.

Special care was taken to correct for the grating blaze function, as di erences in the spectrograph illum ination between stellar and at-eld light beam susually result in an imperfect correction. Instead of using a at-eld spectrum, we have therefore used a high signal-to-noise spectrum of an 0-type star, 10 Lac, to determ ine the blaze function. The orders of the 10 Lac spectrum were exam ined one by one, and the line-free regions of each order were identied. The blaze function at each spectrograph order was then represented by cubic splines tted to these line-free regions, and the stellar spectra were subsequently divided by this new ly determ ined blaze function. This procedure results in an adequate blaze correction, producing in particular a good m atch of ad acent orders in the overlapping regions. Note also that elodie is a very stable instrum ent, so that only one spectrum of 10 Lac was used to de ne the blaze function, although the observations reported here span several years.

Since the overallblaze function was removed by a star of much earlier spectral class than the observed F and G – type stars the continuum levelwas not entirely at.Hence we made cubic spline ts to make the nal continuum estimate. For the overlapping part of the orders we made sure that the overlap was better than 0.5%.

We are aware of the problem of thing low-order splines to correct the continuum. In this process we manually mark the points in the spectrum which we assume are at the continuum level. When using the vwa software (B runtt et al. 2002, cf. Sect. 4.2) we can inspect the the lines and in this way detect problems with the continuum level. In these cases we reject the abundances found for these lines (cf. Sect. 4.5). A Itematively, one could select \continuum windows" from a synthetic spectrum or a spectrum of the Sun and use this to correct the continTable 3.0 verview of the parameters of the proposed corot main targets. uum level.Thishasbeen attem pted for one of our program stars in Sect. 4.4.

for the two stars, respectively. This is a clear indication that it is worthwhile to use severalm ethods to try to determ ine the fundam entalparam eters.

# 3. Fundam entalatm ospheric param eters

In this Section we will discuss previous results for the fundam ental atm ospheric param eters of the proposed corot targets.We will present the results from the calibration of Strom gren photom etry, line depth ratios, H line wings, and hipparcos parallaxes.

### 3.1. Strom gren photom etry

The Strom gren indices of the target stars are taken from the catalogue of H auck & M erm illiod (1998) and are listed in Table 2.W e have used the software templogg (R ogers 1995, see also K upka & B nuntt 2001) to nd the appropriate calibration to obtain the basic parameters, i.e.  $T_{\rm e}$ ; logg, and [M /H  $_{\rm phot}$ . These parameters are given in Table 3. The accuracy of the parameters  $T_{\rm e}$ , logg, and [M /H  $_{\rm phot}$  are around 200{250 K, 0.3 dex, and 0.2 dex according to R ogers (1995).

A catalogue of Strom gren indices determ ined for all prim ary and secondary targets for corot is available from the gaudi database<sup>1</sup>. We also used these data to get the fundam ental param eters. For most stars both  $T_e$  and logg agree within the uncertainties quoted above. But for HD 43587 and HD 45067 we nd a large discrepancy, i.e. logg higher by 0.2/0.3 dex and a higher  $T_e$  by 350/300 K

# 32. Tem perature Calibration from Line Depth Ratios

K ovtyukh et al. (2003) have used spectra of 181 m ain sequence F-K type stars to calibrate the dependence of line depth ratios on  $T_e$ . They used observed spectra from ELOD IE (the same spectrograph we used) and their sam – ple of stars consisted of stars for which  $T_e$  is well determ ined, e.g. using the infrared ux method.

We measured line depths by tting a Gaussian prole to each line, i.e. the depth of the Gaussian denes the line depth. We used  $T_e$  from the Strongeren photometry as our initial guess (assuming the error is  $(T_e) = 250 \text{ K}$ ) to select which of the calibrations by K ovtyukh et al. (2003) that were valid. We note that for each pair of lines dening the ratio calibration the species of elements are typically di erent (e.g. Si/T i, Fe/S etc.), but we refer to K ovtyukh et al. (2003) for details. Typically 50{80 line depth ratios between lines could be used. We then calculated the mean  $T_e$  and rejected 3 outliers and recalculated  $T_e$ . The calibrations are only valid in the range 4000{6150 K so only the four coolest corot target stars could be used with this method.

The results are given in Table 3 for these stars and the Sun.The  $T_{\rm e}~$  we determ ine from the spectrum of the Sun agrees with the canonical value of  $T_{\rm e}~=~5777~K$ .The quoted errors of 5–17 K on the tem peratures are form al

errors, and system atic errors of the order 50–100 K  $\,\rm m\,ust$  be added.

#### 3.3. Tem peratures from H lines

W e have estimated  $T_e$  of the stars considered in this study using their H line proles, following a method proposed by Cayrelet al. (1985) and Cayrelde Strobelet al. (1994). The method is based on the property of H that it is insensitive to any atm ospheric parameter except  $T_e$  in in the range between 5000{8500 K.

In order to overcom e problem sdue to continuum placement, we compute the ratio of the observed H prole to that of the Sun, observed with the same instrumental conguration (spectrum of the solar released light on the moon surface), then compare it to the corresponding ratio of theoretical proles computed from a grid of models. The best t between computed and observed prole ratios gives the elective temperature with an internal error bar of about 50 K.

We have used the new grids of at las9 models presented in Heiter et al. (2002), choosing the models with M LT convection treatment for  $T_e$  lower than 8750 K, with the low value for the e ciency parameter of the convection, following Fuhrmann et al. (1993), A xer et al. (1994), and Heiter et al. (2002).

The H line prole is computed using balmer9 (Kunucz 1998) which includes the Vidalet al. (1973) unied theory for the Stark Broadening and also takes into account the self resonance mechanism in the computation of the H prole.

This method if found to be reliable for  $T_{\rm e}~$  between 5500 and 8500 K.Below 5500 K, the H ~ pro le is not sensitive enough to  $T_{\rm e}~$ , and does not constitute a good tem perature tracer. Above 8500 K, the H ~ wings depend

only slightly on  $T_{\rm e}\,$  , and start to becom e sensitive to gravity.

We nd that the nal  $T_{\rm e}$  estimate is insensitive to the choice of convection description. On the other hand Heiter et al. (2002) nd that the (b  $\,$  y) index and hence  $T_{\rm e}\,$  found from the Stromgren indices is sensitive to the convection description.

The  $T_{\rm e}~$  m easurem ents with this m ethod are also reasonably insensitive to rotation, for v sin i below 80{100 km s  $^1}.$ 

#### 3.4. Com parison of tem perature estim ators

Except for HD 43318 there is very good agreement between  $T_{\rm e}~$  from the Strom gren calibration (templogg) and the line depth ratios. However,  $T_{\rm e}~$  of HD 43318 is on the border of the valid range of the latter calibration . The  $T_{\rm e}~$  from the H lines agrees with the other twom ethods but only for stars with low v sin i. The stars in our sample with moderate v sin i also have the highest  $T_{\rm e}$ , and the discrepant results for the H lines may be an indication that this method cannot be used for these stars.

# 3.5. Using hipparcos parallaxes to determ ine logg

We have used hipparcos parallaxes (ESA, 1997) to nd the surface gravities of the stars. We use the equation  $\log g = 4 [\Gamma_e ] + [M] + 2 \log + 0.4 (V + B C_V + 0.26) + 4.44, where <math display="inline">[\Gamma_e ] = \log (T_e = T_e )$  and  $[M] = \log (M = M)$ . We use  $T_e$  from templogg and we determ ine the bolom etric correction  $B C_V$  from Bessell et al. (1998): we used their results for solar m etallicity and no overshoot. We have estim ated the m asses of the stars by using the evolution tracks by G irardi et al. (2000). The evolution tracks for solar m etallicity is shown in Fig. 1 in which the locations

of the corot targets are also shown along with error bars. W e have made interpolations in models form etallicity Z = 0.019 (solar) and Z = 0.008. For example, HD 49933 has the low est m etallicity in the sample: the derived mass is M = M = 1.17, signi cantly low er than estimated from its position relative to the solar m etallicity isochrones shown in Fig.1.

The determ ination of logg when using the calibration of Stromgren indices and the hipparcos parallax are shown in Fig. 2. Mean error bars which are representative for all the stars are shown in the lower right corner. Note that the two most important error sources for logg are  $T_e$  and the mass. The results for logg and logg<sub>phot</sub> agree very well. The mean difference is  $(\log g_{\rm phot} \log g) = 0.05 \quad 0.22$ .

#### 3.6. Previous spectroscopic studies

Lastennet et al. (2001) (hereafter LLB) have analyzed some of the potential corot targets and they used the sam e spectra we have used in this study: we have six stars in common with LLB (compared in Table 4). LLB have also used the H hydrogen lines to determ ine  $T_e$  . The fact that the H line covers three E chelle orders m akes the determ ination of the continuum a di cult task, hence the error on  $T_e$  is around 250 K.LLB have compared Johnson and Strom gren photom etric indices of observations and calculated m odel atm ospheres in order to determ ine  $T_e$ , logg, and [Fe/H]. The  $T_e$  estimates made by LLB agree wellw ith the results from templogg although the two di erent techniques (H lines and photom etry) show system atic di erences at the 100 K level, LLB have used Fe i and Fe ii lines in a lim ited spectral region to estim ate Fe/H] and logg to within 0.2 dex and 0.5 dex and these results also agree with templogg within the error bars. The exception is for their star HD 46304 but this is probably due to its high v sin i = 200 km s<sup> $\perp$ </sup>.

Vogt et al. (2002) have found a low-m ass companion around HD 43587 in a campaign to search for exo-planets. From their K eck spectra they nd  $T_{\rm e}$  = 5795 K, Fe/H ]= 0.03, and v sin i = 2.7 km s $^1$  (Vogt et al. 2002 have not quoted errors on  $T_{\rm e}$  and m etallicity).D.Fisher (private communication) has re-analysed the K eck spectrum and nds  $T_{\rm e}$  = 5931 100 and Fe/H ]= 0.00 0.05.

The extensive catalogue by C ayrel de Strobel et al. (2001) contains fundamental atmospheric parameters found in the literature based on analyses of medium high resolution spectra. The catalogue contains results from several studies for most of the stars exam ined here, but unfortunately, no individual error estimates are given by the original authors. In Table 4 we sum marize the parameters from these studies (Ref. 2, 4, 5, 7 & 8) along with our new results (Ref. 1a{c}. The references in column ve of Table 4 are listed in detail in Table 5. Note that for LLB we give two results: (9a) which corresponds to their result when comparing observed and synthetic colour-indices in B V, U B, and b y; (9b)  $T_e$  is determined from

the H line while logg and [Fe/H] are determined from a small sample of Fe i and Fe ii lines in a region around 6130 A.

## 4. A bundance analysis

N ine stars were analysed with the sem i-autom atic software vwa (H.Bruntt { HB ) while two groups (I.F.Bikm aev { IFB { and M.G illon/P.M again { MG/PM ) m ade an independent analysis by m eans of using the equivalent width of isolated lines for som e of the slow ly rotating stars. W e will describe each m ethod here before com paring the reTable 5. The references for Table 4.

sults. Firstly, we shall discuss the atm ospheric m odels we have applied.

# 4.1. Atm ospheric m odels

Form ethod A and B (see below) we have used a modi ed version of the atlas9 code (K unucz 1993) for the calculation of the atm ospheric models (K upka 1996, Sm alley & K upka 1997) in which turbulent convection theory in the formulation of C anuto & M azzitelli (1991, 1992) is im plemented. For method C the standard atlas9 models (K unucz 1993) with mixing length parameter = 1.25 were used.

For the extraction of models in a grid with di erent  $T_e$ and  $\log g$  we have used interpolation in the grid of models (also modi ed at las9 models) distributed by H eiter et al. (2002). We have used these interpolated models to make abundance analysis in order to constrain the fundamental parameters in Sect. 5.

# 4.2. Autom atic abundance analysis with vw a (M ethod A)

W e have used the sem i-autom atic software package vwa (B runtt et al. 2002) to carry out the abundance analysis of nine corot targets. For each star the software selects the least blended lines from atom ic line list data extracted from the vald data base (K upka et al. 1999). The atom ic data consist of the element name and ionization state, wavelength, excitation potential, oscillator strength, and dam ping param eters. For each selected line the synthetic spectrum is calculated and the input abundance is changed iteratively until the equivalent width of the observed and synthetic line m atch. W e used synth (version 2.5, see Valenti & P iskunov 1996) to calculate the synthetic spectrum . This software was kindly provided by N. P iskunov (private com m unication).

# 42.1. Rotational velocities

In order to be able to com pare the observed and synthetic spectra the latter is convolved by the instrum ental pro le (approxim ated by a Gaussian) and a rotational broadening pro le. The projected rotational velocities were determ ined by thing the synthetic spectrum of a few of the least blended lines to the observed spectrum by convolving with di erent rotation pro les. Note that we have used zero m acroturbulence, and thus our quoted values for v sin i is a combination of the e ects of rotational broadening and macroturbulence. The accuracy of vsiniby this method is about 5{10%. LLB used a more re ned method (see Donati et al. 1997) but our results agree within the estim ated errors. The exception is for HD 43587 for which we have found 7 km s<sup>1</sup> while Voqt et al. (2002) nd  $v \sin i = 2.7$  km s<sup>1</sup>. Note that D. Fisher nds  $v \sin i$ = 2.2 km s<sup>1</sup> from the same spectrum (private communication). These lower values agrees with LLB and consequently we have used a low value of v sin i= 2:5 km s<sup>1</sup>. The reason for the apparent discrepancy is simply the lim it of the spectral resolution of the elodie spectrograph i.e. v = c=R' 7 km s<sup>1</sup>. Note that since vw a relies on the m easurem ent of equivalent widths sm all errors in v sin i will have a negligible e ect on the derived abundances.

# 4.2.2. M easuring abundances relative to the Sun

D uring our analyses with vwa we have found that when m easuring abundances relative to the same lines observed in the Sun there is a dram atic decrease in the error. Since the abundance of the Sun is well-known (e.g. G revesse & Sauval 1998) we have decided to make a di erential analysis. There are several sources of error that may a ect the derived abundances but the most important error is erroneous log gf values. Incorrect rem oval of scattered light when reducing the spectra will cause system atic errors.

In Fig.3 we show the iron abundance for several lines versus both equivalent width and low er excitation potential for HD 57006. In the top panel we show the direct results while in the bottom panel the abundances are measured relative to the results for the Sun (line-by-line). For the zero point we used  $\log N_{Fe}=N_{tot} = 4.54$  from G revesse & Sauval (1998). The open symbols are used for neutral ion lines (Fei) and led symbols for ionized Fe lines (Feii).

Note the dram atic 40% decrease in the uncertainty for the neutral ion lines when measuring relative to the Sun (bottom panel in Fig. 3). Also, the discrepancy in abundance found from Feiand Feiilines is removed. For the applied atm ospheric model of HD 57006 there is no correlation with either equivalent width nor excitation potential. Also, both Feiand Feiigive the same result which indicates that the applied model is correct.

For the results presented in this work we have measured abundances relative to the abundance found for the same lines in the spectrum of the Sun. However, we have not done this for the star HD 49933 and the stars with higher v sin i since we see no signi cant in provement for these stars. The reason is that these stars are much hotter than the reference star ( $T_e > 1000 \text{ K}$ ). This means that the Sun and the hotter stars have relatively few lines in common which are suitable for abundance analysis. However, it is likely that this is an indication of inadequacies of the model atm ospheres.

# 423. Adjusting the microturbulence

For each model we adjust the microturbulence t until we see no correlation between the abundances and equivalent widths found for the Fei, Cri, and Nii lines. To minimize the e ect of saturated lines we only use lines with equivalent width below 100 m A and for Fe we only use lines with excitation potential in the range 2{5 eV to m in im ize the e ect of erroneous Te of the model atm osphere. For some stars only Fe could be used due to a lack of non-blended Cr and Ni lines. For the slow ly rotating stars (v sin i < 25 km s  $^{1}$ ) the error on  $_{t}$  is about 0:1 0.2 km s<sup>1</sup>, for the stars rotating moderately fast  $(50 < v \sin i < 85 \text{ km s}^{1})$  the error is 0:5 km s<sup>1</sup>, and 0:7 km s<sup>1</sup> for HD 55057 which has v sin i = 120 km s<sup>1</sup>. The contribution to the error on the abundances from the uncertainty of the microturbulence is about 0.03 dex for Fe for the slow rotators while for stars with the highest v sin i (HD 49434 and HD 55057) the errors in the abundances are of the order  $0.07\{0.10 \text{ dex}$ .

For each star we made the abundance analysis for a grid of models in order to be able to constrain  $\rm T_e~$  and logg which will be discussed in Sect.5.

#### 4.3. "Classical" abundance analysis (M ethod B)

"C lassical" abundance analysis was applied (IFB) to three of the slowly rotating corot targets { HD 43587, HD 45067, and HD 57006 { and to the solar spectrum (observed re ection from the M oon).

M odel atm ospheres were calculated as described in Sect. 4.1 with the adopted param eters of  $T_{\rm e}$ ,  $\log g$ , and solar composition. E ective temperatures were determined by using Johnson and Stromgren color-indices extracted from simbad data base and the logg param eters were determined by using hipparcos parallaxes as outlined in Sect. 3.5. The values we have used are given in Table 4 m arked with R ef. 1b. These param eters were not changed during our analysis with m ethod B.

Equivalent widths of all identied unblended and som e partially blended spectral lines were measured by using dech software based on PC (Galazutdinov 1992). Abundance calculations were performed in the LTE approximation by using width9 (Kurucz 1993; with modi – cations by V.T sym baland L.M ashonkina for PC, private communication). A tom ic parameters of the spectral lines were extracted from the vald data base with corrections of oscillator strengths in a few cases as described in the paper of B ikm aev et al. (2002).

Lines with equivalent widths < 100 mA were used when possible to decrease in uences of microturbulence and inaccurate damping constants. For each star the microturbulence was chosen as to minimize the correlation between the abundances and equivalent widths found for Fe, Cr, Ti, Ni, and Co lines.

# 4.4. Abundance analysis after continuum re-norm alisation (M ethod C)

A som ewhat di erent approach was followed by two of us (M G and PM ) and tested on HD 43587.

First, the continuum was redeterm ined on the basis of a num ber of pseudo-continuum windows selected from inspection of the Jungfraujch solar atlas (Delbouille et al. 1973). These windows were selected to be as close as possible to the true continuum and the mean level was measured in each of them. In all cases, it is between 99% and 100% of the true continuum. The same windows are used for the program star, after correction for its radial velocity and after checking that no telluric lines enter the window because of the Doppler shift. The mean ux is then measured in the stellar windows and a table is constructed, containing the ratio of the mean ux in the star versus the mean ux in the Sun. A spline curve is then tted through these points and the stellar spectrum is divided

by that curve, thus providing our re-norm alized spectrum . It may di er from the norm alization described in Sect.2.1 by 1%, which is not negligible at all when weak lines are considered.

Then, a list of very good lines is selected by inspection of the solar atlas, and equivalent widths (EW s) are measured by least-squares thing of Gaussian and Voigt pro-

les. Voigt pro les are generally necessary to adequately t the lines in the very high resolution solar atlas, as well as for the medium and strong lines in the stellar spectrum . For the weakest stellar lines, G aussians are generally adequate. The tted pro le is compared to the observed one and the line is rejected if any signi cant discrepancy appears (e.g. line asymmetries).

B oth the star and the Sun are analysed by using m odels extracted from the same grid (at las9 m odels; K urucz 1993). The line oscillator strengths are adjusted so that the solar EW s are reproduced, using the adopted solar m odel and the known solar atm ospheric param eters and abundances (sim ilar to what is described in Sect. 4.2.2). W henever possible, we use damping constants as calculated by A nstee & O M ara (1995), which have proved to be quite accurate (Anstee et al. 1997 and Barklem & O M ara 2000).

The microturbulence is determined in order to remove any correlation of the computed abundance with the line EW , using sets of lines from the same ion and sim ilar ex-

citation potentials. We chose to determ ine the e ective tem perature by pure spectroscopic means, using excitation equilibria, i.e. by ensuring that abundances deduced from lines of the same ionic species do not depend on the line excitation potential. The surface gravity was determined from ionization equilibria, by ensuring that lines of neutral and ionic species of the same element give the same abundance.

As an illustration of the coherence of the m ethod, let us consider the determ ination of the m ost critical param – eter, i.e.  $T_{\rm e}$ . W e used three excitation equilibria, which give the following  $T_{\rm e}$ :5866 18 K (Fe i), 5850 102 K (Cr i) and 5880 57 K (N i i). The error bars are deduced from the uncertainty in the slope of a straight line tted to abundances vs. excitation potential. A weighted m ean gives  $T_{\rm e}$  = 5867 17 K, taking into account the three individual error bars as well as the scatter in the three determ inations. The internal error bar on  $T_{\rm e}$ , taking into account the uncertainties in the other param eters, am ounts to 20 K. The other param eters are:  $\log g$  = 4:29 0:06 and  $v_{\rm turb}$  = 2:13 0:1 km/s.

# 4.5. Com parison of the abundance analysis m ethods

The three m ethods described above have di erent advantages and disadvantages. M ost importantly, vw a (m ethod A) relies on the computation of the synthetic spectrum

and thus this m ethod can be used for stars with m oderately high v sin i when a mild degree of blending of lines is tolerated. A lso, vw a is a sem i-autom atic program and the user m ay easily inspect if the tted lines actually m atch the observed spectrum .W hen comparing the observed and synthetic spectrum obvious problem s with the continuum level can be found: errors of just 2% of the continuum level will give large di erences in the derived abundance | perhaps as m uch as 0.1{0.2 dex and such lines are rejected after visual inspection.

M ethod B and C both rely on m easuring equivalent widths. It is a much faster m ethod computationally, but special care has to be taken to avoid system atic errors from line blends.

In Fig.4 and in Table 6 we show the com parison of the nalabundance analysis results using the three m ethods described above. W e show the di erences in abundance in the sense \m ethod A " m inus \m ethod B ". W e show results for four di erent stars with low v sin i for which both these m ethods are applicable. For the star HD 43587 we also show result \m ethod A " m inus \m ethod C ". The di erences refer to the m ean abundances, i.e. the lines are not necessarily the sam e in the di erent analyses.

The plotted error bars in Fig. 4 are calculated as the quadratic sum of the standard deviation of the mean for each method. In the cases where we have fewer than we lines we have no good estimate of the error, but from the elements with more lines we nd that an overall error of 0.15 dex seems plausible. Thus, in these cases we have plotted a dashed error bar corresponding to 0.15 dex.

The comparison of method A and C for HD 43587 shows excellent agreem ent for all elements despite the quite di erent approaches. W e em phasize that Te and logg have been adjusted as a part of the analysis for these two methods and the agreement is remarkable, T  $_{\rm e}$  =  $3 \ 62 \text{ K}$ ,  $\log q =$ 0:09 0:16, Fe/H = 0:04 0:14; see Table 4 for the individual parameters (Ref. 1a and 1c). However, the results from method C have signi cantly low er form al error on the fundam ental param eters. It is likely that the renorm alization of the spectrum done with m ethod C is the reason for this improvement, and should be considered in future analyses. The good agreem ent in the derived fundam ental param eters m ay be an indication that the errors quoted in Table 4 for method A (ref. 1a) are too large.

In this context we mention Edvardsson et al. (1993) who carried out an abundance study of 189 slowly rotating F and G type stars using data of sim ilar quality. Edvardsson et al. (1993) used xed values for the atm ospheric parameters and found abundances from a small num ber of lines. Their quoted m s scatter on the abundances is lower than we nd here, but this is may be due to the small number of carefully selected lines. For example Edvardsson et al. (1993) use typically 15 Fe i lines while 150 200 Fe i lines. M ore im porin this study we use tantly, Edvardsson et al. (1993) norm alized their spectra by de ning \continuum windows" from spectra of the Sun and Procyon. The fact that Edvardsson et al. (1993) obtain abundances with sm aller scatter m ay indeed be due to their careful norm alization of the spectra.

The comparison between method A and B show signi cant system atic di erences of the order 0:05 0:10 dex between neutral and ionized abundances of T i, C r, and Fe. The worst case is for star HD 45067 where we nd a system atic o set of 0.1 dex between method A and B. The reason for these discrepancies is that the models used by vw a and the classical analysis have slightly di erent parameters, i.e. di erences in logg and  $T_{\rm e}$  of the order 0.1–0.2 dex and 80–100 K.

Based on the generally good agreement between the three analyses, we have used the results from method A (vwa) for all the stars since they were analysed in a homogeneous way. In Sects. 5 and 6 we will describe in detail the analysis of the results from vwa.

# 5.Constraining model parameters

In order to measure the sensitivity of the derived abundances on the model parameters we have made the abundance analysis for a grid of models for each star. For this purpose we used the vwa software. For the initial model we have used logg values from hipparcos parablaxes and metallicity from templogg. For  $T_e$  we used results from templogg for the hot stars but we used the result from line depth ratios for the cooler stars (as discussed in Sect. 3). We have then carried out abundance analysis ofm odels with lower and higher values of  $T_e$  and logg, i.e. at least vem odels for each star. For each model we adjust the microturbulence to minimize the correlation between abundance of Fe i, Cr i, and T i lines and the measured equivalent width.

C hanges in the m odeltem perature will a ect the depth of neutral lines while changes in log g will mostly a ect the lines of the ionized elements. Furtherm ore, changes in  $T_{\rm e}$  will a ect the correlation of Fe abundances (and in some cases C r and N i) and the low er excitation potential (E  $_{\rm low}$ ;

cf.theBoltzm ann equation).By requiring that there must be no correlation with  $E_{low}$  and the least possible di erence between neutraland ionized lines of the same element (from this point we call this \ion-balance") we have constrained  $T_e_{\rm e}$  and logg.In the next Sections we will discuss the results for the stars with slow (v sin i< 25 km s $^1$ ) and m oderate rotation.

# 5.1. Constraining $T_{\rm e}~$ and $\log g$ for the sbw rotators

To give an impression of how well we can constrain the fundam ental atm ospheric param eters and the uncertainty of the derived abundances, we show the abundances found for di erent m odels for the stars HD 43318 in Fig. 5 and HD 57006 in Fig. 6 As discussed in Sec. 4.2.2 the abundance of each line is measured relative to the abundance found from the spectrum of the Sun where the zero points are from G revesse & Sauval (1998). Open symbols indicate that less than ve lines are used for the abundance estimm ate. Triangles are used to indicate a signi cant (> 1 ) slope when tting a line to abundance vs. E  $_{\rm low}$ . The triangle symbol points down (up) if the correlation is negative (positive).

We will discuss in detail the results for HD 43318 shown in Fig.5 for vedierentmodels. The parameters of the reference model is given below the plot ( $T_e = 6191$ K,

logg = 4:0, and m icroturbulence  $_{\rm t}$  = 1:4 km s <sup>1</sup>) and the adjustments for the di erent models are given as T  $_{\rm e}$ , logg, and  $_{\rm t}$ . For example, in model 2, we have added 209K to T $_{\rm e}$ . This essentially creates ion-balance for Fe and Cr but not for T i. But a higher T $_{\rm e}$  results in a negative correlation for Fe i abundance and E  $_{\rm low}$  which is marked by a triangle symbol pointing down in Fig. 5. For model 3 we have decreased logg which also restores the ion-balance, but now a positive correlation of Fe ii and E  $_{\rm low}$  is the result. The model with T  $_{\rm e}$  = 70 K and logg = 0:3 dex is our preferred model.

The results of four models of HD 57006 are compared in Fig. 6. These models have a much better agreement in the ion balance for both Si, Ti, Cr, and Fe. It is seen that changing logg by 0.2 dex or  $T_e$  by 150 K in the model clearly breaks the ion balance and also results in correlations with Fe i abundance and E low .

For the remaining slow ly rotating stars we show the abundance pattern for the best models in the column  $1{5}$  in Fig. 7. It can be seen that the ion balance for Fe, Cr, and Fe is within the errors bars in all cases for these stars.

#### 5.2. Constraining $T_e$ and $\log g$ for m oderate rotators

Column  $6{9 in Fig. 7 shows the abundance pattern for the four stars with moderate v sin i.$ 

The star HD 49434 is a moderately fast rotator (v sin i = 84 km s<sup>1</sup>). Here we nd no usable Cr lines and thus have only used the ion balance for Fe to adjust  $T_e$  and logg, but with the constraint that there must be no correlation of Fe i abundance and E <sub>low</sub>. This approach, how ever, is connected with large uncertainties due to the blending of lines. HD 49434 was also analysed by B nuntt et al. (2002). In the present study we have included m ore Fe i lines but our result agrees well with B nuntt et al. (2002).

The star HD 55057 has  $v \sin i = 120$  km s<sup>1</sup> and there are only very few lines usable for abundance analysis.

For the moderately high rotators HD 171834 and HD 184663 (v sin i ' 50 60 km s<sup>1</sup>) there is a highly signi cant di erence in the abundance found from neutral and ionized lines of Cr and Fe. A djusting logg and  $T_e$  cannot produce a coherent result. The logg we have found for HD 171834 is 0.5 dex higher than what we nd from the hipparcos parallax and also results from the literature (cf. Table 4), but it is still within the large error of 0.5 dex.

#### 5.3. Sum m ary of the param eter estim ation

In Sect. 5.1 we have estimated how well we can constrain  $T_{\rm e}$  and logg for two slow rotators.From a similar analysis for all ve slow rotators (v sin i < 15 km s  $^1$ ) we nd that we can constrain  $T_{\rm e}$  and logg to within 70  $\,$  100 K and 0.1  $\,$  0.2 dex, respectively. However, these error estimates do not include possible systematic errors due to the sim – pli cations of the applied 1-D LTE atm ospheric models.

W e are planning a future study of the importance of the applied models.

W e have four stars in our sam plew ith m oderately high v sin iwhich m akes it di cult to constrain the atm ospheric param eters. The errors on  $T_{\rm e}$ , logg, and [Fe/H] are about 200 K, 0.5 dex, and 0.15 dex, respectively.

W ith the analyses provided here logg cannot be constrained better than with the parallax from hipparcos but it gives us an independent estimate. On the other hand we determ ine  $T_e$  more accurately than from Strong renphotom etry but not better than the temperatures from the line depth ratios. From the many iron lines the metallicity we nd is determined to within 0.1 dex for the slow rotators (v sin i < 15 km s<sup>-1</sup>) and 0.2 dex for the faster rotators. In the form er case this is a factor of two better than the metallicity determined from Strong renphotom etry.

Our nalT<sub>e</sub> and logg estimates are given in Table 4 under Ref.1a along with the Fe/H ] found from the abundance analysis (cf. Sect. 6).

#### 6. Abundances of the corot targets

In Sect. 4 three di erent m ethods to com pute abundances were applied to a subset of our sam ple, and we obtained sim ilar results within the error bars. For the analysis of the whole sam ple m ethod A (vw a sem i-autom atic software) has been adopted and the results are given here.

Abundances relative to the Sun for nine potential corot targets is shown in Fig.7.The rst ve stars plotted (HD 43318 to HD 57006) are the slow rotators for which the best results are obtained. From the abundance patterns we nd no evidence of classical chem ically peculiar stars.

For the slow ly rotating stars, the lines of M n give a system atically low er abundance, indicating a system atic error. W e have found that for this speci c element, the hyper ne structure levels are not always found in vald, thus yielding an erroneous result. W e also nd a relative over-abundance of B a, but we only have few lines for this element.

The abundances are also given in Table 7. The param – eters of the atm ospheric m odels used are given in Table 4 under R ef. 1a. The abundances are given relative to the solar abundances found by G revesse & Sauval (1998) which are found in the rst column in Table 7. In the parentheses we give the rm s standard deviation based on the lineto-line scatter, but only if at least four lines were used. As an example we nd for Cai in HD 43318 the result

In addition to the quoted errors contributions from the abundance zero points (G revesse & Sauval 1998) of the order 0.05 dex and m odel dependent uncertainties of the order 0.05–0.10 (0.20) dex for the slow (fast) rotators must be added. Thus, we can constrain the m etallicity [Fe/H] to

about 0.10 (0.20) dex. In Table 4 we have given [Fe/H] as the m ean of the iron abundance relative to the Sun found from Fe i and Fe ii lines for all three m ethods described in Sect. 4.

# 7.Conclusions and future prospects

- { We have perform ed a detailed abundance analysis of nine potential corot main targets. The accuracy of the abundances of the main elements is of the order 0.10 dex when including possible errors on microturbulence and inadequacies of the applied 1D LTE atm ospheric models.
- { We have compared three di erent methods for the analysis which show very good agreement. The discrepancies are due to the di erent parameters we have used for the stellar atm osphere models.
- { We have found no evidence for chemically peculiar stars.
- { We have constrained  $T_{\rm e}$ , logg, and metallicity to within 70 100 K, 0:1 0:2 dex, and 0.1 dex for the ve slow rotators in our sample.For the fourm oderate rotators we cannot constrain the fundam ental param eters very well, i.e.  $T_{\rm e}$ , logg, and [Fe/H] to within 200 K, 0:5 dex, and 0.15 dex.
- { For most of the stars our results for the fundam ental param eters agree with the initial estimates from

Strom gren photom etry, line depth ratios, and H lines, and the hipparcos parallaxes. For HD 43318 we have found a som ewhat lower  $T_e$  and logg. For HD 49933 we nd a  $T_e$  about 200 K hotter than previous studies. For the fast rotators HD 171834 and HD 184663 we nd a quite high logg value com pared to otherm ethods, but the uncertainty on our estim ate is large (0.5 dex).

{ For the two corot targets HD 46304 and HD 174866 abundance analyses were not possible due to the very high v sin i.

Suggestions for future studies of the corot targets:

{ From the comparison of two independent analyses (m ethod A and C; cf. 4.5) we have found evidence that a careful (re-)norm alization of the spectra m ay be very in portant but this m ust be investigated further.

- { To probe the interior of the stars with the asteroseism ic data from corot we need to know the abundances of elements which a ect the evolution of the stars, namely C, N, and O. Thus, spectra that cover the infrared regions with good C, N, and O lines must be obtained.
- { Recent 3D atm ospheric models should also be used in the analysis to explore the importance of the models.

We nally note that the next paper in this series will give the results of the abundance analysis for some recently proposed corot prim ary targets, the possible secondary corot targets, as well as the proposed targets for the mons/r mer mission.
