Feedback and Form ation of M assive Star C lusters in G iant M olecular C louds

A bstract. It is well known that the energy input from massive stars dominates the therm al and mechanical heating of typical regions in the interstellar medium of galaxies. These e ects are amplied tramendously in the immediate environment of young massive star clusters, which may contain thousands of O and B stars. We present models of star cluster formation that attempt to account for the interplay between feedback and self-gravity in forming clusters, with application to system s ranging from the O rion N ebula C luster, the G alactic C enter clusters like the A rches, and super star clusters.

1. The Initial C onditions for G alactic Star C luster Form ation

Star form ation in disk galaxies appears to be dom inated by a clustered mode (Lada & Lada 2003), occurring in regions of the disk that are gravitationally unstable (M artin & K ennicutt 2001). The most unstable m ass scales are about 1:3 10^7 ($_{gas}=6$ km s 1)⁴ ($_{gas}=10$ M pc 2) 1 M , roughly consistent with the observed cuto of the Galactic G iant M olecular C boud (GMC) m ass function (W illiam s & M dK ee 1997). GMCs are gravitationally bound (Solom on et al. 1987), and there is a comparable amount of atom ic gas associated with these structures (B litz 1990). A ltogether, a signi cant fraction (1=2) of the total gas m ass inside the solar circle is organized into bound structures.

The lifetim es of GMCs are not well known. B litz & Shu (1980) used observational and theoretical arguments to infer a GMC lifetime of a few times 10^{\prime} yr; their argum ent based on photoevaporation of the clouds was con m ed in a more extensive calculation by Williams & McKee (1997). The rocket e ect associated with the photoevaporation displaces the molecular gas from regions of active star form ation at the same time the gas is being transform ed from m olecular form to atom ic and ionized form. Leisawitz, Bash & Thaddeus (1989) found that open star clusters older than about 10 M yr were not associated with molecular clouds, which is consistent either with post-star-form ation cloud lifetim es shorter than this age or with relative velocities of star clusters and their parent clouds of about 10 km s 1 . Elm egreen (2000) presented a number of argum ents for star form ation to occur in about 1 2 dynam ical tim escales, particularly from the small age spreads in clusters such as the Orion Nebula Cluster and from the statistics of the presence of young stars in regions of dense gas. Hartmann (2003) has argued for such rapid star formation in Taurus. On the other hand, the observation that the angular m om entum vectors of GMCs in M 33 are sm all and are both pro- and retro-grade (Rosolow sky et al. 2003) m ay

indicate a relatively long lifetime so that angular momentum can be shed by magnetic braking (e.g., M estel 1985) and/or cloud-cloud collisions in a shearing disk (Tan 2000).

M ost star form ation in GMCs is concentrated in clumps that occupy a relatively small fraction of the volume and have a small fraction of the mass. Within clumps are overdense regions that we refer to as cores that form individual stars or binaries (Williams, Blitz, & McKee 2000). Star-forming clumps are identied by H_2O massers, out ows, and far infrared and radio continuum emission (Plume et al. 1997; Hunter et al. 2000; Sridharan et al. 2002; Beuther et al. 2002; Zhang et al. 2002; Mueller et al. 2002; Shirley et al. 2003). Most of the 350 m emission maps of Shirley et al. (2003) have morphologies consistent with quasi-spherical, virialized distributions. Typical properties of clumps are masses M 100 10th , diameters 1 pc and surface densities 1 g cm².

C lump properties are very similar to those of the smaller infrared dark clouds (IRDCs) (C arey et al. 1998), which are dense, cold regions embedded in GMCs. Thus, understanding the origin of IRDCs is crucial for progress in the elds of both star cluster form ation and galaxy form ation and evolution. C arey et al. noted nongaussian emission line pro les of H₂CO from 9 out of 10 IRDCs. Thism ay indicate short form ation tim escales via a triggering m echanism . IRDC m orphologies are also more lam entary than the sub-m m emission m aps of star-form ing clumps, which suggest that the latter represent a more evolved stage.

Possible triggers for IRDC form ation include compression of parts of GMCs (which are likely to contain clumpy substructure) by shock waves driven by cbud-cbud collisions (Scoville, Sanders & Clemens 1986; Tan 2000), spiraldensity waves (Sleath & Alexander 1996), ionization fronts (Elmegreen & Lada 1977; Thom pson et al. 2004), supernovae (e.g. Palous, Tenorio-Tagle & Franco 1994) or stellar winds (e.g. W hitworth & Francis 2002). Clumps that were previously pressure-con ned and gravitationally stable may suddenly become unstable. The contraction of the cloud can be halted by the onset of star form ation (M cK ee 1989). We expect that the protocluster will come into an approximate equilibrium in which pressure support balances self-gravity. Som e pieces of evidence in support of this view are the approximately spherical morphologies of star-forming clumps (Shirley et al. 2003); the timescales of star cluster form ation estimated from out ow momentum generation rates (Tan & M cK ee 2002); and the empirical age spreads of stars in young clusters, such as the Orion Nebula Cluster (Palla & Stahler 1999), which are quite long com pared to the dynamical or free-fall timescales of clumps, t = $(3 = 32G)^{1=2}$ 10^5 (M = 4000 M)¹⁼⁴ ³⁼⁴ yr. This last point requires comment, since 1:0 E Im egreen (2000) uses the O rion N ebula C luster as an example of star form ation on a dynam ical time. He estimated the density in the cluster prior to star formation as $n_{\rm H} = 12$ 10 cm³, corresponding to a free-fall time of 125 10 yr. If the star form ation occurred over a time $t_{sf} = 10^6$ yr, then t_f=t ′8 1. He used the dynamical time t_{dyn} R = to compare with t_{sf} . If the virial param - $5^{2}R = GM$ 1, as observed in star-form ing regions (M cK ee & Tan eter _{vir} 2003), then $R = 2.0t = \frac{1=2}{vir}$ ' 2.5 10^{6} yr. For t_{sf} ' 10^{6} yr, star form ation in the O rion Nebula C luster was rapid, but not so rapid that a quasi-equilibrium treatm ent is invalid.

2. Pressurized Star and Star Cluster Form ation

M cK ee & Tan (2002; 2003) considered star form ation from m arginally unstable, turbulent gas cores that are embedded in high pressure regions, such as the centers of star-forming clumps where P ' 1:8G ² = 8:5 10[°] ²K cm ³. High pressures cause equilibrium cores to be compact, r_{core} ' 0:06 (m $_{f}$ =30M)¹⁼² ¹⁼²pc, and collapse times short, t $_{f}$ ' 1:3 10[°] (m $_{f}$ =30M)¹⁼⁴ ³⁼⁴ yr, where m $_{f}$ is the nalstellarm ass forming from the core with 50% e ciency. These properties help to overcom e som e objections to core-based m odels of m assive star form ation (Stahler, Palla & Ho 2000; Tan 2003). The m odel helps to understand features of the O rion hot core (Tan 2004), a close example of a massive protostar.

W e have applied the above turbulent core star form ation m odel to star clusters (Tan & M cK ee 2002). As a rst approximation we assume that stars form independently from one another. This ignores the e ects of mutual stellar interactions (e.g. 0 striker 1994; Elm eqreen & Shadmehri 2003; Bonnell, Bate & V ine 2003). The simplicity of our approach means we only need to specify a stellar initial mass function (IMF) and an overall star form ation rate to de ne a particular star cluster form ation m odel. We use an empirical IMF in the form of a Salpeter power law (dN = d ln m / m $^{1:35}$) at the high-mass end. We param eterize the star-form ation rate in term s of $t_{f} = t$, the num ber of free-fall timescales it takes to form the stars. We adopt a star-form ation e ciency of 0.5. Stars are drawn at random from the IMF according to this rate and their individual protostellar evolution is followed. The properties of all the individual stars, such as bolom etric and ionizing lum inosities and protostellar out ow momentum ux, are summed up to give the overall cluster properties. The e ects of discreteness of the IM F are easily probed via M onte C arlo simulations of m any star clusters.

These models were used to estimate the expected protostellar out ow momentum ux from forming clusters as a function of the star formation rate. Most models of out ows (e.g. Konigl & Pudritz 2000; Shu et al. 2000) predict a linear relation between the accretion and out ow rates from protostars. The out ow velocity is of order the escape speed from the stellar surface. From a comparison to a sample of observed cluster out ow swe estimated that 10, but with large uncertainties (Tan & McK ee 2002).

3. Feedback Processes in Star C luster Form ation

Feedback processes that act against gravitational collapse and accretion of gas to protostars include radiation pressure (transm itted prim arily via dust grains), them all pressure of ionized regions and ram pressure from stellar winds, particularly M HD driven out ows from protostars that are still actively accreting. Pressure support from turbulent bulk motions of the gas and the turbulent magnetic eld is likely to be quite important in the initial clump (M cK ee & Tan 2003). Indeed the decay of this turbulence m ay be one of the most im – portant factors controlling the onset of star cluster form ation (M cK ee 1989). Form ing stars in the protocluster can rejuvenate the turbulence, prim arily by the momentum input from their M HD out ow s.

T idal torques among cores and their form ation from a turbulent m edium lead to a distribution of initial angular momenta. This distribution and the e ectiveness of transport processes may also be important in regulating the

cluster star form ation rate. Important transport processes include m agnetic braking (M estel 1985; A llen, Li& Shu 2003), the m agneto-rotational (B albus & H aw ley 1991; Salm eron & W ardle 2003) and gravitational instabilities (Larson 1984; Johnson & G am m ie 2003) in disks, including globalm odes such as spiral density waves (Lynden-Bell & K alma js 1972) that m ay be easily induced by the presence of binaries or m assive planets (B londin 2000). W e shall assume that these processes are e cient enough not to impede stellar accretion.

The complexity of the feedback processes and their interplay with a turbulent, self-gravitating medium forces us to make several simplifying assumptions in ourm odeling. Our goal is to explore which processes and aspects of the problem are most important. First we layout the parameter space of cluster mass and surface density (Fig. 1). As described in the caption, we can make simple estimates of when various feedback e ects are important: e.g. the dashed line indicates when the escape speed from twice the protocluster radius is the ionized gas sound speed. U sing the adopted empirical value for the overall star form ation rate of = 10, we show the condition for star form ation to be complete within 3 M yr (i.e. before supernova feedback is important). With this rate we can also estimate the combined properties of a protocluster wind composed of superposed M HD out ows. This wind can be dense enough to con ne ionizing feedback. Various observed star clusters are also shown in Fig. 1.

To move beyond these simple estimates we have constructed a dynamical feedback model (Tan & McK ee 2001). The key element here is to investigate the e ect of a turbulent and clumpy medium. We approximate this structure by dividing the gas into a population of cores with 80% of the total mass and an intercore medium. The cores have a mass spectrum dN =d ln m / m ^{0:6}, a uniform density, and a centrally concentrated initial spatial distribution (Fig. 2). The dynamics of the cores are a ected by the potential of the overall protocluster and feedback e ects from a stellar population at the cluster center. These include

radiation pressure, stellar w inds and ionization, which can photoevaporate cores according to the m odels of Bertoldi (1989) and Bertoldi & M cK \approx (1990).

Figure 3a show sthe results of a test case for a G alactic protocluster (4000M $_{\rm e}$ = 1 g cm 2 , model A in Fig. 1) interacting with the feedback from a single 0 star. As described in the caption, a clum py, turbulent m edium is much more capable of con ning feedback. Such e ects are undoubtedly important for connem ent of ultra-com pact H II regions, allow ing them to be relatively long-lived.

Figure 3b shows the evolution of the size of the H II region for the three cases A, B and C shown in Fig. 1, which are relevant to typical G alactic m assive clusters, G alactic C enter clusters like the A rches, and super star clusters (SSC s). Note these models correspond to a constant volume density. A relatively slow star form ation rate of = 30 was adopted and m aterial for new stars was taken from the innerm ost cores. Starburst99 m odels (Leitherer et al. 1999) were

used for the mean stellar properties. Again feedback e ects are weaker than commonly supposed. In cases B and C pre-supernova feedback is con ned for

3 M yr so the em bedded phase lasts for at least this long. W e predict that W olf-R ayet spectral features should be seen in most young, optically visible SSCs. There are also im plications for the numbers of observed em bedded clusters (as probed in radio continuum, e.g. Johnson & Kobulnicky 2003) relative to young optically-revealed system s.

Even in the Galactic case (model A), which has an escape speed small compared to the ionized gas sound speed, ionization is conned for almost 2 M yr. This may be relevant to the O rion N ebula C luster where stars still form in close proximily to O stars and where some cluster mem bers are thought to have ages of 2 M yr (Palla & Stahler 1999; Hoogerwerf, de Bruijne, & de Zeeuw 2001).

W e em phasize that several important physical processes are not included in these models. Our treatment of stellar winds does not include protostellar M HD out ow s or W olfR ayet winds, so wind feedback is underestimated. We assume a central point-like stellar distribution that enhances wind feedback because there are no wind-wind shocks. We ignore dynamical ejection of massive stars, which seem s to be a relatively e cient: Hoogerwerf et al. (2001) argue that 4 out of 10 stars with m > 10M have been ejected from the Orion Nebula Cluster. This obviously reduces the electiveness of feedback. We assume star form ation only begins once the clump is at the chosen density: in reality there will be a more gradual onset. We ignore further accretion to the clump from the surrounding GMC. The two component description of the gas is highly approximate.

The complexity of the star cluster form ation process is daunting. The models we have developed are clearly a very crude rst step. The reliability of such models can be established only with very detailed comparisons to observations of real clusters such as the O rion N ebula C luster, R 136 in 30 D oradus and nearby SSC s. For such comparisons, improved methods to date stars that are younger than a few M yr are needed.
