Far-U ltraviolet Spectroscopy of StarForm ing Regions in $N$ earby G alaxies: Stellar P opulations and A bundance Indicators ${ }_{\substack{* \\ \hline 1 \\ \hline \\ \hline}}$

## ABSTRACT

W e present FU SE spectroscopy and supporting data for star-form ing regions in nearby galaxies, to exam ine their $m$ assive-star content and explore the use of abundance and population indicators in this spectral range for high-redshift galaxies. New farultraviolet spectra are shown for four bright H II regions in M $33 \mathbb{N}$ ( C 588, 592, 595, and 604), the H II region NGC 5461 in M 101, and the starburst nucleus of NG C 7714, supplem ented by the very-low m etallicity galaxy I Zw 18. In each case, we see strong M iky W ay absonption system s from $\mathrm{H}_{2}$, but intrinsic absonption w thin each galaxy is weak or undetectable, perhaps because of the $\backslash \mathrm{UV}$ bias" in which reddened stars which lie behind molecular-rich areas are also heavily reddened. W e see striking changes in the stellar-w ind lines from these populations w ith m etallicity, suggesting that C II, C III, C IV,N II, N III, and P V lines are potential tracers of stellar $m$ etallicity in star-form ing galaxies. Three of these relations - involving $N$ IV , C III, and P V - are nearly linear over the range from $\mathrm{O} / \mathrm{H}=0.05\{0.8$ solar. The $m$ ajor di erence in continuum shapes am ong these system $s$ is that the giant $H$ II complex NGC 604 has a stronger continuum shortw ard of 950 A than any other ob ject in this sam ple. Sm all-num ber statistics would likely go in the other direction; we favor this as the result of a discrete star-form ing event 3 Myr ago, as suggested by previous studies of its stellar population.

## 1. Introduction

The history of galaxies is, in large part, the history of star form ation. M assive stars play key roles both as highly visible tracers of star form ation and as players in altering surrounding star form ation and both energy and chem istry of the interstellar m edium. It is these stars which dom inate the observed properties of actively star-form ing galaxies. The $m$ assive part of stellar populations is $m$ ost clearly observed in the ultraviolet, where their energy distributions peak and com peting light from cooler stars is minim al, as long as the foreground extinction allow s escape of enough of this radiation. In such environm ents, ultraviolet studies of star-form ing regions have proven fruitful in understanding these populations. The recent opening of the far-ultraviolet window, between Lym an and the Lym an lim it, for deep observations, allow s study ofm assive hot stars in a range where they fully dom inate the spectrum. This relatively narrow band contains an em barrassm ent of spectral riches, w ith num erous lines from stellar w inds as well as interstellar $m$ aterial both atom ic and molecular. These include the strong and highly-ionized lines of O VI and the unique ability to $m$ easure cold $\mathrm{H}_{2}$. In addition, this piece of the spectrum is accessible for high-redshift galaxies, at least for com posite sam ples where the Lym an forest can be averaged adequately, allow ing the possibility of direct com parisons of stellar populations over a large span of cosm ic tim e.

The very sensitivity of the farUV light to star form ation and reddening $m$ akes it a purer probe of som e properties of star-form ing regions than observations at longer wavelengths. Since only short-lived stars contribute signi cantly in the far-UV range, the details of star-form ing history should $m$ atter only for very brief bursts (such as $m$ ight be found in individualH II regions, but are less likely on galaxy scales). This m akes the far-UV spectrum $m$ ore sensitive to the stellar population itself than to its history. Furtherm ore, although the extinction is high, its di erentiale ect across the far-UV band is m odest, and
paradoxically the e ective reddening to the stars we see is sm aller than found at longer w avelengths. In observing stars interm ingled w ith highly structured dust distributions, the \picket-fence" e ect (H eisler \& O striker 1988) $m$ eans that $m$ ost of the stars are so reddened as to $m$ ake no signi cant contribution in the deep ultraviolet; all the stars we see are only lightly reddened. This also reduces the e ects of the forest of $\mathrm{H}_{2}$ absonption features because of the $m$ ixing of $m$ olecular gas and dust.

O bservationaldata on nearby galaxies, before the Far-U Hraviolet Spectroscopic E xplorer (F U SE ), were lim ited to a handful of star-form ing system s. Four stanburst galaxies were observed using HUT on A stro-2 (Leitherer et al. 1995, 2002), largely to m easure escaping radiation in the Lym an continuum, which provided initial data for com parison $w$ ith $m$ odels based on stellar spectra dating back to C opemicus. The strongest features fall into tw o blends near 970 (Ly + C III) and 1030A (O VI+ Ly + C II).A Voyager 2 observation of M 33, w ith som e spatial resolution in one direction, was analyzed by $K$ eel (1998), show ing that its far-UV continuum is virtually identical to those of the powerful starbursts, and that NGC 604 is bluer in this range than the overall disk. These data also suggested signi cant Lym an em ission, with spatial pro le suggesting an origin in the di use ISM rather than giant H II regions. Ironically, until the availability of FU SE observations, the richest inform ation on galaxies shortw ard of Lym an cam e from ob jects at high redshift, particularly com posite spectra of Lym an-break galaxies (Steidelet al. 2001, Shapley et al. 2003). To enable com parisons betw een local, well-studied star-form ing system $s$ and these pow erful, young ob jects, we have undertaken a series of F U SE observations of star-form ing regions innearby galaxies. W e present here the analysis of these spectra in the context of their stellar populations and system atic changes $w$ th $m$ etallicity. A com panion paper ( $K$ eel, Shapley, \& Steidel 2004) considers the com parison w th com posite spectra of Lym an-break galaxies.

## 2. Observations

### 2.1. O b ject selection

The FUSE targets were selected for known high UV ux and hence low reddening, and to span a range ofm etallicity. The regions targeted in M 33 include the brightest H II regions in the $m$ id $U V$, and span a radial range w thin the disk from $1.6-4.5 \mathrm{kpc}$ (see Fig .1 ). They also include exam ples w ith a single dom inant star cluster and with multiple clusters orm ore di use associations (also illustrated in F ig. 1 using HST data at 1700A ). N one of the ob jects in M 33 or M 101 achieves \super star cluster" (SSC ) status, if we follow com m on usage in requiring not only high lum inosity and stellar mass (M elnick, M oles \& Terlevich 1985) but that the stars be concentrated into a single clum p on 10 -pc scales as noted by such studies as that of M eurer et al. (1995). W hile NGC 604 has the right lum inosity, its stars are widely spread throughout a 100-pc region including multiple clum ps (H unter et al 1996). In the $m$ ore distant system $s$, the FU SE aperture sam ples multiple regions; F ig. 2 show s the bluest archival H ST im agery with the aperture superim posed. In NGC 7714, there are 10 lum inous SSC s , com parably lum inous in the near-UV, w ithin the aperture, $m$ ore clearly shown in the inset to $F$ ig. 2. In each of these cases, essentially the entire star-form ing region ts w ithin the aperture, an im portant desideratum in com paring these observations $w$ ith globalm easurem ents of distant galaxies.

For each of these ob jects, there are abundance $m$ easurem ents from the traditional optical em ission lines, which we use as an widely-applicable tracer of the abundances of recently-form ed stars as well. The M 33 ob jects span m uch of its disk's abundance gradient, while NGC 5461 and the nucleus of NG C 7714 were selected to sam ple low er and higher m etallicity. W e also analyze the sum med archivalFU SE spectrum of I Zw 18 from A loisiet al. (2003), as a com parison with the lowest know n gas-phase abundances.

Table 1 includes our adopted values from the literature for $[\mathrm{D} / \mathrm{H}]$, the best-m easured of the abundances due to the optical lines from multiple ionization stages of oxygen and its im portance as a coolant.

### 2.2. FU SE Spectroscopy

The FU SE optical system and detectors are described by M oos et al. (2000). Four prim ary mirrors are used to feed independent detectors optim ized for subsections of the far-UV band; $m$ aintaining the coalignm ent of these optical system $s$ is an im portant operational issue. Each detector has a distinct wavelength calibration, but for our purposes, we are not pushing the resolution lim it ofF U SE and can com bine the various data segm ents in 0.1-A pixels.

A s shown in Figs. 1 and 2, the FUSE pointing positions were set at the m idpoint of the stellar distributions from available UV im ages. The large 30" aperture was speci ed for the M 33 and M 101 H II regions at the outset, both for ux integrity in alignm ent of the four instrum ental channels and to include essentially all their starlight, and adopted for NGC 7714 as well when the perform ance penalty for using a sm aller aperture becam e clear during the m ission. The requested center coordinates and total exposure tim es are listed in Table 1.

O f these ob jects, NGC 604 is the brightest in the far-UV range by a factor 10, and will thus play a continued role in our know ledge of stellar populations in this spectral range. In each of these spectra, the useful resolution is lim ited by the signal-to-noise ratio, dictating the wavelength binning to detect features of interest. For NGC 604, we can work at 0.1-A binning, for a velocity spacing typically $30 \mathrm{~km} \mathrm{~s}{ }^{1}$. O nly in this ob ject does it (m arginally) $m$ atter that it is not a point source, w ith starlight com ing from $m$ ost of the aperture area.
$T$ his $s m$ earing along the dispersion axis contributes a broadening of about $60 \mathrm{~km} \mathrm{~s}{ }^{1}$.

The spectra were processed through the FUSE pipeline; we inspected the tw odim ensional spectra to verify data quality and background subtraction, and to note such $e$ ects as the \worm ", a shadow ing of the detector by a repeller wire, near the red end of som e spectra. Each of our targets was observed during two orbits, so we could com pare each orbit's sum $m$ ed spectra as a check on the errors at each wavelength. Loss of ux due to the \worm " does occur in some of the spectra around from $1170\{1180 \mathrm{~A}$, a range which does not a ect any of the features we analyze. Sim ilarly, there are spurious em ission features near 1044 and 1169 A which are second-order scattered solar features, which do not seriously confuse features of interest. For clarity of illustration, we interpolate across terrestrial airglow features in Ly , Ly and O I at the highest resolution before further averaging and display.

W e also use the sum med archival spectrum of I Zw 18 described by A loisiet al. (2003), who kindly provided it in electronic form . W e com pare the spectra of N G C 604 and I Zw 18 at 0.1-A resolution in F ig. 3, show ing foreground absorption from $\mathrm{H}_{2}$, atom ic absorption lines in the foreground and in these galaxies, and prom inent stellar-w ind lines.

### 2.3. Supporting D ata

W e draw on additional data from a variety of sources for these well-observed ob jects. IU E spectra in the large 10 20-arcsecond apertures give $m$ id-UV spectra in roughly $m$ atched apertures; we have collected spectra from the archive, rejecting those with obviously discrepant pointings or ux levels from the com bined spectra.

HST im aging is invaluable in exam ining the stellar populations, resolving the brightest stars in each of these associations. A rchivalW FPC 2 data exist for each of the M 33 regions
in F170W plus longer-w avelength lters, so we can assess the stellar statistics at least into the $m$ id-ultraviolet. The best UV im ages of NGC 604 were taken in support of a slitless-spectrosoopy program, using the ST IS NUV M AM A detector working at 1800-2700 A.

E ach of these stellar collections ionizes a substantial surrounding region. H data (as in Bosch et al 2002) show structure extending 200-800 pc. All four of the M 33 regions $t$ their description of an evolyed H II region, one in which star form ation has been long enough to generate extensive lam ents and loops driven by stellar energy input; they estim ate ages > 4 M yr for all except NGC 604, at 3 Myr , for the current episode of star form ation ( $m$ atching the conclusions of $G$ onzalez D elgado \& Perez 2000).

Stars which contribute strongly in the farUV have spectral types B0 and earlier, for ages up to 15 M yr. H ow ever, the continuum slopes of the shorter-lived O stars vary only slightly across the farUV range, so the continuum o ers little signature of the recent star-form ing history (R obert et al 2001). To this point, the farUV line behavior is not well enough calibrated to infer the star-form ing history independently.

## 3. Interstellar A bsorption Features

The farUV range is rich in narrow absonption lines from the ISM, both ionic and m olecular. The spectrum of NGC 604 is especially com plex, with over 100 detected and identi ed transitions. Foreground $\mathrm{H}_{2}$ in the M iky W ay is so prom inent in all these ob jects that it m ust be carefully accounted for in identifying intrinsic absonption features. For the strongest Fe II lines, we detect not only the M 33 ISM (at about $-200 \mathrm{~km} \mathrm{~s}{ }^{1}$ ), but the foreground high-velocity cloud structure near $-370 \mathrm{~km} \mathrm{~s}{ }^{1}$ described by W akker et al. (2003).

### 3.1. A tom ic features

Num erous atom ic absonption features are seen in these spectra, w ith stronger absonption in $m$ ost cases from foreground $M$ ilky $W$ ay gas. Their strengths in the integrated spectra w ill re ect the distribution of gas tow ard the stellar associations weighted by contribution to the far-UV ux; for these extensive distributions of stars, derived colum $n$ densities should be regarded as characteristic values.

### 3.2. M olecular hydrogen

$T$ he Lym an and $W$ emer band system sof $\mathrm{H}_{2}$ are at once an advantage and a nuisance in far-U V spectrosoopy, detected in alm ost every line of sight crossing a signi cant distance in our own galaxy's ISM. A total of 56 such lines are individually detected in NGC 604. The $\mathrm{H}_{2}$ features in these M 33 data have also been analyzed by B luhm et al. (2003), who found that $\mathrm{H}_{2}$ absonption at the velocities appropriate for disk gas in M 33 is weakly detected in NGC 588, 592, and 595, at colum $n$ densities $N\left(H_{2}\right)=10^{16} \quad 3 \quad 10^{17} \mathrm{~cm}^{2}$, but only an upper lim it $10^{15}$ could be derived for NG C 604, despite the higher data quality and com parable colum $n$ densities from atom ic lines, $w$ ith all the values approxim ate due to the lines being too weak for independent $m$ easurem ent of the $D$ oppler-w idth $b$ param eter. B luhm et al also present instructive sim ulations on the di culty of deriving unique colum $n$ densities when the background source consists of stars spanning a range of colum $n$ density and position w ithin the spectroscopic aperture. For exam ple, the nondetection in NG C 604 $m$ ight result from patchy extinction, correlated w th the $\mathrm{H}_{2}$ distribution, and the far-UV background ux being dom inated by those stars w ith the shallowest $\mathrm{H}_{2}$ absonption. This w ill act in addition to any physicale ects related to the radiation eld and shocks in the vicinity of such an active star-form ing region. These regions are certainly associated w ith large concentrations ofm olecular gas; all three of them within the survey area of Engargiola
et al. (2003) are associated w ith m olecular clouds $\mathbb{N}$ G C 592,595, and 604 w ith their clouds 40,32 , and 8 , respectively). Their $H_{2} \mathrm{~m}$ asses are estim ated in the range $1: 2 \quad 4 \quad 10^{5}$ solar m asses.

In spite of these issues in physical interpretation ofm olecular absonption, the em pirical results are directly com parable to what we m ay see in high-redshift system s , as this spectral region becom es accessible for at least com posite study in Lym an-break galaxies (Shapley et al 2003). W e can use both the sets of $\mathrm{H}_{2}$ line strengths seen from $G$ alactic gas in these spectra, and synthetic absonption spectra, to ask what signatures of m olecular absorption rem ain at $m$ odest spectral resolution. The least confusion $w$ ith other spectral features for $m$ odest $\mathrm{H}_{2}$ colum n densities occurs for blends of features near 1005 and 1072 A . The wavelengths and shapes of these blends depend on the spin-level populations in the gas, generally shifting to longer wavelengths for warm er gas (M ©C andliss 2003).

W e have re-exam ined the NGC 604 spectrum for evidence of associated $\mathrm{H}_{2}$ absonption. The ability to see such features at low redshift is lim ited largely by blending $w$ ith foreground G alactic features, since the spacing betw een multiplet m em bers provides am ple opportunity for overlap. For atom ic absorption species, we nd a di erence between foreground and M 33 absorption typically $220 \mathrm{~km} \mathrm{~s}{ }^{1}$, which gives wavelength shifts very close to the spacing of low -order $m$ em bers of the $\mathrm{H}_{2} \mathrm{~m}$ ultiplets near 963, 982, 1002, and 1014 A . A s a result, only the bluest $m$ em bers of these $m$ ultiplets could be securely detected from gas near the velocity ofN G C 604 in the presence of the much stronger foreground gas. To guard against unrecognized atom ic features, we also require that a putative NGC 604 feature not be seen in the I Zw 18 spectrum at the corresponding em itted wavelength. C om pared to 56 $\mathrm{H}_{2}$ lines seen from foreground M ilky W ay gas, only two potential detections resulted for NG C 604. These are the transitions at rest wavelengths 1001.69 (5;4! 13;1) and 1008.38 $(2 ; 3!8 ; 0)$ at equivalent widths of roughly 0.02 and 0.08 A , respectively. The 1008 line,
w ith better $S / \mathrm{N}$ ratio, appears substantially broader, w ith a pro le com patible w th that of the other narrow features. If accurate, these detections are insu cient to derive the absorbing colum $n$ density, lacking inform ation on the intrinsic $D$ oppler broadening and level populations. If we adopt the \optim um "b-value $10 \mathrm{~km} \mathrm{~s}{ }^{1}$ for the NGC 588 and 592 detections from B huhm et al, and inconporating the $\mathrm{H}_{2} \mathrm{O} \mathrm{O}$ LS tem plate m odels described by M © andliss 2003, we derive $\mathrm{N}\left(\mathrm{H}_{2}\right)=3 \quad 10^{17} \mathrm{am}^{2}$ from this single transition and assum ing the sam em ix of level populations as in the foreground gas. H otter m olecular gas could give com parable absorption at colum $n$ densities several tim es lower, close to the B luhm et al. lim it.

Lines arising in the states $J=0 \quad 3$ are seen in the foreground $M$ iky $W$ ay gas, well below the saturated level that drove R achford et al. (2002) to use detailed pro le tting. A s in their work,we also nd signi cant changes in derived $\mathrm{N}\left(\mathrm{H}_{2}\right)$ between various absonption bands. We follow them in obtaining a characteristic kinetic tem perature from the level populations in $J=0 ; 1$ as

For the NGC 604 foreground $\mathrm{H}_{2}$ spectrum, we obtained $\mathrm{T}_{01}=113 \mathrm{~K}$, at the high end of values seen by R achford et al for dense and self-shielded environm ents but reasonable for the m ore di use \intercloud" ISM. The populations in $J=0 ; 1$ are taken to represent a therm al (collisional) tem perature, with \excess" absonption from higher $J$ representing radiative excitation, so that only the low est levels are useful in deriving the therm al environm ent of the $m$ olcular gas.

Sim ilar issues a ect the strongest $H_{2}$ lines in I Zw 18, albeit w ith less overlap from M ilky W ay features because of the larger velocity shift. From the stacked spectrum , A loisi et al. (2003) set an upper lim it of $\left(\mathrm{H}_{2}\right)=5 \quad 10^{14} \mathrm{~cm}{ }^{2}$ against the em erging continuum .

## 4. Stellar C ontent

### 4.1. Stellar winds

$M$ ost of the stellar signature in far-UV spectra occurs in the $w$ ind lines, which dom inate this spectral range thanks to the num erous resonance transitions ofm etals. B oth the $w$ ind lines and the evolutionary tracks when winds are im portant should have strong m etallicity dependences, since the radiation pressure driving the winds acts largely through the opacity of heavy elem ents. This behavior has been show n, albeit som etim es in com plex ways, upon com parison of stellar spectra from the $M$ ilky $W$ ay and $M$ agellanic $C$ louds. Leitherer et al. (2001) exam ined $w$ ind lines in the $m$ id-UV , notably $C$ IV, from $S M C$ to $G$ alactic abundances, con $m$ ing a signi cant $m$ etallicity dependence in its strength but noting than ionization states other than the dom inant ones can behave di erently as secondary abundance e ects shift the ionization balance in the winds (as seen in SiIV, which is stronger in LM C stars than the M ilky W ay). These changes are m ost pronounced for the brighter lum inosity classes. A m ong the $m$ ost hum inous stars, those in the $M$ agellanic $C$ louds have sm aller wind velocities even for com parable depth (e.g. K udritzki \& Puls 2000).

W hile photospheric lines in the far-UV range are weak enough to scale directly w ith abundances, they are either extrem ely weak or overlain by wind lines. Lam ers et al (1999) suggest that line blanketing is a m ore secure route to the stellar abundances. From the com parison by Robert et al. (2001), Si IV 1122=8 are high-excitation photospheric lines that should serve as useful indicators of the stellar population, independent of $w$ inds.

In interpreting the O VI pro les from galaxy-scale system s such as NGC 7714, G onzalez D elgado et al. (1998) caution from HU T spectra that interstellar absonption from large-scale out ow s can signi cantly overlap wind lines, speci cally between Ly and O V I 1032.

Even FU SE -based spectral syntheses in the far-ultraviolet extend only to 1000 A (R obert et al 2003), so we continue our em pirical approach in com paring system sofvarious properties to seek di erences linked to com position or history. W e can, how ever, be guided by available syntheses of som e of the prom inent blends of features, such as the Ly $-\mathrm{OVI}-$ C II regions from 1025-1038 A (G onzalez D elgado et al 1997). They nd that Ly and C II absonption arise in B stars, at the coolend of farUV contributors, while O VIP Cygni pro les com e from the $m$ ost $m$ assive stars. $H$ igh spectral resolution is crucial to separating the interstellar absopption contributions in each case; for Ly , hydrogen colum $n$ densities $\mathrm{N}_{\mathrm{H}}>10^{21} \mathrm{am}^{2}$ lead to blending of stellar and interstellar com ponents. R obert et al (2001) show that O V I is very weak at SM C m etallicities, and that the youngest population can be diagnosed from the presence of C II 1176 and C IV /N IV 1169 which are speci c to hot O stars. At M agellanic C loud abundances, the S IV 1063=73=74 lines have a w ind contribution only from supergiants, and $\mathrm{P} V \quad 1118=25$ exhibit sim ilar behavior.

To show the som e of the spectral di erences seen with m etallicity, Fig. 4 com pares the spectra of NGC 604 and I Zw 18, now with the strongest Galactic $\mathrm{H}_{2}$ features rem oved by tting $G$ aussians or Voigt pro les (for the stronger lines), and plotted in the em itted w avelength fram e. Fig. 5 is a sim ilar com parison of NGC 7714 w ith NGC 604, ilhustrating the yet stronger features seen at near-solar m etallicity.

The wind lines seen in these system s may be described as follow s. For the fainter ob jects w th short exposures $(\mathbb{N}$ G C 588, 592, 595, 5461, 7714) the data have been sm oothed by typically 0.7 A in making these assessm ents.

NGC 604 ( F ig. 4): C om bining both $m$ em bers of the O V I doublet to reduce confusion, there is a broad wind absorption reaching $2800 \mathrm{~km} / \mathrm{s}$ and probably blending with Ly . O VI 1037, C III 977, and N II 1083 have nearly black cores. A distinct detached absonption m ay be present in C III from $1600-2000 \mathrm{~km} / \mathrm{s}$. There m ay be a broad w ind
feature in N III to $3000 \mathrm{~km} / \mathrm{s}$. P V is weak except for possibly photospheric com ponents near zero velocity. The em ission sections ofP C ygnipro les are strong in O V I 1037, N II 1082, and N III 991.

NG C 588/592/595: These spectra have wind features as m uch like one another as their S/N ratio can tell, both individually and when averaged. C om pared to NGC 604, the cores of C III, O VI, and N II are shallower, w ith residual intensities 10-40\% . A s noted below, the continuum level in NGC 604 is higher than in any of the other system s below 950 A .

NGC 5461: a trough occurs in N IV to about $1000 \mathrm{~km} \mathrm{~s}{ }^{1}$. There is a single well-de ned trough in C IV to $600 \mathrm{~km} \mathrm{~s}{ }^{1}$. No feature is obvious in N III or S III. B road absorption is seen in both O VI lines to about $1000 \mathrm{~km} \mathrm{~s}{ }^{1}$.

IZw 18: There is at m ost weak O VI absonption between $1700-2800 \mathrm{~km} \mathrm{~s}^{1}$, seen only in the 1037 line. $P$ Cygniem ission is absent in O VI, N II, and N III by com parison w ith NGC 604. Essentially no blueshiffed troughs occur for N III. T wo features m ay be present for C III from 0-1200 and 1700-2000 km /s, but blending w ith saturated interstellar C II is an issue. P V is very weak.

NGC 7714: This nucleus has the strongest wind features in our study. B oth O VI lines are strong, extending to $900 \mathrm{~km}{ }^{1}$. The P V lines at 1118;1125 are broad and blueshifted suggesting a wind contribution, which is plausible for non-supergiants at its m etallicity. N III 991 m ay have a broad w ind com ponent blending w th the interstellar O I lines at about $1000 \mathrm{~km} \mathrm{~s}^{1}$. The core of C III is blended w ith O I but show s a w ind trough to beyond $1000 \mathrm{~km} \mathrm{~s}{ }^{1}$.

For high-redshift ob jects, it will be di cult or im possible to separate wind and interstellar contributions to som e of these lines. For purposes of com parison, we have generated sim ple equivalent-w idth values $w$ ith respect to the adjacent (pseudo)continuum
for lines in clean parts of the spectrum, typically spanning a 5-A line region, and tabulate these in Table 2. A irglow em ission contam inated the fainter M 33 regions (com bined in the table as $\backslash \mathrm{M} 33 \mathrm{avg}$ ") too strongly for a reliable $m$ easurem ent of $N$ III 991. For the $N$ II and N III lines we list both the absonption and net equivalent widths (in parentheses), for use when the com ponents are not resolved. We include values for $C \mathbb{I V}$ 1548;1550 from summed $\mathbb{U} E$ low-dispersion spectra, as these values were taken with a large enough aperture to sam ple $m$ ost of the stellar population in a way much like the FU SE aperture. Errors on the FUSE value are typically 02 A for such broad features, as re ected in the lim its for some lines in I Zw 18, while the C IV errors are closer to 1 A . Each of these lines show s a strong trend w ith em ission-line $m$ etallicity ( $F$ ig. 6), show ing that they do in fact have potential use as abundance indicators. The $w$ ind lines $m$ easure stellar values directly, in contrast to the large regions of the interstellar m edium sam pled by em ission-line techniques. These relations are quite sensitive in the sub-solar regim e of particular interest for the evolution of galaxies at $z>3$. The equivalent $w$ idths $m$ easured for $N \mathbb{I V}, \mathrm{C}$ III, and P V vary alm ost linearly with abundances. O ur results indicate that these strong features can be used as m etallicity indioes for high-redshift stellar populations, in regim es for which the opticalem ission lines lie in infrared bands of high atm ospheric em ission and absorption, and can be a valuable tool for approaching the chem ical evolution of galaxies in the range $z=3 \quad 4$.

For ease of use, we present least-square quadratic ts to the data in $F$ ig. 6, along w ith the derived constants needed to invert these ts with line equivalent widths as the independent variables. These intenpolation curves are shown in Fig. 6, and the num erical values are found in Table 3. The $O / H$ ratio is in solar units as found from em ission-line analysis (as cited in Table 1, updated to the \new " solar abundance scale with $12+\mathrm{log}$ ( $\mathrm{O} / \mathrm{H})=8.69$ ), and all equivalent $w$ idths are in $A$ in the em itted fram e. For each line, the data have been approxim ately tted in the form EW $=\mathrm{a}_{1}+\mathrm{a}_{2}(\mathrm{O}=\mathrm{H})+\mathrm{a}_{3}(\mathrm{O}=\mathrm{H})^{2}$.

Sim ilarly, an inverse tting function form etallicity derived from each line is obtained from the quadratic formula, w ith constants tabulated as $(O=H)=C_{1}+C_{2}\left(c_{3}+\left(c_{4} E W\right)\right)^{1=2}$. The values are based on least-squares ts w ith equal weights, slightly modi ed in two cases to keep the $t m$ onotonic across the $m$ etallicity range of our sam ple. For $\mathbb{N} \mathbb{I I}]$, we adopt a at value EW = 1 A for $(\mathrm{O} / \mathrm{H})<0.5$ solar. These form s are for interpolation purposes, and their Im itations appear from the fact that they do not all approach zero line strength at zero $m$ etallicity. C rudely speaking, wind-dom inated lines would have a quadratic dependenœ on $m$ etallicity until saturation sets in, since the $m$ ass-loss rate and fraction of the $m$ ass in the right ionic state each depend on $m$ etallicity, while $m$ ostly photospheric lines (such as P V) are $m$ ore nearly linear in strength $w$ ith the abundances.

Strictly speaking, these relations apply only to galaxies w ith a long (even ifepisodic or weak) history of star form ation, since the elem ents involved in these lines com e from very di erent stellar processes. For exam ple, oxygen should be enriched rather quidkly, com ing from $m$ assive stars, while carbon w ill take longer com ing from interm ediate $m$ asses, w ith the dom inant souroes nitrogen still som ew hat am biguous. At best, these relations could be taken seriously for single elem ents in high-redshift galaxies, and can in fact be used to test for the di erential enrichm ent history of such system $s$, in $m u c h$ the sam e way that the behavior of Si IV and C IV lines with redshifts has been used to infer such di erences by M ehlert et al. (2002), who derive a relation between C IV EW and m etallicity consistent w ith our IU E analysis included in $F$ ig. 6.
4.2. Far-U V spectra and the stellar m ix

Beyond the stellarw ind lines, the greatest di erence am ong all these far-UV spectra is the ux excess in NGC 604 from about 912-940A, above what is seen in any of the other ob jects either of higher or low er m etallicity. Sm all-num ber statistics in the m assive stars
m ight be expected to be m ore im portant for the less rich system s , but in M 33 it is these which have the sam e spectral shape as the $m$ ore lum inous and distant system $s$, leaving NG C 604 as the odd one out. P revious work on its stellar content indicates that there was a strong peak in its star-form ing history about 3 M yr ago, recent enough to a ect the m ix of stars contributing in this spectral range. W e have exam ined additional UV data on the stellar content of these M 33 H II regions to see how NGC 604 m ight be di erent.

The stellar population in NGC 604 has draw n considerable attention, in being one of the brightest star-form ing com plexes in the Local Group while o ering a dram atic structural contrast to the dom inant, com pact stellar chuster in 30 D oradus. B ruhw eiler, M iskey, \& Sm th Neubig (2003) com bined m id-UV W FPC2 im ages with a wide-slit ST IS spectrum to extract individual spectra of the brightest $m$ em bers. They note that the ten m ost UV-lum inous stars will dom inate the integrated spectral features from NGC 604, and that two of these are located $0: 3 \mathrm{~m}$ agnitude above the usual 120-solar-m ass lim it. Speci cally, the \top ten" stars contribute 46\% of the totalm easured ux just longw ard of Lym an . M id-UV ST IS im ages (eentralwavelengths 1820-2700 A) obtained in support of a slitless-spectroscopy program by J.M ais-A pellaniz show, via the ner pixel sam pling, that there are additional spatially resolved com panions to each of the brightest stars identi ed by B ruhw eiler et al, although none so bright as to bias the m easured colors or m agnitudes. NGC 604 also contains signi cant numbers of W R stars, although with a W R /O star ratio near 0.1 rather than the 0.3 seen in, for exam ple, NGC 595 (D rissen, M o at, \& Shara 1993).

To com pare the populations in these H II regions as they a ect the integrated farUV spectra, we produced color-m agnitude arrays for each based on the archivalW FPC 2 data in F170W and F555W (as well as interm ediate-w avelength data when available). Lacking in agery in the farUV band itself, we use the $m$ id-UV properties as proxies to at least identify the hottest lum inous stars. Reddening corrections do not enter for our im $m$ ediate
punposes, since we need to know only how many stars contribute to the UV ux and extinction does not varying greatly between 1700 and 1100 A. B ruhweiler et al. nd, for stars in NGC 604, that the 1100-A extinction is about 1.5 tim es that at 1700 A. Likew ise, we are interested here only in stars selected from UV ux, so the diagram s sam ple only those stars well detected in the $m$ id-UV data. T hese observational R diagram s are show n in F ig. 7. W e include only stars $w$ thout serious crow ding issues, $m$ easured with in 0.3 " radii. The sam ples include stars to about $\mathrm{m}_{170}=19$ on the STM AG scale (based on ux per unit wavelength), although the com pleteness varies considerably even at $\mathrm{m}_{170}=18$ because of di erences in crow ding; for NGC 604, the cum ulative counts with ux suggest statistical com pleteness only above $\mathrm{m}_{170}=17: 0$. The brightest stars in the rich population of NGC 604 are 1.5-2 m agnitudes brighter than found in any of the other associations. The color range am ong UV -bright stars in NGC 588 is sm allest, extending from the blue envelope near $\mathrm{m}_{170} \quad \mathrm{~m}_{555}=3: 5$ redw ard only to -2.0 , while all the other regions have the diagram populated to $\mathrm{m}_{170} \mathrm{~m}_{555}=0$, and in NGC 604 to 2.4. T his m ay in part be a reddening issue, since the stellar distribution in NG C 588 is m ore com pact, w ith less soope for di erential reddening across the association, than the others. Indeed, dust lanes are prom inent in the continuum im ages of NGC 604 in both the optical continuum and UV /opticalcolors; it is clear observationally that the UV re ects only the least-extinguished stars in this ob ject. The observed color distribution in NGC 604 is rich in the bluest stars, but these stars are also represented with sim ilar color in NGC 588 and 595. A m ore im portant di erence is that the richer population in NGC 604 includes several stars w ith F170W m agnitude brighter than seen in any of the other clusters. W hile ridnness e ects $m$ ean that the brighter star-form ing regions $w$ ill have brighter rst-ranked stars, the studies referenced above suggest that NG C 604 has undergone a distinct burst of star form ation about 3 M yr ago, younger than the other regions, an event which is recent enough to leave its $m$ ark on the $m$ assive-star population. $W$ e now focus on these brightest stars.

These data allow us to address how $m$ uch the brightest stars dom inate the $m$ id-UV ux in each case, inconporating the totalF 170W ux w ithin the FUSE aperture. F luctuations in the bright population could a ect the integrated spectra of the lower-lum inosity, sparser regions m ore strongly sim ply from statistics, but the detailed recent history of star form ation will enter through aging as well. $G$ iven the tem perature range of these stars (3 $4 \quad 10^{4} \mathrm{~K}$ follow ing B nuhw eiler et al.), the hottest stars should be m ore dom inant at the shorter wavelengths of the FU SE data. It is not clear that all the far-UV ux is from direct starlight; H ill et al. (1995a,b) and M alam uth et al. (1996) showed evidence that a signi cant fraction of m id-UV light from sim ilar system s is scattered. The H ST F 300W im age ofNGC 604 show s re ection nebulosity, and sm oothed versions of the m id-UV ST IS im ages $m$ atch its $m$ orphology, indicating that scattering im portant at shorter w avelengths as well, as would be expected for a roughly ${ }^{4}$ R ayleigh behavior. Since the FU SE aperture is not much larger than the stellar distribution in NGC 604, the widths of narrow absorption features are not a sensitive test of whether scattering is im portant at these w avelengths. $W$ e do see a role for scattering around som e of the brightest stars in the H ST ST IS im age at 2400 A , from analysis of the point-spread functions of stars. This is easier to interpret than the distinct em ission and absonption structures, since re ected continuum can be confused w ith em ission from the weak [ III] doublet near 2471 A. Som e of the stars $m$ atch the nom inal PS closely, while tw o of the brightest ones exhibit excess light from 0.3-1.0" from the core. This excess contains as much of $28 \%$ of the $m \mathrm{id}-\mathrm{UV}$ light in the brightest case. These data leave open the possibility that scattered light is im portant at the shorter farUV wavelengths.

W e therefore bracket the total UV ux between the sum of detected stars and the large-aperture sum. For larger fractions of scattered light, the brightest individual stars are $m$ ore dom inant, since the total num ber of stars producing the observed light is sm aller. Cum ulative distributions of F170W magnitude are shown in Fig. 8, along with sim ple
geom etric estim ates of corrections for crow ding (which are sm all, but underestim ate the actuale ect where stars are $m$ ore clum ped than random $w$ thin the $H$ II region). A ccum ulating the ux from the bright stars, we nd that only about $20 \%$ of the total ux w ithin the FUSE aperture at 1700 A com es directly from the stars, less than half of what B nuhweiler et al. (2003) nd at 1200A w ithin a narrow slit. T his may be a sign that scattering is im portant, since $m$ uch of the scattered light we see at $m$ id-UV wavelengths in the HST im agery is on larger scales than this. In contrast, as a fraction of the light from detected stars, the brightest ten (a good approxim ation to the stars brighter than any found in the other H II regions) contribute about 40\%, m ore in line w ith the B ruhw eiler et al results. This also $m$ akes sense for these stars being able to a ect the overall spectrum . H ow ever, the high tem perature needed for the excess com ponent in NGC 604 m eans that we are seeing a di erence in history rather than sim ply sm all-num ber statistics in what stars appear at a given time.

### 4.3. Stellar populations

In general, $m$ etallicity $w$ ill be $m$ anifested in the com posite spectra both directly, through photospheric and wind lines, and indirectly, as the evolutionary tracks of stars change with abundances. E ects on the initialm ass function are too sm all to see at the abundances found in the M 33 disk, as shown by M alam uth et al. (1996) for som e of the sam e H II regions we observed. They suggest that the excitation trends seen in the associated ionized gas result from the di erent em ergent ionizing uxes for stars at various m etallicities. H ow ever, di erent evolutionary histories are still im plied by the strong changes in wind properties seen with m etallicity.

C om parison of the our spectra suggests that very recent events in the star-form ation history do have observable im pact in the farUV , as exem pli ed by NGC 604. Its m ix
includes light from a greater fraction of hot stars than the other system $s$, which ts with the other properties of this region in suggesting a burst so recent that even in the far- $\mathrm{U} V$, it does not look like constant star-form ation (in this case, ages 3 Myr ). In general, the tim escales $m$ ay be $m$ etallicity-dependent; R obert et al. (2003) show that evolved O I/III and B I/III stars appear later at low er abundances.

## 5. Sum $m$ ary

W e have used FU SE spectra of star-form ing regions in nearby galaxies, whose gas-phase $m$ etallicities range from $0.05-0.8$ solar, to explore the utility of far-ultraviolet spectra in $m$ easuring the abundances in star-form ing galaxies, as well as to probe the $m$ assive-star populations in these galaxies. The absorption lines from radiatively-driven $w$ inds prove to be very sensitive to $m$ etal abundanœ; all six strong and unblended species (inchiding $C$ IV from archival IU E data) have a strong, m onotonic m etallicity dependence. For $N \mathbb{I V}$, C III, and P V, the relation between straighforw ard equivalent-w idth values and oxygen abundance from em ission-line spectra is closely linear, suggesting that these lines will be useful in tracing the chem icalhistory of galaxies from $z=3 \quad 4$, beyond which the Lym an forest $m$ akes even com posite spectra progressively less inform ative.

The continuum of G C 604 departs from the uniform shape of the other objects below 950 A . A fter considering the ects of sm all-num ber statistics am ong the $m$ assive stars in these ob jects, we conchude that this di erence probably traces to a discrete burst of star form ation 3 M yr ago in NGC 604. This region had been considered by several previous studies to have hoisted such a burst, on grounds ofboth m orphology of the gas and tting of the H R diagram .
