Broadband X-ray spectrum of intermediate polar V1223 Sgr

Abstract. W e present the broadband phase averaged spectrum of one of the brightest interm ediate polars V 1223 Sgr, obtained with INTEGRAL and RXTE observatories (3-100 keV). Good statistical quality of the spectrum in a hard X-ray energy band (INTEGRAL/IB IS and RXTE/HEXTE) allowed us to disentangle contributions of a direct optically thin plasm a emission and a relected component to the spectrum of V 1223 Sgr. The obtained m easurem ent of the post-shock temperature of the accreting matter give us the inform ation about the mass of the white dwarf and the inclination of the system.

1. Introduction

V 1223 Sqr is a very well known binary star that belongs to the class of intermediate polars (IPs) { binary systems with a white dwarf that accrets matter from a Roche lobe lling secondary star (see e.g. com prehensive m odel and discussion in Beuermann et al. 2004). In the IP systems magnetic eld of a white dwarf is strong enough to control the accreting m atter at relatively large distances from it and to form a magnetosphere and magnetic funnel (see e.g.Patterson 1994 for a review).Them atter falls down to the surface of the white dwarf with alm ost free fall velocity and is heated in a strong shock to tem peratures of the order of 10 keV. Falling m atter preferentially com es to the magnetic poles and em its X -rays via an optically thin therm alplasm a em ission (see e.g. Lam b & M asters 1979). In spite of this relatively simple scheme the observed em ission of IP is much more complicated. First of all its spectrum can contain a set of components with di erent tem peratures (mostly visible at low energies), it often dem onstrates an intrinsic photoabsorption, partial covering, different ionization states of an emitting plasm a and a re-

ection from an optically thick relatively medium (see e.g. W amer 1995 for a review). O from the spectrum depends on orbital phase and phase of rotation of the white dwarf (e.g. N orton & W atson 1989). Di erent objects of this class were extensively studied by several X-ray observatories over last decades. However, until now there was no study of hard X-ray em ission of IP (E > 20 keV) except for the case of V 709 C as (de M artino et al. 2001).

Energy band > 20 keV is important because it allows to con dently measure the maxim altemperature of the shock in the accretion column of the IP. It is especially in portant if the X-ray spectrum of IP contains strong reected component, that distorts the observed continuum at energies 10-20 keV. In the most cases the temperature of the post-shock region of the accretion column of \mathbb{P} is of the order of 10 40 keV that makes it quite di cult to measure with telescopes working at 0.5-10 keV energy band, like E IN STE IN, A SCA, CHANDRA, XMM.Observations of IP perform ed with GINGA/LAC (e.g. Ishida 1991, Ishida et al. 1994) practically do not provide statistically signi cant measurements at E 20 keV, that makes it hard to con dently measure the tem peratures higher than 10 20 keV . As the energetics of the X-ray spectrum of IP is dom inated by brem sstrahlung em ission with maximal tem peratures the accuracy of its m easurement is of high importance (see.e.g. discussion in Beuermann et al. 2004).

In this work we present results of measurements of the broadband spectrum of the intermediate polar V 1223 Sgr with the RXTE and INTEGRAL observatories with an accent on the averaged hard X-ray part of the spectrum.

2.D ata analysis

The international gam ma-ray observatory INTEGRAL was launched by the Russian launcher PROTON from the Baikonur cosm odrom e in the high-apogee orbit on O ctober 17, 2002 (E ism ont et al. 2003). The payload includes four principal instrum ents which allow one to carry

out simultaneous observations of sources in the X-ray, gam m a-ray and optical energy range (W inkleret al. 2003).

In the August-Septem ber of 2003 ultra deep (2 m illion sec) observations of the G alactic center region were perform ed. The survey of this region w ith catalog of detected sources was published by R evnivtsev et al. (2004). The interm ediate polar V 1223 Sgr was detected during these observations with a high statistical signi cance in the 18-60 keV energy band.

Due to relatively large distance from the Galactic C enter (16), V1223 Sgr was outside the eld of view of the X-ray monitor JEM-X of the INTEGRAL observatory. On the other hand the source is weak and relatively soft, therefore the sensitivity of the spectrom eter SPI (Roques et al. 2003) is not enough to measure the spectrum of the source. Therefore in the paper we will concentrate on the data obtained by IB IS telescope, its upper detector ISGRI (Lebrun et al. 2003). The source was quite far from the center of the eld of view of the IB IS telescope, resulting in a strong (factor of 9.5) reduction of its elective area useful for the measurem ent of the spectrum of V1223 Sgr.

D ata of the IB IS telescope were processed using m ethods described in R evnivtsev et al. (2004). The image of the region around V 1223 Sgr is presented in Fig1. For the spectral analysis we used a simple ratio of the ux m easured from the source to the uxes of the C rab nebula in the same energy bands and assumed that the C rab nebula spectrum has the form dN (E) = $10E^{-2:1} dE$, where N (E) is the number of photons at energy E. As the spectrum of V 1223 Sgr does not demonstrate very sharp structures such m ethod of the spectral reconstruction is acceptable. Tests of this m ethod on observations of the C rab nebula show ed that the resulted spectra can still possess approxi-

m ately 5% system atic uncertainties in every energy channel.

In order to compare the obtained results with m easurements of other instruments and to accomplish the obtained hard X-ray spectrum of the source with standard X-ray band measurements (1{20 keV} we used data of the RXTE observatory (B radt et al. 1993, R othschild et al. 1998). The PCA and HEXTE spectrom eters of this observatory cover the energy range 3{250 keV.E ective areas of these spectrom eters are quite large

 6400 cm^2 for the PCA at energies 6-7 keV and 650 cm^2 for each (of two) clusters of HEXTE detectors at energies 50 keV. We quote here e ective area of only one HEXTE cluster of detectors because only one HEXTE cluster can observe the source at the same time, the other one observes the background at this time.

Interm ediate polar V1223 Sgr was observed by the RXTE observatory 14 times during period 1996-2000. Totalusable exposure time of these observation is approximately 114 ksec.

The data of the RXTE observatory was reduced with the help of standard LHEASOFT/FTOOLS 5.3 package. As the spectrum of IPs does not vary much at energies higher than > 3 keV (see e.g. Beardmore et al. 2000 for the case of V1223 Sgr) for the following analysis we averaged all available data and analyzed only averaged spectrum of V1223 Sgr. For the spectral approxim ation we used XSPEC package. Norm alizations of spectra obtained by di erent instruments were set free to vary during the tting procedure. System atic errors 1% and 5% were added to every channel of the RXTE/PCA and INTEGRAL/IBIS spectra, respectively. The resulted spectra of all instruments were rescaled to that of the RXTE/PCA.

3. Spectral analysis

First of all we approxim ated the hard X -ray part of the spectrum of V1223 Sqr obtained with INTEGRAL/IBIS and RXTE/HEXTE (energy band 20-100 keV) with a simplest therm alm odel { an optically thin therm al brem sstrahlung. The quality of the t is very good (reduced² 0:9) and the parameter of the tem perature is equal to kT = 29 2 keV. Best t parameters for separate data of RXTE/HEXTE and INTEGRAL/IBIS are 25**:**6 2:5 keV and 29 5 keV, respectively. As the obtained results agree well with each other in our subsequent analysis we will combine data of these two instruments. Obtained value of the temperature parameter is som ew hat sm aller than that obtained by Beardm ore et al. (2000) from G IN G A data (kT = 43 13 keV). However if we apply the same model (with the neutral absorption and broad gaussian line in the energy range 6 7 keV) to the data of the RXTE/PCA detector (energy band 3{ 20 keV) not taking into account harda X-ray data the resulted tem perature would be in a very good agreem ent with that of Beardmore et al. (2000) { kT = 44.5 1.5 keV.M oreover, if we will try to approxim ate only spectral

points in the energy band 10{20 keV we will obtain even higher tem perature { kT = 65 5. This discrepancy can be understood if we will take into account that the spectrum of V 1223 Sgr contains relatively strong re ected (e.g. Basko, Sunyaev & Titarchuk 1974) component and therefore the model for the spectral approximation should be m ore com plex.

In the work of Beardmore et al. (2000) only GINGA/LAC (energy range 2{37 keV) data were used to describe the source spectrum at energies > 10 keV. However, the spectrum of V1223 Sqr obtained by G IN G A /LAC practically does not contain statistically signi cant points at energies higher than 20 keV . In spite of the fact that Beardm ore et al. (2000) included re ected component into their spectral approximation it is very hard for their dataset to determ ine at the same time the tem perature of the therm alplasm a and the am plitude of the re ection. In our case we have data of INTEGRAL/IBIS and the RXTE/HEXTE (20-100 keV) and can determ ine this param eters more con dently while tting the broadband source spectrum .

of the Approxim ation broadband

spectrum (BeppoSAX data) of the another intermediate polar V709 Cas made by de Martino et al. (2001) con ms these arguments. Authors showed that the broadband spectrum of \mathbb{P} should be described by a therm alm odel with the re ection. Neglecting the X-ray re ection in a spectral modeling result in the overestimation of the temperature of a post-shock plasma in the accretion $\operatorname{colum} n \text{ of } \mathbb{P}$.

For the broadband spectral approximation we used a simple analytic model consisting of the brem sstrahlung emission with its re ection from an optically thick cold medium plus the neutral absorption and broad gaussian line at 6.5 keV. The latter component m in ics a set of lines of optically thin plasm a and uorescent Fe line, orig- eters of the approximation of the combined IN TEGRAL

inating as a result of the re ection. Such spectral model should approxim ately represent em ission of the hot plasm a in the post-shock region of V1223 Sgr. The best ttem perature of the brem sstrahlung em ission in this case will denote the maxim altem perature in the post-shock region of the accretion column of P.O btained best t param -

and RXTE spectrum of V1223 Sgr are presented in Table 2. As the value of the plasm a tem perature strongly corre- dwarf in the V 1223 Sqr: lates with the amplitude of the relection we also present con dence contours on these values in Fig. 3.

4.D iscussion

In the previous section we analyzed the broadband phase averaged spectrum of one of the brightest interm ediate polar V 1223 Sgr. W e have shown that even apart from detection of uorescent Fe line at energy 6:4 keV (see Beardm ore et al. 2000) there are strong indications on the presence of the re ection component in the spectrum of V 1223 Sqr. Because of this component any measurements of the post-shock temperature of the accretion column near the surface of P that are based on instrum ents with an e ective energy band lower than 20-30 keV are biased tow ards obtaining higher tem peratures. Our spectral modeling for the st time includes hard X-ray energy range (20-100 keV) and provides more con dent estim ation of the post-shock tem perature. U sing this value we derive som e in portant param eters of V 1223 Sqr.

Current models of a shock in the accretion column of ${\rm I\!P}$ assume that the accreted matter is heated up to its virial tem perature (see e.g. A izu 1973, Fabian et al. 1976, Lamb & Masters 1979). The heated plasma produces mainly bremsstrahlung with possible contribution from a cyclotron emission at low accretion rates (see e.g. Fabian et al. 1976, W amer 1995).

Our new broadband measurements of the X-ray spectrum of V1223 Sgr provide us a set of observables with higher con dence than that of previous. They are: 1) the post-shock tem perature $T_s = 29 - 2 \text{ keV}$, 2) the broadband X-ray ux (absorption corrected) F_{0:5 100keV} 4:6 10 10 erg s 1 cm 2 , that in turn gives us the gm ission m easure of one em itting accretion colum n $E_{m,1} =$ N²dV = $1.07 \quad 10^{13} 4 \text{ D}^2 \text{ cm}^3$, where N_e { is the num ber density of electrons in a hot em itting plasma.

The distance to V1223 Sgr is now known from HST m easurem ent of the parallax of the system , D = 527^{+54}_{43} pc (Beuerm ann et al. 2004). Therefore we can evaluate the isotropic lum inosity of one accretion column $L_{x;1}$ = 4 $D^{2}F_{0:5\ 100 \text{keV}}$ = (1:5 0:3) 10^{34} erg s¹, and the volum e em ission m easure $E_{m\ ;1}$ 3:4 10^{56} cm ³.

The shock temperature can give the direct evaluation of a white dwarf mass (see e.g. Fabian et al. 1976, W amer 1995)

Using an approximation of the white dwarf massradius relation from Nauenberg (1972)

where R₉ { is the radius of the white dwarf in the units 1. The averaged spectrum of V1223 Sgr is shown in Fig. of 10⁹ cm, we obtain for the mass and radius of the white

The obtained estimation of the white dwarf mass is slightly sm aller than that obtained by Beardm ore et al. (2000) because of low er post-shock tem perature m easured by us and is better consistent with the evaluation of white dwarf mass from optical observations: M_{WD} = 0:4 0**:**6M (Penning 1985).

The mass function of the secondary star in the system V1223 Sgr is f (M₂) = 0:0026 0**:**0015 M (W atts et al. 1985), the mass of the secondary star is $M_2 = 0.4$ (Penning 1985). Using these values we can obtain the М inclination angle of the system i = 225.Ifwewill assume that the mass of the secondary star is lower, e.g. (Beuerm ann et al. 2004) the estim ation of $M_2 = 0.25M$ the inclination angle will increase to i = 327.

As the X-ray emission is the major channel of energy losses in the post-shock region we can derive the mass accretion rate M_

$$M = \frac{3 m_H 2L_{x;1}}{8 kT_s}$$

where = 0.62 is the mean molecular weight of the accreting matter. Here factor 2 stands in order to account for two em itting magnetic poles of IP. Substituting measured values we obtain M- $2:54 \quad 10^{17} \text{ g s}^{1}$.

Using M $_{\rm W\ D}$ = 0:71M , R $_{\rm W\ D}$ = 7:8 10^8 cm and $E_{m;1} = 4 R_{W,D}^2 f = 2 h_s N_e^2 - 3.4 = 10^{56} \text{ cm}^{-3}$, where f { is the fraction of the white dwarf surface, occupied by two accretion columns, we can evaluate the height of standing shock h_s and the num ber density of electrons in the postshock region N_e following Fabian et al. (1976) and W arner (1995).

where M_{-17} { is the mass accretion rate in units of 10^{17} $g s^1$. We can derive $N_e = 9.6 \quad 10^{16} f_3^1$ cm⁻³ and $h_s = 1:1 \quad 10^7 f_3 \text{ cm}$, where $f_3 = 10^3 f_3$ is the fraction of the surface of the white dwarf, occupied by two accretion columns in the units of 10 3 . Note that the derived param eters are sim ilar to those obtained by de M artino et al. (2001) for the interm ediate polar V 709 C as.
