PSR J1829+2456: a relativistic binary pulsar

ABSTRACT

We report the discovery of a new binary pulsar, PSR J1829+2456, found during a mid-latitude drift-scan survey with the A recibo telescope. Our initial tim ing observations show the 41-m s pulsar to be in a 28-hr, slightly eccentric, binary orbit. The advance of periastron $! = 0.28 \quad 0.01 \text{ deg yr}^{-1}$ is derived from our tim ing observations spanning 200 days. A ssum ing that the advance of periastron is purely relativistic and a reasonable range of neutron starm asses for PSR J1829+2456 we constrain the companion m ass to be between 1.22 M and 1.38 M, making it likely to be another neutron star. We also place a mupper limit on the pulsar mass of 1.38 M. The expected coalescence time due to gravitational-wave emission is long (60 G yr) and this system will not signi cantly in pact upon calculations of merger rates that are relevant to upcom ing instruments such as LIGO.

1 IN TRODUCTION

The rst binary pulsar B 1913+ 16 was discovered by Hulse & Taylor (1975). This double neutron star (DNS) system with its 7.75-hr orbital period and large eccentricity (e = 0.6) has since become a wonderful laboratory for testing general relativity in the strong- eld regime (Taylor & W eisberg 1989). Perhaps most im portantly, it has provided the rst evidence for the existence of gravitational radiation (Taylor & W eisberg 1982). DNS binaries start life as binary system s with m ain-sequence stars of m ass > 6 M . Eventually the m ore m assive of the two stars undergoes a supernova explosion, leaving a neutron star, som etim es seen as a pulsar. A s the less-m assive star evolves it increases in size until it over-

lls its Roche lobe. At this point, matter starts to accrete onto the pulsar causing it to spin up to periods as short as a few milliseconds (A lpar et al. 1982), a process known as recycling. In most cases the outer layers of the com panion are blown away after accretion, exposing the core of the com panion and producing a white dwarfmillisecond pulsar binary. For some recycled systems, how ever, the com panion is massive enough to explode as a supernova. In most cases, this violent event will disrupt the binary system. The DNS binaries are those systems fortunate enough to survive. For further details see Bhattacharya & van den Heuvel (1991). Our understanding of the DNS binary population is currently ham pered by small-number statistics. Large-scale pulsar surveys are being carried out by a number of groups in order to improve this situation by increasing the sam – ple of objects. In this Letter we report on the results of a drift-scan survey using the A recibo telescope. The survey was conducted at 430 M H z and covered mostly intermediate G alactic latitudes (bj < 60) to optim ise the likelihood of nding millisecond and binary pulsars (see e.g. C ordes & Chemo 1997). The known pulsars detected are described along with prelim inary parameters for a new 41-m s pulsar J1829+ 2456 which is likely to be a DNS binary. W e com – pare the properties of this new system with the known DNS and other relativistic binaries. Finally, we outline the future observational prospects for this system.

2 OBSERVATIONS AND ANALYSIS

In July and August of 1999 the A recibo radio telescope was used to take the data presented here. The receiver was parked and observations were m ade as the sky drifted overhead. The new ly commissioned 430-M Hz receiver system in the G regorian dome was used in combination with the Penn State Pulsar M achine (PSPM), a 128-channel analogue Iterbank spectrom eter which sam ples the incoming voltages from the telescope every 80 s over a bandwidth

of 7.68 M H z (C adwell 1997). The G regorian dom e 430-M H z receiver has a gain of 11 K Jy ¹ and a system tem perature of 45 K. At these latitudes a source passes through the beam in 40 s. This is well matched to a 2^{19} -sam ple time series collected with the PSPM (42 s). Our survey sparsely sam pled a total of 230 deg² within the right ascension range: 15h < 20h for two declination ranges de ned by 8 < 12 and 24 < 28. The instrum ental setup was identical to that described by Lorim er et al. (2004), in which the system sensitivity was estimated to be greater than or about 0.5 m Jy for long period pulsars away from the G alactic plane and 3 m Jy for m illisecond pulsars. Full details of the search sensitivity will be given elsewhere.

The observations were analysed at the JodrellBank Observatory using a 182-processor Beowulf cluster (COBRA and an identical procedure to that described by Lorim er et al. (2004). A suite of data analysis tools (Lorim er 2001) was used in combination with scripts to keep each node continuously processing from the pool of data. Each drift observation was split into 42-s beam s, with each beam overlapping 50% of the previous beam. These beams were then dedispersed using trial dispersion m easures (DM s) between 0 and 491.2 pc cm 3 . The resulting time series were then Fourier transform ed and searched for periodic signals. Incoherent sum m ing of the st 2, 4, 8 and 16 harm onics was used to increase sensitivity to narrow pulse pro les. Any resulting candidates with a signal to noise ratio (S/N) greater than 8 were folded for visual inspection. It took 13,000 CPU hours to complete the analysis of the 14,200 overlapping beam s.

3 RESULTS AND FOLLOW -UP OBSERVATIONS

In the 230 deg² of sky covered by the survey, 4 known pulsars were detected; PSR J1649+ 2533 (period, P = 1.02 s; DM = 34 pc cm³) with S/N 80, PSR J1652+ 2651 (P = 0.92 s; DM = 40.8 pc cm³) with S/N 73, PSR J1532+ 2745 (P = 1.124 s; DM = 14.7 pc cm³) with S/N 38 and PSR J1543+ 0929 (P = 0.75 s; DM = 35.2 pc cm³) with S/N 85. The rate of pulsar detections in the data is consistent with the rate in previous drift{scan data taken using the line{feed in combination with the PSPM (M cLaughlin et al. 2003).

One promising pulsar candidate was found with P = 41**:**02 m s, D M 13.9 pc cm 3 and S/N 10.The candidate was reobserved and con med as a new pulsar, J1829+2456, on June 3 2003 using the same observing system with a 10m in integration. Further observations showed that the pulsar scintillates strongly, with the ux density ranging from 0.07 mJy to 0.7 mJy. In Fig. 1 we present an integrated pulse pro le. The con med approximate position put the pulsar in the line of sight of the Gould belt (Gehrels et al. 2000; G renier 2000), a dense region of atom ic and m olecular gas containing young stars and an ideal environment for producing strong scintillation. The DM from the search observation and the pulsar's G alactic coordinates (1' 53; b' 15:6) imply a distance of 12 kpc (Cordes & Lazio 2002). The true distance m ay in fact be much lower due to the unmodelled excess electron density in the Gould belt. The con mation period was 40.99 ms, signi cantly shorter

than the discovery period. This indicated that the pulsar was most likely a member of a binary system .

In order to determ ine the orbital parameters of PSR J1829+2456, observations were made using the same observing system over the following 6 months. These data were dedispersed and searched for the period of the pulsar. Long observations when the pulsar appeared strongly were split and searched independently to provide more data points. The topocentric periods and observation times were then converted to barycentric periods and times using the TEM PO¹ software package. These barycentric periods and times were then tted to possible binary orbits, resulting in the curve shown in Fig. 2, which represents the pulse period evolution for an assumed orbital period P_b ' 28 hr, projected sem im a jor axis x = $a_1 \sin i$ ' 72 lt-s and eccentricity e ' 0:14.

U sing this prelim inary ephem eris, the data were folded m odulo the predicted period and cross correlated with a high S/N tem plate pro le to obtain an accurate time of arrival (TOA) for each observation. The TOAs were then analysed with TEM PO to produce a prelim inary phase-connected solution (where every rotation of the pulsar is accounted for) over the time span of the observations. This resulted in the ephem eris given in Table 1.

4 D ISC U SSIO N

4.1 M ass determ ination

The orbital parameters in Table 1 can be used to constrain the mass of the binary system . The K eplerian mass function relates the orbital period, $P_{\rm b}$, and the projected sem i-m a jor axis, x, to the masses of the binary components. For this system we calculate a mass function

where T = GM c³ = 4:925490947 s, i is the inclination between the plane of the orbit and the line of sight, x is in

light-seconds, P_b is in seconds and the pulsar and companion m asses m₁ and m₂ are in Solar m asses. Neutron stars are observed to have a narrow range of masses. Given the data in Thorsett & Chakrabarty (1999), and the low m easured m ass of PSR J0737 3039B (Lyne et al. 2004), we expect the pulsar m ass to lie between 1.25 M and 1.47 M . For an orbit viewed edge-on (i= 90), and a minimum neutron star m ass for PSR J1829+ 2456 of m₁ = 1.25 M , we calculate a minimum companion mass m₂ ' 1.22 M . As shown in the following equation, the m easurem ent of the advance of periastron, <u>!</u>, if assumed to be purely relativistic, allows a m easurem ent of the sum of the masses:

W hen the measured $\underline{!}$ is used in combination with the constraint that sin i < 1, we obtain an upper limit on the maximum pulsar mass $m_1 < 1.38$ M $\,$. Similarly, assuming $m_1 > 1.25$ M $\,$, the maximum value of $\underline{!}$ implies i > 66 . These constraints are shown in a mass-mass diagram in Fig. 3. Although we cannot currently rule out a massive white dwarf or main-sequence star, given the similar mass functions, spin and orbital parameters of J1829+2456 to other DNS binaries (see Table 2) it seems most likely that the companion is another neutron star.

4.2 A search for the com panion

The accuracy of the position of PSR J1829+2456 inferred through radio timing is su cient to allow for a search for an optical companion. No optical companion is present in the uncalibrated plates of the D igitised Sky Survey. P reparations are underway for a deep optical search for the companion star.

G iven the possibility that the com panion of J1829+ 2456 is a neutron star, a search was made of the available radio data for a periodic signal which could be coming from the companion if it were active as a radio pulsar. This search was given greater signi cance following the recent detection of 2.8-s pulsations from the companion of PSR J0737 3039A (Lyne et al. 2004). Initial searches of the data (at the DM of PSR J1829+ 2456) booking for other periodic signals showed

that, if the companion was an active radio pulsar, it was too weak to be easily detectable.

To carry out a more sensitive search for the com panion, we made use of the fact that the orbital parameters of the system are known and that the pulsations from the com panion star would be D oppler shifted in the opposite sense to PSR J1829+2456 due to its orbital motion about their com mon centre of mass. To correct for this e ect, we applied the rst-order D oppler form ula to calculate the effective sam pling interval in the rest-fram e of the com panion:

where $t_{sam p}$ is the sam pling interval at the observatory and v(t) is the elective line-of-sight radial velocity of the companion as a function of time, t. We used TEMPO to calculate v(t) to account for the elects of orbital motion in the binary system (using the orbital parameters given in Table 1, assuming a pulsar mass of 1.35 M and changing only the longitude of periastron by 180) as well as contributions from the Earth's rotation and motion about the Sun. All available data were dedispersed and resampled in this way before being passed through the standard search analysis. No signi cant candidates were found down to a S/N of 5. This corresponds to a 430-M Hz ux limit of 0.1 m Jy.

W hile the lack of detection of the companion suggests that it is too weak to be seen as a radio pulsar, or unfavourably beam ed, it should be noted that the companion to PSR J0737 3039A is only clearly detectable over certain phases of the orbit (Lyne et al. 2004). If any companion to PSR J1829+ 2456 was behaving in a sim ilar fashion it may not be visible in the current data set. Further, more sensitive, searches will be carried out as more data are taken. 4.3 Expected relativistic param eters

U sing the constrained range of m asses for the pulsar and companion the expected orbital period derivative and period for geodetic precession due to m isalignment of the spin axis of the pulsar with the orbital angular momentum vector (Barker & O'C onnell 1975) can be determined. Assuming a combined mass of 2.53 M , the expected values for P_b and the expected timescale for geodetic precession are given in Table 1. The expected should be measurable after 18 m onths of timing data. The expected P_b is too small to be measurable without a long-term (5{10 yr) timing campaign. The expected timescale for geodetic precession is 4200 yrs, too long to be measurable through pulse prole or timing variations.

4.4 C om parison with other relativistic binary system s

If our future m easurem ents show PSR J1829+ 2456 to be a double neutron star system it will be the seventh such system to be discovered. Table 2 contains a list of the most relativistic binary pulsar system s and their orbital parameters.

W ealso list the coalescence time $_{GW}$ due to the emission of gravitational radiation of each system. Following Lorin er $(2001)^2$, we can approximate the detailed calculations of $_{GW}$ by Peters (1964) via

where the reduced mass $= m_1 m_2 = (m_1 + m_2)$. For any reasonable range of m_1 and m_2 discussed above, we nd $_{GW}$ 60 Gyr.

The systems listed in Table 2 span a wide range of orbital parameters but can be broadly split into systems that will and will not coalesce within a Hubble time, with PSR J1829+2456 lying toward the edge of the non-coalescing group. The relatively long coalescence time for J1829+2456 m eans that it will not a ect the DNS m erger rate calculations (e.g. K alogera et al. 2004) for gravitational wave detectors such as LIG O.

5 FUTURE STUDY

In an A recibo drift-scan survey of 230 deg² we have discovered a new relativistic binary system, PSR J1829+2456. O urm easurem ents so far suggest that the com panion is most likely another neutron star. The long predicted gravitationalwave coalescence time means that this system has no e ect on the calculations of m erger rates required for instrum ents such as LIGO.A dedicated A recibo timing campaign will allow more accurate measurements of the position of this system, the spin-down rate of the pulsar and the relativistic advance of periastron. Continued tim ing will provide additional valuable inform ation: the system 's proper motion, the relativistic tim e-dilation and gravitational redshift param eter , and possibly a measurem ent of Shapiro delay. An optical search for the companion is planned to con m whether it is a massive white dwarf or, as seem s most likely, another neutron star. Studies of scintillation e ects are also planned which should allow the inclination angle of the orbit to be determ ined.
