## M odelling the Spectral Energy D istribution of Com pact Lum inous Infrared Galaxies: Constraints from High Frequency Radio Data

Abstract. We have perform ed 23 GHz VLA observations of 7 compact, lum inous infrared galaxies, selected to have evidence of starburst activity. New and published multi{frequency data are combined to obtain the spectral energy distributions of all 7 galaxies from the near{infrared to the radio (at 1.4 GHz). These SEDs are compared with new models, for dust enshrouded galaxies, which account for both starburst and AGN components.

In all 7 galaxies the starburst provides the dom inant contribution to the infrared lum inosity; in 4 sources no contribution from an AGN is required. Although AGN m ay contribute up to 50 percent of the total far{infrared em ission, the starbursts always dom inate in the radio. The SEDs of most of our sources are best twith a very high optical depth of 50 at 1 m.

The scatter in the far{infrared/radio correlation, found am ong lum inous IRAS sources, is due mainly to the di erent evolutionary status of their starburst components. The short time{scale of the star form ation process am pli es the delay between the far{infrared and radio em ission. This becomes more evident at low radio frequencies (below about 1 GHz) where synchrotron radiation is the dom inant process. In the far{infrared (at wavelengths shorter than 100 m) an additional source of scatter is provided by AGN, where present. AGN m ay be detected in the near{infrared by the absence of the knee, typical of stellar photospheres. How ever, near{infrared data alone cannot constrain the level at which AGN contribute because the interpretation of their observed properties, in this wave{band, depends strongly on m odel param eters.

#### 1. Introduction

O ne of the m ost intriguing aspects of IRAS galaxies (Soifer et al., 1984, Sanders & M irabel 1996), characterized by their extrem ely cool em ission (peaking between 60 and 100 m), is the origin of their high lum inosities, offen exceeding  $10^{12}$  L . In such galaxies it is clear that we observe radiation from dust at tem peratures of a few 10s of K elvin. How ever, the question of whether the heat source is baryonic nuclear processing in young stars, or accretion of baryons onto a central black hole is still debated. Recent evidence (e.g. Ferrarese 2002) that all spheroids harbour a central black hole, suggested by the existence of a tight correlation between the masses of black holes and the spheroidal components, in plies that there m ay be a relationship between these two processes. The evidence

that alm ost allultra lum inous IRAS sources (ULIRGs) exhibit signatures of on-going or recent interaction, suggests that the triggering m echanism is dynam ical interaction. Several questions remain:

- 1. W hat are the relative fractions of m ass going into star form ation and accretion respectively?
- 2. How tight is the link between star form ation and nuclear activity? And is there any causal link between the two processes?
- 3. How important is the role of mutual feedback in the term ination of these processes?

The answers to these questions take on greater in portance if, as deduced by deep ISO and sub{millimetric surveys (e.g. Franceschini et al., 2001, 2003; E baz et al., 2002; Sm ailet al., 2000; B arger et al., 2000), U L IRG s are the bcal counterparts of a larger population of lum inous galaxies at redshifts z 0:5.

Recent spectroscopic determ inations of the redshift of SCUBA sources (Sm ailet al., 2003) con m that these objects have extrem e lum inosities. If these lum inosities were due to starburst episodes (accounting for possible m agni – cation by gravitational lensing), they would correspond to star form ation rates (SFR s) in excess of several thousand M /yr. If these extrem e SFR s were m aintained over a dynamical timescale, a spheroidal component of a typical L galaxy could be assembled.

B oth star form ation and nuclear activity can be significant sources of energy feedback into the interstellar and intergalactic m edia { galactic w inds and re-ionization respectively (e.g.G ranato et al., 2001; G ranato et al., 2003). The latter m echanism is one of the most im portant, if least understood, ingredients in current m odels of galaxy form ation (C avaliere, Lapi & M enci, 2002).

Bressan, Silva & Granato (2002) showed that com parison of the radio and far{infrared (FIR) emission may provide an accurate diagnostic for the study of the star form ation history during the strong starburst phase characteristic of com pact ULIRGs.By means of new starburst models they were able to show that deviations from the FIR / radio correlation could be used to derive the evolutionary status of the starburst. These deviations are expected in bursts of short duration because at early times (a few  $10^6$  y) even the most massive stars form ed in the burst will not have ended their lives as supernovae and no excess synchrotron em ission should result from the starburst activity. Such starbursts would be relatively strong FIR em itters. Another important signature of a young starburst is its radio slope; as young starbursts are not yet dom inated by synchrotron radiation from supernovae <sup>0:7</sup>, due to their radio slope should be atter than S / the large free-free component from ionized gas.

B ressan, Silva & G ranato's (2002) ability to derive the radio slope of objects in C ondon's (1991) sam ple of com – pact U L IR G s w as lim ited by their use of existing radiom – etry at 1:4 G H z (which m ay be a ected by free-free absorption). M oreover, they did not attempt to perform a com plete t to the com plete SED of the galaxies, nor did they account for the e ects of the AGN in the infrared.

The new 23 GHz uxes presented here allow for both the determ ination of the radio spectrum, una ected by free-free absorption, and place a useful constraint on the level of free-free em ission. The combination of radio data with IRAS uxes at 60 and 100 m provides a strong constraint on the age of starburst activity. FIR data below 60 m are sensitive to the contribution of AGN, which m ay then be estim ated as the excess above the starburst component.

By studying local ULIRGs we can probe all of the im – portant physical mechanisms involved in the form ation of spheroidal systems: dynam ical interaction; the triggering of star form ation; QSO activation and, perhaps most im – portant, feedback. In this paper we present new 23 GHz observations of 7 compact ULIRGs.W ith these new data and existing archival photom etry/radiom etry, we study their star form ation history and possible AGN contributions.

Source selection is brie y discussed in Section 2, corresponding observations are presented in Section 3. In Section 4 we describe the procedure used to obtain the ux m easurements of the observed sources while in Section 5 we present the data. In Section 6 we present starburst and AGN models adopted to t the SEDs of the observed galaxies. D iscussion of the results and conclusions are given in Sections 7 and 8, respectively.

#### 2.Sample Selection

Sources were selected from C ondon et al.'s (1991) catalogue of compact U LIRGs. These, in turn, are a sub{set of sources in the R evised IRAS B right G alaxy Survey (Soifer et al., 1989). O b jects in our sample were selected to have a ratio of FIR to 1.4 G H z lum inosity q 2.5. Such a ratio should, according to the starburst models of B ressan, Silva & G ranato (2002), help ensure em ission is dom inated by a young starburst. All sources were required to be bright enough, at 8.44 G H z, to ensure a strong detection (estimated to be in excess of 7) within a few m inutes integration and to be grouped close enough in R A . to enable the entire sample to be observed within a few hours at the VLA.NGC 7469 (q = 2.29) was added as a well studied com parison source, which is known to contain a central AGN and a circum nuclear starbursting ring.

Integrated radio, FIR and sub-mm uxes of the sources are presented in Table 1. Flux densities at 1:4 GHz were taken from either the FIRST, NVSS or Condon et al. (1990) catalogues, 4:85 GHz uxes from Sopp & A lexander (1992) and 8:44 GHz uxes from Condon et al. (1991). Integrated near{infrared (NIR) uxes from the 2M ASS archive (Jarrett et al., 2003) are shown in Table 2.

#### 3.0 bservations

K (band (22:5 GHz) observations were made with the VLA in D (array on 2002 January  $3^{rd}$ , 0800(0900 LST and 2002 January  $5^{th}$ , 2100(2400 LST .W e used a bandwidth of 50 MHz. During our observations 18 antennae were tted with new low (noise K (band receivers, the remaining 9 with old receivers. The estimated point source rm s. noise in a naturally weighted im age was then 5:958 (t)  $^{1=2}$  m Jy beam  $^1$  where t is the integration time in seconds. At 23 GHz the angular resolution of D (array is approximately 2.5 arcsec.

Pointing errors for the VLA antennae are known to significantly degrade the sensitivity of the instrument at high frequencies. In order to obtain the most accurate possible ux density measurements we ne{tuned the pointing accuracy using the procedure termed second order referenced pointing<sup>1</sup>. At the start of both observing runs the pointing o set was determined for the ux calibrator in

the sensitive X (8:4 GHz) band. The second { order pointing correction was determined at the normal observing frequency, 23 GHz. This pointing o set was applied to m easurem ents of the phase calibrators and the sam e procedure followed to nd accurate pointing corrections near to each source position. Finally these phase calibrator o sets were applied when pointing at the target source. Each source and its associated phase calibrator was observed for 4 (IRAS 0136-10, NGC 34, NGC 7469, IRAS 08572+39) or 5 (CGCG 436-030, UGC 12812, IC 5298) snapshots.

The choice of ux density calibrators was dictated by the available hour angle coverage: on January 3rd 3C147 (0542+498) and on January 5<sup>th</sup> 3C48 (0137+331) were observed. P hase calibration sources were chosen from the subset of the NRAO VLA calibrator list<sup>2</sup> with positions known to better than 2 m as. Each source was associated with the nearest calibrator with tabulated 15 and 43 G H z (2 and 0.7 cm) uxes and designated P or S at both these frequencies, none had tabulated 22 GHz (1.3 cm) ux densities. (For a P class calibrator am plitude closure errors are expected to be 3 percent; for an S class calibrator in the range 3 to 10 percent).

#### 4.1. Calibration & Editing

Rapid ionospheric/tropospheric phase instabilities, coupled with angular resolution capable of resolving structure in the calibration sources, dem ands particular care when reducing data in the 22 GHz band. Calibration and editing were performed within the NRAO data reduction package a ips, follow ing the m ethod suggested for high frequency data obtained with the VLA (e.g. A IPS Cookbook Appendix D).

D ata were loaded such that nom inal sensitivities were used to give relative weight to data points and opacity and gain curve corrections were applied. Throughout calibration both data and their associated weights were calibrated. To avoid the e ects associated with resolving the structure of the primary ux calibrators, clean component models (available via the VLA website<sup>3</sup>), were used for both ux calibrators, 3C 147 and 3C 48, when solving for antenna { based phase and am plitude calibration solutions. Calibration solution intervals were made short (20 seconds) to account for rapidly varying atmospheric phases.

#### 4.2. Mapping & Model-tting

Mapping and model-thing were carried out in a homogeneous manner within difmap (Shepherd 1997). Data were inverted onto a large m ap (1024 x 1024 pixels of 0.35 x 0.35 arcsec) the central quarter of which was cleaned (H ogbom 1974) until the peak in the residual m ap < 4 (where here refers to the rm.s. level of the residuals) and continued cleaning resulted in no further reduction in the residual level. For the stronger sources the data were then self{calibrated and re-cleaned until convergence. The data were re{m apped on to 512 x 512 pixels of side 0.35 arcsec and any further cleaning necessary was performed

in a clean window just big enough to contain the high residuals surrounding the source position. W hen further cleaning resulted in no improvement in the reduction of the residual level, maps were restored.

Our maps show that, with the possible exception of NGC 7469, all sources are unresolved at an angular resolution of approximately 2.5 arcsec, as expected from the results of C ondon et al. (1991). Flux densities were ob-

tained directly from the restored m aps and from m odelling the sources in the visibility dom ain with difmap: modelfit. An initial model for the source was taken from the m ap; this consisted of its ux, m a pr and m inor axes, position angle, the radial distance and position angle of the source from the phase centre and the form (e.g. point{like or G aussian). difmap: modelfit transforms the im age plane m odel com ponents into the u {v dom ain to enable a

direct comparison of model visibilities with the observed, calibrated visibility data. A set of iterative adjustments were made to each of the model parameters to minimize the model's <sup>2</sup> (statistic.W hen successive iterations failed to provide an improvement and  $\frac{2}{r} < 1$  (where  $\frac{2}{r}$  is the reduced <sup>2</sup> (statistic) the iterations were halted. All uses presented in Table 4 are derived from source models with  $\frac{2}{r} < 0.85$ .

#### 5.Results

#### 5.1. Radiom etry

The accuracy of our radiom etry is critically dependent on the ux densities we determ ined for the calibration sources. In Table 3 we list the assumed ux densities of the ux calibrators (3C 48 and 3C 147) and the dependent measured uxes of the phase calibrators. We note that, as expected, the phase calibrator with the worst determ ination of ux, 0927+ 390 (with ux density errors at the level of alm ost 1.5 percent), was that used on January 3 for source IRAS 08572+ 39.

The error estimates were calculated based on the assumption that the term due to measurement noise and that due to errors in gain calibration (and therefore proportional to the measured ux) may be added in quadrature. The rst term was estimated by the noise in the background of the uniform ly weighted map, the second by the fractional error in the associated phase calibrator's ux density (Table 3). The phase calibrators were chosen to be near to the source and as opacity and gain curve corrections were performed on loading data into aips, no further dependence on zenith angle was considered. W e expect ux densities measured directly from visibility data to be more reliable than those determined from the m ap, being independent of im aging errors and of cleaning. These measured source ux densities are presented in Table 4.Suv is the ux density determined from iteratively tting model visibilities to the calibrated data as described above. Positions given in Table 4 refer to the phase centres and r and to the radial o set and position angle (north through east) of the peak from the phase centre, as determ ined by the model{ tting procedure.

#### 5.2. Comparing uxes at di erent resolutions

It is important to note that data at di erent frequencies were obtained from observations at di erent resolutions and that all the radio data are from observations at much higher resolution than that of IRAS (3 arcm in at 100 m). For sources extended in the radio this could bias ux m easurem ents at higher resolutions to lower values

as ux becom es resolved out of interferom etric m aps. For the IRAS uxes we also need to consider the potential of confusion with nearby sources. Using the 1:4 GHz m aps of C ondon et al. (1990) we nd that all of our sources are sm aller than 5 arcsec diam eter in the radio and offen sm aller than 2 arcsec. O ur 23 GHz observations will therefore not underestim ate the uxes in these objects because of their angular sizes. The only data for which resolution m ay be a problem are the VLA A -array observations at 8.4 GHz of C ondon et al. (1991). These have a resolution of 0.25 arcsec and for the source NGC 7469 some ux is alm ost certainly not detected. The 8:4 GHz ux for this object is thus a lower limit, as indicated in Table 1.

W e investigated the possibility of contam ination of the IRAS uxes by using NVSS in ages to look for sources su ciently close to our target sources to cause confusion at 100 m.W e then m ade use of the FIR / radio correlation to estimate the proportion of the IRAS ux contributed by the companion. The IRAS uxes for 3 ob jects were thus estim ated to have a sm all contribution (up to 10 percent) from a nearby source; these are the only three from our sample that show evidence of being resolved in the IRAS data of Soifer et al. (1989). The IRAS uses for these sources were reduced as follow s.NGC 7469:7 percent; IC 5298:10 percent; UGC 12812:3.5 percent. W e note that these corrections are small and at least for the 12 and uxes are of the same order as the errors on the 25 m uxes.

#### 6. A nalysis of the spectral energy distribution

Observations of the spectral energy distribution from the FIR to the radio have been complemented by ux measurements in the NIR J, H and K bands by the Two M icron All Sky Survey (2M ASS e.g. Jarrett et al., 2000). Berta et al., 2003 have convincingly shown that a J-K ux excess, over that expected from a pure starburst, is a strong indicator of the presence of an AGN. Further signature of the presence of an AGN com es from the dust tem perature derived from thing IRAS uxes (eg. Sanders et al., 1988b). The contribution of an AGN in the radio is assumed to be zero (see Section 7) and we take the radio em ission to be due entirely to star form ation. We t the spectral energy distribution with a combination of starburst m odels generated with the recent version of GRASIL (Silva et al. 1998, Bressan, Silva & Granato 2002), that includes radio em ission from star form ing regions, and AGN m odels generated with the radiative transfer code developed by Granato & Danese (1994).

#### 6.1. Starburst m odels

The starburst model is described by the superposition of a burst of star formation on a quiescent disk. The SFR in the disk galaxy is obtained by an infall chem ical evolution model with a Schmidt law and a Salpeter initial mass function ( $\mathbb{IM}$  F) from 0.15 M to 120 M.

The parameters of the chemical evolution models, i.e. the infalltime-scale (t<sub>inf</sub>) and the SF law, SFR =  $M_g^k$  are shown in Table 5.

At an epoch of 11.95 Gy the star form ation rate is enhanced to m in ic the burst. The intensity of the SFR is xed by assuming that the mass of stars formed during the burst is a fraction of the underlying disk mass and by the e{folding time{scale taken to be  $t_b = 10, 15, 25 \text{ or } 50$  M y.

Half of the gas mass was assumed to be in the form of molecular clouds of  $10^6$  M , with the remaining gas distributed as a di use component. Stars form at the centre of these molecular clouds and su er an extinction given by the cloud optical depth, MC. The obscuration time, tesc, was set to linearly decrease with time from to down to a minimum of 3 My (characteristic of norm algalaxies). O lder stars are attenuated only by the di use component. The dust/gas ratio was selected to be 0.01.PAH features and temperature uctuations of small grains were taken into account as described in Silva et al. (1998). O urm ain conclusions are not a ected by the details of these parame

ters.However, since the m id infrared region (12 to 25 m) is sensitive to the optical depth of the molecular clouds ( $_{1\mm}^{M\c}$ ), we considered three di erent values of  $_{1\mmmode m}^{M\c}$  = 20, 45 and 180.

The ensemble of older stars, molecular clouds and diffuse component of the burst follow a spheroidal geometricaldistribution (see Silva et al 1998 for more details).

#### 62.AGN models

Dusty AGN SEDs were selected from libraries generated with the model of Granato & Danese (1994) and Granato, Danese & Franceschini (1997). Each library consists of several hundred cases, belonging to a given geometrical class, in which typically 4 to 5 parameters are varied, assigning 3 to 4 widely di ering values to each. Libraries com – prise both anisotropic ared discs and tapered discs (for de nitions see for instance E fstathiou & Rowan-Robinson 1995). The elects of various parameters on the predicted SED have been explored in Granato & Danese (1994) and Granato et al. (1997). A lso included in the libraries are

m odels in which the size distribution of grains extend to radii larger than the standard value, as suggested for example by M aiolino et al. (2001a, b) and G alliano et al. (2003). We refer the reader to G alliano et al. (2003, in press) for a full description of these libraries.

# Finally the last column reports the value of the merit function of the t. The merit function is calculated as

### 6.3.M odelFitting

Model ts to the SEDs described above are shown in Figures 1 to 4; their parameters are shown in Table 6. Here M <sub>burst</sub> is the totalm ass of gas and stars in units of  $10^{10}$  M ; b is the e-folding time of the SFR in units of  $10^6$  y; age is the current age of the burst in units of  $10^6$  y;  $M_{2}$  is the current m ass in stars in units of  $10^{10}$  M; SFR is the average SFR in units of M /y over the lifetime of the burst;  $L_{AGN}/L_{Tot}$  is the fractional contribution of the AGN to the total lum inosity from 8 to 1000 m; and Rm are the inclination and the ratio of the external to internal radius of the torus, respectively. M Gal is the mass of the old disk, in units of  $10^{11}$  M , as determined by the t to the NIR uxes. It is worth noting that, when an AGN is present, and in particular when this is indicated by the shape of the SED  $% M_{\rm Gal}$  in the N IR , M  $_{\rm Gal}$  must be considered an upper lim it to the mass of the galaxy. This is because the AGN contributes ux in excess of that from the old stellar disk at N IR wavelengths.

SFR  $_{\rm r}$  is the current star form ation rate derived from the L  $_{\rm r}$  of the modelled starburst spectrum . This is added as a comparison showing how the SFR might be estimated using one of the standard measures (Kennicutt, 1998). Kennicutt's (1998) calibration was obtained from the ratio of the bolom etric lum inosity to SFR in a model of constant star form ation over the last 100 M y. Since it refers to a Salpeter IM F between 0:1 M and 100 M we have divided the values obtained with the Kennicutt relation by 1.16 to account for our di erent lim its on the IM F (between 0:15 M and 120 M ). where M  $_{\rm i}$ , O  $_{\rm i}$  and E  $_{\rm i}$  are the model values, the observed values and the observational errors respectively, N is the number of passbands used for the t.

The models shown in Figures 1 to 4 result from the combined contribution (solid line) of a starburst model (dashed line) and an AGN model (dotted line). In the plots we also show the instantaneous, current star formation rate SFR<sub>c</sub>.

The starburst m odel includes the contribution of the underlying quiescent star form ing disk. The spectral energy distribution of this disk is shown as the lower solid line. Its contribution to the total FIR and radio emission is negligible since its star form ation rate amounts to only a few M /yr while that of the starburst is, in general, an order of magnitude larger. However, due to the cooler tem perature of the dust that characterizes the quiescent disk, its contribution to the sub-m illimetre SED m ay be signi cant. This should serve as a warning against tting the sub-m illimetre SED of infrared sources with a single component starburst model. In the near(IR the old population of the galaxy, in agreement with the results of M ayya et al. (2004).

#### 7.D iscussion

A lm ost since the discovery of the far-infrared/radio correlation it has been suspected that the scatter in the relation has a contribution from the delay between the infrared and radio em ission during the star form ation process (e.g. Helou, Soifer & Rowan-Robinson, 1985, W underlich & K lein, 1988). Bressan, Silva & G ranato (2002) investigated this idea with a model in which the scatter in the value of q, the FIR/radio ratio, in ULIRGs is caused by evolution i.e. the e ect of an intense, short duration burst that is quenched rapidly. In particular, high values of q, relative to the average for star form ing galaxies, should be typical of young bursts because of the delay between FIR em ission and radio em ission. Moreover, a high value of q should be associated with at radio slopes because the radio em ission in the early phases of the burst is dom inated by freefree em ission. This suggestion is generally con med by the present investigation. However, it is clear that this sim ple picture is com plicated by the possible presence of AGN, which may contribute a signi cant fraction of the FIR lum inosity shortward of 60 m.

Above 60 m, the FIR to radio SED provides fairly good constraints on the starburst component. In particular, at radio slopes are associated with an excess of FIR ux with respect to the radio em ission, in agreement with the predictions for young starburst models.

In thing the model to the data we have neglected the possible contribution of an AGN at radio wavelengths. It has been show n, using VLBI observations of ULIRGs with compact radio cores (Sm ith et al., 1998), that the average value at 1:6 GHz of  $S_{VLBI}=S_{Total}=0:12$ . These observations suggest that, in our sample, the AGN contribution in the radio is sm all.

Furtherm ore, the shape of the radio spectrum, both in objects with and without the signature of AGN contam ination in the mid- $\mathbb{R}$ , can be reproduced very well by starburst models.

If the contribution of the AGN were signi cant at radio frequencies the relative contributions of the starburst and AGN in the models would require netuning in order to reproduce the observed radio spectrum. In particular, it would be dicult to explain the variation of the radio slope as one moves from the synchrotron dom inated (1.4GHz) to the free-free dom inated (23GHz) regime.

It is also evident from our ts that the starburst alm ost entirely dom inates the SED at 100  $\,$  m, even when there is a strong contribution from the AGN to the total FIR lum inosity.

The ratio between 100 m and radio uxes is always well reproduced by starburst models. The presence of a radio { loud AGN will a ect this ratio more than that between the total FIR and radio uxes.

Thus, we argue that the contribution of the AGN at radio wavelengthsm ust be small in our objects, 10%. This does not signi cantly modify our conclusions concerning the star formation history of the galaxy, if one considers that starburst radio uxes change by about one order of magnitude from 1.4 GHz to 23 GHz.

W hether this is a comm on characteristic of the com – pact ULIRGs remains to be investigated by extending our m ethod to the whole sample of C ondon et al. (1991).

O bservations close to 23 G H z are decisive because they signi cantly extend the frequency range that is not affected by free-free absorption. C ondon et al. (1991) have argued that 1:4 G H z radio uxes in com pact U L IR G s m ay be a ected by free-free absorption. Furtherm ore, B ressan, Silva & G ranato (2002) have shown that this e ect m ay be m istaken for evolution, i.e. a shallow er radio slope de-

term ined from the 1:4 GHz radio ux may result either from free-free absorption or a younger sturburst.

Between 1:4 GHz and 23 GHz synchrotron emission fades by about an order of magnitude, disclosing the thermal emission from ionized gas, which is a more direct tracer of the ongoing star form ation.

Since them al and non-them al radio em ission appear in proportions that are dictated by the recent history of star form ation, observations of the SED over such a wide range of frequencies prove to be essential for the determ ination of the burst param eters.

To clarify this point, gure 5 depicts the fractional contribution of free-free em ission to the total radio em ission for di erent frequencies as a function of the burst param – eters: age and SFR decay{tim e in our models. Free-free em ission from ionized H II regions always provides a signi cant contribution to the 23 G H z ux, being less than 50 percent only during the late evolution of the burst, when the radio em ission is dom inated by supernovae from less m assive stars. At low er frequencies not only does the fractional contribution decrease but during the early phases of the burst it does not provide 100 percent of the radio em ission, as may be expected, due to the supernova em ission of the old stellar disk.

For bursts younger than 20 M y m ore than half of the 23 G H z ux is contributed by free-free em ission from H II regions, while at ages t < 10 M y this fraction rises to 80 percent. E stim ates of the ionizing photon ux (and therefore the SFR) based on the free-free em ission m ay be affected by uncertainties in the fraction of ionizing photons lost by internal dust or escape (which can be as large as 30 percent, P anuzzo et al., 2003) but they are independent of the uncertainties that a ect synchrotron em ission. E ects such as the strength of the m agnetic eld and inverse C om pton cooling on the strong radiation eld of the starburst are discussed in B ressan, Silva & G ranato (2002).

In three sources, NGC0034,  $\mathbb{R}AS01364-1042$  and  $\mathbb{R}AS08572+3915$  the determ ination of the burst param eters would not be possible without high frequency observations. Moreover in  $\mathbb{R}AS01364-1042$  and  $\mathbb{R}AS08572+3915$  the 23 GHz data allow us to conclude that the 1:4 GHz uxes are a ected by signi cant free-free absorption. In all other galaxies the 23 GHz observation unam biguously xes the therm al contribution and then the age of the starburst.

Thus, the combination of accurate radio measurements with FIR data provides a good estimate of the relative contributions of the AGN and the starburst.

In some cases, the presence of an AGN is revealed by the NIR colours showing the shape of a typical, dom inantly power{law spectrum, instead of the knee{ dom inated starburst spectrum. However, by means of these colours alone it is not possible to constrain the fractional contribution of the AGN, because the colours are a function of the torus model (optical depth, inclination etc.)

In sum m ary, we nd that all the com pact ULIRGs in our sample are associated with strong, young bursts of star form ation. The SF rates, averaged over the age of the burst, exceed 100 M /y.Typicaltotalgasm asses involved in the bursts are around  $10^{10}$  M and the m ass of stars form ed so far is between 10 and 40 percent of this m ass.

#### 7.1. High optical depths

Our models generally require a large molecular cloud optical depth at 1 m, typically  $_{1 m}$  ' 50, but values as 180 are necessary for IRAS 01364-1042.0 ne high as m ight ask whether or not such high values are reasonable. Remembering that the extinction within our molecular clouds has a foreground screen geom etry, an optical depth of 50 corresponds to an extinction of 54 m ag. A ssum ing the Galactic interstellar extinction curve (W hittet, 1992) this implies a visual extinction  $A_v$  ' 130 m ag. A corresponding total neutral ISM column density can be derived from the empirical relation of Bohlin et al. (1978) for sightlines to reddened stars in the Galaxy. Again assuming the Galactic extinction curve we nd N<sub>H</sub> = 1:86  $10^{21}$  A<sub>V</sub> =  $10^{23}$  atom s cm  $^2$  where N<sub>H</sub> = N (HI+ 2H<sub>2</sub>) is the 2:5 total neutral ISM column density in atom ic and molecular gas. Several studies have measured the molecular gas column densities towards the centres of lum inous and ultralum inous infrared sources using interferom etric CO data (e.g. Downes & Solomon, 1998; Scoville et al., 1989; Sanders et al., 1988a). Peak column densities of  $N_{H_2}$  10<sup>23</sup> cm<sup>2</sup> are commonly found. The column density of the atom ic gas has also been measured for those sources that show HI absorption (e.g., M undell, Ferruit &

Pedlar, 2001; Beswick et al., 2003; Clemens & Alexander, 2003) and for an assum ed spin tem perature of 100 K, peak column densities of N  $_{\rm H\,I}$  '  $10^{22}$   $10^{23}$  cm  $^2$  are found. The column density of gas in plied by our extinction measurements are therefore quite consistent with measured values for sim ilar, extrem e objects. In addition to these measurements of the gaseous ISM, which indirectly constrain the extinction, there have recently been direct measurements which make use of mid-infrared spectral features. Haas et al. (2001) nd an extinction of  $A_v$ 110 m ag for App 220 by comparing the 7:7 m PAH feature with the 850 m continuum ux and Soifer et al. (2002) nd values of  $A_v = 80$  150 m ag using spectroscopy of the 9:7 m absorption line. Values of 1 m = 50 are therefore quite reasonable and values 3 tim es higher should not be excluded.

#### 7.2. Notes on Individual Sources

NGC 34 (MRK 0938): The presence of two nuclei separated by approximately 1.2 arcsec in the mid-infrared (M iles et al., 1996) and optical tidal tails indicate this galaxy is undergoing a merger (e.g. M ulchaey, W ilson & T svetanov 1996). The nature of the activity has been controversial, som e authors (e.g. V eron {C etty & V eron 1991) claiming a Seyfert 2 nucleus, while others suggest a com – posite spectrum. M ulchaey, W ilson & T svetanov's (1996) emission { line images show the galaxy to be a weak emitter of [0 III] 5007 when compared with Seyfert galaxies in their sample. In addition they argue its strong H emission, distributed over the entire galaxy, as indicative of a starburst.

A twith no AGN component is marginally consistent with the radio data. On the other hand, a large (' 40 percent) AGN contribution to the 8 1000 m lum inosity is obtained by assuming  $_{MC} = 181$ . In this case the AGN is quite dust enshrouded and the spectrum falls o rapidly in the NIR. It is interesting to note that, in both cases, the average SFR during the burst is of the order of 80 90 M /y.

CGCG 436-30: This galaxy is almost certainly interacting and is detected in HI in both emission and absorption; the deduced atom ic gas mass is greater than  $3.4 \quad 10^9 \text{ M}$  and must be concentrated near the core in order to explain the absorption feature (M irabel & Sanders 1988).

There is evidence of a compact radio core that may be di cult to explain as an ensemble of young supernovae associated with the starburst; the major contribution to the FIR and radio emission originates on larger spatial scales (Lonsdale, Smith, & Lonsdale, 1993; Smith, Lonsdale, & Lonsdale 1998).

The monotonically rising NIR uxes require a small AGN contribution but all measured uxes longward of 12 m can be tted with a pure starburst.

Our best t SEDs, with or without the AGN component, indicate a gas consumption time (scale of about 15

M y and a starburst age of 20 M y. The totalm ass involved in the burst is '  $5.5 \ 10^9$  M and the residual gas m ass '  $1.5 \ 10^9$  M . The average SFR ' 200 M /y.

An upper limit to the mass of the galaxy ' 1:9  $10^{11}$  M is provided by the t of the NIR uxes in the modelwithout the AGN component.

IR A S 0136-1042: The relatively low ux at 25 m requires a large value of  $_{MC}$  (181 in Fig.2). As for CGCG 436-30, the NIR could require a small (4 percent) AGN contribution, but the overall t is also compatible with that of a pure starburst.

An upper limit to the mass of the galaxy ' 1:4  $10^{11}$  M is provided by the t of the NIR uxes in the modelwithout the AGN component.

IR A S 0857+ 3915: Consists of two nuclei separated by 5 arcsec. It is the north-west component which dom inates in both the infrared and radio (Sanders et al., 1988b; Condon et al., 1991). Surace & Sanders (2000) found evidence for stars no older than 100 M y and despite the warm IRAS colours Veilleux, Sanders & K im (1999) found no clear evidence for the presence of an AGN from N IR spectroscopy.

We fail to obtain a t to the radio{100 m and 12-60 m data simultaneously with a starburst model abone. A sexpected from the J, H and K uxes a signi cant AGN component is required. R adio data them selves are well tted by a starburst model, if one assumes  $_{ff}$  '0.7 at 1.4 G H z (ie. signi cant free-free absorption). The AGN com ponent is large and  $L_{8\ 1000\ m}^{AGN}$  / $L_{8\ 1000\ m}^{Tot}$  ( $L_{AGN}=L_{Tot}$ ) ranges from 37 to 47 percent, in the case of a small or a large  $_{\rm M\,C}$  , respectively.

The total mass involved in the burst ' 5  $10^9 \rm M$  and the residual gas mass ' 3:3  $10^9 \rm M$ . The average star form ation rate ' 200M /y and the recent star form ation history is essentially xed by the shape of the SED from the radio to 100 m.

IRAS 0857+3915 is the only source common to both our study and the more extended sam ple of ULIRGs analysed by Farrah et al. (2003). Our estimate of the AGN contribution to the total FIR lum inosity (Table 6), is in very good agreem ent with their quoted value (' 34%), despite their analysis being based on entirely di erent models (which make no use of the radio measurements). U sing radio data we are able to provide a more accurate quanti cation of the starburst param eters. Our derived age is 8 M yr versus Farrah et al.'s upper lim it of 57 M yr and our average SFR is 228 M /yr against their quoted value of 173 M /yr. (Distance e ects and IMF e ects alm ost cancelout since our lum inosity is 17% higher and our IMF lim its im ply a 16% lower total mass). As anticipated, the 23 GHz observation allows the determ ination of signi cant free-free absorption at 1:4 G H z, an important source of scatter around the FIR /R adio correlation, not included in the analysis of Farrah et al. (2003).

NGC 7469: This source is thought to have a Sy 12 nucleus and a circum nuclear starburst. U sing high resolution m id-infrared observations, Soifer et al. (2003) argued that the central source is an AGN rather than a nuclear

starburst because of its very high 12 m surface brightness. M iles, H ouck & H ayward (1994) and N ikolic et al. (2003) both found that PAH features in the m id-infrared spectrum, thought to trace star formation, are found in the ring of em ission surrounding the nucleus but not in the nucleus itself. If the hard ionizing photons from the AGN destroy PAH m olecules this supports the picture of a central AGN surrounded by a starburst ring.

Our best t model has  $L_{AGN} = L_{Tot}$  0.17. At midinfrared wavelengths we predict the AGN and starburst contributions to both be signi cant. This is the only source in our sample for which spatially resolved mid-infrared data are available, and in this case our model prediction is consistent with these data. A larger contribution from the AGN is inconsistent with the mid-infrared observations mentioned above, which show that signi cant ux comes from both the starburst ring and the AGN. A larger AGN fraction is also not consistent with the simultaneous t of the FIR and radio data.

IC 5298:Our best tm odel has  $L_{AGN} = L_{Tot} = 0.36$ , a very high optical depth for the m olecular clouds,  $M_{C} =$ 181 and an average SFR of 71 M /y.

W u et al. (1998a,b) found that IC 5298 has properties that are interm ediate between H II regions and liners; it was classified as a Seyfert 2 by Veilleux et al. (1995) although the [O I] lines are rather weak. Poggianti & W u (2000) classify this galaxy as e(a) type, namely with H in emission with moderate equivalent with ('52A) and H in absorption ('4A). They derived a SFR of about 92 M /y from the FIR emission.

M olecular gas observations indicate a gas mass of 9:4  $10^9$  M while H I observations suggest an atom ic gas mass of 5:5  $10^9$  M (M irabel & Sanders 1988).

Our best tm odels indicate a total gasm ass of about 5.6  $10^9$  M, of which half is assumed to in the form of m olecular clouds. About 63 percent of the gas has been converted into stars by the present epoch.

A t to the SED of IC 5298 is also possible without the inclusion of the AGN component by assuming a small optical depth for the molecular clouds,  $_{MC} = 15$ . This is achieved by decreasing the dust to gas ratio to 1/300. In this case the best t to the FIR and radio data require that about 25 percent of the mass of the galaxy is form ed during a short intense burst; this galaxy is actually a post{ starburst galaxy.

UGC 12812 (MRK 0331): Observational data show evidence of both starburst (e.g. Lancon, Rocca-Volmerange & Thuan, 1996; Veilleux et al, 1995; Roche et al, 1991) and AGN (Lonsdale, Smith & Lonsdale, 1993) activity.

The 23 GHz observation indicates a relatively low thermal contribution, hence a relatively old starburst, the model also requires a mild AGN contribution to tIRAS data. A younger model, not requiring the AGN contribution, is marginally compatible with the 23 GHz observation.

Our ts indicate a fair upper lim it to the contribution of the AGN of about 23 percent of the total 8 1000 m lum inosity. The average SFR is between 72 and 84 M /y, for the case with and without an AGN respectively.

#### 8.Conclusions

We have performed new high frequency VLA radio measurements (23 GHz) of 7 compact ULIRGs chosen from Condon et al.'s (1991) sample.We have combined the new observational data with existing data at other radio frequencies (1.4 GHz, 5.4 GHz, 8.4 GHz); in the millimetre; from SCUBA 850 m; infrared IRAS 100, 60 25, 12 m bands and in the NIR with J, H and K band observations from 2MASS.

We t the global SEDs by means of a combination of new AGN and starburst models.We nd:

- 1. The high frequency radio data have proven essential for the determ ination of the relative contribution of the star-burst and the AGN. Although AGN can be detected in several ways (such as via their hard Xray em ission, near-infrared colours or optical line em ission), quantifying the energy contribution of the AGN to the bolom etric lum inosity of the source requires an evaluation of the starburst power. On one hand, the new radio observations at 23 G H z allow a clean de nition (una ected by free-free absorption) of the shape of radio em ission over a wide range of frequencies. On the other, the ux at 23 GHz is mostly contributed (> 50)percent) by free-free em ission from ionized H II regions and is therefore directly related to ongoing star formation. The ux at lower frequencies is instead sensitive to the supernova rate and thus carries inform ation about the previous history of the starburst.
- 2. We have found that radio data, together with the 100 m ux de ne almost unequivocally the recent star form ation history of the burst. This con m s the suggestion by B ressan, Silva & G ranato 2002, that com bining F IR and R adio data provides a ne resolution age determ ination, for these obscured sources.

3. W hile the starburst contribution is generally well constrained by the SED longward of 60 m, the SED below 60 m is sensitive to the contribution from the hot dust of the AGN. Thus, the excess em ission above the starburst contribution at 12, 25 and 60 m may be used to quantify the contribution from the AGN.A degree of uncertainty remains regarding the strength of the AGN. Low optical depth in molecular clouds favours warm em ission from the starburst, thus a sm aller contibution from AGN is required to t the mid-infrared data. However, as the emission from the starburst gets warm er, its contribution at 100 m decreases and to t this data point a larger SFR is required; eventually becoming incompatible with the radio data. Thus, while still a ected by uncertainties, the method we propose proves to be useful in providing an estimate of the relative contribution of AGN and starburst.

- 4. The e ect of the AGN is also visible from the totalJ, H and K uxes but its quanti cation is in possible from these NIR colours alone because of the strong dependence of the AGN em ission on the model parameters at these wavelengths.
- 5. It is possible to t the SEDs of most of the sources in our sample with no contribution from an AGN. However, better ts, especially for the near infrared colours, are obtained when the bolom etric lum inosity has a small AGN contribution. We note that Farrah et al. (2003), who tted the SEDs of ULIRGs with tem plate spectra, nd that in general the starburst contributions dom inante.
- 6. To t the m id-infrared data a very high optical depth at 1 m icron is generally required. In the m ost extrem e case, IRA S01364-1042, the SED cannot be t unless 1 m 180. A lthough we cannot do an object by object com parison, values as high as at least 50 are consistent w ith gas colum n densities m easured in the centre of ULIRGs. The fact that extinction m easurem ents at shorter wavelengths give m uch low er values probably indicates that such observations penetrate only a surface layer of the ISM and do not probe the whole sight-line tow ands the central energy source.
