# DETECTION OF TWO-ARMED SPIRAL SHOCKS ON THE ACCRETION DISK OF THE ECLIPSING FAST NOVA V1494 AQUILAE

### ABSTRACT

We have modeled the unusual orbital light curve of V1494 Aquilae (N ova Aquilae 1999 N o 2) and found that such an unusual orbital light curve can be reproduced when there exist two-arm ed, spiral shocks on the accretion disk. V1494 Aql is a fast classical nova and found to be an eclipsing system with the orbital period of 0.1346138 days in the late phase of the nova outburst. Its orbital light curve shows a small bump at orbital phase 0.2, a small dip at 0.3, som etim es a small bump at 0.4, and a large bump at 0.6 0:7 outside eclipse. Such a double- or triple-wave pattern outside eclipse has never been observed even though overall patterns look like som e supersoft X-ray sources or eclipsing polars. We have calculated orbital light curves including the irradiation e ects of the accretion disk and the com panion by the hot white dwarf. These unusual patterns can be reproduced when we assume twoarm ed spiral shocks on the accretion disk. Especially, triple-wave patterns are naturally obtained. This result strongly suggests the existence of two-arm ed spiral shocks on the accretion disk in the late phase of the nova outburst.

## 1. introduction

Angularm om entum transport plays an essential role in accretion disks of cataclysm ic variables. Two mechanisms have been proposed so far: one is the turbulent viscosity as adopted in the standard accretion disk model of Shakura & Sunyaev (1973) and the other is the direct dissipation by tidal spiral shocks on the accretion disk as rst dem onstrated by Sawada, Matsuda, & Hachisu (1986). The turbulent viscosity is a local physical process while the tidal spiral shocks have a global structure on the accretion disk. Therefore, we have a chance to observe a global spiral shock structure when they play an essential role in the angular m om entum transport of the accretion disk. Such an observational evidence rst came from the Doppler maps of the dwarf nova IP Peg outburst (e.g., Steeghs, Harlaftis, & Home 1997). We have long believed that tidal spiral structures can be detected even in orbital light curves of cataclysm ic variables if the spiral patterns are prominent. At last we nd such an evidence of spiral patterns on the accretion disk from the orbital light curves of V1494 Aquilae.

V 1494 A quilae (N ova A quilae 1999 N o 2) was discovered by A. Pereira on 1999 D ecember 1.785 UT at  $m_V$  6.0 (Pereira et al. 1999). It reached the visual maximum brightness of  $m_V$  4.0 on Dec 3.4 UT ( $t_0$  = JD 2,451,515.9 0:1) and decayed at the rate of  $t_2$  = 6.6 0:5 days and  $t_3$  = 16 0:5 days (K iss & Thom son 2000). Early phase spectra were taken by Fujii (1999) and Ayani (1999), which show P-C yg pro les of hydrogen Balmer lines with a blueshifted component of 1020 km s<sup>1</sup> and 1200 km s<sup>1</sup>, respectively. Thus, V1494 Aql has been classi ed as a fast nova. K ato et al. (2004) have sum - m arized overall developm ent of the V1494 Aql light curve untilautum n of 2003 (for about 3 years). D etailed spectral features have been reported by Lijm a & Esenoglu (2003).

A short-term periodic modulation was rst reported by Novak et al. (2000), who found 0.03 m ag variations with a period of 0.0627 days from their 2000 June observation. Retter et al. (2000) analyzed 31 nights of CCD photom etry during 2000 June-August and suggested a periodicity of 0.13467 (2) days. The full am plitude of the variation in the R-band increased from 0.03 m ag in June to 0.07 m ag in August. Their folded light curve shows a double-wave structure with a shallow erdip at phase 0.5, with about half the amplitude of the main periodicity. Bos et al. (2001) reported, based on un Itered and R-band CCD photom etry obtained on 12 nights during 2001 June-July, a robust change in the shape and amplitude of the 0.13467 days period. It had an eclipse shape with depth about 0.5 m aq. A second shallow eclipse (about 0.1 m ag deep) at phase 0.5 can be seen. Barsukova & Goranskii (2003) re ned, based on V-band photom etry during June and Septem ber of 2002, the orbital period of 0.1346141(5) days. They pointed out that the orbital light curve is quite unusual in the sense that it is not sim ilar to ordinary cataclysm ic variables with a hot spot on the accretion disk. Pavlenko, Dudka, & Baklanov (1999) made a multicolor photom etry and concluded that the eclipse depth is deeper in longer wave lengths (deeper in I-band than in V-band). Pavlenko et al. (1999) further discussed that such an eclipsing characteristic (deeper in longer wave lengths) cannot be explained by the accretion disk or the irradiation e ect of the com panion because these two light sources have the opposite nature (deeper in short wave lengths). Thus, they suggested, as a model of V1494 A qlorbital light curve, a self eclipsing accretion column in a magnetic polar.

Kato et al. (2004) provided a tim e-developm ent of the orbitallight curves am ong 2001 N ovem ber-D ecem ber, 2002 A ugust, and 2003 June. It som et in es shows a triple-wave structure as well as a double-wave structure. K ato et al. suggested that som e structures (probably on the accretion disk) xed in the binary rotational fram e are responsible for the orbital light curve because of the stability of out-of-eclipse light curve patterns. Very recently, K iss, C sak, & D erekas (2004) pointed out that a close com panion to V 1494 A ql (located  $1^{\circ}_{\cdot}4$  southwest) is brighter than V1494 Aql itself in the very late phase of the outburst. They corrected the brightness of the orbital light curve and found that the depth of the eclipse is about twice deeper in m agnitudes than before correction.

The depth of the prim ary eclipse of V1494 Aqlhas becom e deeper as the nova decayed. Such a feature was also observed in the recurrent nova CIAq12000 outburst (e.g., M atsum oto et al. 2001), in which the irradiation of the accretion disk plays an essential role (Hachisu & Kato 2003a). Therefore, we expect the accretion disk in V 1494 Aql is also responsible for the unusual wavy structure of the orbital light curve. In this Letter, we model the orbital light curve. A lm ost the same orbital light curve model as in the supersoft X-ray sources is adopted (e.g., Schandl, M eyer-H ofm eister, & M eyer 1997; H achisu & Kato 2003b,c), which includes the irradiation e ects of the accretion disk and of the companion. In addition, we assume two-armed spiral structures on the accretion disk to reproduce a triple-wave structure outside eclipse. In x2, our num erical m odel for V 1494 A ql is brie y introduced and sum marized. The num erical results are given in x3. D iscussion follows in x4.

### 2. the light curve model

Our binary model is illustrated in Figure 1, which consists of a 0:3 M main-sequence star (MS) lling its Roche lobe, a 1:0 M  $\,$  white dwarf (W D ), and a disk around the W D. The mass of the W D is roughly estimated from the decline rate of the decay phase (e.g., Hachisu et al. 2000; Hachisu & Kato 2001a,b), details of which will be published elsewhere. The mass of the companion is estimated from the mass-period relation for cataclysmic variables (e.g., Patterson 1984; Warner 1995). A circular orbit is assumed. Its ephemeris has recently been rened by Kato et al. (2004). We use this ephemeris, i.e.,

t(BJD) = 2;452;458:3230 + 0:1346138 E; (1) at eclipse m in im a.

W e also assume that the surfaces of the W D, the M S com panion, and the accretion disk em it photons as a blackbody at a local temperature which varies with position. For the basic structure of the accretion disk, we assume an axi-symmetric structure with the size and thickness of

where  $R_{disk}$  is the outer edge of the accretion disk,  $R_1$ is the elective radius of the inner critical Roche lobe for the W D component, h is the height of the surface from the equatorial plane, and \$ is the distance on the equatorial plane from the center of the W D. Here, we adopt

= 2. We obtain our modeled two-arm ed spiral structures by multiplying h with z<sub>height</sub>, as de ned below:

W e further have a slope at the disk edge de ned by z 10(z 0:25)( $\$ = R_{disk}$  0:9) for 0:9 <  $\$ = R_{disk} < 1:0$ . The above various disk param eters are assumed to be =  $0:1_{1} = 2 = 0:40_{1} = 0:41_{1} = 65_{1} = 0:8_{1} = 0:095_{1}$ for the disk shape of Figure 1. Here,  $_1$  and  $_2$  specify the amplitudes of two spirals so that  $_1 = _2$  (= 0:40) m eans just an anti-symmetric structure of spirals with the same height, determ ines the inverse of the pitch angle of logarithm ic spirals, is the position angle of the spirals against the binary components, denotes the width of the spiral pattern and represents the height of the spiral against the thickness of the disk together with  $_1$  and  $_2$ , 4 at the edge of the disk for i.e.,  $z_{\text{height}} = \max(1; 2) =$ the disk shape of Figure 1. In our light curve model, we m ainly change four parameters, i.e., the disk thickness ( ), the inverse of the pitch angle of spirals (), the position angle (), and the heights of two spirals (1 = 2). The other param eters that specify the disk shape are all xed to be the above values. These parameters are roughly determ ined to m im ic the results of 3D simulation m odel of accretion disks (e.g. Makita, Miyawaki, & Matsuda 2000).

The lum inosity of the WD is assumed to be 750 3;000 L because we do not know the exact W D lum inosity at the time of observation. The disk and the com panion star are strongly irradiated by the hot W D. The surfaces of the W D, the disk, and the com panion star are divided into many patches as shown in Figure 1. Here we assume that each patch em its photons as a blackbody (with a single tem perature). Each patch of the disk or of the companion is irradiated by visible (front side) patches of the hot W D. The total lum inosity of the irradiated disk and companion is calculated by summing up the contributions from all patches. The irradiation e ciency is the sam easthat of Schandlet al. (1997), i.e., 50% of the irradiated energy is em itted by photon but the residual 50% is converted into them alenergy of gas. The accretion lum inosity of the disk is also num erically included, although its contribution to the optical light is much sm aller than that

of the irradiation e ect (see discussion of Hachisu & K ato 2001a,b; Hachisu, K ato, & Schaefer 2003). The num erical method adopted here was fully described in Hachisu & K ato (2001b, 2003a,b,c). The inclination angle (i) of the binary is a free parameter that is determined from our light curve tting. The original temperature of the com – panion star is assumed to be 3,000 K, but the shape of the orbital light curve is hardly changed even if we take 2,000 K or 4,000 K for the original temperature of the M S com – panion. The adopted system parameters are sum marized in Table 1.

### 3. numerical results

The best tm odel is plotted in F igure 2 by a thick solid line. The orbital m odulations of V1494 A ql have been reported by several groups. Here, we adopt data of two groups (K ato et al. 2004; K iss et al. 2004) to twith ourm odeled light curves. K ato et al.'s (square) data have been corrected by using K iss et al.'s (circle) data, because K ato et al.'s original data include the light from the close com panion.

We have changed ve parameters (,, , 1 = 2, 1independently and calculated the total of 1300 orbital light curves. It takes about 6 hours to calculate one orbital light curve on a 2:4 G H z Pentium 4 processor, because the surface patch elements are 64 128 ( ) for the com panion surface, 64 128 2 (\$ (up and down sides)) for the disk, and 16 32 ( ) for the W D, and the total of 129 steps for one orbital period. We have used 5 CPUs, so that it took the total com putation time of about 1600 hours, i.e., (6 1300)=5 CPUs. We have found, by the least square method, the best t model for out-ofeclipse (orbital phase 0:1 0:9), i.e., = 0:095, = 0:41, = 65,  $_1 = _2 = 0.40$ , i = 78.5. For the best t model, we increase the number of patches for the disk up to 128 256 2 (\$ (up and down sides)) in order to calculate a rather sm ooth light curve. Such a high quality light curve is shown in Figure 2.

The triple-wave structure of out-of-eclipse orbital light curve is reasonably and naturally reproduced with our spiral shock pattern model. Both the thickness of the accretion disk and the pitch angle of spirals adopted here are roughly consistent with the 3D simulations (e.g., Makita et al. 2000). The present results strongly support the two-arm ed spiral pattern on the accretion disk. We hope a spectroscopic con mation of this spiral pattern by D oppler maps for V 1494 A ql.

#### 4. discussion

The orbital light curve varies from night to night as shown in Figure 3 of K ato et al. (2004). Such a scatter is also clearly shown in the present Figures 2 and 3 for K iss et al.'s (2004) data. To reproduce this variation, we have changed parameter  $_1$  and  $_2$  independently (see Fig. 3). The variation appears in orbital phase of 0:1 0:3 and the upper and lower bounds for these variations can be well reproduced by the models of  $_1 = 0.26$ ,  $_2 = 0.44$  for the upper bound, and  $_1 = 0.44$ ,  $_2 = 0.24$  for the lower bound. Here,  $_1$  and  $_2$  represent the height of the spiral

arm in the rear and front side on the disk of F igure 1, respectively. The other parameters are the same as those in F igures 1 and 2.

It is rem arkable that the peak at orbital phase 0:65 is rather stable and never disappears. This is consistent with the robustness of the period for the out-of-eclipse shape as em phasized by K ato et al. (2004).

Pavlenko et al. (1999) discussed the main light source for the wavy structures of the out-of-eclipse orbital light curve. They argued, as a light source, (1) accretion disk, (2) ellipsoidal shape of the companion, (3) re ection (irradiation) e ect of the companion by the hot white dwarf, (4) interm ediate polar activity, and (5) polar activity selfeclipsed by the accretion colum n. They rejected possibilities (1)-(4) and suggested a viable m odel of polar activity. Their reasons rejecting possibilities (2) and (4) are reasonable but not for possibilities (1) and (3) as discussed below.

Pavlenko et al. (1999) rejected the possibility of accretion disk by pointing out two reasons: (i) the maximum duration of the eclipse of the disk lim ited by the Roche lobe size and it cannot exceed a quarter of the orbital phase while the overall duration of the eclipse is as large as 0.45 of the orbital period. (ii) The peak of light em ission of the accretion disk lies in the blue region of the spectrum, so that the amplitude of the eclipse should increase as the wavelength becom es shorter (\as the wave length is increased" in their text is mistaken). However, they observed the opposite trend: the am plitude in the red region is much more deeper than in the visual region. As for the rst conjecture (i), based on the accretion disk model together with the irradiation e ects of the disk and the com panion, we have already constructed the orbital light curves that m atch well the observational data. Second, we should be careful with the above statement (ii) because the depth of the prim ary eclipse varies from night to night as seen in Figure 3 of K ato et al. (2004) and its depth changes as large as R c 0:4 between di erent periods of the observations as shown in Figures 2 and 3. Pavlenko et al's (2003) R and I light curves are not simultaneous ones but taken in dierent periods (R is earlier than I). The V light curve is reconstructed from Barsukova & Goranskii's (2003) data.

They also rejected possibility (3) based on the same statement as (ii) discussed above. However, their multicolor results m ay simply suggest the fact that the eclipse depth varies from period (night) to period (night). Therefore, we cannot conclude statement (ii) only from the different depths at the di erent periods.

For the assumed W D lum inosity of  $L_{W\,D}$  = 3;000 L , the distance modulus is obtained to be (m M)\_R = 12:05 and the corresponding distance is estimated to be d 1:4 kpc (see Table 1). However, this does not mean the real distance to V1494 A qlbecause we do not know the reallum inosity of  $L_{W\,D}$  at the time of the two observations. For instance, if we adopt  $L_{W\,D}$  = 750 L , the shape of the orbital light curve hardly changes but the distance modulus becomes (m M)\_R = 11:45 and d 1 kpc.
