Weak lensing evidence for a lament between A 222/A 223

Abstract

We present a weak lensing analysis and comparison to optical and Xray m aps of the close pair of m assive clusters A 222/223. Indications for a lam entary connection between the clusters are found and discussed.

1 Introduction

N -body simulations of cosm ic structure form ation predicts that m atter in the universe should be concentrated along sheets and laments and that clusters of galaxies form where these intersect (K au m ann et al. 1999; B ond et al. 1996). This lamentary structure, often also dubbed \cosm ic web", has been seen in galaxy redshift surveys (Vogeley et al. 1994) and X -rays (Zappacosta et al. 2002; T ittley & Henriksen 2001).

Because of the greatly varying m ass{to{light M = L} ratios between rich clusters and groups of galaxies (Tully & Shaya 1998) it is problem atic to convert the m easured galaxy densities to m ass densities w ithout further assumptions. W eak gravitational lensing, which is based on the m easurem ent of shape and orientation parameters of faint background galaxies (FBG), is a model{independent m ethod to determ ine the surface m ass density of clusters and lam ents. Due to the nite ellipticities of the unlensed FBG, every weak lensing m ass reconstruction is unfortunately an inherently noisy process, and the expected surface m ass density of a single lam ent is too low to be detected with current telescopes (Jain et al. 2000).

Cosm ic web theory also predicts that the surface mass density of a lament increases towards clusters (B ond et al. 1996). Filam ents connecting neighboring clusters should have surface mass densities high enough to be detectable with weak lensing (Pogosyan et al. 1998). Such laments may have been detected in several recent weak lensing studies.

K aiser et al. (1998) found a possible lam ent between two of the three clusters in the z = 0.42 super-cluster M S0302+17, but the detection remains som ew hat uncertain because of a possible foreground structure overlapping the lam ent and possible edge e ects due to the gap between two of the cam era chips lying along the lam ent. A lso, G avazzi et al. (2004) could not con rm the detection of a lam ent in this system. G ray et al. (2002) claim to have found a lam ent extending between two of the three clusters of the A bell 901/902 super-cluster, but the signi cance of this detection is low and subject to possible edge e ects, as again the lam ent is close the intersection of four chips of the cam era.

2 Data of the A bell 222/223 system

A 222/223 are two A bell clusters at z 0.21 separated by 14^0 on the sky, or $2600h_{70}^{-1}$ kpc, belonging to the Butcher et al. (1983) photom etric sam ple. Both clusters are rich, having A bell richness class 3 (A bell1958). W hile these are optically selected clusters, they have been observed by RO SAT (W ang & U lm er 1997; D avid et al. 1999) and are con m ed to be massive clusters. P roust et al. (2000, P 00) published a list of 53 spectra in the eld of A 222/223, 4 of them in region between the clusters (hereafter \intercluster region") and at the redshift of the clusters. Later, D ietrich et al. (2002, D 02) reported on spectroscopy of 183 objects in the cluster eld, 153 being m embers of the clusters or at the cluster redshift in the intercluster region. Taking the data of P 00 and D 02 together, 6 galaxies at the cluster redshift are known in the intercluster region, establishing this cluster system as a good candidate for a lam entary connection.

In aging was performed with the W ide Field Im ager (W F I) at the ESO /M PG 2.2 m telescope. In total, twenty 600 s exposures were obtained in R-band in O ctober 2001 centered on A 223, eleven 900 s R-band exposures were taken in D ecember 1999 centered on A 222. The images were taken with a dithering pattern lling the gaps between the chips in the co-added images of each eld.

The R-band data used for the weak lensing analysis is supplemented with three 900 s in the B and V-band centered on each cluster taken from N ovember 1999 to D ecember 2000. The nalB - and V-band images have some remaining gaps and regions that are covered by only one exposure and { due to the dithering pattern { do not cover exactly the same region as the R-band images.

2.1 Catalog creation

Lensing catalogs were created from the R-band in ages using the KSB algorithm (K aiser et al. 1995). Stellar re ection rings and di raction spikes were m asked

and the masked regions excluded from the catalogs. The catalogs from both pointings were merged and the ellipticities of objects contained in both catalogs were averaged.

From this merged catalog all objects with R < 22 m ag, signal-to-noise < 7, G aussian radius $0.4 < r_g < 1.2$, and ellipticity e > 0.8 were deleted. All surviving objects fainter than R > 23.5 m ag were kept as likely background galaxies, while objects brighter than this { for which colors were available { were selected according to the following criteria: Objects detected in B, V, and R m atching colors of galaxies at z < 0.5, 0.23 < (V R) 0.56 (B V) < 0.67, 0.5 < B V < 1.6, were deleted from the sample. Galaxies detected only in the V and R band were kept if (V R) > 1.0. The nal catalog contains 25583 objects, corresponding to a galaxy num berdensity of 15.5 arcm in ² if the m asked regions are not taken into account for the computation of the total area.

3 Mass and light maps

Fig. 1 shows a reconstruction obtained from the catalog described in the previous section. The reconstruction was performed on a 214 200 points grid using the algorithm of Seitz & Schneider (2001) adapted to the eld geometry. The smoothing scale of the shear data was set to 2^{0} . Galaxies in the catalog were weighted by the error estimate of their initial ellipticity measurement.

Both clusters are well detected in the reconstruction. The two components of A 223 are clearly visible. The strong mass peak W est of A 223 is most likely associated with the rejection ring around the bright V = 7.98 mag star at that position. Although the rejection ring and a large area around it were masked, di use stray light is visible extending beyond the masked region, well into A 223, probably being the cause of the observed mass peak.

A loo visible is a bridge in the surface m ass density extending between A 222 and A 223. A lthough the signal of this possible lam entary connection between the clusters is very low, the feature is quite robust when the selection criteria of the catalog are varied and it never disappears.

The noise level in the reconstruction can be estimated by random ly rotating the galaxies while keeping their positions and ellipticity moduli xed. Performing a reconstruction on this random ized catalog gives ² ' 0.015, suggesting that the intercluster connection is present at the 2 level.

The galaxy density distribution and the X -ray contours in Fig. 1 both show a clear connection between the clusters. W hile the X -ray and galaxy density contours are aligned in the intercluster region, the surface m ass density contours connect the clusters E astwards of them.

4 D iscussion

W e presented weak lensing, optical galaxy density, and X-ray m aps of the m assive, close pair of galaxy clusters A 222/223. A llm aps show a connection between the clusters in the intercluster region. The density distribution of color-selected objects, supplemented by the spectroscopic con m ation of galaxies at the cluster redshift in the intercluster region by P 00 and D 02, and the signi cant connection between both clusters in the 0.5 2.4 keV band of RO SAT's PSPC establish a secure lamentary connection between the clusters. The weak lensing indications for a dark m atter bridge are much less secure. The signal-to-noise of the structure extending between the clusters is low but the structure itself is very robust and never disappears when the selection criteria for the lensing catalog are varied.

We note that the lum inosity density of color-selected galaxies in the intercluster region is only by a factor of 2 lower than in the peaks of the galaxy clusters. If the early type galaxies trace the mass well and a constant M = L ratio is assumed, we would expect a clearly detectable lensing signal along the galaxy density contours. This is obviously not the case. A more detailled comparison of the observed and expected surface mass density, also addressing the apparent m isalignment of mass and light in A 223, will be done elsewhere (D istrich et al. 2004, in preparation). We also note that a m isalignment of mass and light is present in the lament candidate of G ray et al. (2002).
