A Composite Extrem e Ultraviolet QSO Spectrum from FUSE

Abstract.

The Far U traviolet Spectroscopic Explorer (FUSE) has surveyed a large sample (> 100) of active galactic nuclei in the low redshift universe (z < 1). Its response at short wavelengths makes it possible to measure directly the EUV spectral shape of QSOs and Seyfert 1 galaxies at z < 0.3. Using archival FUSE spectra, we form a composite extrem e ultraviolet (EUV) spectrum of QSOs at z < 1 and compare it to UV/optical composite spectra of QSOs at higher redshift, particularly the composite spectrum from archival Hubble Space Telescope spectra.

1. Introduction

The ubiquity with which QSOs display spectral properties such as power-law continua and broad emission lines over wide ranges in lum inosity and redshift has led to the use of composite spectra to study their global properties. Inform ation about the continuum in the rest-fram eultraviolet is particularly critical for understanding the form ation of the em ission lines, for characterizing the B ig B lue B um p, and for determ ining the ionization state of the intergalactic m edium (IG M). C om posite Q SO spectra covering the rest-fram eultraviolet have been constructed for objects with 0.33 < z < 3.6 from HST (Zheng et al. 1997, Telfer et al. 2002, T 02 hereafter), and at z > 2 from ground-based sam ples like the SD SS (Vanden Berk et al. 2001), the First Bright Q uasar Survey (B rotherton et al. 2001) and the Large Bright Q uasar Survey (Francis et al. 1991).

The FUSE bandpass, 905–1187 A, allow sus to exam ine the EUV properties of local AGN.We can therefore study the same rest-frame wavelength region covered by the HST composite spectra, at redshifts less than 0.33. The low redshifts of these AGN ensure that, although the FUSE aperture limits it to observing relatively bright AGN, our sample contains a large fraction of intrinsically low-lum inosity objects. An added advantage to working with low redshift spectra is that the determ ination of the mean EUV spectral index requires a less signi cant correction for IGM absorption than was required for the HST sample.

2. FUSE Spectra and C om posite C on struction

Similarly to T 02, we excluded spectra of broad absorption line quasars and spectra with S=N < 1 over large portions from our FUSE sample. We also exclude spectra of objects that show strong narrow emission lines, strong stellar features, or strong interstellar molecular hydrogen absorption. A total of 128 spectra of 90 AGN meet the criteria for inclusion in the sample. We follow the same procedure as T 02 for the reduction of the sample spectra. To summarize: we correct for G alactic extinction using a standard extinction curve, individual E (B V) values for each AGN sightline, and $R_V = 3:1$; we ignore wavelength regions a ected by ISM absorption lines; we correct for Lym an limit absorption if the S/N below the Lym an break is greater than one; we apply a statistical correction for the line of sight absorption due to the Ly forest; we shift the AGN spectrum to the rest fram e and resam ple to common 1 A bins.

The lower redshifts of the FUSE AGN compared with the HST sample of T 02 compels us to use di erent parameters to perform the correction for Ly forest absorption mentioned above. Like T 02, we describe the distribution of absorbers by $0^2n=0.20$ / (1 + z) N . For the column density distribution parameter, we use the result found by D ave & Tripp (2001) from echelle spectra of two Q SOs at z 0.3, = 2.0 for 12.2 < log N < 14.4. For 14.4 < log N < 16.7, we use = 1.35 from the study by Penton et al. (2000). For the redshift distribution parameter, we use = 0.15 (W eym ann et al. 1998). We norm alize the distribution of absorbers by 1.34 10^{-11} cm² at log N = 13 and z = 0.17 and assum e a D oppler parameter of 21 km s⁻¹ (D ave & Tripp 2001).

W e com bine the sam ple spectra using the bootstrap technique described by T 02. W e begin the bootstrap procedure at the central portion of the output com posite. W e then include spectra that fall at longer wavelengths in sorted order to longer wavelengths, and spectra at shorter wavelengths in sorted order to shorter wavelengths. The overall com posite is renorm alized at each step. W e

t a power law of the form F / to the continuum of the composite spectrum; and nd that the best-t power law index is = 0.56. This is equivalent to

the $_{\rm EUV}$ ts to wavelengths > 500A in T 02. We show the composite spectrum and its ratio to the HST composite in the left panels of Figure 1. On the right, we show the emission lines t to the FUSE composite.

We nd a standard deviation of 0.11 in from 1000 bootstrap samples of the FUSE sample. This gives an estimate of the error arising from the range of spectral shapes of the individual AGN that constitute our sample. We explored a number of possible system atic errors that could a ect the spectral shape of the FUSE composite spectrum. The results are sensitive to the extinction correction. Changing all individual values of E (B V) by 1, where we estimate V) (Schlegel, Finkbeiner, & Davis 1998) changes by 0:16. 1 = 0:16E (B) Changing R_V in the extinction law to 4.0(2.8) changes by 0:19(+0:06). The composite is also sensitive to the value of the column density distribution pa-. Reducing it from the chosen ducial value of 2.0 to 1.7 or 1.5 ram eter, by up to 0.3. We estimate the total error from the items above, increases $0.56^{+0.38}_{0.28}$. The EUV spectral index of the HST composite is signicantly 0:12. In Figure 2, we show the redshift and lum inosity 1**:**76 softer. = distributions of the FUSE and HST samples.

3. Sum m ary

W e sum m arize our results as follow s:

(1) W e construct a composite EUV (630-1155 A) AGN spectrum of objects with z < 0.67 from archival FUSE data. (2) W e tapower law continuum and G aussian proles to the emission lines in the composite spectrum, and we nd that 0 vi/Ly and N e viii emission are enhanced in the FUSE composite relative to the HST composite due to the Baldwin e ect, seen also in the comparison between the HST and SDSS composites (T02). (3) W e nd that the best-t spectral index of the composite is = $0.56^{+0.38}_{-0.28}$. The conservative estimate

of the total error in the spectral index includes the standard deviation in in 1000 bootstrap samples of the FUSE data set, uncertainties in the extinction correction applied to the FUSE spectra, and uncertainties in the column density distribution parameter of the intervening Ly forest. (4) The FUSE composite is harder than the EUV portion of the HST composite spectrum of T02 who nd 1:76 0:12 for 332 spectra of 184 AGN with z > 0:33. The Baldwin e ect is = generally attributed to the tendency for low -lum inosity AGN tend to show harder ionizing continua (Zheng & Malkan 1993; Wang et al. 1998; Dietrich et al. 2002). The median lum inosity of the AGN in the FUSE sample is $\log L_{median} = 412$, versus $\log L_{m edian} = 42.9$ for the HST sample. One interpretation of these results is that both the enhanced high-ionization em ission line strengths and the harder continuum shape of the FUSE composite spectrum are due to the larger fraction of low -lum inosity AGN in the FUSE sam ple. How ever, we note that splitting the FUSE sample itself into high-and low-lum inosity/redshift subsamples as shown in Figure 2 results in only marginally di erent values for the EUV spectral index.
