The Radial Velocity and M ass of the W hite Dwarf of EX Hydrae M easured with Chandra

ABSTRACT

We present the rst detection of orbital motion in the cataclysm ic variable EX Hydrae based on X-ray data from the Chandra X-ray Observatory. The large collecting area of the telescope and the high resolution of the HETG spectrom eters allow for an unprecedented velocity accuracy of 15 km s¹ in the X-ray wavelength regime. We nd an emission line velocity am plitude of 58.2 3.7 km s¹ and infer a white dwarfm ass of 0.49 0.13 M , in good agreement with previous studies using optical, ultraviolet, and far ultraviolet data.

1. Introduction

M agnetic cataclysm ic variables (CVs) are sem i-detached, interacting binaries consisting of a late-type star that over ows its R oche-lobe and a white dwarfwith a magnetic eld su ciently strong to in uence the accretion of matter originating from the late-type companion. Them agnetic eld directs the accretion ow away from the orbital plane and onto both of the white dwarf's magnetic poles. A ccretion behaves di erently in the two classes of magnetic cataclysm ic variables. In polars the stars are tidally locked; this \static" orientation results in an accreting ow from the Lagrangian point L1 of the binary along the magnetic eld lines of the white dwarf onto its magnetic pole(s). In intermediate polars (\mathbb{P} s), where the white dwarf is spinning faster than the orbital period, matter also accretes onto the white dwarf along the magnetic eld lines; however, the matter rst accumulates in an accretion disk surrounding the white dwarf. In both polars and \mathbb{P} s the accreting matter approaches the poles of the white dwarf supersonically and so passes through a stand-o shock before cooling and settling onto the white dwarf (A izu 1973; Kyla s & Lamb 1982).

The cataclysm ic variable EX Hydrae belongs to the IP class. It consists of a white dwarf with a spin period of 67 m inutes and has an orbital period of 98 m inutes. Both the spin period and binary period can be identi ed in its light curves, from optical (e.g., Vogt, K rzem inski, & Sterken 1980; Sterken et al. 1983), UV (e.g., M auche 1999; Belle et al. 2003), and X -ray em ission (e.g., W atson, Sherrington, & Jam eson 1978; A llan, H ellier, & B eardm ore 1998). Furtherm ore, the inclination of the EX Hya system is such that its light curve shows a partial eclipse of the lower accretion pole of the white dwarf by the com panion (A llan et al. 1998).

Optical and UV spectroscopy of the EX Hya system has detected the orbital motion associated with the white dwarf (e.g., Breysacher & Vogt 1980; Hellier et al. 1987; M auche 1999; Belle et al. 2003). This motion, combined with the orbital velocity of the companion and the presence of the eclipse, allows for a mass determination of the white dwarf independent of models of the accretion column. In this letter we use Chandra High-Energy Transmission Grating (HETG) data for EX Hya and show that its orbital motion can be detected with high resolution X-ray spectra.

2. Observation and Reduction

EX H ya was observed by Chandra using the HETG in combination with the Advanced CCD Im aging Spectrom eter in its spectroscopy layout (ACIS-S) on 2000 M ay 18 for 60 ks. The observation was continuous and covers 10 orbital revolutions of the binary system and 15 white dwarf revolutions.

We reduced the data using the Chandra Interactive Analysis of Observations (CIAO) software package¹ making only two departures from the standard reduction: 1) we turned random ization o (i.e., we set rand_pix_size = 0.0 in the tg_resolve_events tool) to m inim ize any articial line broadening, and 2) we applied a solar system barycentric correction

so that the event times are in Barycentric D ynam ical T in e instead of spacecraft time. The reduced HETG EX Hya spectrum, as shown in Figure 1 (see also M auche 2002; M ukai et al. 2003), reveals emission lines from H- and He-like ions, as well as from Fe L-shell ions, superimposed on a weak continuum. Fe XVII and Fe XXII density diagnostics reported by M auche, Liedahl, & Fournier (2001, 2003) indicate densities of order n_e 10¹⁴ cm³.

3. Velocity signature

To search for velocity signatures in the EX Hya HETG data we used the following procedure: 1) identify the spectral lines in the rst-order High Energy G rating (HEG) and M edium Energy G rating (MEG) spectra; 2) divide the observation into time segments; 3) add the spectral lines in each time segment to form a composite line pro le (CLP) for each grating arm in order to boost the signal-to-noise ratio; 4) measure the line centroid of the CLP; and 5) look for variations of the line centroid with orbital or white dwarf spin phase.

3.1. Line Identi cation and W avelength Calibration

Table 1 lists the isolated spectral lines, i.e., lines that do not have another strong line within two times the instrumental FW HM, with a signal-to-noise ratio larger than 10. We obtained the reference wavelengths for these lines from the Astrophysical Plasm a Emission D atabase (APED; Smith et al. 2001). Reference wavelengths with uncertainty estimates from APED are taken from quantum electrodynamic theory for H-like ions (Ericsson 1977) and He-like ions (D rake 1988) and from laboratory measurements for Fe L-shell lines (B rown et al. 1998, 2002). Wavelength uncertainties are for individual lines only and do not include the electronic satellite lines that are associated with many of these strong lines. Such blending satellite lines contribute less than a few percent to the strength of the emission feature.

We de ned unblended lines as either single lines or multiplets that are unresolved and from the same ion. For unresolved lines from the same ion we used the emissivity-weighted wavelengths. The He-like Mg and Si forbidden and intercombination lines are unresolved by MEG, and since their theoretical line ux ratios depend on electron density and photoexciting radiation, we cannot weight their wavelengths by the low-density emissivities tabulated in APED. Thus we excluded theses lines from the CLP.

To con dently add spectral lines it is in portant to verify the wavelength calibration and to correct for any system atic o sets between the observed line centroids and the reference wavelengths from the APED database. To t the emission lines we rst determined the contribution of the continuum emission to the spectrum. A global t to line-free regions of HEG and MEG spectra using the Astrophysical Plasm a Emission C ode model (APEC, version 1.3, Sm ith et al. 2001) allows a self-consistent treatment of the continuum for all lines. We de ned the line-free regions as any part of the spectrum greater that 0.1 A in width that is devoid of spectral lines with emissivities larger than 10¹⁸ ph cm³ s¹ (this is

1/1000 of brightest line in the spectrum) in the APED database. We found a good t for a therm al continuum (consisting of brem sstrahlung, radiative recombination, and two-photon emission) for a temperature of 16 1 keV (see Figure 1), in good agreement with the shock temperature of $15.4^{+5.3}_{-2.6}$ keV reported by Fujim oto & Ishida (1997) for an A izu (1973) m odel tted to the ASCA spectrum of EX Hya, and the maximum temperature of 20 keV reported by M ukai et al. (2003) for a cooling ow model tted to the same Chandra HETG data. A two-temperature continuum m odel did not signi cantly lower the 2 of the t. This is not surprising since the highest temperatures dom inate the emission measure distribution in an accretion column cooling mainly by means of therm albrem sstrahlung.

To determ ine if any o sets between the observed wavelengths and their reference values exist we perform ed the following t. We set the distances between each consecutive pair of emission lines equal to their separation based on the APED database and only t the norm alization of each line and the overall wavelength o set. Each line is modeled using a Gaussian with a FW HM equal to the instrum ental FW HM (0.012 A for HEG and 0.023 A for MEG). This resulted in the following o sets for each of the orders (predicted observed wavelength): 0.0012(2), 0.0020(2), 0.0008(2), and 0.0004(2) A for HEG 1, HEG+1, MEG 1, and MEG+1, respectively. Although the o sets are small, they do constitute 10% of the HEG FW HM and 5% of the MEG FW HM, or about 30(50 km s¹ (at 10 A), and need to be corrected for.

Even more important than the absolute and relative wavelength calibration is its stability during an observation; this appears to be extrem ly stable (Chandra Proposers Observatory Guide²). Furthermore, the rotation and orbital periods of the EX Hya system are not relevant timescales for the satellite (dither period is 707.1 sec in the pitch direction and 1000 sec in the yaw direction).

3.2. Binary

To look for changing velocities associated with the binary period in the Chandra HETG data for EX H yawe is phase folded the spectra (using the ephemieris of Hellier & Sproats 1992) and divided the observation into phase intervals centered at $_{98} = 0.05;0:10;...;0:95;1:00$. with a width of $_{98} = 0.25$, where $_{98}$ indicates the phase in the binary orbit. Note that the phase intervals are overlapping.

Unfortunately, by splitting the observation into smaller phase intervals none of the spectral lines have su cient signal-to-noise ratio to con dently measure changes in their wavelengths. We therefore added all lines in each interval to accumulate enough counts to accurately measure the central wavelength. We accomplished this by the following procedure: 1) For each grating rst-order arm we determ ined the count-weighted average wavelength of the lines in Table 1, = $_i c_i refriet _i c_i$, where c_i is the num ber of counts in the spectrum for a segment 2 FW HM wide centered on $_{\rm ref;i}$ (from Table 1) m inus the number of counts predicted by the model continuum (see x3.1).2) Each line in the spectrum was shifted by an am ount equal to its reference wavelength, ref;i and by the wavelength calibration correction (see x3.1). 3) The wavelength-binned shifted spectrum was then transformed to a velocitybinned spectrum according to $v_{bin;i} = c(bin;i) = c_{ref;i}$ (4) The shifted velocity-binned pro le for each spectral line was added to form one line pro le. However, since the bin size for each line was di event we chose to rebin each $v_{\text{bin},i}$ to the bin size corresponding to :)= . 5) Finally, we measured the central velocity for this composite line $v_{bin} = c(bin)$ pro le (CLP).

Figure 2 shows the CLPs for binary phases $_{98} = 0.00, 0.25, 0.50$, and 0.75. The change in CLP centroid is clearly visible showing how powerful the combination of a large e ective area and high spectral resolution can be in the X-ray regime.

The radial velocity shifts as a function of $_{98}$ for the combined orders MEG 1 plus MEG + 1 are shown in the top panel of Figure 3. We present the MEG data rather than the HEG data because they have a factor of 2{10 times more counts per spectral line, which in proves our centroiding accuracy even with the lower resolution of the MEG instrument (see also x5). Results from the HEG and the individual MEG orders are consistent but with lower significance. The gure clearly shows that there is a system atic motion of the CLP with a period equal to that of the binary. The solid line represents the following t to the data points:

where = 1:3 2:3 km s¹, K = 58.2 3:7 km s¹ is the velocity am plitude, $_0$ = 0:48 0.01, ! is xed to 1.0, and = 0.25. Since the data points overlap, and are thus correlated, we calculated ² for each of the ve sets of independent data points (indicated in Figure 3). The ² per degree of freedom (dof) for the independent data sets range from ²=(dof= 1) = 0.1 to 1.0. It is important to note that the value of ² for a sm all number of dof can be di erent from the value one expects to indicate a good t in the case of a large number of dof, i.e., ²=dof = 1.0. The important statistic is Q (² jdof), which is the probability that the observed chi-squared will exceed the value ². A coeptable values for Q, i.e., the 3 con dence interval, range from 0.0015 to 0.9985. For the above values of ²/dof, Q ranges from 0.3 to 0.8.

We also tted the data with 1) a constant velocity and 2) a sine curve with the period not forced to the binary phase, i.e., ! not xed to 1.0 in Eq. 1. The former typelds $= 2.8 \ 2.3 \text{ km s}^1$, $^2 = (\text{dof} = 3)$ ranges from 13 to 19, and Q 7.0 10¹¹, while the latter typelds a period of ! = 1.01 0.04 times the binary period, and values of , K, and $_0$ are indistinguishable from the t described above. The latter t has zero degrees of freedom and hence a meaningless 2 .

The above velocity amplitude and phase o set, K = 58.2 3:7 km s¹, and $_0 = 0.48$ 0.01 are in good agreement with those reported by Breysacher & Vogt (1980, K = 68 9 km s¹, $_0 = 0.5$), Cowley, Hutchings, & Crampton (1981, K = 90 28 km s¹, $_0 = 0.55$), Gilliland (1982, K = 58 9.3 km s¹, $_0 = 0.52$), Hellier et al. (1987, K = 69 9 km s¹, $_0 = 0.53$ 0.03), M auche (1999, K = 85 9 km s¹, $_0 = 0.54$ 0.02, using FUV lines), and Belle et al. (2003, K = 59.6 2.6 km s¹, $_0 = 0.48$ 0.05, using UV lines).

3.3. W hite Dwarf Spin

The bottom panel of F igure 3 shows the CLP radial velocity versus the white dwarf spin period using bins of size one-third the spin period (i.e., = 0:333). The velocities have been corrected for the average binary motion for each data point based on the t described in x32. To provide upper limits on the rotation velocity of the white dwarf and the infall velocities in the accretion column, we tted sine curves to these data. We assumed that the upper accretion column is pointing away from the observer at white dwarf phase 0 (consistent with both the accretion curtain model [R osen et al. 1988] and the accretion pole occultation model [A llan et al. 1998]) and that the cooler part of the lower accretion column, where most of the spectral lines are form ed, is not visible throughout most of the spin cycle (A llan et al. 1998). The dotted curve in the gure represents the best-t rotation velocity of 9:2 5:0 km s⁻¹ ($_0 = 0.50$) and the dashed curve represents the best-t infall velocity of 7:9 5:4 km s⁻¹

($_0 = 0.25$). The 3 upper limits on the rotation and infall velocities are thus 25 km s¹.

4. W hite D warf M ass

C on bining the orbitalm otion of the white dwarfobtained in x3.2 with the orbitalm otion of the companion (Vande Putte et al. 2003, K₂ = 360 35 km s¹) and the eclipse duration (M ukai et al. 1998) allows us to determ ine the white dwarfm ass M₁, companion m ass M₂, and inclination i of the EX H ya system.

Here we followed the approach taken by Beuerm ann et al. (2003) using a computer program kindly provided to us by K.Beuerm ann. Assuming that the emission originates at or near the pole of the white dwarf, the iterative method yields $M_1 = 0.49 \quad 0.13 \text{ M}$, $M_2 = 0.078 \quad 0.014 \text{ M}$, $i = 77:2 \quad 0.6$. The white dwarf mass M_1 corresponds to a white dwarf radius $R_1 = 1.0 \quad 0.2 \quad 10^9 \text{ cm}$ (W ood 1995). If the emission originates above the surface of the white dwarf the inclination of the system decreases 0:1 for every $0:1 \quad R_1$ in elevation above the surface. These results agree within the errors with those found by Beuerm ann et al. (2003) and hence do not change any of the conclusions reached in that paper.

Finally, we note that our estim ate of the white dwarfm ass, which is based on the radial velocity of the emission lines in the Chandra HETG spectrum, agrees with that of Fujim oto & Ishida (1997) ($M_1 = 0.48^{+0.10}_{-0.06} \text{ M}$), which is based on the H-to He-like emission line intensity ratios observed in the ASCA spectrum. Our \classical" radial velocity result is applicable only to high-inclination m agnetic CV binaries, whereas theirs is applicable to a wide range of polars and IPs, although it relies on theoretical models of accretion column.

5. D iscussion

O ur radial velocity m easurement in EX H ya pushes the instrumental limit of the Chandra grating instruments. The MEG instrument has an elective area large enough to accumulate between 3000 and 4000 counts in the CLP so that we can reliably ind the centroid to an accuracy of 0.5 mA, corresponding to an accuracy in velocity space of 10{15 km s¹ (at 10 A). This is consistent with the statistical uncertainty for measuring G aussian line centroids derived by Landman, Roussel Dupre, & Tanigawa (1982):

where S is the statistical uncertainty in (the line center), is the instrum ental resolution (FW HM /2.3548), (x) $_{0}$ is the bin size expressed in term s of , and is the average error expressed in term s of the peak am plitude. For our MEG CLP this equation yields 0.5 mA, as observed, where we have taken = $2 = \frac{P}{P}$, with P the number of counts in the peak bin of the CLP.

Unfortunately the elective area of the HEG instrument is significantly smaller (a factor of 3 at 10 A) and does not allow us to improve over the MEG despite the better instrumental resolution (S = 0.5 mA for HEG, similar to MEG). This means that for this EX Hya data set we obtain similar velocity accuracies for HEG and MEG. To fully exploit the HEG resolution, i.e., gain a factor of 2 in velocity accuracy, a significantly longer observation would be required.

M ore velocity resolution is desirable to detect velocity changes induced by the rotation of the white dwarf around it spin axis. Such velocity signatures would provide inform ation on the location and velocity of the emitting plasm a and on the location of the magnetic pole. The lack of a pronounced velocity variation at the spin period of the white dwarf in this HETG observation is expected. To see this, note that the free-fall velocity onto the white dwarf v = $(2GM_{1}=R_{1})^{1=2}$ 3600 km s^1 , and the immediate post-shock velocity 900 km $\rm s^{1}$. A lso note that the majority of the spectral lines in the HETG v = v = 4spectrum are formed at temperatures of less than 2 keV, i.e., 0.1 times the post-shock tem perature T = 3GM $_{1}$ m $_{H}$ = 8kR $_{1}$ 20 keV (= 0:615 is the mean molecular weight of a completely ionized plasm a of solar composition). From Figures 1 and 2 of A izu (1973) we estimate the velocity of the 2 keV gas to be 0.1v 90 km s¹. Assuming that the accretion colum ns are perpendicular to the orbital plane, the projected post-shock velocity v cosi 18 km s¹. Furtherm ore, the maximum rotational velocity of the white dwarf $v_{mt} = 2 R_1 = 67m in$ 15 km s¹. Both velocities are smaller than the upper limits derived in x3.3.

6. Conclusions

We have con rm ed the orbital velocity of the white dwarf in the cataclysm ic variable EX H ya using the Chandra HETG. This measurement is the rst detection of orbital motion in a CV binary system based on X-ray spectroscopy. By adding various spectral lines visible in the EX H ya spectrum enough signal-to-noise ratio can be accumulated to obtain velocities accurate to $10\{15 \text{ km s}^1.\text{No new conclusions are drawn on the white dwarfm ass (0.49 0.13 M).}$
