Condition for Primordial Black Hole Formation in Randall-Sundrum Cosmology

W e consider spherical collapse in the R and all-Sundrum type IIm odel and estim ate the critical over density for black hole form ation in the radiation dom inated era. It is found that when $(density)^2$ -term is dom inant in the modi ed Friedmann equation the critical density is smaller than in the standard cosm ology, which im plies that PBHs are more easily produced in the R and all-Sundrum m odel.

I. IN TRODUCTION

Prim ordial black holes (PBH s) are e produced in the early Universe as a result of initial large density uctuations. PBH s are stable against evaporation [1] if their masses are small ($< 10^{15}$ g), and hence such PBH is a good candidate for dark matter of the Universe. PBH s with smaller masses evaporate by now and can give signi cant contributions to background -rays and cosm ic rays. In particular, evaporation of PBH s m ay account for the excess of low energy anti-protons observed by the BESS experiment [2].

Since regions with large over density can collapse into black holes, the num ber density of PBHs is very sensitive to the spectrum of the initial density uctuations and the critical over density $_{c}$ above which the black hole is form ed. In the standard cosm ology, the critical density was estimated by Carr [3] for a radiation dom inated universe and it was applied to a num ber of PBH scenarios (e.g. [4, 5, 6], for review see [7]).

However, the evolution of the early universe m ay be drastically changed in the presence of extradim ensions and branes which are predicted by string theories [8]. In braneworld cosm ology, the standard particles including ourselves are con ned in one of branes and only gravity can travel in a bulk space. R and all and Sundrum [9] proposed a sim ple and attractive m odel (called R and all-Sundrum Type IIm odel) for the braneworld, where a brane with positive tension is embedded in a 5D anti-de Sitter space. In this m odel the Friedm ann equation is m odi ed and hence cosm ological evolutions of the scale factor and density are di erent from those in the standard cosm ology, which leads to di erent evolution of the PBH s after their form ation [10, 11, 12].

In this letter, we consider spherical collapse of a region with large over density in the radiation dom inated era of the Randall-Sundrum model and determ ine the critical over density c. It is shown that the critical density is small compared with result of the standard cosm ology, which suggests that more abundance of PBHs is expected in the Randall-Sundrum cosm ology.

II. SPHERICAL COLLAPSE MODEL IN THE STANDARD COSMOLOGY

F irst we consider the collapse in the standard cosm ology in order to clarify the di erence between the standard and the Randall-Sundrum models. Let us consider a spherical region with radius R and over density in a radiation-dom inated universe. If the radius is larger than the horizon, the region behaves like a Friedmann universe. Thus, the evolution of R is described by

where t is the cosm ic time, M $_4$ is the 4D P lanck m ass, is the radiation density and K is a positive constant. The solution of this equation is written as

where is a parameter. From Eq.(1) the constants A and B is related by

P lease notice that the radiation density changes as R^4 and hence R^4 is constant.

The spherical region stops expanding when = =2, which gives the critical time t_c and radius R_c ,

In order to calculate the over density = ($_{b}$)= $_{b}$ we must x the coordinate system or gauge. Here we take \synchronous gauge", i.e., t = t_{b} , A = A_{b} and B = B_{b} . Then, the over density given by

For the region to collapse and become a black hole, the critical radius must be larger than the Jeans radius R_J which is given by [see Eq.(37)]

where $'_{H}$ (t) is the particle horizon at t and (0 (1)) is introduced to take account of am biguity in de ning R_J. By requiring R_c > R_J we obtain the condition for the black hole form ation,

Thus, when $R_i = H_H(t_i) = 2t_i$, the critical over-density c is given by ¹

III. SPHERICAL COLLAPSE IN RANDALL-SUNDRUM MODEL

Now we study the spherical collapse in Randall-Sundrum model. In this model the evolution of the spherical region with radius R is described by the modi ed Friedmann equation as $[13]^2$

where M₅ is the 5D P lanck m ass and represents the dark radiation. When the density is small ($< 3M_5^6 = (2 M_4^2)$) and the dark radiation is absent, Eq.(21) is the same as the standard one. However, for the case of large density, ²-term dom inates the RHS of Eq.(21) and the cosm ological evolution is quite di erent from that in the standard cosm ology. Therefore, we only consider the latter case. Then, the modi ed Friedm ann equation is given by

In similar way to the standard case, we obtain the solution of Eq.(22) in the radiation dom inated era,

¹ This critical over density is the same as the result in Ref. [3]. However, this is accidental because the di erent gauge and Jeans radius are used. If we use \uniform Hubble gauge" adopted in Ref. [3] the critical density is given by $_{c} = 2^{-2}=3$.

² Here we presume that the spherical collapse is described by the modilled Friedmann equation. However, the bulk contribution (5D W yle tensor) might spoil this picture [13]. Since the evaluation of the bulk contribution is very dil cult and is beyond the scope of the present letter, we simply assume that the bulk contribution is small.

where the constants A and B is related by

Next, let us consider the condition that the region collapses into a black hole, $R_c > R_J$. The Jeans length can be read from the mode equation of the density perturbations $_k$ for the modi ed Friedm ann model [10, 14],

where a is the scale factor and H is the Hubble. From Eq.(36) the Jeans length is given by

${\tt IV}$. ${\tt CONCLUSION}$

From Eqs.(39) and (20), the critical value in R andall-Sundrum m odel is about 3 times smaller than in the standard cosm ology. Thus, PBHs are more easily produced when the ²-term controls the cosm ic expansion in the R andall-Sundrum m odel. This can be explained by the grow th rate of the density uctuations. As is seen in Eq.(33) the density perturbations grows as t^{3-2} which is faster than t for the standard case.

W hen the distribution for the density uctuations is Gaussian, the mass fraction f(M) = BH(M) = OfPBHswithmass M is given by [5]

where (M) is the mass variance at horizon crossing and we assume (M) $_{\rm c}$. This shows that the abundance of PBHs is very sensitive to $_{\rm c}$. Therefore, the smaller critical value (39) gives a signi cante ect on the mass spectrum of PBHs. Suppose that the ²-dom inated era ends at t = t. The horizon mass M att is t³. Since the mass of the produced PBH is horizon mass, PBHs with mass smaller than M are produced in ²-dom inated era and have much larger abundance than more massive PBHs. This fact may be useful when one searches the extra-dimension by observing -ray and anti-protons from evaporation of PBHs.

Finally we make a comment on the choice of R_i in estimating the critical density, In this letter we take $R_i = {}^{\prime}_{H}(t_i)$. Another reasonable choice is $R_i = H^{-1}(t_i)$, In this case, the di erence between $_{c}$ (standard) and $_{c}$ (R and all-Sundrum) becomes larger. So the conclusion that the PBHs form ation is easier in R and all-Sundrum cosm ology does not change.

In sum m ary, we have considered the spherical collapse in R and all-Sundrum m odel and estim ated the critical over density for the black hole form ation in the radiation dom inated era. It has been found that when the H ubble expansion is dom inated by ²-term in the m odi ed Friedm ann equation the critical density is sm aller than in the standard cosm ology, which im plies that PBHs are m ore easily produced in the R and all-Sundrum m odel.
