NUCLEOSYNTHESIS OF ²⁶AL IN ROTATING WOLF-RAYET STARS

ABSTRACT

The 26 A lradionuclide can be detected through its decay em ission line at 1.809 M eV, as was rst observed by M ahoney et al. (1982). Since then, COMPTEL on board of the CGRO satellite, performed a sky survey in this energy range, and provided maps of the 26 Al distribution in the Galaxy. These results revealed that the main contributors to the synthesis of 26 A l are most likely the massive stars, which contribute through their winds (W olfR ayet stars) and through their supernova explosion.

C om parison between these observations (in particular observations in localized regions such as the Vela region and the Cygnus region) and the models available at that moment, showed however the need for im provements from both theoretical and observational points of view, in order to im prove our understanding of the 26 Algalactic distribution as well as that of its synthesis.

W ith the launch of the INTEGRAL satellite in October 2002, the observational part will hopefully be improved, and the construction of better resolution maps at 1.809 MeV is one of the main aim s of the mission. From a theoretical point of view, we need the most up-to-date predictions in order to be able to interpret the forthcoming data.

In this paper, we address this latter part, and present new results for 26 Alproduction by rotating W olfR ayet stars and their contribution to the total am ount observed in the G alaxy.

1. ²⁶AL SOURCES

 26 Al is a radioactive nuclide that can be produced by hydrostatic nucleosynthesis in H burning regions, by explosive nucleosynthesis and by spallation. Its half(life time in its ground state is of 72 10⁵ yr, and it is thus a good tracer of recent nucleosynthetic events in the Galaxy.

The maps obtained with COMPTEL (Diehl et al. 1995, K nodlæder et al. 1999, Pluschke et al. 2001) allow ed to pin down the main contributors to the diffuse em ission observed mainly in the galactic plane : massive stars (Prantzos & Diehl 1996, K nodlæder 1999). These objects end their lives with a supernova explosion, during which ²⁶A l can be synthesized and will eventually be expelled (Heger et al. 2003). The more massive (and shorter lived) ones will also contribute during quiescent evolutionary phases through their winds.

2. WOLF-RAYET STARS

W olf-R ayet (hereafter W R) stars are the bare cores of m assive O (type stars that lost their hydrogen rich envelope due to very strong stellar winds or by m ass transfer in a close binary system. They exhibit at their surface the products of the internal nuclesoynthesis accompanying rst the central H (burning (W N phase) and then central H e(burning phase (W C and W O phases). At solar m etallicity, all stars m ore m assive than about 30 M go through a W R phase, which typically lasts for a few 10⁵ years in the case of non-rotating objects (M eynet & M aeder 2003; 2004), and m assively contribute to the chem ical enrichm ent of the interstellar m edium (hereafter ISM).

 26 Al is synthesized during the central H {burning phase in these stars, and is eventually ejected into the ISM as the star is peeled o by strong winds during the W R phase. The am ount of 26 Al ejected in the ISM through winds is very sensitive to m ass loss rates, m etallicity, rotation and initial mass. M eynet et al. (1997) presented a rst study of the e ects of initial m ass and m etallicity, as well as the e ects of di erent possible prescriptions for convection. At that time, they could already show that the am ount of 26 Al ejected increases with m etallicity and initial m ass. In the grid of m odels used by M eynet et al. (1997), arti cially twice enhanced m ass loss rates were used, which appeared at that time to better t the observed properties of the W R stars in a series of environments (M aeder & M eynet 1994).

In the following, we present the results obtained for a new grid ofm odels including rotation and updated m ass loss prescriptions for the di erent evolutionary phases that m assive stars are likely to go through. Part of these results were discussed in Vuissoz et al. (2004).

3. ROTATION INDUCED MIXING

M assive stars are known to have high equatorial velocities ($\langle v \rangle = 200$ { 250 km s⁻¹) while on main sequence. Such a rotation a ects the evolution of stars in several ways. It rst has a direct incidence on its structure through the centrifugal acceleration. It also a ects the mass loss in terms of geometry and quantity. Finally it triggers instabilities in the radiative interior of the star, which allow transport of angular momentum and chem ical species.

Transport of angular momentum and chemical species is ensured by the meridional circulation, which settles in to balance the thermal desequilibrium induced by the departure from spherical symetry in rotating objects, and by the shear instability associated with the turbulent layers in regions with high angular velocity gradients (Zahn 1992; Maeder & Zahn 1998).

We chose an initial velocity = $300 \text{ km} \text{ s}^{-1}$ for allm asses and m etallicities, taking into account that this value is compatible with the m ean averaged observed velocity of 0 -type stars at solar m etallicity. Considering this, the rotating m odels used here well reproduce a series of observed features for 0 -type and W R stars, that non{rotating m odels fail to t (M eynet & M acder 2004).

4. RESULTS FOR ²⁶AL

The e ects of rotation on ²⁶Al production in W R stars are consequences of both the e ects on them ass loss and of the rotation induced m ixing. The main results for what concerns ²⁶Al are the following :

At given m etallicity, rotation allows stars with lower initial masses to enter the W R phase. W hen we take stellar rotation into account (which is an observational fact), the number of stars contributing to the ²⁶A lenrichment of the ISM through stellarwinds is thus increased. The total contribution of W R stars to the galactic content of ²⁶A l is larger when using rotating m odels than when using non{rotating ones, as can be seen in Fig. 3, and as will be discussed in the next section.

At given m ass and m etallicity, rotation results in an entrance into the W R phase at an earlier % f(x) = 0

evolutionary stage (not necessarily at an earlier tim e). For instance the solar m etallicity 60 M starm odel enters the W R phase during the core H e{burning phase when it is non{rotating and during the end of the core H {burning phase when it is rotating. In this last case the duration of the W R phase is longer so that the cum ulative tim e interval during which ^{26}Al is expelled is larger for rotating stars. This leads to an enhancem ent of the ^{26}Al yields. This is well illustrated in Figs. 1 and 2 where the evolution of the cum ulated m ass of ^{26}Al is shown as a function of time for both rotating and non{rotating m odels.

The higher the m etallicity, the larger the ejected m ass of 26 Al (see Fig.1 and Fig.2).

This is due to the metallicity dependence of mass loss rates and to the higher ^{25}Mg mass fraction available for ^{26}Al synthesis at higher metallicity.

R otation allows surface enrichment of ^{26}A lprior to the W R phase. This is a direct consequence of the combined e ects of meridional circulation and turbulence which allow ^{26}A lto di use outwards from the convective core, where it is produced by proton capture on ^{25}M g, up to the radiative envelope, and to appear earlier at the surface of the star.

5. CONTRIBUTION OF W R STARS TO THE ²⁶AL GALACTIC CONTENT

O ne can evaluate the contribution of W R stars to the total galactic m ass of 26 A l in the following way:

R is the galactic radius taken equal to 15 kpc.

(r) is the surface density distribution of atom ic and m olecular hydrogen according to Scoville & Sanders (1987). This quantity is used to m im ic the present star form ation rate in the G alaxy, provided that the m olecular clouds distribution is considered a good tracer of the star form ing regions.

M $_{LW R}$ is the minimum mass for a star to enter the W R phase at a given metallicity. Its dependence on initial velocity and initial metallicity is explicitly taken into account.

(M) / m $^{(1+\,x)}$ is the Initial M ass Function, x dening the slope of the IM F. Here, two dierent prescriptions were used, in order to show the impact of this physical ingredient on the global production of $^{26}{\rm A}$ lby W R stars.

 Y_{26}^W (M $_i,\,r,\,Z$) is the yield of ^{26}A l (excluding the supernova contribution) for a given m ass M $_i$ at a given m etallicity Z.

The expression in Eqn. 1 is normalized so as to account for a rate of 3 SN as per century in the G alaxy % f(x) = 0

(e.g. Capellaro et al. 1999).

Furtherm ore, we considered a metallicity gradient along the galactic radius such as Z = 0.04 for r 4 kpc, and d log(Z)/dr = -0.07 dex kpc⁻¹ beyond, with the condition that Z = 0.02 at r = 8.5 kpc (so-lar neighbourhood).

In Fig. 3, we can see that the radial surface density prole of 26 Al has a similar shape whether we use rotating or non-rotating models. In particular, in both cases there is a peak between 4 kpc and 6 kpc associated with the existence of the molecular clouds ring at 5 kpc, which is accounted for in the expression of the surface density distribution (r).

The rotating models lead to a larger contribution of W R stars to the $^{26}\mathrm{A}$ lsurface density prole in the inner 8 kpc ring. There, Z & Z , and as seen in Fig. 1 and Fig. 2, the com bined e ects of m etallicity and rotation lead to a substantial enhancem ent of the yields.

The total mass of 26 Al originating from W R stars is increased by a factor 2.5 to 2.9 when rotation is taken into account. The values obtained are also quite sensitive to the IMF slope, the Salpeter IMF (x = 1:35) favouring a larger contribution, even though the Scalo IMF (x = 1:7) is considered better suited form assive stars.

For an IM F slope of 1.7, we obtain a total ejected m ass of $^{26}\text{Alby W}$ R stars of 1.27 M in case of rotating m odels, which represents 42% to 63% of the total observed m ass, that is estimated to range between 2 and 3 M .

According to the recent observations by RHESSI (a -ray observatory for the Sun which was able to measure the diuse emission of both ²⁶Al and ⁶⁰Fe), the new estimate derived for the line ratio ⁶⁰Fe=²⁶Al 0:1 (see Sm ith's contribution in these proceedings) is consistent with the value predicted by Timmes et al. (1995), from computations including the sole contribution of type II supernovae (SN II). This would designate SN II as the dom inant contributors to the ²⁶A lgalactic content. How ever, the most recent com putations of nucleosynthesis from SN II indicate that the line ratio ⁶⁰Fe=²⁶Al should be larger than about 0.4. If this is the case, as pointed out by Prantzos (2004; see also his contribution in these proceedings), ²⁶Alshould, at least up to a 50 % level, originate from sources that produce ²⁶ A lbut do not produce ⁶⁰Fe, as is the case for the WR stars. Our results show that rotating stellarm odels of WR stars could actually be responsible for such an amount of ²⁶Al. Let us stress how ever, that this result has to be taken with caution, considering the 2.6 sigm a level of the RHESSI detection of 60 Fe and the large uncertainties existing on the physical param eters entering the derivation of such a quantity (see also Palacios et al, 2004).

6. CONCLUSIONS

W e have presented new results concerning $^{26}Alpro$ duction by W R stars from a new grid of models including rotation and updated physics, in particularthe most recent prescriptions for mass loss rates.

Taking rotation into account globally leads to an enhancem ent of w ind ejected m ass of 26 A lby very m assive stars.

C onvolved with appropriate IM F and star form ation rate indicator, these yields lead to a total m ass of about 1.3 M of 26 Al originating from W R stellar winds. This value is in agreement with the conclusions drawn by Prantzos (2004) from recent measurements of the line ux ratio 60 Fe= 26 Al.
