TW O-D IM ENSIONALSTRUCTUREOFTHIN TRANSONIC D ISCS: OBSERVATIONALMANIEESTATIONS

#### Abstract

W e study the two-dim ensional structure of thin transonic accretion discs in the vicinity of a non-spinning black hole with in the fram ew ork of hydrodynam ical version of the Grad-Shafranov equation. Our analysis focuses on the region inside the m arginally stable orbit (MSO), r $<r_{m ~ s}$. W e show that all com ponents of the dynam ical force in the disc becom e signi cant near the sonic surface and (especially) in the supersonic region. Under certain conditions, the disc structure can be far from radial, and we review the a ected disc properties, in particular the role of the critical condition at the sonic surface. Finally, we present a sim ple m odel aim ed at explaining the quasi-periodical oscillations that have been observed in the in fra-red and X -ray radiation of the G alactic C entre.


## 1. Introduction

$T$ he investigation of accretion ow s near black holes (BH s) is undoubtedly of great astrophysical interest. Substantial energy release m ust take place nearBHS, and general relativity e ects, attributable to strong gravitational elds, $m$ ust show up there. D epending on extemal conditions, both quasispherical and disc accretion ows can be realized. The structure of thin accretion discs has been the subject of $m$ any papers. $M$ any results were included in textbooks [1, 2]. Lynden B ell [3]was the rst to point out that superm assive BHs surrounded by accretion discs could exist in galactic nuclei. Subsequently, a theory for such discs was developed that is now called the standard $m$ odel, or the $m$ odel of the disc $[4,5,6]$.

Since then the standard disc thickness prescription hasbeen w idely used,

where the disc thickness $H$ is assum ed to be determ ined by the balance of gravitationaland accreting $m$ atter pressure forces $w$ ith the dynam ical force neglected. This relation w as later used in the renow ned approach where all quantities were averaged over the disc thickness [7], w ith a lot of such one-dim ensionalm odels follow ing $[8,9,10,11,12,13,14,15,16,17]$. A s for the tw o-dim ensionalstructure of accretion discs, it was investigated $m$ ostly only num erically and only for thick discs $[9,18,19,20]$.

Even though standard disc thickness prescription (1) and the averaging procedure are likely to be valid in the region of stable orbits $r>r_{m}$ [1], they in our view require a more serious analysis. It is the assum ption that the transverse velocity $v \mathrm{~m}$ ay alw ays be neglected in thin accretion discs all the way up to horizon [21], i.e. that the disc thickness is alw ays determ ined by (1), that is the most debatable [22]. This assum ption is w idely used, explicitly or im plicitly, virtually in all papers devoted to thin accretion discs $[23,24]$.
$T$ here is a briefdiscussion on thin discs in this volum e that covers theory shortcom ings and a briefdescription of our approach (cf. Sec. nam ed Thin disk in [22]). In this paper we brie $y$ describe our study of subsonic and transonic regions of thin discs follow ed in Sec. 5 by the elaborate discussion of the supersonic ow. Finally, in Sec. 6 we develop a toy $m$ odel for explaining the observed quasi-periodicaloscillations detected in the infra-red and X ray observations of the G C .

## 2. B asic equations

W e consider thin disc accretion on to a BH in the region where there are no stable circular orbits. T he contribution of viscosity should no longer be signi cant here [22]. H ence we m ay assum e that an ideal hydrodynam ics approach is suitable well enough for describing the ow structure in this inner area of the accretion disc. Below, unless speci cally stated, we consider the case of non-spinning BH, i.e. use the Schw arzschild metric, and use a system of units $w$ th $C=G=1: W$ e $m$ easure radial distances in the units of $M$, the BH mass.

In B oyer-Lindquist coordinates the Schw arzschild $m$ etric is [25]

W e reduce our discussion to the case of axisym $m$ etric stationary ow s . For an ideal ow there are three integrals of $m$ otion conserved along the stream lines, nam ely entropy, $S$, energy $E=$, and $z$-com ponent of angular m om entum $\mathrm{L}=\$ \mathrm{um}$, where $=(\mathrm{m}+\mathrm{P})=\mathrm{n}(\mathrm{m}$ is intemal energy density, $\mathrm{P}=\mathrm{nT}$ is pressure) is relativistic enthalpy. T he relativistic Bemoulli equation $u_{\rho}^{2}=2$ ut $\quad 1$, where $u_{p}$ is the physical poloidal 4 -velocity com ponent [22,26,27], now becom es

Below we use another angular variable $==2$ and for the sake of sim pli cation we adopt the polytropic equation of state $P=k(S) n$ so that tem perature and sound velocity can be written as [1]

## 3. Subsonic ow

Follow ing Sec. 1, we assum e that the -disc theory holds outside the M SO . W e adopt the ow velocity com ponents, which this theory yields on the M SO $r=r_{m}$ s $^{a}$ as the rst three boundary conditions for our problem. For the sake of sim plicity we consider the radial velocity, which is responsible for the in $o w$, to be constant at the surface $r=f_{s}$ and equal to $u_{0}$ and the toroidal velocity to be exactly equal to that of a free particle revolving at $r=r_{m s}{ }^{b}$. W e also assum e the speed of sound to be constant at the M SO, $\mathrm{C}_{\mathrm{s}}=\mathrm{C}_{0}=$ const. H aving introduced ms [27] | the Lagrange coordinate of stream lines at the M SO |for $\mathrm{C}_{\mathrm{s}}$ 1, i.e. non-relativistic tem perature, we obtain from (4) and (5),

[^0]where $e_{0}=\mathrm{E}_{0}=0$ and $l_{0}=\mathrm{L}=(0 \cos \mathrm{~m}$.$) , is the poloidal four-velocity of$ a free particle having zero poloidal velocity at the M SO .

In the extrem e subsonic case, $u_{p} \quad C_{s}$, the $G$ rad-Shafranov hydrodynam ic equation is signi cantly simpli ed [22, 27]. The num erical results are shown in Fig. 1. In the subsonic region, $r<r$ $r_{m} 3 \mathrm{f}$, the disc thickness rapidly dim inishes, and at the sonic surface we have $H(r)=u_{0}=c_{0} H\left(r_{m}\right)$, so that you cannot neglect the dynam ical force there.

W e stress that taking the dynam ical force into account is indeed extrem ely im portant. This is because, unlike zero-order standard disc thickness prescription (1), the G rad-Shafranov equation has second order derivatives, i.e. contains tw o additional degrees of freedom. This $m$ eans that the critical condition only xes one of these degrees of freedom (e.g. im poses som elim itations on the form of the ow) rather than determ ines the angular m om entum of the accreting m atter $[22,27]$.

## 4. Transonic ow

In order to verify our conclusions we consider the ow structure in the vicinity of the sonic surface in $m$ ore detail. Since the sm ooth transonic ow is analytical at a singular point $r=r ;=0$ [28], it is possible to express the quantities via a series of pow ens of $h=\left(\begin{array}{ll}r & r\end{array}\right)=r$ and . Substituting these expansions into equations ofm otion we get a set of equations on the coe cients which allow sus to reconstruct the ow structure in the vicin ity of the sonic point (see Fig. 2), in particular

 lines, $a_{0}=H\left(r_{m}\right)=H(r)$, and $1 \quad u_{0}^{1}$. Equation (8) yields shape of the sonic surface, $\mathrm{u}_{\mathrm{p}}=\mathrm{C}_{\mathrm{s}}$; 进 has the standard parabolic form $\mathrm{h}=(+1)_{1}{ }^{2}=3$.

Since the transonic ow in the form of a nozzle (see Fig. 2) has longitudinal and transversal scales of one order ofm agnitude [28], near the sonic surface we have $r_{k} \quad r$; i.e. $r_{k} \quad H(r)$. Hence for thin discs (i.e. for $c_{0}$ 1) this longitudinal scale is alw ays much sm aller than the distance from the $B H, r_{k}=r \quad H(r)=r \quad 1$. Only by taking the transversal velocity into account do we retain the sm all longitudinal scale $r_{k} \quad r_{g}$ : $T$ his scale is left out during the standard one-dim ensional approach.

## 5. Supersonic ow

Since the pressure gradient becom es insigni cant in the supersonic region, the $m$ atter $m$ oves here along the trajectories of free particles. Neglecting the r $P$ term in the -com ponent of relativistic Euler equation [29], we have [21]

Here, using the conservation law of angular mom entum, um can be easily expressed in tem sof radius: $u_{m}=2^{P} \overline{3}=r . W$ e also introduce dim ensionless functions $f(r)$ and $g(r): \quad f(r)=r u_{\wedge}$ and $g(r)=u_{r}>0$. Using (9) and the de nitions above, we obtain an ordinary di erential equation for $\mathrm{f}(\mathrm{r})$ which could be solved if we knew $\mathrm{g}(\mathrm{r})$ :

Equation (10) govems the supersonic ow structure for the case of nonspinning BH. To get a better m atch w ith observations (cf. Sec. 6), we also consider a m ore general case of spinning B H , i.e. a K err B H w ith non-zero speci c angular mom entum a. A fter som e calculation, equation (10) can be generalized to the $K$ err $m$ etric $w$ ith a strikingly sim $p l e$ form,

where $g(r)$ is a straightforw ard generalization of $g(r)$ to the $K$ err case; we om it it here due to space lim itations. For the Schwarzschild BH ( $a=0$, $e_{0}={ }^{P} \frac{1}{8=9}, I_{0}=2 \overline{3}$ [28]) equation (11) reduces back to (10).

Integrating (11), we obtain

$T$ he results of num erical calculations are presented in $F$ ig. 1. In the
${ }^{c}$ For $r$ just below $r$; the function $f$ should be positive to re ect the fact that the ow diverges. Then, $f=0$ corresponds to the point where the divergency nishes, and the ow starts to converge.

supersonic region the ow perform stransversaloscillations about the equatorial plane, their frequency independent of their am plitude. W e see as well that the m axim um thickness of the disc in the supersonic (and, hence, ballistic) region, which is controlled by the transverse com ponent of the gravitational force, actually coincides $w$ th the disc thickness $w$ thin the stable onbits region, $r>r_{m}$, where standard estim ate (1) is correct.

O nce diverged, the ow converges once again at a hodal point closer to the BH. The radialpositions the nodes are given by the im plicit form ula $\mathrm{f}\left(\mathrm{r}_{\mathrm{n}}\right)=1$; i.e.

w here n is the node num ber; the node w th $\mathrm{n}=0$ corresponds to the sonic surface. In this form ula the sonic radius r can be to a good accuracy approxim ated by $r_{m s}=r_{m s}(a)$ the expression for which can be found in m ost textbooks [1]. Figure 3 shows the positions of nodes for di erent values of $c_{0}$ (the positions do not depend on $u_{0}$ for $u_{0} \quad c_{0}$ ) and the BH spin param eter $a$. The $m$ atter travel tim e betw een the nodes has weak dependence not only on $u_{0}$ but also on $c_{0}$ as well. This provides a m eans for testing the theory via observations, and we do this in the follow ing section.

## 6. A pplications to observations

Suppose som e perturbation in the disc (a \chunk") approaches the M SO . W e expect to observe radiation com ing from the chunk w ith the period of its orbitalm otion,

$w$ here $a$ is the angular mom entum per unit $m$ ass of the BH and $r_{m}$ is an estim ate of the distance from the BH to the chunk [1]. A fter a number of rotations, the chunk reaches the MSO and passes through the nodal structure derived earlier (cf. Sec. 5) generating a are. Each time the chunk passes through a node, 迆 generates som e additional radiation, and therefore the are is likely to consist of several peaks. W e believe that it is these peaks that w ere discovered in the infra-red and $X$-ray observations of
the G C $[30,31]$.
$T$ he tim e intervalbetw een the detection of tw o subsequent peaks equals the tim e it takes for the chunk to pass betw een two adjacent nodes ( $n$-th and ( $n \quad 1$ )-th), $\mathrm{T}_{\mathrm{n}}^{(1)}$, plus the di erence in traveltim es to the observer for the radiation com ing from the $n$-th and ( $n \quad 1$ )-th nodes, $T_{n}^{(2)}$ :

w here n is the index of the observed tim e interval (counting from one).
The rst term in rh.s. of (15) can be easily obtained from the analysis of particle's geodesics in the equatorial plane [1]

For de niteness and sim plicity, we assum e that the observer is located along the rotation axis of the $\mathrm{BH} . \mathrm{On}$ its w ay to the observer, the radiation travels along the null geodesic that originates at a node in the equatorial plane (e.g. $r=r_{n}, \quad=2$ ) and reaches the observer at in nity ( $r=1$,
$=0)$. U sing these as boundary conditions for null geodesics in the $K$ err $m$ etric [32], we num erically nd $\mathrm{Tn}_{n}^{(2)}\left(\mathrm{a} ; \mathrm{C}_{\mathrm{s}}\right)$.
$F$ igure 5 show s the dependence of observed tim e intervals on the value of the speed of sound in the disc. A though each individual tim e intervalm ay depend on $c_{0}$, the range $\left[T_{m \text { in }}(a), T_{m}\right.$ ax $\left.(a)\right]$ of observed tim $e$ intervals (see the caption to $F$ ig. 5) is independent of $C_{0}$. W ith such weak dependence on the speed of sound in the disc, we have only tw o m atching param eters: the speci c spin a and the mass M of the BH.

In the are precursor section we associate the period $T_{n} s w$ th the 2200300 s one (group 5, cf. Table 2 in [30]) and the tim e interval $\mathrm{T}_{1}$ w ith the period of 1100100 s (group 4 in [30]). In consistency $w$ ith the infra-red observations of the are, the periods $T_{1}, T_{2}$, etc. chinp $w$ th the peak num ber [31], i.e. resem ble the QPO structure and thus form a cum ulative peak of a larger w idth shifted to higher frequencies on the ares' pow er density spectra (700 100 s , group 3, cf. Fig. 3a and 4a in [30]). W e can estim ate the average frequency of this peak as $1=\bar{T}=1=2\left(1=T_{m}\right.$ in $+1=T_{m}$ ax $)$. $T$ he results of the periods' $m$ atching procedure are show $n$ in $F$ ig. 4. D espite large uncertainties in the observationaldata allow ing signi cant freedom of a and M, high positive values of a (i.e. the disc orbiting in the sam e direction as the BH spin) are clearly ruled out.

Even though individualtim e intervals betw een subsequent peaks in the are $m$ ay depend on the tem perature in the disc (which is proportional to $c_{0}^{2}$, see (5)), their $m$ in $\dot{m} u m$ and $m$ axim um values rem ain the sam e for the range of sound velocities where there are several intervals observed. In the particular case of $a=0: 5$, illustrated in the gure, we have $T_{\text {T }}$ in 32 and $\mathrm{T}_{\mathrm{m}}$ ax $\quad 60 \mathrm{w}$ ith all other tim $e$ intervals lying in betw een.
