H ST ABSOLUTE SPECTROPHOTOMETRY OF VEGA FROM THE FAR-UV TO THE IR

ABSTRACT

The Space Telescope Im aging Spectrograph has measured the absolute ux for Vega from 0.17{1.01 m on the HST W hite Dwarf ux scale. These data are saturated by up to a factor of 80 overexposure but retain linearity to a precision of 0.2%, because the charge bleeds along the columns and is recovered during readout of the CCD. The S/N per pixel exceeds 1000, and the resolution R is about 500. A V m agnitude of 0.026 0.008 is established for Vega; and the absolute ux level is $3.46 ext{ 10}^9$ erg cm 2 s 1 at 5556 A. In the regions of Balmer and Paschen lines, the STIS equivalent widths di er from the pioneering work of Hayes in 1985 but do agree with predictions of a Kunucz model atmosphere, so that the ST IS ux distribution is preferred to that of H ayes. Over the full wavelength range, the m odel atm osphere calculation shows excellent agreem ent with the ST IS ux distribution and is used to extrapolate predicted uxes into the IR region. However, the IR uxes are 2% low with respect to the standard Vega m odel of C ohen. IUE data provide the extension of the measured ST IS ux distribution from 0.17 down to 0.12 m. The ST IS relative ux calibration is based on model atmosphere calculations of pure hydrogen W Ds, while the Hayes ux calibration is based on the physics of laboratory lamps and black body ovens. The agreem ent to 1% of these two independent m ethods for determ ining the relative stellar ux distributions suggests that both m ethods may be correct from $0.5\{0.8 \text{ m} \text{ and adds} \}$ con dence to claim s that the uxes relative to 5500A are determ ined to better than 4% by the pure hydrogen W D models from 0.12 to 3 m.

1. IN TRODUCTION

The most commonly used ux calibration for the fundamental standard Vega (Lyr, HD 172167, HR 7001) is the compilation of Hayes (1985), while M egessier (1995) suggests an increase of 0.6% in the Hayes value of 3:44 10^9 erg cm 2 s 1 A 1 at 5556 A. The Hayes ux for Vega is traceable to fundamental standard lamps pedigreed by NBS (now N IST), which is charged with maintaining fundamental standards of physical units. The Hayes ux compilation is based on direct comparisons of the star to calibrated lamps and black body ovens. M ost ground based estimates of absolute stellar ux are traceable to the ux of Vega.

W ith the advent of extensive space based observations in the far-UV, a need for standard ux candles arose at wavelengths below the atm ospheric cuto . A few rocket experiments established som eUV standard stars with 10% precision (e.g. Strongylis & Bohlin 1979). To establish standards with better accuracy, a technique based on model atmospheres for simple, pure hydrogen W Ds was suggested by D. Finley and J. Holberg for calibrating the IUE satellite spectrophotom etry, (cf. Fig. 8 in Bohlin, et al. 1990). The hot W D standard stars G 191B 2B, GD 153, and GD 71 at $V = 12\{13 \text{ mag were es}$ tablished by computing LTE modelatmosphere ux distributions for pure hydrogen atm ospheres, which were then norm alized to precisely measured V magnitudes from A.Landolt (see Bohlin 2000). EUV observations below the Lym an lim it dem onstrated that any e ects of interstellar extinction in these three stars is less than 1% longward of the 912 A Lym an lim it. These three W D standards are now based on

NLTE m odels by Ivan Hubeny (Bohlin 2003) and are complemented by three solar analog stars for HST calibrations extending into the IR (Bohlin, Dickinson, & Calzetti 2001).

The Vega observations with ST IS are discussed in Section 2. Section 3 establishes the best estimate of the V band magnitude of Vega, while Section 4 presents the nst direct comparison between the W D and the standard lamp m ethods for establishing absolute ux. A third m ethod for de ning the ux of Vega at all wavelengths is based on m odeling of its stellar atm osphere, as discussed in Section 5. M odel atm osphere codes are now sophisticated enough to warrant detailed comparisons between observation and theory. Because of the excellent agreement of a m odel (K unicz 2003, C astelli and K unicz 1994) with the ST IS observations up to 1 m, the m odel should provide a good estimate of the ux beyond 1 m, as discussed in Section 6.

2. CALIBRATION OF THE SATURATED OBSERVATIONS

ST IS observations of Vega in the three CCD low dispersion m odes G 230LB, G 430L, and G 750L (K in Q uijano 2003) produce heavy saturation of the full well depth. However at G ain = 4, the A -to-D am - pli er does not saturate; and the excess charge just bleeds into adjacent pixels along the colum ns, which are perpendicular to the dispersion axis. G illiland, G oudfrooij and K im ble (1999, GGK) have dem on-strated that saturated data on the ST IS CCD are linear in total charge vs. stellar ux, as long as the extraction region on the CCD im age is large enough

to include all the charge. In particular, G G K dem onstrated linearity to 0.1% accuracy using 50 overexposed im ages of a star in M 67 to compare with unsaturated exposures of the same star. In the G 430M m edium dispersion spectralm ode, 0.8s observations of C en A saturated by about a factor of 4; and G G K showed that the ratio to a m ean G 430M spectrum at 0.1s is linear to 1%. Furtherm ore, G G K dem onstrated that the short 0.3s ST IS exposure tim es are stable and accurate to 0.2%, i.e. 0.0006s.

2.1. C orrections for the TallExtractions of the Saturated D ata

For Vega, the extraction heights required to include all the charge in the saturated images are 84, 54, and 40 pixels tall for G 230LB, G 430L, and G 750L, respectively, for single integrations of 6s for G 230LB and 0.3s for G 430L and G 750L. For these saturated images, the signal level is so high that any signal loss due to charge transfer e ciency (CTE) e ects (B ohlin & G oudfrooij 2003) is < 0.1%.

Because of scattered light from the ST IS gratings, a tall extraction height contains more signal than the standard 7 pixel extraction, to which the absolute ux calibrations apply (Bohlin 1998). The am ount of excess signal in the tall extractions must be derived from unsaturated images. Observations of the starAGK + 81 266 that is used to monitor the change in ST IS instrum ental sensitivity are used to derive the correction for the heights of 54 and 40 pixels, respectively for G 430L with 43 observations and G 750L with 37 observations. For G 230LB, the three unsaturated G 230LB observations of Vega itselfare used to correct the 84 pixelextractions of the saturated observations. All three unsaturated Vega G 230LB spectra at the detector center give the sam e correction from a 7 to an 84 pixel high extraction. This correction drops from 1293 at 1700 A to 1.150 at 3000 A with a maximum di erence among the three observations of 0.2% in the 1.293 correction factor at 1700 A.

The uncertainties in the tall slit corrections for G 430L and for G 750L below 8450 A, where saturation ends (see 2.3 below), can be characterized by the rm s scatter among the many AGK + 81 266 determ inations. The ratios of the 54 and 40 pixel high extractions to the standard 7 pixel extraction have an added uncertainty of 0.2{0.6% m easured by the m s of these ratios for AGK + 81 266 but do not show trends with time that m ight be caused by the increasing CTE losses. The CTE correction for the 7 pixelextractions grows from zero in 1997 to a maxim um of 3% in the relevant 3000 {8450 A range for the AGK + 81 266 data obtained near the tim e of the Vega observations; but the lim it to any error caused by our assumption of a matching CTE correction in the 54 or 40 pixel tall extractions is included in

the $0.2\{0.6\%$ m s values. For example in the range covered by the V liter (see Section 3), the m s uncertainty in the tall slit correction is 0.3%. The m s uncertainties of < 0.2% for G 230LB and $0.2\{0.6\%$ over the 3000{8450 A range for the tall slit correction ratios should be included in the total system atic error budget as a function of wavelength.

2.2. Veri cation of Linearity for Saturated D ata

2.2.1. Shutter T im ing

Linearity for the Vega data can be veri ed directly, because 0.3s observations of Vega in the G 230LB m ode are unsaturated below 2900 A, i.e. over the

rst 900 pixels of the 1024 pixel spectrum . Exposures of 6s were obtained in order to re-verify linearity up to a saturation factor of 20. The 6s observations with G 230LB are more saturated at the longest wavelengths than at any wavelength in the G 430L or G 750L spectra. Table 1 is the purnal of the Vega observations, while Figure 1 dem onstrates both the repeatability of G 230LB observations and, also, the linearity beyond saturation. The individual fram e exposure tim es are the exptim e per cr-split fram e from Table 1, i.e. 0.3s for all observations, except for the saturated G 230LB observations of 6s. One spectrum in the 52X 2E1 aperture was placed 130 pixels from the top of the detector, where the CTE correction is 4 lower than the central correction, which exceeds 1% only below 2000 A. However, the at eld correction for the E1 position relative to centered spectra is currently based on only 13 observations obtained in 2000 {2002 and is uncertain by 0.5%. The E1 exposure will not be included in the analysis below. Figure 1 shows the ratio of the ve centered individual G 230LB observations to their average. The two 6s exposures are low by 0.9998 0.0005 and the three centered and unsaturated ratios average 1.0027 0.0005. The discrepancy between the ux for the two exposure times is 0.29% 0.07%. One simple explanation is that the nom inal 0.3s exposures are really 0.3009s 0.0002s, in agreement with GGK who nd that the 0.3s shutter tim ing is accurate to 0.0006s.

2.2.2. Saturation and Charge Transfer E ciency Corrections

O ther possibilities for the 0.3% ux di erence between the 0.3 and 6s exposures are non-linearities, either in the saturated data or in the CTE correction of the unsaturated data. GGK dem onstrate linearity to better than 0.1% for exposures of point sources overexposed by 50 and for spectra of C en A at 4 over saturation (see above). The loss of signal due to charge transfer e ciency (CTE) is < 0.1% for the saturated spectra, while the amount of the CTE correction for the unsaturated 0.3sG 230LB data ranges from 1.5% at the shorter wavelengths to 0.5% at the longest wavelengths. Bohlin and Goudfrooij (2003) suggest their CTE correction formula is accurate to 10% for the signal level of the Vega data, which corresponds to < 0.2% for the CTE correction of < 2% for the 0.3s uxes. Because these uncertainties are comparable to the measured timing error of the 0.3s exposures, the nom inal 0.3000s value is retained. The uncertainty of 0.3% in the 0.3s exposure tim es will contribute to the uncertainty in the nal determ ination of the measured ST IS V m ag that will be compared with V = 0.035, which was previously used to set the overall level of the absolute ST IS ux calibration on the W D scale (Bohlin 2000 and Section 3 below .)

2.3. Additional D etails

The 84 pixel extractions have more contam ination from the out-of-band scattered light that lls in the line cores slightly and produces the 1% dips in Figure 1 at the locations of the deeper lines in the 7 pixel extractions from the 0.3s im ages. At the strong 2800 A M g II line, the di erential lling reaches 2%. To minimize the out-of-band stray light, a standard 7 pixel extraction is used longward of 8450 A, where there is no saturation in the 0.3s exposures with G 750L.

A fler extracting the spectra from the images, adjusting the ux to a standard 7-pixel-high aperture, correcting for sensitivity changes with time Bohlin (2003), and applying the CTE correction (Bohlin & Goudfrooij 2003), corrections to the wavelengths are made for sub-pixel wavelength errors that are obvious in the high S/N saturated spectra. These shifts range up to 0.5 pixel and are found by cross-correlation of the absorption lines with a model ux distribution.

3. THE V BAND MAGNITUDE OF VEGA

The ST IS ux calibration is based on standard star reference uxes that are pure hydrogen W D m odels normalized relative to the average ux of Vega over the V band (Colina and Bohlin 1994, Bohlin 2000). The absolute ux of these fundam ental standard stars G 191B 2B, G D 71, and G D 153, depends directly on the di erence between the V m agnitude of Vega and V for each W D star. The one sigm a uncertainties in the Landolt V m agnitudes of the W D stars are in the range 0.001 { .004 m ag (Landolt 1992 and private com m unication). The m easured ST IS ux for Vega relative to the W D standard star uxes determ ines the instrum ental V m agnitude of Vega with respect to the precision Landolt V m agnitudes of the W Ds. The Landolt transform ations from his instrum ental scale to Johnson V m agnitudes is summarized in Colina and Bohlin (1994). There are three choices for the de nition of the Landolt V bandpass: the K itt Peak Iter+ detector (Landolt, private communication), the CTIO lter+ detector (Landolt 1992), and the latter as modi ed by Cohen et al. (2003b) to include an estim ate of the atm ospheric transparency above the CTIO observatory. None of the estimated bandpass functions include the telescope optics; but that om ission is expected to cause < 0.001 m ag errors (Colina and Bohlin 1994). The three bandpass functions yield slightly di erent m agnitudes for Vega in the range of V = 0.021 to 0.031; but V = 0:026 for the C ohen et al. (2003b) bandpass with the atmosphere included should be the most accurate. Conservatively, 0.005 m ag is assigned to the uncertainty that still remains in the Landolt-Cohen CTIO bandpass function. The small scatter of 0.002 among the separate determ inations from the three W Ds is included in the 0.005 m aq bandpass error estim ate.

Colina and Bohlin (1994) previously adopted V =0:035 for Vega. Megessier (1995) and Bessell, Castelli, and Plez (1998) adopt V = 0.03, while Johnson et al. (1966) also quote 0.03 in their Table 2 of the best mean values with a probable uncertainty of 0.015 m ag. Because the ST IS determ ination is more accurate and di ers from the ground based value by less than its = 0.015 mag, V = 0:026 0:008 is adopted for Vega. The rm s uncertainty of 0.008 is the combination of the 0.005 m ag from the bandpass and 0.003 m ag uncertainties from each of the shutter tim ing, the tall slit correction, the Landolt W D m agnitudes, and the CTE correction to the W D standard stars. The constant o set of 0.006 m ag between Johnson V and color corrected Landolt V is not usually applied (Colina and Bohlin 1994). However, the 0.006 has been added for this direct com parison to Johnson V values, while 0.020 is used to compare with the Landolt V magnitudes of the W D standard stars. Because the ST IS observations determ ine the ux of Vega relative to the fundamental 12{13 m ag W D standards, adopting V = 0.026 m eans that the ST IS low dispersion spectroscopic modes on the CCD detector are perfectly linear over this 10 range in stellar ux.

4. COM PAR ISON OF STIS FLUXES W ITH HAYES

M egessier (1995) claims that the average monochromatic Hayes ux of 3:44 10^9 erg cm² s¹ A¹ at 5556 A includes one value from a faulty tungsten strip lamp at Palomar. E liminating the Palomar value of 3:36 10^9 erg cm² s¹ A¹, M egessier nds that the ux at 5556A is

3:46 $10^9 \text{ erg m}^2 \text{ s}^1 \text{ A}^1$ 0:7% from a weighted average of three remaining independent determ inations. The absolute scaling of the ST IS sensitivity functions is set by a recalibration for V = 0:026 and the corresponding integration over the model as normalized to 3:46 $10^9 \text{ erg cm}^2 \text{ s}^1 \text{ A}^1$ at 5556 A. Even though the monochromatic model

ux is increased by only 0.6% at 5556A relative to H ayes (1985), the slightly di erent ux distributions over the broad band V lter causes a 0.9% higher average for the m odel com pared to the H ayes ux distribution. The resulting ST IS ux for Vega produces a ratio of ST IS divided by the original H ayes (1985) uxes shown by the solid line in Figure 2. Before dividing by the H ayes ux, the ST IS values are binned over the H ayes 25 A bandpass, the ratio is then sm oothed tw ice with a 5 point boxcar and plotted at the 25 A sam ple spacing of the H ayes com pilation.

M ore in portant than the question of absolute ux level is the slope (dF/d) of the independently determ ined W D and Hayes ux distributions. Over the 5000{8500 A range, the two ux distributions agree to 0.5% in slope. The H lines of Hayes and ST IS also m atch; but the higher Balm er lines below 5000 A and the Paschen lines above 8500 A are signi cantly di erent in the two spectra. In order to understand the nature of these di erences, the twomeasured uxes are compared with the Kurucz (2003) $R = 500 \text{ m odel in Figures } 3\{4 \text{ on a vacuum}\}$ wavelength scale. The resolving powerR of the three ST IS CCD low dispersion modes ranges from 500 to 1100 for narrow slits; how ever, the broader PSF in the 2 arcsec wide slit and the tall extraction heights for the saturated data cause som e added degradation. The line depths of the hydrogen lines in the ST IS spectra are best m atched by the K unucz m odel at R = 500. Figure 3 illustrates the discrepant H ayes H line pro le in comparison to the model and to ST IS. The equivalent width of the Hayes H line is too low. The rest of higher Balm er lines show sim ilar discrepancies, which cause the three big dips in Figure 2 between 3900 and 5000 A, where ST IS m easures stronger features. Perhaps, the Hayes data at the shorter wavelengths su er from stray light that

Its in the line pro les. Figure 4 illustrates a different situation for the Paschen lines. At these long wavelengths, ST IS CCD observations su er from a severe fringing pattern that must be rem oved with a contemporaneous at from a tungsten lamp. The de-fringed ST IS spectrum su ers from residual artifacts at the 2% level, so that all the di erences between the ST IS data and the model can be ascribed to fringe residuals. Several of the Hayes lines are too strong by up to a factor of 2; and the centroids of several of his spectral features lie at the wrong wavelengths. In one case, the 8677.4 A (8675 A air wavelength) Hayes point is a peak, rather than the m inim um that should correspond to the Paschen line just shortward, at 8667.4 A. These apparent major errors in the Hayes spectrophotom etry cause the spurious structure in the ratio of ST IS/H ayes in F igure 2. Hayes (1985) used the 25A step size from the one available data set with a continuous scan but also included other data sets with resolutions of 10 to 100 A in his nal weighted average of absolute

uxes. He warns of the low accuracy of his energy distribution \...near strong lines and in the Balmer and Paschen con uences..." Some additional problem swith the Hayes spectrophotom etry at the longer wavelengths of Figure 4 are probably caused by telluric water vapor lines, while the Balmer line region may be contam inated by ozone and O_4 absorption features in the Earth's upper atm osphere (K urucz 1995). Our nal ux distribution (see the next section for details) is shown in Figure 5 and is entirely independent of the Hayes com pilation.

5. COM PAR ISON OF THE STIS OBSERVATIONS WITH A VEGA MODEL ATMOSPHERE CALCULATION

The excellent agreement of the STIS spectrum with the Kurucz (2003) calculations motivates a m ore detailed investigation with the goal of establishing typical uncertainties that m ight apply to the model atmosphere uxes in the unobserved IR region. The Balmer line pro les are correct in the Kunucz models, because the e ective temperature (9550 K) and gravity ($\log g = 3.95$) are determined by thing theoretical line pro les to high resolution observations (Castelli & Kurucz 1994). The metallicity is M/H] = 0:5, and a detailed discussion of the elemental abundances is in Castelli and Kurucz (1994). The main di erence between the Kurucz (2003) and the Castelli and K urucz (1994) m odels is the correction of a spurious dip in the ux distribution in the 3670 (3720 A region.

5.1. 6600{8500 A

Starting the detailed com parison at the long wavelengths, only one spectral feature, the O I multiplet at 7775 A (7773 A air), is deeper than 1% in the range from H to the 8500 A cuto of Figure 4. The only deviation > 1% between the model and the ST IS ux is from 7800{8200A, where ST IS is system atically 1% high. Again, this sm all di erence is probably an artifact of the de-fringing process.

5.2. Scaling to the Continuum Level

Below H , there are no firinges in the ST IS spectra; and Figures 6{8 show the comparison between the data and the model after norm alizing to a continuum. These gures show the uxes divided by the theoretical sm ooth continuum, conveniently provided by K unucz as a third column in hism odel les. Both ST IS and the model uxes are divided by the same continuum values. The continuum level has no physical signi cance and only provides a scaling that allows the spectral features to be displayed on a com m on expanded scale. Therefore, from 3640{3980 A, a low er continuum level is adopted in order to bring the features in this range closer to unity after normalization. Figure 6 presents the regime from H to H ; Figure 7 covers the Balmer continuum and higher Balm er lines; and Figure 8 com pares the observations with the model in the region with strong metal line blanketing from MgII (2800 A) down to the ST IS G 230LB cuto .

5.3. 4100{6600 A

Figure 6 shows the region of best agreement, where model and observation agree to 1%. The two 1{ 2% dimension of weak lines could be due to smalldimenses of the actual ST IS resolution from the R = 500 m odel.

5.4. 2800{4100 A

Figure 7 shows the most troubling divergence of the model from the STIS ux distribution. The model has higher uxes by 3% from 3100A to 3670 A. This di erence gradually dim in ishes tow ard shorter wavelengths and disappears around 2800 A, while a similarly largerm odel ux appears in the ve or six well resolved regions between the Balmer lines shortward of H . In the problem atic region of di cult atom ic physics (C astelliand K unucz, see above), the model still dips for 20{30 A near 3700 A to a few percent lower than the sm oother ST IS transition from lines to continuum. Because the ST IS ux calibration is based on similar calculations of the shape of the Balmer jump region, the source of the di erence must arise from errors in the W D models or in the Kurucz Vega model. The Balmer jump in the hot W D s is 6{7 times weaker; and line strengths are correspondingly less, so that the hotter W D uxes should have a low er fractional error across the transition region from Balmer lines to continuum. In other words, any opacity errors in the Balmer continuum or in the overlapping wings of the lines are m agni ed in the Vega m odel relative to a 30,000 {60,000K W D modelatmosphere.

5.5. 1680{2800 A

Figure 8 covers the region of heavy m etal line blanketing and shows excellent agreem ent of the wavelengths of the spectral bumps and dips, implying that the model does include the proper set of spectral lines. Several regions agree in ux to 1%, especially those around the 0.9 level, i.e. 10% blanketing. However, as the blanketing increases, the am ount of increase is too large in the model. For example, the model is too low by an average of 6% in the 1800{ 1900 A region, where the ST IS ux drops as low as 0.82 com pared to 0.74 for the model. The source of these di erences are di cult to ascribe to ST IS, because its ux calibration is determ ined by the W D standard stars, which are perfectly smooth with no lines in this region. B roadband residuals in the ST IS calibration are < 0.5% for all three standard stars between Ly- and 9600 A, while narrow band (25A) residuals are all <1% . Because the di erences in Figure 8 increase with the amount of blanketing, a m ore likely cause seem s to be som e system atic overestim ate of the line strengths in the model. There is no evidence for interstellar reddening, which would reduce the observed ux the most in the 2200 A region for the standard galactic reddening curve of Seaton (1979).

5.6. Below the 1680 A Cuto of ST IS

In the far-UV, the comparison of the model with the IUE spectrum follows the above pattern, where the model is often lower but rarely higher than the measured ux distribution. An outstanding exam ple is from 1600{1650 A, where the IUE is fairly constant at 0.80 to 0.85 relative to the continuum . However, the model has a big dip down to 0.64 and averages 0.77, i.e. the model is 7% low averaged over1600{1650A.The possibility that the UV m etal lines are too strong in the model is again supported by a comparison of the strong 1670.8 A Al II line in the model vs. an IUE high dispersion spectrum . The fullwidth at half the continuum level of the IUE line is 0.81 A, while the measured width in the model is 0.88 A, even when comparing the full resolution R = 500;000 Kunucz spectrum to the R = 12,000IUE linepro le.

5.7. The R ecom m ended F lux D istribution

IUE spectrophotom etry on the HST WD scale (Bohlin 1996) completes the observed ux distribution of Vega below the STIS CCD cuto at 1675A after multiplying by 1.04 to normalize to the STIS uxes over the 1700{1900 A range. Longward of

4200 A, the few isolated di erences between the ST IS spectrum and the model are at the 1{2% level and can be attributed to instrum ental e ects. In the continuum, the ST IS data are 0.4% higher at 5556 A and only 0.1% higher in the V band. Therefore, in view of this excellent agreem ent of the model with ST IS, the R = 500 model with e ective tem perature 9550 K and $\log g = 3.95$ is adopted as the standard star ux distribution longward of 4200A. The ST IS PSF is expected to have a Gaussian core corresponding to R 500 with broad wings extending to the 2 arcsec width of the 52 2 entrance slit. The R = 500 m odel that m atches the ST IS resolution is shown in Figure 5 and comprises the recommended ux distribution. However, higher resolution model spectra are available from Kurucz (2003) and provide equally valid model ux distributions after normalization to $3:46 ext{ 10}^9 ext{ erg cm}^2$ $s^{1} A^{1}$ at 5556 A.From 1675 to 4200 A, the nal Vega absolute ux distribution is de ned by the new ST IS observations as calibrated on the HST pure hydrogen W D scale. The only dependencies of this HST ux scale on ground based observations are the adopted m onochrom atic ux for Vega at 5556A from Megessier (1995) and the Landolt V magnitudes of the three pure hydrogen prim ary standard W Ds, as reviewed in the Introduction but re ned using the new V magnitude and model ux distribution de ned for Vega in this work. alpha_lyr_stis_002. ts. Included in the leave the estim ated system atic uncertainty of 1% and the statistical uncertainties, which determ ine a S/N per pixel that ranges from 1300 at 1700 A to 6700 at 3000 A.

6. THE INFRARED SPECTRUM OF VEGA

Our infrared spectrum of Vega is provided by the R = 500 K unucz m odel, after norm alizing the m odel 10 ⁹ to the 3**:**46 ux of Megessier at 5556A.Cohen et al. (1992) used 1991-vintage K unucz m odels to establish Sirius and Vega as primary IR irradiance standards, which are the basis for a heroic effort to standardize IR uxes and photom etry that is now up to Paper X IV (Cohen et al. 2003a). W hile our Vega ux distribution is 0.6% higher at 5556A, the cooler C ohen tem perature of 9400 K m akes the broadband ratio of the 9550/9400 K models about 2% lower from 1.2 to 35 m.Our norm alization of the hotter K urucz m odel im plies an angular diam eter of 3,273 m as, in com parison with the C ohen et al. (1992) value of 3.335 m as and the m easured value of 3.24 0.07 m as (Hanbury Brown et al. 1974). How ever, a 2% low er IR ux for Vega causes worse agreem ent with the few existing absolute IR ux m easurements as summarized by Cohen et al. (1992), who adopted an uncertainty in the IR of 1.5% from the Hayes (1985) standard error at 5556 A. Perhaps, 2% is a more realistic minimum uncertainty for Vega in

the IR.Because them ore recent K unucz LTE m odels have realistic line proles, narrow band comparisons of the 1991 vs. 2003 K unucz m odels can dier by larger factors, if an absorption line is an important contributor to the average ux over the bandpass.

Future work on Vega model atmosphere calculations might solve the discrepancies below 4100 A (see Section 5) and could also result in a cooler Te than used by K urucz (2003). The 2% IR uncertainty for the Vega modeling e ort is not applicable to the pure hydrogen W D calibrations, where lack of m etal line absorption and higher Te result in low er dispersion between the possible W D IR ux distributions below 2 m. Above 2 m, di erences between LTE and NLTE model atm ospheres for the hottest W D G 191B 2B exceed 2% (Bohlin 2003). Because NLTE models for the hot W Ds are brighter in the IR compared to the visible, a NLTE model for Vega m ight improve the agreem ent with the IR absolute ux determ inations.

The use of a model to represent the \mathbb{R} ux from Vega does not produce an ideal standard star. Cohen et al. (1992) utilize Sirius as their only primary standard beyond 17 m because of Vega's disk of cold dust. Furtherm ore, Gulliver, Hill, & Adelm an (1994) point out that Vega is a pole-on rapid rotator. K unucz tuned his Vega m odel to the average visible spectrum. However, the hot poles em it more in the UV; the cooler equator has more ux in the \mathbb{R} ; and the averages in the UV and \mathbb{R} m ay be appropriate to di erent models. A com posite average of K unicz models for T_e = 9300 K at the equator to 9620 K at the pole has been constructed by Hill, Gulliver, and Adelm an (1996) and is currently being updated by Gulliver (private communication). Hopefully, the composite model will be brighter in the UV and IR relative to 5556 A and will t the absolute ST IS spectrophotom etry and the absolute ux m easurem ents better, while m aintaining the sam e 5556 A surface brightness as the 9550K m odel that produces the excellent agreem ent with the H anbury Brown angular diam eter.

Sirius is a slow rotator and easier to model, because one model should tall wavelengths. ST IS observations of Sirius should be made to test whether the K urucz (2003) model for Sirius and its observed

ux agree better than for the Vega case. In addition, m ore high precision IR absolute ux m easurem ents should be m ade relative to pedigreed laboratory light sources.

7. SUMMARY

As a result of the ST IS observations of Vega, a V m ag of 0.026 is established for the improved bandpass function of Cohen et al. (2003b). The Kurucz (2003) m odel of Vega agrees so well with the ST IS observations that the m odel itself de nes the standard star uxes longward of 4200A. These im provem ents, com bined with the more realistic bandpass function that is used to translate the V m agnitudes of the W D standards into relative uxes, have resulted in W D uxes that are uniform by 0.5% fainter than found by Bohlin (2000). The WD standard starm odel ux distributions must be updated in the CALSPEC archive, along with the new Vega spectrum. Because these les have not been updated since 00Apr4, the changes quanti ed by Bohlin (2003) as a function of wavelength for the switch from LTE to NLTE are also included in the new *mod*.ts les. The updates for the CAL-SPEC secondary ux standards are being prepared and will re ect the above changes plus a number of new ST IS observations, better corrections for the changes with time and temperature, and improved

CTE corrections for the CCD data. In addition, a suite of N ICM OS grism calibration observations are being obtained to resolve the IR di erences between the pure hydrogen W Ds and the solar analogs and to extend the HST spectrophotom etric coverage to 2.5 m. Unfortunately, Vega is too bright for N IC - M OS grism observations.
