### O xygen and nitrogen abundances in nearby galaxies

Correlations between oxygen abundance and m acroscopic properties

Abstract. We perform ed a compilation of more than 1000 published spectra of H ii regions in spiral galaxies. The oxygen and nitrogen abundances in each H ii region were recomputed in a hom ogeneous way, using the P {m ethod. The radial distributions of oxygen and nitrogen abundances were derived. The correlations between oxygen abundance and macroscopic properties are examined. We found that the oxygen abundance in spiral galaxies correlates with its lum inosity, rotation velocity, and m orphological type: the correlation with the rotation velocity m ay be slightly tighter. There is a signi cant di erence between the lum inosity { m etallicity relationship obtained here and that based on the oxygen abundances determ ined through the R<sub>23</sub> (calibrations. The oxygen abundance of NGC 5457 recently determ ined using direct measurements of Te (Kennicutt, Bresolin & Garnett 2003) agrees with the lum inosity { metallicity relationship derived in this paper, but is in con ict with the lum inosity { metallicity relationship derived with the R $_{23}$ -based oxygen abundances. The obtained lum inosity { m etallicity relation for spiral galaxies is compared to that for inregular galaxies. Our sample of galaxies shows evidence that the slope of the 0/H { M  $_{\rm B}$  relationship for spirals ({0.079 0.018) is slightly more shallow than that for irregular galaxies ({0.139 0.011). The e ective oxygen yields were estimated for spiral and irregular galaxies. The elective oxygen yield increases with increasing lum inosity from M  $_{\rm B}$ 11 to M B 18 (or with increasing rotation velocity from  $V_{rot}$  10 km s<sup>1</sup> to  $V_{rot}$  100 km s<sup>1</sup>) and then remains approximately constant. Inregular galaxies from our sam ple have e ective oxygen yields low ered by a factor of 3 at maximum, ie. irregular galaxies usually keep at least 1/3 of the oxygen they m anufactured during their evolution.

### 1. Introduction

Investigating the m acroscopic properties of galaxies that could drive their chem ical evolution is very important in understanding their global evolution, which has been the goal of m any studies over the past twenty years. It has been found, for example, that the properties of H ii regions in late-type galaxies are linked to m acroscopic characteristics of galaxies such as lum inosity or H ubble type. Sm ith (1975) concluded that excitation di erences am ong the H ii regions of Sbc{Scd{Irr galaxies can be best understood in term s of an abundance sequence which progresses from higher to low erheavy-elem ent enrichm ent as one progresses from earlier to later type galaxies. He also noted that his results show no apparent correlation between the average heavy-elem ent abundance and galaxy m ass. The correlation between oxygen abundance and the morphological type of galaxy was later con med by Vila-Costas & Edmunds (1992) and Zaritsky, Kennicutt & Huchra (1994).

Lequeux et al. (1979) revealed that the oxygen abundance correlates with totalgalaxy m ass for irregular galaxies, in the sense that the higher the total m ass, the higher the heavy element content. Since the galaxy m ass is a poorly known parameter, the m etallicity { lum inosity relation instead of the m ass { m etallicity relation is usually considered (Skillman, Kennicutt & Hodge (1989); Richer & McCall (1995); Hunter & Ho m an (2000); P ilyugin (2001c); M elbourne & Salzer (2002), am ong others).G arnett & Shields (1987) found that spiraldisk abundance also correlates very well with galaxy lum inosity. T hey concluded that the m etallicity of galaxies correlates better with galaxy lum inosity than with m orphological type.Zaritsky, Kennicutt & Huchra (1994) found that the characteristic gas-phase abundances and lum inosities of spiral galaxies are strongly correlated, and this relationship m apsalm ost directly onto the lum inosity { m etallicity relationship of irregular galaxies.

The origin of this correlation is open to debate. It is widely suggested that there are two mechanisms which can be responsible for a lum inosity { metallicity relation for spirals and irregulars: higher astration level and decreasing e ciency of heavy-element loss with increasing lum inosity. The mass exchange between a galaxy and its environm ent can alter the relation between oxygen abundance and gas mass fraction; it m in ics the variation in the oxygen yield. To investigate the possibility of a varying yield, Edmunds (1990) and Vila-Costa & Edmunds (1992) have suggested to use the \e ective" oxygen yield, ye, as the yield that would be deduced if a system was assum ed to behave as in the sim plest model of chem ical evolution. The variation of the value of the e ective oxygen yield from galaxy to galaxy can be considered as indicative of the e ciency of mass exchange between galaxies and their environm ents. A sim ilar approach, the concept of the oxygen abundance de ciency in the galaxy which is introduced as a de ciency of the oxygen abundance observed in the galaxy in comparison with the oxygen abundance predicted by the closed-box m odel for the sam e gas m ass fraction, has been used by Pilyugin & Ferrini (1998; 2000a,b). The e ective oxygen yields for a set of spiral and irregular galaxies were derived recently by Garnett (2002). He found that the value of e ective oxygen yield is approximately constant,  $y_e = 0.0112$ , for  $V_{rot} > 150$ km s<sup>1</sup>. The e ective oxygen yield decreases by a factor of 10 { 20 from  $V_{rot}$  300 km s<sup>1</sup> to 5. This means that low -m ass galaxies have lost the bulk of their manufactured oxygen, up to  $90 \{ 95\% \}$ .

A courate abundance determ inations are m and atory for such investigations. In H ii regions, they can be derived from measurements of temperature-sensitive line ratios, such as [0 III] 4959,5007/[0 III] 4363.Unfortunately, in oxygen-rich H ii regions, the tem perature-sensitive lines such as [0 III] 4363 are often too weak to be detected. For such H ii regions, abundance indicators based on m ore readily observable lines were suggested (Pagelet al. 1979; A lloin et al. 1979). The oxygen abundance indicator R<sub>23</sub> = ([0 II] 3727,3729 + [0 III] 4959,5007)/H, suggested by Pagel et al. (1979), has found widespread acceptance and use for the oxygen abundance determ ination in H ii regions where the tem perature-sensitive lines are undetectable. G rids of photoionization m odels are often used to establish the relation between strong oxygen line intensities and oxygen abundances (Edm unds & Pagel1984; M cC allet al. 1985; D op ita & E vans 1986; K obulnicky et al. 1999; Kewley & Dopita 2002; am ong others). Radial distributions of oxygen abundance determ ined with theoretical (orm odel) calibrations have been obtained for large sam ples of spiral galaxies by Vila-Costas & Edmunds (1992), Zaritsky et al. (1994), van Zee et al. (1998), Considere et al. (2000), am ong others.

The early calibrations were one-dimensional (Edm unds & Pagel1984; M cCallet al. 1985; Dopita & Evans 1986; Zaritsky et al. 1994), i.e. a relation of the type O = H =f (R<sub>23</sub>) was used. It has been shown (Pilyugin 2000; 2001a,b) that the error in the oxygen abundance derived with the one-dimensional calibrations involves a system atic error. The origin of this system atic error is evident. In a general case, the intensity of oxygen emission lines in spectra of H ii regions depends not only on the oxygen abundance but also on the physical conditions (hardness of the ionizing radiation and geometrical factors) in the ionized gas. Thus, when one estimates the oxygen abundance from em ission line intensities, the physical conditions in H ii regions should be taken into account. In the T $_{\rm e}$  { method this is done via the electron tem perature T<sub>e</sub>. In one-dimensional calibrations the physical conditions in H ii regions are ignored. Starting from the idea of M cG augh (1991) that the strong oxygen lines contain the necessary inform ation for determ in ining accurate abundances in (low-metallicity) H ii regions, it has been shown (Pilyugin 2000; 2001a,b) that the physical conditions in H ii regions can be estimated and taken into account via the excitation parameter P.A two-dimensional or parametric calibration (the so-called \P { method") has been suggested. A more general relation of the type  $O = H = f(P; R_{23})$  is used in the P { method, compared with the relation of the type  $O = H = f(R_{23})$  used in onedimensional calibrations. Thus, the one-dimensial  $R_{23}$  { calibration provides more or less realistic oxygen abundances in high-excitation H ii regions, but yields overestim ated oxygen abundances in low -excitation H ii regions. This is in agreement with the results of Kinkel & Rosa (1994), Castellanos et al. (2002), Kennicutt, Bresolin & Gamett (2003), Gamett, Kennicutt & Bresolin (2004), who found that the  $R_{23}$  { method yields overestim ated oxygen abundances in high-m etallicity H ii regions.

It should be stressed that "strong lines { oxygen abundance" calibrations do not form an uniform fam ily. The calibrations of the st type are the empirical calibrations, established on the basis of H ii regions in which the oxygen abundances are determined through the  $T_e$ { method. Two-dimensional empirical calibrations both at low and high metallicities were recently derived by Pilyugin (2000; 2001a,c). The calibrations of the second type are the theoretical (or model) calibrations, established on the basis of the grids of photoionization m odels of H ii regions. The two-dimensional theoretical calibrations were recently proposed by Kobulnicky et al. (1999) and Kewley & Dopita (2002). It has been shown (Pilyugin 2003b) that there is a discrepancy between the oxygen abundances in high-m etallicity H ii regions determ ined with the T<sub>e</sub> { method (and/or with the corresponding "strong lines { oxygen abundance" calibration) and that determ ined with the model tting (and/or with the corresponding "strong lines { oxygen abundance" calibration). Thus, so far, there actually exist two scales of oxygen abundances in H ii regions. The rst (em pirical) scale corresponds to the oxygen abundances derived with the T  $_{\rm e}$  {

m ethod or w ith empirical calibrations (the P  $\{ m \text{ ethod} \}$ . The second (theoreticalorm odel) scale corresponds to the oxygen abundances derived through m odel tting or w ith theoretical (m odel) calibrations.

Pilyugin (2003b) suggested to use the interstellar oxygen abundance in the solar vicinity, derived with very high precision from the high-resolution observations of the weak interstellar O I 1356 absorption line tow ards the stars, as a \R osetta Stone" to make a choice between "theoretical" and "em pirical" scales of oxygen abundances in high-m etallicity H ii regions. The agreem ent between the value of the oxygen abundance at the solar galactocentric distance traced by the abundances derived in H ii regions through the T<sub>e</sub> { m ethod and that derived from the interstellar absorption lines tow ards the stars is strong evidence that the classical  $T_e$  { m ethod provides accurate oxygen abundances in H ii regions, i.e. the "em pirical" scale of oxygen abundances in high-m etallicity H ii regions is correct. Therefore, at high m etallicities the "strong lines { oxygen abundance" calibrations must be based on the H ii regions with the oxygen abundances derived through the  $T_e$  { method but not on the existing grids of models for H ii regions.

The usual quantities: the oxygen and nitrogen abundance distributions in galaxies (Sect. 2), the correlations between oxygen abundance and m acroscopic properties of galaxies (Sect. 3 and Sect. 4), and the estimation of effective oxygen yields and their variations among galaxies (Sect. 5) will be considered in this paper.

W hat is the novelty of our study? All previous investigations of these problem swere carried out with the R23based oxygen abundances. Let us refer to the recent analysis and conclusion of B. Pagelwho is the foundator of the R<sub>23</sub> { calibrations:\Starting from around 1980, the notorious R<sub>23</sub> m ethod has been the m ost w idely used m ethod for the oxygen abundance determ ination. Investigations since then have shown that our calibrations have overestim ated oxygen abundances near solar. There is som e prom ise in new ly developed strong-line indices and especially in renem ents of the R<sub>23</sub> m ethod (P { calibration).Untilm ore of these re nem ents have been applied, abundances near and above solar have to be taken with a grain of salt" (Pagel2003). For the present study, the oxygen and nitrogen abundances for a large sam ple of H ii regions in latetype galaxiesw ill be derived using a hom ogeneousm ethod: the two-dimensional calibration (P { method). In Sect. 6, the oxygen abundances obtained here will be compared with the recently derived T<sub>e</sub>-based oxygen abundances in the disk of the galaxy NGC 5457 (Kennicutt, Bresolin & Gamett 2003). The O /H {  $M_B$  relationship obtained here with the P-based oxygen abundances will be compared with the  $O/H \{ M_B \text{ relationship obtained recently by}$ G amett (2002) on the basis of oxygen abundances derived through the R<sub>23</sub> { calibrations. The comparison between P-based, Te-based, and R23-based data provides an additional check of the P-based abundances and shows the di erence between the P-based and R 23-based data.

#### 2. The chem ical abundances

# 2.1. The algorithm for oxygen and nitrogen abundances determ ination

The oxygen and nitrogen abundances in H ii regions are derived in the following way.W e adopt a two-zonem odel for the tem perature structure within H ii regions.

As the rst step, the  $(O/H)_P$  oxygen abundance in H ii regions is determ ined with the expression suggested in Pilyugin (2001a)

where  $R_{23}=R_2$  +  $R_3$  ,  $R_2$  =  $I_{[D\ II]\ 3727+\ 3729}=I_H$  ,  $R_3$  =  $I_{[D\ III]\ 4959+\ 5007}=I_H$  , and P =  $R_3/R_{23}$  .

Then, the electron temperatures within the [D III] and [D III] zones are derived. For this purpose the expressions for the oxygen abundance determination from Pagel et al. (1992) and the  $T_e$  ([D III]) {  $T_e$  ([D IIII]) relation from G amett (1992) are used,

where  $n_e$  is the electron density in cm  $^3$  (we assume a constant value of  $n_e$  = 100 cm  $^3$ ),  $t_3$  =  $t_{[O\ III]}$  is the electron temperature within the [O III] zone in units of  $10^4 K$ ,  $t_2$  =  $t_{[O\ III]}$  is the electron temperature within the [D III] zone in units of  $10^4 K$ . The  $t_2$  value is determined from the equation (G armett 1992)

U sing the value of 0 /H derived from Eq.(1) and the m easured em ission line ratios, Eqs.(2) - (6) can be solved for  $t_{[0 \text{ III}]}$  and  $t_{[0 \text{ III}]}$ .

A ssum ing  $t_2 = t_{[N II]} = t_{[O II]}$ , the N/O abundance ratio in H ii regions is determ ined from the expression (P agel et al. 1992)

Then the oxygen (and nitrogen) abundances (O /H ) $_{\rm to}$  can be determined from Eqs.(2)-(7) with  $t_3 = t_p$ . The oxygen abundance (O /H )<sub>to</sub> is in good agreem ent with the value of (O /H )\_P (the dierences between (O /H )\_{t\_P} and (O /H )\_P are usually less than 0.03 dex, see Fig. 12 in Pilyugin 2001a). However, for H ii regions in which most of the oxygen is in the O  $^+\,$  stage, the value of (O /H ) $_{\rm t_P}\,$  is less reliable than the value of  $(O/H)_P$  .

#### 2.2. Central abundances and radial gradients

A compilation of published spectra of H ii regions in latetype galaxies has been carried out. Our list contains more than 1000 individual spectra of H ii regions in 54 latetype galaxies. W e perform ed an extensive com pilation of spectra of H ii regions from the literature but our collection does not pretend to be exhaustive. Only the galaxies with available spectra for at least four H ii regions were taken into consideration. U sing these spectrophotom etric data and the algorithm described in the previous section, the oxygen and nitrogen abundances were derived for our sam ple of H ii regions.

In investigations of the relationships between the oxygen abundances and the macroscopic properties of spiral galaxies, the concept of the characteristic oxygen abundance has been introduced: it is de ned as the oxygen abundance in the disk at a predeterm ined galactocentric distance. Due to the presence of radial abundance gradients in the disks of spiral galaxies, the choice of the characteristic (or representative) value of the oxygen abundance in a galaxy is not trivial. The value of the oxygen abundance at the B-band e ective (half-light) radius of the disk (Gamett & Shields 1987; Gamett 2002), the value of the central oxygen abundance extrapolated to zero radius from the radial abundance gradient (Vila-Costas & Edm unds 1992), the value of the oxygen abundance at  $r = 0.4R_{25}$ , where  $R_{25}$  is the isophotal (or photom etric, or Holmberg) radius, (Zaritsky, Kennicutt & Huchra 1994), and the value of the oxygen abundance at one disk scale length from the nucleus (Garnett et al. 1997), have been used as the characteristic oxygen abundance in a galaxy. To estimate the characteristic oxygen abundance in spiralgalaxies, the radial distribution of oxygen abundances within the galaxies should be established.

The radial oxygen abundance distribution in every galaxy is well tted by the following equation:

where  $12 + \log (0 / H)_0$  is the extrapolated central oxygen abundance,  $C_{0=H}$  is the slope of the oxygen abundance gradient expressed in term s of dex/R  $_{25}$ , and R /R  $_{25}$  is the fractional radius (the galactocentric distance norm alized to the disk isophotal radius).

em ission line ux measurements in the H ii regions is (are) reported in column 7. The list of references to Table 1 is given in Table 2.

The derived radial distributions of the oxygen abundance in galaxies are presented in Figs.1 to 5. The oxygen abundances for individual H ii regions are shown by the

led circles. The linear best ts (derived via the least squares method) to these points are presented by solid lines. The galactocentric distances are norm alized to the isophotal radius.

As in the case of the oxygen abundance, the radial nitrogen abundance distribution in every galaxy is well tted by the following equation:

$$12 + \log (N = H) = 12 + \log (N = H)_0 + C_{N = H}$$

and the radial distribution of the nitrogen to oxygen abundance ratios is well tted by the single equation of the type:

The derived parameters of the nitrogen abundance distributions are presented in Table 3. The name of the galaxy is listed in colum n 1. The extrapolated central 12 +  $\log (N / H)_0$  nitrogen abundance and the gradient (the coe cient C  $_{N=H}$  in Eq.(10)) expressed in terms of dex/R<sub>25</sub> are listed in colum ns 2 and 3. The scatter of nitrogen abundances around the general radial nitrogen abundance trend is reported in colum n 4. The number of available individual spectra of H ii regions in the galaxy with m easured nitrogen em ission line uxes is listed in colum n 5.

The extrapolated central value of the nitrogen-to-oxygen ratio  $\log (N / O)_0$  is listed in column 6. The radial gradient of the nitrogen-to-oxygen abundance ratio (the coefcient  $C_{N=0}$  in Eq.(11)) expressed in terms of dex/R<sub>25</sub> is reported in column 7. The scatter of  $\log (N / O)$  values around the general radial trend is presented in column 8. The nitrogen emission line uxes in the H ii regions were taken from the same sources as the oxygen emission line uxes (see references in Table 1).

The derived radial distributions of the nitrogen abundances and nitrogen-to-oxygen abundance ratios in galaxies are shown in Figs.1 to 5. The nitrogen abundances for individual H ii regions are shown by the open squares. The linear best ts to these points are presented by dashed lines. The nitrogen-to-oxygen abundance ratios for individual H ii regions are shown by the open circles. The linear best ts to these points are presented by solid lines.

For the majority of galaxies, all the H ii regions with available oxygen and nitrogen em ission line m easurem ents were used in the analysis of the abundance gradients. For a few galaxies, however, som e H ii regions were rejected for the following reason. The relationship between oxygen abundance and strong line intensities is double-valued with two distincts parts usually known as the \low er" and \upper" branches of the R<sub>23</sub> { 0 /H relationship. Thus, one has to know apriori on which of the two branches the H ii region lies. The above expression for the oxygen abundance determ ination in H ii regions, Eq.(1), is valid only for H ii regions which belong to the upper branch, with  $12 + \log (O/H)$  higher than 82. It has been known for a long time (Searle 1971; Sm ith 1975) that disks of spiral galaxies show radial oxygen abundance gradients, in the sense that the oxygen abundance is higher in the central part of the disk and decreases with galactocentric distance.W e thus start from the H ii regions in the central part of disks and m ove outward until the radius R where the oxygen abundance decreases to  $12 + \log (O / H)$ 82. It should be noted that it is di cult to establish the exact value of R due to the scatter in oxygen abundance values at any xed radius. An unjusti ed use of Eq. (1) in the determ ination of the oxygen abundance in low-m etallicity H ii regions beyond R would result in overestim ated oxygen abundances, and would produce a false bend in the slope of abundance gradients (Pilyugin 2003a). Therefore,

H ii regions with galactocentric distances larger than R , those with 12+  $\log\left(0\ / \mathrm{H}\right)$  less than 8.2 were rejected. The list of such galaxies is given in Table 4.

The credibility of the radial oxygen abundance gradients (as well as gradients of the nitrogen abundance and gradients of the nitrogen-to-oxygen abundance ratios) is de ned not only by the large number of H ii regions and their sm all dispersion but also by the distribution of these H ii regions along the galactic radius. For exam ple, the six H ii regions in the galaxy NGC 4651 (Fig. 3) give a much m ore reliable value of abundance gradients than the 8 H ii regions in the galaxy NGC 4725 (Fig. 4). The estim ated values of the radial oxygen abundance gradient in galaxies NGC 1068, NGC 1637, NGC 2841, NGC 3521, NGC 4571, NGC 4713, NGC 4725, NGC 5033, and NGC 5055 are not beyond question.

# 3. Characteristic oxygen abundance in spirals as a function of M $_{\rm B}$ , V<sub>rot</sub>, and H ubble type

As was noted above, in investigations of the relationships between the oxygen abundances and them acroscopic properties of spiral galaxies, the concept of the characteristic oxygen abundance has been introduced: it is de ned as the oxygen abundance in the disk at a predeterm ined galactocentric distance. Following Zaritsky, Kennicutt & Huchra (1994), the value of the oxygen abundance at  $r = 0.4R_{25}$  will be used here as the characteristic oxygen abundance in a galaxy. To derive a reliable galaxy luminosity the accurate value of the distance is necessary. The com pilation of the up-to-date distance measurem ents for our sam ple of galaxies is discussed in the Appendix.

The characteristic oxygen abundance in spiral galaxies as a function of absolute blue magnitude M  $_{\rm B}$  is shown in Fig. 6. The solid line is the characteristic oxygen abundance { lum inosity relationship (linear best t derived through the least squares method):

 $12 + \log (O = H) = 6.93 (0.37) 0.079 (0.018) M_B: (12)$ 

The dashed lines correspond to this relation shifted by  $\{0.2 \text{ dex and } + 0.2 \text{ dex}$ . Fig. 6 clearly demonstrates that there is a correlation between the characteristic oxygen abundance of a galaxy and its blue lum inosity. The bulk of the galaxies lies within the band de ned by the dashed lines (0.2 dex around the best t). The dotted line in Fig. 6 is the lum inosity { metallicity relationship for irregular galaxies (see below) extrapolated to the lum inosity range of spiral galaxies. The line presented in Fig. 6 by the plus signs is the extrapolated O/H { M B relationship for irregular galaxies derived by R icher & M cC all (1995). Inspection of Fig. 6 shows that the slope of the derived lum inosity { metallicity relationship for spiral galaxies is low er than the one for irregular galaxies.

We have carried out a search in the literature form easurem ents of rotation velocities for our sample of spiral galaxies.Unfortunately, a measurem ent of the rotation velocity is not available for 7 galaxies of our sample.On the

contrary, there are two orm ore m easurem ents of rotation velocities for a num ber of galaxies. The m ore recent value (or a m ean value if the m easurem ents are close to each other) is taken for these galaxies. The adopted values of the rotation velocity for the galaxies and corresponding reference (s) are listed in Table 5 and Table 6.

The characteristic oxygen abundance in spiral galaxies as a function of rotation velocity  $V_{rot}$  is shown in Fig.7. The solid line is the oxygen abundance { rotation velocity relationship (linear best t)

The dotted lines correspond to this relation shifted by { 0.2 dex and + 0.2 dex. Fig. 7 shows that the characteristic oxygen abundance of a galaxy correlates with its rotation velocity. The deviation of an individual galaxy from the general trend is usually less than 0.2 dex. The m ean value of the scatter in the characteristic oxygen abundances at a given rotation velocity is 0.12 dex for 46 points.

The characteristic oxygen abundance in spiralgalaxies as a function of morphological type, expressed in terms of T-type, is shown in Fig. 8. The solid line is the characteristic oxygen abundance { T relationship (best t)

The dotted lines correspond to this relation shifted by { 0.2 dex and + 0.2 dex. Fig. 8 shows that the characteristic oxygen abundance of a galaxy correlates with its morphological type. The deviation of an individual galaxy from the general trend usually does not exceed the value 0.2 dex, as in the cases of the 0/H { M<sub>B</sub> and the 0/H { V<sub>rot</sub> diagram s. The m ean value of the scatter in the characteristic oxygen abundances at a given morphological type is 0.13 dex for 53 points.

O ne can see that the characteristic oxygen abundance correlates well with both the absolute blue lum inosity, the rotational velocity, and the morphological type; the correlation with the rotation velocity perhaps being slightly tighter.

## 4. Com parison between O/H-M<sub>B</sub> relationship for spiral and irregular galaxies

Zaritsky, Kennicutt & Huchra (1994) found that the characteristic gas-phase oxygen abundance { lum inosity relation of spiral galaxies extends alm ost directly to the lum inosity { metallicity relationship of irregular galaxies. Melbourne & Salzer (2002) and Lam areille et al. (2004)

found that the slope of the oxygen abundance { lum inosity relationship for high-lum inosity galaxies is steeper than when dwarf galaxies are considered alone and may be evidence that the relationship is not linear over the full lum inosity range. G armett (2002) concluded that the metallicity { lum inosity correlation shows a roughly uniform growth in the average present-day O/H abundance over 11 m ag in absolute blue magnitude M  $_{\rm B}$ . Let us com pare the derived metallicity { lum inosity relationship for spiral galaxies with that for irregular galaxies.

The irregular galaxies were selected from the samples of Richer & M cC all (1995) and Pilyugin (2001c). The lum inosities and oxygen abundances for irregular galaxies are taken from these studies and are listed in Cols. 3 and 4 of Table 7. The values of the gas mass fraction in the irregular galaxies were estimated taking into account the atom ic hydrogen mass only since the molecular hydrogen in dwarf irregular galaxies is only a small fraction of the total gas mass. The H i uxes were taken mainly from Karachentsev, Makarov & Huchtmeier (1999). The derived values of gas m ass fraction in irregular galaxies are reported in Col. 5 of Table 7. The rotation velocities for irregular galaxies taken from the literature, the values of the rotation velocity and corresponding references to the sources are listed in Cols. 6 and 7 of Table 7.

The oxygen abundances in spiral and irregular galaxies are plotted versus absolute blue m agnitude M<sub>B</sub> in Fig. 9. The lled circles in Fig. 9 are spiral galaxies, and the solid line is the O/H { M<sub>B</sub> relationship for spiral galaxies, Eq. (12). The open squares in Fig. 9 are irregular galaxies from Table 7. The dashed line is the O/H { M<sub>B</sub> relationship (best t) for irregular galaxies

derived by Richer & M cC all (1995) is presented by the plus signs. Inspection of Fig. 9 (as well as the comparison between Eq. (15), Eq. (16), and Eq. (17)) shows that the O/H { M<sub>B</sub> relationship for our sam ple of irregular galaxies agrees, within the uncertainties, with that from Lee at al. (2003) and from Richer & M cC all (1995). Fig. 9 shows a familiar oxygen abundance { lum inosity correlation for late-type galaxies, an increase in metallicity with lum inosity over the full range of absolute blue magnitude, M<sub>B</sub>

from 22 to 11.C on parison between Eq. (12) and Eq. (15) shows that the O/H { M  $_{\rm B}$  relationships for spiral and irregular galaxies have slightly di erent slopes.

Fig. 10 shows the oxygen abundance in spiral (lled circles) and irregular (open squares) galaxies as a function of rotation velocity  $V_{rot}$ . The most prominent feature is the bend in the O/H {  $V_{rot}$  relation.Gamett (2002) also found that the correlation between O/H and  $V_{rot}$  does not increase steadily but rather turns over for rotation speeds greater than 125 km s<sup>1</sup>. It is worth noting that the presence of the bend in the O/H {  $V_{rot}$  relation does not necessary in ply the existence of a bend in the O/H {  $M_B$  trend.Fig.11 shows the absolute blue magnitude  $M_B$  as a function of the rotation velocity  $V_{rot}$  for spiral (lled circles) and irregular (open squares) galaxies. Inspection of Fig.11 shows that the correlation between M  $_B$  and  $V_{rot}$  is not linear but rather shows a bend. This bend in the

 $0 \ /H \ \{ \ V_{rot} \ trend \ would \ thus occur even if the increase in oxygen abundance with lum inosity can be described by a single linear function over the full magnitude range.$ 

#### 5. The e ective oxygen yields

The observed oxygen abundance in a galaxy is de ned not only by the astration level but also by the mass exchange between a galaxy and its environment. The latter can alter the relation between oxygen abundance and gas mass



fraction; it m in ics the variation in the oxygen yield. To investigate the possibility of a varying yield, it is useful to de ne the \e ective" oxygen yield,  $y_e$ , as the yield that would be deduced if a system was assumed to behave as in the simplest m odel of chem ical evolution (E dm unds 1990; V ila-C osta & E dm unds 1992)

Since we used the oxygen abundances given by number relative to hydrogen, while the value of  $z_0$  in Eq. (18) is given in units of m ass fraction, the conversion for oxygen from G armett et al. (1997) and G armett (2002)

was adopted.

#### 5.1. The gas m ass fractions

The gas fraction in a galaxy is estimated using the following standard relation:

where M  $_{\rm H_{I}}$  is the m ass of atom ic hydrogen in the galaxy, M  $_{\rm H_{2}}$  is the m ass of m olecular hydrogen in the galaxy (both M  $_{\rm H_{I}}$  and M  $_{\rm H_{2}}$  are corrected for the helium and heavy element contribution), L<sub>B</sub> is the blue lum inosity of the galaxy, and k is the m ass-to-lum inosity ratio. The m ass of atom ic hydrogen is derived in a standard way using the m easured H i ux taken from literature and the adopted distance (Table A.1). If the m ass of atom ic hydrogen instead of the H i ux m easurem ent is reported in literature, this value is rescaled to the adopted distance. The atom ic hydrogen m asses expressed in term s of M  $_{\rm H_{I}}/L_{\rm B}$  and corresponding references to the H i ux m easurem ents are listed in Table 5 and Table 6.

The mass of molecular hydrogen can only be estimated with indirect methods. The commonly accepted method is the use of the CO line ux and X conversion factor between the ux in the CO line and the amount of m olecular hydrogen. The conversion factor  $X = N (H_2)/I(CO)$ strongly depends on the physical properties of the interstellar medium which are known to vary from galaxy to galaxy. The best-estim ated values of the conversion factor for a sample of well-studied nearby galaxies span the  $10^{20}$  molom  $^2$  (K km s $^1$ )  $^1$ range 0:6 Х 10 (Boselli, Lequeux & Gavazzi 2002). The high values of the conversion factor correspond to low-lum inosity irregular galaxies, and the low values of the conversion factor are found in spiral galaxies. Then the value of  $X = 1 \quad 10^{20}$ molom  $^2$  (K km s<sup>1</sup>)  $^1$  (including helium and heavy elem ents contribution) is adopted here for spiral galaxies. The molecular gas content is derived with this conversion factor using the measured CO ux from literature and distance (Table A.1). If the mass of molecular hydrogen instead of the CO ux measurement is reported in the literature, this value is rescaled to the adopted distance and adopted conversion factor. The molecular hydrogen m asses expressed in terms of M  $_{\rm H_2}/L_{\rm B}$  and corresponding references to the CO ux m easurem ents are given in Table 5 and Table 6.

The mass of the stellar component of the galaxy is estimated by converting the measured lum inosity to mass via the mass-to-lum inosity ratio. It is dicult to get a reliable estimation of the mass-to-lum inosity ratio for individual galaxies. The and { dependent values will be used here only for exam ination of the general trends of these values with lum inosity and rotation velocity but not for exam ination of individual galaxies. A similar investigation was carried out by G armett (2002). He considered the impact of the choice of the mass-to-lum inosity ratio on the trends by comparing the trends derived with the color-based mass-

to-lum inosity ratio and constant mass-to-lum inosity ratio. G amett (2002) has found that the trends are fairly robust against the choice of mass-to-lum inosity ratio. Based on this conclusion, a constant value of the mass-to-lum inosity ratio k = 1.5 is adopted here for all spiral galaxies, and k = 1 is adopted for all irregular galaxies.

The derived values of the gas m ass fraction in galaxies are listed in Table 5 (C ol. 3). Unfortunately, for several spiralgalaxies on our list no m easurem ent of the CO ux is available. For these galaxies, the gas m ass fraction is based on the atom ic hydrogen m ass only and is a lower limit. Taking into account that the average value is M  $_{H_2}/M_{H_1}$ = 0.14 (B oselli, Lequeux & G avazzi 2002), one can hope that the use of a lower limit instead of the estim ated value of gas fraction for several galaxies is quite acceptable.

The gas mass fraction in spiral galaxies as a function of absolute blue magnitude M  $_{\rm B}$  is shown by the led circles in Fig. 12. The solid line is the gas mass fraction { lum inosity relationship (best t determ ined via the least squares method) for spiral galaxies

C om parison between Eq. (21) and Eq. (22) shows that the {  $M_B$  relationship for spiral galaxies coincides remarkably well with the {  $M_B$  relationship for irregular galaxies. It can also be seen in Fig. 12 that the gas mass fraction { lum inosity relation for spiral galaxies is a direct continuation of the gas mass fraction { lum inosity relationship for irregular galaxies.

#### 5.2. The e ective oxygen yields

The derived elective oxygen yields are presented as a function of absolute blue magnitude M  $_{\rm B}$  in Fig. 13a and as a function of rotation velocity V<sub>rot</sub> in Fig. 13b.

Inspection of Figs.13a,b shows that there is only a hint of trends of the elective oxygen yield with lum inosity and rotation velocity. The form albest to the log ( $y_e$ ) { M  $_B$  relation (solid line in Fig.13a) is

The mean value of the deviation of individual galaxies from the general trend is 0.13 dex. The form all best t (least squares method) to data for spiral galaxies, the log( $y_e$ ) {  $V_{rot}$  relation (solid line in Fig.13b) is

The mean value of the deviation of individual galaxies from the general trend is 0.12 dex. The mean value of the e ective oxygen yield in spiral galaxies is  $y_e = 0.00268$ . The dashed line in Figs. 13a,b corresponds to the mean value of  $y_e$ . Taking into account the large scatter of points

in the log ( $y_e$ ) { M<sub>B</sub> and the log ( $y_e$ ) { V<sub>rot</sub> diagram s, it is di cult to establish mm ly how real are the trends of the e ective oxygen yield in spiral galaxies with lum inosity and rotation velocity. M ore accurate data are needed to con m or reject these trends. Here we can only conclude that the e ective oxygen yield in spiral galaxies remains approxim atively constant.

It is widely accepted that the mass exchange (gas infall and/or galactic wind) between a galaxy and its environment plays a major role in the evolution of galaxies. Gas infall and galactic winds produce a shift of the position of a galaxy in the { 0 /H diagram towards lower oxygen abundances compared to the predictions of the closed-box models (see e.g. M ouhcine & Contini 2002). The location of spiral and irregular galaxies in the { 0 /H diagram together with the predictions of the closed-box m odel

are presented in Fig. 14a.

The solid line in Fig. 14a is the prediction of the closedbox m odel for the evolution of galaxies with oxygen yield  $y_0 = y_e = 0.00268$ . As can be seen in Fig. 14a, the positions of spiral galaxies in the { 0/H diagram are close to the track predicted by the closed-box m odel. The m ean value of the 0/H deviation of the individual galaxies from the closed-box m odel is 0.13 dex. The dashed lines in Fig. 14a correspond to the predictions of the closed-box m odels with oxygen yields y = 1:5 y<sub>0</sub> and y = y<sub>0</sub>/15. The m aprity of spiral galaxies is located within the band de ned by dashed lines.

It is well known that the closed-box model predicts m any m ore low-m etallicity stars than are observed in the solar neighbourhood, the so called  $\G$  {dwarf" paradox. Various versions of the infall model, in which an infall of gas onto the disk takes place for a long time, have been suggested (Tosi 1988a,b; Pagel & Tautvaisiene 1995; Pilyugin & Edmunds 1996a,b; Chiappini, Matteucci & Rom ano 2001; am ong m any others) to explain the observed m etallicity function. An infall m odel has also been applied to other spiral galaxies (D az & Tosi 1986; M olla, Ferrini & D az 1996,1997; Pilyugin et al. 2002; M ouhcine & Contini 2002; Chiappini, Romano & Matteucci 2003). It is thus generally accepted that gas infall can play an in portant role in the chem ical evolution of disks of spiralgalaxies. Therefore, the fact that the positions of spiral galaxies are close to the position of the track of the closedbox model may appear surprising. It has been shown (Pilyugin & Ferrini 1998) that the present-day position of a system in the { 0 /H diagram is governed by its evolution in the recent past and is, in fact, independent of its evolution on long tim escales. Therefore, the fact that the present-day position of spiral galaxies is close to the position of the closed-box model is not in con ict with the model, in which an infall of gas onto disk takes place for a long time (which is necessary to satisfy the observed abundance distribution function and the age { m etallicity relation in the solar neighbourhood) since these observational data re ect the evolution of a system in the distant past. O fcourse, the sim ple m odel of chem ical evolution of galaxies can be used only as the rst-order approximation. To establish a more accurate relation between the presentday values of oxygen abundance and gasm ass fraction in a galaxy, an appropriate m odel of chem ical evolution should be developed (e.g. Pagel & Tautvaisiene 1995).

Inspection of Figs. 13a,b shows that the values of the e ective oxygen yield in irregular galaxies are lower than that in spiral galaxies. The e ective oxygen yield in irregular galaxies shows a clear trend with lum inosity and rotation velocity. The positions of irregular galaxies in the

{ 0 /H diagram are system atically shifted tow ards low er oxygen abundances compared to the predictions of the closed-box model with oxygen yield yo typical for spiral galaxies. This suggests that the mass exchange between a galaxy and its environm ent (galactic winds) plays an im portant role in the chem ical evolution of irregular galaxies. The dotted line in Fig. 14a corresponds to the closed-box models with oxygen yield  $y = y_0/4.0$  nly two irregular galaxies from our sample are located below the dotted line. This implies that irregular galaxies lose only a moderate part of their m anufactured heavy elements. Two facts are im portant: i) the sm ooth variation in gas m ass fraction in spiral and irregular galaxies with lum inosity over the full lum inosity range, ii) the growth of e ective oxygen yield with increasing lum inosity from M<sub>B</sub> {11 to {18 which rem ains approxim ately constant form ore lum inous galaxies. These two facts taken together allow us to suggest

that the di erence in the slopes of the  $0\/H~$  { M  $_{\rm B}~$  relationships for spiral and irregular galaxies is real and that the variation of the e ective oxygen yield with lum inosity is responsible for the bend in the lum inosity { metallicity relationship.

How realistic is the value of the mean oxygen yield derived here for spiral galaxies? Fig. 14b shows the oxygen abundances extrapolated to zero radius in spiral galaxies together with the -0 /H track predicted by the closedbox m odel with the derived oxygen yield. O ne can expect that the central oxygen abundances in the most evolved spiral galaxies correspond to the oxygen abundance when the system had exhausted the gas. As can be seen in Fig. 14b, the upper lim it of the central oxygen abundances in spiral galaxies is close to the oxygen abundances predicted by the model with derived oxygen yield when the gas mass fraction is close to zero. The present-day oxygen abundance at the solar galactocentric distance in our Galaxy is about 12 + log (O /H) = 8.50 as traced by H ii regions (Rodr guez 1999; Caplan et al. 2000; Deharveng et al. 2000; Pilyugin, Ferrini & Shkvarun 2003) and derived from the interstellar absorption lines towards the stars (Meyer, Jura & Cardelli 1998; So a & Meyer 2001), and for the present-day gas m ass fraction, 0.15 { 0.20 appears to be a reasonable value (M alinie et al. 1993). As shown in Fig. 14b, the position of the solar vicinity (large plus sign) is close to the -0 /H track predicted by the closed-box model with derived oxygen yield. Thus, the data in Fig. 14b im ply that the value of the oxygen abundance derived here is quite realistic.

It should be noted that the value of the oxygen yield is derived here on the basis of gas-phase oxygen abundances. Som e fraction of the oxygen is locked into dust grains in H ii regions. M eyer, Jura & Cardelli (1998) obtained a lim it to the dust-phase oxygen abundance in the interstellar m edium in the vicinity of the Sun. A ssum ing various m ixtures of oxygen-bearing grain com pounds, they found that it is di cult to increase the oxygen dust fraction beyond 0.14 dex, sim ply because the requisite m etals are far less abundant than oxygen. E steban et al. (1998) found that the fraction of the dust-phase oxygen abundance in the O rion nebula is about 0.1 dex. Thus, the true value of the oxygen yield is slightly higher than the value obtained here and is around y = 0.003.

#### 6.Com parison with previous studies

How reliable are the results obtained here? How signi cant is the di erence between the P-based and the R<sub>23</sub>-based O/H { M<sub>B</sub> relationships? The validity of the oxygen abundances obtained here can be tested by a comparison with the T<sub>e</sub>-based oxygen abundances determ ined recently in the disk of the galaxy NGC 5457 by K ennicutt, B resolin & G arnett (2003). It is worth noting that the comparison of oxygen abundances derived through the P {m ethod and through the T<sub>e</sub> {m ethod has already been m ade for the galaxy NGC 5457 (Pilyugin 2001b), as well as for the M ilky W ay (Pilyugin, Ferrini & Shkvarun 2003), and

for a sample of star-form ing em ission-line galaxies from the KPNO International Spectroscopic Survey (KISS) (Melbourne et al. 2004). A good agreem ent has been found in all cases. Recently Kennicutt, Bresolin & Garnett (2003) obtained new spectra for a num ber of H ii regions in the disk of the galaxy NGC 5457 and determined the Te-based abundances. They com pared their tem peraturebased abundances with those derived for the sam e H ii regions using di erent calibrations. A coording to their Fig. 14, the validity of the P-based abundances is questionable. The data from Kennicutt, Bresolin & Garnett (2003) have been used here to test the validity of the P { calibration as well as other popular calibrations. To enlarge the com parison we have also included direct abundance measurements of H ii regions in this galaxy from the literature (the compilation of the spectral data was performed by Pilyugin 2001b) as well as direct abundance measurements ofH ii regions in other galaxies (com pilation from P ilyugin 2001a).

Fig. 15a shows the O /H  $_{P}$  { O /H  $_{Te}$  diagram (the analog of Fig.14 from Kennicutt, Bresolin & Gamett 2003). The lled circles are direct abundance measurements of H ii regions in the galaxy NGC 5457 with 12+ logO /H  $_{Te}$  > 8.2 from Kennicutt, Bresolin & Garnett (2003). The led triangles are direct abundance m easurem ents of H ii regions in this galaxy from other authors (com pilation from Pilyugin 2001b) The open squares are direct abundance m easurem ents of H ii regions in other galaxies (com pilation from Pilyugin 2001a). Fig. 15a shows that there is a satisfactory agreem ent between  $O/H_{T_{e}}$  and  $O/H_{P}$  abundances. The origin of the disagreem ent between Kennicutt et al's and our conclusions is evident. The relationship between oxygen abundance and strong oxygen line intensities is double-valued with two distincts parts usually known as the \lower" and \upper" branches of the  $R_{23}$ { 0 /H relationship. The high-m etallicity P { calibration is valid only for H ii regions which belong to the upper branch, i.e. with 12+ log (O /H ) higher than 82.The unjusti ed use of the high-m etallicity P { calibration in the determ ination of the oxygen abundance in low -m etallicity H ii regions results in overestim ated P-based oxygen abundances (Pilyugin 2003a).Our O/H<sub>P</sub> { O/H<sub>Te</sub> diagram (Fig. 15a) show sonly the high-m etallicity H ii regions with 12+ log0 /H<sub>Te</sub> > 82.0 n the contrary, Fig.14 ofK ennicutt, Bresolin & Garnett (2003) also includes low-metallicity H ii regions, with 12+ log (O /H) lower than 8:2. They do not belong to the upper branch, and, as a consequence, the high-m etallicity P { calibration cannot be used in the determ ination of the oxygen abundance in these H ii regions. This is the reason why the low-m etallicity H ii regions in the galaxy NGC 5457 are not presented in our Fig. 15a and are excluded from the analysis above (see Sect.2).

Fig. 15b shows the  $O/H_{ZKH}$  versus  $(O/H)_{T_e}$  diagram for the same sample of H ii regions as in Fig. 15a. The  $O/H_{ZKH}$  abundances are derived using the highm etallicity calibration from Zaritsky, K ennicutt & Huchra (1994). Zaritsky et al.'s calibration is an average of the three calibrations by Edmunds & Pagel (1994), M cC all

et al. (1985), and D opita & E vans (1986), hence this calibration can be considered as \representative" for onedimensional calibrations. Fig. 15c shows the  $O/H_{KKP}$  versus  $(O/H)_{T_e}$  diagram for the same sample of H ii regions as in Fig. 15a. The  $O/H_{KKP}$  abundances are derived using the two-dimensional high-metallicity calibration from K obulnicky, K ennicutt & P izagno (1999). Fig. 15a-c shows that the  $O/H_P$  abundances agree signi cantly better with the  $O/H_{T_e}$  abundances than do the  $(O/H)_{ZKH}$  and  $(O/H)_{KKP}$  abundances.

W e assum e that the tem perature-based abundance is the \true" abundance and that the di erence between, e.g. the P-based abundance and the T<sub>e</sub>-based abundance is due only to the error attached to the P-based abundance. However, the 0 /H  $_{\rm T_e}$  abundances determ ined by Kennicutt, Bresolin & Garnett (2003) in Hii regions of the galaxy NGC 5457 with close galactocentric dis-0:57R<sub>25</sub>) show a large scattances (0:55R<sub>25</sub> Rα ter, from 12+ log (O /H ) $_{T_e}$  = 8.05 for H ii region H 71 to 12+  $\log (O/H)_{T_e} = 8.45$  for H ii region H 128. This m ay be evidence for large uncertainty in  $O/H_{T_e}$  abundances. If this is the case, the uncertainty in the  $0/H_{T_o}$  abundances can make an appreciable contribution to the disagreem ent between the P-based and the T<sub>e</sub>-based abundances.

It is worth noting that the direct comparison of tem perature-based oxygen abundances  $O/H_{Te}$  with those derived with di erent calibrations is a ected by the selection criteria. Indeed, in the high metallicity range, the weak tem perature-sensitive line O [III] 4363 is usually measured in high-excitation H ii regions. It is known that

the disagreem ent between tem perature-based abundances and those derived with one-dimensional R<sub>23</sub> calibrations is lowest for high-excitation H ii regions and is larger for low -excitation H ii regions, while the P {based abundances agree with the T<sub>e</sub> {based abundances both for high { and low {excitation H ii regions. Since the two-dim ensional calibration of Kobulnicky, Kennicutt & Pizagno (1999) converts, in fact, into one-dimensional calibration at high m etallicities, one can expect that the mean value of the disagreem ent between  $O/H_{KKP}$  and  $(O/H)_{T_{o}}$  abundances is larger than for the sam ple of high-excitation H ii regions in Fig. 15c. This statem ent can be checked through com paring the radial gradients traced by oxygen abundances derived using di erent methods. This also provides additional veri cation of the validity of oxygen abundances derived through di erent m ethods.

The O /H $_{T_e}$  abundances versus galactocentric distance for the galaxy NGC 5457 are shown in Fig. 16a. The small led circles are the data from Kennicutt, Bresolin & Gamett (2003). The best t to these data

is shown by the solid line. The open circles are 0 /H $_{\rm T_e}$  abundances from other authors (com pilation from Pilyugin 2001b).The best t to all data

is shown by the dashed line. Fig. 16a, as well as the comparison between Eq. (26) and Eq. (27), shows that the  $O/H_{T_e}$  abundances from K ennicutt, B resolin & G armett (2003) are slightly shifted towards lower abundances compared to those from other authors.

Fig.16b shows the oxygen abundances derived here using the P (calibration for a large (65) sample of H ii regions with  $R_q > 0.6R_{25}$ . The least squares t to these data

is shown in Fig. 16b by the dashed line. The O /H<sub>Te</sub> { R<sub>g</sub> relationship of K ennicutt, B resolin & G arnett (2003) is shown by the solid line. Fig. 16b, as well as the comparison between Eq. (26), Eq. (27) and Eq. (28), shows that there is a very good agreem ent, both in the zero point and slope, between the radial O /H<sub>Te</sub> abundance gradient and the O /H<sub>P</sub> abundance gradient in the disk of the galaxy NGC 5457.

Fig. 16c shows the radial distribution of the O /H<sub>K K P</sub> abundances, derived using the high-m etallicity calibration from K obulnicky, K ennicutt & Pizagno (1999), for the sam ple of H ii regions from Fig. 16b. The least squares t to these data

is shown in Fig. 16c by the dashed line. The O /H<sub>Te</sub> { R<sub>g</sub> relationship of K ennicutt, B resolin & G amett (2003) is shown by the solid line. Fig. 16c, as well as the comparison between Eq. (26), Eq. (27) and Eq. (29), clearly show s that the central oxygen abundance in NGC 5457, derived using the calibration from K obulnicky, K ennicutt & P izagno (1999), is overestimated (by a factor 2) in comparison with the one derived with the T<sub>e</sub> and P {m ethods. The slopes of the (O /H)<sub>Te</sub>-based and the (O /H)<sub>R23</sub>-based gradients are signi cantly di erent.

A coording to G armett et al. (1997), the radial oxygen abundance gradient within the disk of NGC 5457 with oxygen abundances derived through the  $R_{23}$  (calibration is

C om parison between Eq. (26), Eq. (27) and Eq. (30) clearly shows that the central oxygen abundance in NGC 5457, derived using the R<sub>23</sub> calibration, is overestim ated (by a factor 2) in comparison with the one derived with the T<sub>e</sub> and P {m ethods. The slopes of the (O /H)<sub>Te</sub>-based and the (O /H)<sub>R<sub>23</sub></sub>-based gradients are signi cantly di erent.

There is thus a very good agreem ent, both in the zero point and slope, between the radial O /H<sub>T<sub>e</sub></sub> abundance gradient and the O /H<sub>P</sub> abundance gradient within the disk of the galaxy NGC 5457. For radial distributions of abundances derived with other calibrations, both the central oxygen abundances and the slopes do not agree with (O /H)<sub>T<sub>e</sub></sub>-based values. This strongly supports our claim that the O /H<sub>P</sub> abundances are signi cantly m ore realistic than abundances derived with other calibrations.

The temperature-based characteristic oxygen abundance in the galaxy NGC 5457 can also be used as the "Rosetta Stone" to test the validity of the O /H  $\{M_B re$ lationship obtained here. The characteristic oxygen abundance as a function of absolute blue magnitude M  $_{\rm B}\,$  for our sample of spiral galaxies is presented in Fig. 17. The positions of individual galaxies (points) and the O/H {  $M_{\rm B}$  relationship (solid line) are the same as in in Fig. 6. The dashed lines correspond to the lines shifted by  $\{0.2\}$ dex and + 0.2 dex along the vertical axes relatively to the derived O /H { M B relationship. The oxygen abundances in the galaxy NGC 5457 are presented by the open circle (O /H at  $R = 0.4R_{25}$ ) and open square (O /H at the disk half-light radius). The line shown by plus signs in Fig. 17 is the lum inosity { m etallicity relathionship for spiralgalaxies obtained by G amett (2002). Fig. 17 shows that there is a large di erence between the lum inosity { m etallicity relationship derived here and that from G arnett (2002). The main reason of this discrepancy is due to the fact that our lum inosity { metallicity relationship is based on the oxygen abundances derived through the P { calibration while G amett has used oxygen abundances derived through the R<sub>23</sub> {calibrations. The recent results on the oxygen abundance determ ination in the disk of the well-studied spiral galaxy NGC 5457 (M 101) provide a possibility to check the credibility of these relationships. Kennicutt, Bresolin

& G amett (2003) derived the radial distribution of the oxygen abundance in the disk of NGC 5457, traced by the H ii regions with oxygen abundances derived with the classical  $T_e$  { m ethod. The characteristic oxygen abundance (as adopted here the oxygen abundance at  $R = 0.4R_{25}$ ) in the galaxy NGC 5457 is presented by the open circle in Fig. 17. It is evident that the  $T_e$ -based characteristic oxygen abundances in the galaxy NGC 5457 are in con-

ict with Gamett's lum inosity { metallicity relationship but agree with our lum inosity { metallicity relationship. It is not suprising since it was shown above that there is a very good agreem ent, both in the zero point and slope, between our P-based oxygen abundance distribution, Eq. (28), and the  $T_e$ -based oxygen abundance distribution, Eq. (26), of Kennicutt, Bresolin & Gamett (2003), while the  $R_{23}$ -based oxygen abundance distribution, Eq. (30), of Gamett et al. (1997) is quite di erent. It should be noted that Gamett (2002) used the oxygen abundances at the disk half-light radius to built the lum inosity { metallicity relationship.C an this make a signi cant contribution to the deviation of the characteristic oxygen abundance in the galaxy NGC 5457 from the lum inosity { metallicity relationships based on oxygen abundances at the disk half-light radius? Based on Garnett's conclusion: \for com parison, I include results based on using the value of 0 /H at one disk scale length; this change has little e ect on the overall results", one can expect that the di erence in the choice of the \characteristic" radius plays a minor role.For veri cation and illustration, the T<sub>e</sub>-based oxygen abundance in the galaxy NGC 5457 at the disk half-light radius (equal to 1.685 tim es the exponential scale length) is obtained and presented in Fig. 17 by the open square. Fig. 17 shows that using the characteristic oxygen abundance at  $R = 0:4_{25}$  in the galaxy NGC 5457 instead of the value of 0 /H at the disk half-light radius has little effect on the overall result. Thus, the Te-based characteristic oxygen abundances in the galaxy NGC 5457 are in con ict with the lum inosity { metallicity relationship derived by Gamett (2002) with the R<sub>23</sub>-based oxygen abundances, but agree with our lum inosity { metallicity relationship derived with the P-based oxygen abundances.

### 7.Conclusions

W e perform ed a com pilation of more than 1000 published spectra of H ii regions in 54 spiral galaxies. The oxygen and nitrogen abundances in each H ii region were recom puted in a hom ogeneous way, using the P {m ethod. The radial distributions of the oxygen abundances, nitrogen abundances, and nitrogen-to-oxygen abundance ratios were derived. The param eters of the radial distributions (the extrapolated central intersect value and the gradient) are listed.

The correlations between oxygen abundance and m acroscopic properties of galaxies are exam ined. The oxygen abundance in the disk of a galaxy at  $r = 0.4R_{25}$ , where  $R_{25}$  is the isophotal radius, is used as a characteristic (or representative) oxygen abundance for spiral galaxies. We

found that the oxygen abundance in spiral galaxies correlates with its lum inosity, rotation velocity, and m orphological type: the correlation with the rotation velocity m ay be slightly tighter.

There is a signi cant di erence between the lum inosity { metallicity relationship derived here and that based on the oxygen abundances derived through the R<sub>23</sub> { calibrations. The  $T_e$ -based characteristic oxygen abundances in the galaxy NGC 5457 (K ennicutt, B resolin & G arnett 2003) agree with our lum inosity { metallicity relationship derived with the P-based oxygen abundances but is in conject with the lum inosity { metallicity relationship derived by G arnett (2002) with the R<sub>23</sub>-based oxygen abundances.

The derived lum inosity { m etallicity relation for spiral galaxies is compared to that for irregular galaxies. W e found that the slope of the oxygen abundance { lum inosity relationship for spirals is slightly m ore shallow than the one for irregular galaxies.

The e ective oxygen yields were derived for spiral and irregulargalaxies.W e found that the e ective oxygen yield increases with increasing lum inosity from M<sub>B</sub> 11 to 18 (or with increasing rotation velocity from М<sub>в</sub> 10 km s  $^{1}$  to V<sub>rot</sub> 100 km s  $^{1}$  ) and then remains V<sub>rot</sub> approxim ately constant. Irregular galaxies from our sam ple have e ective oxygen yields low ered by a factor of 3 at maximum, i.e. irreqular galaxies usually retain at least 1/3 of the oxygen they manufactured during their evolution. From the comparison between the elective oxygen yields for spiral and irregular galaxies (with R23-based oxygen abundances in spiralgalaxies), G amett (2002) found how ever that an irregular galaxy can lose up to 90% 95% of the oxygen m anufactured.

#### Appendix A:D istances and lum inosities

To derive a reliable galaxy lum inosity, an accurate value of the distance is necessary. Over the past decade, great progress has been made in accurate distance measurements for galaxies using many dierent methods. Therefore, we have performed a thorough literature search for distance information to determ ine the most reliable, up-to-date distances for our sam ple.

The Cepheid period { lum inosity relation remains the m ost useful m ethod for estimating the distance of galaxies. Anothere cient tool is the lum inosity of the tip of the red giant branch (TRGB) stars. One of the m ost prom ising distance indicators is believed to be the peak brightness of type Ia supernovae (SN e Ia). The supernovae of type II (SN e II) are also reliable distance indicators; the m ethod of distance determ ination is based on m odels of the expanding photospheres of SN e II (EPM). The planetary nebula lum inosity function (PNLF) is a reliable distance indicator for galaxies potentially as far away as 25 M pc. Surface brightness uctuations (SBF) have emerged as a reliable distance indicator. The classic m ethod of distance m easurem ents via the lum inosity of the brighest blue and red supergiants (BBSG and BRSG) has been widely used over last decade. The Tully-Fisher (TF) relation, or \lum inosity{rotation velocity" relation, is the m ost com m only applied distance indicator for spiralgalaxies at the present tim e. There are di erent versions of the TF relation: the lum inosity in di erent bands can be used in the TF relation, and the CO linew idth instead of the H i linew idth can be used as the tracer of rotation velocity.

The important point is that the TRGB, SN Ia, PN LF, SBF, BRSG, and TF m ethods request a calibration. The Hubble Space Telescope Key Project on the Extragalactic D istance Scale has provided Cepheid distances to more than 20 galaxies, in addition to the existing ground-based Cepheid distances to about 10 galaxies. This data set constitutes a solid basis for calibrating other distance indicators (Ferrarese et al. 2000). It should be noted, how ever, that some uncertainty in the Cepheid distances still remains, due to uncertainties in the slope and zero point of the Cepheid period { lum inosity relation (see discussion in Ferrarese et al. 2000; Freedm an et al. 2001; am ong others). Therefore, the slightly di erent values of the Cepheid distance to a given galaxy have been derived by di erent authors using the same observational data. As a result, there is som e disagreem ent in the literature on the magnitudes of other standard candles. For example, two recent calibrations of the peak absolute m agnitude of SN e Ia, based on the SNe Ia events in galaxies with known Cepheid distances result in slightly di erent magnitudes: М<sub>в</sub> = 19:56 (Parodiet al. 2000) and  $M_{\rm B}$  = 19:32 (Gibson & Stetson 2001). The method based on modeling the expanding photospheres of SN e II is a "physicalmethod" and is hence completely independent of the calibration of the local distance scale. The EPM distances agree with the Cepheid distances within around 10% (Eastman, Schmidt & Kirshner 1996; Leonard et al. 2002a). Since system atic uncertainty clearly remains at the 10% level for Cepheid and at the 10{20% level for EPM, it is not clear whether the observed discrepancy is signi cant (Leonard et al. 2002a).

The most important point to take into account when com paring di erent m ethods of distance determ ination is their accuracy. The relative C epheid distances are deter-5% (Freedman et al. 2001). A typical accum ined to racy of the TRGB distances is 12% (Karachentsev et al. 2003a, b). A coording to Parodiet al. (2000), the SN e Ia are the best standard candles known so far, with a lum inosity scatter of less than 0.25 m ag. The EPM distances agree with the Cepheid distances within 10% (Eastman, Schmidt & Kirshner 1996; Leonard et al. 2002a). There is also a good agreem ent between PNLF and Cepheid distances over two orders of magnitude in the derived distances (Feldmeier, Ciardullo & Jacoby 1997). The SBF distance measurem ents rely on the empirical calibration of absolute uctuation amplitudes. A relative accuracy of

10% in extragalactic SBF distances can be reached, provided that the galaxy color is well known (Jensen et al.

2003).D istance m oduliderived with the BBSG and BRSG method have typical errors of 0.4 { 0.5 m ag (D rozdovsky & Karachentsev 2000). Solanes et al. (2002) have exam ined the TF distancem oduli of spiral galaxies in the region of the Virgo cluster taken from eight published datasets and have found a dispersion of 0.41 m ag. Tutui & Sofue (1997, 1999) have analysed H iand CO TF m ethods. They concluded that the errors in the H i TF distances can be especially large in the case of interacting galaxies since the H i linew idth m ay be strongly disturbed by galaxy { galaxy interaction and m ay not re ect correctly the rotation velocity of the galaxy. The method of \sosie galaxies" (look-alike galaxies) is a particular application of the TF method which avoids some practical problems (Paturel 1984; Terry, Paturel & Ekholm 2002). The distances derived with the \sosie galaxies" m ethod appear to be m ore reliable than those obtained with the direct TF relation.

Typically, two or more distance estimations for a galaxy from our sample are available in the literature. Examination of available distances con ms that the Cepheid, EPM, SBF, SN Ia, PN LF, and TRGB methods provide accurate distance determ inations. Estim ations of distances with two ormore of these methods exist for 14 galaxies from our sample. The deviation of individual distance estimations from the mean value is usually less than 10%. These m ethods will be referred to as \high-precision" methods below. The agreement between the TF (and BBSG, BRSG) distances and distances derived with the high-precision methods is appreciably worse. Moreover, the TF distances derived by di erent authors for the sam e galaxy can show a signi cant scatter. Taking these facts into account, the adopted value of the distance for a galaxy is chosen in the following way. If the distance derived with the \high-precision" method (s) is available, this distance is adopted. If only the TF and/or BBSG, BRSG distances are available, the mean value is adopted. If a galaxy is a member of compact group, the information on the distances to other m em bers of the group is used to check the distance. We have to adopt the redshift (H $_0$ ) distances for three galaxies (NGC 3344, NGC 5068, and IC 5201) from our sample due to the lack of other reliable distance estimations.

#### Here are som e com ments on individual galaxies.

NGC 628. { There is no distance to NGC 628 determ m ined w ith one of the high-precision" m ethods. How ever, the available distances to NGC 628 derived with the m ethod of brightest stars seem to be quite reliable. F irstly, the distances derived from two di erent investigations are in agreement: 7.24 Mpc (Sohn & Davidge 1996) compared to 7.32 Mpc (Sharina, K arachentsev & T ikhonov 1996). Secondly, the distance m oduli estim ated by Sharina, K arachentsev & T ikhonov (1996) for four galaxies in the group of NGC 628 have a m ean value of 7.80 Mpc with a sm all scatter. As noted by Sharina, K arachentsev & T ikhonov (1996), if a group contains a su cient number of irregular galaxies, the \brightness stars" m ethod m akes it possible to m easure the distance

to the group with alm ost the same accuracy as with the C epheid m ethod.

NGC 753. { The galaxy NGC 753 belongs to the P isces lam ent.The TF distances of several dozens of galaxies of this lam ent lie between 50 M pc and 80 M pc (Tully & P ierce 2000).The TF distance (49.30 M pc) of NGC 753 from Russel (2002) is adopted here.

NGC1068. { Two values of TF distances to NGC1068 show an appreciable discrepancy: 12.45 M pc (Schoniger & Sofile 1994) compared with 18.10 M pc (Takam iya & Sofile 2000). The galaxy NGC1068 is a member of the LGG73 group (Garcia 1993). A distance of 16.07 M pc to the galaxy NGC1055 (also a member of LGG73 group) was estimated by Paturel et al. (1998) using the method of \sosies galaxies". The mean TF distance of 15.30 M pc is con med by the Paturel et al.'s data and is adopted here.

NGC 2442. { There is no reliable distance determ ination for NGC 2442. This galaxy is a mem ber of the LGG 147 group (Garcia 1993). The distance to another mem ber (NGC 2434) of this group has been determ ined with the SBF method and is equal to 21.58 M pc (Tonry et al. 2001). This value is adopted as distance to NGC 2442.

NGC 2805. { There is no reliable distance determ ination for NGC 2805. This galaxy is a mem ber of the LGG 173 group (Garcia 1993). The distance to another member (NGC 2880) of this group has been determ ined with the SBF method and is equal to 9.77 Mpc (Tonry et al. 2001). This value is adopted as distance to NGC 2805.

NGC 2835. { Dierent distance values to NGC 2835 were used recently: 10.76 Mpc (Elmegreen & Salzer 1999) and 6.03 Mpc (Larsen & Richtler 2000). The TF distance to NGC 2835 is 9.80 Mpc (Russel 2002). The galaxy NGC 2835 is a member of the LGG 172 group (Garcia 1993). The distance to NGC 2784 (a member of the LGG 172 group) has been determ ined with the SBF method and is equal to 9.82 Mpc (Tonry et al. 2001). This value is adopted as distance to NGC 2835.

Virgo galaxies. { W e chose individual distance estim ations to Virgo galaxies in the same way as in the case of eld galaxies. If the distance estimation with one of the \high-precision" methods is available, this distance is adopted. O therw ise the distance is derived by averaging the available TF distances. The distances of V irgo galaxiesNGC4254,NGC4501,NGC4571,NGC4651,NGC4654, NGC 4689, and NGC 4713 were taken from Solanes et al. (2002). These distances were obtained by averaging distance moduli based upon the TF relationship taken from eight published datasets (Ekholm et al. 2000; Fouque et al. 1990; Federspiel, Tammann & Sandage 1998; Gavazzi et al. 1999; K raan-K ortew eq, C am eron & T am m ann 1988; Mould, Aaronson & Huchra 1980; Pierce & Tully 1988; Yasuda, Fukugita & Okamura 1997). The distances from these works have been previously hom ogenized. It seems quite in possible to check the distance of individual V irgo cluster galaxies by com paring their value with the "group" distance. Indeed, the galaxies NGC 4321, NGC 4651, and NGC 4689 belong to the LGG 289 group (Garcia 1993). Their TF distances range from 15.00 Mpc for NGC 4689 to 22.28 Mpc for NGC 4651. The distances for nine galaxies of the LGG 289 group have been determ ined with the SBF m ethod (Tonry et al. 2001), these distances lie between 15.00 Mpc (NGC 4564) and 22.42 Mpc (NGC 4365). Thus, both the TF distances and the SBF distances of galaxies of LGG 289 group are spread over more than 7 Mpc. There are two estimations of the distance to the Virgo cluster galaxy NGC 4571 with the \brightest supergiant stars" m ethod. The m ean BRSG distance value of 17.15 Mpc is in agreement with Solanes et al.'s TF distance of 17.22 Mpc.

The adopted values of distance and the corresponding references to sources of data are presented in Table A 1 (Cols. 6 and 7). The list of references to Table A 1 is given in Table A 2. Using the adopted distances and the total face-on blue magnitudes corrected for galactic and internal absorption  $B_T^0$ , the lum inosities of galaxies were determ ined. The  $B_T^0$  values are taken from the Third R efference C atalog of bright G alaxies (de Vaucouleurs et al 1991, RC 3) and are listed in Col. 4 of Table A 1.
