R elativistic B inary Pulsar B1913+16: Thirty Years of Observations and Analysis

Abstract.

We describe results derived from thirty years of observations of PSR B1913+16. Together with the Keplerian orbital parameters, measurements of the relativistic periastron advance and a combination of gravitational redshift and time dilation yield the stellar masses with high accuracy. The measured rate of change of orbital period agrees with that expected from the emission of gravitational radiation, according to general relativity, to within about 0.2 percent. System atic elects depending on the pulsar distance and on poorly known galactic constants now dom inate the error budget, so tighter bounds will be dicult to obtain. Geodetic precession of the pulsar spin axis leads to secular changes in pulse shape as the pulsar-observer geometry changes. This elect makes it possible to model the two-dimensional structure of the beam. We nd that the beam is elongated in the latitude direction and appears to be pinched in longitude near its center.

1. Introduction

Pulsar B1913+16 was the rst binary pulsar to be discovered (Hulse & Taylor 1975). Thirty years of subsequent observations have enabled us to measure num erous relativistic phenom ena. We have used these measurements for fundamental tests of gravitational physics and to place tight constraints on physical parameters of the system. In this paper, we provide the latest results of our observations and analysis.

2. Observations

The observable pulsar is a weak radio source with a ux density of about 1 m Jy at 1400 M Hz. Its observations are nearly always sensitivity limited. Over the years we and our colleagues have built a number of sensitive receiver \back ends" for use at A recibo, including a swept local-oscillator system program med to follow the dispersed pulse, as well as Iter banks and signal averagers (see W eisberg & Taylor 2003 for a summary). Our most recent data have been

gathered with the W ideband A recibo Pulsar Processors (WAPPs"), which for PSR B1913+16 achieve 13 stime-of-arrival measurements in each of four 100 MHz bands, using 5-m inute integrations. In addition to the timing observations, we have used the Princeton Mark IV coherent de-dispersing system (Stairs et al. 2000) to measure average pulse shapes and polarization over the last ve years. A major improvement in data acquisition for this experiment was made in 1981, and data taken since then have much higher quality than the earlier observations. The results reported here are based largely on data gathered from 1981 through 2003.

3. Relativistic T im ing A nalysis

N on-relativistic analysis of arrival time data from this system can yield ve orbital parameters: the projected sem in a jor axis of the pulsar orbit $a_p \sin i$, orbital eccentricity e, epoch of periastron T_0 , orbital period P_b , and argument of periastron $!_0$. Relativistic e ects lead to three additional measurables: the mean rate of advance of periastron $h!_i$, gravitational redshift and time-dilation parameter

, and orbital period derivative $P_{\rm b}$. M easured pulse times of arrival calculated for each vem inutes of observation serve as the input data for program TEM PO (http://pulsarprinceton.edu/tem po). This program ts a model with eighteen parameters (eight orbital quantities plus ten astrometric and spin parameters) to the data, using the timing model of D amour & D enuelle (1985, 1986). Fitted values for the orbital parameters are listed in Table 1, with uncertainties in the last shown in parentheses.

The pulsar orbit is fully specied (up to an unknown rotation about the line of sight) by the first seven parameters listed in Table 1.0 ther orbital quantities such as inclination, masses of the stellar components, and the sem in a jor axes, may be derived from these seven; Taylor & W eisberg (1982) provide the relevant form ulas. For example, the masses of the pulsar and companion are $m_p = 1.4414$ 0.0002 and $m_c = 1.3867$ 0.0002 solar masses, respectively. (Note that in order to express the masses in grams, a value would need to be introduced for the New tonian gravitational constant G. The uncertainty in G is comparable to our quoted uncertainties in m_p and m_c .) As described below, the eighth

m easured orbital parameter, P_b , overdeterm ines the system dynamically and thus provides a test of gravitation theory.

3.1. Em ission of G ravitational R adiation

A coording to general relativity, a binary star system should emit energy in the form of gravitational waves. The loss of orbital energy results in shrinkage of the orbit, which is most easily observed as a decrease in orbital period. Peters & M atthews (1963) showed that in general relativity the rate of period decrease is given by

Note that except for Newton's constant G and the speed of light c, all quantities on the right hand side of Eq. (1) have measured values listed in Table 1, or, in the case of the component masses, are derivable from those quantities. The predicted orbital period derivative due to gravitational radiation computed from Eq. (1) is $P_{b,GR} = (2:40242 \quad 0:00002) \quad 10^{-12} \text{ s/s.}$

C om parison of the m easured P_{b} with the theoretical value requires a sm all correction, $P_{b,G\,al}$, for relative acceleration between the solar system and binary pulsar system, projected onto the line of sight (D am our & Taylor 1991). This correction is applied to the m easured P_{b} to form a \corrected" value $P_{b,corrected} = P_{b}$ $P_{b,G\,al}$. The correction term depends on several rather poorly known quantities, including the distance and proper motion of the pulsar and the radius of the Sun's galactic orbit. The best currently available values yield $P_{b,G\,al} =$

and we conclude that the measured orbital decay is consistent at the (0:13 0:21)% level with the general relativistic prediction for the emission of gravitational radiation. The observed and theoretical orbital decays are compared graphically in Figure 1.

A couracy of the test for gravitational radiation dam ping is now dom inated by the uncertainty in the galactic acceleration term . W ork now underway should lead to improved accuracy of the pulsar properm otion, and the Sun's galactocentric distance m ay be better known in the future. How ever, we see little prospect for a signi cant improvement in know ledge of the pulsar distance. Consequently, it seem sunlikely that this test of relativistic gravity will be improved signi cantly in the foresseable future.

4. Geodetic Precession: M apping the Em ission Beam

Relativistic spin-orbit coupling causes the pulsar's spin axis to precess (D am our & Ru ni 1974; Barker & O'C onnell 1975a,b). In the PSR B1913+16 system

this so-called \geodetic" precession has a period of about 300 y. The resulting change of aspect with respect to the line of sight should cause a secular change in pulse shape. W eisberg, Rom ani, & Taylor (1989) reported shape changes at 1400 M H z and attributed them to the line of sight moving across the middle of a hollow -cone beam . K ram er (1998) found that the separation between the two principal pulse components began to shrink in the mid-1990s, suggesting that the line of sight had continued to drift across the conal beam, moving farther from its center. K ram er tted a model to these data, which indicated that the pulsar spin and orbital angular momenta are misaligned by 20 and that the beam will no longer intersect our line of sight after the year 2025. Weisberg & Taylor (2002) con med these results and found that the conal beam appears to be elongated in the direction parallel to the spin axis; they also noted that the beam appears to be \hourglass-shaped," or pinched in longitude near its center (see Fig. 2). K ram er (2002) argued that these observations could also result from the line of sight precessing away from the center of a circular emission cone and onto a core pencil beam that is o set below the center and toward the the trailing part of the cone.

W e divided all of our 1400 M H z pro les into com ponents that are respectively even and odd about the pro le center. W e then tted the even com ponents to a m odel that allows for a noncircular conal beam (W eisberg & Taylor 2002). W ith m ore data now available, we nd that the m odel parameters have changed little from earlier solutions. The current m odel is illustrated in Figure 2 in the form of equal-intensity contours of the beam.

Rankin (1983) showed that in most pulsars core emission becomes more prominent at low frequencies. We have observed PSR B1913+16 at the lower frequency of 430 M Hz at several epochs, and three of the resulting pulse proles are shown in Figure 3. A core component is quite prominent in the data taken in 1980-81, but it faded very signic cantly between 1980 and 1998 and was nearly gone by 2003. This behavior further supports our model in which the line of sight is precessing away from the axis of a centered pencil beam plus a longitudepinched cone elongated in the latitude direction.

E ven with 30 years of observations, only a small portion of the north-south extent of the em ission beam has been observed. As a consequence, our model is neither unique nor particularly robust. The north-south sym metry of the model is assumed, not observed, since the line of sight has fallen on the same side of the beam axis throughout these observations. Nevertheless, accumulating data continue to support the principal features noted above.
