# Spectroscopy of P lanetary N ebulae in Sextans A and Sextans B

A bstract. Sextans A and Sextans B are two dIr galaxies situated in the outskirts of the LocalG roup (LG), in which both PN e and H II regions have been detected (Jacoby & Lesser [5], M agriniet al. [6], [7]). We present spectroscopic observations of PN e and H II regions in these two galaxies (obtained with the VLT) P relim in any results about PN e physico-chem ical properties are presented.

# 1 The galaxies: Sextans A and Sextans B

Sextans A and Sextans B are both dwarf Irregular galaxies (Ir V and Ir IV-V m orphological types, respectively, cf. van den Bergh [12], hereafter vdB00) with approxim ately the same V lum inosity, belonging to the outer fringes of the Local Group. Their distances from the barycenter of the LG are quite sim ilar (1.60 and 1.72 M pc, see vdB 00) and their separation on the sky is relatively sm all ( 10 degree), which corresponds to about 280 kpc. Moreover their velocity di erence is only 23 6 km s<sup>1</sup>. These results suggest the hypothesis of a comm on form ation of these two galaxies, probably together with NGC 3109 and the Antlia galaxy. Considering the mean distance of the four galaxies from the barycenter of the LG, 1.7 M pc, this sub-group is located beyond the zero velocity surface of the LG (cf. vdB 00) and thus it can be considered the nearest external group of galaxies. As said by M ateo ([9]) \No two Local G roup dwarfs have the same star-form ation history". This is true also when comparing very similar galaxies. In fact, in spite of a probable com m on form ation, Sextans A and Sextans B show a di erent star form ation history as indicated by the di erent am ounts of stars in the various evolutionary phases, and also re ected in the di erent number of PNe and HII regions observed. Sextans A shows a large amount of old stellar population, whereas it has a modest intermediate (4-10 Gyrs ago) and recent star form ation (1-4 Gyrs ago). On the other hand, Sextans B exhibits a very strong recent star form ation (1-4 G yrs ago), together with a very old population (cf. M ateo's ([9] review about the star form ation history of the LG dwarfs).

In this context, PN e represent an useful tool to trace the chem ical enrichment history of galaxies, moreover when compared with chem ical abundance derived

from H II regions, because they are tracers of stellar population in a wide range of ages, from old to interm ediate age.

#### 2 Observations and data reduction

PNe (1 in Sextans A and 5 in Sextans B) and H II regions (10 and 9, respectively) have been observed in D ecem ber 2003 with VLT (ESO, Paranal) equipped with FORS2 spectrograph in multi-object spectroscopy (MOS) observing mode. The FORS2 spectrograph was used with two setup: the 300 V and 300 I gratings providing a dispersion of 3.0 A/pixel. The total resulting spectral range, from 3200A to 10000 A, includes basic lines needed for the determ ination of chem ical abundances. For each galaxy, a total of six exposures were taken, three with the 300 V grating (total exposure tim e 5400 s) and three using the 300 I one (3600 s). A spectrophotom etric standard star, GD 108, was observed once during each night. The data were reduced using the IRAF LONG SLIT package and com plem ented with M IDAS (MOS and LONG packages). The spectra are presented in Figs. 1 and 2. Identi ed em ission lines are marked with the nam e of the corresponding ion and/or wavelength.

### 3 Chem ical abundances of planetary nebulae

Chem ical abundances have been derived with the classic Ionization Correction Factors (ICFs) method, following Kingsburgh & Barlow ([4]). As the [0 III] 4363 em ission line was always measurable with a su ciently high signal to noise ratio, the [0 III] electron tem perature was derived for all PN e. As the nitrogen em ission lines are so intense in Sextans A, the [N II] 5755 is observed and an electron tem perature is derived. [S III] infrared em ission lines were detected in 4 PN e. T hey allow a better accuracy in the measurem ent of sulphur abundance, especially in low metallicity environments where [S III] lines are extrem ely faint.

In addition, PN e have been m odelled with the phoionization code CLOUDY 94.00 (Ferland et al. [2]), assuming a blackbody central starwith e ective tem – perature derived using the Am bartsum ian's ([1]) or Gurzadyan's ([3]) m ethods, and a spherical nebula with constant density, derived from [S II] 6717/6731 A

ux ratio when available or assum ed equal to 3000 cm  $^3$  in the other cases. For further details on the modelling procedure see M agriniet al. ([8]) and Perinotto et al. ([10]). The chem ical abundances derived with the two m ethods are in good agreem ent one to each other. The CLOUDY model allowed to derive also some nebular and stellar parameters as the radius of the nebula, the stellar lum inosity and tem perature (see Table 2). The prelim inary chem ical abundances and their errors, derived with the ICFs m ethod, are shown in Table 1.

Although the de nition of Type IPNe is a function of metallicity of the host galaxy (cf. Magrini et al. [8]), as a rst approximation, we applied the Galactic Type I de nition by Kingsburgh & Barlow ([4]),  $\log (N / 0) > -0.1.W$  ith

this de nition, the Sextans A PN is a Type IPN, while the Sextans B PNe are non-Type I.U sing the stellar lum inosity and temperature derived with the CLOUDY model, we compared the location of the six PNe in the  $\log T_2 - \log L_2$  space with the H-burning evolutionary tracks from Vassiliadis & W ood ([13]). We found a more massive progenitor for the Sextans A PN (2.5M) than those of Sextans B PNe (1-1.5M), in agreement with its Type I nature.

A nother interesting aspect from Table 1 is the large range of O/H, 0.7 dex, of Sextans B PNe in spite of their sim ilar evolutionary age. Since oxygen is not processed by PN progenitors, this represents a sign of the dishom ogeneity of the interstellarm edium at the time of the form ation of the PN progenitors. We plan to compare this dishom ogeneity with the spatial distribution of H II regions chem ical abundances.

# 4 The metallicity-lum inosity relationship using PNe

In Fig. 3, the relationship of V-lum inosity vs. oxygen abundance from PNe in the LG is shown. Galaxies are identi ed with di erent symbols according to their morphological type. A di erent behaviour of star forming (irregulars and

spirals) and non-star form ing (spheroidals) galaxies was already noted by several authors (cf. M ateo [9]): spheroidal galaxies are generally m etal richer than irregular galaxies with the same V lum inosity. There are several hypotesys about this behaviour (cf. P ilyugin [11]), but a satisfatctory understanding is still m issing. The uniform way to derive chem ical abundances with PNe, which are present in galaxies of every m orphological type, will help to understand the origins of this fundam ental relation.
