STAR FORM AT ION AT RED SHIFT ONE: PRELIM IN ARY RESULTS FROM AN H SURVEY

We present the rst successful demonstration of multi-object near-infrared spectroscopy on high redshift galaxies. Our objective is to address the true star formation history of the universe at z 1, a crucial epoch which some have suggested is the peak of star formation activity. By using H the same robust star formation indicator used at low-z-redshifted into the J- and H-bands, we can trace star formation without the systematic uncertainties of dierent calibrators, or the extreme dust extinction in the rest-UV, which have plagued previouse orts. We are using the instrument CIRPASS (the Cambridge Infra-Red PA noramic Survey Spectrograph), in multi-object mode, which has been successfully demonstrated on the Anglo-Australian Telescope (AAT) and the William Herschel Telescope (WHT). CIRPASS has 150 bres deployable over 40° on the AAT and 15° on the WHT. Here we present preliminary results from one of our elds observed with the WHT: He detections of z 1 galaxies in the Hubble Deep Field North.

1 Introduction

1.1 Background

An important issue in studies of galaxy formation and evolution is determining the peak epoch of star form ation in the universe. There is clear evidence that the star form ation rate (SFR) was higher in the recent past - it is known to rise steeply to z 1 and perhaps to peak around redshifts 1 2. (e.g. Lilly et al. 1996, Tresse et al. 2002). However there are large discrepancies between SFR estimates obtained from dierent methods: dierent indicators have uncertain relative calibration and are also di erently a ected by dust extinction. There is a factor of uncertainty in the star form ation history of the universe at z 1 (e.g. Hopkins et al. 2001), a discrepancy which needs to be addressed by using a uniform tracer of star form ation across all redshift bins. The H emission line is a reliable tracer of the instantaneous SFR as the H lum inosity of a galaxy is directly proportional to the ionising ux from its massive stars. It is also relatively in mune to metallicity e ects and less susceptible to extinction than the rest-UV. However, tracing H to early epochs forces a move to the NIR at z > 0.6. Previous H surveys in the NIR have so far been restricted to small samples, as they have relied on longslit spectroscopy which is ine cient for surveys, in terms of telescope time (e.g. G lazebrook et al. 1999, Tresse et al. 2002, Erb et al. 2003). A large sample (several hundred) of galaxies is needed to address this matter properly.

1.2 An H Survey with the CIRPASS multi-object spectrograph

We are using the bre-fed CIRPASS spectrograph (Parry et al. 2000), to undertake an H survey of galaxies at z = 0.7 1.5 (D oherty et al. 2004), in order to address the true star form ation history of the universe at this epoch. We aim to target several hundred galaxies. We have carried out a successful pilot study for this project, perform ing multi-object spectroscopy of galaxies in the vicinity of the HDF-N. The instrument operates in the near-infrared, between 0.9 and 1.67 m and was used in multi-object mode, with 150 bres of 1.10 diam eter on the sky (comparable to the expected seeing convolved with typical galaxy pro les), deployable over 150 eld of view. The plate was centroided to an accuracy better than 0.5^{0} using six guidebundles centred on bright stars. A Hawaii 2K detector was used, and a grating of 831 lines/mm, producing a dispersion of 0.95A/pixel. The full width at half maximum (FW HM) of each bre extends over 2.7 pixels in both the spatial and spectral domain. The wavelength coverage was 1726A, covering most of the J-band, and the grating was tilted to set a central wavelength of $_{\rm c}$ = 1.25 m . The resolving power was R = FWHM5000. At this resolution the background is very dark between the OH sky lines in the J-and H-bands, allowing for high sensitivity to emission lines falling between the skylines (which contam inate only about 10% of the array). We used half of the bres on target objects and half on sky, to allow for good sky subtraction. Thus with the capability of observing 75 objects simultaneously, CIRPASS o ers a huge multiplex advantage, ideal for carrying out such a survey.

2 Initial Results: Bright H galaxies in the HDF-N




Figure 1: Example spectra for two objects where H $\,$ was detected at more than 5 $\,$. The night sky spectrum is overlaid in dotted lines for convenient identication of sky residuals which did not fully subtract out. The expected position of H $\,$ at the optical spectroscopic redshift (C ohen et al. 2000) is marked with a dashed line.

We detected H in a sub-sample of our targets in the HDF-N at > 5 in just 3 hours of observing. Examples are shown in Figure 1. In an average bre, between skylines, for a spectrally unresolved line (velocity FW HM < 60 km s 1) we achieve a sensitivity of 72 10 17 erg s 1 cm 2 at 5 (in 3 hours, equivalent to a star form ing rate of $5h_{70}^2$ M yr 1). The em ission lines we detect are typically broader than this, with velocity full width at halfmaximum of 100 250 km s 1, equivalent to $_{1D}$ = 40 100 km s 1 . Some of this velocity width may be due to galactic rotation in the extended galaxies: the most spatially extended galaxies exhibit the broadest lines. H traces the instantaneous star form ation rate as the H lum inosity of a galaxy is directly proportional to the ionising ux from massive stars, which drops o after only about 20 m illion years after star form ation ceases. The UV lum inosity, on the other hand, evolves in time with changes in stellar population, continuing to rise even after star form ation has ended. We compared SFRs derived using the two dierent methods, for each of our > 5 detections, using conversions given in Kennicutt (1998). We performed photometry on the HST/ACS images from GOODS v1.0 (G iavalisco et al., 2003), with 1^{0} apertures, for consistency with our in fra-red bre size and used the B band magnitudes (4500A) to calculate rest fram e UV (2400A) ux densities and corresponding star form ation rates. We nd that SFRs calculated from the UV lum inosity densities are typically a factor of at least two lower than those derived from H. This is probably due to the di erentiale ect of dust extinction in the redshift one galaxies between rest and 6563A. This result is consistent with values in Glazebrook et al. (1999), Tresse et al. (2002), and Yan et al. (1999), who all nd SFR (H)/SFR (UV) ratios of around 2-3.

3 Summary

We have performed multi-object, near-infrared spectroscopy of z 1 galaxies in the Hubble Deep Field North, using CIRPASS-MOS. These observations form an important pilot study for an on-going survey to trace star formation rates at redshift one. The brightest H galaxies (about 10% of our sample) were detected at at least 5 in only 3 hours exposure time, demonstrating

the success of this technique. We have shown that we can detect H at su cient signal to noise to obtain a good estimate of star formation rates in these galaxies. By pre-selecting galaxies with H redshifted between the OH sky lines, we can detect star formation rates of $5h_{70}^{2}$ M yr 1 (5 in 3-hours). The star formation rates obtained are higher than those estimated from UV continuum by a factor of about two, due to dust obscuration in the UV. This is consistent with previous work in this area. The results of this pilot study are discussed further in Doherty et al. (2004, submitted to MNRAS). The full survey will be presented in Doherty et al. (2004b, in prep.) We have another 60 sources in this eld, at known redshifts, therefore by stacking the spectra we will be able to obtain a global star formation rate for z 1 galaxies in the vicinity of the HDF-N. We aim to build up a sample of several hundred galaxies in total, over several dierent elds, which will allow us to determine the H luminosity function at z 1 and hence address the true star formation rate at this important epoch.
