R ecycled pulsars with black hole com panions: the high m ass analogues of PSR B2303+46

ABSTRACT

W e investigate the possibility that m ass transfer early in the evolution of a m assive binary can e ect a reversal of the end states of the two components, resulting in a neutron star which form s before a black hole. In this sense, such system s would comprise the high-m ass analogues of white dw arf-neutron star system s such as PSR B 2303+46. O ne consequence of this reversal is that a second episode of m ass transfer from the black hole progenitor star can recycle the nascent neutron star, extending the life of the pulsar.

An estimate of the formation rate through this channel is rst performed via a simple analytical approach, and then rened using the results of the SeB a binary evolution package. The central role of kicks in determining the survival rate of these binaries is clearly demonstrated. The nalresult is expressed in term softhe number of eld pulsars one can expect for every single neutron star-black hole (ns,bh) binary. We also calculate this gure for black hole-neutron star (bh,ns) systems formed through the usual channel. A ssum ing kicks drawn from the distribution of C ordes & C hemo (1998), we nd an expectation value of one (ns,bh) binary per 4 10⁴ pulsars, and one (bh,ns) system for every 1500 pulsars. This helps to explain why neither system has been seen to date, though it suggests that detection of a (bh,ns) binary is in minent.

1 IN TRODUCTION

The \recycling" of pulsars through m ass accretion from a binary companion has been established in the literature for m ore than two decades (A lpar et al. 1982). In the case of neutron star-neutron star binaries, the recycled pulsar is in fact the rst neutron star to form, as the m ass accretion is driven by Roche-lobe over ow during the evolution of the second, initially less massive star. There are several double neutron star system s (ns,ns) currently known, which have all experienced som e degree of recycling (A rzoum anian et al. 1999; Burgay et al. 2003).

The second star need not end up as a neutron star, of course. van K erkwijk & Kulkarni (1999) and D avies et al. (2002) showed that the binary PSR B2303+46, which contains a slowly rotating pulsar, was consistent with a white dwarf-neutron star (wd,ns) system where the white dwarf evolved rst. This reversal leaves the neutron star with no source of matter to accrete, hence no recycling takes place in this instance, and one is left with a white dwarf and an unrecycled pulsar. The mechanism behind this reversal is detailed in Tutukov & Yungelson (1993), Portegies Zwart & Y ungelson (1999) and Tauris & Sennels (2000). E sentially, as the prim ary evolves and lls its R oche lobe, it spills so m uch m assonto the lighter com panion that the evolutionary destinies of the two stars are reversed. The initially m assive prim ary has insu cient m ass to become a neutron star, ending up as a heavy white dwarf, w hereas the com panion gains enough m ass to evolve into a neutron star. We label such a binary as a white dwarf-neutron star (w d,ns) system to distinguish its heritage from the m ore common (ns,wd) binaries, in which the neutron star form s rst. For the (w d,ns) evolution channel, the stars have to be of sim ilar m ass, and these m asses have to straddle or lie just below the boundary between white dwarf and neutron star form ation.

An analogous situation exists in higher mass systems, where both components have a ZAMS mass below the threshold for black hole formation. Unlike the (wd,ns) systems above, the pulsar in this scenario will experience recycling if the system undergoes Roche-lobe over ow when the companion leaves the main sequence. As yet, no neutron stars have been discovered with black hole companions. An estimate of the rate at which such objects are formed, coupled with educated guesses about the longevity of such a system, allows us to infer the number of such systems that m ay exist in our Galaxy. A more useful comparison is the ratio of the number of (ns,bh) systems to pulsars, as an expectation value for the (ns,bh) detection rate per pulsar found. If this number is greater than the number of pulsars currently known, the absence of (ns,bh) binaries is easily understood. Conversely, if the rate im plies that some (ns,bh) systems should have been detected already, this estimate serves as a lower bound for e ects that select against the detection of these binaries.

2 ANALYSIS

To estim ate the frequency of (ns,bh) system s in the G alaxy, we construct a probability for a single binary system to be generated with the initial param eters that are a necessary (but not su cient) condition for (ns,bh) form ation. W e assum e that stars with masses between 8 and 25 M become neutron stars, with stars above this lim it becoming black holes. This is consistent with recent work by Fryer et al. (2002) and Heger et al. (2003) on the end state of massive stars. The binarity fraction is taken to be 50% (i.e., 2 out of 3 stars are in a binary), and a standard Salpeter IMF is assumed ($dN = m^{2:35} dm$), drawn from 8 to 100 M . The m ass of the secondary is determ ined by drawing the m ass ratio q from a at distribution. The choice of a mass ratio distribution is still quite contentious; a study of massive stars in the Orion nebula (Preibisch et al. 1999) showed a secondary IMF that is consistent with that of the eld star population, but a at distribution could not be ruled out either. G iven the inherent observational biases in studying system s with wide m ass ratios (H ogeveen 1992), a at m ass ratio distribution is not an unreasonable assumption here.A distribution skewed towards lowermass secondaries would, of course, result in a sm aller num ber of (ns,bh) system s.

To form a (ns,bh) system via this channel, a number of conditions must occur in order, each with an associated probability. First, the system must have a small enough initial separation for a rst mass transfer episode. Second, enough mass must be transferred from the primary to the secondary to ensure that the secondary becomes a black hole, with a reduction in its evolutionary timescale com m ensurate with the mass gained. The primary must retain enough mass to become a neutron star. We assume that the main sequence lifetime of the primary is not extended by mass loss (as it is the envelope which is lost). Third, the system must survive the natal kick that accompanies the collapse of the primary to a neutron star. Fourth, the perturbed system must retain a su ciently close orbit that a second bout of mass transfer can occur, this time from the more massive secondary onto the neutron star primary. Lastly, the system must survive any natalkick arising from the collapse of the secondary into a black hole.

Setting aside for a moment the question of whether many (ns,bh) progenitor systems survive the rst natalkick, we can address in a basic, analytical way the potential upper lim it for the form ation rate of these binaries.

The probability that an arbitrary binary will transfer m ass as the primary leaves the main sequence depends upon the ZAM S m ass M $_0$ of the primary, the initial mass ratio q $_0$,

and the initial sem im a jor axis a_0 . Practically speaking, such system s have initial periods of less than 10 years (Pols et al. 1991), with sem im a jor axes on the order of a few thousand solar radii. Initial orbital separations are typically taken to be distributed evenly in loga, out to roughly 10^6 R (A bt 1983). A s the region of interest occupies three decades in a, out of a possible six, we take the probability of initial m ass transfer to be 1=2.

W e assume that the entire envelope of the primary is transferred during this initial episode, though based on the degree to which the transfer is non-conservative, not all of this matter will be accreted by the secondary. W ith a mass loss fraction f, the nalmasses $(M_1; M_2)$ of the components are related to their initial masses $(M_1^0; M_2^0)$ by the expressions

where M _{core} is the core m ass of the primary, which we take to be $0.058 (M_{1}^{0})^{1:57} M$ (Iben & Tutukov 1985).

The mass loss fraction f is taken to be a linear function of the initial mass ratio only (Pols et al. 1991; Portegies Zwart 1995), ranging from 1 at $q_0 = 0.2$ to 0 when $q_0 = 0.6$. Values above or below this range assume a value of unity or zero, respectively. An alternative is to treat f as a quadratic function of q; in the sim plest case, f = 1 q^2 . We will have m one to say about the relevance of this parameter later when discussing the results of a detailed binary evolution code in section 3.

The nalprobability to consider is whether the system will remain su ciently closely-bound to transfer mass from the black hole progenitor back onto the nascent neutron star. To rst order, we consider that any system that survives the rst natal kick will eventually go on to a second bout of mass transfer. G iven the extrem e di erence between the imparted kick speed and typical orbital speeds for this scenario, those systems receiving a prograde kick will alm ost invariably be disrupted, while system s that remain intact may still be close enough for mass transfer after tidal circularisation has completed.

The question of norm alisation m ust also be considered. We choose to norm alise to the Galactic supernova rate of 0.01 yr ¹ (consistent with the 0.008 yr ¹ reported by Cappellaro et al. 1997).We assume all stars with a zero-age m ain sequencem ass between 8 and 25 M contribute to the supernova rate. The question of whether black holes experience a supernova at form ation is a complex and unresolved one, with a critical dependence on the star's pre-collapse m ass (Fryer et al. 2002). For our purposes, we ignore the natal kick im parted to a nascent black hole, and do not count these events tow ards the supernova rate.

From the above considerations, we can establish the range of prim ary and secondary masses for which the (ns,bh) scenario is physically possible. Figure 1 shows the boundaries in mass space for (ns,bh) candidates. The four boundary conditions are indicated by rom an num erals, and represent the following: (I) that the envelope mass M_e of the primary is greater than the di erence between the ZAM S mass M₂ of the secondary and 25 M (the threshold for black hole form ation), so that M_e = M₁ 0.058M₁^{1:57} 25 M₂. (II) The tautological requirement that the initial primary mass is greater than that of the secondary (i. e., 0 < q 1).

(III) The ZAMS m ass of the prim ary does not exceed the threshold for black hole form ation (M $_1 < 25M$). (IV) If the initial m ass transfer is very non-conservative, the envelope m ass M $_{\rm e}$ will not be su cient to m ake the secondary a black hole, so we require that M $_2$ 25 M $_{\rm e}$ (1 f). Note that this last requirem ent is essentially a m ore stringent version of condition (I), and only com es into play for prim aries above 20 M $_{\rm e}$.

A crude estimate of the (ns,bh) form ation rate can be obtained by simply calculating the area bounded by the four aforem entioned conditions, weighted by the initial mass function. This gives an upper limit to the form ation rate, as it ignores the e ects of natal kicks, and the likelihood of the two mass transfer episodes. From our previous assum ptions (Salpeter IM F, at mass ratio distribution, and a 50% binarity), and norm alising to the Galactic SN R, we ind a form ation rate of 1.6 10^{-4} yr ¹. If we consider a more severely nonconservative mass transfer, with f = 1 q², the form ation rate shrinks by a factor of two, to 7.5 10^{-5} yr ¹.

3 D ISC U SSIO N

Having determ ined the form ation rate of recycled (ns,bh) binaries, we can estimate the number of such systems per pulsar by comparing the product of the respective form ation rates and pulsar lifetim es. This is dependent upon the extent to which the pulsar is recycled, a complicated topic which we do not address at present. We take a lifetim e $_1 = 10^8$ yr as a reasonable average, consistent with recycled pulsar lifetim es inferred from neutron star binaries (A rzoum anian et al. 1999). For unrecycled pulsars, we assume an average lifetim e of $2 = 10^7$ yr. The results are summarised in Table 1.

The estimate of the (ns,bh) formation rate above is clearly too large; am ong approximately 1500 known pulsars, m any of these systems should have already been seen. M ost of the putative (ns,bh) systems should in fact have been disrupted by symmetric and asymmetric kicks during the formation of the neutron star. To better understand the extent to which kicks prevent these systems from forming, we employ a more detailed numericalm odel of binary evolution, including several choices regarding the distribution of natal kick speeds.

We chose to use the SeB a package for our numerical model, as described in Portegies Zwart & Verbunt (1996). However, several design choices require comment at this point. Our prescription for handling helium star winds is that of Langer (1989). The stellar evolution tracks that form the core of the package are the analytic interpolations given in Eggleton et al. (1989).

Probably the least well-constrained quantity in our model is the initial black hole mass function; i.e., the mapping of pre-collapse masses and the mass of the resulting black hole. The approach used in SeBa is based on that of Fryer & Kalogera (2001). There, the total binding energy of the progenitor at collapse is compared to the energy released in the supernova, multiplied by an e ciency factor which is taken to be roughly 1=2. In SeBa, we take the supernova energy as xed at 16^{11} ergs, instead of a function of the progenitor mass. The mass of the CO core is taken as the minimum mass of the black hole, to which

som e fallback material may be added. The binding energies for the helium and hydrogen envelopes are calculated separately, and then each is compared to the supernova energy in turn. If the hydrogen envelope has a mass M $_{\rm H}$ with binding energy E $_{\rm H}$, a supernova providing energy E $_{\rm S\,N}$ will produce an amount of fallback hydrogen F_H given by $(1 \frac{E_{SN}}{E_{H}}) (0 F_{H})$ 1). Any remaining su- $F_{H} = M_{H}$ pernova energy after the hydrogen layer is unbound is then applied to the helium layer, so that the amount of fallback helium is just $F_{He} = M_{He}$ (1 $\frac{E_{SN} E_{H}}{E_{Ho}}$). If any of the hydrogen falls back on to the black hole, the entire helium envelope will also be captured, by de nition. The nalblack hole mass is then just the CO core mass plus the total fallback m aterial.

To better investigate the role of kicks, we chose three separate kick distributions. The rst allows a sym metric kick only, with a zero-magnitude asym metric kick. Next, we performed a series of runs using the asym metric kick distribution of Paczynski (1990) and Hartman (1997), with a dispersion speed of 300 km s⁻¹. Last we use the model form ulated by Cordes & Chemo (1998), derived from observations of the Galactic pulsar scale height. This last distribution is a double-gaussian, drawing 86% of the velocities from a gaussian with a dispersion of v_{disp} = 175 km s⁻¹, and the remainder from a gaussian with v_{disp} = 700 km s⁻¹.

The results of this simulation are summarised in Table 1, directly below the event rates derived from a direct integration as described in the Analysis section above (sets A and B in the table). The set C come from the output of the SeBa binary evolution code with no asymmetric kicks applied at neutron star form ation (sym m etric kicks still occur). D and E also come from the SeBa routine, but with natal kicks drawn, respectively, from the Paczynski and Cordes-Chemo distributions described above. The (ns,bh) form ation rate is found by scaling the output to the G alactic supernova rate of 0.01 yr ¹. A swell, it is assumed that recycled pulsars will live an average of 10^8 yr, as before, while slow pulsars are taken to have a lifetime of 2 10^7 yr for this estimation. We immediately see the enormous impact that natalkicks have on the form ation rates of such binaries. The considerable di erence between the analytical results (A and B), and the zero-kick num erical simulations arises from ignoring the e ects of wind mass loss in the form er. System s that survive the supernovam ay widen considerably due to wind mass loss from the secondary as it leaves the main sequence, preventing a second m ass transfer episode (Portegies Zwart et al. 1997). Hence our initial overestim ate of the form ation rate.

G iven that the number of known pulsars is less than two thousand, it is not at all surprising that no (ns,bh) system has been found to date.W hile strongly dependant upon the chosen natal kick distribution, it is clear that the total number of known pulsars must grow by a factor of several before even one such binary is likely to be found.

Figure 2 shows the initial ZAM S m assess of both components of (ns,bh) progenitors. For each of the three choices of kick distribution, $12 \quad 10^6$ binaries were generated, with the remaining intact (ns,bh) systems shown on the plot.W e then overlayed the criteria from Figure 1 to check how well our constraints were borne out. The bulk of the (ns,bh) systems fall inside the theoretical bounds we established. One exception is our assumption about the extent of nonconservative

m ass transfer as a function of the m ass ratio q.C learly, our initial linear approxim ation for the conservation factor f was too lenient. The dashed line in Figures 1 and 2 represents the mass conservation condition when f = 1 q^2 . This assum ption better m atches the data, but the true curve lies between these extrem es. Of special note are the scattering of (ns,bh) systems with very high primary ZAMS masses, well to the right of condition III in both gures. These rare systems do result in (ns,bh) binaries, but are the result of Case A mass transfer from a very massive primary to a secondary that is just below the mass threshold for black hole form ation.W e did not consider Case A mass transfer when form ulating our initial scenario, but it is interesting to note this alternate, albeit secondary form ation channel. The fraction of (ns,bh) systems arising from Case A mass transfer varies as a function of the natal kick distribution.W ith no natal kicks, this channel com prises about 10% of the total (ns,bh) population. This rises to roughly 30% when Cordes-Chemo or Paczynski-type kicks are applied, since system s that exhibit Case A mass transfer are closely-bound by definition, and m one likely to survive a natal kick.

It is also interesting to consider the <code>\norm al"</code> form ation channel of (bh,ns) binaries; i. e., where the black hole form s

rst. The naltwo columns of Table 1 show the formation rate of these systems, and an estimate of the ratio of regular pulsars to (bh,ns) binaries. While such systems form roughly two orders of magnitude more frequently than (ns,bh) binaries, the shorter lifetime of the unrecycled pulsarm eans that (bh,ns) are only about 20{30 times more common than the reversed channel. Looking at the expectation value of pulsars to (bh,ns) systems, we note that the number for set E is com parable to the current number of known pulsars, in plying that detection of such a system could occur in the very near future.

4 CONCLUSIONS

W e investigated a channel for the form ation of (ns,bh) binaries, where a bout of m ass transfer reverses the ordinary evolutionary order, resulting in a neutron star which form s rst. This neutron star can then be spun up by a second episode of m ass transfer from the black hole progenitor star, resulting in a recycled pulsar orbiting a black hole. The rapidlyspinning pulsar should live several times longer than a typical pulsar. We then estim ated the form ation rate of such system s via both a sim ple analytical calculation and then a m ore detailed binary evolution code, and used assumptions about the relative lifetim es of the recycled pulsars to calculate the expected ratio of eld pulsars to (ns,bh) system s. The result is that the current known pulsar population m ust grow by factors of several before such a system is likely to be found, despite containing a longer-lived recycled pulsar.

U sing the sam e m ethods, we show that norm al (bh,ns) binaries should be m ore com m on than (ns,bh) system s by an order of m agnitude, and that the expected number of pulsars per (bh,ns) system is com parable to the current known pulsar population.Forboth (ns,bh) and (bh,ns) binaries, the strongest single factor in determ ining the form ation rate is the distribution from which natal asym m etric kicks are selected.

Set A is the result of direct integration of the area in gure 1 weighted by the MF, with the mass loss via nonconservative mass transfer given by a simple linear relation, where B is the same calculation, with the mass loss factor varying as the square of the mass ratio q; sets C, D and E arise from detailed binary simulations using the SeB a package. Set C includes symmetric B laauw kicks but no asymmetric kicks. Set D allows for a random asymmetric kick drawn from the distribution of Paczynski (1990), with a dispersion of 300 km s⁻¹; set E draws s its kick from the distribution of C ordes & C herno (1998), a double-G aussian with dispersions of 175 and 700 km s⁻¹, respectively. The (ns,bh) formation rate gives the number of recycled (ns,bh) system s per year, while the next colum n estimates the total number of recycled (ns,bh) system s in our G alaxy, by multiplying the formation rate by the lifetime of a typical recycled pulsar, taken here to be 10^8 yr. C olumn 5 shows the expected number of pulsars per single (ns,bh) system . Here we assume that pulsars are formed at the supernova rate, and live an average of 2 10^7 years without recycling. The naltwo columns show the formation rate of (bh,ns) system s, and the number of pulsars expected for every (bh,ns) system.
