
#### Abstract

W e generated synthetic observations from the four-arm m odel presented in for the $G$ alactic ISM in the presence of a spiral gravitational perturbation. We lound unal veloclly crow ding and di usion have a stronge ect in the 1 v diagram. The v b diagram presents structures at the expected spiralarm velocities, that can be explained by the o the-plane structure of the arm s presented in previous papers of this series. Such structures are observed in the Leiden/D w ingeloo H I survey. The rotation curve, asm easured from the inside of the m odeled galaxy, show s sim ilarities w ith the observed one for the M ilky W ay G alaxy, although it has large deviations from the sm ooth circular rotation corresponding to the background potential. The magnetic eld inferred from a synthetic synchrotron m ap show s a largely circular structure, but w ith interesting deviations in the $m$ idplane due to distortion of the eld from circularity in the interarm regions.

## 1. INTRODUCTION.

O ur position inside the M ilky W ay G alaxy allows us to $m$ ake observations at a much higher spatial resolution that we could do in other disk galaxies. But that sam e fact $m$ akes it $m$ uch $m$ ore di cult to infer the large scale characteristics of our hom e galaxy. A lot of the current questions of the spiral structure of the $M$ ilky $W$ ay could be resolved if we knew the position and full velocty vector of the observed gas. N um erical studies of large

scale galactic structure have proved to be very valuable in disceming the sought after characteristics. N evertheless, th is is a very com plicated problem and, so far, it is im possible to include all the physics involved. Therefore, $m$ odelers $m$ ust decide which parts of the problem are not going to be considered, in the hope that those neglected w ill have little in uence in the overall conclusions. The m odels presented here do not include self-gravity of the gas, supemova explosions or other energetic events, and have uncom fortably low spatial resolution. T hey include a substantialm agnetic eld, a high therm alpressure (to represent tangled elds, cosm ic rays, and subgrid turbulence), and the extra degree of freedom of three dim ensions. W e believe these are de nitive factors that have not been su ciently explored. T he them alpressure was also adjusted to drop sharply at high densities to encourage the form ation of denser structures.

P apers I and II from here on, we presentea tne resulls of our sim ulations of the ISM response to a spiral gravitational perturbation. W e show ed that the extra sti ness that the $m$ agnetic eld adds to the gas $m$ akes it develop a combination of a shock and a hy-

draulic jum p w ith signi cant com plications added by vertical bouncing. This jump/shock leans upstream above the plane ( $m$ ore in the two-arm models than the fourarm ones), ahead of the $m$ ain gas concentration in the m idplane. A $s$ it shocks, the gas shoots up to higher z in a way sim ilar to water jum ping over an obstacle in a riverbed. The gas then accelerates as it runs over the arm, and falls dow $n$ behind it, generating a secondary set of shocks. In the two-arm cases, the gas bounces back up, generating interarm structures that $m$ im ic the ones found at the arm $s$.

## 2. ALL SKY MAPS.

Figur shows a map of the integrated colum $n$ density of the sim ulation, acmen from the position of the observerm arked in $F$ igur
grayscale shows the colum $n$ density, with contours in a geom etric sequence and labeling in units of kpc om ${ }^{3}$. ( $T$ he reader should keep in $m$ ind that our $m$ odel spans only from 3 kpc through 11 kpc in radius, and up to 1 kpc in z . The shaded region in the galactic center direction show s the angular extent of the central \hole" in our sim ulation grid. In addition, the full strength of the perturbation is applied only for $r>5 \mathrm{kpc}$, and therefore, the usefiulpart of the grid extends from $r=5$ to 11 kpc .) T w o vertical protuberances are clear in this Figure, corresponding to the directions tangent to the Sagittarius arm, at $160^{\circ}$ and 1 75. Im prints corresponding to other arm s are also present; they are harder to pick up in this Figure, but becom e evident when we restrict the line-af-ight integration to œrtain velocity ranges, as in $F$ igur ( $\mathrm{A} m \mathrm{ap} \mathrm{w}$ ith the line-of-sight com ponert f f the velocmes for the $m$ idplane is presented in $F$ igur $T$ he $P$ erseus arm appears in all the velocity ranges, out it is $m$ ore prom inent in $l>90^{\circ}$ at negative velocities, and $\mathrm{l}<90^{\circ}$ at $\mathrm{v}>20 \mathrm{~km} \mathrm{~s}{ }^{1}$. A lso prom inent are: a superposition of the P erseus, Scutum and Norm a arm s at between $10^{\circ}$ and $60^{\circ}$ at $v<20 \mathrm{~km} \mathrm{~s}{ }^{1}$; the Sagittarius arm from l $60^{\circ}$ to $90^{\circ}$ at interm ediate negative velocities, w ith a very large vertical extension; and a superposition of the Sagittarius and Scutum arm s at from $10^{\circ}$ to $60^{\circ}$ for large positive velocities.
$T$ he diagram for $0<v_{l o s}<20 \mathrm{~km} \mathrm{~s}{ }^{1}$ features three large column density elem ents. The one at $1 \quad 75^{\circ}$ corresponds to the Sagittarius arm. At l $0^{\circ}$ to $30^{\circ}$, we see a narrow stripe of the whole inner galaxy, including the P enseus, Scutum, and Sagittarius am s. The third elem ent, at $175^{\circ}$, corresponds to a tangent direction through the region between the Sagittarius and P erseus arm s , in which low er density gas spans a large distance w th a sm all range of velocities.

## 3. L V DIAGRAM.

Longitude-velocity diagram s are a straightforw ard w ay of presenting the data-cubes, and it is relatively easy to extract inform abion about global properties of the $G$ alaxy. $F$ igure
shows a longitude-velocity diagram as seen by an ooserver situated as $m$ arked in $F$ igur at galactic latitude $\mathrm{b}=0^{\circ}$. A gain, the shaded region $m$ arks the region around the galactic center that we do not include in ourm odel. Several features can be pointed out. The rotation curve, as traced by the extrem um velocity of the gas in the inner galaxy, has sm alldeviations from a at arree which are not sym $m$ etric about $l=0^{\circ}$ (see Section E ven w ithout velocity dispersion intrinsic to the gas $\Perp$ the $m$ odel, there is a fair am ount of gas

m oving at forbidden velocities in the generaldirection of the galactic antioenter (positive in the second quadrant, negative in the third). A lso, the gas in the anti-oenter direction has a positive $m$ ean velocity, while the envelope of the em ission averages to zero at $1 \quad 170^{\circ}$. These characteristics depend strongly on the chosen position for the observer. Features sim ilar to these are observed in 1 v diagram s from M iky W ay's H I surveys, although details (like the longitude of the zero velocily around the anticenter) do not necessarily coincide with our m odel. The proxim ity of our outer boundary ( 3 kpc in the antigenter direction) $m$ ight have som $e$ in uence on this.

$R$ idges and intensity enhancem ents in this diagram are usually interpreted as spiralarm s. Since in ourm odelwe have the advantage of know ing exactly where the m aterial is and with which velocity it is moving, we can trace the gaseous spiralarm sinto the sim ulated $l \mathrm{v}$ diagram. W e found the position of the spiral arms by $t-$ ting, for each radius in the sim ulation grid, a sinusoidal function along arimuth to the vertical colum $n$ density of the gac $F$ igure resents the result of the $t$, while $F$ igur races une spiral arm s into the $1 \quad v$ diagram. M ost or the ridges in this diagram correspond to spiral arm S , although the relation is not one-to-one. For exam ple, around $l=120^{\circ}$, at the $P$ erseus arm, the line of sight goes through a large velocity gradient, which spreads the arm in velocity, and di uses the ridge. T he converse also happens: lower intensity ridges that are not related to spiral arm s are generated when the velocity gradient is sm all, and large spatialextents condense into a sm all velocity range, for exam ple, at ( $\mathrm{l} ; \mathrm{v}$ ) $\quad\left(90^{\circ} ; 30 \mathrm{~km} \mathrm{~s}{ }^{1}\right)$. $T$ he capacity of the velocity eld to create or destroy structures in this diagram with little reg


## 4. V B DIAGRAM.

A nother natural way of presenting data cubes is the velocity-latitude diagram. For our $m$ odel, the v b diagram show sthe signature of the vertical structure of the spiralarm-

N otice the higher intensity ridge that runs from $\mathrm{v}=0 \mathrm{~km} \mathrm{~s}^{1}$ at b $40^{\circ}$ to about $\mathrm{v}=8 \mathrm{~km} \mathrm{~s}^{1}$ at the galactic pole. That ridge is generated by crow ding of the falling gas in velocity space. A spectrum taken tow ard those latitudes would show a line that could be interpreted as a cloud, although the gas has no spatial concentmtion.
Figur zoom s into a $20^{\circ}$ rection around the galactic $m$ idplane. Exam ination off igur how $s$ that such line-of-sight crosses the P erseus arm at v $\quad 30 \mathrm{~km} \mathrm{~s}{ }^{1}$ and the Norm a arm at v $70 \mathrm{~km} \mathrm{~s}{ }^{1}$, very close to the sim alotion at those approxim ate velocities, Figure an show \m ushroom " shaped structures, w ith a resanveny narrow, horizontal stem and large vertical cap on the left edge of the stem. These are the characteristic signatures of the vertical structure of the gaseous arm s , along w th a tendency of the tip of the cap to bend slightly back over the stem, to less negative velocities at higher latitude.
In amonto guide the follow ing discussion, we present in Figur he density (grayscale) and line-of-sight com ponent or the velocity (contours) along a vertical plane in the $1=75^{\circ}$ direction. Since we are looking at the arm from the concave side, the gas $m$ oves through it from left to right, though not parallel to the plane of the $F$ igure. $T$ he reader should keep in $m$ ind that these velocities are the result of the presence of the arm s on top of the galactic rotation. If the gas were in purely circular orbits, we should see positive velocities up to the solar circle, at a distance of $4: 1 \mathrm{kpc}$, and then negative velocities, $m$ onoton ically decreasing until the edge of the grid. This general pattem is found in the $F$ igure, w ith velocities increasing from 0 to $+10 \mathrm{~km} \mathrm{~s}^{1}$ at 2 kpc , then back to zero at 4 kpc , going increasingly negative, though not $m$ onotonically, beyond that.

Let us concentrate on the $P$ erseus arm, at about 6 kpc .

Just upstream from the arm, there is a vertically thin distribution of $m$ aterial form ed by the dow $n$ ow from the Sagittarius arm. The encounter of this $m$ aterialw ith the arm decelerates the gas, appearing as a rapid succession of decreasing velocity contours at d $4: 5 \mathrm{kpc}$. T hat velocity gradient spreads the vertically thin gas structure along the horizontal axis of the $v$ b diagram, creating the stem structure in the m idplane. Beyond 5 kpc , we have the vertically swellod structure of the arm itself, which appears in $F$ igur mushroom cap. Between b is the vertically extended and $7^{\circ}$, the gas is speeding up above the arm increasing its line-of-sight velocity, causing the tip of the cap to slightly bend back over the stem. ( $T$ he reversal of th is trend betw een $\mathrm{b} \quad 7: 5^{\circ}$ and $10^{\circ}$ involves a very sm all am ount of $m$ aterial very close to the verticalboundary and could be an artifact.) $W$ ithin the arm, the radial velocity has one orm ore extrem es, creating caustics as the gas doubles back in velocity space. This behavior repeats as we approach the N orm a arm, but we reach the sim ulation boundary before developing the full arm structure, and we get only the stem and the beginning of the cap.
$W$ hen we restricted the integration to the thin preshock interarm region, we notioed that ita bim print is very sm all. But, as seen in $F$ igur the true \interarm " region is much broader and incuraes the high $z$ part of the cap of the previous arm, after the $m$ idplane density has-dommased.
In Figure
the $v \quad b$ diagram for the sim ulation in the $l=19$ direction is com pared $w$ ith the equiv-
 ities of the spiral arm s , along w th the characteristic gap betw een caps of successive am s. At other galactic longitudes, the observed pattem is less regular, presum ably due to galactic com plexities not found in ourm odel. No otice that, in the survey data, the galactic w anp displaces the $m$ ushroom structures o the $b=0^{\circ}$ plane, while restrictions in the sim ulation does not allow such sym m etry break.

## 5. ROTATION CURVE.

In order to estim ate the in uence of the spiral arm s on $m$ easurem ents of the galactic rotation curve, we m easured it in the sim ulation in a way that em ulates how it is $m$ easured in the $M$ ilky $W$ ay. For gas inside the solar circle, we picked a galactic longitude. W e then looked for the $m$ axim um velocity along the line-of-sight ( $m$ ini$\mathrm{m} u m$ for negative longitudes) and assum ed that it arises from the tangent point and, therefore, the gas at that galactocentric radius $m$ oves $w$ ith that extrem e velocity. By repeating this procedure for an array of galactic longitudes, we can tman the rotation curve interior to the solar circle. $F$ igur how s the results. T he dotted line show s the case for une northem galaxy, while the dashed line shows the rotation curve for the southem galaxy. For com parison, the rotation curve that arises from the hydrostatic plus rotationalequilibrium in the initialcon-

$80^{\circ}$ ( $6: 5 \mathrm{kpc}<\mathrm{r}<7: 8 \mathrm{kpc}$ ) than in the corresponding negative longitudes by som e $7 \mathrm{~km} \mathrm{~s}{ }^{1}$. The converse happens in the $40^{\circ}<1<55^{\circ}$ range ( $5 \mathrm{kpc}<\mathrm{r}<$ $6: 5 \mathrm{kpc}$ ). This behavior and the am plitude of the oscillations are reproduced by our simulations, although around $r=7: 5 \mathrm{kpc}$, the di erence betw een our rotation curves, $10 \mathrm{~km} \mathrm{~s}^{1}$, is som ew hat larger than observed.

## 6. KINEMATIC DISTANCES.

An im portant use of the rotation curve is the estim ation of distances in the G alaxy, by assum ing that the target $m$ oves in a circular onbit. In this section we try to estim ate the error in those distances. The fact that the calculated curve falls below the rotation set by the rotatinnalhydrostatics and the background potential (F igure creates lines of sight in which the gas never reaches une velocity that direction should have in circular orbit, and therefore, if this \true rotation" is used to estim ate distances, no gas would be assigned to those regions. If we im agine the galaxy as $m$ ade of nubber and being distorted by the distance errors, the picture obtained w ould have large holes in those regions. For this reason, and for self-onncistency, we used the rotation curve derived in Section

Since we nave the privileged in form ation of where the gas really is, we can estim ate the error created by assum ing that the gasm oves in circular orbits $w$ ith the adopted rotation curve. At a given distance along a xed longitude direction, we take the velocity of the gas given by the sim ulation, and calculate at w hat distance the circular orbit assum ption puts it. Even if the rotation curve

has oscillations, the line-of-sight velocity of the gas in circular orbits $m$ ight rem ain $m$ onotonic on either side of the tangent point, provided that the ooillations are not too large (as can be seen in Figur that is not the case above the plane, but here we focus in the distances

errors to the spiral arm s, the density is plotted also (dashed-dotted line). A though it depends on the galactic longitude, the distances tend to be over-estim ated around the arm $s$ and under-estim ated in the interarm $s$ by a varying am ount, typically sm aller than 1 kpc . G as $m$ oving at forbidden velocities cannot be given a location w th this m ethod.

## 7. CYLINDRICALROTATION .

$K$ inem atics of the gas above the galactic plane hasbeen studied as a test for $m$ odels for the galactic fountain, which in tum are used to explain the ionization of the ISM at high $z$ (see discussion in $M$ iller \& Veilleux 2003). U nfortunately, the velocity resolution achieved for external galaxies m akes it di cult to estim ate rotation velocity gradients over the vertical distance our m odels span, and therefore com norison is di cult. Nevertheless, we present in $F$ igur a synthetic spectrum that could be obtained by placung une slit penpendicular to the galactic plane, at a distance of $6: 2 \mathrm{kpc}$ from the galactic center. Three spiral arm crossings are clear in this picture, at $160 ; 195$ and $145 \mathrm{~km} \mathrm{~s}{ }^{1}$ (respectively, as we m ove aw ay from the observer). N otioe that the arm s show a leaning tow ard higher velocity as we m ove up, due to the gas speeding up over them after the shock. A lso, the arm at $195 \mathrm{~km} \mathrm{~s}{ }^{1}$ spreads over a range of velocities, since we look at it at a sm aller angle.

The right lim it of the em ission in this diagram is usually associated $w$ th the rotation of the galaxy. T hat m axim um velocity is not reached at the point of sm allest radius, the tangent point, but the o set is quite sm all ( 1 kpc or less). That point corresponds to an interarm region, where the gas falls back dow $n$ to the plane, and slow $s$ dow $n$ as it $m$ oves out in radius. Therefore, near the $m$ idplane, this $m$ axim um velocity falls below the rotationalvelocity that we get when repeating this exercise at a di erent radius.

As in previous cases, not all the ridges in this plot
correspond to density structures, but are generated by velocity crow ding. Such is the case of the elem ent at $\mathrm{V}_{\text {los }}>220 \mathrm{~km} \mathrm{~s}{ }^{1}$ around $\mathrm{z}=200 \mathrm{pc}$, which is generated by a plateau of nearly constant velocity in a region w ith density lower than its surroundings, which have a larger spread in velontry
From Figur we would in fer that the velocity $m$ axim um increases som e $20 \mathrm{~km} \mathrm{~s}{ }^{1}$ up to $\mathrm{z}=200 \mathrm{pc}$, and then com esback dow n to $220 \mathrm{~km} \mathrm{~s}{ }^{1}$ around $\mathrm{z}=400 \mathrm{pc}$. W hen placing the slit at a di erent position, we get sim ilar beh heights observed a sim ilar behavior in a coupse or galaxies in their sam ple, although w ith a larger velocity am plitude. T hose seem to be exceptions, since $m$ ost of the galaxies in their sam ple do not show signi cant gradients. T he am plitude of the velocity gradient in this m odelw ould have been di cult to detect with the resolution achieved in their study.

## 8. SYNCHROTRON EM ISSION .

$F$ igure shows an all sky $m$ ap of the synchrotron em ission. I ne grayscale corresponds to the total synchrotron intensity, while the direction of the $m$ agnetic eld, as inferred from the polarization of the integrated em ission, is presented in dashes. T he synchrotron em issivity is given by

where $B$ ? is the com ponent of the $m$ agnetic eld perpendicular to the line-of-sight, $p=2: 5$ is the spectral index of the distribution of cosm ic ray electrons, $\mathrm{n}_{\mathrm{cr}}=$ $\exp \left(r=r_{c r} \quad \ldots \quad\right.$ density, $r_{c r}=13 \mathrm{kpc}$ and $z_{\text {cr }}=2: 5 \mathrm{kpc}$ For each ( $1 ; \mathrm{b}$ ) direction, this em issivity is nlegratea, and the direction of the polarization is accounted for by the process described in $P$ aper II.

The degree ofpolarization of the integrated em ission is generally high, varying from $>70 \%$ in the $m$ idplane and

in the $10^{\circ}$ and $180^{\circ}$ at all latitudes, to $40 \%$ in four isolated regions tow ard ( $1 ; \mathrm{b}$ ) ( $120^{\circ} ; 70^{\circ}$ ). This is expected, since our resolution does not allow us to m odel the random com ponent of the eld.

To help with the discussion of this $m$ ap, we present ${ }^{\text {th }} \mathrm{m}$ idplane $m$ agnetic eld in the sim ulation in $F$ igure reproduced from P aper II. The grayscale represents une surface density, and the dashes follow the direction of the $m$ agnetic eld, w ith its length proportional to the eld strength.
Recalling Figure the second and third quadrants have interarm gas neanoy. The e erseus arm is 2 kpc aw ay in the $l=180^{\circ}$ direction, and 5 kpc aw ay tow ard $l=90^{\circ}$. In that $90^{\circ}<1<180^{\circ}$ range, near the m idplane, the $m$ agnetic eld has a negative pitch angle. This has the e ect that the eld is pointing directly tow ard the observer, and the plane-ofthe-sky com ponent is very sm causing the low em ission at low latitudes in $F$ igur A round the $l=90^{\circ}$ direction, that negative pitch ange-

increases the com ponent of the eld pro jected in the sky, causing a higher em ission in the $90^{\circ}<1<60^{\circ}$ range. On the other hand, the eld above the plane tw ists m ore abruptly, w ith a sm aller negative pitch region, yielding a short path length to integrate over and leaving only a sm all im print on this plot. A s a consequence, o the galactic plane, we see a pattem in the sky that resem bles that of a circular eld: horizontal in the $1 \quad 0^{\circ}$ and $180^{\circ}$ at all latitudes, and in the $m$ idplane, at all longitudes; nearly vertical o the plane in the $190^{\circ}$ and $90^{\circ}$ directions (the sky projection of an overnead circle).

A though the sign of the radial com ponent of the eld changes between the arm and interam regions, those changes are not enough to account for the changes in the di erential rotation $m$ easure that are typically interpreted as netic eld and references therein).

## 9. CONCLUSIONS.

By placing an im aginary observer inside the $m$ odeled galaxy from Paper II, we generated various synthetic observations. Since we actually know where the gas is, we can distinguish which parts of the m odel are generating the observed structures. In particular, velocity crow ding e ects can be distinguished from real spatial concentrations.

The synthetic $l v$ diagram hascom $m$ on characteristics w ith the observed diagram, although some sim ilarities are only in a qualitative level. A gain, velocity crow ding generates ridges that do not correspond to spiral arm s. But the converse also happens, as a large velocity gradient can dihute a spiral arm in velocity space. In the $v$ b diagram, on the other hand, velocity crow ding and dilution generate structures that test the vertical distribution ofm atter and velocity above the am s presented in Papers I and II. Such structures can be observed in the Leiden/D w ingeloo H I survey.

W e also explored the rotation curve that the im aginary observer would $m$ easure from $w$ thin the $m$ odel galaxy. Several of the characteristics of this $m$ easured rotation curve are also observed in the curve $m$ easured for the M ilky W ay, being higher in som e radial ranges than on the opposite side of the galactic center. T his agreem ent is probably a consequence of our having tried to $t$ the positions of the spiralarm sin ourm odel to the proposed positions for the G alaxy. $N$ evertheless, the $m$ easured rotation curve has large deviationsw ith respect to the rotation from our initial conditions, which is also in uenced by pressure gradients and $m$ agnetic tension and is therefore slightly di erent from the rotation consistent w ith the background gravitational potential.

A though the $m$ agnetic eld is largely non-circular, the averaging $e$ ect of the synthetic synchrotron $m$ aps generates a largely circular im print, w ith exception of the m idplane. A s m entioned in P aper II, restrictions in our m odel lim it the am ount of vertical eld that our m odel generates, increasing the circularity of the eld and di$m$ inishing the verticalextent of the synchrotron em ission.
$T$ he ISM ofthe $M$ ilky $W$ ay G alaxy is very com plex system, in which $m$ any di erent physical processes com bine to generate large scale structure. The extra freedom of the third dim ension and the dynam icale ects of a strong $m$ agnetic eld, in our view, are two key elem ents in the form ation of such structures. Until we nd a way of re-
liably $m$ easuring distances to the di use com ponents of the disk, velocity crow ding e ects w ill keep blurring and distorting the pictures we generate. M ore realistic modeling w ith higher resolution, inclusion of gas self-gravity, and stellar feedback (including cosm ic ray generation and di usion) is necessary to further clarify that picture.
