## THE ROLE OF PRESSURE IN GMC FORMATION

## ABSTRACT

W e exam ine the hypothesis that hydrostatic pressure alone determ ines the ratio of atom ic to m olecular gas averaged over a particular radius in disk galaxies. The hypothesis in plies that the transition radius, the location where the ratio is unity, should always occur at the same value of stellar surface density in all galaxies. We exam ine data for 28 galaxies and nd that the stellar surface density at the transition radius is indeed constant to 40% at a value of 120 M pc<sup>2</sup>. If the hypothesis can be con me ed at all radii within a large range of galaxy types and metallicities, combining it with the observed constancy of the star form ation rate with H2 surface density may enable a physically m otivated star form ation prescription with wide applicability. ## 1. INTRODUCTION

Current ideas about the formation of GMCs present a nagging puzzle. Some authors have suggested that GMCs form by agglom eration of pre-existing molecular clouds (e.g. Scoville & Hersh 1979; Kwan & Valdes 1983). Others have argued that GMCs form primarily from atom ic gas through som e sort of instability or large-scale shock (e.g. W oodward 1976; Blitz & Shu 1980; Engargiola, et al. 2003). In principle, both modes may occur: in galaxies that are predom inantly atom ic, GMCsm ight form by one process, and in galaxies that are primarily molecular, the GMCsmight form by another. If so, two di erent GMC form ation mechanisms could be at work in the sam e galaxy because m any galaxies show a transition from being predom inantly molecular at their centers to being predom inantly atom ic in their outer parts (e.g. Wong & Blitz 2002; Helfer et al. 2003). For example, in the outer parts of spiral galaxies there is so little molecular gas (e.g. Dam e et al. 1987; Dam e 1993; Heyer et al. 1998) that making GMCs from atomic gas seems to be the only available form ation pathway. On the other hand, the centers of many galaxies are so overwhelm ingly molecular (e.g. Mauersberger et al. 1989; Young et al. 1995; W ong & Blitz 2002, Helfer et al. 2003) that it is implausible for the inner galaxy molecular clouds to form from anything other than pre-existing molecular gas. The stars in these galaxies form only from molecular gas, yet there is no obvious change in the star form ing properties across the molecular/atomic transition region. How could it be that molecular clouds that form by two independent processes would show no obvious di erence in their star form ation properties?

independent of whether the preexisting gas is atom ic or m olecular. That is, the ratio of atom ic/m olecular gas depends on som e other factor, such as the am bient pressure. Because the rate of star form ation depends only on the am ount of molecular gas (Wong & Blitz 2002), whatever determ ines the molecular gas surface density, determ ines the variation of star form ation within a galaxy.

One possibility is that the process of cloud form ation is

In this paper, we consider the hypothesis that the m olecular gas fraction in a galaxy disk is determ ined by the m ean hydrostatic pressure at a particular radius. We show that if the hydrostatic pressure is the only param eter determ ining the molecular gas fraction, one predicts that the radius at which the atom ic and molecular gas surface densities are the same, the transition radius, occurs at a constant value of the stellar surface density, Remarkably, in a sample of 28 galaxies, is found to be constant to about 40% at the transition radius, even though the observed variation of in these galaxies is at least 3 orders of magnitude.

# 2. BACKGROUND

Several authors have previously suggested that gas pressure determ ines the molecular fraction at a given radius in a galaxy. Spergel & Blitz (1992), for example, argued that the extraordinarily large molecular gas fraction at the center of the Milky Way is plausibly the result of the very high hydrostatic pressure in the Galactic bulge. Elmegreen (1993) suggested on theoretical grounds that the ratio of atom ic to molecular gas in galactic disks results from both the ambient hydrostatic pressure as well as the mean radiation eld. The dependence on the pressure is steeper than that of the radiation density  $(f_{m ol} / P^{2:2}j^{1:1})$  and ought to be the dom inant factor. Observationally, Wong and Blitz (2002) showed that the radial dependence of the atom ic to molecular gas ratio in seven molecule rich galactic disks can be understood to be the result of the variation in interstellar hydrostatic pressure (with  $f_{m ol} / P^{0:8}$ ).

Let us assume, therefore, that N  $(H_2)/N$   $(H_1)$ , the ratio of H<sub>2</sub> column density to H I column density, is determ ined only by the midplane hydrostatic pressure,  $P_{\text{ext}}$ . In an in nite disk with isothermal stellar and gas layers, and where the gas scale height is much less than the stellar scale height, as is typical in disk galaxies, to order:

where q is the total surface density of the gas,  $v_q$  is the velocity dispersion of the gas, is the midplane surface density of stars, and  $\,_g$  is the m idplane surface density of gas. The  $\,$ rst term on the right is due to the hydrostatic pressure of the gas in the stellar potential; the second term is due to the self-gravity of the gas.

In most galaxy disks, is much larger than  $_g$  when averaged over azimuth, except in the far outer parts of a galaxy where the stars become quite rare. In the solar vicinity, for example, = 0.1 M pc  $^3$  (e.g. B inney & Merri eld 1998), but  $_g$  ' 0.02 M pc  $^3$  (e.g. Dame 1993). For a self-gravitating stellar disk, =  $^2$   $^2$   $^2$  h, where h is the stellar scale height and h =  $^2$  (v  $^2$ =4 G ) $^0$ :5. Thus, neglecting  $_g$ , Equation 1 becomes:

where  $_{\rm g}$  is the total surface density of the gas,  ${\rm v}_{\rm g}$  is the velocity dispersion of the gas,  $_{\rm g}$  is the m idplane surface density of stars, and  $_{\rm g}$  is the m idplane surface density of gas. D irect solution of the uid equations by numerical integration shows that this approximation is accurate to 10% for  $_{\rm g}$  20 M pc  $_{\rm g}$  (where  $_{\rm g}$ ), which covers the range of stellar surface densities in this study.

We choose to express the midplane pressure in the form of Equation 2 since there is good evidence that both h and  $v_{\alpha}$  are constant with radius in disk galaxies. Furthem ore, because of the weak dependence of Pext on h, and the small variation of h measured among galactic disks, we expect variations of h to have little effect on  $P_{\text{ext}}$ . The constancy of the stellar scale height within galaxies was demonstrated by van der Kruit & Searle (1981a,b) and has been con med in other edge-on galaxies (e.g. Fry et al. 1999). While there is some evidence that the stellar scale height ares at large radius in som e galaxies (Narayan & Jog 2002), this is only found only at the edges of stellar disks in regions where the stellar, gaseous and dark matter components of the disk m ake com parable contributions to the potential. A dopting a constant stellar scale height is further supported by the observations of Bottem a (1993), who shows that the stellar velocity dispersion follows an exponential distribution with scale length twice that of the stellar surface density in disks. This observation suggests that the stellar disk is distributed vertically in a sech  $^2$  z pro le with  $= (\overline{2} G h)^{1=2}$ .

W hile the stellar component of galactic disks can be approximated with a constant scale height, the gas component is better described by a constant velocity dispersion, g, which is observed in face-on galaxies (e.g. Shostak & van der K ruit 1984; Dickey et al. 1990) and the Milky W ay (Burton 1971; Malhotra 1995). The Milky W ay observations show that the gas scale height decreases as the stellar surface mass density increases in a manner consistent the gas remaining isothermal (Malhotra 1995). This ensemble of observations suggests that  $_{\rm g}=8~{\rm km~s}^{-1}$  characterizes the H I velocity dispersion in the stellar dominated regions of galactic disks.

Thus, since  $(v_g = \frac{p}{h})$  is approximately constant within galaxies, then

$$N (H_2)=N (H I) = f P_{ext}(g; )$$

The mass surface density of atom ic gas,  $_{\rm H\,I}$ , is reasonably constant across the inner portions of galactic disk (e.g. W evers et al. 1986; C ayatte et al. 1994; W ong & Blitz 2002). While some changes of HI with radius are observed, the variation is small compared to the changes observed in stellar surface mass density and molecular surface mass density. We may therefore adopt a single value for the surface density of atom ic gas in a galaxy across the stellar disk. N (H I) saturates at a value of about 1 10°1 cm 2 (Wong & Blitz 2002). Thus, N  $(H_2)/N$   $(H_1)$  has a value of unity when 2N (H<sub>2</sub>)+N (H I) has a value of 2  $10^{1}$  cm  $^{2}$ . Equation 2, therefore im plies that the radius where the atom ic and molecular surface densities are equal in spiral galaxies depends only on if  $v_g/h$  is constant.

### 3. RESULTS

We use B IM A SONG (Helfer et al. 2003), an interferom etric imaging survey of the CO in 44 nearby spirals, to determ ine the distribution of the molecular gas. To determ ine the H $_2$  surface density, we use a conversion factor of N (H $_2$ )/T $_{\rm A}$  (CO) v = 2 10 $^{\!0}$  cm  $^2$  (K km s  $^1$ )  $^1$ . For the H I, we adopted a single value that characterizes the column density across the galactic disk. These values were drawn from maps of galaxies reported in the literature. A dopted values and the corresponding references appear in Table 1 along with the orientation parameters and distances used in Helfer et al. (2003). If no H I observations have been reported for the galaxies, we used a value of 8 M pc  $^2$ , which corresponds to a surface density of 1  $10^{\!0.1}$  cm  $^2$ , typical for the stellar disks of galaxies.

The stellar surface densities are determ ined using reduced K-band in ages from the 2M ASS Large Galaxy Atlas (Jarrett et al. 2003). We adopted a constant K-band mass-to-light ratio of M $_{\rm L}$ =L $_{\rm K}$ =0:5M=L (Bell & de Jong 2001). Our nalsample consists of only those

galaxies with both 2M ASS data and CO detections. Of these, 22 galaxies have H I surface densities in the literature and 6 galaxies do not. The stellar and gas surface densities are corrected to face-on values using the orientation parameters listed in Table 1.




Fig. 1. Plot of the median stellar surface mass density where N (H  $_2)$  N (H I) as a function of where this surface density occurs in the galaxy. For galaxies with measured H I densities (lled circles, 22 galaxies), the range of stellar surface densities is plotted as an error bar, running between the values of the 1st percentile and the 99th percentile of surface density in the galaxy. Galaxies without H Im easurements are plotted as open circles (6 galaxies). The transitions stellar surface density is remarkably constant and has a mean value of 120 10 M pc  $^2$  for the 22 galaxies with both CO and H I data. Points for the M ilky W ay (M W ) and M 33 are also plotted.

We de ne the transition stellar surface density ( ::) where N  $(H_2)$  = N  $(H_1)$ , as the median value of the stellar surface density at all positions for which 0:9N (H I) N (H<sub>2</sub>) 1:1N (H I). We associate this surface mass density with the transition radius Rt in the galaxy by nding the radius where the azim uthally averaged stellar surface m ass density (R<sub>gal</sub>) equals the transition it. In Figure 1, we plot the transition surface density, radius against the transition stellar surface density, using the adopted distances in Table 1. We also list the values ;t are listed in Table 1 as a check since Pext of <sub>HT</sub> depends directly on this quantity.

Figure 1 shows a remarkable constancy of if N (H2)/N (H I) is determined by pressure only; the 10 M pc<sup>2</sup>. Also plotted in the mean value is 120 qure is the range of m easured for each individual galaxy. Formally, the dispersion in the mean value of ;ty is only 40%, yet the the range of to which the 2M ASS survey is sensitive in these galaxies varies, by almost 3 orders of magnitude. The scatter in HI given in Table 1 is only 60%. The range of galactocentric distance where the transition radius occurs varies by m ore than an order of magnitude. Apparently, the con-;t is not due to a sm all range in the observed stancy of properties of the galaxies. The small scatter in suggests that various assum ptions such as that of a constant value of h both within and among galaxies are justi ed.

As a check, one can calculate the value of  $_{;t}$  for the M ilky W ay, scaling the measured at the distance of the Sun (35 M pc  $^2$ ; B inney & M erri eld 1998), and a radial scale length for the stars of 3 kpc (Spergel, M alhotra & B litz 1996; D ehnen & B inney 1998). The transition radius for the M ilky W ay occurs at a galactocentric distance of about 4 kpc (D am e et al. 1993), or about 1.3 scale lengths inward of the Sun. This converts to a stellar surface density of 132 M pc  $^2$ , in good agreem ent with the determinations in other galaxies. The trend can also be checked in M 33 using the data for  $f_{m \ ol}$  presented in H eyer, C orbelli, Schneider, & Y oung (2004), which gives  $_{;t}$  = 190M pc  $^2$  where  $_{H \ I}$  =  $_{H \ 2}$  (R  $_{gal}$  = 300 pc).

There appears to be a small but signi cant decrease in the transition surface density with radius, which may be due to a breakdown of the assumptions of a constant mass-to-light ratio,  $v_{\rm g}$  and hwith radius, or that pressure alone determines N (H $_2$ )/N (H I). A linear to the data in Figure 1 gives log = (2:36 0:05) (0:06 0:01) (R=1 kpc)M pc  $^2$  with errors given by the scatter in the data around the trend.

### 4. DISCUSSION

Figure 1 is consistent with the hypothesis that the m ean hydrostatic pressure determ ines the ratio of atom ic to molecular gas at a given radius in a disk galaxy. The sm all scatter in the mean value of suggests that globally, the pressure m ay be the only im portant factor in determ ining the ratio of atom ic to molecular gas. But the variation in the hydrostatic equilibrium of a disk is expected to be rather sm ooth. W hy then do galaxies show so much azim uthal variation in the molecular gas, and by im plication in the atom ic-to-m olecular gas ratio (Helfer et al. 2003)? Signi cant variations in the interstellar pressure can result from a variety of causes such as spiral shocks and explosive events (e.g. supernovae). Thus large pressure variations can occur on all scales locally even if the mean hydrostatic pressure varies only slowly. Furtherm ore, even if the hydrostatic pressure drives the ratio globally, locally the radiation eld can be important in determ ining how much of a molecular cloud can rem ain neutral (Hollenbach & Tielens 1999). Thus, signi cant deviations from the mean molecular abundance can be produced by both pressure and radiation variations.

Pressure or density? The rate of form ation of moleculargas is thought to be dependent on the local gas density in the chemical reactions that produce H 2 and CO.Are we then using pressure as a surrogate for the mean gas density in determining N (H2)/N (H I) as a function of galactocentric distance? Pressure, as de ned in Equations 1 and 2, is taken to be  $g \frac{2}{g}$  where g includes both therm aland turbulent contributions. Because q is m easured to be typically  $7 \{ 8 \text{ km s}^{1} \text{ and the gas tem}$ perature of the cold gas layer where most of the gas mass resides is typically .  $100\,\mathrm{K}$  , the therm alpressure is only a sm all fraction of the turbulent pressure. Observationally,  $_{q}$  is constant with radius (see x2), thus  $P_{ext}$  /  $_{q}$ ; variations in pressure are e ectively the same as variations in density. We choose to describe the functional dependence in terms of pressure rather than density because it is directly measurable through Equation 2 (assuming h is known), whereas the density is inferred and not directly measurable on galactic scales. But it should be kept in mind that given the measured constancy of  $_{\rm g}$ , we cannot distinguish the e ects of pressure from those of density.

W hat pressure is in plied by  $_{i}$ ? In the M ilky W ay, the value of h is about 300 pc (B inney & M erri eld 1998),  $v_g$  is about 7 km s  $^1$  (D ickey & Lockman 1990),  $_g$  is 8.6 M pc  $^2$ , and is 132 M pc  $^2$ . U sing Equation 2,  $P_{\rm ext}=k=1.5$   $10^4$  cm  $^3$  K after correcting for helium . This value is still an order of magnitude below the mean internal  $P_{\rm int}=k=3$   $10^4$  cm  $^3$  K for GMCs that have typical surface densities of 100 M pc  $^2$  (B litz 1993). Because  $P_{\rm int}=k=1.0$  y, must be self-gravitating. U sing Equation 2 to scale  $P_{\rm ext}=k=1.0$  to the inner regions of disks suggests that GMCs are self-gravitating over nearly the entire disk.

W hat are the implications for understanding star form ation on galactic scales? If the global atom ic {molecular transition is governed by pressure across a wide range of galaxies, it will be possible to develop a perscription for star form ation on global scales that is physically well motivated. Non-thermal radio-continuum is tightly correlated with the far IR emission in galaxies (e.g. Condon 1992), in plying that the radio-continuum is a good extinction-free indicator of the star formation rate in spiral galaxies. Murgia et al. (2002) have shown that for a sample of 180 spiral galaxies, the ratio of radio-continuum to CO emission is constant to within a factor of 3, suggesting that the star formation e ciency of

m olecular clouds averaged over galactic scales is constant at about 3.5%. Therefore, if the relationship between pressure and N ( $\rm H_2$ )=N ( $\rm H_2$ ) (i.e. the function f in Eqs. 1 and 2) can be determined for all galaxies, or if the variation in f can be found for di erent galaxy types, then it will be possible to determine the star form ation rate in galaxies by measuring the stellar and gas surface densities only. Furthermore, it will be possible to obtain reliably the star formation rate from simulations, since the turbulent gas pressure can be directly calculated. In addition, if the variation in f can be measured for galaxies of low metallicity, then determining the star formation rate can be extended to high z. The measurement of f will be the subject of a future paper.

We suggest, then, that GMCs can form from either preexisting atom ic or molecular gas depending on the dominant state of the di use interstellar medium at a particular radius in a galactic disk. That dominant state is determined by the hydrostatic pressure, modiled by local perturbations such as density waves, supernova remanants, etc.
