Euclidean A lgorithm for a G ravitational Lens in a Polynom ial Equation

#### Abstract

The Euclidean algorithm in algebra is applied to a class of gravitational lenses for which the lens equation consists of any set of coupled polynom ial equations in the im age position. In general, this algorithm allows us to reduce an apparently coupled system to a single polynom ial in one variable (say $x$ in C artesian coordinates) without the other com ponent (say y), which is expressed as a function of the rst com ponent. This reduction enables us to investigate the lensing properties in an algebraic $m$ anner: For instance, we can obtain an analytic expression of the caustics by com puting the discrim inant of the polynom ialequation. To illustrate th is Euclidean algorithm, we re-exam ine a binary gravitational lens and show that the lens equation is reduced to a single real fth-order equation, in agreem ent with previous works. We apply this algorithm also to the linearlized Kerr lens and nd that the lens equation is reduced to a single real th-order one.


## x1. Introduction

G ravitational lensing plays an im portant role in $m$ odem astronom y, in particular in the problem s of determ in ing the cosm ological param eters, probing the $m$ ass pro le of galaxies, and detecting a dark ob ject such asM AC HO.W hen the lensm ass distribution is axially sym $m$ etric along the line of sight, the basic equation is reduced to one dim ension. E xcept in this case, the system is coupled nonlinearly in general. It is thus believed that we need num erical treatm ents. Recently, how ever, the lens equation, which is apparently coupled, has been show n by chance to be reduced to a single real algeb raic equation even for asym $m$ etric cases, such as those of a tw o-point
 be expressed as a single com plex algebraic equation in the com plex form alism . $\mathbf{L}^{1}$ ', '5', H ow ever, this equation is nonlinearly coupled in the real and im aginary parts, and therefore we m ust solve it num erically.
$T$ he reduction to a single real algebraic equation enables us in principle to study the lensing properties analytically or num erically in an e cient and accurate $m$ anner. For instance, we can obtain an analytic expression for the caustics, (a) ; ${ }^{(3)}$ (3) which is a curve in the source plane, and a criteria for a change in the num ber of im ages. The reason that this can be done is that this change corresponds to that in the num ber of realroots for the single realalgeb raic equation, which is determ ined by a discrim inant in algebra. (2)

[^0]It is worthwhile mentioning the resultant method, a part of the elim ination
 equations have a com $m$ on root. For instance, let us take the $C$ artesian coordinates $(x ; y)$ to denote these equations by $P(x ; y)=0$ and $Q(x ; y)=0 . W$ e can apply the resultant $m$ ethod to our problem : F irst, these equations are considered only for $y$. A com $m$ on root $y$ for them exists if the resultant vanishes, where the resultant is a function of $x$, denoted by $X$ ( $x$ ). Sim ilarly, a com $m$ on root $x$ exists if for the resultant $Y(y)$, we have $Y(y)=0$, if we pay attention to only $x . H$ owever, all of the roots for these equations, $X(x)=0$ and $Y(y)=0$, do not necessarily satisfy the original equations $P(x ; y)=0$ and $Q(x ; y)=0: A n$ appropriate com bination of a root $x$ for $X(x)=0$ and $y$ for $Y(y)=0$ is true, but the resultant $m$ ethod itself never tells about a way of choosing it.
 have a one-dim ensional equation for one com ponent of the coordinates and a linear equation for the other com ponent of the coordinates, which is solved trivially and thus regarded as a function. In this sense, such a form alism, in which we have a onedim ensional equation and the associated function, is not know $n$ for a m ore general lens system. The $m$ ain purpose of this paper is to dem onstrate that the Euclidean algorithm is w idely applicable to the lens equation for a pair of realpolynom ials. In section 2, we study a binary gravitational lens as an exam ple. In the A ppendix, a linearized $K$ err lens is investigated as another exam ple.

## x2. Euclidean algorithm

### 2.1. B inary G ravitational Lens

$W$ e consider a binary system consisting of two point $m$ asses, $M_{1}$ and $M_{2}$, and a separation vector $L$ from ob ject 1 to 2 , which is located at a distance $D_{L}$ from the

W e have the identity $1+2=1$. For brevity, 2 is denoted by . Equation (2.1) consists of a set of two coupled realquintic equations for ( $x ; y$ )

For two point $m$ asses at di erent distances, the lens equation becom es $m$ ore com plicated. T his has been previously investigated (e.g., E rdland Schneider (1993) (10) $)$.

## 22. Euclidean algorithm

 we search for a com m on factor of 20 and 12 . T he larger integer, 20 , is divided by the sm aller one, 12, w ith the rem ainder 8 , and 12 is divided by 8 w ith the rem ainder 4. Such a procedure is repeated until the rem ainder vanishes. $T$ hus, we obtain

which show sthat 4 is the greatest com m on divisor (G.C D.) of 20 and 12. A ctually, Eq. (2-6) can be rearranged as

Thus unity is the G.C D. in this case. This procedure is called the Euclidean algorithm, which is applicable w idely in algebra. Let us apply it to a pair ofpolynom ials, given in Eq. $\left.\overline{2}^{2} \cdot 5\right)$, in which a com $m$ on factor gives us a com $m$ on root, nam ely an im age position.

Equation $(\overline{2}-5)$ is coupled $w$ th respect to $x$ and $y$. For sim plicity, the separation of the binary is assum ed to be on the $x$-axis $'=(\prime ; 0)$. C onceming $x$, Eq. $[2 \cdot 5)$ consists of a fth-order equation and a fourth-order equation, respectively:

$W$ e divide $f_{5}$ by $f_{4} w$ ith the quotient $q_{3}$ and the rem ainder $f_{3}$ as

$w$ here $f_{i}$ is $i$-th order in $x$ and $q_{i}$ is linear in $x . W e$ can elim inate $f_{3}$ and $f_{2}$ from these equations in order to show that both $f_{5}$ and $f_{4}$ have a com $m$ on factor $f_{1}$ if $f_{0}$ vanishes. In short, Eqs. (2.9) and (2-10) are equivalent to the pair of equations $f_{0}=0$ and $f_{1}=0$. In the cases of integers considered above, Eqs. (2.6) and (2.7), $f_{1}$ and $f_{0}$ correspond to 4 and 0 , respectively.

Because $f_{1}$ is linear in $x$, it takes the form

where D (y) and E (y) are polynom ials in y, a, b, ' and , and G (y) is an algebraic function. Because $G(y)$ plays no role in the follow ing discussion, we w rite $D(y)$ and $E$ (y) as

The com m on root of Eqs. (2-9) and (2-10) is thus obtained by (1) solving Eq.


### 2.3. P articular cases

There can exist multiple roots in algebraic equations. A condition for a true m ultiple root is a discrim inant in algebra, which corresponds to the caustics in the theory of gravitational lenses. An apparent multiple root is due to the adopted coordinate system : For instance, let us im agine tw o roots $w$ th the sam e value of $y$ but di erent $x$. These tw o im ages appear on a line parallel to the $x$-axis. A rotation of the coordinate system breaks such an apparent multiplicity. H ere, we discuss th is apparent $m$ ultiplicity in our algorithm.

In the preceding subsection, we have assum ed $f_{i} \in 0 . H$ ow ever, $f_{1}=0 \mathrm{~m}$ ay be satis ed autom atically for a particular set of the lens and source param eters. $T$ hen, a com $m$ on factor for Eqs. (2-9) and (2-10) becom es $f_{2}$, which is second order in $x$. H ence, apparent multiple roots are located at the sam e y but di erent x. In this particular case, a practical strategy for solving the lens equation in our algorithm is (1) solving Eq. (2-2 $\mathbf{D}_{1}^{\prime}$ ) for y to nd single roots and m ultiple roots, (2a) substituting a single root $y$ into Eq. $[2-27$ ) to determ ine $x$, and (2b) substituting a multiple root $y$ into $f_{2}=0$ and solving it as a square equation for $x$. If the $m$ ultiplicity is three, the $m$ ultiple root $y$ m ust be substituted into $f_{3}=0$, which becom es a cubic equation for $x$.

Let us consider the example $(a ; b)=(1=2 ; 1=4)$ for ${ }^{\prime}=1$ and $=1=2$. Then, the fth-order equation is factorized as

x3. C onclusion

W e dem onstrated that the Euclidean algorithm workswell in the case of a binary gravitational lens: The im age position for Eqs. (2.9) and (2-10), whidh are a set of coupled polynom ial equations, is obtained by (1) solving Eq. (2.2 2 ) for $y$ and (2) substituting a root y into Eq. $(2 \cdot 27)$ to determ ine $x$. In the case ofm ultiple roots, we $m$ ust substitute the $m$ ultiple root $y$ into $f_{2}=0$ and solve it as a square equation for x . If the multiplicity is three, the $m$ ultiple root $y \mathrm{~m}$ ust be substituted into $f_{3}=0$, which becom es a cubic equation for $x$.

The Euclidean algorithm is applicable to any pair of polynom ials. The linearized K err lens is investigated in the A ppendix. It would be interesting to investigate $N$ point $m$ asses or som e analytic models for a galaxy ${ }^{(1)}$ if the lens equation is a polynom ial. These interesting applications w ill be considered in the future.

A Linearized $K$ err Lens

W e consider the linearized $K$ err spacetim ew ith $m$ ass $m$ and speci $c$ angularm o$m$ entum vector $q$. In units of the Einstein ring angular radius $E$, the lens equation for this spaœtim $e$ is expressed ast ${ }^{(11) ;}$; 121

Here, $D_{S}$ and $D_{\text {LS }}$ denote the distance betw een the observer and the source and the distance betw een the lens and the source, respectively. A though the orientation of the spin vector $q$ is arbitrary, only the projection of $q$ onto the lens plane $m$ akes contribution. On the lens plane, we adopt the C artesian coordinates such that $s=(0 ; s), \quad=(a ; b)$ and $=(x ; y)$. The lens equation becom es fth-order and fourth-order in $x$, respectively as

Thus the lens equation is reduced to a single, real fth-order one.
