Abstract. We present CCD UBVI photom etric and medium/high resolution spectroscopic observations obtained in the eld of the previously unstudied dissolving open cluster candidates NGC 5385, NGC 2664 and Collinder 21.0 ur analysis stands on the discussion of star counts, photom etry, radial velocity distribution, and proper motions available from the Tycho 2 catalogue. All the three aggregates clearly em erge from the m ean G alactic eld, but, regrettably, the close scrutiny of properm otions and radial velocities reveals that we are not facing any physical group. Instead, what we are boking at are just chance alignments of a few bright unrelated stars. Our analysis casts som e doubt on the Bica et al. (2001) criterion to look for Possible Open Cluster Rem nants. It seem sm andatory to de ne a better criterion to adopt for further investigations.

1. Introduction

Bica et al. (2001) identi ed 34 neglected star clusters (see http://obswww.unige.ch/webda/dissolving_ocl.html) having relatively high galactic latitude (jbj> 15°), being poorly populated and appearing to be candidate objects to be experiencing the late stages of star cluster dynam ical evolution. For these objects the acronym POCR {Possible Open Cluster Rem nant{ is used. In their study, Bica et al. (2001) basically select these candidates on the basis of star counts. All of them indeed clearly emerge from the background.

The nal residue of open star cluster evolution is offen called an open cluster rem nant (OCR). These ghostly objects are characterized by very low surface brightness and they are hardly distinguishable against the background

eld stars (de la Fuente M arcos 1998). They consist of a sm all num ber of coeval relatively m assive stars, m ost of w hich are binaries, con ned in a core, since due to the evolution the less m assive star m em bers evaporated from the cluster and m erged with the G alactic disk eld (de la Fuente M arcos 1997).

Recently, these objects have started to receive some attention mainly because they play a fundam ental role in our understanding of the subject of open cluster evolution and dissolution, and, ultimately, on the origin of the eld star population. Photom etry, kinematics, binary percentage and membership are basic data to constrain N body models of cluster dissolution, which aim to reconstruct {for instance{ the Initial Mass Function (IMF) of Galactic clusters (e.g. de la Fuente Marcos 1997). On the other hand, they may be what still remains of old clusters, and therefore once discovered they can allow us to improve on the statistics of old open clusters in the G alactic disk. These objects are widely recognised to be of paramount importance for our understanding of the formation and early evolution of the Galactic disk (Carraro et al. 1998). Som e POCR candidates have been studied recently.

The best discussed case is doubtless NGC 6994 (M 73), studied by Bassino et al. (2000), Carraro (2000) and O denkirchen and Soubiran (2002).By combining together photom etry, astrom etry and spectroscopy this object turned out to be just a chance alignment of four stars.

Pavaniet al. (2001) discuss new photom etry of NGC 1901 and NGC 1252, bringing new evidence that these stellar groups are POCRs. However, proper motions studies for NGC 1252 seem to point to the opposite conclusion (B aum gardt 1998). On the other hand, the radial velocity survey conducted by V illanova et al. (2003a,b) con rm s that NGC 1901 is a genuine POCR.

F inally, on the basis of only star counts and photom etry, Carraro (2002) discusses the cases of NGC 7772 and NGC 7036 and Baum e et al. (2003) the case of NGC 1663, favoring the possibility that these two objects be indeed OCRs and providing a list of possible candidate m embers for spectroscopic follow up.

In this paper we present a photom etric, astrom etric and spectroscopic investigation of three previously unstudied POCRs, namely NGC 5385 and NGC 2664 and Collinder 21, with the goal to clarify their real nature. The analysis closely follows the strategy earlier proposed by O denkirchen and Soubiran (2002).

The layout of this paper is as follows.

In Sect. 2 we brie y present the observations and data reduction.Sect. 3 illustrates star counts analysis and spatial con gurations.Sect. 4 is dedicated to the outcom es of the proper motion analysis, whereas in sect. 5 we discuss our spectroscopy.Our conclusions are presented in sect.6.

2.0 bservations and D ata R eduction

2.1. Photom etry

Observations were carried out with the AFOSC camera at the 1.82 m Copernico telescope of C in a E kar (A siago, Italy), in the photom etric nights of December 17 and 18, 2001. A FO SC samples a 8° :14 8° :14 eld in a 1K 1K thinned CCD. The typical seeing was between 1.8 and 2.3 arcsec. The basic data of the studied objects are summarized in Table 1, whereas the details of the observations are listed in Table 2.

The data has been reduced by using the $\mathbb{R}AF^1$ packages CCDRED, DAOPHOT, and PHOTCAL. The calibration equations obtained by observing Landolt (1992) SA 93, PG 1047+003, PG 2331+055 and PG 0231+051 elds along both the nights, are:

where UBVI are standard magnitudes, ubvi are the instrum entalones, and X is the airm ass. The standard stars in these elds provide a very good color coverage, being

(B V) 1:448. For the extinction coe cients, 0:329 we assumed the typical values for the A siago O bservatory (Desidera et al. 2001). Photom etric global errors have been estim ated following Patat and Carraro (2001). For the V

lter, they amount to 0.02, 0.04 and 0.08 at V 12.0. 16.0 and 20.0, respectively.

The photom etry for the most obvious candidates is reported in Tables 3 to 5, whereas all the photom etric catalogues are available upon request to the authors.

2.2. Spectroscopy

using AFOSC in Echelle mode (in the grism #9 and # 10 combination) and the REOSC Echelle Spectrograph onboard the 1.82 m telescope of A siago A stronom ical 0 bservatory.

The Echelle spectrograph works with a Thomson 1024 CCD and the allowed wavelength coverage is approxim ately 4140 6840 A.D etails on this instrum ent are given in Munari & Zwitter (1994) and at the Asiago Observatory $H \text{ om e page}^2$.

The exposures times were 45 m inutes for the all stars. In order to improve the signal to noise ratio, two exposures were taken for each star reaching at the end S=N values up to 150. The data have been reduced with the IRAF package ECHELLE using thorium lamp spectra for wavelength calibration purposes. By comparing nal

known sky lines positions along the spectra we obtained an error ${\tt m}$ easurem ent of about 0.01 A .

The AFOSC in Echelle mode spectra cover the wavelength range 4100 6800 A, and for typical exposure times of 30 to 60 m inutes we obtained S=N values up to 300, which allows us to derive radial velocity with error almost always lower than 8 km/s. In this case, the data has been reduced with the IRAF package for onedimensional spectroscopy CTIOSLIT and by using the Hg-Cd lamp spectra for wavelength calibration purposes. Together with radial velocities we provide also spectral classi cations, which have been derived as described in V illanova et al. (2004).

In Tables 6 to 8 we report som e details of the spectroscopic observations.

3. Star counts, surface density and spatial distribution

POCRs are identied by Bica et al. (2001) as star overdensities at relatively high galactic latitude. For star count purposes we are going to use USNO-B1 (M onet et al. 2003) catalogue for NGC 5385 and UCAC2 (Zacharias et al. 2003) catalogue for NGC 2664 and Collinder 21, because UCAC2 does not extend to NGC 5385 declination. In the following, we are comparing star counts inside the OCR region with star counts in a o -set eld, which is aim ed to represent the m ean Galactic disk eld.

A crucial role in star counts is played by binaries. A ntici-

pating the results of Section 5, we nd that in the OCRs under investigation the binary fraction ranges from 18% to 25%, a value which is not much di erent from the estimated typical percentage in the Galactic disk eld population, which in the the proper F K spectral range amounts to about 14% (Halbwachs et al 2003). If one considers also M type stars, this percentage would increase. Therefore, we do not expect that binary stars signi cantly a ect star counts.

3.1.NGC 5385

Fig. 1 shows a noting chart in a 20° 20° region around NGC 5385 down to B = 21.5 according to USNO-B1.The center of this in age, which we also consider the center of NGC 5385, has been derived as the mean of the position of the 9 m ost obvious members of the aggregate. Indeed this object seems to consist of 9 stars with magnitudes 11 B 13 in a eld of about 3° :5 3° :5 The aggregate appears rather sparse, being them ean mutual angular separation larger than $30^{\circ\circ}$. Out of the central group, there is a clear de ciency of sim ilar brightness stars, which appear at least 1 m ag fainter on the average, if we exclude som e obvious case northward NGC 5385.

In Fig. 2 we show the surface density of stars of di erent m agnitudes as a function of angular distance from the center of NGC 5385, (based on USNO-B1). The central group of bright stars produces a signi cant localenhancem ent in the surface density of stars with m agnitudes B

13.5 (see panel (a)). Fainter stars in the magnitude bins 13.5 B 17.0 (panel (b)) B 18.0 (panel (c)) do not show any signs of a spatial concentration, star counts in the cluster area always agree within the uncertainties with the surrounding eld ones. In fact in the lower panel the overdensity in the central part lies quite close to the noise level to be considered signi cant.

In conclusion only the brightest stars indicate the existence of a cluster, and we are here going to look form em – bership in this magnitude range. This of course does not exclude that also fainter stars could be members, in the case the cluster turns out to be a physical one.

3.2.NGC 2664

Fig. 3 shows the distribution of stars in a eld of 30° 30° around NGC 2664 down to a magnitude UCm ag (between V and R) of 16.3 according to UCAC2. This gure reveals that NGC 2664 is de ned by 4 stars with magnitude 10.5 UCm ag 11.5 con ned in 2° .5 2° .5 arom in around the nom inal center, taken as the mean of the 4 m ost obvious members positions. In the immediate surroundings there is a clear lack of bright stars, although outward about 3° from the cluster center the eld is quite rich in bright stars, and a few other concentrations of the same kind as NGC 2664 seem to be present.

In Fig. 4 we show the surface density of stars of di erent m agnitudes as a function of angular distance from the center of NGC 2664, (based on UCAC2 as well). The central group of bright stars produces a sm all but sizeable local enhancem ent in the surface density of stars with m agni-13.5 (see panel (a)). The same seems tudes UCm ag to occur for the magnitude bins 13:0 UCmaq 16:0 (panel (b)), whereas fainter stars, in the magnitude bin UCm ag 16:0 (panel (c)) do not show any clear sign of a spatial concentration. At all distances in fact the cluster density pro le is comparable with the eld, and only at a distance of 3 arcm in does there seem to be a signi cant enhancem ent.

Therefore, the asterism NGC 2664 seems to be mainly identied by four bright stars and a few fainter stars in its immediate vicinity.

3.3.Collinder 21

Fig. 5 shows the distribution of stars in a eld of 30° 30° around Collinder 21 down to a magnitude of 15.3 according to UCAC2. The appearance of Collinder 21

(also designated as 0 CL 371 and C 0147+270) on the sky is very in pressive. It consists of about 10 stars distributed in a ring-like structure in a very poorly populated eld, which m akes this structure to emerge very sharply. There are two well known binary stars in this circlet: the visual binary system BD+26 305AB and the binary HD 11142, resolved by speckle interferom etry, which presents a separation of 0^{00} :56 between its components. All the other stars have m uch larger angular separation.

In Fig. 6 we show the surface density of stars of di erent magnitudes as a function of angular distance from the center of Collinder 21, based on USNO-B1. The bright star belonging to the circlet produce a signi cant local enhancement in the surface density of stars with m agnitudes UCm ag 13.0 (see panel (a)) at a distance corresponding to the radius of the circlet. Fainter stars in the magnitude bins 13:0 UCmaq 16:0 (panel (b)) UCm ag 16:0 (panel (c)) do not show any signs of a spatial concentration since star counts in the cluster area always agree within the uncertainties with the surrounding elds ones.

The only exception is again at a distance of about 3 arcmin, where the enhancement is alway signi cant at 2 level. In conclusion star counts suggests that a clear concentration exist in the region of Collinder 21.

At the end of this section, we would like to stress that the existence of som e stars overdensity is a necessary condition

for a physical cluster to exist, but not a su cient one.W e repeat here the kind of analysis proposed by O denkirchen and Soubiran (2002), to show what actually num ber statistics can tell us about these 3 objects.

We use their Equation (1):

which gives us the probability of nding n neighbours in a circular eld of radius around an arbitrarily selected star, for a random distribution of stars with m ean surface density .

The statistics of star counts in the comparison elds for NGC 5385, NGC 2664 and Collinder 21 provide in the m agnitude range 10.0 m ag 13.0 a m ean surface density of 20, 16 and 64 stars/deg², respectively.

In the case of NGC 2664, we are looking at the probability to nd 3 orm ore neighbours within a radius of 2.5 arcm in. As a consequence the probability of nding 3 or more neighbours turns out to be lower than $1.2 \quad 10^{-4}$. As for NGC 5385, we must look for the probability to nd at least 8 neighbours within about 3 arcm in, which

am ounts to less than 1.1 10^{11} . Finally, in the case of Collinder 21, we need at least 5 neighbours within about 3 arcm in, and the corresponding probability results lower than 4.4 10^{4} .

These numbers are saying to us that random con gurations like those ones we are facing are rare. As a consequence, in all the three cases (and especially for NGC 5385) we cannot exclude these are physical groupings, and therefore only proper motions and radial velocities can settle the question of their real nature.

4.P roper m otion analysis

In portant inform ation on the kinem atics of the lum inous stars in and around our targets can be derived from the proper motions available in the Tycho-2 catalogue (H g et al. 2000). We decided to opt for this catalogue since it provides hom ogeneous proper motions data for all the targeted stars. The recently released UCAC2 catalogue in fact does not provide data for Collinder 21.

In Figs. 7, 9 and 11 we show the nding charts of our targets, in a eld which roughly corresponds to our photom etric survey, and indicate there the stars for which we have proper motion measurements at our disposal. Moreover, Tables 3 to 5 list proper motion values, magnitudes and colors for the most obvious candidate members of the aggregates under investigation.

4.1.NGC 5385

The vector point diagram for all the candidate member stars having proper motion measurements in the eld of NGC 5385 (see Fig. 7 for the identi cation) from Tycho 2 catalogue is shown in Fig. 8, where panel a) present the Color-Magnitude Diagram (CMD) derived from our photom etry, whereas panel b) shows the proper motions distribution. Of the 10 brightest stars which presum ably de ne the aggregate (they clearly detach from the bulk of the stars), 7 are plotted with open squares, and these are the stars for which we obtained a radial velocity measurement (see below). However, we found in the Tycho 2 catalogue proper motion for all these 10 stars, and the 3 for which no radial velocity measurement is

available are plotted with led triangles. The remaining stars are nally plotted with open circles.

the surrounding of NGC 5385.We are therefore inclined to suggest that the stars belonging to NGC 5385 sim ply are part of the localGalactic eld.

It is evident that these stars do not share a common m ean tangentialm otion. In fact individual propermotion vectors range from about 5 to 63 m as yr ¹, while the typical uncertainties of the propermotions is about 2 m as yr ¹ per component. This spread in tangentialmotion is seen to be in agreement with that shown by eld stars in

4.2.NGC 2664

The vector point diagram for all the candidate member stars having proper motion measurements in the eld of

NGC 2664 (see Fig. 9 for the identi cation) from the Tycho-2 catalogue is shown in Fig. 10, together with the CMD obtained from our photom etry. Also in this case, there is a group of stars sharply detached from the bulk of the stars in the eld. These are 4 stars, and are plotted with squares in both the panels.

It is evident that these stars do not share a common m ean tangentialm otion. In fact individual propermotion vectors range from about 4 to 26 m as yr ¹, while the typical uncertainties of the proper motions is about 2 m as yr ¹ per component. Only, we note that stars # 2354 and # 2400 have quite a similar (within the errors) tangential motion, and might constitute a physical pair. The spread in tangential motion is seen also in this case in agreement with that shown by eld stars in the surrounding of NGC 2664.

4.3. Collinder 21

The CMD and the vector point diagram for all the candidate m ember stars having proper motion m easurements in the eld of Collinder 21 (see Fig. 11 for the identi cation) from the Tycho-2 catalogue are shown in Fig. 12 panels. 12 bright stars, in the magnitude range 8 V 13, de ne the aggregate and are plotted in both panels as open squares.P roperm otions are also available for 3 dim – m er stars (solid triangles) which bridge (see the CM D in panel a)) the brightest group to the bulk of the stars in the ekd. How ever these 3 stars have signi cantly diverse properm otion com ponents (see Table 5).C om ing back to the 12 brightest stars, their properm otion vectors range from about 3 to 68 m as yr ¹, while the typical uncertainties of the properm otions is about 2 m as yr ¹ per com ponent. It is evident that these stars do not share a com m on m ean tangentialm otion.There are two clear pairs.O ne is the well known visual binary system BD + 26 305ab (stars # 866 and # 1114), and the other is com posed by the stars # 1472 and # 272, which how ever deserve further investigation.A part from these two pairs, the bulk of the stars exhibit a disordered m otion.

5. Spectroscopic analysis

Multi-epoch spectra have been acquired for all the candidate members (23 stars in total for a grand total of 54 spectra) in the aggregates under investigations. The results of the spectroscopic survey are listed in Tables 6 to 8.

5.1.NGC 5385

For this object we provide 3 epochs E chelle spectra for seven bright stars, which turn out to be all dwarfs (see

Table 6), but for star # 1797, which seems to be a subgiant.By looking at this table results we nd that 2 stars are probably unresolved binary stars (# 1641 and # 1873), whereas all the other stars do not exhibit signi cant variations in their radial velocity. The studied stars have radial velocity ranging from -62 km/s to + 30 km/s, and they di er one from the other, thus suggesting that NGC 5385 is not a physical aggregate. There m ight be som e com m on m otion pairs in this sam ple. Stars # 399 and # 1797 (see

Table 3) have m arginally consistent properm otion com ponents, and stars # 1641 and # 217 as well. The rst couple has also compatible spectral type (see Table 6). Radial velocities however (see Table 6) contradict this hypotesis. M oreover both pair m em bers are located in very di erent posistion (see Fig. 7).

W e derived stellar distances from the Sun basing on the spectral classi cation reported in Table 6.The relation between spectral type, lum inosity class and absolute m agnitude has been taken from the M ichigan Spectral C atalogue P roject.³ D istance m oduli range from 4.87 to 8.17 m ag, which turn into distances going from 94 to 430 pc.Schlegel et al (1998) extinction m aps provide for NGC 5385 region a reddening of 0.04 m ag, which does not significantly alter the derived distances. The signi cant spread of stars distances rules out the possibility they form a physical group. M etal abundances were derive using the MOOG code (freely distributed by Chris Sneden, University of Texas, Austin) as described in Carraro et al. (2004). The S=N ratio and the limited resolution prevented us from deriving very precise m etallicity estimates, and therefore the value reported in Table 6 m ust be taken as an indication. We not that within the uncertainties the bulk of the stars possess solar iron abundance, but for star # 457, which exhibits a super solar iron abundance. W ithin 3 the metallicity distribution looks hom ogeneous (0.4 0.2), although we believe that m ore precise estimates of the metallicity would probably reveal some spread, which is expected for a random group of stars.

5.2.NGC 2664

4 etal abundances were derive using the MOOG code For this object we provide 2 epochs E chelle spectra. From the analysis of Table 7 results we nd that one star is a ³ http://www.astrolsa.um.ich.edu/users/hdproj/mosaicinfo/ab spectrascopic binary (# 1826), and due to blending prob-

lem s w e w ere not able to derive either stars spectral type or m etallicity. The rem aining three stars do not exhibit signi cant variations in their radial velocity. Star # 2354 is a dwarf, while stars # 1890 and # 2400 are giants. The studied stars have radial velocity ranging from + 12 km /s to + 30 km /s, and they basically di er one from the other, thus suggesting that NGC 2664 is not a physical aggregate. The proper m otion pair (# 2354 and # 2400) seem to be actually a pair, since the radial velocities of the two stars do not di er very m uch (see Table 7).

As for NGC 5385, we computed spectral type based distances, which are listed in the last column of Table 7. The distance m oduli range from 7.70 to 10.41 m ag., which im – plies distances ranging from 350 to 1207 pc, which slight corrections due to the interstellar reddening, which in the direction of NGC 2664 am ounts to 0.02 m ag (Schlegel et al. 1998). The four stars which de ne the group cannot be considered physically bound. Finally, the possible related stars # 2354 and # 2400 lie too apart to be considered as a physical pair.

In the same table we list estimates of the metal content of three stars, which turns out to be around solar or slighly supersolar for all the stars within the errors.

5.3. Collinder 21

For this object we provide 2 epochs medium resolution spectra for all stars but for # 450, for which we add an E chelle spectrum .5 stars turn out to be giants, and all the other are dwarfs. Though in this case the errors are much larger, from the analysis of Table 8 results we con m that this star (# 450) is a binary. Large velocity variations are also shown by the couple # 866-# 1114 (BD + 26 305a,b), which how ever we are inclined to ascribe to their nature of visual binary. All the other stars show deviating radial velocity, roughly ranging from -20 km /s to + 60 km /s, thus suggesting that this circlet is not a physical aggregate. The possible proper motion pair (# 1472-# 272) is not con m ed by radial velocity m easurem ents, and, on top of that, these two stars are located in quite di erent places (see Fig. 11).

As for the previous objects we have derived stars individual distances based on spectral classi cation. The distance m oduli range from 3.9 to 10.84 m ag, which m eans a distance between 60 and 1470 pc. The reddening in this direction is 0.07 m ag (Schlegel et al. 1998), and therefore these estimates do not change signi cantly due to it. The distance spread is too huge to be consistent with C ollinder 21 being a physical aggregate.

Unfortunately, in this case we do not have su ciently high resolution spectra to derive reasonable estimates of the m etal abundance.

6.D iscussion and Conclusions

In this paper we have analysed the possibility that NGC 5285, NGC 2664 and Collinder 21 m ight be POCRs. Our study how everyields negative answers for all of them. In fact, star counts and the appearance of the CMDs con rm that we are facing signi cant stellar overdensities above the general Galactic eld.

However, the close scrutiny of the kinem atic data (proper motion and radial velocity) provide us with a completely diverse picture. All the agglom erates are not physical clusters since they show very dierent velocity components, and therefore they force us to consider them simply as projective chance alignment of unrelated eld stars.

W e found out a num ber of possible unresolved binary stars or com m on m otion pairs which m ight deserve further investigation.

The probale binary fraction we found ranges from about 25% in NGC 2664 and NGC 5385 to 18% in Collinder 21, and it is not much di erent from the typical Galactic disk eld binary percentage.

Our ndings con m previous suggestions (O denkirchen & Soubiran 2002) that an overdensity of stars does not necessarily imply the existence of a physical ensemble, and cast som e doubts on the POCRs list provided by B ica et al. (2001), which is purely based on star counts. N evertheless, work is in progress to de ne a m ore e cient OCRs

nding criterion (de la Fuente M arcos, in preparation) and to probe the real nature of other POCRs candidates.
