FORM ATION AND EVOLUTION OF VERY LOW MASS STARS AND BROW N DWARFS

# Abstract

The form ation and evolution of brown dwarfs are currently "hot topics" in cool star research. Latest observations and modeling e orts on disks, accretion, out ows, spatial distribution, and binarity in the context of the formation by ejection model and alternative scenarios were presented and discussed vigorously in this splinter session. A second major topic was rotation and activity of these objects. This part included observations of rotation periods and amplitudes, variability, and X-ray activity, and their consequences for the generation of magnetic elds and the cool atm ospheres.

#### 1. Introduction

In recent years, large populations of objects with m asses between stars and planets have been found in the solar neighbourhood, in young open clusters, and in starforming regions. The form ation and evolution of these very low m ass (VLM) stars and brown dwarfs (BDs) is one of the current "hot topics" in coolstar research. This splinter m eeting was intended to bring together the community to discuss latest results and future directions of research in this rapidly evolving eld.

A fier the discovery of large numbers of VLM objects one of the most debated questions is that of their origin. There are two lines of form ation models; scenarios where brown dwarfs form very similar to stars and models which include ejection from a multiple system. Initial observations to distinguish between these proposed scenarios are becoming available now. They are summarised and discussed in Sect. 2.

O bærvations also deliver inform ation on the rotation and activity of these objects. These parameters are directly connected to the interior structure and the atm ospheres, and give insights into the physics of dynam o generation, magnetic elds, surface spots, and winds. The

### 2. The formation of brown dwarfs

A large part of this splinter session was dedicated to an extended discussion of form ation scenarios for brown dwarfs. Today, we distinguish two main groups of models: BD s could form very similar to stars, i.e. from the direct graviational collapse of dense cores (e.g., Padoan & Nordlund 2002). A lternatively, the form ation process could involve a truncation or cut-o of the gas accretion reservoir. This cut-o could result either from an ejection from a multiple system (e.g., Reipurth & C larke 2001, Bate et al. 2003) or from external forces, e.g. the radiation pressure of a nearby OB star (W hitworth & Z innecker 2004).

The ejection scenarios are of particular interest for observers, because any ejection process should signi cantly in uence the properties of the objects. Thus, the ejection m odels can be probed by searching for a signature of the ejection, for example by investigating accretion disks, spatial distribution, and binarity of young BD s. In the splinter session, all these three subtopics were discussed in detail.

## 2.1.D isks and accretion

The existence of accretion disks around substellar objects has been established by infrared photom etry, optical spectroscopy, and photom etric monitoring. In his talk, D aniel A paifocused on the results of recent infrared observations, which can be used to infer the geometry and structure of disks. First evidence for circum substellar disks cam e from deep mid-and near-infrared surveys in star forming regions and young open clusters (e.g., M uench et al. 2001, Liu et al. 2003, Jayawardhana et al. 2003). For a few objects, the combination of NIR and MIR photom etry were used to constrain models for the disk structure (N atta & Testi 2001, A paiet al. 2002, M ohanty et al. 2004). It appears that BDs may show a variety of disk geometries, either ared and at disks, in some cases with a central hole. Including sub-mm /mm data points, it was possible to constrain the mass for a circum substellar disk around CFHT BD Tau 4 to a value between 0.4 and  $5.7 M_{Jup}$ (Pascucci et al. 2003, see Fig. 1). For the same object, is has been found that the dust is indeed con ned to a disk, and that the grains grow to 2 m sizes (A paiet al. 2004). Thus, sub-mm/mm observations are probably the

Infrared colour excess is not the only observational signature for the existence of accretion disks around young BD s.A lexander Scholz presented photom etric light curves of a sample of VLM stars and BD s in young open clusters in O rion, which show the typical variability characteristic of classical T Tauristars, i.e. high am plitude and partly irregular ux modulation. The usual interpretation for this behaviour is the existence of hot spots form ed by matter ow from the accretion disk onto the object. Most of these highly variable VLM objects show a near-infrared colour excess. Moreover, optical spectroscopy reveals a strong accretion signature in their spectra, i.e. intense em ission features like H and the infrared C a triplet. Thus, these objects are the VLM representatives of classical T Tauristars (Scholz & E islo el 2004a, Scholz & E islo el 2004b).

Furtherm ore, M atilde Fernandez dem onstrated in her talk that VLM objects do also show out ow activity.Optical spectroscopy for Par-Lup 3-4, a VLM star near the substellar limit (Comeron et al. 2003), exhibits doublelined [SII] em ission features, a clear hint for the existence of a jet. Deep in aging revealed that there is indeed an All these results demonstrate that brown dwarfs undergo a T Tauriphase very similar to stars. Particularly, young BD spossess accretion disks with lifetim es between 3 and 10M yr. Although the disk lifetim e of BD s is still very uncertain, it seems to be not vastly di erent from solar-mass stars. How ever, this result alone is not su cient to distinguish between form ation scenarios. In particular, it does not to rule out an ejection scenario, as pointed out by several speakers. Ejection should produce truncated disks, but it is not clear, how much mass the disk would bese in such a process. Additionally, the processes which regulate the disk lifetim e (i.e. accretion, winds, out ow s) are only poorly understood for VLM objects.

#### 2.2. Spatial distribution

If brown dwarfs form by ejection from multiple systems, the ejection velocities should in uence the spatial distribution of these objects. Therefore, large-scale surveys of star form ing regions are able to set tight constraints for the form ation m odels.

In this splinter session, two speakers focused on the spatial distribution of substellar objects in the C ham aeleon star forming region. Jochen E islo elreported about a wideeld survey which delivered more than 100 new VLM members in C ham aeleon I (Lopez M art n et al. 2004). It was shown that this spatial distribution does not depend signi cantly on object mass: The young brown dwarfs as well as their solarm ass siblings are concentrated in the regions around the two dark clouds in this region. The survey constrains the average velocity of BD s to values below  $1 \text{ km s}^{1}$ . Thus, there is no evidence for extraordinarily high escape velocities in the substellar regime.

This important nding is con med by the results presented by K evin Luhm an. He pointed out that with ejection velocities up to 10 km s<sup>-1</sup>, the brown dwarfs should populate a region with radius 3 pc around the cloud cores in C ham aeleon. Large-scale surveys, how ever, show no extended BD population in this region. There is no halo of high-velocity BD s around the cloud cores, in contradiction to the original ejection model (R eipurth & C larke 2001). W e conclude that if BD s form via an ejection process, it should release the BD s at relatively low velocities.

# 2.3.Binarity

The ejection process should also leave its imprint in the binarity of brown dwarfs. As shown by recent HST im aging surveys, the binary frequency among BDs is in the range of 15%. Rem arkably, there is a paucity of wide BD binaries with separations larger than 15AU compared to solar-type stars (M art n et al. 2004, Bouy et al. 2003). Thus, the distribution of separations could be either com - pressed or truncated compared with the distribution for

short period BD binaries. This was the topic of the talk by Ansgar Reiners. He presented results of a search for spectroscopic binaries am ong VLM stars and BD s. For about 60 objects, second epoch radial velocities were measured. W ith sensitivities of 300m s<sup>-1</sup> them inim um separations of HST in aging were detectable. Com bining radial velocity data with high-resolution in aging, the com plete distribution of separations can be covered. Thus far, it appears that short-period binaries exist am ong VLM objects, although their frequency is not very high. This result points in the direction of a cut-o at wide separations, which could be interpreted as an indication for an ejection process.

O n the other hand, there is evidence for the existence of a few wide VLM binary systems in C ham aeleon I star form ing region. W ithin the wide- eld survey presented by Jochen E isb el, two possible wide binaries with separations around  $10^{\circ0}$  were found, which include objects around and even below the substellar boundary (Lopez M art n et al. 2004). In his talk, K evin Luhm an now showed im ages and spectra for a BD binary in the same region. C olours, spectral types, particularly the low gravity of both com – ponents are consistent with their m embership to the very young population in this region. T heir separation is  $1^{\circ0}_{\cdot}44$ , which corresponds to 240 AU. G iven the low object density in C ham aeleon, it is unlikely that the objects are unrelated late-type m embers of this star form ing region (Luhm an 2004).

# 2.4.D iscussion

E very scenario for the form ation of brown dwarfs should be consistent with the observational results given above. To probe the initial conditions of the form ation process, increasingly sophisticated 3D Sm oothed Particle Hydrodynam ic simulations are now available, as pointed out by Jurgen Steinacker in his talk. In combination with 3D continuum radiation transfer, these SPH simulations can be used to produce in ages of the collapsing core at di erent wavelengths and evolution times. Thus, the evolution of cloud cores can be visualised and directly compared with observations (Steinacker et al. 2004). This method has already turned out to be valuable in the massive star regime. Like for brown dwarfs, the question whether accretion through a disk is the main form ation mechanism is also the key topic in massive star-form ation. Recently, the

rst massive disk seen in absorption has been detected in M 17 (Chini et al. 2004). The ongoing modeling indicates that the attened structure around the central object m ay indeed have an extent of about 20000 AU with a mass around 10 solarm asses. The same approach is in principle able to probe disk form ation models in the VLM regime.

In the later stages of the form ation process, it is crucial to distinguish between the star-like form ation m od-

a cut-o is the ejection process, but there are alternative processes which could have a similar e ect, as explained by Hans Zinnecker in his talk. He explored the possibility that a pre-stellar core is eroded by the ionising radiation of a nearby OB star. In principle, such a process could form a brown dwarf or even planetary mass object from a core, which would otherwise have formed an intermediate or low-mass star (W hitworth & Zinnecker 2004). It was concluded that this photo-erosion scenario works well to produce free- oating VLM objects, because it works over a wide range of conditions. On the other hand, it is probably quite ine cient, since it requires a relatively massive initial core. M oreover, this process can only operate in the vicinity of an OB star, whereas BDs were found also in regions where such stars are not available. Thus, the photo-erosion scenario could be an additional process to produce a sm all num ber of BD s, but the predom inant part of the substellar population must have a di erent origin.

Therefore, the pivotal point for our understanding of BD form ation is still to distinguish between scenarios with or without an ejection process. This problem was intensely debated during the general discussion in the splinter session. The observational results discussed above delivered valuable guidance through this discussion. O nem ain prediction of the original ejection model are high spatial velocities, which would produce a spherical halo of BD s in star form ing regions (R eipurth & C larke 2001). Wide-eld surveys do not see such a halo, as pointed out in Sect. 2.2. How ever, recent simulations show that an ejection process does not necessarily lead to very high spatial velocities (Um breit et al. 2004), which makes it di cult to rule out this scenario based on the spatial distribution of BD s.

It is also very complicated to constrain the form ation scenarios by investigating the accretion disks, since the ejection scenario does not rule out the existence of longlived disks. Thus, it could be that we just observe the BD s, whose disks have survived the ejection. Our best hope in this eld are sub-mm observations, which could deliver disk m asses for large sam ples of BD s.

Finally, binarity surveys are a third important tool to verify BD formation scenarios. Two con icting observational results have been presented in this splinter session. On the one hand, several groups nd a cut-o of the BD binary distribution at separations of about 15AU (e.g., M art n et al. 2004, Bouy et al. 2003). It is not clear whether this nding is just an observational bias or an indication for the truncation of wide binaries by ejection. On the other hand, there are a few examples of wide binaries detected in star forming regions, as pointed out in Sect. 2.3. Future astrom etric space missions are probably able to establish beyond doubt if these objects are indeed physically linked. But since there are only very few of these wide binary BD s, it is doubtful whether their existence tells us som ething about BD form ation in general. For the future research in this eld, the investigation of the earliest stages of the form ation process will become m ore and m ore in portant. The detection of 'proto' brown dwarfs could indeed deliver clear evidence for a star-like origin of these objects. Subhan joy M ohanty pointed out in the discussion that very recent (as-yet unpublished) radio observations appear to indicate the presence of at least som e gravitationally bound cores with m asses in the substellar regime (W alsh et al., in prep.). The con m ation of these results would support star-like form ation for brown dwarfs.

R ecapitulating, it is still too early for a de nite answer about the process that form s substellar objects. Young brown dwarfs sharem any properties with their more massive siblings, in particular disk frequency, disk geometry, and spatial distribution, indicating that the majority of these objects form s in a way similar to stars. On the other hand, there is no clear observational result which can only be explained by including an ejection process. Thus, many of the participants suggested that the ejection scenarios are not of signi cant importance for BD form ation.

#### 3. Rotation and activity of VLM objects

The second m ain focus of the splinter session was the rotation and activity of VLM objects. This subject area was covered by four talks, which will be reviewed in the following.

Subhanjoy M ohanty presented results of a high resolution spectroscopic study of young brown dwarfs. Particularly, he concentrated on the interdependence of rotational velocity and H 10% width, where the latter is directly correlated with the accretion rate. A plot of v sin i vs.H showsaconspicuousmorphology:W hereasslow rotators cover a broad range of H widths up to 400 km s  $^{1}$ , fast rotators show only very low H activity, with 10% widths below 200 km s<sup>1</sup>. The boundary between fast and slow rotators lies at 20 km s<sup>1</sup>. In other words, while nonaccretors (H width < 200 km s<sup>1</sup>) are found at both high and low velocities, accretors (H width > 200 km s  $^{1}$ ) appear to be exclusively slow rotators. The most straightforward interpretation is that the accretion disk is able to brake the rotation. It was pointed out in the discussion that the same result was obtained for VLM objects in the Oricluster, where a plot of angular velocity inferred from the rotation period vs.photom etric am plitude (which can be used as accretion indicator) shows a very sim ilarm orphology (Scholz & E islo el 2004a). Thus, there is evidence for rotational braking through interaction with the circum substellar disk. In addition, the mean rotational velocity increases as the objects get older. This can be explained by spin-up due to hydrostatic contraction.

In the following talk, Reinhard M undt reported about an extended variability and rotational study of young stars

the object masses reach down to the substellar limit, this dataset is particularly well-suited to probe the mass dependence of rotation and activity. One main result of this study is a change in the photom etric amplitudes in the VLM regime. At a R-I colour of 1.5, the am plitudes decrease by a factor of about three. Thus, VLM objects show only very low amplitude variations. The most convincing explanation so far is that these objects exhibit smaller spots than m ore m assive stars, probably because the coupling between magnetic eld and gas is signi cantly decreased on these very cool ob jects. Indeed, the magnetic Reynolds number, which should exceed unity to ensure coupling between eld and gas, goes down from six at spectral type M 2 to about 0.8 at M 5.5. This is just the sam e spectral range in which the photom etric am plitudes decrease. An alternative interpretation for the low am plitudes would be highly symmetric spot distributions, but this would require a change in the magnetic eld con guration, which is unlikely, since at the age of NGC 2264 all stars with masses up to 1M are fully convective.

To probe the magnetic eld properties of VLM objects, it is highly interesting to study their X-ray properties. This was the topic of Beate Stelzer's talk. VLM objects are fully convective throughout their evolution. Thus, a solar-type dynam o cannot work in these objects, since it requires a radiative core. How ever, VLM objects at least down to late M spectral types show X-ray activity: Several BD s in Cham aeleon I have been detected by ROSAT (Neuhauser & Comeron 1998). Recent observations with XMM con rm ed these detections, and proved that the ROSAT sources are not spurious (Stelzer et al. 2004). In addition to these Cham aeleon objects, X-ray emission was detected for BD s in the Pleiades (Stelzer et al. 2004).

ray light curve of the eld BD GL569B ab shows that { apart from ares { this objects does probably also show quiescent emission (see Fig. 2). Thus, the dynam o of BD s does persist at least up to ages of 1 G yr. However, no Ldwarfhas been detected in X -rays so far. This seem s to be in agreem ent with the decline of the H activity at late M spectral types, which is interpreted as a consequence of the cool e ective temperatures, which result in high atm ospheric resistivities (M ohanty et al. 2002). In com bination with the results presented by R einhard M undt, we conclude that VLM objects show m agnetic activity for as long as they are not too cool to prevent coupling between eld and gas.

In the sam e tem perature range, where the magnetic activity declines, another process begins to play a signi cant role: the condensation of dust clouds in the atm ospheres. A tm osphere m odels suggest that this process becom es im portant for objects with T < 2500K, corresponding to late M spectral types. Sim ilar to m agnetic spots on solarlike stars, dust clouds could produce inhom ogeneous surfaces, which could cause periodic modulations of the ux. This was the motivation for num erous variability studies on ultra-cooldwarfs, which were reviewed in the talk of Coryn Bailer-Jones. Variability with smallam plitudes has been detected on about 40% of the targets (e.g., Bailer-Jones & Mundt 2001, Clarke et al. 2002, Enoch et al. 2003). The origin of these variations is most likely the existence of dust clouds, since these objects are too cool to produce magnetic spots (Gelino et al. 2002, see above). Spectrophotom etric monitoring has been used to distinguish between clouds and spots, and it delivered tentative evidence for the existence of dust (Bailer-Jones 2002). It was surprising that ultra-cool dwarfs in most cases show only non-periodic variability and no photom etric period, which is in contrast to sim ilar studies for solar-like stars. One explanation could be that the variability surveys are not sensitive to the periods of ultra-cooldwarfs. How ever, rotational velocities show that these objects are in general rapid rotators with  $v \sin i = 10 ::: 40 \text{ km s}^{-1}$ , corresponding to a period range where the variability studies were sensitive (Bailer-Jones 2004). Therefore, to explain the absence of photom etric periods, Bailer-Jones et al. proposed the 'm ask hypothesis': The clouds evolve on timescales of a few hours, and thus the period is 'm asked' by nonperiodic variability (Bailer-Jones & M undt 2001, G elino et al. 2002). In the discussion, it was pointed out that there is indeed a change of the variability characteristic at late M spectral types, in the sense that earlier type objects often show stable periods. The most probable explanation is a change of the nature of the surface features from m agnetically induced spots to dust clouds at late M spectral types.
