The convective U rca process

One possible fate of an accreting white dwarf is explosion in a type Ia supernova. However, the route to the therm onuclear runaway has always been uncertain owing to the lack of a convective model consistent with the U rea process.

We derive a form alism for convective motions involving two radial ows. This form alism provides a fram ework for convective models that guarantees self-consistency for them istry and energy budget, allows time-dependence and describes the interaction of convective motions with the global contraction or expansion of the star. In the one-stream limit, we reproduce several already existing convective models and allow them to treat them istry. We also suggest as a model easy to implement in a stellar evolution code.

W e apply this form alism to convective U rea cores in C handrasekharm ass white dwarfs. W e stress that in degenerate m atter, nuclear reactions that change the num ber of electrons strongly in uence the convective velocities. W e point out the sensitivity of the energy budget on the mixing. W e illustrate our model by computing stationary convective cores with U rea nuclei. W e show that even a very small m ass fraction of U rea nuclei (10⁸) strongly in uences the convective velocities.

F inally, we present prelim inary computations of the late evolution of a close to C handrasekhar m ass C+O white dwarf including the convective U rea process.

1. P relude to therm onuclear explosions

W hen a CO white dwarf accretes m atter, its centre gets denser and hotter. At some point, the C-C burning ignites m ildly in the centre. W hen the radiative lum inosity can no longer get rid of the heat produced, a convective core forms and grows as the burning releases m ore and m ore energy. D uring the burning process, U rea pairs such as 23 N a 23 N e are produced. These release neutrinos through em ission and capture of electrons preferentially around U rea shells. The net am ount of energy released and the change in the electron fraction at the time of the explosion have always been uncertain due to the lack of a convective m odel self-consistent with the energy and chem istry budgets [1{10}. Form er theoretical attem pts [11{13}] to describe the interplay between convection and chem istry have all left open the question of energy conservation.

A better understanding of the phase in m ediately preceding the therm al runaway provides an essential link between the core evolution in the progenitor and the supernova explosion. Know ledge of the physical and chem ical prole at the time of the explosion may also provide new insight in the physics of the explosion itself. Indeed, the neutron excess at the time of ignition is a crucial parameter of the explosion, and it is strongly a ected by the convective U rca process.

2. A model for the convective U rca process

Except for the work of Iben [4{6], the convective U rca process has been so far neglected in presupernova computations. This is because we lack a proper energy equation in a convective region. Indeed, far from the U rca shell, out of equilibrium nuclear heating overwhelm's neutrino losses [2]. Hence the net heating crucially depends on the actual chem ical mixing. The amount of convective work necessary to carry the electrons is uncertain [7{9]. Last but not least, in degenerate matter chem is vontrols the buoyancy and thence the convective velocities. Fortunately, the problem is well known and solved in the radiative state. Our basic idea is to min ic convection by considering the interaction between two radiative columns of uid side by side [14].

The resulting convective model guarantees energy conservation. Besides, it is time-dependent, non-local, allows for dierent rising and descending convective velocities, describes horizontal chemical inhomogeneities and treats the interaction of convection with the mean ow. We have checked carefully dierent limits of our model against corresponding existing convective models [11,12,15] and found good agreement.

A lthough the full model would be rather di cult to implement in a convective core, the one-stream, local, time independent limit yields a straightforward extension of the mixing length theory fully consistent with chemistry and energy budget. The main di erence with the mixing length is the dependence of the convective velocity on the chemical gradients.

3. A pplication to degenerate CO convective cores

We use our convective model to compute convective cores with a hom ogeneous total abundance for the U rca pair A = 23. Indeed this pair operates at mass density $1.7 \ 10^9$ g cm⁻³ and is hence one of the main actors at the onset of C burning which occurs around density $2 \ 10^9$ g cm⁻³ and tem perature $3 \ 10^8$ K.

3.1. Stationary m odels




Figure 1. Variation of the stationary convective prole for dimensionary mass fractions X $_{\rm U}$ of the U reapair A = 23.

We set used the full two-stream model to compute stationary convective cores. We varied the mass fraction of U rca matter X $_{\rm U}$ from 10 12 to 10 3 . Strong modi cations of the convective prole occur form ass fractions higher than 10 8 as Fig. 1 shows. A nalytical arguments on the existence of a stationary convective core con rm this low threshold.

The convective velocities are strongly reduced by the presence of U rca m atter. Indeed, the velocity of a convective blob is proportional to its di erence in density with the surrounding m edium. Besides, the density of degenerate m atter depends m ainly on the electron num ber density. This means that convection in degenerate m atter crucially depends on electron em issions and captures. These simulations also show that the one-stream, local limit is a good approximation to the two-stream m odel in this context.

3.2. Stellar evolution m odels

We have started to implement a one-stream, stationary limit of the two-stream model in P.Eggleton's stellar evolution code [16]. This has already required signicant changes to the code to handle chemical gradients with su cient accuracy.

First, it appears that the backreaction of the chemical gradients on the convective velocity, and hence the mixing, causes serious convergence problem s. We momentarily overcome these problems by articially lowering the mixing at the outer edge of the convective core. Simulations with $X_U = 10^{-7}$ con m the reduction of the convective speed which now takes place only upward of the U rea shell.

Second, for higher U rea m ass fractions, our code breaks down when the outer edge of the convective core reaches the U rea shell. At this point, the convective state changes on short time scales due to the gradient of the U rea composition.

4. Conclusion and future prospects

We have developed a new convective model suitable for studying the convective U rca process. A rst application to stationary convective cores suggests that electron em issions and captures control convection in degenerate matter.

We hence expect to uncover new results on the initial conditions for the explosion of type Ia (and possibly core-collapse supernovae). In particular, we shall be able to predict the degree of neutronisation at the time of the therm al run-away, a crucial parameter for explosive nucleosynthesis

However, we still need to implement a fully time-dependent version of our convective model in a stellar evolution code including an extended chemical network.

Finally, our model may well prove to be relevant for other elds of stellar evolution such as the He ash, the fate of 0, Ne and Mg cores and AGB stars.
