Quantifying the Cosm ic W eb in the New Era of Redshift Surveys

A bstract. Twom ain strategies have been in plemented in mapping the local universe: whole-sky Shallow' surveys and Deep' surveys over limited parts of the sky. The two approaches complement each other in studying cosm ography and statistical properties of the Universe. We summarise some results on the power spectrum of uctuations and W iener reconstruction of the density eld from the 2dF G alaxy Redshift Survey (2dFGRS) of 230,000 redshifts. We then discuss future challenges in quantifying the web of cosm ic structure in the on-going redshift surveys.

#### 1. Introduction

The recent m easurements of the Cosm ic M icrowave Background uctuations, supernovae Ia, redshift surveys, clusters of galaxies and other probes suggest a boncordance' model in which the universe is at and contains approximately 4% baryons, 26% cold dark matter and 70% dark energy. It remains to be seen if this model will survive future tests, but in any case there are many challenges ahead to understand the formation of galaxies, and how they trace the mass distribution in the non-linear regime. Redshift surveys provide an important bridge between linear cosm ology' and the more complex processes of galaxy formation.

Twomain strategies have been im plemented in mapping the local universe: whole-sky Shallow' surveys (e.g. IRAS) and 'deep' surveys over a limited parts of the sky (e.g. 2dFGRS, SDSS). The Table below summarises the properties of the main new surveys:  $2dFGRS^1$ , SDSS<sup>2</sup> + LRG<sup>3</sup>, 2MASS<sup>4</sup> /6dFGS<sup>5</sup>, DEEP2<sup>6</sup>, and VIRMOS<sup>7</sup>.

Each strategy has its pros and cons. The whole-sky surveys have given useful'fullpicture' of the local cosm ography and they have allowed us to predict the local velocity eld assuming that light roughly traces mass. The complete picture depends on carefulm apping of the Zone of A voidance (ZoA), as discussed in detail at the P roceedings of this C ape Town (2004) meeting and at the previous two ZoA conferences in Paris (1994) and M exico (2000). The deep limited-sky surveys are very useful for statistical studies such as the power spectrum. B oth types of surveys pose challenges for quantifying the web of cosm ic structure.

Using simulations B ond, K ofm an & Pogosyan (1996) coined the term bosm ic web' and argued that a lam ent-dom inated structure was already present in the overdensity elds of the initial G aussian uctuations, and was then am pli-

ed over a Hubble tim e by non-linear gravitational dynam ics. In the new era of large redshift surveys (see the Table) and huge simulations the next important step is to quantify this bosm ic web' using various novel statistical measures beyond the traditional methods (e.g. Martinez & Saar 2002; Lahav & Suto 2004 for reviews) and to identify G reat Attractors', G reat W alls', Zeldovich pancakes' and voids. This will allow us to understand the role of initial conditions vs. non-linear gravitational evolution and to constrain cosm ological models and scenarios for biased galaxy form ation.

#### 2. Results from the 2dF G alaxy Redshift Survey

Redshifts surveys in the 1980s and the 1990s (e.g the CfA, IRAS and Las cam – panas surveys) m easured redshifts of thousands to tens of thousands of galaxies. Multi bre technology now allows us to measure redshifts of millions of galaxies. The Anglo-Australian 2 degree Field Galaxy Redshift Survey<sup>8</sup> (2dFGRS) measured redshifts for 230,000 galaxies selected from the APM catalogue. The survey is now complete and publically available. Them edian redshift of the 2dF – GRS is z 0:1, down to an extinction corrected magnitude limit of lp < 19:45 (Colless et al. 2001). A sample of this size allows large-scale structure statistics to be measured with very small random errors. Here we sum marize some recent results from the 2dFGRS on clustering and galaxy biasing. C om prehensive recent review s are given by Colless (2003) and Peacock (2003).

# 2.1. The power spectrum of 2dF galaxies

An initial estim ate of the convolved, redshift-space power spectrum of the 2dF - GRS has been determ ined (Percival et al. 2001) for a sam ple of 160,000 redshifts. On scales 0.02 < k < 0.15 hM pc<sup>-1</sup>, where H<sub>0</sub> = 100 hkm /sec/M pc, the data are robust and the shape of the power spectrum is not a ected by redshift-space or non-linear e ects, though the am plitude is increased by redshift-space distortions. Percival et al. (2001), E fstathiou et al. (2002) and Lahav et al. (2002) com pared the 2dFGRS and CMB power spectra, and concluded that they are consistent with each other.

A key assumption in deriving cosm ological parameters from redshift surveys is that the biasing parameter, de ned as the ratio of of galaxy to matter power spectra, is constant, i.e. scale independent. On scales of 0.02 < k < 0.15 hM pc<sup>-1</sup> the uctuations are close to the linear regime, and there are theoretical reasons (e.g. Fry 1996; Benson et al. 2000) to expect that on large scales the biasing parameter should tend to a constant and close to unity at the present epoch. This is supported by the derived biasing close to unity by combining 2dFGRS with the CMB (Lahav et al. 2002) and by the study of the bi-spectrum of the 2dFGRS alone (Verde et al. 2002).

The 2dFGRS power spectrum (Figure 1) was tted in Percival et al. (2001) over the above range in k, assum ing scale-invariant prim ordial uctuations and a -CDM cosm obgy, for four free parameters:  $_{\rm m}$  h,  $_{\rm b}$ =  $_{\rm m}$ , h and the redshift space  $_{\rm 8g}^{\rm S}$ . The amplitudes of the linear-theory m s uctuations are traditionally labeled  $_{\rm 8m}$  in m ass  $_{\rm 8g}$  in galaxies, de ned on 8h  $^1$  M pc spheres. A ssum ing a G aussian prior on the Hubble constant h = 0:7 0:07 (based on Freedman et al. 2001) the shape of the recovered spectrum within the above k-range was used to yield 68 per cent con dence limits on the shape parameter  $_{\rm m}$  h = 0:20 0:03, and the baryon fraction  $_{\rm b}$ =  $_{\rm m}$  = 0:15 0:07, in accordance with the popular concordance model (e.g. Bahcall et al. 1999; Lahav & Liddle 2004). For xed concordance model parameters n = 1;  $_{\rm m}$  = 1 = 0:3,  $_{\rm b}$ h<sup>2</sup> = 0:02 and a Hubble constant h = 0:70, the am plitude of 2dFGRS galaxies in redshift space is  $_{\rm 8g}^{\rm S}$  (L<sub>s</sub>;z<sub>s</sub>) 0:94 (at the survey's e ective lum inosity and redshift).

Recently the SDSS team presented their results for the power spectrum (Tegm ark et al. 2003a,b; Pope et al. 2004), and they found good agreem ent with the 2dFGRS gross shape of the power spectrum. Pope et al. (2004) em phasize that SDSS alone cannot break the degeneracy between  $_{\rm m}$  h and  $_{\rm b}$  =  $_{\rm m}$  because the baryon oscillations are not resolved given the window function of the survey.

# 2.2. Upper lim its on the neutrino m ass

Solar, atm ospheric, and reactor neutrino experiments have conmed neutrino oscillations, implying that neutrinos have non-zero mass, but without pinning down their absolute masses. While it is established that the elect of neutrinos on the evolution of cosmic structure is small, the upper limits derived from large-scale structure could help signic cantly to constrain the absolute scale of the neutrino masses. Elgar y et al. (2002) used the 2dFGRS power spectrum (Figure 1) to provide an upper limit m<sub>itot</sub> < 2:2 eV, i.e. approximately 0.7 eV for each of the three neutrino avours, or phrased in terms of their contribution to the matter density,  $=_m < 0:16$ .

## Lahav

The W MAP team (Spergel et al. 2003) reported an improved limit of m  $_{tot} < 0.71 \text{ eV}$  (95% CL). A ctually the main neutrino signature comes from the 2dFGRS and the Lyman forest which were combined with the W MAP data. The main contribution of W MAP is that it constrains better the other parameters involved, e.g. m (see also Hannestad 2003 and Tegmark et al. 2003b for similar results from SDSS+W MAP). Despite the uncertainties involved, it is remarkable that the results from redshift surveys give upper limits which are lower than those deduced from laboratory experiments, e.g. tritium decay.

#### 3. W iener reconstruction of 2dFGRS

W iener Itering is a well-known technique and it has been applied to many elds in astronomy. For example, the method was used to reconstruct the angular distribution over the whole sky including the ZoA (Lahav et al. 1994), the real-space density, velocity and gravitational potential elds of the 12-Jy IRAS (Fisher et al. 1995). The W iener Iter was also applied to the reconstruction of the maps of the cosm ic microwave background temperature uctuations. A detailed form alism of the W iener Itering method as it pertains to the large-scale structure reconstruction can be found in Zaroubiet al. (1995). The W iener Iter is optim al in the sense that the variance between the derived reconstruction and the underlying true density eld is minim ised. As opposed to ad hoc sm oothing schemes, the W iener Itering is determined by the data. In the limit of high signal-to-noise, the W iener Iterm odi es the observed data only weakly, whereas it suppresses the contribution of the data contam inated by shot noise.

Erdogdu et al. (2004) reconstructed the underlying density eld of the Two-degree Field Galaxy Redshift Survey (2dFGRS) for the redshift range 0:04 < z < 0:20 using the W iener ltering method. They used a variable smoothing technique with two di erent e ective resolutions: 5 and 10 h<sup>1</sup> M pc at the median redshift of the survey. They identi ed all major superclusters and voids in 2dFGRS. In particular, they found two large superclusters and two large local voids. One of the two large superclusters is shown in Figure 2. (2003) from the SD SS.

#### 4. D iscussion: Future studies of the cosm ic web

W e m otivate the great need for new approaches to analysis of redshift surveys and simulations by som e illustrative examples:

(i) Consider two im ages, say of a cat and a dog. If we take Fourier transforms of both, and swap the amplitudes and phases, we will still be able to recognise the cat in the image which retains its original phases, even if it has the amplitudes from the dog's original image! Phase information is thrown away in the commonly used power spectrum (or its Fourier transform, the two-point correlation function). Two realisations of the galaxy distribution may have the same power spectrum, but they may look very di erent due to phase correlations. These phase correlations are expected to be due to the non-linear elects in the

evolution of the gravitational instability and would arise even if the primordial uctuations were purely Gaussian.

(ii) The 2-degree-Field G alaxy Redshift Survey (2dFGRS) power spectrum is consistent with the low density ( $_m = 0.3$ ) Cold D ark M atter model (Percival et al. 2001). Volum e averaged p-point correlation functions up to order p = 6 have recently been calculated (B augh et al. 2004) and in particular on sm all scales they are sensitive to the appearance of two rich superclusters in the 2dF-GRS volum e, one of them is shown in Figure 2. V isual inspection of the A bell catalogue suggests that such superclusters are quite common. However, they seem less common in -CDM simulations which nevertheless do agree with the 2dFGRS power spectrum (p = 2) statistic. It is important to know whether the

-CDM simulations pass the test of high order moments, whether they require strong biasing in high density regions and whether 2dFGRS is a fair sample of the nearby universe.

(iii) Recent studies of higher moments, e.g. the three point correlation function (or its Fourier transform, the bi-spectrum) in both 2dFGRS and SDSS showed that they set important constraints on biasing, although the interpretation is model dependent (e.g. Verde et al. 2002; K ayo et al. 2004).

It is timely to address these issues now for a number of reasons:

For the statistics (e.g. m inimal spanning tree, percolation and M inkow ski functionals) could not be applied e ectively to ux limited surveys, where the mean separation between observed objects varies with distance from the observer. With volume limited sam ples we can apply these and new m ethods easily, and contrast data with simulations on equal footing.

The new surveys are also large enough now to sub-divide the galaxies by colour or spectral type. Recent studies of 2dFGRS and SDSS show the bim odality of galaxy populations in colour or related properties (e.g. M adgwick et al. 2002; K au m ann et al. 2004) and that clustering patterns of Yed' and blue' galaxies are quite di erent on scales sm aller than 10 h <sup>1</sup>Mpc (e.g. Zehaviet al. 2003; M adgwick et al. 2004).

We can now probe the evolution of clustering patterns with redshift, given DEEP2 and VIRMOS at redshift z 1 compared to 2dFGRS and SDSS at z 0:1.

The N-body simulations (e.g. Virgo) are now well advanced in resolution and volume to allow us to produce 2dF-like or SD SS-like sam ples.
