COSM IC EVOLUTION OF THE GALAXY MASS AND LUM INOSITY FUNCTIONS BY MORPHOLOGICAL TYPE FROM MULTI-WAVELENGTH DATA IN THE CDF-SOUTH

Abstract. We constrain the evolution of the galaxy mass and lum inosity functions from the analysis of (public) multi-wavelength data in the Chandra Deep Field South (CDFS) area, obtained from the GOODS and other projects, and including very deep high-resolution in aging by HST/ACS.Our reference catalogue of faint high-redshift galaxies, which we have thoroughly tested for completeness and reliability, com es from a deep 1 Jy) in age by IRAC on the Spitzer Observatory. These in aging data in the eld are complemented (S3:6 with extensive optical spectroscopy by the ESO VLT/FORS2 and VIMOS spectrographs, while deep K-band VLT /ISAAC in aging is also used to derive further com plem entary statistical constraints and to assist the source identi cation and SED analysis. We have selected a highly reliable IRAC 3.6 m sub-sample of 1478 galaxies with S_{3:6} 10 Jy, 47% of which have spectroscopic redshift, while for the remaining objects both COM BO-17 and H yperz are used to estim ate the photom etric redshift. This very extensive dataset is exploited to assess evolutionary e ects in the galaxy lum inosity and stellar m ass functions, while lum inosity/density evolution is further constrained with the number counts and redshift distributions. The deep ACS in aging allows us to di erentiate these evolutionary paths by m orphological type, which our simulations show to be reliable at least up to z 1:5 for the two main early- (E/SO) and late-type (Sp/Irr) classes.

These data, as well as our direct estimate of the stellar mass function above M $h^2 = 10^{10}$ M for the spheroidal subclass, consistently evidence a progressive dearth of such objects to occur starting at z 0:7, paralleled by an increase in luminosity. A similar trend, with a more modest decrease of the mass function, is also shared by spiral galaxies, while the inregulars/m ergers show an increased incidence at higher z. Remarkably, this decrease of the com oving density with redshift of the total population appears to depend on galaxy mass, being stronger for moderate-mass, but almost absent until z = 1.4 for high-mass galaxies, thus con ming previous evidence for a "downsizing" e ect in galaxy formation. Our favoured interpretation of the evolutionary trends for the two galaxy categories is that of a progressive morphological transformation (due to gas exhaustion and, likely, merging) from the star-forming to the passively evolving phase, starting at z 2 and keeping on down to z 0:7. The rate of this process appears to depend on galaxy mass, being already largely settled by z 1 for the most massive system s.

1. IN TRODUCT ION

Subject of active, as much as inconclusive, investigation during the last 40 years or so, the cosmological origin of the Hubble galaxy morphological sequence can now be very e ectively constrained by combining the

unique in aging capabilities of HST/ACS with the wide IR multi-wavelength coverage o ered by the Spitzer Space Telescope and the rem arkable photon-collecting power and multiplexing of spectrographs on large ground-based telescopes (VLT, Keck). As much a complex process as it might have been { involving both gravity and hydrodynamics (see e.g. Baugh et al. 2005), and possibly other physical processes such as black-hole form ation and accretion, tidal interactions and m erging, and feedback from stellar and nuclear activity (Springelet al. 2005) { we have now a de nite chance to observe it in operation.

At the current stage, how ever, the subject remains still rather controversial. While slow infall of primordial gas may explain disk formation in a relatively simple way, (e.g. Mo, Mao & White 1998), we still lack an adequate understanding of spheroid formation. On one side, the homogeneity of the early-type population and tightness of the fundamental plane might suggest that these galaxies have formed from a singlem onolithic collapse, an early aggregation of lumps of gas turning into stars in the remote past (z_{form} 3) via a huge burst-like episode followed by quiescence (Eggen et al. 1962; Larson et al. 1975; Chiosi and Carraro 2002).

This how ever is in apparent contradiction with recently favoured models of hierarchical galaxy form ation which postulate that early-type galaxies are assembled at later tim es by stochastic m erging of low er-m ass galaxies, either accompanied by strong star form ation activity (e.g.W hite et al. 1978; W hite et al. 1991; Som erville & Prim ack 1999; Cole et al. 2000), or through more "silent" dry-merging and dynamical aggregation (Bell et al. 2005a, Tran et al. 2005). In such case, ellipticals would be form ed over tim escales com parable to the Hubble time, with a major fraction of the mass assembly taking place around z (e.g. Som erville et al. 2001), and virtually all massive galaxies disappearing by z 1:5.Benson et al. (2002) nd popular hierarchicalm odels to produce as m any spheroids with highly inhom ogeneous colors as observed locally, but to underpredict the proportion of hom ogeneous, passive objects at redshifts z 1. This suggests that while the star form ation rate in spheroidals at low redshifts (z 1) is predicted correctly, the form ation rate at higher redshifts is underestimated. On the other hand, recent results from the K20 project (see Daddiet al. 2004a and references therein) claim that sem ianalytic models underestim ate the num ber of massive galaxies at z 2 by about a factor of 30 and suggest that the assembly of massive galaxies took place at substantially earlier epochs than predicted by these models.

O bærvational constraints on the star form ation history have been inferred from the broad-band colors, line strength indices and stellar chem ical abundances. W hen referred to massive ellipticals, these observations offen suggest that the bulk of stars m ight have been form ed in a rem ote past. However, som e secondary activity of star form ation in the recent past is also evident: nearby ellipticals show a large variety of m orphological and kinem atical peculiarities (e.g. Longhetti et al. 2000) and a considerable spread of stellar ages, particularly for the eld population (T hom as et al. 2005). Strong evolution in the population of early-type galaxies has been reported by K au mann, C harlot & W hite (1996) and K au m ann & C harlot (1998), which has been considered to support the hierarchical galaxy form ation m odels. Published results from high redshift galaxy surveys appear not unfrequently in disagreem ent with each other, and con icting conclusions are reported (see Faber et al. 2005 for a recent review about galaxy evolution at z < 1). This is partly due to the sm all sam pled areas and the corresponding substantial eld-to- eld variance. How ever, a more general problem stems from the apparent con ict between reports of the detection of massive galaxies at very high redshifts (e.g. C im atti et al. 2004; G lazebrook et al. 2004; Labb e et al. 2005; D addi et al. 2005a,b) and indications for a fast decline in the in the com oving number density at z > 1 (Franceschini et al. 1998; Fontana et al. 2004).

In sum mary, whereas early monolithic collapse and hierarchical models imply radically di erent histories for spheroids, neither the theoretical predictions nor the observational constraints for eld galaxies have yet been sufciently de nitive for precise conclusions to be drawn in favour of one or the other scenario.

The most direct way of constraining the evolutionary history of galaxies and trying to resolve the discrepancies would be to derive the redshift-dependent lum inosity and mass functions from deep unbiased surveys. This has been pursued by a number of team s, relying on either U-band optical selection as a probe of SFR density (Lilly et al. 1996; M adau et al. 1996) and UV selection by GALEX (Schim inovich et al. 2005), or observations in the K-band (C ow ie et al. 1996; C im atti et al. 2002; D ickinson et al. 2003; Franx et al. 2003; D rory et al. 2004; Fontana et al. 2004; B undy, E llis & C onselice 2005).

We contribute to this e ort by exploiting in this paper very deep public in aging by the IRAC photom etric cam era on the Spitzer Observatory to select a most unbiased sample of high-z (z 2) near-IR galaxies. We use for this the IRAC Channel-1 3.6 m data over 160 arcm in² in the Chandra Deep Field South (CDFS) taken within the GOODS project (Dickinson et al. 2004). The other IRAC in aging data in the eld are either redundant (Channel-2 at 4.5 m, too close to channel-1 and som ewhat less sensitive), or include non-stellar contributions by the galaxy ISM (the longer wavelength Channels-3 and 4) which would far com plicate the interpretation.

Near-IR surveys are best suited for the study of faint high-redshift galaxy populations, for various reasons. C om pared to UV-optical selection, the observed uxes are m inim ally a ected by dust extinction. At the same time they are good indicators of the stellar m ass content of galaxies (Dickinson et al. 2003; Berta et al. 2004), and closer to provide a mass-selection tool. For typical spectra of evolved galaxies, the IRAC Channel-1 3.6 m also bene ts by a K-correction particularly favourable for the detection of high-redshift galaxies, particularly if we consider that the H opacity minimum (corresponding to a typical peak in galaxy's SED s) at ' 1:7 m in stellar athm ospheres (Sim pson & E isenhardt 1999) falls within the waveband of Channel-1 for z= 1 objects.

In addition to the Spitzer observations, the GOODS project has provided the community with an unprecedented am ount of high quality optical and near-IR data in CDFS, particularly the very deep 4-band ACS im aging, allow ing the most accurate m orphological analysis currently possible over an appreciable area. Building on our previous experience of faint galaxy im aging and statistical modelling (Rodighiero et al. 2001; Cassata et al. 2005), on our tools for spectro-photom etric analysis (Poggianti, B ressan & Franceschini 2001; B erta et al. 2004), and expertises for reduction of deep IR im aging data from space (e.g. Rodighiero et al. 2004 for ISO data; Lonsdale et al. 2004, H atzim inaoglou et al. 2005, Rodighiero et al. 2005 for Spitzer data), we illustrate in this paper the pow er of com bining such multi-wavelength inform ation in the analysis of the evolutionary m ass and lum inosity functions of faint galaxies.

Since the spectroscopic follow -up is currently only partial in the eld, and to avoid as far as possible confusion problems in the IRAC data, we lim it our analysis to moderate depths. In spite of this, the constraints on the history of massive galaxy evolution are already relevant. Pushing the analysis to the IRAC sensitivity lim its will allow to extend our conclusions further down in mass/lum inosity and up in z.

Though substantially larger than HDF's, our survey eld is still of m oderate size. Eventually, a complete understanding of the in uence of large-scale structure on the evolutionary history and to reduce the e ects of cosm ic variance will need new-generation datasets on large areas (e.g. COSMOS, Scoville et al. 2004).

The paper is structured as follows. Section 2 describes the optical and IR (Spitzer) data, the near-IR data and ACS/HST imaging, the spectroscopic data used in our analysis, and our criteria for catalogue combination and merging. Section 3 details on our quantitative morphologicalanalysis of faint galaxies, and Section 4 sum marizes our e ort for the photom etric redshift estimate. Our statistical analyses are reported in Section 5, while Section 6 is dedicated to derive the mass function in stars of our galaxies. A comparison of observed and model number counts is discussed in Section 7. Sections 8 and 9 sum marize our results and conclusions.

We adopt in the following a standard set of values for the cosm ological parameters $_{\rm M} = 0.3$ and = 0.7, while for ease of comparison with other published results we express the dependence on the Hubble constant in terms of the parameter h H _0=100 K m =s=M pc and provide the relevant scaling factors.

2.0 bservations and D ata A nalysis

2.1. Deep IR Imaging with Spitzer

The GOODS southern eld is located in the Chandra Deep Field South (CDFS) area, that is centered at RA (J2000)= 03:32:30.37 and DEC (J2000)= -27:48:16.8. The IRAC Spitzer observations in the eld include deep in aging in four near-IR bands (3.6, 4.5, 5.8 and 8.0 m). The exposure time per channel per sky pointing was 23 hours as a m inim um .D ue to the fact that observations were done in two epochs, it is approxim ately two times this in a central deeper strip where the two overlap.W e exploit in this paper a galaxy catalogue that we have derived from the 3.6 m IRAC data.

W e started the data reduction using products generated by the Spitzer Science Center (SSC) Basic Calibrated Data (BCD) pipeline. We used all BCDs available in the archive at the end of November 2004. The archived data were processed with pipeline version S10.5.0 provided by the Spitzer Science Center.W e applied an additive correction factor to each BCD fram e in order to rem ove the m edian background.We have then processed and mosaiced all corrected BCDs within the M opex package¹, using a standard procedure that accounts for cosm ic radiation hits, outliers, at-eld and distortions of the detector. The pixel size in the nalm ap is $0.6 \, \text{arcsec/pixel}$. The GOODS IRAC mosaic with a signi cant sky coverage (sky pixel repetition factor> 20) covers an area of approximately 18 square arcm inutes on the sky. 12

The IRAC source extraction has been perform ed with SExtractor (Bertin & A mouts, 1996). A ssuming that essentially all the sample sources are seen as point-like by the IRAC 3 arcsec imager, we computed the uxes within a 5.9 arcsec diam eter aperture and applied a correction factor derived from the stars in the IRAC images to assess the total uxes. In the case of extended sources, we used K ron like magnitudes (AUTO_MAG output param eter in SExtractor).

22.Near-IR Ground-based Im aging

As part of GOODS, near-infrared im aging observations of the CDFS have being carried out in J, H, Ks bands, using the ISAAC instrum ent mounted on the ESO VLT telescope.We made use of the publicly available J and K band im aging (version 1.0, released² by the ESO/GOODS team in April 2004). This data release includes 21 fully reduced VLT/ISAAC elds in J and Ks bands, covering 130 arcm in² of the GOODS/CDFS region. It also includes m osaics of the co-adjoined tiles as single FITS les in J and Ks bands, as well as the corresponding weight-m aps.

To provide a hom ogeneous photom etric calibration across the entire eld, the GOODS team at ESO have rescaled all images to the same zero point (26.0 in the AB system). The nalmosaics have a pixel scale of 0.15". We have run SExtractor on the J and K mosaics to obtain totalm agnitudes (BEST_MAG output parameter in SExtractor) for all the objects in the eld.

2.3. The Near-IR Source Selection Functions

The completeness of our 3.6 m catalogue was assessed through num ericalsim ulations. A num ber of sources spanning the 0.3-30 Jy ux range was added to the im age at random positions using a synthetic T inyT im PSF (K rist, 2002). A conservative overall gure of 1600 sources (corresponding to 200 beam s/source) was chosen as the additional source density in order to avoid confusion e ects.

Source extraction was carried out as done on the original in age, and inputs and outputs were cross-correlated using a 1.5 pixel search radius (corresponding to 0.9 arcsec). The results are shown in Figure 1, where a t to the selection function curve is also shown. Our sample turns out to be 60% complete above 1 Jy, 90% complete above 5 Jy, and m ore than 95% above 10 Jy. Further tests of the validity of our IRAC source selection will be discussed in Sect. 5.1 based on a comparison of our and independent results on the galaxy num ber counts.

The IRAC 3.6 m sample at 1 (10) Jy includes 5622 (1646) sources, respectively.

We have also performed extensive M onte-C arb simulations, including the insertion of several IRAC/GOODS-like toy galaxies in the realimage, to determ ine the limit of completeness in the K band.We applied the same extraction criteria used on the ISAAC images and we derived the detection rate as a function of the simulated magnitude.We estimated the K-band sample to be more than 90% complete at K < 21 (Vega reference system).

2.4. ACS/HST Optical Im aging

The core of the GOODS project was the acquisition and reduction of high-resolution HST/ACS imaging data ob-

tained as an HST Treasury Program (Giavalisco et al. 2004). The GOODSACS/HST Treasury Program has surveyed two separate elds (the CDFS and the Hubble Deep Field North) with four broad-band lters: F435W (B); F606W (V); F775W (i); and F850LP (z). Observations in the V, i and z lters have been split into ve epochs, separated by about 45 degrees, in order to detect transignt objects. Observations in the B band are taken during epoch 1 for both elds. Im agestaken at consecutive epochs have position angles increasing by 45 . The total exposure times are 25, 25, 5 orbits in the V, i and z bands, respectively. The exposure time in the B band is three orbits. In August 2003 the GOODS team released version 1.0 of the reduced, stacked and mosaiced in ages for all the data acquired over the ve epochs of observation. To improve the point spread function (PSF) sam pling, the original im ages, which had a scale of 0.05 arcsec pixel¹, have been drizzled on to images with a scale of 0.03 arcsec pixel¹. W e used the version 1.0 of the im age catalogue.

The data set is com plem ented with the ACS/HST catalogs released by the HST/GOODS team in O ctober 2004, containing the photom etry in B, V, i and z bands. The source extraction and the photom etric m easurem ents have been performed by the GOODS team running a modi ed version of SExtractor on the version 1.0 im ages. Particular attention has been payed to the photom etry of faint sources, thanks to the careful determ ination of the local sky background. As for the case of the K-band im aging, we have considered the total m agnitudes (as from the BEST_MAG output parameter in SExtractor). M oreover, for the purposes of a detailed m orphological analysis, we used the high resolution deep im aging carried out by ACS/HST in the z-band (version 1.0, G iavalisco et al. 2004).

2.5.0 ptical Spectroscopy

In the last few years ESO has perform ed various system atic spectroscopic observational programs in the CDFS area by using all available multi-object spectrographs (i.e. FORS1, FORS2, VIMOS; see C in atti et al. 2002b; Le Fevre et al. 2004a,b; Szokoly et al. 2004; Vanzella et al. 2005). The contributions of the major projects are hereby sum marized.

The VIM OSVLT Deep Survey (VVDS, Le Fevre et al. 2004a) observed a large sample of galaxies in the CDFS area. The redshift data have been released to the community³: a total of 1599 objects with $I_{A\,B}$ 24 have m easured redshifts. The completeness in redshift m easurement for the targeted objects is high, better than 84%, and 784 of these fall within the GOODS-South ACS eld.

In the fram ework of the GOODS project, a large sam – ple of galaxies in the CDFS has been spectroscopically targeted (Vanzella et al. 2005). A total of 303 ob jects with $z_{850} < 25.5$ have been observed with the FORS2 spectrograph, providing 234 redshift determ inations. The reduced

spectra and the derived redshifts are released to the $\operatorname{com}-\operatorname{munity}^4$.

Further GOODS spectroscopic observations have been carried out with FORS2 at VLT (Szeifert et al., 1998) using the 300I grism, without blocking liter (ESO program s 170 A-0788 and 074 A-0709). This con guration gives a low resolution (R 850) in the wavelength range

5600 10000A.Data reduction has been detailed in Vanzella et al. (2005).

Another fraction of spectroscopic redshifts has been obtained as part of the K 20 survey (C in attiet al. 2002b), which have also been recently made public⁵. The K 20 sam – ple includes 546 objects to K_s 20 (Vega system) over two independent elds (52 arcm in² in total, 32 arcm in² in the CDFS). The spectroscopic redshift com pleteness is 94% and 87% for K_s 19 and K_s 20 respectively.

All the spectroscopic redshifts available in the version 1.0 of the GOODS/CDFSACS catalogue have been com – piled in a master list 6 .

2.6. Infrared to Optical Source Associations

The excellent quality of HST imaging allowed us to obtain reliable associations form ost of the Spitzer IR sources with the corresponding optical counterparts. On the other hand, the much worse spatial resolution of IRAC com – pared to ACS implies some signi cant complication in source association, which is discussed below.

It should be noticed that the deep K -band ISAAC im ages might in principle provide decisive support for the identi cation. However, only a fraction (60%, see Sect. 2.6.4) of the IRAC Spitzer 3.6 m sources turned out to have counterparts in the K -band (partly because the ISAAC imaging covered only 80% of the Spitzer/ACS common area). For this reason, our identi cation of the Spitzer sources followed a two-step procedure.

We have set booked for optical identi cations by matching with the ACS z-band catalogue. This provided us with reliable associations for a large majority of the 3.6

m objects.We have then proceeded to match all Spitzer sources with sources extracted from the ISAAC K -band images.This second step was needed not only to obtain near-IR data essential for the SED tting, photom etric redshifts, etc., but also to disentangle the correct identi cation for dubious matches, multiple associations, or confused sources emerging from step one.

2.6.1. Associations with the ACS z-band D ata

The validity of the association of the 3.6 m with z-band ACS sources was veri ed here by using the likelihood ratio technique introduced by Sutherland & Saunders (1992). W e adopt here the form alism described by Ciliegi et al. (2003). The likelihood ratio (LR) is de ned as the ratio between the probability that a given source at the observed position and with the measured magnitude is the true optical counterpart, and the probability that the same source is a chance unrelated object:

where n (m) is the surface density of objects with m agnitude m; q(m) is the expected distribution as a function of m agnitude of the optical counterpart; f(r) is the probability distribution function of the positional errors.

In the presence of m ore than one counterpart in the errorbox, the reliability $R el_j$ for object j being the correct identi cation is:

where the sum is over the set of all candidates for this particular source and Q is the probability that the optical counterpart of the source is brighter than the m agnitude lim it of the optical catalogue (Q = $R_{m \text{ lim}}^{m} q (m) dm$).

For each IRAC source we adopted a mean positional error of 1 arcsec, and we assumed a value of 0.1 arcsec as the optical positional uncertainty. We choose a search radius of 1.5 arcsec from the position of the centroid of the infrared error box to look for the possible optical counterparts.

Figure 2 shows the resulting magnitude distribution of the correct identi cations (dotted histogram) together with the expected distribution of background objects unrelated to the infrared sources (solid histogram). The smooth curve tted to the former (dot dot dashed line) has been used as input in the likelihood calculation. Since the fraction of infrared sources with more than one possible optical counterpart is 15% (see below), this corresponds to an expected fraction of correct identi cations above the magnitude lim it of the optical catalogue of the order of 85%. On this basis we adopted for the Q param eter the value Q = 0.85 (to check how this assumption could a ect our results, we repeated the analysis using di erent Q values in the range 0.5-1.0: no substantial difference in the nal number of identications and in the associated reliability has been found).

Once q(m), f(r) and n(m) have been determ ined, we computed the LR value for all the optical sources within a distance of 1.5 arcsec from the infrared positions. The best threshold value for LR (L_{th}) is then to be de ned, in order to discriminate between spurious and real identications. As discussed by C illegi et al. (2003), L_{th} has to be small enough to avoid missing many real identications, and be large enough to keep the num ber of spurious identications as low as possible.

For the LR threshold we adopted the value $L_{th} = 0.15$. W ith this and from eq. 2 with Q = 0.85, all the optical counterparts of infrared sources with only one identica-

The LR analysis has been performed for the whole IRAC sample to $S_{3:6} = 1$ Jy.

In order to m inim ize the problem of m isidenti cation, we have checked by visual inspection all the optical associations of each IR source with $S_{3:6\ m} > 10\ Jy$, our highly reliable and complete sub-sample. For stars and isolated objects, the cross-correlation is unambiguous: the shape and the peak of the infrared contours overlayed on the z im age have con m ed the associations. How ever, for several IRAC sources, particularly for the extended ones, the relationship between infrared and optical em issions m ay be m uch m ore uncertain: few optical sources can lie inside the IRAC errorbox and contribute to the infrared em ission. Such cases are dealt with in the following subsections.

2.6.2. Multiple Associations and Confused Sources

We found that 10% (15%) of the $S_{3:6\ m} > 10$ Jy sources have more than one optical counterpart within 1 (1.5) arcsec from the IR centroid position. Examples are shown in Figure 3, where we report zoom s on the optical z-band in age with the 3.6 m contours overlaid (red lines) for a couple of sources. The black squares m ark the positions of the original IRAC catalogue, while the blue circles are the optical counterparts. The thicker blue circles indicate our nal associations, choosen by the autom atic procedure discussed above.

In m any such cases, the LR analysis was able to disentangle the correct identication: in the lack of independent inform ation (Sect. 2.6.3) we assumed that the object with the highest likelihood ratio value was the correct counterpart of the IRAC source. A fraction of the IR sources with multiple optical counterparts display clear signs of confusion, due to the largely di erent spatial resolution of the Spitzer and HST im - ages. In such cases an extended 3.6 m emission appears to emerge from more than one optical source (generally by no more than two), and there is no obvious indication of the level of contribution by the various optical components to the IR ux. An example is given in Figure 4: in this case the two brighter optical sources are at the same redshift (z 0:37).

The fraction of confused sources in our matched $\rm IRAC/ACS$ sample above $\rm S_{3:6\ m}$ = 10 Jy is of the order of 5% .

Concerning the part of the sample with uxes between 1 and 10 Jy, the fractions of sources with multiple optical associations (hence with potential confusion problem s) is 16% for an association radius of 1 arcsec and 28% for 1.5 arcsec radius. For these we used the LR value to identify the correct optical counterpart.

2.6.3. M atching with the ISAAC K -band Im aging

To reduce the level of contam ination and confusion in our samples we have made full use of the deep ISAAC K - band im aging, which is close enough to the 3.6 m selection wavelength and at the same time provides sub-arcsec resolution.

We have cross-correlated the z-band ACS catalogue with the ISAAC in age in the 130 sq. arcm in common area, by applying the LR analysis presented in Sect. 2.6.1. This comparison allowed us to resolve the majority of the confusion problems in the complete 10 Jy sample. Our procedure was to split the 3.6 m confused source into as many components as revealed by the ISAAC in age (typically two), and to assign to each one a ux according to the observed ratios of the uxes in the K-band. An example of the application of this procedure is reported in Fig. 4.

In such a way we have resolved 60% of the confused cases, and brought the fraction of confused sources to only 2% of the complete sample.

Due to the small number and negligible impact on our results of the latter, we have not attempted to apply complex deblending procedures to recover the 3.6 m ux coming from each single components. Instead, when building the observed SEDs for these 30 objects, we have summed the optical uxes of the components of the IRAC blend, at least where there was evidence for interaction from morphology (see the example in Figure 4).

In conclusion, our choice of a moderate x limit (S_{3:6 m} = 10 Jy) for our reference complete samplem inimizes the photom etric complications due to source confission. For the fainter sample, used in the following only for extracting morphology-selected number counts, the application of the procedure of using the ISAAC image did not bring a signi cant improvement in the statistics of multiple or confused sources.

2.6.4. The Band-merged RAC/GOODS Catalogue

Once each 3.6 m source has been assigned to its z-band { and whenever possible K -band { counterparts, we proceeded by building a multi-wavelength catalogue, in order to include all the available photom etric bands. The crosscorrelation with the ISAAC (J and K) and the other H ST bands was done using a search radius of 1.5 arcsec around the z-band positions. The area covered by H ST observations, approximately 160 square arcm inutes, is smaller than that originally covered by Spitzer, 81% of which (130 sq. arcm in) is also surveyed in K by ISAAC.

Our nal sample includes 1646 IRAC sources with $S_{3:6\mbox{ m}} > 10$ Jy (1478 turn out to be galaxies and 168 stars, see below) and a total of 5622 sources with $S_{3:6\mbox{ m}} > 1$ Jy inside the Spitzer/ACS common area of 160 sq. arcm in, 5302 of which are galaxies and 320 stars. Sixty percent of the total sample sources have a K-band counterpart. This fraction reaches 75% when considering the high-reliability limit of $S_{3:6\mbox{ m}} > 10$ Jy.

3.MORPHOLOGICAL CLASSIFICATION

W e have perform ed a quantitative m orphological classi – cation using the z-band ACS in ages for all sam ple galaxies.For this we m easured for each galaxy the set of param – eters C oncentration (C), A sym m etry (A) and clum pinesS (S) of the galaxy light distribution (CAS param eters).

The concentration roughly correlates with the bulge to disk ratio, enabling distinction between bulge- and diskdom inated galaxies (Abraham et al. 1996). The asym m etry di erentiates norm al isolated galaxies from irregular/m erging systems (Conselice et al. 2000). The clum piness (a measure of the uniform ity of the galaxy surface brighness distribution) is expected to correlate with the ongoing star form ation rate (Conselice 2003a).

W hen attempting a morphological classi cation of a large sample of galaxies at widely di erent redshifts, it is crucial to take into account the e ects of the so-called morphological K-correction. This considers that galaxies observed at bluer wavelengths tend to display a later morphological type. For this reason we have used in this work

the longest wavelength z-band (the F850LP ACS liter) to study the morphology of the entire sample: this band corresponds to about rest-fram e I, V, B and U for galaxies at z=0.2, 0.5, 1 and 1.5 respectively.

However, as already discussed by various authors (W indhorst et al. 2002; Papovich et al. 2003), this e ect is relevant mainly when comparing U rest-frame with visual (B or V rest-fram e) m orphologies. This m eans in our case that only some of the galaxies at a redshift larger 1:5 may be signi cantly in uenced by this efthan z fect. Cassata et al. (2005, henceforth CA05) discuss in detail and try to quantify it by com paring the visualm orphology of a sample of z 1 galaxies in their U and B rest-frame. They nd that the morphology is preserved for all early-type galaxies, while som e B rest-fram e disks appear as irregular in the U rest-fram e (but this is not im portant in our approach, that segregates only early-from late-type galaxies). G iven that the technique used for this work is calibrated on the results by Cassata et al. (2005), the same conclusions of that work can be applied here. Therefore, we do not expect our analysis to be a ected by strong m orphological K -correction e ects, especially considering that ourm ain points about the evolutionary m ass and lum inosity functions in the following Sects. concern the z < 1.5 universe, and since we con ne our analysis to the basic early-to late-type structural di erentiation.

M orphological classi cation based on the CAS param eter set is particularly e ective in disentangling spheroid-dom inated from spiral/irregular galaxies. Early type galaxies usually have a low value of asymmetry, an high concentration and a sm all clumpiness. Cassata et al. (2005) nd that early type galaxies in the K 20 catalogue (a subset of the current GOODS sample, C in atti et al. 2002) occupy a rather precise dom ain of the CAS param – eter space, as m easured on the ACS/GOODS in ages:

G a laxies having CAS param eters lying in the region above are classi ed as early-type, while the remaining are classi-

ed as late-type. The stars are very e ectively isolated by combining the z-band ux with the stellarity index calculated by SExtractor (CLASS_STAR) on the z-band im - ages. Figure 5 plots the stellarity index (CLASS_STAR) versus the z_{AB} m agnitude. Stars are easily identified in the rectangular box of high stellarity and bright m agnitude.

We have nst applied the above technique to the 1646 objects of our 3.6 m catalog above 10 Jy, and identi ed in such way 168 stars, 472 (32%) early-type and 1006 (68%) late-type galaxies in the complete sample. This compares with a fraction of 26% early-types (74% spirals and irregulars) estimated by Bundy et al. (2005) among galaxies brighter than $z_{AB} = 22.5$.

The morphology of a subsam ple of 155 galaxies (about 10% of the objects in our 10 Jy catalog) has also been visually inspected, in order to check the reliability of our autom atic technique. We found that the visual and the CAS mophologies agree with each other for 90% of the 55 galaxies autom atically classi ed as early-type and for 97% of those autom atically classi ed as late-types. The autom atic classi cation procedure then provides a valuable and robust tool for disentangling early from latem orphological type galaxies.

We have then addressed the m ore challenging problem of estimating structural properties for sources fainter than 10 Jy and down to $S_{3:6} = 1$ Jy. To this end, we have applied our m ethod to all 3976 sources detected within this ux interval, of which 152 turned out to be stars, 548 early-type and 3276 late-type galaxies. Then the fraction of spheroidal galaxies to total drops from m ore than 30% in the bright sample to 14% fainter than $S_{3:6} = 10$ Jy.

It should be noted that, among all objects in this ux interval, 990 have z-band ACS magnitude fainter than 25 (927 of which classi ed by CAS as late-type, 61 as early-type and 2 stars). Our simulation experiments (see also Cassata et al. 2005) indicate that, beyond z_{AB} ' 25 m ag, the autom atic classi cation is less reliable.

For this reason we have perform ed a visual check of a large subset of the IRAC/GOODS galaxy sample, with particular attention to the 990 optically fainter, in random magnitude order, to determ ine how many would be consistent with an early-type and how many with a latetype morphology. As for the 548 CAS-classi ed ellipticals, visual inspection shows that approximately 30% may be consistent with having misclassi ed late-type morphologies. On the other hand, a CAS-classi ed late-type galaxy has a much lower chance (of the order of 4% at the 1 Jy limit) to be a spheroidal system.

In conclusion, for spheroidal galaxies we evaluate that the overall uncertainty due to morphological misclassi – cation of the faint optical counterparts is such that their

number ranges from 380 to 690 objects (i.e. from 10% to 18% of the total galaxy population) at the 1 Jy sensitivity lim it of our survey. The corresponding relative uncertainty in the late-type morphological subset is lower by a factor 5, or of the order of 20% at most. This provides us with the upper and low erboundaries in the num ber counts di erentiated by morphological class (see Sect.5.1).

4.PHOTOM ETRIC RED SHIFTS

available in The spectroscopic data the GOODS/IRAC/GOODS area (see Section 2.5) have been cross-correlated with our S (3:6 $_{\rm m}$) > 10 Jy com plete catalogue, including 1478 extragalactic sources at this ux limit. Of these, 695 (or 47%) turned out to have a spectroscopically con med counterpart.

For an important fraction of the remaining galaxies, we have used public photom etric redshifts from COMBO-17 (W olf et al. 2004), a multi-band photom etric survey entirely covering our eld. W olf et al. have shown that the COMBO-17 photom etric redshifts are highly reliable and accurate for galaxies with R < 24 and z < 1, for which the typicall-redshift error z = (1 + z) is 0.07. The comparison of the photom etric redshift estim ate and spectroscopic m easurem ents show s, how ever, an increasing scatter from the one-to-one relation above $z_{phot} > 0.8$ (see Fig. 4 in W olf et al. 2004). This observed discrepancy between the photom etric and the spectroscopic data at high z is mostly due to the fact that COMBO-17 is based on optical SEDs only, and cannot exploit the Balm er-jum p spectral feature for galaxies at z > 1.A ltogether, of our 783 galaxies without spectroscopic redshift, we have used 375 photom etric estimates from COMBO-17, all those with z_{phot} 0:8. One hundred and 26 IRAC 3.6 m sources do not have a COMBO-17 association due to the di erent selection functions.

For the remaining 408 sources (27%) in our sample, photom etric redshifts have been estim ated here using the H yperz code (Bolzonella et al. 2000), exploiting the avail-

In particular we have included in our analysis the IRAC 3.6 m uxes, as providing a useful contraint on the solutions (e.g. Rowan-Robinson et al. 2005; Polletta et al. in prep). W hile ne-tuning the procedure, it turned out that fairly accurate photom etric redshifts were obtained by using only two templates from the set provided by H yperz, namely one for ellipticals (E :ised) and one for norm al Sb spirals (Sb:ised). W e assumed the reddening law by Calzetti (2000).

W e have used the num erous spectroscopic redshifts in the eld to check the reliability of our photom etric estimates. For the spheroid (late-type) classes we obtained a median o set of $(z)=(1 + z_{spec}) = 0.06$ (-0.08) and a m s scatter of $[(z)=(1 + z_{spec})] = 0.08 (0.11)$. In Figure 6 we report a com parison of photom etric versus spectroscopic redshifts separately for early-type (left panel) and late-type galaxies (right panel). We show here sources with $S_{3:6} > 10$ Jy and for which H yperz found a reliable t (corresponding to a rejection probability based on 2 lower than 99%). These plots show that our procedure im plies som e system atic deviation at z < 0.6, where H yperz tends to underpredict the redshift.

For only 60 sources in the complete 10 Jy sample either COMBO-17 or the Hyperz ts turned out to be marginally acceptable or bad (rejection² probability higher than 95%). This how ever corresponds to only 4% of the Spitzer com plete sam ple, hence does not im pact on our conclusions.

5. STAT IST ICAL ANALY SES

5.1. Extragalactic Number Counts from Spitzer RAC D ata

We have st estimated the extragalactic number counts at 3.6 m in the GOODS-CDFS area, by weighting each sources with the reciprocal of the e ective area $1=A_e$ (> ability of an extensive photom etric coverage at > 1 m. S_i) within which they could be detected to a given ux

density. The errors associated with the counts in each ux level have been computed as in G ruppioni et al. (2002):

where the sum is over all the sources with x ux density S_i . These errors represent the Poissonian term of the uncertainties, and have to be considered as lower limits to the total errors.

We plot in Figure 7 a comparison of the IRAC/GOODS total di erential 3.6 m counts from our analysis with those published by Fazio et al. (2004), that were computed from a much wider sky area (9 square degrees). We report our counts corrected for incom pleteness (lled diam onds) and those uncorrected (open diam onds), versus the corresponding corrected (dotted line) and uncorrected (solid line) counts by Fazio et al. (2004).

A general agreem ent is observed between the two independent samples, in particular concerning the \raw" counts. Once the data are corrected for the corresponding selection functions, we observe the Fazio's et al. distribution keeping slightly higher at the fainter ux range ($S_{3:6} < 3$ Jy). Below this level, source confusion starts to play som e role, and it is di cult to assess if the reason for this slight discrepancy m ight be due di erent treatm ent of the blended sources or di erences in the determ ination of the com pleteness corrections. In any case, this does have a quite modest impact on the integral counts which are used in the following.

Figure 8 provides details about the cumulative number counts for our IRAC/GOODS sample of $3.6\,$ m selected galaxies (empty diamonds) for di erent morphological classes (all stars are excluded). The contributions of each sources to both the counts and the associated errors are weighted for the area within which the source is detectable.

The two upper panels in the gure show the relative contribution of the early- and late-type morphological classes, while the lower panel the results for the whole 3.6 m population. The enrorbars include both the Poisson noise and the uncertainties in the morphological classic cation as discussed in detail in Sect. 3. The form er dom inate at the brighter uxes, while the latter uncertainty determines the enrorbars at the faint ux limits. All inform ation on num ber counts is also reported in Table 1.

The vertical dotted lines mark the limit, 10 Jy, above which the sample is 95% complete. The data and their errorbars have all been corrected for incompleteness (see Section 2.3). The correction factor at the 1 Jy limit am ounts to a factor 1.5 only (see Fig.1). The implications of the total observed counts and the separate contributions by the various morphological classes will be discussed in Section 7.

52. Redshift Distributions

The observed distributions of redshifts for complete galaxy sam ples provide a fundam ental test for evolutionary m odels (e.g. Franceschini et al. 1998; Som erville et al. 2004; Kitzbichler and W hite 2004). Figure 9 shows our estimated redshift distributions N (z) for the 3.6 m sample with $S_{3:6} > 10$ Jy (thick solid histogram s) in the CDFS area, a ux level at which the sam ple is 47% spectroscopically complete. The distributions here include 695 spectroscopic, 375 COM BO-17 and 408 H yperz photom etric redshifts. The upper panels show the relative contribution of spheroids and late-type galaxies, while the bottom panel reports the total distribution. The prom inent peak around z 0:8 is partly contributed by already known CDFS galaxy overdensities falling within the redshift bin (C in attiet al. 2002, Vanzella et al. 2005, Le Fevre et al. 2004a, A dam iet al. 2005). The total observed distribution shows a rapid decline above z 12, and this feature is com m on to both m orphological classes. E lliptical galaxies are virtually absent above z 1:6, while spiral/irregular galaxies show an apparent tail extending up to z 2:7.

Note that the detailed behaviour of the N (z), as well as of the num ber counts, is a combination of the intrinsic evolution of the lum inosity functions, the K-corrections and the ux limit (e.g. Ilbert et al. 2004). We will resort to detailed modellistic ts in Sect.7 to disentangle these various elects.

Particular interest resides in the high-redshift tail of the distribution, because the statistics of the higher-z

galaxies provides the tightest constraints on the form ation m odels.

A question m ight arise here about the reliability of the morphological classi cation for such faint distant objects. We have then spent some e ort in adding visual inspection to the automatic analyses for all 183 galaxies with z > 1.3 in the complete sample. This inspection has essentially con meed the results of the CAS classi cation and has shown that 5-6% at most of the 151 latetypes could be m isclassi ed spheroids, while 30% of the 32 spheroids could be instead be classi ed as later type galaxies. Then, at close inspection, we do not expect m ore spheroidal galaxies at z > 1.3 than shown in Fig. 9.

O ur totalobærved z-distribution is consistent with the results of the analysis of Som erville et al. (2004) based on the photom etric redshifts by M obasher et al. (2004). The Som erville's et al. analysis considered the z-distributions for only the total population of a K-band selected galaxy sam ple.

We nd also fair consistency with a recent report by Rowan-Robinson et al. (2005) based on the analysis of SW IRE survey data (Lonsdale et al. 2004) in the Lockm an veri cation eld (VF) to $S_{16} > 10$ Jy and r < 25, based on purely photom etric redshifts and galaxy classi cation based on colors. Here, elliptical galaxies (red subpopulation) also appear to cuto at z 1:4, while a tail of star-form ing galaxies is seen up to z 3.

Our advantage compared to these analyses is in the substantial spectroscopic redshift coverage and the detailed structural analysis of the Spitzer galaxy sample m ade possible by the very deep multiband ACS data. A comparison with m odel predictions will be discussed in Sect. 7.

5.3. Color B in odality versus M orphological Classi cation

Recent work has shown that the rest-fram e color distribution of galaxies is bim odal at all redshifts out to z = 1

(see, e.g. Hogg et al. 2002; B lanton et al. 2003; B ell et al., 2004). O ne peak is red and consists of mostly quiescent galaxies earlier than Sa in morphological type. The other peak is blue and consists prim arily of star-form ing galaxies later than Sa (Strateva et al. 2001, B ell et al. 2004).

W ith the present large dataset we are able to check if our morphological and structural classi cation is consistent with a color-based selection. Figure 10 shows our observed color distributions from the $S_{3:6} > 10$ Jy uxlimited sample in three redshift bins from z = 0.3 up to z = 1.5. Rem arkably, a best color di erentiation turned out to be provided by the V-I (or alternatively V-z) observed color in all redshift bins. The red dotted line histogram s correspond to the morphologically classi ed ellipticals, while the blue dashed line to the late-type galaxies.

These plots show not only a bim odal distribution at all redshifts, but also a clear correlation between galaxies with early-type (late-type) morphological classi cation and the reddest (bluest) population. There is only a marginal trend for the early-type population to increase the median color with z, while the late-types keep remarkably unchanged.

However, it is relevant to note that quite a signi cant fraction, of the order of 30%, of the population morphologically classi ed as spheroidal galaxies (472 objects brighter than 10 Jy) display blue colors typical of later morphological types. A lso, this result looks largely independent of redshift.

We have boked in some detail into this population of spheroidal galaxies with blue colors, in particular considering the 150 such objects with V I < 1.0 f these, roughly a third appear as typically bulge-dom inated earlytype spirals or irregulars with bright com pact cores, which are m isclassi ed as spheroidal galaxies. Roughly another third are norm al ellipticals with blue colors, while the re-

m aining third are ellipticals with signs of interactions. Less than 1% are compact objects.

Our conclusion is that a structural analysis of faint galaxies provides independent information and classi cation toolwith respect to the most usually adopted multi-color data.

5.4. Further Statistical Constraints from Deep K-band Observations

We take advantage of the deep K-band data in the GOODS/CDFS eld to compare the statistical properties of the Spitzer long-wavelength galaxy population with those selected at 2.2 m (see Sect. 2.2). Figure 11 shows s the cumulative number counts for our ISAAC/CDFS 2.2 m selected galaxy sample (thin black histogram). Stars are excluded from the analysis. The two upper panels show the relative contribution of the di erent morphological classes (including uncertainties in the morphological classi cation). The morphological analysis is the same as performed for the 3.6 m sample, and the classi cation criteria are consistent with those in CAO5 (see Sect.3).

The bottom panel in Fig.11 reports the results for the whole K band population. The vertical dotted lines indicate the K = 21 m ag (Vega system) lim it, where the sam ple is more than 90% complete.

We also derived redshift distributions for the Kband samples, taking advantage by the overlap between GOODS-CDFS, the VVDS (Le Fevre et al. 2004a) and K 20 (C in atti et al. 2002a; M ignoli et al. 2005) surveys, and by the fact that these are characterized by high spectroscopic completeness.

The results are summarized in Figure 12, where the solid histograms in the four panels show the relative

5.5. The Space-Time Distribution of the Sample Galaxies

We have further investigated the distribution in spacetime of our sample galaxies by applying the $V=V_{m ax}$ test, rst developed by Schmidt (1968) to study the spatial uniform ity of quasars. The test compares the maximum

where $\frac{dV}{dz}dz$ is the dimension of the element. The volum e V_{m ax} V (z_{m ax}) refers to the maximum redshift z_{m ax} at which the source would still be detected with a ux density matching the survey limit. To compute it, we have not obtained a best-t spectral representation (L) of the observed SED, as discussed in Sect. 6.1 below, and the best-t rest-frame monochromatic luminosity L_{3:6} (or L_K in the case of the K 20 sam ple discussed in Sect. 5.5.2) at the source redshift z. Then the redshift of the source is increased from the observed value z to that at which the ux density coincides with the survey limit, using the luminosity-distance relation:

In eq.(6) the best-t spectral representation L is kept xed as a function of redshift, without applying any evolutionary corrections. In the case that the source lum inosity L would increase at higher-z due to the younger ages

of the stellar populations (which m ight be considered as typical), the volume $V_{m\ ax}$ available to the source would be underestim ated (which then provides us with an upper lim it to $V=V_{m\ ax}$).

5.5.1. The V=V_{m ax} test for the Spitzer 3.6 m galaxy sample

We have rst applied the V=V_{m ax} test to the objects in the ux-lim ited GOODS/IRAC sample with S_{3:6} 10 Jy. In spite of the lim ited spectroscopic coverage (47%) for the Spitzer-selected sample, we believe that we can still obtain a signi cant assessment of the source space distribution: the use of the m ean of the V=V_{m ax} statistics is expected to average out random errors (though not the system atic ones) introduced by the photom etric redshift estimate.

Due to the moderate angular resolution ($3 \operatorname{arcsec}$) of the Spitzer IRAC 3.6 m in ages, the high-redshift detected galaxies are spatially un-resolved and can be considered as behaving like point sources. For these, the effects of the cosm ological angular size variations and surface brightness dimming ($/[1 + z]^4$) do not directly a ect the source detectability. For this reason, we have not

attempted to carry out detailed simulations of all selection e ects, not useful in the present situation, and rather computed $z_{m ax}$ by simply considering the cosm ological dimming of the total ux as in eq.5).

A problem potentially a ecting our analysis of the source space distribution are the obvious galaxy clusters/aggregations peaking at z 0.67 and 0.73 and visible in both the VVDS (Le Fevre et al. 2004a) and GOODS/IRAC (see Fig.16 below) catalogues, which may bias our assessment of the sam ple hom ogeneity in redshift space. For this reason, and in addition to the total ux-limited sam ple, we have considered a second one excluding sources (and the corresponding V and $V_{m ax}$ volumes) between z = 0.63 and z = 0.77. We have a posterioriveried that this is a large enough redshift interval to get rid of the dispersion e ect in z introduced by the fraction of sources with photom etric redshifts.

Figure 13 reports our results on the distribution of the $V=V_{m\ ax}$ statistics for the spheroidal and the late-type populations as a function of the galaxy's stellarm ass (see Sect. 6.1 below). The blue lled triangles correspond to sources falling in the z= 0.63 to 0.77 redshift interval, which show a correlation between the $V=V_{m\ ax}$ and the mass values (or with the lum inosity in the subsequent Fig. 14). This

correlation is due to the fact that the more massive and lum incus objects at a given redshift would be visible over a wider $V_{m\ ax}$ volume. A similar elect, with larger scatter, is also apparent in the whole population, because of the characteristic peak in the source redshift distribution (Fig. 9).

Them ean and median values of $V = V_{m ax}$ for the various galaxy subsamples are summarized in Table 2. As shown there, the $V = V_{m ax}$ distributions for both the spheroidal and the star-forming classes show signi cant departures from the uniform distribution's expectation value. The most signi cante ect is the apparent dearth of spheroidal galaxies at high-z indicated by the very low $hV = V_{m ax}$ i 0:32 0:03, (median value of 0:25 0:03), obtained both including and excluding the cluster volum e. A lthough form ally this departure from uniform ity is very signi cant, we should caution how ever that the size of our eld is relatively sm all and our $V = V_{m ax}$ analysis subject to cosm ic variance e ects, particularly for the more strongly clustered spheroidal population.

Late-type galaxies show less evident departure from uniform ity. W ithin this broad galaxy ensemble, we have attempted to check if di erences m ight be present in the $hV=V_{m ax}$ i between early-type spirals and late-type spi-

rals and irregulars. We have used for this the asymmetry parameter A and set the value of 0.4 as discriminating the most irregular systems from more symmetric standard spiral galaxies (e.g. CA 05; Conselice 2003b). Table 2 indeed reveals that regular spirals with A < 0.4 tend to show a somewhat similar, though lesse extreme, dearth of objects at the survey upper redshift boundary, whereas merger/irregulars reveal a marginal evidence for positive evolution ($hV = V_m$ axi' 0.513 0.005). This result is in good agreement with the value of $hV = V_m$ axi in excess of 0.5 found by D addiet al. (2004b) for star-forming (starburst and irregular) objects at z > 1.4.

$5.5.2.V = V_{m ax}$ for galaxies in the K -band selected sample

We have also applied the $V=V_{m ax}$ test to objects in the K 20 sample (K_s 20) analyzed by CA 05, including 74 E/S0 and 226 Spiral/Irregular galaxies. Though having lower statistically signi cance, the advantage o ered by this sample is the virtual completeness of its spectroscopic follow-up, also useful in identifying and excluding galaxies belonging to the z= 0.7 cluster.

Even in the K_S-band ISAAC images, with a typical spatial resolution close to 1 arcsec, the vast majority of the sources do not appear as spatially resolved. We have then calculated the $V=V_{m\ ax}$ distribution as for the GOODS/IRAC sample, that is neglecting detailed treatment of surface brightness dimming elects. The results of the test, summarized in Figure 14 and Table 2, appear completely consistent with those from the GOODS sample.

In conclusion, we disign cant evidence in our eld that galaxies belonging to the norm al Hubble sequence, i.e. spheroidals and spirals with low asymmetry, tend to disappear towards the survey limit at z 1 to 2, while highly asymmetric objects (irregular/mergers) are more evenly distributed. Our results extend to low redshifts and strenghten the conclusion of D addi et al. (2005a) that the $V=V_{m ax}$ distributions is skewed to low values for the spheroidal population, indicative of negative evolution. The characteristics of this evolution will be better speci ed and clari ed in the following Sections.

6.THE GALAXY EVOLUTIONARY MASS AND LUM INOSITY FUNCTIONS

The quality of data available in this area, particularly the redshift information (either spectroscopic or photom etric) and the extensive photom etric coverage of the galaxy SEDs, motivated us to attempt a direct estimate of the evolutionary lum inosity and mass functions for galaxies.

6.1. The Broad-band Spectral Fitting Procedure

Our estimate of the stellar mass follows from a detailed com parison of the observational SEDs with galaxy synthetic spectra. To generate them, we have adopted the spectrophotom etric synthesis code described by Berta et al. (2004), which is a development of that described in Poggianti, Bressan & Franceschini (2001). W e have m ade use of the latter, rather than relying on the stellarm assestim ated e.g. by the H yperz code (Bolzonella et al. 2000), for various reasons. The code by Berta et al. has been speci cally tay lored to the stellarm assevaluation and has been system atically tested against the outputs of other codes (e.g. Dickinson et al. 2003; Fontana et al. 2004). In addition, the code accounts in detail for the complex variety of stellar populations and population-dependent extinction typical of star-form ing and starburst galaxies, as detailed below .

A coording to Berta et al, the galaxy observed SED is modelled as a combination of a set of simple stellar populations (SSP) of solar m etallicity and di erent age. Each SSP is weighted by its total mass and extinction, and represents a temporal section in the star-formation history of the galaxy. So, the mass fraction contained in any SSP corresponds to a given averaged star formation rate (SFR) during the time section covered by the SSP. Each SSP is extinguished by a di erent amount of dust in a uniform screen and modelled according to the standard extinction law ($R_V = A_V = E \ B \ V = 3:1$, C ardelli et al. 1989). The total spectrum is built up by sum m ing the extinguished spectral energy distributions of all contributing stellar generations.

Considering that high extinction values characterize only stellar populations embedded in thick molecular clouds and that disk populations are moderately absorbed (A_V 0.5, e.g. K ennicutt 1992; K au mann et al. 2003), we have limited the E (B {V) values for the populations with ages 10^9 yrs to be less than 0.1.

All the SSP spectra have been computed with a Salpeter initial mass function (IM F) between 0.15 and 120 M , adopting the Pickles (1998) spectral library, extended and interpolated with the Kurucz's (1993) stellar atm osphere models, following the work of Bressan et al. (1994) and Bertelli et al. (1994). Photospheric stellar and nebular (line and continuum) emission has been included through the ionization code CLOUDY (Ferland, 1996). The result is corrected for cosm ological dim ming and for the K-correction and compared to the observed SED by convolving with the appropriate liter transmission curves.

The code seeks for the best-t solution, by exploring the param eters space through the A daptive Sim ulated Annealing algorithm (Ingber et al. 1989) and m in in izing the di erence between the observed data and the model m easured by the 2 . It takes of the order of 10 m inutes CPU time on a PC to explore the whole parameter space per galaxy.

The number of the SSP's involved in the t depend on their morphological classi cation and redshift. Ellipticals/S0 galaxies have been tted by using only SSP 's older than 5 10^8 yrs. Late-type galaxies have been m odelled by adopting a combination of 9 SSP's, between 10⁷ yrs and 12 10⁹ yrs. O bviously, for each galaxies 1 only the SSP's younger than the age of the universe at the galaxy redshift have been considered.

Our code outputs best-t estimates for various physicalparam eters (e.g. rest-fram e lum inosity, age, star form ation rate, extinction, stellarm ass) for each sample galaxy. Due to the wide exploration of the parameter space, we expect that not only the stellar mass value, but also the corresponding uncertainty should be fairly reliable, for a given stellar IM F. This especially bene ts by the Spitzer 3.6 m ux constraint on the old stellar populations dom inating the stellarm ass, particularly for the higher redshift (z 2) galaxies.

The typical (2) uncertainties in the stellar mass determ ination depend moderately on the source redshift (mostly thanks to the Spitzer ux constraint) and are of bin a and for a lum inosity interval L is estimated as: the order of a factor 2 (som ew hat less for spheroidal galaxies in which the extinction is presumed to be ine ective, som ewhat more for star-forming in which the extinction adds to the total uncertainty).

We have applied our spectrophotom etric tting algorithm to the IRAC/GOODS 3.6 m sample brighter than 10 Jy, using all the photom etric bands available on the multi-wavelength catalogue (see Sect. 2.6.4), and the redshift. A couple of examples of the SED tting quality are reported in Figure 15, where the contributions by young and old stellar populations are detailed.

In Figure 16 we report the galactic stellar mass distribution as a function of redshift for the 3.6 IRAC/GOODS sample with S3:6 > 10 Jy. M orphologically classi ed ellipticals are marked as red diam onds, late-types as blue triangles. The two already m entioned structures at z 0:67 and at z 0:73, am ong others, are particularly evident.

6.2. Lum inosity and M ass Functions

Lum inosity functions in various redshift intervals have been estim ated using the $1=V_{m ax}$ test, a standard m ethod for ux limited samples (e.g. Dickinson et al. 2003; Fontana et al. 2004; Bundy et al. 2005). We have followed the same procedure to estimate $V_{m \mbox{ ax}}$ as in Sect. 5.5, except for the e ect of the redshift binning: when z_{low} < z < $z_{h\,\text{igh}}$, the $V_{m\,\,\text{ax}}$ is calculated as:

W e report in Fig. 17 the lum inosity functions ($L_{3:6}$ = $_{3:6}L(_{3:6})$ calculated for three redshift bins: 0.2 < z <0.55, 0.55 < z < 0.8 and 0.8 < z < 1.4, containing 258, 471 and 503 galaxies, respectively. In each panels, the early- and late-type contributions are plotted, together with the total functions (see the gure caption for the m eaning of the sym bols). Errorbars have been estim ated by Poisson statistics. We have not attempted to include in our error budget the e ects of uncertainties in the photom etric redshift and stellar mass estimates, which are overwhelm ed by those related with the cosm ic variance. W e excluded from the analysis redshift bins above z = 1.4, since beyond this lim it the spectroscopic com pleteness becom es low, the photom etric redshifts are less reliable and the morphological classi cation more uncertain or even im possible. Num erical values and errors for the lum inosity functions are reported in the Appendix.

To take care of the two prom inent structures at z 0:67 and z 0:73, galaxies in the redshift interval z = 0:63 to 0.77 have been rem oved, as in Sect. 5.5.

W e then checked the levelofagreem ent of our sam pling com pared to well established lum inosity functions.W e report in each panels of Fig. 17 the K-band localLF by Cole et al. (2001), transform ed to 3.6 m using the rest-fram e color of a typical sample galaxy and adapted for cosm ology. This transform ation is rather straightforw ard because the spectra of galaxies are all very sim ilar to each other in this spectral range (we nd $h_{2,2}=S_{3:6}i' 10^{0:24}$). We see an excellent agreem ent between our LF in the low estredshift bin and the Cole et al. local LF, except for a slight excess in the highest lum inosity bin, likely due to evolution. The low-z function at the higher lum inosities is dom inated by early-type galaxies, in agreem ent with Bundy et al. (2005), K au m ann et al. (2003), and C roton et al. (2005).

The trend for increasing lum inosity continues with increasing redshift and gets quite signi cant in the z=1.2bin. At this epoch our most massive galaxies are 0.7 m ag brighter on average than at z = 0, in good agreement with the estimate by Treu et al. (2005a) based on a detailed study of the evolution of the early-type galaxy fundamental plane. A likely interpretation for this increase in lum inosity may be a decrease in the M =L due to the dom inant stellar populations in galaxies getting younger with redshift. It is hard to establish from the left panels of F ig. 17 if there m ight be density evolution accompaning this evolution in L.

Note that the K-correction in the computation of the 3.6 m luminosity has an increasing e ect at increasing redshift. However we believe that the corresponding uncertainties should not a ect appreciably our LF determ in nations, since the near-IR galaxy spectra are rather well behaved and hom ogeneous in the relevant wavelength interval (see Fig. 15).

The next step for obtaining the mass functions $\sin p \ln p$ requires to exchange the L with M in eq.62, and binning in mass rather than in lum inosity. The results of this operation are reported in the right-hand panels of the gure and in the Appendix. The local mass function by Cole et al. (2001) is also reported for reference in all panels.

In spite of the di erent criteria for the sample selection, ourm ass functions are compatible with the results by Fontana et al. (2004) and Bundy et al. (2005), who found little evolution up to z 1. The Fontana et al. sam ple is

K -band selected, has a better spectroscopic redshift coverage (95%), but is shallower and over a smaller area (only 80 arcm in²), while the Bundy et al. sam ple ism ostly optically selected and covers a larger area.

W hile the total mass function in the low-redshift bin at median z 0.3 in Fig. 17 keeps marginally low with respect to the Cole et al. local estimate (which might indicate either a moderate evolution in comoving density already at such low redshifts, or more likely a mismatch between Cole et al. and our stellar mass estimates), we notice an extremely good match of the low-z lum inosity functions. We take this as to support the reliability of our results, which is an important check on consideration of the uncertainties in the photom etric redshift for a signi cant fraction of our low-z sources and of the cosm ic variance problem. The evolutionary mass functions in Fig.17 revealsom e remarkable di erences compared to the lum inosity functions. W hile the latter show essentially a migration along the L-axis (lum inosity evolution), the mass function is more consistent with mere evolution in number density progressing from the lowest to the highest z-bin.

7.MODELLISTIC ANALYSIS

W e investigate in this section the e ectiveness of number counts and redshift distributions in further constraining the evolutionary properties of faint high-redshift galaxies.

7.1. Simple Heuristic M odels for Galaxy Counts and Related Statistics

W e attempt here to compare our statistical observables with simple heuristic prescriptions. In our approach, essentially three main galaxy classes are considered as dom inating the near-IR selected galaxy catalogues and being characterized by potentially di erent evolutionary histories: spheroidal (E/SO) galaxies, quiescent spirals, and an evolving population of irregular/m erger systems (hereafter the starburst population).

It is straightforward to show (e.g. based on the lum inosity functions of Seyfert galaxies and quasars extrapolated from the optical) that active galactic nuclei do not signi cantly contribute to the extragalactic counts in the IR (Franceschiniet al. 2005; Bellet al. 2005b). So we have not considered further in our analysis the contribution of active nuclei.

The SED templates describing the spectral shapes at di erent galactic ages, needed to calculate the Kcorrections and to transform the lum inosity functions from one wavelength to the other, have been computed using the same spectral synthesis code based on the P adova stellar isocrones as in Berta et al. (2004). Consistently with Sect. 6.1, we have adopted a Salpeter \mathbb{M} F with a lower lim it $M_1 = 0.15M$ and a Schmidt-type law for the star form ation (SF) rate:

where is a norm alization parameter (SF e ciency) and M $_{\rm g}$ (t) is the residual mass of gas at any given galactic tim e.D uring phases of active star-form ation, stellar em ission is assumed to be extinguished by dust in a uniform screen, modelled according to the standard extinction law (R $_{\rm V}$ = A $_{\rm V}$ =E (B $\,$ V] = 3:1, C ardelliet al. 1989). A further relevant parameter is the timescale t_{infall} for the infall of prim ordial gas. The evolution patterns for the di erent galactic populations considered here are obtained with the follow ing choices of the parameters.

For early-type galaxies, we have set a quick infall timescale $t_{infall} = 0.1$ Gyr and a high SF e ciency, $= 2 \text{ Gyr}^1$. The corresponding SF law has a maximum at a galactic age of 0.3 Gyr, and is truncated at 0.8 Gyr to m im ic the onset of a galactic wind. During this quick star-form ing phase, the galaxy em ission is assumed to be extinguished by $A_V = 6 \text{ m}$ agnitudes.

For late-type galaxies, we adopted a longer $t_{in\,f\,all} = 4$ Gyr and a correspondingly lower e ciency = 0.6 Gyr¹. In this case, the peak of the SF occurs at 3 Gyr and a galactic wind is never produced. The same parameters assumed to reproduce the spectra of spirals and irregular galaxies. This may not be entirely representative of a galaxy during a starburst phase, but, given the spectral region considered in this work, our assumption is still a good approximation. We have then generated two grids of m odel spectra for both early- and late-types spanning a range of galactic ages from 0.1 to 15 Gyr.

Our assumed local lum inosity functions (LLF) at 3.6 m and in the K-band have been derived from those estim ated by Kochanek et al. (2001) for both the earlytype and late-type galaxy classes, based on a K-band selected sample taken from the Two Micron All Sky Survey (2MASS) and including 4192 low-redshift (z 0:02) galaxies.We have made use of their lum inosity functions di erentiated by morphological type according to the de Vaucouleurs's parameter T estimated by the authors, and adopting the value T = 0.5 as the boundary between spheroidal and late-type galaxies. For spheroids the K band Schechter best-t parameters are = 0.92, M_K = 23:53 and norm alization factor n = 0:45 10^{2} M pc 3 for $H_0 = 100$ km sec¹ M pc¹]. Transform ation from 2.2 to 3.6 m is performed with the SED templates for the two classes at the present cosm ic time.

In our schem atic evolutionary model, we have assumed that, once formed at a given redshift, the comoving num – ber densities of the spiral population keeps constant, while the galaxy lum inosities evolve following their evolutionary stellar content. This choice rejects our assumption that, once having acquired its nalmorphological structure within the Hubble sequence, a normal galaxy evolves only due to the secular change of the integrated stellar spectrum.

For the spiral galaxy class we assumed a high redshift of form ation ($z_{form} = 5$, but the speci c value is by no m eans critical, any other choice between 2 and 5 would give essentially the same results) and constant number density henceforth. Spheroidal models are developed in Sect. 7.1.2 below.

7.1.1. A population of fast evolving starbursts

We have seen in Sec. 5.5 that the star-forming galaxies (the highly asymmetric, A > 0:4, mergers/irregulars) display a V=V_{m ax} distribution indicative of an excess of sources at high-redshifts. This, as well as number counts and z-distributions, are not consistent with the assumption that the galaxy luminosity function evolves purely following the secular evolution of the constituent stellar populations.

The inability to reproduce the faint galaxy counts in the B-band with no-evolution prescriptions is also a wellestablished result (E llis 1997). Even m ore evident departures from no-evolution were reported from deep observations in the m id-and far-IR (e.g. Franceschiniet al. 2001; E lbaz et al. 2002; G ruppioniet al. 2002; Lagache, D ole & P uget 2003). A llthis indicates the presence of a num erous population of irregular/m erging system s at high-redshifts, likely suggesting lum inosity as well as density evolution going back in cosm ic tim e.

W e then added to ourm odellistic description a population of starburst galaxies whose com oving num ber density (z) evolves according to:

for z < 1, keeping constant above, and whose lum inosities $L \ (z)$ also increase as

where (z) = 1 t_H $(z)=t_H$ (z = 0) is the look-back time in units of the present Hubble time t_H (z = 0), and the evolution constant is k = 1:7 for 0 < z < 2, and k = 0 at z 2 [such that L (z = 1) ' 2:6 L (z = 0) and L (z = 2) ' 4 L (z = 0)].

For the local lum inosity function of this population of irregular/m enging starbursts, we have referred to that obtained in the B-band by Franceschiniet al. (1988), based on a local, m orphologically selected, sample (from UGC), with complete spectroscopic identication. We have both appropriately transformed this LLF to the K-band and taken care to slightly rescaling it in such a way that the sum of this with the LLF of spiral galaxies would match the K-band LLF by K ochanek et al. (2001).

7.1.2. An empirical evolutionary schemes for spheroidal galaxies

W e have considered two simplied schemes of the form ation of spheroidal galaxies for in mediate comparison with the data, both of them tied to t the LLF derived from K ochanek et al. (2001). The rst one is a classic prescription assuming a single in pulsive episode for the form ation/assembly of the eld ellipticals, occurring at a high redshift ($z_{form} > 2.5$, e.g.D addiet al. 2000 and C in attiet al. 2002b), and P ure Lum inosity Evolution (PLE) thereafter. We assumed a redshift of form ation $z_{form} = 3.0$. In this case, the birth of stars coincides with the form ation of the spheroid. In the following we will refer to this as the monolithic form ation model.

The second model for spheroids describes a situation in which massive ellipticals form (or at least assemble) at lower redshifts through the merging of smaller units down to recent epochs. In such a case their formation is not a single coeval process, but is spread in cosm ic time. We achieved this by splitting the local spheroidal galaxies into several sub-populations, each one form ing at di erent redshifts. For simplicity, we assumed that all sub-populations have the same mass and lum inosity functions and di er only for the normalizations, whose total at z = 0 has

to reproduce the local observed lum inosity function. We emphasize that this assumption of a lum inosity function building up with time by keeping a constant shape may result as oversimplied in the light of our results in Sect. 6. However we consider it as a useful reference and defer more sophisticated treatment to future papers.

We have calibrated and tested this model against deep galaxy surveys in the K band (K 20: C in atti et al. 2002a,2002b, HDF's: Franceschini et al. 1998 and Rodighiero et al. 2001; GDDS: A braham et al. 2004). In our current in plan entation, we assume 7 spheroidal subpopulations, the bulk of which (80%) form in the redshift interval 0:9 < z < 1:6, with additional fractions being produced at higher (starting from z 5) and low er z (down to z 0:5). The detailed fractions of eld ellipticals as a function of their form ation redshift in our model is sum marized in Table 3.

O f this seem ingly hierarchical scheme, that we name as the P rotracted-Assem bly (PA) model, we have considered two applications. (The PA term inology is intended to underline that our scheme, although generically in line with the hierarchical expectations, does not provide a physical discription, and at the same time is more general).

In our $\,$ rst considered case (hereafter PA m odel 1) stars are assumed to be coeval to the spheroid sub-populations forming at di erent redshifts $z_{f\,\text{orm}}$.

We have also considered a dierent situation in which the structural assembly of stars in the host galaxies happens later than their form ation epoch. We have then modied our previous P rotracted-A seembly scheme by assuming two dierent epochs, one for the birth of stars and the other for their assembly. In this second case (hereafter P A model 2) all the stars present in today ellipticals are assumed to be born at high redshift (z = 5), while they are dynamically assembled in the various spheroid sub-populations at the redshifts z_{form} in Table 3.

In Fig.8 we compare the observed IRAC/GOODS 3.6 m counts with the predictions of the three models discussed above: our PA 1 (solid blue lines), the PA 2 (three dots-dashed red line) and the monolithic model (dashed green lines). These predictions di er only for their treatment of the early-type population. We note a generally good agreem ent of both P rotracted-A ssem bly predictions for spheroids, while the monolithic model does overpredict the elliptical number counts fainter than $S_{3:6}$ 60 Jy. This excess, by a factor > 3, is very signi cant all the way down to $S_{3:6}$ 1 Jy. On the other hand, within the uncertaintes we cannot discrim inate between the two P rotracted-A ssem bly solutions.

A loo the source counts for late-types are well reproduced, with a slight tendency to underpredict them in the ux range 40 $Jy < S_{3:6} < 100 Jy$. In general, only the two solutions including the PA description for spheroids reproduce well the total source counts (Fig. 8, bottom panel).

Similar conclusions can be derived from the redshift distributions. In Fig. 9 the observed redshift distribution

of the 3.6 m IRAC/GOODS sample with $S_{3:6} > 10$ Jy is compared with our models. Again, the PA predictions

t much better the observed distribution of spheroids. P A model 1 tends to slightly overpredict the number of sources above z 1.2 (both for early-and late-type galaxies), while this excess is not present in model 2 (because in this case all stellar populations are somewhat older and dim mer at the epoch of their assembly into the galaxy).

The predictions of PA m odel 1 for the K -band statistics are presented in Figures 11-12 for source counts and redshift distributions, showing a generally good agreem ent with the observations.

7.2. Comparison with Other Models

W e have compared our results with an improved version of the phenom enological evolution model by Xu et al. (2003). The model reproduces the bright end of the num – ber counts, but starts to exceed the observations below $S_{3:6} < 25$ Jy, for both spheroidal and late-type galaxies.

Silva et al. (2005) have elaborated a more physicalm odel considering the mutual feedback between starforming regions in galaxy spheroids and the active nuclei growing in their centers. This model's predictions for passive spheroids are in good agreement with the 3.6 m IRAC/GOODS number counts at faint uxes, but the model foresees too many spheroidal galaxies at $S_{3:6} > 100$ Jy (by factors 3 5) and too few spirals/irregulars (again by factors 3). The model could perhaps be made more consistent with our data in case that the bulk of the high-z formed spheroids could be incorporated into m assive spiral galaxies as their bulge components (hence escaping classi cation as E/S0's at low-z).

72.1. Predictions of the GALICS sem i-analytic code

GALICS is a hybrid model of hierarchical galaxy formation combining large cosm ological N-body simulations with simple sem i-analytic recipes to describe the fate of the baryons within dark matter haloes (Hatton et al. 2003).

The available set of di erent simulated cones of universe allows one to check the e ects of clustering and cos-

m ic variance when dealing with observations covering lim – ited sky areas. We have used the GALICS database⁷ to simulate 10 cones of the universe, each covering an area comparable to the IRAC/GOODS survey. The comparison of GALICS predictions with the 3.6 m observed redshift distribution is reported in Fig. 9 (hatched grey regions). A general agreem ent is observed for the total and also for the separate early- and late-type populations. As in the case of our P rotracted A ssem bly model 1 (see Sect. 7.1), the num ber of sources at z > 1:3 is just slightly overpredicted.

The observed number counts are compared in Figure 18 with the predicted e ect of the cosm ic variance shown as the hatched regions. GALICS predictions look consistent with the total number counts, with a slight excess at $S_{3:6} < 10$ Jy and a dearth of spheroidal galaxies at $S_{3:6} < 40$ Jy. Within the uncertainties in the identic cation of the various morphological categories in the sem i-analytic mock catalogues, this hierarchical code perform s well in explaining the observational data.

8.D ISCUSSION

8.1. Phenom enological M odels vs. Num ber Counts and z-D istributions D ata

We have tried simple modellistic representations of the data on num ber counts and redshift distributions, to assist our interpretation. The most challenging constraints concern the spheroidal galaxy population and the modelling of their expected very lum inous early phases. Results of the match of modellistic expectations and observational data are brie y discussed in the follow ing.

8.1.1. A Zeroth-order Solution: the M onolithic PLE M odel

The simplest evolutionary scheme that we have used for comparison with the data is a monolithic PLE model. Once the local LF is established by low-z near-IR surveys (Sect. 7.1), this crude representation has quite few parameters to play with, and to correct for the inconsistencies that it revealed in the previous Sect. Apart from the formation epoch (z_{form} should in any case be 3 or larger), the most in portant model parameters are those ruling the stellar IM F. In our application we considered the standard Salpeter form with di erential spectral index x = 1.35, (N M] / M [×]): with this ingredient, the expected number of young spheroidal galaxies between z 1 and 2.5 exceed the observations (see top left panel of Fig. 9).

The e ects of a di erent choice for the stellar $\mathbbm F$ and of variations in $z_{form}\,$ were discussed in some details by K itzbichler and $\mathbb W$ hite (2004), who compared (m onolithic) P LE m odels with number count, z-distributions and the galaxy $\mathbb M$ /L ratios from K -band surveys. They found sim - ilar inconsistencies to our above and that, to cure them, one would need to adopt an $\mathbb M$ F almost completely deprived of massive stars (with an $\mathbb M$ F di erential spectral index x > 2).

We have tested the e ect of a slighter modi cation of the MF in our monolithic model by changing from the Salpeter to the Scalo one (Scalo 1986), but the effect turned out to be a marginal reduction (by few tens percent) of the excess num ber counts and z-distributions. On the other hand, a more radical change, like that of bringing the IMF spectral index x to values in excess of 2, would entail problem atic side e ects. In particular, if we keep norm alization to the local census of stellar populations in norm algalaxies, a very steep IMF would prevent young galaxies to produce the m etals observed in the galaxy intra-cluster plasm as (M ushotzky & Loewenstein, 1997; Baum gartner et al. 2005) and would make im possible to explain the observed IR and optical background light (which would perhaps rather require a shallower \mathbb{M} F, x < 1:35, richer in massive stars, see M adau and Pozzetti, 2000; Franceschiniet al. 2001).

An alternative might perhaps be to assume that the whole early phases of the spheroidal galaxy evolution

happen inside a heavily dust extinguished medium (e.g. Franceschiniet al. 1994; K itzbichler and W hite 2004; Silva et al. 2005). Such extinction should be very high (several opticalm agnitudes) to prevent detection by the IRAC 3.6 m band. The main di culty with this solution, how ever, stems from the request by the observational constraints that such lum inous galaxies should be kept enshrouded by a thick dust envelope during their whole early life, i.e. severalGyrs { corresponding to the z interval from z 3 1.C onsidering the modest average dust attenuation in low -z galaxies (A_V ' 0:2 0:3 m agnitudes, K au m ann et al. 2003), and the results of hydrodynam ical simulations of galaxy m ergers (e.g. M ihos and Hernquist 1994), it is clear that such high obscuration only characterizes transient short-lived evolutionary phases with violent redistribution of the dusty ISM , on timescales of 0:1 Gyr, like those inferred for the ultra-lum inous IR galaxies (Genzel et al. 1998; Rigopoulou et al. 1999).

8.1.2. An Improved Scheme: Protracted-Assembly for Spheroidal Galaxies

We have obtained much easier ts to the data with the alternative approach of assuming a progressive build up of the spheroidal galaxies taking place over a signi cant fraction of the Hubble time. We have empirically represented this by splitting the luminosity function of spheroids into various sub-components and by attributing to each one a formation redshift z_{form} and a weight (see Table 3). For simplicity, the luminosity functions of the various sub-components are matched by a solution where 80% of the nal spheroidal mass function is assembled between z 1:6 and z 0:9 for a standard cosm ology.

We have considered two speci c in plementations of this P rotracted-A ssem bly scheme: one based on the assumption that stellar populations are formed at the same time of the whole galaxy formation, z_{form} . The alternative was that stars preexisted the galaxy assembly, e.g. being produced at z 5 and assembled into galaxies only later at z_{form} . This latter assumption of a progressive build-up of already aged stellar populations seems to be slightly favored by the observations (Figs. 8 and 9).

In either case, the adoption of a P rotracted-A ssem bly in cosm ic time for spheroidal galaxies (i.e. the essential postulate of hierarchical m odels) appeared to overcom e m ost of the apparent inconsistencies of the m onolithic m odel.

The PA m odel is also reasonably consistent with the scanty existing data on high-z (z > 1.4) spheroidal galaxies. D addi et al. (2005a) have recently color selected a sample in the Hubble UDF to K ' 21 and used the ACS grisms for spectroscopic identication. The number of spheroidal galaxies with 1.4 < z < 2.5 over a 12 sq. arcm in area predicted by the PA m odel is perfectly consistent with the 7 objects found by D addi et al.

Labbe' et al. (2005) com bined ultra-deep K-band and ISAAC in aging of 5 sq. arcm in in HDF-South to identify 3 passive spheroidal galaxies with 1:9 < z < 3:8 and K < 22:5 (though one of the three could host an AGN). The prediction of the PA model at such high-z depends on the detailed parameters describing the sm all fraction of objects form ing at z > 2 in Table 3: our best-t predicts 1.5 galaxies for the Labbe' et al. selection function.

8.2. Evolutionary Trends for Lum inosity and M ass Functions

821. Evolution of the G bbalM ass Function

O ur investigation of the evolution of high-redshift galaxies followed two main routes. The rst one was to infer general constraints from statistical observables like the number counts, z-distributions, and $V=V_{m\ ax}$ analyses, as discussed in the previous Sect. 8.1. The second approach was to derive direct information about the evolution of the main galaxy distribution functions from our reference IRAC/GOODS ux-limited sample, whose results are sum marized in Fig. 17.

Do these independent lines of investigation bring to consistent solutions? We have attempted to answer this question in Figure 19, where we report the integrated commoving stellar mass density as a function of the redshift for the twom orphological classes and for the total population. The integral has been computed using galaxies with masses larger than 10^{10} h 2 M , to ensure completeness within all three redshift bins. We not that the mass density increases by 50% from z 1:2 to z = 0:3 for the total sample.

The black dotted line in Fig.19 shows the evolution of the integrated com oving mass density in spheroidalgalaxies with M $\rm h^2>10^{10}M$, as predicted by our P rotracted-A ssem bly m odel (and derived from the distribution of form ation epochs of the sub-populations in Table 3). Indeed, this predicted redshift dependence m atches reasonably well our direct determ ination of the evolutionary com oving density (red dot-dash line), based on the integral of the observationalm ass function.

In essence, this good m atch provides consistent evidence that signi cant evolution of the global m ass function has occurred typically at z ' 0:7 to 2, also clearly indicated by the V=V_{m ax} analyses in Sect. 5.5. This is the m ost robust of our conclusions, and agrees with the results of various other published analyses (D ickinson et al. 2003; G lazebrook et al. 2004; Fontana et al. 2004). Our average rate of evolution of the total stellar m ass density can be approxim ated as an exponential fall-o with redshift:

O unestim ated decrease by an average factor 2.5 from z = 0 to 1.2 of the stellarm ass density of E /SO galaxies is then somewhat steeper than the 40% decrease estimated by Treu et al. (2005a), based on previous work by Im et al. (2002). Also our observed functional dependence on redshift, an exponential fall-o , is di erent from their assumed power-law proportionality / $(1 + z)^{0.6}$.

8.2.2. M ass-dependent and M orphology-dependent E ects

C loser inspection of our direct m ass and lum inosity function determ inations reveals, how ever, quite m ore com plexity in the evolution pattern than the sim ple overall decline with redshift in Fig. 19.

We report in Figure 20 a comparison of the evolutionary mass functions at dierent redshifts for the two morphological categories. First of all, the evolution of the mass functions in Figs. 19 and 20 shows a dierentiale ect with morphological type. For the late morphological types, the e ect of a number density evolution seem spresent but not

large, while it is quite more signicant for the spheroidal the GOODS-N area, have found signicant evolution of galaxy class (right panels in Fig. 20). the Fundam ental Plane as a function of redshift and mor-

An important aspect also revealed by Fig.20 is that this decline is not uniform ly shared by all galactic masses, but mostly concerns objects with M h² 10¹¹ M . The comoving number density of the most massive galaxies, instead, keeps remarkably stable from local to z = 1.2, independently if they belong to the spheroidal or the late-type category.

The di erentiale ect of the evolution rate with galaxy m ass applies to both m orphological categories in the two panels of F ig. 20: in both cases the highest m ass galaxies show the lowest rate of evolution. A gain, the di erential e ect is stronger for the spheroidal com ponent.

This is in line with a similar result by Bundy et al. (2005), who nd little evolution to z=1 for the highest galactic masses. Indeed, Fig.19 should be red together with g.8 of Bundy et al. (2005), which shows the evolution of the same integral of the mass function, above $M h^2 = 10^{11} M$: in their case there is essentially no evolution of the com oving mass density from z = 1 to 0, while with our lower stellarm ass threshold the decrease is appreciable for both galaxy classes. The rate of galaxy assembly appears to be a strong function of the mass. This is also in keeping with the low speci c SFR estimated by D addiet al. (2005b) in their most massive galaxies at z > 1.4.

Treu et al. (2005a,b), based on a high-resolution spectroscopic study of a sample of eld spheroidal galaxies in

the Fundam ental P lane as a function of redshift and m orphological properties, that can be explained as a change of the average M = L ratios. They also nd that "this evolution depends signi cantly on the dynam icalm ass, being slow er for largerm asses". It is interesting to note that their analysis is based on dynam ical estim ates of the galactic m asses. Sim ilar conclusions are also reached by Juneau et al. (2005). So this e ect of di erential evolution, a manifestation of the "downsizing" process originally identi ed and investigated by Cowie et al. (1996), appears to respond to both the mass of the galaxy's stellar content, and to the total, possibly dark-matter dom inated, mass. Downsizing in the formation of stars in spheroidal galaxies was also clearly indicated by Franceschiniet al. (1998) from their analysis of galaxies in the HDF-North (see also hints in G avazziet al. 1996).

82.3. Evolution Patterns

The synopsis of the evolution of the galaxy mass and luminosity functions of ered by Fig.17 may shed some light onto the physical processes driving them. Let us start at low-z and progress in redshift, and let us instruction of the total mass function. There is only one way to produce the number density evolution, which is observed to become e ective at z > 0.9: this is via the interm ediate-m assignations to decrease progressively in

m ass, hence m igrating towards the left side of the gure. This was likely achieved through both m erging of lower m ass preexisting objects and form ation of new stars.

That new stars are likely form ed during the merging events accompaning the evolution of the mass function is shown by the luminosity evolution which is evident in the left-hand panels of Fig. 17. In principle, (negative) number density evolution would be expected to characterize the luminosity function in a similar way as it does for them ass function in the right-hand panels. This negative density evolution appears as completely counter-balanced by an increase in luminosity, so that the net apparent e lect is that of a (positive) luminosity evolution. Clearly, if the average galaxy mass decreases and the average luminosity increases with redshift, this requires a steady decrease of the M =L ratio.

A lso of interest m ight be to try to di erentiate the evolutionary paths am ong the di erent m orphological classes. A s for the spheroidal galaxies, two ways m ay produce in principle the observed strong number density evolution: one is through the interm ediate-m ass objects increasing in m ass, and m igrating to higher m asses at decreasingz (increasing cosm ic tim e), via m erging acquisition and new star-form ation. The other path is via m orphological transform ations of spirals/inregulars to relaxed early-type m orphologies, again consequence of m erging episods or gas exhaustion. All these processes are likely to happen together.

For the late-type galaxy population, and in spite of the apparent slow evolution of the mass function in Fig. 20, the evolutionary pattern was likely very complex: on one side, late-types lose in favour of the spheroidal population due to m orphological transform ations, on the positive side they should increase by galaxy m erging and star form ation.

In conclusion, our analysis has con $\,$ m ed that the cosmic epochs close to redshifts $\,$ 1 to 2 have experienced an active phase of star form ation at the low-m ass end, and galaxy transform ations at the knee of m ass function, M h^2 $\,10^{11}$ M $\,$. Perhaps only the most massive galaxies in the eld have been relatively quiet actors at this times, as shown by the corresponding slow evolution of their m ass function.

82.4. M atching with Independent Evidence of Evolution

A lthough we do not have yet a complete understanding of the whole set of phenomena, it is certainly not a chance that the redshift interval from 0:7 to 2 coincides with the cosm ic epochs of peak activity revealed by IR searches of the dust-obscured star-form ation (e.g. by ISO, Franceschiniet al. 2001, E lbaz et al. 2002; and by Spitzer, Perez-G onzales et al. 2005, Le F lock et al. 2005).

On this respect, it is also interesting to note a parallelism between the slow evolution to z = 1.4 of our most massive galaxies and the history of the star-formation in the most lum incus IR galaxies, which are their natural progenitors. Both the ULIRG sam ples analyzed with Spitzer by Perez-G onzales et al. (2005) and LeF loc'h et al. (2005) and the very lum incus SCUBA sources (e.g. Sm ail et al. 2002; Chapm an et al. 2003) show a bolom etric ∞ m oving em issivity peaking at high-z (z > 1.5), whereas low er lum incusty sources have peak em ission at low er z. From the tight relationship of the bolom etric IR em ission with the SFR (e.g. K ennicutt 1998; Rowan-Robinson et al. 1997), the more lum incus the IR galaxy is, the more accelerated its evolution and most con ned backwards in cosm ic tim e itsm ain phases of star form ation. This meets, at least qualitatively, the requirem ents set by our analysis of the m ass and lum incusity functions.

Finally, and in the light of the close relationship of quasar activity and the host galaxy form ation in plied by the ubiquitous presence of super-massive black holes in the cores of all local massive galaxies, it is remarkable to note the same dependence on source lum inosity of the cosm ological evolution of the X-ray emissivity in a com – plete unbiased sample of X-ray AGNs recently quanti ed by Hasinger, Miyaji & Schmidt (2005). This similarity in the cosm ic evolution of galaxies and AGN s/quasars, and the lum inosity-dependent e ect, were already noticed by Franceschini et al. (1999).

A large am ount of independent data seem to provide concordant evidence for an evolution pattern in galaxies at z ' 0:7 to 2 as a function of the object's mass (both stellar and totalm ass). These data, suggestive of a global "downsizing" in galaxy form ation with cosm ic time, require some important correction factors (probably related to feedback by form ing objects) to the hierarchical dark matter assembly, which makes otherwise an appropriate baseline scenario, as also con med here.

9.CONCLUSIONS

This paper is devoted to a system atic exploitation of public multi-wavelength data from the GOODS survey in the Chandra Deep Field South to derive observational constraints on the emergence of the Hubble galaxy morphological sequence through cosm ic time. Critical data for this purpose are made available, in particular, by the very deep multicolor high-resolution in aging by HST /ACS and by the Spitzer Space Telescope deep photom etric infrared im aging. We also make use of extensive optical spectroscopic observations by the ESO VLT /FORS2 and VIMOS spectrographs.

Our main selection for faint high-redshift galaxies is based on deep in ages by IRAC on Spitzer. We have selected from them a highly reliable IRAC 3.6 m sample of 1478 galaxies with $S_{3:6}$ 10 Jy for detailed statisticalanalyses and for the derivation of mass and lum inosity functions in bins of redshift. We have also extended the morphologically-di erentiated number counts down to a ux limit of $S_{3:6} = 1$ Jy.We have carefully analyzed and thoroughly tested these data for com pleteness and reliability, based on simulations. Forty-seven percent of the sam ple objects have spectroscopic redshift from the VVDS, K20 and GOODS projects. For the remaining, we have used photom etric redshifts from COM BO-17 forgalaxies below z 1, while, for galaxies for which the COM BO-17 guess was above 1, we have re-estim ated the photom etric redshifts with H yperz.Deep K-band VLT /ISAAC imaging in the eld is also used to derive further com plem entary statistical constraints and to assist the source identi cation and SED analysis.

This very extensive dataset is then used to assess evolutionary e ects in the galaxy stellar mass and lum inosity functions, while lum inosity/density evolution is further constrained with the number counts and redshift distributions. The estimate of galaxy stellar masses benets in particular by the constraint set by the IRAC 3.6 m ux on the number of low-mass stars. The deep ACS imaging has allowed us to dimensitate these evolutionary paths by morphological type, that our simulations show to be reliable at least up to z 1.5.

The main results of the paper are hereby sum marized.

{ We have derived lum inosity functions at 3.6 m for various galaxy populations as a function of redshift up to z = 1:4. A fter careful calibrations of the M =L ratio, based on a detailed spectral tting analysis to the observed SED's for each sam ple galaxy, we have also obtained estim ates of the evolutionary stellar m ass functions.On one side, the 3.6 m lum inosity functions that we have derived show evidence for a positive, m oderate lum inosity evolution as a function of redshift (by

0:7m ag in the L-band from z=0 to 1.2 for the m ost m assive galaxies, M $h^2>10^{11}\,\text{M}$, in agreem ent with T reu et al. 2005a), likely due to stellar ages in galaxies becoming younger at increasing z.On the other hand, the corresponding global mass function shows evidence for an exponential decrease in the com oving density of galaxies ($/\exp{([2+z]^4=141.6)}$) at the corresponding redshifts.

- { The galaxy number counts, z-distributions, the $hV = V_{m ax}$ i test, as well as our direct estimate of the stellar m ass function above M $h^2 = 10^{10} M$, provide consistent evidence for a progressive dearth (by a fac-2:5 by z = 12 for the stellar mass density, see tor Fig. 19 and eq. 13) of the spheroidal galaxy population to occur starting at low -z and becoming quite signi cative at z 0:7, paralleled by an increase in lum inosity (half a m ag in L-band). Sim ple evolutionary m odels, tting the fast convergence of the num ber counts and redshift distributions, and the evolutionary mass function, require the main episodes for spheroidal build-up (of either old or new ly-form ed stellar populations) to happen between z 2 and z 1 for such eld population, on average.
- { This decrease in comoving density of galaxies with redshift shows, however, a remarkable dependence on galaxy mass, being strong for moderate-mass, but almost absent until z = 1.4 for high-mass galaxies,

thus con m ing previous evidence for a "downsizing" e ect in galaxy formation (e.g. Cowie et al. 1996; Franceschiniet al. 1998). By comparison with dynam ical studies of the high-redshift spheroidal population (Treu et al. 2005a,b), it is concluded that both stellar m ass and total "dynam ical" m ass are driving param eters of this di erential evolution. This evolutionary pattern m ay also help explaining som e inconsistencies in the evolution of galaxies at high redshifts previously reported by di erent team s. O ur results appear consistent with recent reports by independent team s and selection functions (Fontana et al. 2004; Bundy et al. 2005).

- { As for the complementary class of actively star-forming (irregular/m erger) galaxies, deep Spitzer/IRAC 3.6 m and K-band observations show them to evolve towards m oderately higher luminosities and number densities up to z 1 to 2, while normal spirals (those with asymmetry indices A < 0.4) show similar, though slower, convergence at z > 1 to that of spheroids.
- { 0 ur favored interpretation of the estim ated m ass functions and evolutionary trends for the two broad galaxy categories is that of a progressive m orphological transform ation (due to gas exhaustion and, likely, m erging) from the star-form ing to the passively evolving phase starting at z 2 and keeping on down to z 0:7. The rate of this process appears to depend on galaxy m ass, being already largely concluded by z 1:4 for the m ost m assive system s.
- { We nally discuss how well this evidence for a differential rate of galaxy build up with galactic mass compares with estimates of the SFR history based on deep far-IR surveys (e.g. Perez-Gonzales et al. 2005). A match between the two complementary views, of the history of SFR by the best star-formation tracer (the bolometric ux) on one side, and the rate of stellar mass build up traced by the near-IR emission on the other, would be achieved just by assuming that the progenitors of the most massive galaxies are the most (bolometrically) luminous sources at high-z. Am ple evidence is accumulating in favor of the latter.

If the evolution pattern for galaxies to z 1:4 is now close to be understood, the know ledge of what exactly happened in the critical higher redshift era is still lim ited by very poor statistics in the number of detected sources and lack of spectroscopic follow-up. How is the mass function behaving in detail at such high redshifts? Does the "downsizing" trend continue there, as it m ight seem natural to expect? In principle, the sensitivity of Spitzer/IRAC would allow accurate stellar mass determ inations at these high-z, but quite further substantiale ort with powerful spectrographs is needed before we get credible answers. It is encouraging that much along this line has already been undertaken (am ong others, by GDDS, Abraham et al. 2004, Juneau et al. 2005; FIRES, Franx et al. 2003; GMASS, C im attiet al, in progress; COSMOS & z-COSMOS, Scoville et al., Lilly et al., in progress).
