# Com parative D irect A nalysis of Type Ia Supernova Spectra. II. M axim um Light

# ABSTRACT

A comparative study of near{m axim um {light optical spectra of 24 Type Ia supernovae (SN e Ia) is presented. The spectra are quanti ed in two ways, and assigned to four groups. Seven \core{norm al" SN e Ia have very sim ilar spectra, except for strong high{velocity Ca II absorption in SN 2001el. Seven SN e Ia are assigned to a \broad{line" group, the most extrem e of which is SN 1984A. Five SN e Ia, including SN 1991bg, are assigned to a \cool" group. Five SN e Ia, including SN 1991Dg, are assigned to a \cool" group. Com parisons with Synow synthetic spectra provide a basis for discussion of line identi cations, and an internally consistent quanti cation of the maxim um {light spectroscopic diversity among SN e Ia. The extent to which SN Ia maxim um {light spectra appear to have a continuous distribution of properties, rather than consisting of discrete subtypes, is discussed.

#### 1. IN TRODUCTION

In the st paper of this series (B ranch et al. 2005; hereafter P aper I), the param eterized supernova synthetic{spectrum code Synow was used to t and interpret a time series of spectra of the well{observed, spectroscopically norm al, Type Ia (SN Ia) SN 1994D. In this paper we concentrate on near{m axim um {light spectra of 24 SN e Ia. M axim um {light spectra are of particular interest because they are the ones m ost likely to be obtained, especially for high {redshift SN e Ia. In x2 the spectra are quanti ed and arranged to illustrate relationships

between them . In x3 to x6 four groups of spectra are discussed, and selected comparisons with Synow synthetic spectra are shown. Results are discussed in x7.

As in Paper I, we con ne our attention to optical spectra, from the Ca II H & K feature in the blue (3700 A) to the Ca II infrared triplet (Ca II IR 3) in the red (9000 A). The 24 spectra selected for study were obtained within three days of B {band m axim um light [which occurs about 18 days after explosion (Vacca & Leibungut (1996)], a time interval short enough that spectroscopic evolution is not strong, yet long enough to allow some events of special interest to be included. All spectra have been corrected for the redshifts of the parent galaxies. The original spectra have a range of slopes, owing to intrinsic di erences, di erences in the am ount of reddening by interstellar dust, and observational error. In this paper, because we are interested only in the spectral features, and not in the underlying continuum slopes, the spectra are tilted by multiplying the ux by , with chosen to m ake the ux peaks near 4600 A and 6300 A equally high. The tilting m akes it m uch easier to com pare the spectral features. The events of the sam ple are listed in Table 1, together with param eters to be discussed below.

## 2. ARRANGING THE SPECTRA

Various ways of arranging the spectra according to measurements of selected features were explored. The arrangement shown in Figure 1 appears to be useful. The W (5750) parameter is the equivalent width of the absorption near 5750 A, usually attributed to Si II 5972, and W (6100) is that of the stronger absorption near 6100 A, produced by Si II 6355. (Because of the presence of emission features, these are equivalent {width {like quantities rather than true equivalent widths.) The wavelength limits of integration are chosen by eye<sup>3</sup> in the same way as they are form easuring the R (Si II) parameter, which is the ratio of the intregral is the mean of the uxes at the wavelength limits. The ratio of W (5750) to W (6100) is correlated with, but not equal to, R (Si II). For our present purpose of arranging the spectra, the measurement errors are not in portant, even though the fractional error of W (5750) is large when W (5750) is small.

P lotting W (5750) against W (6100) illustrates the relationships according to only two spectral features. To quantify the relationships over a broader wavelength range, the spectra were interpolated onto a standard wavelength grid of 2 A separation, and for each pair of

spectra the  ${}^{2}$  {like gure of merit form ed from the logarithm ic ux di erences between 3700 and 6500 A (or as much of this interval as possible) was minimized by scaling the ux and varying the tilt (Appendix A). The results identify the nearest neighbor of each event. In F igure 1, a single{headed arrow points to a nearest neighbor (e.g., SN 2002bf is the nearest neighbor of SN 1984A) and a double{headed arrow connects events that are mutual nearest neighbors.

In x3 to x6 four groups of spectra, denoted by di erent symbols in Figure 1, are considered. The group assignments were made on the basis of Figure 1, as well as on the appearance (depth, width, and shape) of the 6100 A absorption feature. Some comparisons with synthetic spectra are shown, and line identications are discussed.

### 3. CORE {NORMALS

Figure 2 shows spectra of seven SN e Ia that are tightly clustered in Figure 1 and have sim ilar 6100 A absorptions, not only in equivalent width but also in shape. O ther features, even weak ones, also are sim ilar. These will be referred to as \core{norm al" SN e Ia. The only conspicuous di erence among them is the strong high{velocity Ca II IR 3 absorption near 8000 A in SN 2001el.

In Branch et al. (2003) and in Paper I, Synow ts to the spectra of two core{norm als, SN 1998aq and SN 1994D, were presented and discussed. Descriptions of the Synow code and its use can be found in these two papers and references therein. For the present work, we adopted precepts for thing spectra of core (norm als that di erm ildly from those of previous papers. For photospheric (velocity (PV) ions the line optical depth e{folding velocity,  $v_e$ , is 1000 km s<sup>1</sup>. For most detached high (velocity (HV) ions,  $v_e = 2000$  km s<sup>1</sup>. (HV Ca II in SN 2001el is an exception.) The excitation tem perature, T<sub>exc</sub>, is 10,000 K. The ions used are PV O L, Mg II, SiII, SiII, S II, Ca II, Fe III, Co II, and NiII, HV Ca II, and HV Fe II. In Paper I, N a I also was used, but the identi cation (at maximum light) was not considered to be de nite. In this paper N a I is not used for core { norm als, on the grounds that if N a I were present in core{norm als then it should be much stronger in cooler SN 1991bg{like events, which is not the case. Lines of C II also are not used, because if present at maximum light they are weak and di cult to con m [although they appear to be present at maxim um light in at least SN 1998ag (Branch et al. 2003), and will be used in Paper III (in preparation) on prem axim um { light spectra ]. In Paper I, HV Fe II was not used in near{m axim um { light spectra. In this paper HV Fe II is used<sup>4</sup> because we now have stronger evidence for its

presence, as discussed below. The Synow thing parameters for the core{norm als are listed in Table 2.

In Figure 3 the spectrum of SN 1994D is compared with two synthetic spectra. As usual, the blackbody continuum of Synow makes the synthetic spectrum too high from about 6500 A to 7800 A. (The continuum of SN e Ia cannot be modeled as a single blackbody curve, but an attempt to model the exact continuum shape at the Synow level of analysis would be an unrewarding thing exercise.) One synthetic spectrum includes HV Fe II, detached at 16,000 km s<sup>1</sup>, and the other does not. The main e ect of HV Fe II is produced by two lines of multiplet 42, 5018 and 4924. (The third line of the multiplet, 5169, is in this case overwhelm ed by SiII absorption.) In SN 1994D and most other events of the sample, an absorption near 4430 A, which we believe to be produced by SiIII 4550, is not well tted because the Si III synthetic absorption is too blue. The t could be improved by lowering  $v_{phot}$  and slightly detaching all ions other than Si III, but this would not help us to understand the discrepancy so we have refrained from doing it. Because the synthetic spectra usually are too high in the red, and because of the presence in some spectra of the telluric absorption near 7600 A, it is di cult to know how to t the absorption produced by 0 I 7773 (and Mg II 7890), so little signi cance should be attached to the tting parameters used for 0 I.

In Figure 4 the spectrum of SN 2001el is compared with a synthetic spectrum in which HV Ca II has a high optical depth (= 12, compared to = 2 to 5 for other core{normals}, a high value of  $v_e = 12,000$  km s<sup>-1</sup>, and a maximum velocity of 30,000 km s<sup>-1</sup>. The high value of  $v_e$  makes the absorption at and extend to the maximum velocity. This t is not unique, but it demonstrates that HV Ca II can account for the feature. Polarization observations indicate that asymmetry, not taken into account in Synow, a ects HV Ca II line formation in SN 2001el (W ang et al. 2003, K asen et al. 2003). The best t for SN 2001el is obtained with a HV Fe II optical depth that is the highest among the core{normals. Since SN 2001el has strong HV Ca II absorption, this is regarded as support for the HV Fe II identication. The normality of all features not a ected by HV Ca II and HV Fe II indicates that the PV spectrum of SN 2001el is very much like those of the other core{normals.

M ost of the spectral features of the core{norm als have established line identi cations. Ions whose presence is considered to be de nite are PV Si II, S II, Ca II, O I, Mg II, Fe III, and HV Ca II. Co II and Si III are probable, while N i II is possible, but di cult to

establish. We will return to the issue of HV Fe II below. The issue of C II will be addressed in Paper III (in preparation) on premaximum spectra. A few of the weak features of the core{norm als are not reproduced by the Synow spectra. Possible identications of the weak absorptions near 5500 A and 5150 A (seen most clearly in Figure 3) are Si III 5740 and Co II 5311, respectively. The weak absorptions near 4150 A and 4550 A (see Figure 2) remain unidentied (but see x7 on the 4550 A absorption).

#### 4. BROAD {LINE SNe Ia

Figure 5 shows the spectrum of the core{normal SN 1994D (for comparison) and the spectra of seven SN e Ia that are spectroscopically normal in the traditional sense that their strongest spectral features are the usual ones, rather than the conspicuous Fe III features of SN 1991T or the blue T i II trough of SN 1991bg. However, these seven \broad{line" SN e Ia have 6100 A absorptions that are broader and deeper than those of the core{norm als, which puts them to the right of the core{norm als in Figure 1. The spectra of SN 1992A and SN 1981B are not very di erent from core{norm al, but their lines are broader, e.g., notice the lack of resolution in the absorption com plex from 4600 A to 5100 A . Therefore, we regard SN 1992A and SN 1981B as sm all steps from the core in the direction of SN 1984A . The spectra of F igure 5 do not appear to com prise a sim ple one{dim ensional sequence. In SN 2002bf the absorption near 7500 A is broad and shallow . SN 2001ay has a weak C a II IR 3 absorption and steep pieces of spectra near 4000 A and 4200 A . Extrem e photom etric peculiarities of SN 2001ay are discussed by Howell & Nugent (2004).]

The thing parameters for the broad { line SN e Ia are in Table 3. The ions are the same as for the core{norm als. Reasonable tswere obtained with  $v_{phot} = 12,000 \text{ km s}^{-1}$ , a typical value for core-norm als, and higher values of  $v_e$ : 2000 km s<sup>-1</sup> for both PV and HV ions, or higher as indicated in Table 3. For consistency with the modeling of the core{norm als, PV and HV components were used for Ca II, but these broad Ca II features also can be tted as single high { $v_e$  components, so the Ca II thing parameters are far from uniquely determined.

In Figure 6 the spectrum of the moderately broad { line SN 2002bo is compared with two synthetic spectra. HV Fe II, with a high optical depth of 1.5, a ects the synthetic spectrum in several places. In Figure 7 SN 1984A is compared with synthetic spectra in which Si II has  $v_e = 5000 \text{ km s}^1$  and a maximum velocity of 25,000 km s<sup>1</sup>. The quality of these two ts is about the same as for the core{norm als.

Line identi cations in the broads are the same as in the core{norm als. G iven the non{ uniqueness of Synow ts (e.g., to an extent, lowering  $v_e$  can be compensated by raising the

optical depth), most of the di erences between the optical depths used for the broads and the core{norm als are not necessarily signi cant.

## 5. COOL SNe Ia

Figure 8 shows spectra of the core{norm al SN 1990N and ve \ccol" SN e Ia, four of which have a conspicuous absorption trough from about 4000 to 4400 A, due in part to PV Ti II (Filippenko et al. 1992a; M azzali et al. 1997; G amavich et al. 2004). SN 1989B, on the other hand, is spectroscopically norm al in the traditional sense, and not far from core{norm al, but its 6100 A absorption is deeper than in the core{norm als. Its W (6100) value is sim ilar to that of SN 1981B, which is one of the broad{line events of x4, but the features of SN 1989B are better resolved than those of SN 1981B. Notice, for example, the well resolved region between 4600 A and 5100 A in SN 1989B. The 6100 A absorption of SN 1989B is alm ost identical to that of SN 1986G. For these reasons, we regard SN 1989B as a sm all step from the core in the direction of SN 1991bg{like spectra, and it is included with the cools even though it does not have the blue absorption trough.

The thing parameters for the cool SN e Ia are in Table 4. SN 1989B can be the with parameters that dieronly mildly from those of the core{normals. For the others of Figure 8, the PV excitation temperature is lowered from 10,000 to 7000 K in view of the development of T i II lines, which require low temperature. In addition to T i II, vemore ions, N a I, M g I, C a I, S c II, and C r II, are introduced. G amavich et al. (2004) used M g I and C a I in their study of SN 1999by, and S c II also is plausible at low temperature. (S c II lines appear in SN e II when they become su ciently cool.) Si III and Fe III require high temperature so they are not used for the cools.

The spectrum of SN 1986G cannot be well tted with the precepts that were adopted for the core{normals; when the 6100 A absorption is tted, the 5750 A absorption, which is strong in the observed spectrum, hardly appears in the synthetic spectrum. A plausible solution is to impose a maximum velocity on SiII. In Figure 9 the spectrum of SN 1986G is compared with a synthetic spectrum in which SiII has a maximum velocity of 15,000 km s<sup>1</sup> and a high optical depth of 100. Owing to the maximum velocity, the 6100 A absorption saturates, and owing to the high optical depth, the 5750 A absorption appears.

It has been suggested (G amavich et al. 2004) that  $Ti \amalg m$  ay contribute to the 5750 A absorption in SN 1991bg{like spectra, but we nd that when the  $Ti \amalg$  optical depth is chosen to t the blue trough,  $Ti \amalg m$  akes no signi cant contribution to the 5750 A absorption. (If the  $Ti \amalg$  optical depth is raised, or an improbably high value of  $T_{exc}$  is used, an absorption

due to T i II lines does appear near, but not near enough, to the 5750 A absorption.) On the basis of detailed spectrum calculations with the PHOENIX code (Baron et al. 2003 and references therein), S. Bongard et al. (in preparation) also conclude that T i II m akes no contribution to the 5750 A absorption. Again, a plausible solution is to impose a m axim um velocity on Si II. This is shown in Figure 10 for SN 1991bg; in the synthetic spectrum the Si II m axim um velocity is 14,000 km s<sup>1</sup> and the optical depth is 200.

In view of the large number of ions that may be present, line identications in the cools (other than SN 1989B) are a challenge. Si II, Ca II, Mg II, Ca II, and Ti II can be regarded as de nite. (Contrary to previous opinion, S II cannot, because Sc II has lines that could be wrongly attributed to S II.) As shown in Figures 9 and 10, Cr II, Sc II, Mg I, Ca I, Na I, Co II, and Ni II can be combined to obtain reasonable ts; all of these ions are plausible, but none are de nite.

## 6. SHALLOW {SILICON SNe Ia

Figure 11 shows spectra of the core{norm alSN 1994ae and ve \shallow {silicon" SN e Ia that have sm aller values of W (5750) and W (6100), thus occupying the lower left corner of Figure 1. Despite their shallow SiII absorptions, SN 1999æ and SN 1999aw are spectroscopically norm al in the traditional sense. SN 1991T and SN 2002cx are spectroscopically peculiar because Fe III produces the strongest features (Filippenko et al. 1992b; Ruiz{Lapuente et al. 1992; Je ery et al. 1992; M azzali, D anziger, & Turatto 1995; Fisher et al. 1999).

In Figure 12 the spectrum of SN 1999æ is compared with that of the core{normal SN 2001el. SN 1999æ has weaker Si II and S II features, but its HV Ca II is almost as strong as that of SN 2001el (M azzali et al. 2005a), and the features attributed to HV Fe II are about as strong as in SN 2001el. This is additional support for the HV Fe II identication.

The thing parameters for the shallow (silicon SN e Ia are in Table 5. The value of  $v_e$  is 1000 km s<sup>-1</sup> except where indicated otherwise in the Table. In Figure 13 the spectrum of SN 1999ee is compared to a synthetic spectrum. The ions used are the same as in the core normals, but with high values of  $v_e = 4000$  km s<sup>-1</sup> for HV Fe II and 6000 km s<sup>-1</sup> for O I and HV Ca II.

Figure 11 shows that the spectra of SN 1999ee, SN 1999aw, and SN 2000cx have m any sim ilarities at wavelengths longer than about 4300 A. However, compared to SN 1999ee and SN 1999aw, SN 2000cx is strongly depressed from about 3800 A to 4200 A. In Figure 14 the spectrum of SN 2000cx is compared to a synthetic spectrum in which SiII is mildly detached at 15,000 km s<sup>1</sup>. As in Branch et al. (2004a), HV TiII is used to provide blocking in the

blue, and to account for the sharp ux peak near 4150 A.Branch et al. were unable to suggest an identi cation for the distinct absorption feature near 4530 A, except for HV H, which would be surprising. However, as shown in Figure 15, we now realize that HV Cr II can account for this feature. If the HV Ti II identi cation is correct, then HV Cr II, at practically the same detachment velocity, is a more plausible identi cation than H. In the synthetic spectrum of Figure 14 HV V II also is introduced, but its main e ect is in a crow ded spectral region and the identi cation is not de nite.

SN 1991T may be a continuation of the sequence shown in Figure 11; e.g., it bears some resemblance to SN 1999aw, although its Ca II and Si II features are weaker. As further discussed in x7, even though SN 1991T and SN 2002cx are mutual nearest neighbors spectroscopically, in several respects they are quite di erent. It may be that the only thing these two have in common is a high temperature.

# 7. DISCUSSION

The high degree of spectral hom ogeneity among the core{norm als suggests that they result from a standard, repeatable SN Ia explosion mechanism that does not produce spatially large composition inhom ogeneities near the characteristic photospheric velocity of 12,000 km s<sup>-1</sup> (Thom as et al. 2004). The strong HV Ca II of SN 2001el may involve a spatially large structure near 20,000 km s<sup>-1</sup> (K asen et al. 2003; K asen & P lewa 2005). On the other hand, the features attributed to HV Fe II are only mildly enhanced in SN 2001el and rather hom ogeneous in the others, suggesting that weak HV Fe II is \natural" in SN e Ia, in the sense that it does not require unusual high{velocity structures (Ho ich, W heeler, & Thielem ann 1998, Lentz et al. 2001b). W eak HV Ca II also is ubiquitous (M azzali et al. 2005b).

Based on previous work (B ranch 1987; B enettiet al. 2004) we expected to t the broad { line SN e Ia with high values of  $v_{phot}$ , but better ts were obtained by holding  $v_{phot}$  constant at 12,000 km s<sup>-1</sup>, a typical value for the core{norm als, and using increased  $v_e$  values. This may be a consequence of nuclear burning extending to higher velocity in the broads than in the core{norm als (Lentz et al. 2001a; B enettiet al. 2004; Stehle et al. 2005).

A lthough the composition structures of the cools surely di er from those of the core{ norm als (e.g., the low lum inosity requires a low mass of  $^{56}$ N i), the immediate reason for the spectroscopic di erences appears to be the lower temperature. The blue trough in cools, usually referred to as the T i II trough, is produced not only by T i II, but also by other ions that appear at low temperature. T i II is not signi cant for the 5750 A absorption.

The 5750 A absorption of the cools can be accounted for in terms of a high Si II optical depth together with a maximum Si II velocity. This is a plausible way to simultaneously t these two absorptions while explaining why R (Si II) and the ratio of W (5750) to W (6100) go the wrong way with temperature (i.e., increasing with falling temperature), considering that the lower level of 5972 is the upper level of 6355. If correct, this maximum velocity would indicate that in the cools nuclear burning extends only to unusually low velocities, near 15,000 km s<sup>1</sup>.

In m ost of the shallow (silicon SN e Ia the spectral features appear to be produced by the sam e ions as in the core(norm als, although the optical depths are quite di erent, especially in SN 1991T and SN 2002cx. M ost of the di erences from core(norm als m ay be caused by a higher tem perature. Like SN 2001el am ong the core(norm als, SN 1999æ provides support for the HV Fe II identi cation. The cause of the depression of the spectra of SN 2000cx in the blue from about 3800 A to 4200 A appears to be extra HV line blocking. If HV T i II is present, then HV CrII is a m ore plausible identi cation than HV H (Branch et al. 2004a) for the 4530 A absorption in SN 2000cx. A s noted in x3, a less distinct absorption appears near 4550 A even in the core(norm als; HV CrII is a possibility.

O ne of the most interesting issues that can be addressed by studies of this kind is whether SN e Ia have a continuous distribution of properties, or consist of discrete subgroups. On the whole, we have a sense of continuity. SN 1992A and SN 1981B m ay be small steps from the core in the direction of SN 1984A; SN 1989B m ay be a step in the direction of SN 1986G and SN 1991bg; SN 1999ee m ay be a step in the direction of SN 1991T. If the distribution is continuous, then exactly how the boundaries of the core{norm algroup are de ned is not important.

The cools stand apart from the others in Figure 1, but this in itself does not establish that they di er in kind from the others. As noted by Hatano et al. (2002) and Ho ich et al. (2002), there is a tem perature threshold below which, owing to abrupt changes in key ionization ratios, line optical depths change abruptly (Hatano et al. 1999). Therefore, the tem perature interval required to go from SN 1989B through SN 1986G to SN 1991bg{like events m ay be narrow. SN 1991bg{like events also are quite sublum inous, but especially in the B band, which is strongly blocked by the blue trough. Sim ilarly, there is a tem perature threshold above which Fe III features become e conspicuous (Hatano et al. 2002). M ost SN e Ia m ay be variations on the basic core{norm al them e, with the diversity re ecting di erences of degree, rather than di erences of kind.

Evidence recently has been presented that in term sof stellar population age there are two SN Ia groups of roughly equal size, one from a young ( $10^8$  years) population and another from another from an older (3 G yr) population (M annucci et al. 2005a; Scannapieco

& Bildsten 2005; M annucci, D ella Valle, & Panagia 2005b). However, we see no basis for splitting the SN e Ia of our sample into two groups of roughly equal size. It may be that there are two di erent binary{star evolution paths to SN e Ia, one requiring a short time and the other a long time, but with the two paths producing similar outcomes, i.e., carbon{oxygen white dwarfs that explode as they approach the Chandrasekharm ass.

The one event of our sam ple that does seem to be di erent in kind is SN 2002cx, which we have placed in the shallow (silicon group. Like SN 1991T it had conspicuous Fe III lines, but unlike SN 1991T it did not have a slow light(curve decline rate and it was sublum inous (Liet al. 2003). Its late(tim e spectra were unlike those of norm al SN e Ia, being dom inated by very low velocity (700 km s<sup>1</sup>) perm itted lines of Fe II, Ca II, Na I, and perhaps O I. Several other SN 2002cx(like events have been discovered (S. Jha et al., in preparation). On the basis of the rst(season observations by Li et al. (2003), Branch et al. (2004b) suggested that SN 2002cx m ay have been a pure de agration while m ost other SN e Ia, even SN 1991bg(likes (H o ich et al. 2002), m ay be delayed detonations or gravitationally con ned detonations (P lewa, Calder, & Lamb 2004; K asen & P lewa 2005). However, the late(tim e spectra of SN 2002cx (S. Jha et al., in preparation) do not resemble the spectra calculated by K ozm a et al. (2005) for one particular 3{D de agration m odel, so the nature of SN 2002cx rem ains uncertain.

The normality of PV features in events such as the core{normal SN 2001el and the shallow {silicon SN 2000cx, both of which have strong HV features, suggests that HV and PV are somewhat independent (with HV Fe II and weak HV Ca II being ubiquitous and natural, as discussed above). An interesting issue for further study is how much of the photom etric diversity of SN e Ia is caused by HV features (which may not correlate with lum inosity). Another issue is whether the strong HV blue line blocking of SN 2000cx occurs only in the shallow {silicon group. It is clear that strong HV Ca II IR 3 absorption occurs not only in the core{normal SN 2001el but also in the shallow s.

O ur study is com plem entary to that of B enetti et al. (2005; hereafter Be05), who did not consider the strenths of spectral features. Sixteen events of our sam ple were included in the study of Be05, who assigned SN e Ia to three groups on the basis of absolute m agnitude (M<sub>B</sub>); light{curve decline rate (m<sub>15</sub>; Phillips 1993); the blueshift of the 6100 A absorption 10 days after m axim um [ $V_{10}$  (Si II); B ranch & van den Bergh 1993]; the rate at which the 6100 A absorption drifts to the red [v (Si II); Be05]; and R (Si II). W ith a few borderline exceptions (SN 1989B and SN 1992A), our cools corresponds to the Be05 FA IN T group, which is to be expected since both tem perature and lum inosity are controlled m ainly by the <sup>56</sup>N i m ass. Our broad{line group corresponds to the Be05 HVG (high tem poral{velocity gradient) group. This also m akes sense because broad 6100 A absorption requires high Si II optical depth over a substantial velocity range, which makes it possible for the absorption minimum to shift appreciably with time. The broads appear to have thicker silicon layers than the core{normals. Our core normals and shallows correspond to the Be05 LVG (low temporal{velocity gradient) group. The lower velocity range over which Si II has a high optical depth permits only a smaller shift in the absorption minimum with time.

Polarization observations (W ang et al. 2001; Howell et al. 2001; W ang et al. 2003; Leonard et al. 2005) show that som e spectral features are a ected by asym m etric structures. A straightforward way to rule out asym m etry as the sole cause of the di erences between groups of SN e Ia would be to demonstrate a correlation with parent galaxy type (BeO5) or other indicators of the parent{galaxy population (G allagher et al. 2005). If asym m etry were the sole cause of SN Ia di erences, SN Ia subtypes would not correlate with galaxy types. But, in fact, there are correlations and em erging correlations. SN 1991bg{like events tend to occur in older populations (H ow ell 2001). In the BeO5 sam ple the m ean host galaxy m orphological type (the T type) was found to increase from the FA IN T to HVG to LVG groups. Sim ilarly, for our sam ple the m ean T type increases from cools to core{norm als to broads to shallows, but the statistics are too poor to allow de nite conclusions.

The expected rapid increase in the number of well observed SN e Ia in the near future (e.g., W ood {Vasey et al. 2004) will allow the relationships among SN e Ia to be clarited. W e expect that our Paper III (in preparation), on premaximum spectra, also will clarify the view presented here.

The  $y_i$  values are the observed spectral ux values of spectrum '. The factor  $S_i$  is a scale factor and the factor (i = 0) ' produces tilt; 0 is just a reference wavelength that need not actually be specified. (This scaling and tilting of spectra is more elaborate than the tilting we describe in the main text (see x 1) for spectra that we present and twith Synow spectra.)

For two spectra labeled by indexes 1 and 2, we form ulate the 2 {like function:
