# The Discovery of a P CygniAnalog in M 31<sup>1</sup>

# ABSTRACT

We present spectroscopy and discuss the photom etric history of a previously obscure star in M 31. The spectrum of the star is an extrem ely close m atch to that of P C ygni, one of the archetypes of Lum inous B lue Variables (LBV s). The star has not shown m uch variability over the past 40 years (< 0.2 m ag), although sm all-scale (0.05 m ag) variations over a year appear to be real. Nevertheless, the presence of a sub-arcsecond extension around the star is indicative of a past outburst, and from the nebula's size (0.5 pc diam eter) we estim ate the outburst took place roughly 2000 yrs ago. P C ygni itself exhibits a sim ilar photom etric behavior, and has a sim ilar nebula (0.2 pc diam eter). We argue that this m ay be m ore typical behavior for LBV s than commonly assumed. The star's location in the HR diagram o ers substantial support for stellar evolutionary m odels that include the e ects of rotation, as the star is just at a juncture in the evolutionary track of a 85M star. The star is likely in a transition from an O star to a late-type W N W olf-R ayet.

## 1. Introduction

Lum inous Blue Variables (LBVs) are a rare class of lum inous stars which undergo episodicm ass-loss, and probably represent a transition between them ost massive 0 stars and

the red supergiant and/or W olfR ayet stage. (See the recent conference proceedings edited by D avidson et al. 1988, N ota & Lam ers 1997, and de G root & Sterken 2001.) All of the \accepted" LBV swere discovered on the basis photom etric and/or spectroscopic variability, but the num ber of LBV \candidates" (based upon spectroscopic sin ilarities to known LBV s) exceeds this num ber (P arker 1997). Understanding the num ber of bona- de LBV s relative to that of other evolved m assive stars (W olf ayets, red supergiants) in nearby galaxies (i.e., at di ering m etallicities) provides a crucial test of the success of m odern stellar evolutionary theory (M aeder & M eynet 2000). M assey (2002) has argued that if the archetypal LBV s P Cygnior C arina were located in M 31 or M 33 we would not know of them today, since their spectacular photom etric outbursts were hundreds of years ago.

In this Letter we report the discovery of a star in M 31 whose spectrum is uniquely sim ilar to that of P C ygniitself. A comparison of the star's location with stellar evolutionary tracks provides a strong substantiation of the latest generation of stellar models that include the e ects of rotation (M eynet & M aeder 2005), while also o ering a caution in interpreting evolutionary stages of these hydrostatic models. The star has been relatively photom etrically stable for the past 40 years, yet it shows compelling evidence of an outburst 2 m illennia ago. This provides further support for the argum ent large photom etric variations on the tim e-scale of decades may be more a selection e ect than a consequence of the physics of LBV s.

#### 2. The D iscovery

The Local Group Galaxies Survey (LGGS) project has obtained in ages of M 31 with the Kitt Peak 4-m telescope. The LGGS has now completed the photom etric calibrations and photom etry for M 31 (> 350,000 stars), and is preparing the paper for publication. A subset of several dozen bright, blue stars were selected for spectroscopy with the W IY  $N^3$ 3.5-m telescope and Hydra multi-object ber positioner. The selection criteria included V < 0.5, and the reddening free index Q = (U = B)0:72 B V < 18, B V) < 0:6 in order to eliminate foreground dwarfs. The spectra were obtained using a 790  $1 \text{ mm}^{-1}$ grating (KPC-18C) in second order, with a BG-39 blocking Iter to Iter out ist order red light. The observations covered 3970A to 5030A. The \blue" ber bundle was used for these observations; each ber is 3.1" in diam eter. The detector was a Tektronix 2048 x 2048 device (\T2KA") with 24 m pixels. The resulting spectral resolution was 1.5A. Our exposure of the northern eld (in which our object was found) consisted of six 30m integrations (ie., 3 hrs).

The eld was recon gured halfway through the sequence in order to update the apparent position changes due to refraction. The observation was made on (UT) 2005 September 29.

In reducing the data that night we were immediately struck by the similarity of one of the stars to the well-known Galactic star P Cygni. The following night we obtained a 10 s exposure of P Cygni itself with the same setup to con m ourmemory. We give the comparison in Fig.1.

The degree of similarity to P Cygni is nearly unique. While the term \P Cygni pro le" (blue-shifted absorption with an emission component extending redwards from line center) is used to describe individual lines in other stars having this characteristic mass-loss signature, only a few stars show even a close resemblance to P C yqni itself throughout the blue-optical region, and all of these stars have been called LBVs. Even amongst these the di erences can be striking. For instance, although the LMC LBV-candidate R81 has been described as the \P Cygni of the LMC" by W olf et al. (1981a), its optical spectrum contains He I lines without a strong em ission component; com pare their Fig. 1 with our Fig. 1. W alborn (1989) describes other LBVs at minimum light (i.e., maximum  $T_e$ ) as having the same general spectral characteristics as P Cygni, but the comparison is more apt in some cases than in others. AG Car (Hutsem ekers & Kohoutek 1988, Fig. 1), AF And, M 33 Var B (Kenyon & Gallagher 1985, Figs. 2-3), and R127 (Stahlet al. 1983, Fig. 3) do all show the sam e general P Cygnilines in He I and in the Balmer lines as does P Cygni, but R71 is an another example where the H e I lines do not show a pronounced em ission component (W olf et al. 1981b, Fig. 3). HDE 316285 also shows m any similarities in the infrared (M cG regoret al. 1988) and yellow red (Morrison & Rao (1990), but the blue-optical spectra shows little resemblance to P Cygni (W alborn & Fitzpatrick 2000). In the M ilky W ay, the LBV He 3-519 (Sm ith et al. 1994) probably bears the most sim ilar spectrum known to P Cygni.

O ur M 31 star is identi ed in the LGGS catalog as J004341.84+ 411112.0, based upon its J2000 coordinates (i.e.,  $= 00^{h}43^{m}41$ .84,  $= +4111^{0}12$ .0) determ ined from USNO-B astrom etric positions in the eld. It is located in A 30, an OB association cataloged by van den Bergh (1964); see Fig. 2. We note with som e am usem ent that one of the original ve Hubble-Sandage variables (Hubble & Sandage 1953), Var 19 = AF And, is located just 2' away<sup>4</sup>.

Second, we considered whether or not it was possible for the ber positioner to have accidently dropped the ber button, m iracubusly hitting

The starwas rst cataloged (as \40 4631") by Berkhuipen et al. (1988), who presented UBVR<sub>J</sub> photom etry based upon photographic plates taken in 1963. The next published photom etry is given by Magnier et al. (1992) from their 1990 BVRICCD survey of a 1 deg<sup>2</sup> eld in M 31, where it appears as object 228465. If the data are taken at face value, the star brightened by 0.6 m ag in V, and reddened by 0.5 m ag in B V during the 37 years (see Table 1). However, nearby (< 10°) stars of a similar brightness show this same o set in V, so we discount this as an indication of variability. However, the photographic B value of neighboring stars are more in accord with Magnier et al. (1992), albeit with large scatter. The LGGSCCD photom etry, carried out in 2001-2002, agrees well with M agnier et al. (1992). The slight di erences between our two observations (0.06 m ag) appears to be real: the form al errors are one-tenth of that, and a comparison of the stars in overlap between the two elds indicate median di erences < 0:01 at all lters except I, for which there is a sm all system atic o set (0.02 m ag) for the 2002 observation. G. Jacoby also kindly obtained current-epoch (2005 November) V and R in ages at W IYN for us, which we have calibrated using the LGGS photom etry of stars of sim ilar color. We conclude that over recent times the star has been relatively constant (< 0.2 m ag) in brightness over the past 40 years, but that it does show real variations of order 0.05 m ag. This behavior is quite sim ilar to that of P Cygni, although di erent than m any other LBVs (Israelian & de G root 1999).

H ill et al. (1995) identify their UV-bright source 30-3 with this star, using M agnier et al. (1992) as a cross-reference. They used Ultraviolet Im aging Telescope (UIT) data, and detected the star in the 2500A im age but not in the 1500A im age<sup>5</sup>. The fact that the star is UV-bright is consistent with the M assey et al. (1996) study of UIT sources in M 33, which discovered m any LBV candidates.

We checked the HST data archives for images of the star; only one WFPC2 image contains a (barely) unsaturated exposure. This is a 300 sexposure through the F675W (\R") lter, u42z5701r. The star is in fact slightly extended, with a full-width-at-half-maximum (fwhm) of 2.0 pixels (0.2") of the WF3 chip. O ther stars on the image have signi cantly

the position of AF And rather than our intended target. It was not. For one thing, we made a minor tweak in the positions of all of the bers half way through the exposure (see above), and the spectrum before and after the recon guration matched. In addition, had the button been dropped the positioner would have been unable to retrieve it when we recon gured for the next eld, and that was not the case. We are indebted to N olan W alborn for raising this particular specter, but we feel it has been completely exorcised.

sm aller fwhm s, as shown in Fig. 3. However, the star does not appear to be double, given the radial prole, just extended. If we make the simple assumption that the size of the image adds in quadrature, then there is something around the star that has a diameter of about 0"015. At the distance of M 31 (760 kpc, according to van den Bergh 2000), this would have a size of 0.5 pc. P C ygni is known to have several shells of gas around it; the most prominent of these has a diameter of 22" (0.2 pc), which is taken as evidence that the star had a major mass-loss event 900 years ago (see discussion in Israelian & de G root 1999). If the expansion velocity is the same for our object, then the relevant time scale would be about 2,000 yr. C on mation with the better scale of the ACS would be desirable; several ACS images in the archive include the eld, but the star is saturated<sup>6</sup>.

Determining the star's absolute visual magnitude requires knowing the reddening. If the star's intrinsic color is the same as P Cyqni's,  $(B \vee V)_0 = 0.19$ , (Lamers et al. 1983), then E (B V) = 0.64. The foreground reddening to M 31 is E (B V) = 0.07, but most of the reddening of OB stars in M 31 is due to extinction within the disk of M 31 (van den Bergh 2000). Four OB associations away from the minor axis were found to have V) = 0:12 0:24 by Massey et al. (1986). The reddening across M 31 is quite Ε(B patchy, and A 30's location is near the m inor axis where inclination e ects will result in a larger amount of dust through the line of sight, so the value E (B V) = 0:64 seems quite reasonable. We derive an absolute visual magnitude of  $M_V = 89$ . This may be compared to P Cyqni's absolute visual magnitude, M = 8:3 (Lamers et al. 1983). If the e ective tem peratures (and hence bolom etric corrections) are similar as well, as is implied by the strong spectral similarities, we can scale P C yqni's bolom etric lum inosity by 0.6 m ag as well, and expect that our star has  $L=L = 10^{61}$ . In Fig. 4 we show the location of the star in the H-R diagram along with the evolutionary tracks for z=0.04 (corresponding to the metallicity of M 31's H II regions according to Zaritsky et al. 1994) from Meynet & M aeder (2005). A coording to their calculations, an object in this part of the H-R diagram would be spectroscopically identied as a late-type W N (W NL) W olfR ayet star, and should never undergo an LBV phase as such. However, Andre Maeder (private communication) em phasizes that since their calculations are hydrostatic one can not really tell what stage a star is in (LBV vs W N L) from the models, as the dierence between the two may be prim arily one of atm ospheric extent. The starm ay be at a transition point, and m ay evolve to the WNL stage after episodes of mass loss. There are hints in the spectra that the star is nitrogen-rich (Fig. 1), as is P Cygni and many other LBVs (W alborn 1989); a better spectrum is needed for modeling the CNO abundances, and such work is planned.

## 3. Sum m ary and D iscussion

The LGGS project has obtained photom etry of > 350,000 stars seen towards M 31.0 ne of the brightest of these, LGGS 004341.84+ 411112.0, turns out to have a spectrum that is remarkably similar to that of the P Cygni, one of the best studied LBVs in the M ilky W ay. The star has been relatively constant in B over the past 40 years, with variations < 0.2 m ag, but with evidence of variations of 0.05 m ag during a year. M uch the same can be said for P Cygni (Israelian & de G root 1999). However, the star has likely had an outburst two m illennia ago, as judged by the fact that the star is slightly extended H ST in ages, indicative of a 0.5 pc nebula, similar to the 0.2 pc nebula seen around P Cygni. This has consequences for interpreting the nature of objects found with spectroscopic similarity to other known LBV s; these stars are considered LBV \candidates" until variability is established, but the present study emphasizes that this may require m ore than a lifetim e.

If we assume that the spectral similarity of our star to that of P Cygni is indicative of a similar elective temperature (and hence intrinsic color and bolom etric correction), we can place the star on the H-R diagram using our photom etry. The star falls on the evolutionary track for a 85M star at the extrem e end its evolution to cooler temperature, just as the evolutionary tracks turns to lower lum inosity (M eynet & M aeder 2005). The star is likely in a transition between an O star and a W NL. This provides strong vindication of the current generation of stellar evolutionary m odels that include rotation, but it also notes the di culties in interpreting the evolution phases in plied by the m odels. An atm ospheric analysis of the star is planned, and long-term follow-up (both photom etric and spectroscopic) is warranted.
