Interstellar Extinction Law in the J;H , and K $_{\rm S}$ B ands tow ard the G alactic C enter

ABSTRACT

We have determ ined the ratios of total to selective extinction in the nearinfrared bands (J;H;K_S) toward the Galactic center from the observations of the region jlj. 2:0 and 0:5. jbj. 1:0 with the IRSF telescope and the SIR IUS camera. Using the positions of red clump stars in color-magnitude diagram s as a tracer of the extinction and reddening, we determ ine the average of the ratios of total to selective extinction to be $A_{K_S}=E_{H K_S}=1:44$ 0:01, $A_{K_S}=E_{J K_S}=$ 0:494 0:006, and $A_H=E_{J H}=1:42$ 0:02, which are significantly smaller than those obtained in previous studies. From these ratios, we estimate that A_J : $A_H:A_{K_S}=1:0:573$ 0:009:0:331 0:004 and $E_{J H}=E_{H K_S}=1:72$ 0:04, and we nd that the power law A / $^{1:99 0:02}$ is a good approximation over these wavelengths. Moreover, we nd a small variation in $A_{K_S}=E_{H K_S}$ across our survey. This suggests that the infrared extinction law changes from one line of sight to another, and the so-called \universality" does not necessarily hold in the infrared wavelengths.

1. Introduction

The wavelength dependence of interstellar extinction is not only in portant inform ation for understanding the nature of interstellar dust grains but an essential ingredient in recovering the intrinsic properties of reddened objects. Change in the interstellar extinction law a ects many published conclusions based on the observations of heavily reddened objects, such as photom etric distances, the selection of young stellar objects in color-color diagram s, and the age determ ination of clusters from comparison with isochrones. Since the G alactic center (G C) region is not observable at visible wavelengths due to large interstellar extinction, observations and a precise extinction law at infrared wavelengths are required for the study of objects in the G C. However, accurate determ ination of the absolute extinction A is not easy in the infrared.

The most widely used technique to obtain the interstellar extinction law is the colordi erence (CD) method, in which the extinction curves are determined in the form of the ratios of color excesses E $_1$ =E $_2$ $_1$ as a function of 1 . Here E_{B V} ($_1$ = V and $_2$ = B) is custom arily used as a standard normalization. The absolute extinction A can be derived from the ratios of color excesses, only if the ratio of total to selective extinction R_V = A_V=E_{B V} is evaluated. While the ratio of color excesses is easily observed and thus determined precisely, R_V cannot be evaluated directly from observed data; R_V can only be deduced by the extrapolation of the extinction curve to 1 = 0 with reference to som em odel (e.g., van de Hulst 1946) for its behavior at wavelengths beyond the range. The intercept of the extinction curve in the E $_V$ =E_{B V} versus 1 diagram is R_V because

In this diagram, then, the total extinction (norm alized by $E_{B~V}$) at each wavelength is obtained as the vertical distance $A = E_{B~V}$ of each data point from the level of R_V through the relation

Unfortunately, the extrapolation has uncertainty due to (1) the contam ination by dust em ission and (2) the possible existence of neutral extinction by grains much larger than the wavelength of observation. The total extinction value A is derived as the di erence between the two terms on the right-hand side¹ of eq. [2]. Since the value of eq. [2] is sm all in

the infrared, even a small change in R_V can have significant in using on the value. Therefore, the accurate determination of A is discult in the infrared.

Red clump (RC) stars in the Galactic bulge have recently been used to study the extinction law (W ozniak & Stanek 1996), resulting in a precise determ ination of the ratio of total to selective extinction R (U dalski 2003; Sum i 2004). RC stars are the equivalent of the horizontal branch stars for a m etal-rich population, and they have narrow distributions in lum inosity and color with weak dependence on m etallicity. In addition, distances to RC stars in the Galactic bulge can be regarded as the same. They thus occupy a distinct region in the color-m agnitude diagram (CMD), and can be used as standard candles at an equal distance; they are located in a straight line with a slope of $R = A = E_{0}$, in accordance with the variable extinction to each of them. We refer to this as the \RC m ethod". The RC m ethod is based on the \variable extinction m ethod" (K relow ski & Papaj1993) or the \cluster m ethod" (M ihalas & B inney 1981).

In the cluster method, we expect the di erence between the observed and absolute magnitudes to be the same for every cluster star except for di erences produced by variations in the amount of interstellar extinction along the line of sight to each star (M ihalas & B inney 1981). Therefore, photom etry and the determ ination of the spectral type of each star is necessary to derive the slope $R = A = E \circ$. Here the amount of interstellar extinction is di erent, but the interstellar extinction law, and furtherm ore the property of interstellar dust, is assumed to be identical between the lines of sight. In the real world, we should note that the extinction A might be nothing but an average of possibly variant extinction due to variant dust grains integrated over the whole line of sight.

In the RC m ethod, while this assumption is similarly applied, we select RC star candidates from the CMD and do not have to perform spectroscopy. We can obtain R directly from the observed data, and therefore R can be much more reliable than that obtained by the extrapolation of the extinction curve in the CD m ethod. The reliable R provides the absolute extinction A which is exactly what we want to know. W hile visible observations of RC stars are restricted to a few windows of low extinction, we can observe highly reddened RC stars at elds very close to the GC in the infrared. Thus, we can use the RC stars near the GC to determ ine the infrared extinction law very accurately and compare the results with the past determ inations for the GC and other lines of sight.

In this paper, we have determ ined the ratios of total to selective extinction $A_{K_s} = E_{H_{K_s}}$, $A_{K_s} = E_{J_{K_s}}$, and $A_H = E_{J_{H_s}}$, and the ratio of absolute extinction $A_J : A_H : A_{K_s}$, by adopting the RC method to investigate the extinction law toward the G alactic center.

2. Observations

O ur observations were obtained in 2002 M arch July, and 2003 April August using the near-infrared camera SIR IUS (Simultaneous Infrared Imager for Unbiased Survey; Nagashim a et al. 1999; Nagayam a et al. 2003) on the IR SF (Infrared Survey Facility) telescope. IR SF is a 1.4m telescope constructed and operated by Nagoya University and SAAO (South A frican A stronom ical Observatory) at Sutherland, South A frica. The SIR IUS camera can provide J (1:25 m), H (1:63 m), and K $_{\rm S}$ (2:14 m) images simultaneously, with a eld of view of 7? 7?7 and a pixel scale of 0.45.

O ver the period 2002–2003, about 800 3 (J;H;K_s) in ages were obtained over jlj. 2:0 and jb j. 1:0 (see Fig1). Our observations were obtained only on photom etric nights, and the typical seeing was 1^{02} FW HM in the J band. A single in age com prises 10 dithered 5 s exposures.

3. Reduction and Analysis

D ata reduction was carried out with the IRAF (Im aging Reduction and Analysis Facility)² software package. Im ages were pre-reduced following the standard procedures of near-infrared arrays (dark fram e subtraction, at-elding, and sky subtraction). Photom – etry, including point-spread function (PSF) tting, was carried out with the DAOPHOT package (Stetson 1987). We used the daofind task to identify point sources, and the sources were then input for PSF – tting photom etry to the allstar task. About 20 sources were used to construct the PSF for each im age.

Each in age was calibrated with the standard star # 9172 (Persson et al. 1998), which was observed every hour in 2002 and every half-hour in 2003. We assumed that # 9172 has J = 12.48, H = 12.12, and $K_s = 12.03$ in the IRSF/SIRIUS system. The average of the zero-point uncertainties was about 0.03 m ag in the three bands. The averages of the 10 limiting m agnitudes were J = 17.1, H = 16.6, and $K_s = 15.6$.

To measure the ratios of total to selective extinction $A_{K_s} = E_{H_{K_s}}$, $A_{K_s} = E_{J_{K_s}}$, and $A_H = E_{J_H}$, we selected the bulge RC stars, which constitute a compact and well-de ned clump in a CMD. Their mean magnitude and color are thus good references, and we apply the method developed in the V and I bands by U dalski (2003) and Sum i (2004).

As a rst step we divide each eld into four sub-elds of 4^0 4^0 on the sky. Then we construct K_S versus H K_S, K_S versus J K_S, and H versus J H CMDs. Second, we extract stars in the region of CMDs dom inated by RC stars (the rectangular region of the CMD in Fig. 2), and the extracted stars are used to make magnitude (lum inosity function: Fig. 2, upper right) and color (Fig. 2, lower left) histogram s. These histogram s have clear peaks that can be tted with a Gaussian function (thick curves in Fig. 2 histogram s).

Due to highly nonuniform interstellar extinction over the area surveyed, the RC peaks in CMDs shift from one sight line to another. The peaks shift in the range 13:4 . K_s . 14:6 and 0:4 . H K_s . 12, and therefore we have to shift the region to extract RC stars from sub-eld to sub-eld. Since the mean J, H, and K_s magnitudes of RC stars become too faint in highly reddened elds, estimates of the peak magnitudes and the colors of RC stars can be unreliable in such elds. To avoid this problem, we use only the sub-elds in which the peak magnitude of RC stars is more than 1 m ag brighter than the 10 limiting magnitudes (Fig.1, hatched squares). In addition, we con rm ed the completeness to be 85%

4. Results

Fig. 3 shows the location of the RC m agnitude and color peaks in the K_S versus H K_S (upper left), K_S versus J K_S (upper right), and H versus J H (lower) CM D s. Error bars include uncertainties in the RC peak and the photom etric calibration. Solid lines are least-squares ts to the data. If the variations of the RC m agnitudes and colors are due to the interstellar extinction, the ratios $A_{K_S}=E_{H-K_S}$, $A_{K_S}=E_{J-K_S}$, and $A_H=E_{J-H}$ can be directly determ ined by the slopes of the tting lines. Thus, we obtain $A_{K_S}=E_{H-K_S}=1:44$ 0:01, $A_{K_S}=E_{J-K_S}=0:494$ 0:006, and $A_H=E_{J-H}=1:42$ 0:02.

 $A_{K_s}=E_{H-K_s}, A_{K_s}=E_{J-K_s}$, and $A_H=E_{J-H}$ provide us with the ratios of absolute extinction, $A_{K_s}=A_H, A_{K_s}=A_J$, and $A_H=A_J$, by which we obtain $A_J:A_H:A_{K_s}=1:0.573 \quad 0.009:$ 0:331 0:004. Here $A_H=A_J=0.573$ is the weighted mean of that derived by $A_H=E_{J-H}$ and that derived by $A_{K_s}=E_{H-K_s}$ and $A_{K_s}=E_{J-K_s}$ [i.e., from $(A_{K_s}=A_J)=(A_{K_s}=A_H)$]. Using the ratios $A_H=E_{J-H}=1:42$ 0:02 and $A_H=E_{H-K_s}=2:43$ 0:01, in turn, we can determ ine the most frequently quoted \near-infrared extinction law", the ratio $E_{J-H}=E_{H-K_s}$ to be 1:71 0:02. When we plot the observed peaks of RC stars in the J H versus H K_s color-color diagram, the slope of peak distribution $E_{J-H}=E_{H-K_s}=1:72$ 0:04 (Fig 4) is consistent with this ratio.

To exam ine the variation of the extinction law we divide the survey region into four sub-regions, N+ (+2 > 1 > 0;+1 > b > 0), S+ (+2 > 1 > 0;0 > b > 1), N (0 > 1 > 2;+1 > b > 0), and S (0 > 1 > 2;0 > b > 1). The CMDs of the divided regions are shown in Fig. 5. The $A_{K_s} = E_{H-K_s}$ ratios for N+, S+, N , and S are 1.46 0.02, 1.45 0.02, 1.34 0.02, and 1.51 0.03, respectively. We can see a sm all but clear di erence from one line of sight to another. As discussed in x5.3, the extinction curve can be approximated by a power-law A / . Then the power-law exponents for N+, S+, N , and S are 1.96, 1.97, 2.09, and 1.91, respectively. The low num bers of data points in CMDs of K_s versus J K_s and H versus J H create uncertainties that are too large to detect variations of sim ilar size to those found in $A_{K_s} = E_{H-K_s}$.

5. D iscussion

5.1. Possible Errors in R

An advantage of the RC method is the large number of RC stars, which makes their mean magnitude determination straightforward and precise. RC stars are also numerous in the solar neighborhood. A lives (2000) derived the average K band luminosity of 238 H ipparcos RC stars, $M_{\rm K} = 1:61 \, 0.01$, and their precise calibration is possible.

Population e ects on the intrinsic magnitude and color of RC stars are the main error sources of the method. It is known that their brightness depends on their metallicity; how – ever, the dependence is very weak (. 0.05 mag / [M / H]; Salaris & G irardi 2002). To change the slope that we obtain, the metallicity distribution of RC stars in the bulge would have to be highly correlated with the extinction. M oreover, no metallicity gradient has been found in jlj. 4 (Frogelet al. 1999; Ram irez et al. 2000).

A nother error source is the variation of distance to RC stars, changing their mean magnitude by 0.05 m ag along the G alactic longitude in the current observation range (N ishiyam a et al. 2005). This difference can change the slope $A_{K_s} = E_{H_{K_s}}$ of 1.44 [K s= (H K s) = 1.37/0.95, see the K s vs. H K s CMD in Fig. 3] to 1.49 (= 1.42/0.95). The change is only 0.05, even if the distance is completely correlated with the extinction, which is very unlikely. Therefore we conclude that the variation of the metallicity and distance does not a ect our results.

The change in the extinction law, as shown in Fig. 5, suggests that within a single eld, there may also be similar variations that would produce a selection bias in the results. To estim ate the size of such bias, we divide the data points plotted in the K $_{\rm S}$ versus H Ks CMD into two groups: those having a counterpart in the K_s versus J K_s CMD (bluer sources) and those without one (redder sources). The form er has a color distribution 0:4. K $_{\rm S}$. 0:7 and a slope A $_{\rm K_S}$ =E $_{\rm H}$ $_{\rm K_S}$ = 1:46, and the latter has 0:5 . H $K_{\rm S}$. 12 and Н $A_{K_s} = E_{H_{K_s}} = 1.43$. Thism eans that the selection bias due to the extinction, which probably re ects the distribution of sources along the lines of sight, produces an uncertainty of only a few per cent in our results. This small uncertainty is also con m ed by the consistency 1:7 derived by the distribution of RC stars in the color-color (E_{JH} vs. ofE_{JH} =E_{HKS} E_{H} K_s) diagram (Fig. 4) and derived by the product of A_{H} = E_{JH} and A_{H} = E_{H} K_s. Note that the sources whose J m agnitudes have been determ ined form a sm all sub-group.

The \mathbb{R} SF/SIR IUS system is similar to the MKO system (Tokunaga et al. 2002), and the e ective wavelengths following equation (A3) of Tokunaga & Vacca (2005) are calculated for a typical bulge RC starwhen it su ers extinction of A_{K_s} 0:4 1:6 (the range of extinction in Fig. 3). We have employed a model of K unicz (1993) with the parameters of $T_e = 4750$ K, [M = H] = 0.1 dex, and $\log g = 2.0$, and a power-law extinction curve (see x5.3). The elective wavelengths change by 0.01 m to the longer wavelengths as the star sulers more extinction, and the mean elective wavelengths of the J, H, and K_s liters are 1.25, 1.64, and 2.14 m, respectively. The changes are small, and these wavelengths are not very sensitive to the source spectral energy distribution, and we thus conclude that the elective wavelengths can be uniquely de ned for our study.

5.2. Comparison with Previous CD M ethod Studies

P revious results in the literature are listed for comparison in Table 1.0 ur results show a clear di erence from those obtained in previous work. The ratios of total to selective extinction determined in this study are smaller, which corresponds to faster decrease in the absolute extinction A when the wavelength increases. Therefore, the resulting power-law index is larger in this study.

The theoretical curve No. 15 of van de Hulst (1946, hereafter vdH) based on the M ie scattering theory has been used to estim ate the wavelength dependence and is still favored by several authors (e.g., G lass 1999; Jiang et al. 2003). Our results are the closest in agreem ent to vdH.

Rieke & Lebofsky (1985, hereafter R & L) determined the near-infrared extinction law by applying the CD m ethod to their observations of ve supergiants near the GC and o S ∞ . Their results have quite often been referred to as the standard extinction law, especially toward the GC, so let us examine them. Their observations were made in the K band, not K_s, but we can use results of Cardelli et al. (1989, hereafter CCM 89) derived by the analytic formula of the average extinction law for 0:9 m 3:3 m by thing the data of R&L with a power law. Since the CD method requires the ratio of total to selective extinction, R & L set $E_{V K} = E_{B V} = 2.744$ and assumed $R_{V} = A_{V} = E_{B V} = 3.09$ for the GC sources to evaluate A = E_{BV} and A = A_{V} . While their assumption of R_{V} is reasonable, a small change in R_V results in a large di erence in $A = E_B_V$ at near-infrared wavelengths (see eq. [2]). If R_V toward the GC is $R_V = 3.00$, which is smaller by only 0.09 than that in R&L, we obtain the ratio $A_J = A_V$: $A_H = A_V$: $A_K = A_V = 0.260 : 0.150 : 0.085$ with their $E_V = E_B_V$. These ratios are in fact similar to the ratios shown by vdH, $A_J = A_V$: $A_H = A_V$: $A_{K} = A_{V} = 0.245 : 0.142 : 0.081$. Although the lower limit of R_{V} in R & L was determined by the extinction at L, M , 8 m , and 13 m , the observations at these wavelengths have relatively large uncertainties. W e also note that the extinction law that they derived in the wavelength range L, M, and 8 m is inconsistent with those obtained toward the GC, in

particular by spectroscopy with the Infrared Space Observatory (ISO) for 2:4 m (Lutz et al. 1996; Lutz 1999, see x5.3). Therefore, although the inconsistency m ight be the result of spatial variation of the extinction law examined in the previous section, it is also quite possible that the inconsistency was caused by the uncertainty of R_V in the CD m ethod.

Indebetouw et al. (2005) derived A = A_{K_s} by the CD m ethod, using data of the Spitzer Space Telescope (SST) and Two M icron All Sky Survey (2MASS) along two lines of sight (l= 42 and 284) in the Galactic plane. They observed RC stars and determ ined A = A_{K_s} for 1.25 m 8:0 m. They measured color excess ratios E $_{K_s}$ = E_{J,K_s} by tting the locus of RC stars in color-color diagram s. To derive A = A_{K_s} from E $_{K_s}$ = E_{J,K_s} , they rst determ ined A $_J$ = A_{K_s} by tting the RC locus in a CMD. Since the elds of l= 42 and 284 are dom inated by the disk stars, which are located at di erent distances from us, they assumed that the extinction per unit distance is constant to t the RC locus. Their results are also di erent from ours. We notice, how ever, that the intercept of E $_{K_s}$ = $E_{J,K}$ at $^1 = 0$ in

their Fig. 5 seems to be larger (less negative) than their result obtained by thing the RC locus in CMD $A_{K_s} = E_{JK} = 0.67$, but rather close to our result 0.494. A lineagh the data of the SST have the potential to establish the extinction law for 3.55 m 8.0 m, the uncertainty of $A_J = A_{K_s}$ a ects $A = A_{K_s}$ at these wavelengths, and thus the determination of $A_J = A_{K_s}$ should be approached cautiously.

5.3. Power-Law Extinction in the Infrared

It is frequently remarked that the continuous extinction curve between 0.9 and 5 m can be approximated by a power-law A / (D raine 2003). However, the power-law tting has been based on the CD m ethod, and is not free from the oset errors of eq. [1]. In contrast, without any a priori assumptions about the extrapolation to the longer wavelengths, our new results are tted very well by the function with = 1.99 0.02 (see the three data points that are very well aligned in Fig. 6). Here we have used the mean elective wavelengths of the J, H, and K_S Iters determined in x5.1. This good t presents, for the rst time, direct evidence for the power-law approximation in the wavelength range of 1.2 2.2 m.

This corroborates the m ethod of determ ining the absolute extinction on the assumption of a power law in the near-infrared without resorting to the CD m ethod. This wavelength range has no absorption features so far identi ed in either the di use orm olecular interstellar m edium. Therefore, we proceed with the power-law approximation, which is expressed by a straight line in a logarithm ic graph like F ig. 6, and compare the index in the m easurem ents in the literature. This also m itigates the di erence between various photom etric system s used in the near-infrared, whose problem s have been pointed out by K enyon et al. (1998).

He et al. (1995) m ade photom etry of 154 obscured OB stars in the southern M ilky W ay. They basically employed the CD m ethod but derived the absolute extinction also, on the assumption that the interstellar extinction follows a power-law. A lthough their observation shows considerable scatter (as suggested by their Fig. 9; also see their Fig. 10), the average extinction is clearly di erent from our results (Table 1).

A lso on the assumption of power-law extinction, M oore et al. (2005) determ ined the power-law index toward a set of nine ultracom pact H II regions and two planetary nebulae with 0.27 . (Br) . 4:7. Their observations of hydrogen recombination lines at 1.0 m . 2.2 m showed that the power-law index varies from 1.1 to 2.0 and a clear tendency that is smaller for higher extinction regions. They suggest that the atter near-infrared extinction laws might be the result of grain growth in the regions of higher extinction. The steep extinction law determ ined toward the GC in this study, then, might mean that the interstellar medium in its line of sight is largely di use. A steep index of 2 in the polarization, which is supposed to indicate the di erence of two orthogonal extinctions, of GC objects is also reported by N agata et al. (1994). A lthough it has been suggested that interstellar extinction remains relatively invariant (e.g., CCM 89) in the near-infrared region (& 0:7 m), these studies indicate clear variation in the extinction law .

At longer wavelengths, two sets of extinction determ ination from the emission line ratios using the Short W avelength Spectrom eter on board ISO have been reported toward the GC

(Lutz et al. 1996; Lutz 1999) and O rion (R osenthal et al. 2000). A lthough these two studies have assumed the absolute extinction values at some wavelengths and therefore are vulnerable to o set errors, the extinction law toward the GC seems to be clearly di erent from that of R osenthal et al. (2000), especially in the range 2.5 m . . . 8 m (Fig. 6). In the GC Lutz (1999) points out that the extinction becomes atterat & 2.5 m and lacks the pronounced m inimum near 7 m expected for the standard grain models; this atter slope or addition of another extinction component is also observed in the polarim etry of the GC objects at 2.8 4.2 m (N agata et al. 1994). Our extinction law, which has steeper exponents in the wavelength range of 1.2 2.2 m, and other studies discussed above lead to the conclusion that the extinction law varies from one line of sight to another even in the near-infrared wavelength range.

6. Conclusion

The ratios of total to selective extinction $A_{K_s}=E_{H-K_s} = 1:44 = 0:01$, $A_{K_s}=E_{J-K_s} = 0:494 = 0:006$, and $A_H=E_{J-H} = 1:42 = 0:02$ have been directly obtained toward the Galactic center from the observation of bulge red clump stars. Then the ratio of absolute extinction $A_J:A_H:A_{K_s} = 1:0:573 = 0:009:0:331 = 0:004$ is obtained, and the power law approxim ation $A_J = 1:99$ is shown to be good enough in the wavelength range of 1:2:22 m. These values are clearly different from those obtained in previous studies toward the Galactic center and other lines of sight. The previous extrapolation procedures m ight have caused the difference, although the observed color excesses in the literature can be consistent with the current results. Furtherm ore, sm all variations in the ratio of total to selective extinction do exist am ong the sub-regions in the current study. This indicates that, contrary to the widely accepted ideas, the extinction law is not \universal" even in the infrared, and therefore one should be extrem ely cautious about applying reddening corrections.
