The association between gas and galaxies I:CFHT spectroscopy and pair analysis

ABSTRACT

W e investigate the relative distribution of the gaseous contents of the Universe (as traced by a sample of Lym an (Ly-) absorbers), and the lum inous baryonic matter (as traced by a redshift survey of galaxies in the same volume searched for Ly- absorbers), along 16 lines-of-sight (LOS) between redshifts 0 and 1.0 ur galaxy redshift survey was made with the Multi-Object Spectrograph (MOS) on Canada-France-Hawaii Telescope (CFHT) and, when combined with galaxies from the literature in the same LOS, gives us a galaxy sample of 636 ob jects. By combining this with an absorption line sample of 406 absorbing systems drawn from published works, we are able to study the relationship between gas and galaxies over the latter half of the age of the Universe. A correlation between absorbers and galaxies is detected out to separation of 1.5 M pc. This correlation is weaker than the galaxy-galaxy correlation. There is also some evidence that the absorbing systems seen in CIV are more closely related to galaxies, although this correlation could be with column density rather than m etallicity. The above results are all consistent with the absorbing gas and the galaxies co-existing in dark matter laments and knots as predicted by current models where the colum n density of the absorbing gas is correlated with the underlying m atter density.

1 IN TRODUCTION

This paper is part of our e orts to provide constraints and m easurem ents of the relationship between the distribution of the gaseous contents of the U niverse as traced by neutral Hydrogen and the lum inous baryonic mater as traced by galaxies.

The manner in which gas collapses gravitationally into dark matter potential wells to form stars (and hence galaxies), and the way in which these stars then a left the gas is a topic of great interest at present. This is being pursued both observationally and theoretically at redshifts from 7 to zero (i.e. when the universe was approximately 5% of its current age, to the present day). In this paper we investigate this process observationally during the second half of the evolution of the universe. There is a continuing debate about the relationship between low redshift Lym an (Ly-) absorbers and galaxies, where here 'low redshift' is taken to mean redshifts less than 1. A simpli ed (strawm an) version of the two sides is (a) that all low redshift Ly- absorbers are part of physicallydistinct lum inous-galaxy halos, or (b) that they are all part of the lam entary structure seen in recent SP H /M esh structure form ation m odels, and are only related to galaxies by the fact that both are following the underlying dark m atter distribution. In practice, alm ost all authors acknow ledge that the universe includes a mix of the above two populations (and indeed others), and the debate is m ore about which population dom inates a particular set of observations.

Regardless of whether either hypothesis is correct, we emphasize that even if one (naively) believes a clear answer can be obtained (either (a) or (b) above), this answer will be a function of the neutral H ydrogen colum n density of the absorbers. For N_{H I}> 10^{21} cm², one is probing a colum n density of m aterial com parable to that of the disk of our galaxy, and hence all galaxies, to varying degrees, should be expected to contribute to the population of such absorbers. At colum n densities N_{H I} 10^{12} cm², one is getting close to the neutral hydrogen content of the expected uctuations within voids, and we expect that a m ore heterogeneous set of causes could produce such absorption.

The increasingly sophisticated models of galaxy form ation and evolution now available (see references above) suggest that if we could make a perfect census of the gaseous and lum inous constituents of a large volum e of the low redshift Universe, we would nd that both the gas (quasar absorption line system s) and stars (galaxies) trace the same fundam ental structures (whose course of form ation and distribution was set by the early perturbations of the distribution of dark matter in the Universe). These same models, however, also indicate that a wide range of detailed relationships between the gas and galaxies should be observed. The details of the structures will depend on an equally wide range of interesting astrophysics, including the process of star form ation and \galaxy feedback" and we hope that the approach of this paper can lead to a better understanding of this astrophysics.

Observationally comparing the distribution of galaxies and quasar absorption line systems shows some of the com -

plexity of the phenom ena at work. This can be illustrated by considering Figure 1. In this gure we show an in age of the lines-of-sight (LOS) towards the QSO sLBQS 0107-025A and B.As discussed later in the paper, for this eld we have sam ples of galaxies and Ly- absorption line system swhose locations in this com m on volume of space can be com pared. In the gure we have selectively labelled illustrative cases of associated' galaxies and absorption lines. For two of the galaxies labelled with a redshift, arrows indicate where there is a detected absorption line in both of the QSO spectra. For those absorber-galaxy pairs, the projected spatial separation and velocity di erence between the galaxy and the absorber are also provided.

W e consider a few of these cases below :

(i) A bright, multi-component object lies between the two Q SOs at a redshift of 0.2272. There is absorbing gas seen at nearly this same redshift in both Q SO LOS, and in one of them, C IV absorption is also detected. This then could potentially be interpreted as a straightforward case of a large gaseous halo around a bright galaxy. The complex morphology of the galaxy could indicate an ongoing merger.

(ii) At a distance of 350 kpc to the south and east of the two QSO LOS is another bright morphologically-complex galaxy at a redshift of 0.1145. This galaxy is also close in velocity to absorption seen in both LOS. It is instructive though to compare the small visible extent of the stars in the (large) galaxy with the distance to the two QSO LOS. Smooth, undisturbed gaseous halos of this size seem improbable, although it is one of the goals of this paper to investigate this statistically.

(iii) Generally to the north of the twoQSOs are a collection of 5 galaxies marked with redshifts near 0.20. All 5 of these galaxies are within 500 km s¹ (and also within a projected distance of 500 kpc) of an absorber seen in the LOS to LBQS 0107-025B.No absorption is detected in the other QSO LOS.This collection illustrates the common di culty of picking out one individual galaxy to the to one absorber. A lthough there is indeed a single 'closest' galaxy, it seems rather arbitrary to claim that it is the sole cause of any absorption.

(iv) F inally, a collection of six galaxies, all within 500 km s¹ of each other at a redshift around 0.24 are m arked surrounding the LOS to LBQS 0107-025A. D espite their proximity to the LOS, and the case above where a group of galaxies can be associated with an absorber, no absorption is seen at this redshift in either of the two QSO LOS.W hile one could speculate that low column density absorbers might be fragile entities that are destroyed in a dense environment, there is no good independent evidence at present that this galaxy 'group' has crossed such a threshold.

These examples demonstrate the great variety of appearances the underlying relationship between the absorbers and galaxies presents, along even one LOS. This richness should be kept in mind when interpreting the results derived from the ensemble of data we consider in this paper.

The outline of the paper is as follows: in x 2 we describe the various data sets used in this paper. In x 3 we analyse the data, and in x 4 we present our conclusions.

2 DATA

Our observational program would ideally be designed to allow a statistical com parison between the absorption gas detected in Hubble Space Telescope (HST) UV spectroscopy between redshifts of 0 and 1 and the galaxies within a cylindrical region at least 3 M pc^{1} in radial extent away from the QSO Line of Sight (LOS). In practice, what we achieved was an absorption line sample taken from the HST Quasar Absorption Line Survey (Bahcall et al. 1993, 1996; Jannuzi et al. 1998), an HST Key Project during cycles 1-4, with varying redshift coverage, and galaxy sam ples from a variety of observatories. The main one reported here was obtained using the Multi-Object Spectrograph (MOS) at the Canada-France-Hawaii Telescope (CFHT). Som e additional galaxy redshifts have been obtained using the COSM IC spectrograph at Palom ar, and gleaned from the literature. W e are in the process of supplem enting this data set with additional observations using other facilities. A lthough we do not claim that any of these galaxy sam ples are 'com plete', we have endeavoured to ensure that they all com e with known selection functions, allowing a statistical analysis to be performed. Completeness in this context would be rather an illusory concept, as there will always be weaker lines and less lum inous or lower surface brightness galaxies that are m issed by any survey. This point has been made by many authors including Linder (1998, 2000) and Rosenberg et al. (2003).

2.1 Sample de nition

The elds observed with MOS on the CFHT were chosen to include Key Project QSOs (Jannuzi et al. 1998) with QSO redshift greater than 0.5 and Faint Object Spectrograph (FOS) higher dispersion spectroscopy covering from redshift 0.34 to 1 (i.e., FOS gratings G 190H and G 270H). W hile UV spectroscopy down to z=0 is obviously desirable (and has been obtained with the HST along a lim ited num ber of sight lines) the KP LOS including coverage to z=0(observations made with the FOS G130H grating) are of QSOswith redshifts too low for e cient CFHT MOS follow up. In Table 1 we list the Q SO s selected. The columns include the Q SO RA, Dec, redshift and V band m agnitude, followed by the date of the HST UV spectroscopy for the 3 FOS gratings used in this paper, followed by the num ber of CFHT MOS masks observed (see x 2.4) and the date of the MOS observation.

There is one additional eld observed as part of the CFHT MOS sample which was not part of the HST Key Project.HST UV spectra of the QSO pair LBQS 0107-025A and LBQS 0107-025B were studied by D inshaw et al. (1995), D inshaw et al. (1997) and Young et al. (2001). This LOS was included in the CFHT MOS target list because of the presence of two QSO sbright enough for reasonable S/N HST UV spectroscopy within the MOS eld of view. An analysis taking full advantage of this will be perform ed in a later paper, but for the present paper we generally use them as two beparate' LOS.W e have checked whether rem oving one of the LBQS 0107-025 QSOs from the sample makes any signi cant di erence to our num erical results or conclusions, and have found that it does not.

2.2 HST Quasar Absorption Line Sam ple

The complete list of selection criteria for the KP quasars is discussed in section 2.1 of Jannuzi et al. (1998). W e review here only the criteria used by the KP that might produce a bias for our study. First is their practical decision to select targets with bright V-band magnitudes and well determ ined redshifts in order for their targets to have predictable UV lum inosities that, in the absence of high colum n density absorption systems along the LOS, would enable a high signal-to-noise ratio UV spectrum to be obtained in a modest exposure time with HST. A sample biased toward objects bright in V-band apparent magnitude might be more inclined to include lensed quasars, i.e. objects with a foreground over-density along the LOS. In practice, the redshifts of the quasars included in the KP are low, and therefore less likely to be lensed. Second, a subset of the quasars included in the KP sample were not random ly selected, but were chosen for a GTO program of J. Bahcall because they were behind foreground objects whose absorption properties were to be investigated. These include AGN like M arkarian 205 (with the galaxy NGC 4319 very close to the LOS to M kn 205, producing absorption in the spectrum of the background AGN; W eedm an (1970); Bahcall et al. (1992)) and 3C 232 (with the galaxy NGC 3067 in the foreground). Of the objects we selected from the KP catalogues for observation with CFHT, only NAB 0024+22 was not a random ly selected target by the KP. This quasar was part of the GTO program of Bahcall and was selected because it

was discovered as part of a search for quasars with LOS near a cluster of galaxies (Bahcall et al. 1973). A bell 31, with a redshift of 0.160, is along the LOS to this quasar. The cluster redshift is sm aller than the range we investigate along this LOS.

W e had two additional criteria for selecting our sam ple for the CFHT observations. The elds needed to be observable during our scheduled CFHT observing runs. W e chose to focus on LOS with quasars with redshifts greater than 0.5, in order to maxim ize the e ciency of our redshift galaxy survey.

With the previously mentioned exception of LBQS 0107 025A and B, the sample of absorption lines we use is drawn from the KP catalogue papers, Bahcall et al. (1993), Bahcall et al. (1996), and Jannuzi et al. (1998). The KP Ly- absorption line catalogue was constructed to include all features with a signi cance level greater than 4.5 (as de ned and discussed by Schneider et al. (1993)). This corresponds to a variable equivalent width limit along each LOS. Plots showing these equivalent width limits as a function of wavelength are given in Figure 2 of Jannuzi et al. (1998). W ith the modest spectral resolution of the FOS (R = 1300; approximately)230 km s¹), the Ly- absorption features were generally unresolved and conversion from the observed equivalent width to colum n density in neutral hydrogen must be done with some assumption about the Doppler-b parameter for the lines. For the subset of lines that were broader than the instrum ental pro le, their width probably indicates the blending of multiple absorption features, and not a line pro le that can be t to deduce the column density of the absorber.W e note that approxim ately 10% of the detected Key Project Ly- absorbers were in fact resolved, and, as noted by Jannuzi et al. (1998), are a sign of possible clustering of absorbers on these velocity scales. This results in an additional contribution to the uncertainty in the derived column densities.

For LBQS 0107 025A and B we have chosen to use the line lists from Young et al. (2001), supplemented with lines from the GHRS observations of D inshaw et al. (1997). (In detail this meant adopting the lines from Table 5 of D inshaw et al. (1997), and Tables 3 and 5 of Young et al. (2001) for LBQS 0107 025A, and from Table 5 of D inshaw et al. (1997), and Tables 4 and 6 of Young et al. (2001) for LBQS 0107 025B.) We shifted the wavelengths of the D inshaw et al. (1997) by -1.72A as recomm ended by Young et al. (2001).

W e want the subset of absorbers caused by intervening, rather than associated, absorption system s. W e follow W eym ann et al. (1998) and exclude any line from our sam ple with a di erence of less than 3,000 km s¹ from the system ic velocity of the quasar. N ote that while this is a traditional choice of velocity range for excluding associated system s, it will not exclude all associated system s. In particular, one of our quasars, PG 2302+029, includes at least one associated system with an ejection velocity of over 50,000 km s¹ (Jannuzi et al. (1996); Sabra et al. (2003); Jannuzi et al. 2006, in preparation). W e have excluded the broad system at z = 0.695 from the sam ple used in this paper.

All of the line lists we use have complete identi cations with the exception of the spectrum of PG 1718+481. The e ects of the incomplete identi cation of the PG 1718+481 absorbers are discussed in x 3.4, where it is shown they are negligable.

2.2.1 Comments on Individual Lines of Sight

D etailed notes about the HST FOS spectra along the individual LOS we are studying, and the resulting absorption line lists, are included in the KP catalogue papers and in Young et al. (2001) (for the LBQS 0107 025 LOS). Here we comment on the special properties of a few of the elds.

A spreviously m entioned, NAB 0024+ 22 was discovered during a search for quasars near or behind clusters of galaxies (Bahcall et al. 1973). A bell 31, with a redshift of 0.160, is foreground to the redshift range covered by the FOS spectroscopy (0.2950 to 1.0998). Intervening absorption line system s including absorption by C IV are at z = 0.4069, 0.4830, 0.8196, and 1.1102. The SNR of the KP spectrum of this quasar is not as high as the typically observed object, resulting in a sm aller sample of detected absorbers given the relatively long redshift path observed (z = 0.8). Bergeron & Boisse (1991) reported an emission line galaxy at z=0.791 in the LOS to PKS 2145+06, which was later identi ed as being associated with an extensive m etal line systems in the FOS UV spectrum obtained by the KP (Bergeron et al. 1994). This z=0.791 system is high enough column density to produce a Lym an limit system starting at 1633A, preventing the observation of Ly- absorption along this LOS below z 0.3.

2.3 Im aging

To compare the distribution of the galaxies along the same LOS that the FOS spectroscopy maps the gas distribution requires know ledge of the positions and redshifts of galaxies in the elds of our quasar sample. Im ages of the quasar

elds can provide the positions and m agnitudes of the galaxies. The spectroscopy that allows the determ ination of the galaxy redshifts requires the im aging catalogue as input for the design of multi-slit m asks.

For the CFHT MOS, the images used to generate the multi-slit mask designs are obtained during the same observing block as the spectroscopy (i.e., the instrum ent has not been removed from the telescope between the imaging and spectroscopy observations). Therefore we obtained images for our elds during our two observing runs. The im ages were reduced shortly after they were obtained and catalogues of galaxies generated to guide the design of the multi-slit masks. A fter the observing runs were completed, the images were re-reduced, the photom etry and astrom etry of the images calibrated, and nal catalogues were constructed. Since the main purpose of the scheduled observing time was to perform the spectroscopy, only R band in ages deep enough to detect the galaxies we wished to target for spectroscopy were obtained. It would be desirable to obtain im ages including additional band-passes and with enough photom etric standard observations to im prove the accuracy of our photom etry.

In the following subsections we describe the imaging observations, the astrom etric and photom etric calibration of the images, and the measurem ent of the galaxy positions and R band magnitudes in the elds of our targeted quasars.

2.3.1 Observing

W e had two observing runs with CFHT MOS (July 29 - August 1, 1995 UT and November 29 - December 3, 1997 UT). The date each eld was im aged is listed in Table 2. The instrum ent and telescope properties were signi cantly di erent during the two runs and we will describe the particulars by run.

D uring the 1995 observing run, the 29th of July UT was photom etric and 600 second R band exposures were obtained of six quasar elds. Two and 10 second exposures of the photom etric standard stars in the eld of NGC 7790 O dewahn et al. (1992) were also obtained to allow a photom etric zero-point to be determ ined for the in ages. Unfortunately, the proper ba es were left o of the telescope when MOS was installed on the telescope prior to our run. As a result, bright arcs of light, produced by stars outside of the FOV, cut across the in ages and e ectively increased the sky level over approxim ately one third of the FOV of the

in ages. The amount and distribution of the scattered light was, naturally, pointing dependent. The mixture of sharp and di use features in the scattered light made it di cult to completely remove during the processing of the images. This complicated the determ ination of the sky background around objects, and the subsequent generation of the galaxy catalogues necessary for the construction of the multi-slit masks. The two most strongly a ected in ages were those of LBQS 0107 025AB and PG 1718+481. To increase the area that could be mapped for galaxies, we obtained two additional images of each eld, each o set in position from the others, and combined the images of each eld after masking the regions with the worst scattered light in each of the exposures. The combined in ages allowed us to produce in proved m easurem ents of the galaxies in these elds, but there are still regions in each im age where we would not be able to detect galaxies and objects whose measured properties were strongly a ected by scattered light. The imaging on 30 and 31 July 1995 UT was not done under photom etric conditions, so the ux zero-point for the combined in age was set to m atch the im aging on the 29th. The CCD in MOS during this run was the Loral-3 with pixels of approxim ately $0.313^{\rm 00}$ in size and a gain of 1.9 electrons per ADU.

During the 1997 observing run, the 29th of N ovem – ber UT was photom etric and 600 second exposures of four quasar elds were obtained. Two and 10 second exposures of the photom etric standard stars in the eld of NGC 7790 were also obtained. The correct ba es were on the telescope. The nights of UT 26 N ov, 30 N ov, and 1 D ec, during which 600 second exposures of 5 additional quasar elds were obtained, were not photom etric. For two of the elds taken during these nights, two 600 exposures were obtained to compensate. The CCD in MOS during this run was the ST IS-2 with pixels of approximately 0.44^{00} in size and a gain of 4.52 electrons per ADU.

2.3.2 Reductions

The images were reduced and analysed twice. During the observing run a basic reduction was perform ed with \mathbb{RAF}^2 (bias subtraction and at ekking). FOCAS (Vakes 1989) was used to generate a catalogue that could be used for the identication of galaxies and the generation of the multislit masks. Following the observing runs, the images were processed in a more relaxed manner, astrometric and photometric calibrations were determined, and measurements of the object positions and magnitudes completed. In the following subsections we describe this second round of reductions, which yielded the measurements presented in this paper.

The nalprocessing of all of the images was performed using codproc and other tasks distributed with v2.12 of IRAF.B is subtraction and at elding were the main processing steps.W hile only single exposures were obtained for most elds, e ort was made to identify saturated pixels and defects caused by cosm ic rays, scattered light, satellite trails, etc., and to map the locations of a ected pixels in a bad pixel mask for each image. These masks were used during the generation of the catalogues, described below, to ag objects whose properties could not be well measured.

2.3.3 A strom etry

In order to generate relatively accurate positions for the galaxies whose properties are presented in the electronic Tables 3-18, we needed to determ ine for each of the images an accurate world coordinate system. This was generated using software in IRAF (tasks cosetwors and m soom atch in the m scred package; as described by Valdes (2002)) and the USNO A 2.0 catalogue of the positions of objects in each of the elds (M onet et al. 1998). A limited m agnitude range was used of USNOA2.0 reference stars in order to avoid the docum ented relative o set in astrom etry for this catalog as a function of magnitude. Using the IRAF task m scom atch (in v4.7 of the m scred package), a fourth order m apping between the images in x, y pixel coordinates to RA and DEC of the reference stars was determ ined. The RMS residuals of the twere 0.3 to 0.4^{00} for each of the images. At the time these solutions were determ ined, the USNO A 2.0 was the best catalogue available. A though catalogues with im proved positions are now available (e.g. USN 0-B1.0, M onet et al. (2003) or G SC 2.2³), a trial new solution using the

A dditional support is provided by E uropean Southern O bservatory, Space Telescope E uropean C oordinating FacilUSNO-B1.0 did not result in a signi cantly in proved solution, so we have retained our original ts. The residuals to our solutions were largest around the border of the in ages and we suspect that the uncertainties in the positions of objects around the edge of each eld should probably include an additional 0.1 to 0.2^{00} of system atic error. Our measured positions of objects given in this paper are in the ICRF and J2000.

2.3.4 Photom etry and Catalogue Generation

W e did not obtain multiple standard star observations nor observe in a range of colours that would allow us to determ ine our own extinction solutions and colour term s. This fundam entally lim its the accuracy we can obtain in our photom etry. However, our needs in the current study only require photom etry accurate to a few tenths of a magnitude. U sing a representative M auna K ea extinction curve determ ined from photom etric observations during other runs and our observations of the stars in NGC 7790, which have been calibrated in the R band by O dewahn et al. (1992), we were able to determ ine zero points for the 10 elds in aged during our photom etric nights.

There were ve elds observed only on non-photom etric nights. W e have determ ined an approxim ate zero-point for these in ages as follows. First, for the 10 elds we calibrated with ourm easurem ents of NGC 7790, we com pared ourm easured m agnitudes to the red m agnitudes of the GSC22 for objects in common. The pass-bands, of course, are not the same, and we would not expect the magnitudes to be identical, but we were grati ed that all of the elds observed under what we believe to have been photom etric conditions yielded similar o sets (mean o set of 0.1 of a magnitude) and RMS residuals (0.15 to 0.25). We then assigned to each of the ve elds (all from the 1997 run) observed on nonphotom etric nights a zero-point based on the calibration determ ined from the photom etric night of that run.W e then com pared these ve elds to the GSC 2.0. Two of the elds, 3C 57 and PKS 2340 036, had mean di erences in the same range as those elds observed under photom etric conditions. Three of the elds; NGC 2841 UB3, 4C 41.21, and PKS 2344+09; had signi cantly larger initial o sets (0.43, 0.47, and 0.62 m agnitudes). The RMS residuals, however, were sim ilar to those of all the other elds. We therefore adjusted the zero-points for these elds so that their mean o set when com pared to the GSC 2.0 stars would also be 0.1 of a m agnitude. This adjustment is consistent with what is evident from inspecting the images (and number counts), namely that these exposures taken with som e clouds did not reach the same depth (in the same exposure time) as our other exposures. A system atic uncertainty of 0.2 m ags should probably be assigned to our reported m agnitudes for observed galaxies, but we feel we have successfully placed our observations on a comm on relative photom etric scale.

Using our magnitude zero-points for each image and measurements of the variance in the sky brightness of each image, we have con med that the ve sigma detection

ity, the International GEM IN I project and the European Space A gency A strophysics D ivision. thresholds for point sources in all of our in ages is a magnitude of 24.9 or greater, well below our selection of targets for spectroscopic follow -up.

For each eld the object catalogues were generated using SExtractor 2.2.2 (Bertin & A mouts 1996) run with the minimum detection area, G aussian convolution liter, and signal above sky threshold optim ized to detect and m easure all of the objects for which spectroscopic data was obtained. We measured eight xed aperture magnitudes (starting at 2^{00} and increasing to 10^{00} in diameter) and the SExtractor MAG_BEST, which is similar to the K ron total magnitude (K ron 1980). Results for our spectroscopically observed galaxies are included in the electronic Tables 3-18.

A spreviously discussed, for some of our elds scattered light a ected our im ages. Even without these problem s, any catalog will su er increasing incom pleteness for galaxies of fainter total m agnitude and/or surface brightness. A s a test of the com pleteness of our im aging catalogs, articial galaxies were inserted into each im age (using the IRAF artdata task) and SE xtractor used to attempt to recover the objects. W hile not a perfect measure of the robustness of our catalogs, the 50% completeness limit of our catalogs for each quasar eld is typically 24.4 (R band) and greater than 24.0 for all elds. The elds most seriously a ected by the arcs of scattered light could be missing even bright galaxies at the 5% level, but visual inspection indicates that the fraction is likely to be much smaller.

2.3.5 Bounded Restfram e B-band M agnitude

W e would like to have well measured lum inosities for each of the galaxies expressed in a common rest-frame band.Unfortunately, we do not have well measured colours or spectrophotom etry that would allow an accurate determ ination of the over-all spectral energy distributions (SED s) of the galaxies in our sample. This prevents the assignment of the proper K correction for each galaxy in our sample.

We can, however, constrain the range of rest frame B band lum inosities possible for each galaxy using our R band measurements, the redshifts determined from our spectroscopy, and the galaxy SED templates and K corrections of Colem an et al. (1980). For each galaxy we determ ined the range of possible K corrections and intrinsic B R colours and tabulated the resultant maximum and m in im um rest-fram e B band m agnitudes. These are listed for each galaxy in the electronic Tables 3-18.W e assumed no evolution or intrinsic extinction. W hile more involved procedures m ight, with other data sets, provide probability distributions for the rest B band lum inosities of each galaxy, the procedure described above allow s us to m ake the gross com parisons between sub-sam ples that are reasonable given the other uncertainties in our measurem ents. In other words, those galaxies that m ight be the intrinsically more lum inous are separable from those that could not. The observed redshifts and R band m agnitudes are the dom inant constraints.

The association between gas and galaxies 7

2.4.1 Observing

The majority of the galaxy redshifts described in this paper were obtained using the CFHT Multi-Object Spectrograph (MOS), (Le Fevre et al. 1994), during observing runs in July 1995 and November 1997. As described above, in aging catalogs were prepared in realtime, from which masks were designed. For July 1995 the Loral 3 CCD was used along with the 0300 grism, yielding roughly 3.5A per pixel. No wavelength blocking lter was used, yielding a wavelength coverage that varied depending on the location of the slit within the eld of view, but reasonable signal-to-noise (S/N) was generally obtained for wavelengths between 5000 A and 9000 A.For the November 1997 run, the STIS 2 CCD was used with the same grating, yielding a dispersion of 5.2A per pixel, for both runs, masks were designed with a $1.5^{\circ\circ}$ slit width, corresponding to 4.8 pixels in July 1995 and 3.4 pixels in Novem ber 1997. Som e of the observations were taken through cloud. A ux standard star was observed in order to allow an approximate ux calibration of the data and to allow us to rem ove the instrum ental signature, but because of the above m entioned cloud, the uxes recorded could be low .

Spectroscopic multi-slit m asks were designed using the galaxy catalogs generated during the observing run. Slits were assigned to galaxies with a magnitude ranking. Slits had a default length of 10^{00} and width of 1.5^{00} . A fler this, the assignment algorithm checked whether it was possible to add further objects by sliding slits sideways by a limited amount. Finally all slits were expanded in length to llthe array and allow better sky subtraction for some objects. Depending on the galaxy surface density and distribution in the eld between 40 and 47 galaxies had slits assigned to them per mask in thism anner. Between one and three masks per LOS were taken.

Because of the varying conditions mentioned above, the redshift success rate for objects which were assigned slits varies from mask to mask. The average success rate was 0.5, with a nadir of 0.07 for a mask taken through thick cloud, and a pinnacle of 0.89 for one particularly good mask.

It was never our intent to obtain a sam ple com plete to any given m agnitude, but m erely to obtain a statistically useful sam ple of the galaxies around the LOS.By com paring with the photom etric catalog, we can reconstruct our com pleteness for each eld as a function of m agnitude, as will be discussed below.

2.4.2 Reduction

The spectroscopic data reduction using IRAF followed the standard procedure for M O S spectroscopy used for exam ple in the CNOC2 project (Yee et al. 2000). The data were bias subtracted and trim m ed. If necessary, bad colum ns were interpolated over. Repeat exposures of the same m ask were combined and cosm ic rays rem oved. Because the spectral extraction involves sum m ing over several colum ns, at elding to correct for pixel-to-pixel variations in CCD sensitivity was not necessary (and would have added noise). Individual apertures were then sum m ed to generate 1D spectra, sim ultaneously subtracting the sky using adjacent regions along the slit. These spectra were wavelength calibrated using arc spectra obtained at the same position on the sky (to m in-

im ize the e ects of exure), and the spectra were approxim ately ux calibrated using observations of a standard star taken through the same slit width.

2.4.3 Redshift D eterm ination

The driving goal for the redshift m easurements was to obtain redshifts that could all be placed in the same reference frame, in our case heliocentric. To do this, all the galaxy redshifts determined in di erent ways were tied together in the same reference frame, and then this frame was tied to that of the absorption line lists, which were adjusted to the heliocentric velocity frame as described by Jannuzi et al. 1998.

All galaxies were cross correlated with two absorption line tem plates using the IRAF XCSAO task. One tem plate was the Yabtem p97' one which com eswith the XCSAO package, and the other was a high-quality wide-wavelength coverage spectrum of the early-type galaxy NGC 4889, kindly provided by B.Oke (private com m unication, tem plate available on request from S.M orris). As usual, the cross correlation process involved continuum thing and also litering of high and low Fourier components. Redshifts for em ission line objects were obtained more interactively using the IRAF RVIDLINES task inside the RV package. The results of these routines were then checked by eye, and each measurem ent agged as successful or failed. This som ew hat subjective procedure was necessary in order to deal with the combined e ects of zero order contam ination, poor sky subtraction, residual cosm ic rays and other reduction problem s. In practice, for the cross correlation measurements, there was a fairly clear threshold in R-value reported by the routine above which between m easurem entwere judged successful. Despite all of the above, it is still of course possible for som e objects in our redshift catalog to have 'catastrophic' redshift errors (i.e. redshifts based on spurious features of m is-identi ed features). W e believe that the above procedure should have m in im ized the num ber of such errors, and would be surprised if there were more than a handful these in the redshift catalog, but it should be noted that the redshift errors do not take account of this possibility.

B oth the above routines autom atically convert redshifts to a heliocentric fram e. N evertheless, as is well known, this does not m ean that there are no system atic shifts in velocity introduced by the di erent processes, and so objects with reliable redshifts determ ined from 2 orm ore of the above approaches were used to m easure and rem ove any such shifts. (Shifts of -49 km s¹ and +72 km s¹ were m easured for the NGC 4889 and em ission line redshifts relative to the fabtem p97 m easurem ents).

At this stage we are left with 641 galaxy redshifts in our catalog with their associated redshift errors. The success rate of obtaining redshifts from a given number of slits on a m ask varied considerably depending on conditions and the m agnitude range of objects on the m asks, but for typical m asks and conditions was around 60-70%.

As described above, the photom etry perform ed on the m ountain for mask design was repeated after the observing run. The resulting photom etric catalog was then re-m atched with the redshift catalog, resulting in our dropping two of our m easured objects because of large uncertainties in their positions and m agnitudes. The CFHT MOS data therefore provided 639 new redshifts of galaxies in the targeted LOS.

The objects with identi ed redshifts are listed in a set of Tables (3-18) available in the electronic version of the paper. The columns in the associated electronic table are as follows:

(i) RA: The J2000 Right ascension of the galaxy. The relative positions for galaxies in a single quasar eld should be good to a few tenths of an arcsecond.

(ii) DEC: The J2000 D eclination of the galaxy. The relative positions for galaxies in a single quasar eld should be good to a few tenths of an arcsecond.

(iii) z: The redshift determ ined from our MOS spectrum of the galaxy.

(iv) z_{err} : this is the error reported by the cross correlation routine, and as such should be considered a lower lim it on the redshift error.

(v) R-m ag: R-band apparent m agnitude (MAG_BEST from Sextractor). As discussed above, these are only accurate to 0.2 m agnitudes.

(vi) B_{max} : estimate of the maximum rest frame B band lum inosity as discussed in x 2.3.5

(vii) $B_{\rm m \ in}$: estimate of the maximum rest frame B band lum inosity as discussed in $\times\,2.3.5$

2.5 Additional Galaxy Redshifts

W e also searched the literature to nd additional galaxies with measured redshifts around the sample Q SO LOS.As the typical redshift range for the SD SS and 2dF galaxy redshift samples are not well matched to absorption line data used in this paper, we have not chosen to add in galaxies from those surveys at this stage.

Our main method for nding additional redshifts was through the NED database⁴.We list the results of this search below.Since the analysis in this paper is statistical in nature, we have chosen only to add redshifts from other authors to our sample when they make a signi cant di erence to the num ber of redshifts known for a given LOS.

2.5.1 PKS 0122 00

G alaxies in this LOS were observed by both Bowen et al. (1997), and Chen et al. (2001), but as only two additional galaxy redshifts would have been added to the sam ple, for sim plicity these were not included. For the three galaxies in common between our sam ple and that in Chen et al. (2001) a mean velocity di erence of 30 km s¹ is measured, with an RMS of 450 km s¹.

2.5.2 PKS 2145+06

A galaxy that seems to be associated with a M gII absorber at z 0.79 in the LOS has been studied in a number of papers, e.g. (Churchillet al. 2000a,b). This galaxy has not been added to the sam ple.

2.5.3 PG 2302+029

This LOS was surveyed by Bowen et al. (2001), obtaining spectra for 24 objects. In this same eld, we measured redshifts for 42 objects. We had 6 galaxies in common. (For which we measure a reassuringly small mean velocity shift of -65 km s⁻¹ with RMS 227 km s⁻¹, in line with our error estimates). This then gives us 18 additional redshifts which we add to our sample. These objects are included in (the electronic) Table 16.0 n a less positive note, it is interesting that 2 groups designing masks for the same LOS could end up with so little overlap in their samples.

2.5.4 Q0107 025A,B

The region around the LOS to the QSO pair Q0107-025A,B was also observed with the COS-MIC spectrograph on the Palomar 5m telescope (http://www.astro.caltech.edu/palomar/200inch/cosmic/) by W eym ann et al. (private communication). The measured redshifts for one of the masks observed was kindly made available to us by M. Rauche. This yielded 28 additional objects with redshifts. In this case there was no overlap by design, and so we are assuming that any systematic shifts between the two redshift sets is small. These objects are included in (the electronic) Table 4.

3 ANALYSIS

3.1 Sam ple Properties

The nalgalaxy sample as described in x 2 above contains 685 objects with redshifts. Of these, 49 have 'redshifts' less than 500 km s⁻¹, and hence are almost certainly stars. A sum ing this to be true, we can check that our redshift error estim ates are reasonable. The mean velocity of this sample is 5 km s⁻¹, with RMS 190 km s⁻¹. The mean of the error estim ates on the velocities is 230 km s⁻¹, suggesting we m ight be slightly overestim ating our velocity errors, but, to be conservative, we make no adjustment for this.

The absorber sam ple as described in x 2 above contains 815 lines, of which 381 are identi ed as Ly- and 54 are C IV. Of the C IV sam ple, there are 25 with unique redshifts less than one (i.e. counting doublets as one system). For our present analysis we will restrict ourselves to this subsam ple of 406 absorption lines.

The nal redshift distribution of this absorption line sample is shown in Figure 18. The dramatic drop in line numbers shortward of z 0.35 is where Ly- moves below the blue edge of the HST FOS G 190H grating. In our subsample, absorption line systems at redshifts less than 0.35 are generally either metal line systems, or Ly- detected in a GHRS exposure towards LBQ S0107-025A or B.

The nalredshift distribution of the galaxies with measured redshifts is shown in Figure 19.

In Figure 20 we show the distribution of the galaxy sam – ple with projected distance to the Q SO LOS in our adopted cosm ology. There are relatively few galaxies within 200 kpc of the LOS (as would be expected for a uniform ly sam pled distribution). The survey geom etry, com bined with cosm ology, results in a fairly at distribution out to radial distances of 1 M pc, with a drop o from there out to 2 M pc which e ectively de nes the corners of our surveyed volum e.

In Figure 21 we show a pie diagram resulting from com – bining all of the LOS. This gure should allow the reader to understand our survey geom etry and the regim e over which our statistical results apply. In particular one can clearly see that our survey covers in pact param eters out to 2 M pc for redshifts above 0.45.0 ne can also see that (because the KP observations did not include wavelengths shortward of

1630A) very few absorber-galaxy pairs are found with redshift less than 0.34. All symbols and lines are as de ned for Figure 2.

By comparing the galaxy sample with measured redshifts with the photom etric catalogs, we can compute the completeness as a function of magnitude for each eld individually. Because of the fairly sm all number statistics of individual elds, these histograms block fairly noisy, although inform ative. For this paper, we show the merged result from combining all of the elds. As can be seen in Figure 22, the average completeness peaks at around 60% at the bright end, falling sm oothly to 20% at R 20 and 10% at R 21. This completeness can be taken as roughly referring to the volum e enclosed by the solid line in the bottom panel of Figure 21.

3.2 Identifying Absorber-Galaxy pairs'

There are two reasons for trying to identify absorber-galaxy pairs'. One is to investigate the physical relationship (if any) between the gas and the galaxies, while the other is to allow us to try to the the velocities of the galaxies to the frame of the absorbers.

A lso clearly visible is the sharp drop in absorber-galaxy pairs which could be found produced by the blue edge of the FOSG 190H (corresponding to a redshift of 0.34 for Ly-)

A straightforw and way of tying galaxies to absorbers is to set limits in impact parameter and velocity di erence, and to call all galaxies within that distance of an absorber 'associated'. This begs the question of what to do when there is more than one galaxy within this distance of an absorber, with common approaches being to just take the closest, as de ned by som emetric combining the velocity di erence and projected distance, or to accept all such pairs.

A more complex approach has been followed by the series of papers by Lanzetta and Chen (Lanzetta et al. 1995, 1996; Chen et al. 1998; Ortiz-Gil et al. 1999; Chen et al. 2001), who identify physical absorber-galaxy pairs by separating them from Yandom ' and borrelated' pairs in the following manner. Random ' pairs are rem oved by calculating the value of the absorber-galaxy correlation function assum ing a parametric form (kindly provided to us by H siao-W en

Chen), given the impact parameter and velocity di erence (Lanzetta et al. 1998). Pairs are passed to the next stage if their calculated correlation amplitude is greater than 1. To remove 'correlated' pairs they also then require that the impact parameter is less than 200 h⁻¹ kpc (286 kpc in our adopted cosm ology). Given the form of the correlation function, and the above additional cut, one can calculate the region of impact parameter/velocity di erence space within which an absorber-galaxy pair would be declared 'physical'. W e note that this is in practice extrem ely sim ilar to a sim ple cut at impact parameter of 286 kpc and velocity di erence of 530 km s⁻¹.

A nother route to the above pairing was discussed by M orris et al. (1993), where the three dimensional distance between absorbers and galaxies was corrected for the statistical fact that objects close in projected distance might have relatively large peculiar motions relative to each other because they are orbiting in the same potential well. As discussed in that paper, it is possible to use the two point correlation function to estimate the probability distribution of the real three dimensional separation of two objects, and then to adopt the expectation value of this probability distribution as what was referred to as the perturbed Hubble ow' distance.

For sim plicity we will only adopt straight cuts in im pact parameter and velocity di erence (shown for example in Figure 24), along with the Lanzetta et al. correlation function approach, in this paper.

3.3 Properties of < 286 kpc. Absorber-Galaxy pairs'

In order to compare our results with those of Chen et al. (2001), we have produced pair samples using their approach, and also with cuts in impact parameter 286 kpc and velocity di erence 530 km s¹ (the region enclosed by dashed lines in Figure 24). For our sample, these two approaches produce identical lists of 13 absorber-galaxy pairs. Given our fairly large sample of Ly- absorption lines and galaxies with redshifts, this small number of physical pairs m ight be seen as suprising, but we re-em phasize that our strategy in designing the galaxy redshift survey was not to identify the galaxies bausing' the absorption, but to obtain a sta-

tistically well-understood sam ple of galaxies over a region large in impact parameter. For this reason we did not try to concentrate our e orts at small impact parameters. Indeed, this would have been a rather ine cient use of telescope time and MOS spectrograph real-estate.

Chen et al. (2001) use their sample of 34 galaxyabsorber pairs to conclude that L* galaxies have tenuous gaseous halos of colum n density > 10^{14} cm⁻², with radius 180 h⁻¹ kpc and covering factor near unity, and that the halo radius scales with galaxy B-band lum inosity as $L_B^{0:39}$. Their Figures 3 and 4 m ake the case for this conclusion. In Figure 23 we show a reproduction of their Figure 3 (converted to our adopted cosm ology) along with the additional pairs from our sample. A lso marked are the ducialEW of 0.3A (corresponding roughly to a colum n density of 10^{14} cm⁻²) and the L* in pact parameter of 257 kpc (180 h⁻¹ kpc with h= 0.7).

In response to an interesting question from the referee of this paper, we have investigated the sub-sam ple of pairs found with large rest EW (taken to mean larger than 1A) and large in pact parameter (taken to mean larger than 100 kpc). There are 5 such pairs in our sam ple. W ith such a sm all sam ple, it is in possible to draw any statistically convincing conclusions, but it is notable that all 5 galaxies so identi ed have at least one other galaxy close to it in redshift. The clearest exam ple is the absorber galaxy pair in the PG 2302+029 LOS at redshift 0.59 where there is a clear group or wall of galaxies at this redshift (see Figure 13). O ne possible inference, which could only be con med with a much larger sam ple, would be that large EW, large im pact parameter 'pairs' are identi ed in som ewhat overdense regions.

The additional pairs from our sample do signi cantly increase the number of large column density pairs with separations larger than 100 kpc, but the incomplete nature of our sample (and indeed of most samples of this nature) does have open the possibility that a galaxy of comparable brightness m ight be found closer to the LOS.

We also boked at the rest fram e B-band lum inosities of the galaxies that are paired in this manner, nding that these were not signi cantly di erent from the lum inosities of all the galaxies found in pairs with separation up to 5000 km s⁻¹ and in pact parameter up to 2 M pc. I.e. there is no evidence from our sam ple that more lum inous galaxies are more likely to be found in absorber-galaxy pairs. How - ever, the large uncertainties in the derived absolute B-band m agnitudes we tabulate, that results largely from an uncertain k-correction, m ean that any such trend, even if present, could be undetectable using the data in this paper.

As a result of these inconclusive results, we have chosen to abandon the approach of trying to identify a single physical galaxy-absorber pair, and in the next section will concentrate on the statistical properties of all the galaxyabsorber pairs within a fairly generous window.

3.4 Properties of All Absorber G alaxy Pairs with velocity di erence less than 1000 km s⁻¹

W e can now analyse the statistical properties of the relative distributions of the gas and galaxies along the 16 lines of sight. The basic sample we will use will be taken from all possible pairs of absorbers and galaxies with velocity di erences less than + /- 5000 km s 1 . For the C IV system s we have only taken the stronger line of the doublet. W e note that therefore individual absorbers or galaxies can appear multiple time as di erent pairs. The entire sample is shown in Figure 24. This complicated plot shows both the regions we have determ ined to contain an excess of absorber-galaxy pairs', and also a region beyond + /-1000 km s¹ which we will use to determ ine the background' value for random pairings. Our sample is large enough to break into bins of in pact parameter (shown divided by horizontal lines in the gure).W e also m easure absorber-galaxy pair over-densities for three di erent velocity ranges + /-200, 500 and 1000 km s¹.We show the illustrative box at impact parameter of 286 kpc and velocity di erence of 530 km s¹ which approxin ates the region selected by Lanzetta et al. (1995, 1996); Chen et al. (1998); Ortiz-Gilet al. (1999) and Chen et al. (2001) as containing physical pairs.

In Figure 25 we show the above data projected onto the x-axis and displayed as a histogram .We also show the m ean background values for the Ly- and C IV sam ples.Two thing can be readily seen from this gure.First that there is a strong over-density of pairswith a sm all velocity di erence in both Ly- and C IV, and secondly that the velocity di erences seen in C IV are somewhat sm aller than those seen in the Ly- .The RM S of the velocity di erences between all absorber-galaxy pairs seen in Ly- with velocity di erence between 1000 km s¹ is 440 km s¹ (191 pairs), while the RM S for absorber-galaxy pairs seen in C IV with velocity di erence between 1000 km s¹ is 350 km s¹ (31 pairs).

We also show in Figure 26 how the pairs in the two other plots are distributed in redshift. As a result of the wavelength coverage of the FOS spectra providing our absorption line sample, there is a clear break in the sample at z=0.29. For the following analysis we will consider both the whole sample, and also just the pairs with z>0.29 to check whether the results are being a ected by the low redshift

sub-sample (which mostly comes from the LBQS 0107-025A and B LOS).

G iven this sam ple, we can now pose the question: H ow large is the absorber-galaxy pair over-density compared to the background, and how signi cant is the detection of this over-density? In order to measure the latter, we consider the numbers of pairs seen in the various bins in impact param – eter and velocity di erence in Figure 24 to be drawn from a Poisson distribution with an expected mean given by the background' density measured at the same range of impact parameter but with velocity di erences between -5000 and -1000 km s⁻¹ and between + 1000 and + 5000 km s⁻¹. The results of the analysis are shown in Figures 27, 28, 29, and 30.

In Figures 27 and 28 we show that (as expected by a visual inspection of Figure 24) there is a substantial overdensity of absorber-galaxy pairs at in pact parameters less than 500 kpc. The fractional over-density is larger for the

system s seen in C IV than for the Ly- system s. At larger im pact parameters, the fractional over-density is less. It is reasonable that the strength of the over-density generally drops as one increases the velocity di erence range within which one counts pairs.

In Figures 29 and 30 we show that the over-densities notable in Figures 27 and 28 have a <1% probability of arising by chance out to impact parameters of at least 1.5 M pc. This is consistent, for example, with the models of D av e et al. (1999). Figure 18 in that paper for example shows correlations in absorber-galaxy properties out to these sorts of scales.

Note that the probabilities reported assume that the expected (or background) value is known perfectly. In practice there is a (Poisson) error on our measurement of this background, which could be folded in to the analysis, but has not been in order to avoid overly complicated plots.

As noted in x 2.2, the identi cations of the lines in the PG 1718+481 LOS are not complete. We have rerun the above statistical tests including all the unidenti ed lines as Ly- and nd that this makes no signi cant di erence to the results reported in this section.

W e also rem ind the reader that the FOS spectral resolution of 230 km s 1 m eans that no pairs of absorption features can be identi ed with velocity di erence sm aller than this. The low density of Ly- absorbers at these redshifts m ake the likelihood of two such lines coinciding by chance low, although clustering can obviously change this conclusion. This issue is discussed in m ore detail in Jannuzi et al. (1998). W e also note that the galaxy redshift uncertainties (also of 230 km s 1) will arti cially m ove galaxies across the boundaries of any velocity di erence cut. The general trend will be (a) to weaken any m easured correlation, and (b) for this weakening to be stronger for the sm aller velocity di erence bins.

A n obvious question is whether the observed results are sim ply due to the absorbing gas being in the halo of a galaxy, and the detected pair excess being due to the galaxy-galaxy correlation function. This is tested using the galaxy sam ple and forming a similar sam ple of galaxy-galaxy pairs to the absorber-galaxy pairs. In order to approximately match the absorber galaxy sam ple, we choose galaxies from each eld within 500 kpc of the Q SO LOS, and collect up all resulting pairs with that sam ple. This subsam ple should then be able to nd pairs in the same volume of space as the absorber sam ple. Figures 31 and 32 are the equivalent of Figures 24 and 26 but for the galaxy-galaxy pairs. The over-densities found for galaxy-galaxy pairs were plotted in Figures 27 and 28.

The above analysis shows that the galaxy-galaxy pair over-density is signi cantly higher than the absorber-galaxy pair over-density seen for the Ly- system s, but com parable to that seen for the absorber system s seen in C IV. This result could have several interpretations, but one m ight be that the absorbing gas seen in C IV (and which has obviously been polluted by out ows from galaxies) is still in close proxim ity with galaxies, while system s seen in Lyare m ore widely distributed, albeit still correlated with the

galaxy distribution.⁵ A nother possible interpretation is that we are just seeing the column density correlation with in – pact parameter noted by other authors and modelled for example by D ave et al. (1999). Separating hydrogen column density from metallicity as the underlying driver of these correlations needs further work and will benet throm higher resolution UV spectroscopy (i.e. data from the HST archive taken with the Space Telescope Im aging Spectrograph (ST IS)).

3.5 The link to sim ulations and theory

O ne of the m any bene ts provided by the powerful cosm ological simulations begun in the 1990s and continuing into the present (see introduction for list of references), is the ability to simulate the evolution of the physical properties of Ly- absorbers as a function of redshift and cosm ic time. This helps trem endously when trying to m ake use of diverse observational data sets in order to understand what physical processes in uence the physical properties and evolution of the IG M and galaxies. The theoretical m odels aid us in identifying the high redshift progenitors of structures observed at low redshift. For example, it is from such m odels (e.g. D av e et al. (1999); Schaye (2001)) that we understand

that a given relative over-density in the (dark) m atter distribution will be associated with a di erent colum n density of neutral hydrogen as a function of redshift. Ly- absorbers with N_{H I} approximately 10^{14} cm² at z = 0 are in regions of over-density that at z = 3 would have neutral gas colum ns closer to 10^{16} cm² (D ave et al. 1999). We note that this does not im ply that regions of neutral colum n density 10^{16} cm² at z= 3 evolve into regions with neutral colum n density 10^{16} cm² at z= 3 evolve into regions with neutral colum n density 10^{14} cm² at z= 0, but m erely that these two di erent colum n densities of neutral material ag regions at those two epochs with the same dark m atter overdensity.

A natural next step for this work will be to compare the statistics we have derived from our observations with statistics measured as close as possibly identically on sin – ulations which include feedback, with a goal of verifying or ruling out the feedback assumptions they have made. This is a challenging project, as the simulation must faithfully include both low density inter-galactic gas, and also accurately predict the locations and physical properties (stellar lum inosities and star form ation histories) of the high ly-collapsed galaxies. The redshift range from z=1 to the present day is well known to be hard to model at high resolution, because of the large dynam ic range needed. That said, several of the references to modelling work given in the introduction suggest that this problem is tractable.

4 CONCLUSIONS

A goal of our work is an improved understanding of how gas is transformed into galaxies, and how those galaxies in turn in uence the gas around them (e.g. by winds, jets or radiation). Studies of absorbers and galaxies at high redshift have already yielded evidence for such mechanism s playing a role in the formation and evolution of galaxies (e.g. A delberger et al. (2003); C roft et al. (2002); Frank et al. (2003); B ruscoli et al. (2003) and K ollm eier et al. (2003)).

We have focussed on the second halfofthe history of the Universe, i.e. at redshifts less than one. This is a period in which the star form ation density of the Universe is thought to be dropping away from its peak, the rapid evolution of the properties of the Ly- absorbers has slowed, and when the Hubble sequence of galaxies is well established. D expite this apparent middle-aged placidity, there should remain clear evidence of the wild excesses of youth, and that is what we claim to have measured. An advantage of focussing on this (large) fraction of the history of the Universe is that the galaxy population can be studied in detail, and with con dence that a representative sam ple has been obtained.

There is evidence from the KP data set alone for clustering of som e fraction of low redshift (z < 1) Ly- absorbers on velocity scales < 300 km /sec. This evidence is that approximately 10% of the KP Ly- absorbers are \resolved" in the FOS spectra (Jannuzi et al. 1998).

At higher column densities, the Lym an limit systems contained in the KP sample all have extensive associated m etal line systems. For all the extensive m etal line systems (multiple absorption lines from strong resonance line producing species, e.g. Si, O, N, etc.) for which we could check for the presence of an associated Lym an Limit system, we detect such a system. In other words, the absorption line system s that are unam biguously higher column density sys-

tem s (at low redshift) are unquestionably more like the gas producing the ISM of a galaxy than like the gas one might expect in a void. These same absorbers also often have associated OV I, or NV, or other evidence of more highly ionized components i.e. multi-phase gas again, like a galaxy.

O ur conclusions for the m ore m oderate colum n density system s that dom inate our current sam ple can be sum m arized as:

A correlation between absorbers and galaxies has been detected out to impact parameters of at least 1.5 Mpc.

The strength of the absorber-galaxy correlation is weaker than the correlation between galaxies and galaxies.

The velocity di erences seen between galaxies and absorbers with detected C IV are typically sm aller than the velocity di erences seen between galaxies and absorbers seen in Ly- only.

The above is consistent with absorbers being a mixed population containing some pristine⁶ material probably infalling for the st time along the laments predicted by current models, and some contaminated material produced by out ows which in general lies closer to galaxies in velocity.

The above qualitative picture needs to be eshed out by comparing the num erical strengths of the observed correlations and relationships with SPH or AMR modelling.

W hile we have so far only m ade a fairly super cialanalysis of the (no-doubt com plex) relationship between gas and galaxies at redshifts less than one, we feel the above results are very encouraging, and that they suggest that there is considerable room for further observation and m odelling of this crucial interaction.
