XMM —New ton and Chandra observations of SHEEP sources

ABSTRACT

We present Chandra and XMM-Newton observations of 12 bright (f(2 10 keV) > 10^{-13} erg cm 2 s 1) sources from the ASCA SHEEP (Search for the High Energy Extragalactic Population) survey. Most of these have been either not observed or not detected previously with the ROSAT mission and therefore they constitute a sample biased towardshard sources. The Chandra observations are important in locating with accuracy the optical counterpart of the X-ray sources. Optical spectroscopic observations show that our sam ple is associated with both narrow-line (NL) (six objects), and Broad-Line (BL) AGN (ve objects) with one source remaining unidentied. Our sources cover the redshift range 0.04 to 1.29 spanning lum inosities from 10^{42} to 10^{45} erg s 1 (2-10 keV). The NL sources have preferentially lower redshift (and lum inosity) compared with the BL ones. This can be most easily explained in a model where the NL AGN are intrinsically less lum inous than the BL ones in line with the results of Ste en et al. The X-ray spectral ttings show a roughly equal number of obscured (N $_{\rm H}$ > 10^{22} cm 2) and unobscured (N $_{\rm H}$ < 10^{22} cm 2) sources. There is a clear tendency for obscured sources to be associated with NLAGN and unobscured sources with BL ones. However, there is a marked exception with the highest obscuring column observed at a BL AGN at a redshift of z=0.5.

1 INTRODUCTION

Chandra surveys resolved 80 per cent of the X-ray background at hard energies (i.e. 2-10 keV) Brandt et al. (2002), Giacconi et al. (2002), Alexander et al. (2003), shedding ample light on its origin. Optical identications of the Xray sources are showing that these are mainly AGN. The largest fraction of these are absorbed in X-rays, presenting an average spectrum with a slope of = 1:4 (Tozzi et al. 2001) sim ilar to the slope of the X-ray background. Large area bright surveys perform ed with XMM-Newton in the 2-10 keV band are complementary as they help us to explore the bright, nearby counterparts of the sources detected in the deep Chandra elds. One remarkable nding from these bright surveys is the scarcity of obscured AGN ($N_H > 10^{22}$ cm²) at bright uxes (Piconcelli et al. 2002, Georgantopoulos et al. 2004, Perola et al. 2004). This com es in contrast to the predictions of the population synthesis models (e.g. Com astriet al. 1995, Gilliet al. 2001).

Selection in the hardest band allowed by imaging sur-

veys (5–10 keV) facilitates the selection of the most obscured candidates, as this bandpass is relatively unbiased to absorption. Indeed columns as high as a few times $10^{23}\ \mathrm{cm}^{-2}$ do not practically a ect X-ray energies above 5 keV . The HELLAS survey (Fibre et al. 1999) pioneered these studies using the MECS detector on board BeppoSAX . The HELLAS survey covered an area of 85 deg² detecting about 150 sources down to a ux limit of 5 $10^{-14}\ \mathrm{erg}\ \mathrm{cm}^{-2}\ \mathrm{s}^{-1}$ in the 5–10 keV band.

The SHEEP survey further explored this energy bandpass with ASCA GIS. It comprises of 69 objects serendipitously detected in a non-contiguous area of 39 \deg^2 down to a ux limit of 10 13 erg cm 2 s 1 in the 5-10 keV band (Nandra et al. 2003). 35 of these objects were detected by ROSAT, in either pointed observations or in the All Sky Survey, with 13 of them having secure optical counterparts in optical catalogues. For the remaining 34 sources, which were either not observed or not detected by ROSAT, it is very discult to locate the optical counterpart as the ASCA

error box is large (typically 60 arcsec m s). We have thus obtained C handra snapshot observations in order to extract reliable positions (< 1 arcsec) of the X-ray source that will enable us to search for their optical counterparts. Preliminary results from these observations are presented in N andra et al. (2004).

Here, we report our results from X-ray and optical observations of 12 out of the 34 Chandra sources which have a 2 10 keV ux larger than 10 13 erg cm 2 s 1 (estim ated assum ing a Photon index = 1:9). We have obtained optical spectroscopy for 11 of these objects. Furtherm ore, eight of these have been also observed by XMM-Newton , providing good quality spectra. Consequently, for these bright sources, we can derive their X -ray spectral param eters (i.e. N_H and) using proper spectral tswith good photon statistics (instead of hardness ratios only). Moreover, Nandra et al. (2004) noticed that a fraction of the Chandra sources are much fainter (in some cases more than an order of magnitude) than the original ASCA source. A lthough variability could play som e role, there is clearly som e am biguity about the reality of these sources. W atanabe et al. (2002) who perform ed Chandra pointings of hard ASCA sources also report the same problem . By choosing to study initially only the bright sources, we m in im ize the possibility that a source is spurious. The optical counterparts for three of the sources in the present SHEEP subsample have already been presented in N andra et al. (2004) We include them in the present work as they satisfy the ux lim it we have set, and we also present the results from XMM-Newton observations of them.

2 DATA ACQUISITION

2.1 The Chandra observations

Our sources were observed using the Advanced CCD Im aging Spectrom eter, ACIS-S, on board the Chandra observatory (Weisskopf 1997). We use the event le provided by the standard pipeline processing. Only Grade 0,2,3,4 and 6 events are used in the analysis. Charge Transfer Ine ciency (CTI) problem s do not a ect our observations as S3 is a back-illum inated chip. Each CCD chip subtends an 8.3 arom in square on the sky while the pixel size is 0:5. The spatial resolution on-axis is 0:500 FW HM. The ACIS-S spectral resolution is 100 eV (FW HM) at 1.5 keV.We estimate that even in the brightest case (A X J1531.9+2420) the pileup fraction is less than 12 per cent. Im ages, spectra, ancillary les, response matrices, and light curves have been created using the CIAO v2.2 software. We use a 200 radius extraction region in order to produce both the spectral les and the light curves. We take into account the degradation of the ACIS quantum e ciency in low energies, due to molecular contam ination, by using the AC ISABS model in the spectral tting. The observation details are given in Table 1.

2.2 The X M M -N ew ton O bservations

The X-ray data have been obtained with the EPIC (European Photon Imaging Camera; Struder et al. 2001 and Turner et al. 2001) cameras on board the XMM \rightarrow Newton

operating in full frame mode. Four sources have been observed by uswhile another four have been recovered from the XMM—New ton archive. The observational details are given in Table 2. The data have been analyzed using the Science Analysis Software (sas 5.3). Event les for both the PN and the MOS detectors have been produced using the epchain and emchain tasks of sas respectively. The event les were screened for high particle background periods. In our analysis we have dealt only with events corresponding to patterns 0-4 for the PN and 0-12 for the MOS instruments.

The source spectra are extracted using an 18 arcsec radius circle. This area includes at least 70 per cent of the X-ray source photons at o—axis angles less than 10 arcm in. The background spectral less are extracted from every in age independently, using regions free from sources with a total area about 10 times larger than the source area. The response matrices and the auxiliary less are produced using the sastasks rmfgen and arfgen respectively. A X J 1035.1+3938 has just been detected by X M M—N ewton and thus we cannot derive a spectrum as there are not su cient counts. The ux of this source is F (2 10 keV) = 6.8 10 14 erg cm 2 s 1 .

2.3 The optical observations

Optical im aging of our targets in the Johnson B and R band has been performed with the Skinakas 1.3-m/f7.7 Ritchey-C retien telescope of the U niversity of C rete, except from A X J0335 2{1505 and A X J0440.0{4534 which were observed with the ANDICAM detector in the SMARTS 13 m telescope at C T IO, C erro-Tololo Interam erican O bservatory. All im ages were reduced in the same way, as explained by Nandra et al. (2004). Typically, all observations were carried out through standard Johnson B and Cousins R lters. Exposure time was 20 m in for both lters. In all cases, observations were carried out under photom etric conditions, with seeing being between 1 1:5 arcsec, and an optical source was detected within 1 arcsec of the Chandra source. The rst, second, fith, and the last two sources in Table 3 appear point-like, while the other seven sources are extended, with dim ensions ranging between 10 up to 30 arcsec (in the case of AXJ0440.0(4534). The integrated R band magnitudes, and B R colours of all sources are listed in Table

Optical spectroscopy of eight sources in the Northern Hem isphere has been obtained with the Ritchey-Cretien Focus Spectrograph on the 4-m M ayall telescope at the K itt-Peak NationalObservatory. The spectral coverage was from 5000 to 8000 A, with a resolution of about 300 km s 1 . The optical spectra for three of these were presented in Nandra et al. (2004). Three more sources have been obtained with the Cassegrain spectrograph at the CTIO 4-m V.N. Blanco telescope on 9 Dec 2003. We used the R-C spectrograph with the G 181 grating (316 $1/m \, m$), blazed at 7500 Ang, and the order-blocking lter GG-495. There is only one camera-CCD combination that can be used, which is the Loral 3K CCD with the Blue Air Schmidt camera. The slit-width was 1.5" and the spectral resolution was about 250 km/s. The spectral coverage is 5000-9700 Ang. The optical spectra show that ve sources present Broad Lines (FW HM > 1000km s 1) and therefore are clearly associated with AGN. Another six present only Narrow Lines. It is difcult to classify these as in some cases the H or the H




Figure 1. The optical spectra

lines happen to lie outside the spectral window. However, their X-ray properties i.e. high X-ray lum inosities ($L_x > 10^{42}$ erg s 1) combined with the hard spectra, suggest that most are AGN. The redshifts and optical classication (BL or NL) are given in Table 3. The spectra are presented in Fig. 1.

3 THE DATA ANALYSIS

W e investigate the X-ray properties of our sources by perform ing spectral things with the XSPEC software package v11.2. The poor count statistics do not allow the use of the standard 2 analysis in all cases. Instead, we use in some cases the C-statistic technique (Cash 1979), which is proper for thing spectra with limited number of counts. Note that this method can be used to estimate parameter values and con dence regions but does not provide a goodness-of-t (A maud 1996).

We tithe Chandra and XMM-Newton data separately for each source in the 0.3-8 keV band. In the XMM-Newton case we to simultaneously the PN and the MOS data for each source. We use a power-law model with two absorption components (wa*zwa*po in XSPEC notation) to the data. The column density for the rst absorption component is xed to the Galactic value (the values used for each eld were taken from Dickey & Lockman (1990) and are listed in Table 4) while the N $_{\rm H}$ for the second comp

ponent (representing the intrinsic absorption) is left as a free param eter during the model tting process.

In the case of the Chandra data where we have limited photon statistics, we x the photon index to 1.9 and allow both the N $_{\rm H}$ and the normalization to vary. In the case of XMM -Newton sources with adequate photon statistics we leave both the column density and the photon index free to vary. The results for Chandra and XMM-Newton are presented in Tables 4 and 5 respectively. All quoted errors correspond to the 90 per cent con dence level. The N $_{\rm H}$ values listed in these tables correspond to the column density of the intrinsic component. The lum inosities have been estim ated assuming $H_o = 70$; m = 0.3= 0:7. The Xray spectra are presented in Fig. 2. We see that in some sources that there are residuals which may denote the presence of emission lines. However, in most cases these are hardly statistically signi cant. The stronger case for a line is in AXJ1531.9+2420, the brightest source in our sample: an FeK line at 6.4 keV (rest-fram e) is statistically signi cant at just above the 95 per cent con dence level. A gain a M gX I line at 1.35 keV (rest-fram e) is statistically signi cant at the 93 per cent con dence level.

In the case of those sources where we have many photons to perform a model tting with the standard 2 analysis, we not that the model ts well the data except from the C handra ts of A X J1511.7+0758 and A X J1531.8+2414. The second source has also been observed by X M M $^4\!N$ ewton , and the model provides a good to the data. The best

tting spectral slope (= 2:4) is steeper than the = 1:9 value that we used for the model thing of the Chandra spectrum. When we leave the photon index free in the Chandra spectral twe obtain = $2:40^{+0:24}_{0:13}$ w ith 2 = 38:3=23 in excellent agreem ent with XMM -Newton . The other source, AXJ1511.7+0758, is the less lum inous in our sample. Its optical counterpart has a NL spectrum . The relatively low lum inosity combined with the steep X-ray spectrum raises the possibility that a large fraction of the X-ray emission com es from star-form ing processes. Thus we have added a Raymond-Smith component to the X-ray spectrum. The addition of this component signicantly improves the t 36:9=20 for kT 02 keV). Leaving free the photon index as well results in a further im provement (The best t photon index becomes = $1.46^{+0.22}_{0.18}$.

The absorbed ux estimates from the Chandra and XMM-Newton spectra are in agreement, except from the case of AXJ1230.8+1433, AXJ1406.1+2233, and AXJ1532.5+2415, which show a ux variation of the order of 0.6, 2.5 and 3, respectively, between the Chandra and XMM-Newton observations. The two observations are separated by about 0.5, 10 and 13 months, respectively. The last object is still spectroscopically unidentied and hence we cannot estimate its luminosity. On the other hand, the other two objects are ofmoderate luminosity (3 and 9 10^{43} erg s 1 respectively). Similar amplitude variations are observed in nearby BL objects on similar time scales. There is also a reasonable agreement, within the errors, between the Chandra and the XMM-Newton NH best tting values.

M ost objects in the current sample show some amount of intrinsic absorption. Among the 11 objects with optical identications, six are \absorbed" systems (i.e. they have a column density of > 10^{22} cm 2). Nevertheless, ve \soft", i.e. N_H < 10^{22} cm 2 , sources can still be found in our sample. Sources A X J1511.7+ 0758, A X J1531.8+ 2414 and A X J1531.9+ 2420 have not been observed by RO SAT. As they are soft bright sources, they would probably have been detected. Source A X J1035.1+ 3938 was lying within the eld-of-view (4.5 arcm in o -axis) of a RO SAT HRI pointing (1.7 ksec) but was not detected. Finally, source A X J1230.8+ 1433 has been detected by RO SAT HRI.

In general, optically classied NL objects show more obscuration when compared to the BL objects. The median column density of the former class of objects in our sample $2 10^{22}$ cm 2 , compared to $7 10^{20}$ cm 2 for the BL AGN. In fact, using a Kolm ogorov-Sm imov test we nd that the column density distribution of the NL and BL samples are di erent at the 87 per cent signi cance level. This is not a highly signi cant result (because of the small number of sources in our sam ple) but is nevertheless indicative that the trend we observe, i.e. N $_{\rm H}$;N $_{\rm L}$ > N $_{\rm H}$;B $_{\rm L}$, m ay correspond to a real characteristic of the SHEEP sources. However, there are two clear exceptions to the general trend. The object which presents the highest X -ray obscuration is a BL AGN (A X J0140.1+0628 at z=0.5). Reversely, one of the objects with the lowest obscuration is a NL source at redshift of 0.045 (A X J1511.7+ 0758).




Figure 3.The redshift distribution of the BL (NL) AGN denoted with open (hatched) histogram.

Finally, there is a separation in redshift between BL and NL populations in our sample. The NL AGN are preferentially found at low redshifts (median redshift z=0.11) while the BL AGN are in general located at higher distance having a median redshift of z=0.5 (see Fig. 3). Applying the




Figure 4.The column density derived from the Chandra spectral ts as a function of the 2-10 keV intrinsic luminosity. BL (NL) AGN are denoted with lled (open) symbols. The triangles denote upper limits. The errors correspond to the 90 per cent con dence level.

W ilcoxon, M ann, W hitney rank sum test, we nd that the probability of BL objects having a median redshift larger than that of the NL objects is higher than 90%. A gain, this is not a highly signi cant result, but it is highly suggestive that NL objects are rare at redshifts higher than 0.3. A ltematively, as there is a tight correlation between redshift and lum inosity in ux limited surveys, high luminosity sources, i.e. $L_{\rm X} > 10^{44}$ erg s 1 , appear to be associated primarily with BL AGN while the lower luminosity ones with NL AGN. The only highly luminous ($L_{\rm X}$ 10^{45} erg s 1) NL object in our sample (A X J0144.9-0345) has high column density (N $_{\rm H} > 10^{22}$ cm 2) and thus is a candidate type II Q SO .

4 DISCUSSION

Our survey provides a glim pse of bright, nearby examples of the hard AGN population which produces an appreciable fraction of the X-ray background. The subsample of the SHEEP survey presented here contains both Type I (BL) and Type II (NL) AGN, according to the optical classica-

A Ithough the number of objects that we study is small, we nd that there is a considerable di erence in their redshifts, with N L objects preferentially found at redshifts lower than those of BLAGN. The cross-correlation of GINGA and HEAO-1 X-ray background maps above 2 keV with nearby galaxy catalogues, demonstrates that an appreciable fraction of the hard X-ray em ission may arise at low redshift, 0:1 (Jahoda et al. 1991, Lahav et al. 1993). Our NL AGN clearly provide examples of this nearby AGN population. The distance separation between NL and BL AGN is ubiquitous in hard X-ray surveys with the redshift peak of the populations depending on the surveys's ux lim it.

Our results are consistent with the hypothesis that N L AGN are, on average, less lum inous than 10^{44} erg s 1 . A \vdash

though our statistics is clearly small, the same e ect i.e. the NL AGN occupying preferentially the low lum inosities, can be also witnessed in the XMM -Newton hard 4.5-7.5 keV sam ple of Caccianiga et al. (2004) which contains 28 sources. Five out of the seven NL AGN in Caccianiga et al. (2004) have 2-10 keV intrinsic lum inosities lower than $10^{44}\ \mathrm{erg\ s}^{-1}$. Obviously, larger surveys are needed in order to con m unambiguously that NL AGN are intrinsically less luminous than the BL AGN. For example, this could be the case in a scenario where highly lum inous AGN (QSO) com e preferentially in a \Broad Line avour" in contrast to the low lum inosity AGN (Seyferts) which appear as both NL or BL according to the viewing angle in respect to the obscuring torus. Ste en et al. (2003) nd that the fraction of N L AGN decreases at high redshift, z > 1. Treister et al. (2004) observe the same e ect but raise the criticism that this could be caused by incompleteness in the spectroscopic identication. Indeed lum inous N L A G N at high redshift cannot be easily detected in the optical owing to large amounts of redenning (e.g. Fiore et al. 2003). The results em erging from our own survey as well as from that of Caccianiga et al.




Figure 2.The X-ray spectra (XMM-Newton or Chandra) together with the best tpower-law model and the residuals (lower panels). Only the XMM-Newton spectra are presented (both the MOS and PN in the same panel) where available. In the case where the spectra have been tted with C-statistic we bin the data to produce a signal to noise ratio of 10 for illustrative purposes

(2004), which has practically complete spectroscopic identication, lend support to the ndings of Ste en et al. (2003). We note that the density of NLAGN in Ste en et al. (2003) decreases only at z > 1. A direct comparison of the redshift distribution of our sample with that of Ste en et al. is not straightforward as the ux limit of the latter sample is much deeper. Nevertheless, if the NLAGN are intrinsically fainter than the BLAGN, the elect is that the NLAGN are observed at lower redshifts compared with the BL ones in any given survey. Similarly, recent surveys (e.g. Barger et al. 2004) show evidence of \cosmic downsizing" where the low luminosity AGN have been formed at a later epoch compared with the bright QSOs. In particular, the peak of the redshift distribution of the low luminosity AGN peaks around z = 0.7. Thus given that the NLAGN are low lumin

nositiy sources this provides an additional reason why these are observed at relatively low redshifts.

The column density distribution is almost equally divided between high and low column densities (table 4). In particular the fraction of sources with N $_{\rm H}~>~10^{22}$ cm $^{-2}$ is 58 22 per cent. It has to be mentioned that we are dealing with a biased 'hard' sample since we have primarily observed with Chandra , the sources for which no ROSAT positions are available (ie those either not detected or not observed by ROSAT) and hence the above fraction should be only viewed as an upper limit. Therefore, our sample cannot provide a fair comparison with the X-ray background population synthesis models of e.g. Comastri et al. (2001). We note that Caccianiga et al. (2004) nd a fraction of 26 10 for the fraction of obscured AGN, inconsistent with the predictions of

C om astriet al. (2001).W e should be able to provide stronger constraints, when all the objects in the SHEEP survey have been observed by Chandra .

W e $\$ nd that N L objects are m ore obscured $\$ com $\$ pared to BL objects, as expected from Unication models. However, there is a notable exception as the hardest source in the sam ple is associated with a BL AGN (0140.1+0628). The X M M - New ton spectrum presented here con ms the column density derived from the Chandra hardness ratio analysis (N andra et al. 2004). The observed colour (B $\{R = 0.8\}$) suggests little absorption in the optical: A $_{\text{V}}$ 1:5 assum ing B { R = 0.3 at z = 0.5 according to the SD SS Q SO tem plate spectrum of Vanden Berk et al. (2002). On the other hand the column density measured in the X-ray spectrum corresponds 55 assum ing the G alactic dust-to-gas ratio (Bohlin, Savage & Drake 1978). This large discrepancy can be naturally explained by sublimation of the dust (eg Granato, Danese & Franceshini 1987). This may be the case in Broad-Absorption-Line (BAL) QSOs which usually present large absorbing column densities in the X-ray spectra, with typically $N_H > 10^{23}$ cm 2 (G allagher et al. 2002), while they present moderate reddening in their colours (Brotherton et al. 2001). A ctually, from the existing optical spectrum alone we cannot exclude the possibility that our object is a BAL. Them ost e cient diagnostic for the classic ation of a source as a BAL is the presence of a broad C IV line (1549 A) which is outside the spectral window at the redshift of our object.

Finally, one the softest X-ray sources is associated with a N L source (A X J1511.7+0758). It is puzzling why the optical reddening which should be responsible for the obliteration of the broad-line region does not produce signi cant absorption in X-rays. Typically, N L A G N (Seyfert-1.8-1.9.-2.0) present column densities higher than 10^{23} cm 2 (eg Awakiet al. 1991). One possibility is that at the low lum inosity regime -our source has $L_x = 10^{42} \mbox{ erg s}^{\mbox{ 1}}\mbox{-no broad-line region is}$ form ed (Nicastro 2000). Indeed, there are a few bona-deexam ples of Seyfert-2 galaxies, (see Panessa & Bassani 2002, Georgantopoulos & Zezas 2003) with no obscuration in Xrays. A Itematively, the possibility that, at least, the X-ray em ission com es prim arily from star-form ing processes cannot be ruled out. As discussed earlier the X-ray spectrum requires the presence of a soft therm alcom ponent. This would naturally explain the relatively low level of X -ray lum inosity (see e.g. Zezas, Georgantopoulos & W ard 1998) as well as the soft X-ray spectrum. Nevertheless, the weak H relative to the [O III] line as well as the relative strength of the N II relative to the H a suggest against the star-form ation activity.

5 SUMMARY

W e present Chandra and XMM-Newton observations of a subsample of 12 bright sources (f(2 $\,$ 10keV) > 10^{-13} erg cm 2 s 1) from the SHEEP ASCA 5-10 keV catalogue. We have obtained optical spectroscopic observations for 11 of these. The optical spectra show that our sources are associated with both NL and BLAGN. The X-ray spectra reveal intrinsic absorbing column densities of the order $10^{20}\,$ $10^{23}\,$ cm 2 . The BLAGN on average do not present obscuration in X-rays compared to the NLAGN. There are however exceptions in this trend with the most obscured source being a

BLAGN.Although the statistics is limited, the NLAGN are found at lower redshift and luminosity compared with the BL sources. The most likely explanation is that NLAGN are intrinsically less luminous than the BL ones and thus they are preferentially found at lower redshifts.
