# N ew s from the \D entist's C hair": Observations of A M 1353-272 w ith the V IM OS IFU

Sum m ary. The galaxy pair A M 1353-272 nicknam ed \The D entist's C hair" show s two 30 kpc long tidal tails. P revious observations using $\mathrm{m} u$ uti-slit m asks show ed that they host up to seven tidaldw arf galaxies. The kinem atics of these tidaldw arfs appeared to be decoupled from the surrounding tidal $m$ aterial. $N$ ew observations of the tip of the southem tidal tail with the VIM OS integral eld unit con $m$ the results for two of these genuine tidal dwarfs but raise doubts whether the velocity gradient attributed to the outerm ost tidal dw arf candidate is real. W e also discuss possible e ects to explain the observational di erence of the strongest velocity gradient seen in the slit data which is undetected in the new integral eld data, but arrive at no m conclusion. A dditionally, low -resolution data covering $m$ ost of the tw o interacting partners show that the strongest line em itting regions of th is system are the central parts.

## 1 Introduction

Follow ing old ideas about the creation of dwarf galaxies during interaction of giant galaxies and detailed investigations of several nearby exam ples of these T idal D warf G alaxies (T D G s, D uc et al, 2000, 1997; D uc \& M irabel, 1998; H ibbard et al., 1994), we carried out a rst sm all survey of interacting galaxies (W eilbacher et al, 2000) w ith the aim of better understanding the star-fom ation history of TDGs and constraining the num ber of TDGs that are built per interaction (W eilbacher et al., 2003). D uring this survey, we studied a system cataloged as AM 1353-272, which we called \T he D entist's C hair" for its peculiar shape. Fig. 1 show s the tw o com ponents of the system, A', a galaxy w ith 30 kpc long tidal tails, and $\mathrm{B}^{\prime}$, a disturbed disk galaxy, have a distance of D $\quad 160 \mathrm{M} \mathrm{pc}\left(\mathrm{H}_{0}=75 \mathrm{~km} \mathrm{~s}{ }^{1} \mathrm{M} \mathrm{pc}{ }^{1}\right) . \mathrm{W}$ thin the tails several obvious chum ps w ith blue optical colors are visible. U sing optical and near-infrared im aging, evolutionary m odels, and optical spectroscopy, seven of these clum ps were classi ed as TDG candidates in form ation (W eilbacher et al, 2002, , marked $\mathrm{a}^{\prime}$ to $\mathrm{d}^{\prime}$ and $\mathrm{k}^{\prime}$ to $\mathrm{m}^{\prime}$ ). The largest velocity gradient
w ith an am plitude of $>300 \mathrm{~km} \mathrm{~s}{ }^{1}$ appeared in TD G candidate $\mathrm{a}^{\prime}$, at the very end of the southem tidal tail. This raised the question how an ob ject w ith relatively low lum inosity could exhibit such fast \rotation". H ow ever, as these observations w ere done using the multi-slit technique and hence are spatially restricted due to the narrow slit, subsequent observations were planned using an integral eld unit ( $\mathbb{F} U$ ) to cover more of the tidal tails and view the velocity structure of the TDGs in two dim ensions.

## 2 IFU Observations

O ur new VIM OS data taken at the ESO VLT consists of 1.3 hours of exposure tim $e$ in high resolution blue m ode ( eld of view of $13^{\infty} 13^{\infty}$ ) and good seeing conditions ( 009 ), targeted at the tip of the southem tidal tail. This includes the TDG candidates $a^{\prime}$ to $r^{\prime}$. The center of galaxy $A^{\prime}, m$ uch of the southem tidal tail, and the com panion $B^{\prime}$ were targeted $w$ ith low resolution (blue grism, $54^{\infty} 54^{\infty}$ ), and observed for 1 hour in $m$ ediocre conditions $w$ ith $2^{\varrho}!0$ seeing. These tw o pointings are sketched in F ig. 1 .

$T$ he data were reduced using the ESO pipeline for the VIMOS instru$m$ ent. W e m ade a sm all enhancem ent to the code that allowed us to interpolate the wavelength solution between adjacent spectra on the CCD. This was only used for the low-resolution data, where the errors introduced w ith this $m$ ethod are sm aller than the accuracy allowed for by the spectral resolution. In low resolution mode, on the order of $15 \%$ of the spectra could not be wavelength calibrated due to overlapping spectral orders. From the nal datacube of extracted and wavelength calibrated spectra, we m easured the relative uxes and velocities in each spectral elem ent using G aussian ts to the brightest usable em ission line. In the low resolution data [0 iii15007 is the strongest em ission line but at this redshift (z $0: 04$ ) it is strongly blended w ith a sky em ission line, so H had to be used instead. In the high-resolution data, [ O iiilj5007 is less a ected by the sky-line and is the only line w ith suf-
cient $S / N$ for the analysis in the low surface brightness region near the end of the tidal tail.

## 3 R esults

Fig. 2 sum $m$ arizes the results that can be derived from the low-resolution pointing using ts to the H em ission line. The southem tidal tail in undetected in this exposure and the strongest line em ission appears to be in the center of $A^{\prime}$ and in the tw o knots at the end of its bar-like central structure (designated $y^{\prime}$ and $~^{\prime}$ in $W$ eibacher et al, 2002). G alaxy $B^{\prime}$, despite being strongly reddened, also is a strong source of H line em ission. A s the velocity resolution is on the order of $100 \mathrm{~km} \mathrm{~s}^{1}$, in this m ode of $V \mathbb{I M} O S$ we cannot resolve the velocity structures in individual knots, but the bar-like structure

in $A^{\prime}$ seem $s$ to rotate (the eastem end near knot $Y$ is receding, the westem end near knot $\mathrm{g}^{\prime}$ is approaching). The sam e is true for the com panion $\mathrm{B}^{\prime}$.

To verify our original FORS2 multi-slit observations, we try to \reconstruct" them from the VIMOS datacube. To that end we average over the spaxels approxim ately in the dispersion direction of the FORS2 observations and derive an average redshift over the slit width. Fig. 3 show $s$ the resulting velocity eld along this arti cialslit and com pares it with the velocity pro le of the FORS2 data. From this plot it can be seen that the velocity gradients of knots $b^{\prime}$ and $C^{\prime}$ are very well recovered, while the steep slope $w$ ith in knot $a^{\prime} w$ th an am plitude of $350 \mathrm{~km} \mathrm{~s}^{1}$ in the FORS2 data appears alm ost at in the reconstructed V IM OS data. W e tested several altemative slit positions and curvatures, varied the e ective slit width, and also tried to add slit e ects (velocity o sets due to non-centered em ission within the slit) to our reconstruction. $N$ one of these changes im proved the $m$ atch for knot $a^{\prime}$. In fact, slit e ects signi cantly w orsened the agreem ent for all three knots. The FORS2 observations were done on these extended ob jects in 190 seeing with a 1.2 slit, so that it appears unlikely that slit e ects would have a strong contribution to the observed velocity gradient. O ther problem s, like instrum ental exures should have been rem oved by the data reduction procedure as detailed in $W$ eilbacher et al. (2002). W e are therefore con dent that slit e ects do not play an im portant role in the FORS2 data. On the other hand, if we assum e that the original slit-based data give the correct results it is unclear, how the VIM OS data could be awed to hide this one velocity gradient. The
w avelength calibration w orks well for the high-resolution $m$ ode as con m ed by checks w ith sky em ission lines.

## 4 Sum m ary \& O utlook

W e presented a few tentative results for the interacting system called $\backslash T$ he D entist's Chair" from new observations w th the V $\mathbb{M} O S$ integral eld m ode: line em ission seem $s$ to be concentrated $w$ ithin the centers of the interacting partners while the tidal tails them selves are not detected $H$ narrowband slices. T hree knots, previously identi ed as TDG candidates near the end of the southem tidal tail, are detected in [0 iii]5007 em ission. For tw o of them the velocity pro les were con m ed. H ow ever, the strongest velocity gradient in the outerm ost TDG candidate (knot $\mathrm{a}^{\prime}$ ) as m easured on FORS2 data is not con m ed by the VIMOS datacube. The reason for this discrepancy is unknown.

To solve this $m$ ystery and nd m ore clues to the origin of the velocity elds seen in this interacting system, further, deeper $\mathbb{F} U$ observations, taken w th appropriate dither o sets to facilitate $m$ ore accurate sky subtraction, are required.W ith other instrum ents likee.g.the GM OS $\mathbb{F}$ U would be possible to cover both the C a-triplet and H in the sam e exposures and directly com pare the stellar velocity eld w ith ionized gas dynam ics. A s good $\mathrm{S} / \mathrm{N}$ is required to detect the absorption lines, this can only be done in the brighter northem tidal tail.
