Initial conditions for reaching the critical velocity

A bstract. The aim of this paper is to determ ine the initial rotational velocities required on the ZAMS for single stars to reach the critical velocity, som etim es called the break-up velocity, during the M ain-Sequence (MS) phase. Som e useful relations between $=_{\rm crit}$, $=_{\rm crit}$ (is the velocity at the equator), the m om ents of inertia, the angular m om enta, the kinetic energy in the rotation and various other basic physical quantities are obtained.

1. Stellar evolution near the critical lim it

The new results from VLTI on the shape of A chemar (D om iciano de Souza et al. 2005) show that detailed parameters of rotating stars become accessible to interferom etric observations. In order to make valuable comparisons with models of rotating stars, we provide here a few basic data on rotating stellar models.

W e also search the initial conditions required for a star to reach the critical lim it during its M ain-Sequence phase. W hen the surface velocity of the star reaches the critical velocity (i.e. the velocity such that the centrifugal acceleration exactly balances gravity), one expects that equatorial ejections of matters ensue (Townsend et al. 2004). The physics involved in the ejection process, determ ining the quantity of m ass ejected, the tim escales between outburst episodes, the conditions required for a star to present such outbursts are in portant questions not only for understanding Be, B [e] or Lum inous B lue Variable stars, but probably also for having a better know ledge on how the st stellar generations in the Universe behaved (Ekstrom et al. 2005). Indeed, at lower metallicity, the stellar winds are weaker and much less angular momentum is removed at the surface. This favors an evolution to the critical lim it and m ay have im portant consequences for the evolution of the statellar generations. A loo there are some indications that the distribution of the initial velocities contains more rapid rotators at lower m etallicity (M aeder et al. 1999). Finally, realistic sim ulations of the form ation of the rst stars in the Universe show that the problem of the dissipation of the angular momentum is more severe at very low Z than at the solar Z. Thus these stars m ight begin their evolution with a higher am ount of angular m om entum (A bel et al. 2002).

Rotation a ects all the outputs of the stellar models. The reader will nd reviews on the e ects of rotation in M aeder & M eynet (2000a), H eger & Langer (2000), Talon (2004) and M eynet & M aeder (2005b). In this work, we compute 112 di erent stellar models with initial masses equal to 3, 9, 20 and 60 M , for m etallicities Z equal to 0, 0.00001, 0.002 and 0.020, and for values of the ratio

of the angular velocity to the critical angular velocity _{crit} equal to 0.1, 0.3, 0.5, 0.7, 0.8, 0.9, 0.99. For the 3, 9 and 20 M models, the computation was perform ed until the end of the M ain-Sequence phase or until the star reaches the critical velocity. For the 60 M stars, we have obtained all the models on the ZAM S, but only a subset of them were computed further on the M ain-Sequence. W e consider that a star arrives on the ZAM S, when a fraction of 0.003 in m ass of hydrogen has been burned at the center. On the ZAM S, the star is supposed to have a solid body rotation. D uring the M ain-Sequence phase the variation of

inside the star is computed self-consistently taking into account the various transport mechanisms, i.e. convection, shear di usion, meridional circulation and horizontal turbulence. The removal of angular momentum at the surface by the stellar winds and the changes of resulting from movements of contraction or expansion are also accounted for. A detailed description of the physical ingredients used in this grid of models will be given elsewhere (Ekstrom et al., in preparation), let us just mention here that the prescriptions for the opacity tables, the initial chemical compositions and the treatment of convection are as in M eynet & M aeder (2005a).

Based on the set of num erical results described above, we rst present useful relations between basic quantities, and then explore the initial conditions required for a star to reach the critical velocity during it M S evolution.

2. M om ents of inertia and energy contents on the ZAM S

Figure 1 shows for di erent initialm asses and m etallicities the m om ent of inertia and the gravitational energy of the stellar m odels on the ZAM S.O nly the results obtained for a value of = crit equal to 0.7 are presented, since these quantities present a very weak dependence on = crit. Num erically, these quantities were

computed by summing the contribution of the di erent shells composing the star (between 250 and 400 shells). Since the deformation due to rotation is very weak in most of the star (even near the critical velocity) and since the outer layers contain little mass, we neglect, in all the following estimates, the deformation of the shells induced by rotation. To each isobaric surface, limiting a volume V (which is not a sphere), we associate an average radius r given by $r = (V = (4=3))^{1=3}$.

Looking at the results concerning the moments of inertia, we note that, at a given metallicity, the moments of inertia increase with the initial mass. The increase amounts to about 3 orders of magnitudes between 3 and 60 M \cdot . For the non-zero metallicities, we have linear relations between log I and log M \cdot . In the case of the Pop III stellar models, the linear relation breaks down and the increase of the moment of inertia with the mass is less steep than at higher metallicities.

W hat is the cause of this di erence? Passing from 3 to 60 M increases the radius by a factor 5-6, whatever the m etallicity between Z = 0.00001 and 0.020 (see the left part of F ig. 2). On the other hand, for zero m etallicity stars, the radius passes from about 1 R for a 3 M stellar model to 3.2 R for a 60 M , thus the increase am ounts to only a factor 3. This comes from the fact that, at the beginning of the core H-burning phase in Pop III m assive stars, only the pp chains are active. The pp chains are not e cient enough to compensate for the energy lost at the surface and the starm ust extract energy from its gravitational reservoir. The contraction is more severe in the higher mass range where the lum inosities are higher. This explains the shallow er increase of the radius as a function of the mass in Pop III stars and therefore the less steep increase of the m om ent of inertia with the mass.

Let us add here that the contraction occurring in Pop III stars at the beginning of the core H-burning phase leads to an increase of the central tem perature until the point of helium ignition is reached. Then, due to He-burning, sm all am ounts of carbon and oxygen are synthesized. W hen the abundances of carbon and oxygen in the core reach a level of 10 10 in m ass fraction, the H-burning can occur through the CNO cycle and this cycle becom es, as at higher m etallicity, the dom inant energy source for the rest of the M ain-Sequence phase.

Looking at the left part of F ig. 1, we note that, for a given initial m ass, the variation as a function of the m etallicity is much smaller than the variation as a function of the initial m ass at a given m etallicity. There is at m ost an order of m agnitude of decrease when the m etallicity passes from Z = 0.020 to 0. The decrease is more pronounced in the range of the high m ass stars than in the range of the interm ediate m ass stars. The reason for that is again the di erence in the way the beginning of the H-burning occurs in m assive P op III stars.

The gravitational energy or binding energy is shown in the right part of Fig. 1. Passing from 3 to 60 M , the binding energy increases by about two orders of magnitude. For a given initial mass, the dependence on the m etallicity is much more modest. For a 20 M stellar model at Z = 0.020 the binding energy is about 4 10⁰ ergs, its Z = 0 counterparts has a binding energy equal to slightly more than 10^{51} ergs, i.e. about a factor 2.5 higher. Let us recall for comparison that the binding energy of a neutron star is of the order of 10^{53} ergs, about two orders of magnitude greater.

The left part of F ig.2 show show the polar radii of the di erent m odels vary as a function of the initial m ass and m etallicity. The right part of this gure illustrates the fact that in the 3 M stellar m odel, a given fraction of the total m ass is enclosed in a smaller fraction of the total radius than in the 60 M , indicating that lower m ass stars have a more concentrated m ass distribution than higher m ass stars.

3. Critical velocity, angular m om entum, kinetic energy of rotation and surface velocity on the ZAM S

The variation of the critical velocity as a function of the initial mass and metallicity is shown in Fig. 3. At a given metallicity, the critical velocity is higher for higher initial mass stars. The increase is not far from being linear. The slope remains nearly the same for metallicities higher than 0.00001, while it is

much steeper for the pop III stellar models. For a given initial mass, the critical velocity is higher at lower Z. For the 60 M model, the critical velocity passes from slightly more than 800 km s¹ at Z=0.02 to nearly 1600 km s¹ at Z=0.

The critical periods are shown on the right part of Fig. 3. They are related to $_{crit}$ by the simple relation $P_{crit} = 2 = _{crit}$. The critical periods are com - prised between 2.5 and 25 days for the whole dom ain of m asses and m etallicities explored in the present work.

The variation with = crit of the total angular m om entum content is shown in Fig. 4. Note that the highest point on the right of the gures gives an estim ate of what could be called the critical angular m om entum content. Since the m om ent of inertia of the star does not depend m uch on the rotation velocity, and since on the ZAM S, we supposed solid body rotation, one obtains linear relations between L and = crit. We note that the m etallicity dependence rem ains m odest at least in the range of m etallicities between 0.00001 and 0.020. For the 9 M m odels and above, starting from the Z=0.020 m odels, there is

rst a slight increase of the angular m om entum content when lower m etallicities are considered, the initial m ass and the value of $= _{crit}$ being kept constant (com pare the curve with the black squares for the Z=0.020 m odels with the curve with the triangles corresponding to 0.002 m odels). Then for still lower m etallicities, the angular m om entum decreases with the m etallicity (the curve for the Z=0.00001 m odels overlap the Z=0.02 m odels) reaching its lower values for the P op III stellar m odels.

In the mass range between 9 and 20 M , two stars on the ZAM S, having the same angular momentum content, would have very similar value of = $_{\rm crit}$ whatever their metallicity between 0.00001 and 0.02. Only if the metallicity is zero, would the value of = $_{\rm crit}$ corresponding to that angular momentum content bem uch higher. As a num erical example, a 20 M on the ZAM S with L= 0.3 1^{53} cm² g sec¹ has a = $_{\rm crit}$ = 0.5 when Z is comprised between 0.00001

and 0.020. This angular momentum content corresponds to $= c_{\text{crit}} = 0.3$ when Z = 0.

The rotational kinetic energy expressed as a fraction of the binding energy is shown in Fig. 5. Rotational energy amounts to at most a percent of the binding energy. This is consistent with the well known fact, that the e ects of the centrifugal acceleration remains quite modest on the hydrostatic structure of the stellar interior, even when the surface rotates with a velocity near the critical one.

The relations between the equatorial velocity and $= _{crit}$ are plotted in Fig. 6. We give in Table 1 the values of obtained for $= _{crit} = 0.7$ for various m asses and m etallicities. The value $= _{crit} = 0.7$ corresponds to an initial rotation of 290 km s¹ for a 9 M stellar model. The time averaged velocity of this model during the M ain-Sequence phase is equal to 240 km s¹.

We see that for a given value of $= _{crit}$ and of the initial mass, the surface equatorial velocity is higher at low er Z. At a given m etallicity, a value of $= _{crit}$ corresponds to a value of the equatorial velocity which is higher for higher initial m asses. This means that if the stars begin their evolution on the ZAM S with

approximately the same value of $= _{crit}$, they have a higher surface velocity at lower metallicities and for higher initial masses. For instance, a 3 M stellar model with an initial value of $= _{crit}$ equal to 0.7 has an initial velocity equal to 220 km s¹ (see Table 1), while a 60 M model, starting with the same value of $= _{crit}$, has an initial velocity of 800 km s¹.

4. The Roche model and surface deform ation on the ZAM S

The relation between $=_{crit}$ and $=_{crit}$ obtained in the frame of the Roche model is shown in Fig. 7 (left part). This relation is the same whatever the initial mass or metallicity. One sees that except at the two extremes, the values of $=_{crit}$ is smaller that that of $=_{crit}$. The variation with $=_{crit}$ of the ratio of the equatorial radius to the polar radius is also a property of the Rochem odel. It is shown in the right part of Fig. 7. We note that for $=_{crit}$ below 0.7, the equatorial radius is longer than the polar one by less than 10%.

The variation of the polar radius when the rotation velocity varies is illustrated in the left part of Fig. 8. For the 3, 9 and 20 M at solar metallicity, the polar radius decreases when the rotation increases. The decrease is at most 1.5%. For the 60 M model the behaviour is reversed, the polar radius slightly increases when rotation increases. The maximum increase amounts to 4.5%. This di erence of behavior for the 60 M star is likely linked to the fact that in massive stars radiation pressure plays a more important role.

In the right part of Fig. 8, the variation of the lum inosity as a function of the rotation is shown for 60 M stellar models on the ZAMS at various m etallicities. One sees that the lum inosity decreases by at most 5 to 10% when rotation increases up to the critical limit. This is due to the fact that a rotating star is, on the average, more extended. As a consequence, the gradients of the tem perature and thus the uxes are smaller.

5. Initial conditions for reaching the critical lim it

The conditions for reaching the break-up lim it have recently been reviewed by M eynet & M aeder (2006). We concentrate here on the case of 20 M stellar m odels. The cases of the other initial m asses will be discussed in E kstrom et al. (in preparation).

Figure 9 shows the evolution of the surface velocity expressed as a fraction of the critical velocity during the M ain-Sequence phase. The com putations were stopped as soon as the star reaches the critical lim it. Q uite generally the curves can be decom posed into three parts, whose importance depends on the initial rotation and m etallicity:

1. At the very beginning, there is a short adjustment period, which lasts for a few percents of the M ain-Sequence lifetime, during which meridional circulation transports angular momentum from the outer parts of the star to the inner ones, until an asymptotic prole of the angular velocity is reached (Zahn 1992). As a consequence the surface velocity decreases. For instance, a value of = crit on the ZAM S equal to 0.35 passes to a value of 0.30 or slightly lower after a few 10⁵ years. For lower initial values

of = crit the decrease is much weaker, while for higher values, it is higher. This illustrates the dependence of the meridional velocity on \cdot .

2. As explained for instance in M aeder & M eynet (2000a), after the rst adjustment period, a large outer cell of meridional circulation sets in, transporting angular momentum from the inner parts of the star to the outer ones. If this transport is rapid enough and the stellar winds not too intense, then, = $_{\rm crit}$ increases. This is the case for all the models with = $_{\rm crit}$ 0:3 for Z 0:00001. For Pop III stars, the increase of = $_{\rm crit}$ only occurs for the model with = $_{\rm crit}$ = 0:7. This is a consequence of the G ratton-O pick e ect making the meridional circulation velocity smaller at lower Z. 3. At the end of the M ain-Sequence phase, the increase of $= _{crit}$ accelerates when the star contracts after the blue hook in the HR diagram.

At solar m etallicity, the lower initial value of $= \operatorname{crit}$ for a 20 M star to reach the critical limit during the M ain-Sequence phase is about 0.8 ($_{ini} = 400$ km s¹). At Z = 0.002 the lim it ing value is around 0.7. At Z = 0.00001, the lim it ing value is below 0.7, while for Pop III stars, the lim iting value is about 0.99 ! M ore precise values will be given in Ekstrom et al. (in preparation), how ever based on these results we can already draw the following consequences: only stars with a su ciently high initial velocity will reach the critical limit. This is well in line with the results obtained by M artayan et al. (2005) showing that the initial velocities of the Be stars is signi cantly higher than the initial velocities of the normalB stars. For 20 M stars, the range of initial velocities for which the star reaches the critical lim it during the MS phase is larger at lower Z when Z varies between 0.02 and 0.00001. For pop III 20 M stellar models, this range is much smaller than at higher metallicities. For higher initial mass stars, the lum inosity may be su ciently close from the Eddington lim it that the {lim it can be reached (M aeder & M eynet 2000b).

The complete coverage of the ranges of initial masses, metallicities and velocities will allow to make predictions for the frequency of Be stars resulting from single star evolution at various metallicities.
