# Physical parameters of the 06.5V + B1V eclipsing binary system LS 1135

### ABSTRACT

ASAS photom etric observations of LS 1135, an O {type SB1 binary system with an orbital period of 2.7 days, show that the system is also eclipsing. This prompted us to re{exam ine the spectra used in the previously published spectroscopic orbit. Our new analysis of the spectra obtained near quadratures, reveal the presence of faint lines of the secondary component. We present for the rst time a double{lined radial velocity orbit and values of physical parameters of this binary system. These values were obtained by analyzing ASAS photom etry pintly with the radial velocities of both components performing a numerical model of this binary based on the W ilson {D evinney m ethod. W e obtained an orbital inclination i 68 :5.W ith this value of the inclination we deduced masses M  $_1$ 30 1M and M $_2$ 9 1M ; and radii  $R_1$  12 1R and  $R_2$  5 1R for primary and secondary components, respectively. Both components are well inside their respective Roche lobes. Fixing the  $T_{eff}$  of the primary to the value corresponding to its spectral type (0.6.5V), the  $T_{eff}$  obtained for the secondary component corresponds approximately to a spectral type of B1V. The mass ratio M  $_2$ =M  $_1$ 0:3 is among the lowest known values for spectroscopic binaries with 0 {type com ponents.

#### 1 INTRODUCTION

The star LS 1135 ( $_{2000:0} = 08^{h} 43^{m} 50^{s}$ ,  $_{2000:0} = -46$  07' 09"), a member of the OB association Bochum 7 (Vela OB 3), was discovered by Corti et al. (2003, hereafter CNM) to be a single-lined binary (SB1) system with an orbital period of 2.7532 days. The spectrum was classified as 0.6.5V ((f)). The rather high am plitude of the radial velocity variations and the lack of detected spectral lines of the secondary com - ponent led CNM to suggest that the secondary m ight be an early B type star.

M agnitudes and colors for LS 1135 from photoelectric photom etry have been published by M o at & Vogt (1975) as V = 10.38; B V = 0.4; U B = 0.68, and by D rilling (1991) as V = 10.38; B V = 0.38; U B = 0.66. LS 1135 was found to be a photom etrically variable star in the \All Sky A utom ated Survey" (ASAS) (cf. Pojm anski 2003). It is catalogued as an eclipsing system, and a period of 2.7532 days was found independently in the photom etric data, in perfect agreem ent with the period obtained from the radial velocities by CNM. The fact that LS 1135 is an eclipsing binary, m otivated us to search for signatures of the secondary component by reinspecting the spectra used by CNM. Here we report the discovery of the spectral lines of the secondary, and calculate for the rst time a double{lined radial velocity orbit and a set of values of the m ain physical param eters of the components of LS 1135. These are based on a simultaneous analysis of the photom etric light curve and radial velocity variations of both components by m eans of the W ilson-D evinney (W {D) Code (W ilson & D evinney 1971, W ilson 1990, W ilson & Van Hamme 2004).

# 2 OBSERVATIONS

## 2.1 The ASAS V light curve of LS 1135

A SAS (cf.Pojmanski 2002) has been monitoring photom etrically a large part of the sky down to stellar magnitude V  $14^{m ag}$ . The ASAS instrument was upgraded in late 2000, being then called ASAS-3 (Pojmanski, 2001). The current conguration obtains images with a wide-eld (8:8 x 8:8) CCD camera, using a standard V liter. The scale

( 15"=pixel) of the system results in sub-sampled in ages, which are suitable to be analyzed through aperture photom etry. Figure 1 shows a 4' x 4' region of the sky around LS 1135.

LS 1135, catalogued as ASAS 084350-46072, is classied as an eclipsing binary of type ESD/ED (sem idetached/detached) in the ASAS-3 Catalog of Variable Stars, available in the Internet (cf. ASAS W eb Site). We have retrieved from the ASAS-3 database the V photom etric data of LS 1135 observed between 2000, N ovem ber, and 2005, July. The light curve is shown in Figure 2. The data in this gure correspond to V values measured with the 3 pixel (= 46".5) aperture. We selected 313 data values corresponding to this aperture because they show the light curve with the lowest dispersion of data points, and avoid the introduction of third light due to the star located 27" to the S-W of LS 1135 (see Fig.1).

W e note that there are several much fainter stars included in the photom etric aperture. Taking into account that according to the \The Tycho-2 Catalogue of the 2.5 M illion Brightest Stars" (H g et al. 2000), the magnitude di erence between LS 1135 and the neighbour at 27" to the S-W is 2.3 magnitudes, the other stars included in the aperture appear to be more than 5 magnitudes fainter than LS 1135. Thus their contribution to the total light would be less than 1%, which has been ignored in our analysis.

The zero point calibration used by ASAS photom etry is based on the H ipparcos photom etry (Perrym an et al. 1997).

#### 2.2 Spectroscopy

Photographic and digital spectra in the blue spectral region, as previously described by CNM, were used in our study of LS 1135.We have re{exam ined those spectra observed near the quadratures of the orbital motion in a search for spec-

tral signatures of the secondary component.We found that some of the Hei absorption lines appear double near the maximum radial velocity separation of the components.We could measure the radial velocities from these lines due to the secondary component in ten spectra. The values of these radial velocities were obtained tting gaussians to the spectral lines within the IRAF<sup>1</sup> routine splot, and are tabulated in Table 1 according the Heliocentric Julian D ate (HJD) of observations. The instrum ental con guration is given in colum n 3, following the notation from Table 1 in CNM. Typical errors in the determ ination of the radial velocities of the faint lines of the secondary component are rather large, 40 km s<sup>1</sup>.

## 3 THE RADIAL VELOCITY ORBIT

As a rst step to estim ate values of the physical parameters of the com ponents of the binary system LS 1135, we determ ined a double { lined radial velocity orbit for the binary. For this we adjusted circular orbits to the complete set of radial velocities i.e. those published by CNM for the primary, and the values listed in Table 1 for the secondary. Because the radial velocities of the secondary component have considerably larger errors, they were assigned lower weight. For the determ ination of the orbital elements we used an im proved version of the code originally published by Bertiau & Grobben (1969). Eccentricity was xed to 0.0 since both m in in a in the light curve appear symmetrically separated. W e also calculated an orbital solution leaving the eccentricity as a free param eter. This solution gave a very sm all value of the eccentricity, com parable with the error of the circular orbit. W e have therefore adopted e = 0 for further analysis in this paper.

The initial value for the period was set to 2.7532 days from the previously published single{lined radial velocity orbit. The value obtained for the double{lined radial velocity orbit resulted in almost the same value, namely 2.753205  $10^{5}$  days. The values of the orbital parameters are presented in Table 2. These values are to be considered as pre-

lim inary estimates, awaiting more accurate radial velocities for the secondary component from high resolution spectra with higher signal-to-noise ratio.

# 4 W {D ECLIPSING BINARY MODEL FOR THE LIGHT AND RADIAL VELOCITY CURVES OF LS 1135

In order to obtain the absolute values of the physical parameters of the binary components, we need to determ ine the orbital inclination i of the system . To this end, we adjusted a num erical eclipsing binary model to the observations, using the W {D Code.We used the PHOEBE package tool (Prsa & Zwitter, 2005) for the light curve (LC) and di erential corrections (DC) ts.ASAS photom etric data and radial velocities of both components of the binary system were used to adjust the model.

The code was set in M ode 2 for detached binaries with no constraints on the potentials (except for the lum inosity of the secondary component). The simplest considerations were applied for the emission parameters of the stars in the m odel, i.e. stars were considered as black bodies, approximate rejection m odel (M REF=1) was adopted, and no third light or spots were included. G ravity darkening exponents  $g_1 = g_2 = 1$  and bolom etric albedos A  $lb_1 = A lb_2 = 1$  were set for radiative envelopes. We used the square root limb darkening law. Bolom etric and V band limb darkening co-

e cients were taken from Van Hamme (1993).We adopted the mass ratio  $q = M_2 = M_1 = 0.31$  from our radial velocity orbit. The tem perature for the prim ary component was set to the corresponding value from the Spectral Type-T<sub>eff</sub> calibration tables published by M artins et al. (2005).T<sub>1</sub> was xed in this value and T<sub>2</sub> was computed with the model t. We considered that the system has a circular orbit and that both components rotate syncronously (F<sub>1</sub> = F<sub>2</sub> = 1). The radial velocity of the centre of mass of the binary system was xed in the value obtained from the radial velocity orbit.

Photom etric data were weighted from the originalm agnitude errors provided by the ASAS database taking the weight as w /  $1=m_{err}^2$ , in such a way that the observations with the lowest magnitude error had weight = 1.W e then generated synthetic light and radial velocity curves by m eans of the LC program of the W -D code, and adjusted them to the observations. In order to get a better delineated light curve, we proceeded to calculate norm alpoints of the ASAS photom etric data taking 0.02 phase bins. A weighted average of the magnitudes was computed for every bin, using the individual errors provided by ASAS database. A typicalrms 0:024 m ag is present in each m ean point for the aperture considered in this paper. The results of our best tting m odel are depicted in F igures 3 and 4 together with the norm alpoints of the ASAS light curve of LS 1135, and the observed radial velocities of both components, respectively. The physical parameters of the system are presented in Table 3.

## 4.1 Ephemeris

The ASAS-3 variable star catalog  $^2$  provides for the V data of LS 1135 an epoch  $T_0 = H JD 2451872.87$  together with the period which is used to construct the light curve as a function of the orbital phase. This epoch does not correspond to a time of m inimum light. We obtained the time corresponding to the principal eclipse with the W -D m odel as an output of the DC program. In this way both photom etric and radial velocity data contribute to this result.

The epoch was selected being approximate to the time provided by ASAS. The ephemeris for the main minimum of the LS 1135 binary system then results as follows:

$$M \text{ in } I = H JD 2451871 :911 (10) + 2^{d} 7352044 (20) \quad E \qquad (1)$$

# 5 CONCLUSIONS

W e have obtained in this work a rst approximation to estimate the absolute physical parameters of the LS 11350 -type binary system. From a simultaneous analysis of the radial velocities and the light curve with the W {D code, we nd the following:

Fixing the  $T_{\rm eff}$  of the prim ary component to the value corresponding to its spectral type, namely 0.6.5V, from the best tting W {D modelwe nd  $T_{\rm eff}$  25500 K for the secondary component. This value corresponds approxim ately to a spectral type B1V, according to the scales of di erent authors (Bohm -V itense, 1981; Schm idt-K aler, 1982; C row ther, 1997).

The inclination of the orbital plane of the system relative to the sky plane was found to be 68:5 0:5 according the best tting W {D model. W ith this value of i, we have obtained values for the individualm asses of the prim ary and secondary components  $M_1 = 30$  1 M and  $M_2 = 9$  1 M and for the mean radii  $R_1 = 12$  1 R and  $R_2 = 5$  1 R. Both components appear to be well inside their respective Roche lobes, and therefore LS 1135 is a detached binary still on the main sequence. Detached eclipsing binaries with accurate elements at the high mass end of the main sequence are exceedingly few in num ber, and are very much needed as the benchm arks of theoretical stellar m odels. Thus LS 1135 appears as an excellent candidate for an accurate determ ination of physical parameters in a high mass binary system . W ithin the uncertainties, the rst values of physical param eters of the binary components of LS 1135 which we have determ ined are in fair agreem ent with recent tabulations of Galactic O star parameters based on models of stellar at-

m ospheres (cf. M artins et al. 2005). O f course, for m ore accurate values a better de ned light curve is needed, as well as spectra with higher signal-to-noise ratio for a m ore accurate determ ination of the radial velocities of the secondary com ponent.

It is also interesting to mention that the mass ratio which we have obtained from the radial velocities  $q = M_2 = M_1$  0.31, if con med, would be among the lowest values recorded for 0 type main sequence binaries. Therefore, the physical parameters of the primary 0.6.5V type component would be better de ned in this case, since the perturbations introduced by the secondary component on the spectral behaviour of the primary would be minor as compared to binary system s with sim ilar components.
