RED MERGERS AND THE ASSEMBLY OF MASSIVE ELLIPTICAL GALAXIES: THE FUNDAMENTAL PLANE AND ITS PROJECTIONS

ABSTRACT

Several recent observations suggest that gas-poor (dissipationless) mergers of elliptical galaxies contribute signi cantly to the build-up of the massive end of the red sequence at z . 1. We perform a series ofm a prm erger sin ulations to investigate the spatial and velocity structure of the rem nants of such mergers. Regardless of orbital energy or angular momentum, we nd that the stellar rem nants lie on the fundam ental plane de ned by their progenitors, a result of virial equilibrium with a sm all tilt due to an increasing central dark m atter fraction. However, the locations of m erger rem nants in the projections of the fundam ental plane { the Faber-Jackson and Re M relations { depend strongly on the merger orbit, and the relations steepen signi cantly from the canonical scalings (L / $^4_{
m e}$ and $R_e / M^{0.6}$) for m ergers on radial orbits. This steepening arises because stellar bulges on orbits with lower angular momentum lose less energy via dynamical friction on the dark matter halos than do bulges on orbits with substantial angular momentum. This results in a less tightly bound remnant bulge with a smaller velocity dispersion and a larger e ective radius. Our results in ply that the projections of the fundamental plane { but not necessarily the plane itself { provide a powerful way of investigating the assembly history of massive elliptical galaxies, including the brightest cluster galaxies at or near the centers of galaxy clusters. We argue that most massive ellipticals are formed by an isotropicm erging and that their fundam entalplane projections should thus di er noticeably from those of lower mass ellipticals even though they should lie on the same fundam ental plane. Current observations are consistent with this conclusion. The steepening in the L e relation for lum inous ellipticals may also be rejected in a corresponding steepening in the M $_{\rm BH}$ e relation for massive black holes.

1. INTRODUCTION

Several independent lines of evidence point to the importance of gas-poor (dissipationless) mergers in the assembly of massive elliptical galaxies. For example, the decreasing rotational support and transition from disky to boxy isophotal shapes with increasing stellar mass in elliptical galaxies suggests an increasing fraction of dissipationless mergers in the growth of the most massive elliptical galaxies (e.g., Bender et al. 1992; Korm endy & Bender 1996; Faber et al. 1997; N aab et al. 2006). The lack of correlation between metallicity (Gallazzi et al. 2005) or metallicity gradients (Carollo et al. 1993) and galaxy mass for massive ellipticals, while both are positively correlated with galaxy mass for lower-mass ellipticals, provides additional support for this picture. There is also indirect evidence from the evolution of galaxy lum inosity functions (Bellet al. 2004; Faber et al. 2005; B lanton 2005) and sem i-analytic m odels of galaxy form ation (Kau mann & Haehnelt 2000; Khochfar & Burkert 2003; De Lucia et al. 2006) that a signi cant fraction of low-redshift ellipticals were assembled via dissipation less m ergers. M oreover, there is direct observational evidence for a substantial num ber of \red" m ergers between earlytype galaxies in an intermediate redshift galaxy cluster (van Dokkum et al. 1999; Tran et al. 2005) as well as in more localgalaxies (Bellet al. 2005; van Dokkum 2005). In spite of the importance of gas-poorm ergers, how ever, the properties of these mergers and their remnants are not fully understood.

If elliptical galaxies gain substantial mass via dissipationless merging at z . 1, this process could have a signi cant impact on their properties. The purpose of this paper is to study how such mergens a ect the global dynamical and kinematic structure of the rem-nants, as ellipticals show a very tight correlation in the space spanned by their half-light radii (R_e), central velocity dispersions ($_e$), and central surface brightnesses (I_e) known as the fundamental plane (D ressler et al. 1987; D progovski & D avis 1987). Relationships between two of the fundam ental plane variables, such as the Faber-Jackson relation (Faber & Jackson 1976) and the stellar mass-size relation, may also serve as important constraints for galaxy formation models (e.g., M cIntosh et al. 2005).

This is particularly true for the most lum inous ellipticalgalaxies, including brightest cluster galaxies (BCGs) that populate the exponential tails of the galaxy lum inosity, mass, and velocity dispersion functions and contain the most massive black holes in the universe. These galaxies are likely to have undergone multiple generations of gas-poor mergers, as repeated merging during cluster form ation is a well-motivated mechanism for BCG formation (Merritt 1985; Dubinski 1998). In this model, anisotropic infallalong cosm ological laments introduces

a preferential direction in the merging process (W est 1994), in contrast to mergers of galaxies in less overdense environments. As discussed below, we suspect that this special assembly history has implications for the scaling relations of massive ellipticals: the preferentially radial orbits of mergers that form the most lum inous ellipticals may lead to dierent Faber-Jackson and stellar mass-size relations for these galaxies than for norm al ellipticals.

There are, in fact, tantalizing observational hints of deviations from the canonical elliptical galaxy scaling relations for BCGs and other lum inous ellipticals. For example, Oegerle & Hoessel (1991) nd that while BCGs lie on the sam e fundam ental plane as low erm ass ellipticals, their central velocity dispersions change very little with increasing lum inosity and their e ective radii increase steeply with lum inosity, signi cantly more so than for normal ellipticals. A similar e ect is present in the early-type galaxy sample of the Nuker team (see g.4 of Faber et al. 1997 and Lauer et al. 2006, in prep.) as well as in the Postm an & Lauer (1995) BCG sample (Graham 1996), while Wyithe (2006) has claim ed to detect an analogous change in the M_{BH} e relation for the most massive black holes.

In this paper, we present the results of a large num ber of simulations of major mergers of elliptical galaxies. Our galaxy models contain dark matter haloes and stellar bulges, both simulated with su cient force and mass resolution to reliably investigate the rem nants down to 0:1R_e (over 10⁶ total particles per sim ulascales of tion). We consider a wide variety of energies and angular m om enta for the m erger orbits and quantify the effects of orbital param eters on the m erger rem nants. This work is a signi cant extension of our earlier related study (Boylan-Kolchin et al. 2005, hereafter BMQ), where we considered only a few possible orbits for the merging galaxies. The simulations presented in this paper allow us to study in detail the e ects of dissipationless m erging and m erger orbits on the fundam ental plane and its projections. Section 2 describes the initial galaxy m odels and simulation parameters. Section 3 contains the results of our simulations, including the locations of m erger rem nants in the fundam ental plane (Section 3.1) and its projections (Section 3.2). In Section 4 we discuss our results and their in plications for the assembly of massive elliptical galaxies and their central black holes.

2. METHODS

The galaxy models used in our simulation consist of dark matter haloes and stellar spheroids and are fully described in BMQ; we review the essential features here. The initial dark matter haloes have the N avarro et al. (1997) density proles with a virial mass M $_{200}$ = 10^{12} M and a concentration c = 10, resulting in a virial radius of 162.6 kpc and scale radius of 16.26 kpc. The initial stellar bulges have the H emquist (1990) density proles with a total stellar mass M = 5 10^{10} M , resulting in a stellar baryon fraction of $f_{\rm b}$ = 0.05. The additional free parameter in the stellar prole, the scale radius a, is set by the $\rm R_e$ M relation measured for SD SS elliptical galaxies by Shen et al. (2003):

where $R_e = 1.8153$ a for the H emquist pro le; this gives $R_e = 2.82$ kpc for our initial models. This relation is appropriate for low redshift elliptical galaxies. Ideally, we would use the R_e M relation for z 1 rather than z 0. The data that are available at higher redshift indicate there has not been strong evolution in the R_e M relation from z = 1 to z = 0 (Trufillo et al. 2004b; M cIntosh et al. 2005). W e include the e ects of baryonic dissipation via the adiabatic contraction m odel of B lum enthal et al. (1986). A lthough the applicability of this model to elliptical galaxies is not fully obvious, recent hydrodynam ic sim ulations suggest that it is surprisingly accurate (G nedin et al. 2004). The resulting (circular) aperture velocity dispersion within Re for the stellar component in our models is $_{e}$ = 151 km/s. W e also perform a number of unequal mass mergers, with m ass ratio 0.33:1, where the less m assive galaxy also has $f_b = 0.05$ and a scale radius set by equation (1). Although we present the parameters of our initial conditions in physical units, the simulations reported here can be readily scaled to other stellar and dark m atterm asses (see associated discussion in Section 3.2).

Weuse GADGET-1 (Springelet al. 2001) to perform the merger simulations. All runs use a force softening of $0.3 \text{ kpc} (= 0.106 \text{R}_{e})$ and equal-m as particles for the stellar and dark matter components: N = 2.510⁴. $N_{DM} = 5$ 10° for each galaxy model. The initial particle positions of each component are sampled from the component's spherically symmetric density pro le. To ensure that the models are in equilibrium, we compute separate distribution functions for the halo and bulge and then use these distribution functions to initialize the particle velocities. Our initial galaxy models do not include any velocity anisotropy. As Nipotiet al. (2002) show, however, the inclusion of a modest amount of velocity anisotropy in models of merging galaxies does not substantially change the properties of the rem nants, while adding signi cant velocity anisotropy makes the initial model unstable. Additionally, Ciotti et al. (1996) show that velocity an isotropy cannot be the prim ary origin for the tilt in the fundam ental plane.

N-body models set up with this procedure are in general extremely stable over many dynamical times (e.g., K azantzidis et al. 2004), which we have explicitly checked for ourmodels. An additional source of spurious evolution inherent to N-body simulations is two-body relaxation, a consequence of using simulation particles that are many orders of magnitude more massive than the stars or dark matter particles they represent. We have performed test runs to ensure that two-body relaxation does not a ect our results for the duration of the simulations (6 Gyr) for our choices of particle num ber and force resolution (see BM Q for detailed resolution and stability studies).

The centers of the galaxies in the merger simulations are initially separated by the combined virial radii of the two haloes and the orbital parameters are de ned in the standard two-body point mass approximation (Binney & Tremaine 1987, Appendix 1D; Khochfar & Burkert 2006). In this limit, orbits can be characterized by two quantities: energy E and angular momentum L, orequivalently, pericentric distance r_p and eccentricity e (or circularity $1 e^2$ for runs with

E < 0). The orbital parameters for all of our production runs are listed in Table 1. Since our goal is to understand the e ects of di erent orbits on the properties of the m erger rem nants, we consider both parabolic encounters and bound orbits, and for each energy we perform sim ulations over a range of orbital angular m om enta. The energy of the bound orbits is taken to correspond to the most probable energy from Benson (2005), which is based on a study of dark m atter halo m ergers averaged over all cosm ological environm ents. We use this value of E only as a rough guide and note that existing statistical studies of dark matter halo mergers are dominated by low m ass objects and therefore do not necessarily represent the orbits responsible for the assembly of massive elliptical galaxies in cluster environm ents. Larger sam ples of habes should soon provide robust statistical inform ation about the environm ental dependence of halo m ergers. In particular, as we argue later in this paper, major mergers leading to the form ation of central massive galaxies in clusters may follow preferentially radial orbits.

The non-spherical nature of the lum inous portion of m erger rem nants m eans that quantities such as R_e and $_e$ depend on the orientation at which the objects are viewed. An immediate consequence is that an intrinsic scatter in the fundamental plane projections will exist solely due to a variation in viewing angle. In order to compute R_e and $_e$ that can be compared with observations, and to quantify the e ects of viewing angle, we observe the rem nant in each simulation from 10^4 di erent lines of sight chosen random ly from points on a sphere. The e ective radius is determined by the radius of the circle containing half of the projected stellar m ass and the mass-weighted aperture velocity dispersion is computed within one R_e .

3. RESULTS

3.1. The Fundam ental Plane

The fundam ental plane is typically expressed in the coordinate system de ned by the observables $(x;y;z) = (\log_e; \log I_e; \log R_e)$ as

where a represents the angle of the plane from the vertical axis $z = \log R_e$, and b=a represents the amount of rotation about the z-axis. If we write

where c_1 and c_2 are structure coe cients, then the fundam ental plane observables are related by

(Bender et al. 1992). Therefore, if elliptical galaxies form a hom obgous sequence (if c_1 and c_2 are constant) with light tracing dynam icalm ass and a constant stellarm assto-light ratio, they should lie on the virial plane given by a = 2; b = 1. How ever, the observed fundam ental plane di ers from the virial plane. For example, $a = 1.24 \quad 0.07$, $b = 0.82 \quad 0.02$ in the Gunn r-band (forgensen et al. 1996) and $a = 1.53 \quad 0.08, b = 0.79 \quad 0.03$ in the K-band (Pahre, D jorgovski, & de Carvalho 1998b). Results for allSD SS wavebands are sim ilar to the K-band fundam ental plane (Bernardi et al. 2003a). This di erence represents a \tilt" in the observed fundam ental plane from the virial plane: either $c_2 = c_1$, M dyn=M, or M = L varies system atically with galaxy m ass.

We are able to investigate the rst two possibilities with our simulations, but we cannot directly test the third. In what follows, we assume a constant stellar mass-to-light ratio for the galaxies in our simulations. We can therefore interpret our results as testing the amount of the fundamental plane tilt that is due to either non-homology or central dark matter fraction. A number of authors have argued that stellar population variations with galaxy mass are responsible for the fundamental plane tilt (e.g. Gerhard et al. 2001; Treu et al. 2005; Cappellari et al. 2006). As Pahre, de Carvalho, & Djorgovski (1998a) point out, how ever, the existence of a signi cant tilt in the near-infrared, where stellar population e ects should be less pronounced than in the optical, indicates that stellar populations alone are not the cause of the fundam ental plane tilt. Furtherm ore, K-band M = L ratios do not vary strongly with the age of the stellar population for relatively old stellar populations that are appropriate for the galaxies we are simulating. Analyses of SD SS early-type galaxies (K au m ann et al. 2003; Padm anabhan et al. 2004) also nd that stellar massto-light ratios are relatively constant with mass. We therefore believe that assuming a constant stellar massto-light ratio is a reasonable approximation.

Fig. 1 shows the locations of all of our equalmass merger remnants in the edge-on projection of each of the three planes discussed above { virial, r-band, and K-band. We nd that the 0.33:1 merger remnants show all of the same trends as the 1:1 remnants and thus the form er are not plotted here. The 1 errors of the fundamental plane in the direction of R_e are indicated by the dotted lines in Fig. 1. Each remnant is marked with

a di erent colour, and each point represents one random view ing angle of the rem nant. The initial galaxy is spherical by construction, so it is located at a single point in the fundam ental plane (large triangle; low er-left corner). The stellar m ass-to-light ratio has been chosen so that the initial m odel lies on the observed fundam ental plane (this corresponds to K -band and r-band m ass-to-light ratios of 1.0 and 3.6, respectively); the same stellar m assto-light ratios are used to place the m erger rem nants on the fundam ental plane.

The left panel of F ig. 1 shows that all of the rem nants lie signi cantly o the sim ple virial theorem expectation. Strikingly, how ever, all of the simulated observations of all of the m erger rem nants lie wellw ithin the 1 errors of the fundam ental plane for both the optical and nearinfrared planes. These results establish that the rem - nants of m a jor m ergers of spherical elliptical galaxies lie on the fundam ental plane de ned by their progenitors for the wide range of orbital energies and angular m om enta covered by our simulations. We note, however, that our dynam ic range in R_e and M is rather m odest, and all of our simulations begin at the same point in the fundam ental plane. Thus our simulations cover only a limited part of the observed plane.

Since massive elliptical galaxies may have undergone multiple dissipationless mergers during their assembly history, we also perform ed a simulation in which the two progenitors were random ly chosen to be the rem nants of runs P3 and B6 and the orbit was parabolic with $r_p = 21$ kpc. We nd this remerger rem nant lies on the same fundamental plane as the initial galaxy model and rst-generation merger rem nants (Fig. 1, black region in upper right corner). This single remerger simulation is certainly not de nitive, but it does support the hypothesis that the presence of elliptical galaxies on the fundamental plane is consistent with multiple generations of

dissipationless m erging. W hile the observed fundamental plane is typically plotted in the $(x;y;z) = (\log_e; \log_e; \log_e; \log_e)$ space as shown in Fig. 1, we nd it useful to interpret the plane theoretically in the transform ed coordinate system $(x^0;y^0;z^0) = (\log_{dyn}; \log_e)$, in which a plane can be written as

where both M $_{\rm dyn}$ and M refer to the m asses enclosed within R_e. The parameters and quantify how the ratio of dark m atterm ass to stellarm ass within R_e varies with increasing galaxy m ass and size.

C om paring equations (2) and (5), and using the de - nitions in equation (3), gives

The virial plane of a = 2; b = 1 corresponds to = 0; = 0 (ie. M_{dyn} / M); it is therefore conveniently parallel to axis z^0 = $\log R_e$ in the $M_{dyn} - M_e$ Re space. The observed r-band and K-band fundam ental planes have (;) = (0.323; 0.0323) and (;) = (0.0327; 0.242), respectively. It is interesting to note that the r-band plane of Jorgensen et al. (1996) has 0, i.e. $M_{dyn} = M_e / M_e$, while the K-band fundam ental plane has 0, i.e. $M_{dyn} = M_e / R_e$.

Fig. 2 shows the locations of our m erger rem nants in the edge-on view of the = 0 (left panel; appropriate for r-band) and = 0 (right panel; appropriate for K-band) planes. The rem nants appear m ore consistent with the K-band plane than the r-band plane. A lthough Fig. 2 and Fig. 1bc display the same information in di erent coordinate systems, Fig. 2 illustrates clearly how the dynam ical m ass within R_e increases m ore than the stellar m ass within the same radius, m eaning that the inner regions of our m erger rem nants are m ore dark m atterdom inated than their progenitors. This increasing dark m atter fraction with increasing galaxy m ass is the prim ary cause for the tilt of the observed fundam ental plane from the virial plane in our gas-free m ergers.

Since systematic non-homology and varying central dark matter fraction in elliptical galaxies are often considered as possible origins for the tilt of the fundamental plane (e.g., Faber et al. 1987; Ciotti et al. 1996; Graham & Colless 1997; Pahre et al. 1998a; Gerhard et al. 2001; Padm anabhan et al. 2004; Trujillo et al. 2004a), it is useful to assess the importance of non-hom ology in the context of the two-component dark matter and stellar models considered in this paper. We nd that both c_1 and c_2 [as de ned in equation (3)] are constant for our m erger rem nants³: $c_1 = 2.70$ with a maximum deviation of < 4% and $c_2 = 2:90$ with a maximum deviation of < 3%. This im plies that the nal systems (bulge+ halo) are in virial equilibrium and are dynam ically hom ologous (because c_2 is constant) and that the lum inous portions of our rem nants are structurally hom ologous (because c_1 is constant). The total system is structurally non-hom ologous, how ever, due to a change in the dark matter halo relative to the bulge. The inner part of the halo, which contains the bulge, does not grow in radius as much as the bulge does during the course of each m erger, while the outer part of the halo expands signi cantly. This results in an increased central dark matter fraction for the remnants, as shown in Fig. 2. The amount of tilt in our simulations is very similar to the observed fundam ental plane tilt, in plying that there is no need to invoke stellar mass-to-light variations to account for the tilt in our simulations.

As the bulges them selves are structurally hom ologous (c₁ is constant and the density proles of the remnant bulges are well-t by a Hemquist prole), we refer to a varying dark matter fraction rather than a structural non-hom ology as the origin of the tilt. We note that G raham et al. (1996) nd Sersic r^{1-n} models provide better ts to BCG surface brightness proles than the r^{1-4} law and that n correlates positively with mass, indicating a real non-hom ology in the elliptical galaxy population that is not captured by our simulations (but see G onzalez et al. 2005 for an argument that two separate r^{1-4} proles tBCG signi cantly better than Sersic proles).

A further point of interest is that the scatter due to viewing angle variation of the non-spherical rem nants in our simulations (represented by the spread within each colour in Fig. 1) is roughly parallel to the observed fundamental plane. This trend is a consequence of the virial equilibrium of individual galaxies: at xed stellar mass, ${}^{2}_{e}R_{e} = R^{0}_{e} {}^{0.33}$, so $R_{e} / {}^{e}_{e} {}^{(2 3)}$. Intuitively, a non-spherical rem nant m aintains a sm all line-of-sight velocity dispersion by extending in the perpendicular direction. This shows that while viewing angle variation introduces som e scatter into the fundam ental plane (Gonzalez-Garc a & van Albada2003), this scatter tends to be along the fundam ental plane itself. In addition, the scatter due to viewing angle variation does not increase between the rst and second generation m ergers, further indicating that the fundam ental plane scatter is relatively insensitive to dissipationless m erger history.

Sim ilar conclusions about m ergers and rem ergers preserving the fundam entalplane have been reached in various settings by previous authors (Capelato et al. 1995;

³ N ote that we com pute the surface m ass density, while it is the surface lum inosity density that is m easured observationally. The two are simply related by the stellar m ass-to-light ratio, which we assume is constant.

Nipotiet al. 2003; Gonzalez-Garc a & van Albada 2003; Robertson et al. 2005). The previous rem erger simulations most relevant to this work are those of N ipoti et al. (2003) and Robertson et al. (2005). They show that both rem ergers of two-com ponent galaxies sim ilar to ours and rem ergers of triaxial rem nants of gaseous disk galaxy m ergers lie on the (K-band) fundam ental plane. These results suggest that the spherical sym m etry typically assum ed in initial galaxy models of merger simulations, albeit unrealistic, does not signi cantly a ect the results on the preservation of the fundam ental plane. Exploring the evolution of the fundam ental plane under dissipationless m erging for general triaxial initial conditions would be useful; however, we believe that a brute-forced sam pling of the large parameter space associated with merging triaxial galaxies is highly ine cient. We will discuss a more econom ical procedure in Section 4 that uses the results of cosm ological simulations to motivate realistic m erging sequences.

32. Projections of the Fundam ental Plane

The fact that our merger rem nants are consistent with the fundam ental plane does not necessarily imply that the properties of the rem nant are insensitive to the merger orbit, nor does it imply that the rem nants necessarily follow the observed Faber-Jackson or R_e M relations: requiring a galaxy of a given mass to lie on the mean of both fundam ental plane projections picks out a single point in R_e e I space, whereas the fundam ental plane at xed mass forms a line in the same space (an R_e e correlation).

In order to quantify the e ects of merger orbits on the projections of the fundam ental plane, we compute the slopes in the R_e / M and M / $_e$ relations for each of our 1:1 merger simulations. Fig. 3 shows the dependence of the slopes (left) and (right) as a function of the pericentric distance of the orbit⁴ for both the bound orbits (diam onds) and parabolic orbits (squares). The slopes have a strong trend with pericentric distance: increasing $r_{\rm p}$ corresponds to decreasing and decreasing

. These trends were already noted in BMQ based on a few orbits, but the comprehensive set of simulations with di erent L and E presented in this paper provide a much more quantitative understanding of the impact of the merger orbit on the fundam ental plane projections. The slopes for the re-merger remnant, marked with an X in Fig. 3, agree well with those for the rst generation mergers. A lthough Fig. 3 shows only the results of 1:1 merger simulations, we nd similar trends in 0.33:1 mergers. These results suggest that the angular momentum and energy of the orbit have the biggest impact on the fundam ental plane projections, with the mass ratio of the merging galaxies and the internal structure of the initial bulge/halo system being of secondary importance.

For comparison, the observed fundamental plane projections are $R_e / L^{0.56}$ and $L / \frac{4}{e} 4^{4:14}$ (Pahre et al. 1998b; Bernardi et al. 2003b), although as noted in Section 1, these scalings are probably not applicable to the most lum inous ellipticals. Our high angularm on entum simulations have scaling relations in good agreement with both of the observed projections. The

low angular momentum runs, however, deviate signi – cantly from these canonical scalings (similar deviations for low angular momentum runs were also reported in N ipotiet al. 2003, BM Q, and R obertson et al. 2005).

The combination of Figs. 1 and 3 reveals that while all of the remnants lie on the fundamental plane, the remnant properties are nonetheless strongly a ected by merger orbits. Dierences in merger orbits can lead to signi cant dierences in the projected scaling relations, but variations in the R_e M relation are compensated by corresponding variations in the M $_e$ relation, maintaining the fundamental plane because of virial equilibrium of the buke-halo system.

It is important to point out that although we have quoted our results in terms of galaxies with specic masses and radii, they can be easily rescaled to other masses and radii. Such a rescaling will a ect the am plitude of the relations we are studying but not the slopes. For example, if we increase all masses by a factor of 10 and all radii by a factor of $10^{1=3}$ (to preserve virial scalings), the velocity dispersion will scale as $\overline{M} = R = 10^{1=3}$. This moves our initial conditions of of the R_e M relation, since $R_e = 2.83$ $10^{-3} = 6.1$ kpc rather than the 10.2 kpc given by the Shen et al. relation. This di erence is comparable to the observed scatter in the relation, $\ln r = 0.3$ \$hen et al. 2003). The velocity dispersion will also di er from that predicted by the Faber-Jackson relation: $_{e} = 151$ 1 $b^{=3} = 325$ km s¹ rather than 151 $10^{-4} = 269 \text{ km s}^{-1}$. Thus m ergers of galaxies at these scales have rem nants with identical e slopes as those given above but R_e M and M with dierent amplitudes than the means of the observed relations. The slopes of the relations quoted here are therefore quite robust.

Qualitatively, the dram atic steepening of the R_e M and M_e relations with decreasing orbital angular momentum in Fig. 3 can be understood by considering the role of dynam ical friction and energy transfer during a merger. At a given orbital energy, stellar bulges with substantialangularm om entum need to losem ore angular momentum (and accordingly, more energy) via dynam – ical friction on the background dark matter halo than do bulges on low angular momentum orbits. This leads to a more tightly bound remnant bulge with a larger

(sm aller) and sm aller R_e (sm aller), as is found in the simulations. The same e ect also explains why orbits with more initial orbital energy (our parabolic orbits) tend to lead to less bound rem nants with sm aller (larger) and larger R_e (larger).

Q uantitatively, we can understand the essence of the physics involved in producing the trends seen in F ig.3 by exam ining the energy equation for the stellar bulges. The energy conservation equation for two identical bulges, each with initial stellar m ass M $_{;i}$ and e ective radius R_i, merging to form a nalbulge of m ass M $_{;f}$ and effective radius R_f can be written as

The parameter f depends on the structure of the bulge and surrounding dark \underline{m} atter halo:

where $M_{dyn}(\mathbf{r}) = M_{(\mathbf{r})} + M_{dm}(\mathbf{r})$. The parameter $f_{prb} + f_t$ measures the orbital energy of the bulge-

bulge system when the bulges \touch." can be decom posed into two separate parts, with one contribution from the initial orbital energy at large radii (f_{orb}) and the other from the subsequent energy transfer between the stellar bulges and dark m atter haloes during the m erger (f_t) ; see BMQ for more details. The values of f and for our equal-m ass m erger simulations are listed in Table 2. These results show that, as argued in the previous paragraph, at xed initial orbital energy (xed forb), increasing the orbital angularm om entum results in a larger value of , which is due to more energy transfer from the bulges to the haloes (a larger positive value of f_t). This in turn leads to a more tightly bound remnant bulge with a larger and smaller R_e (Fig. 3). Table 2 also includes the values of for the 0.33:1 m ergers (runs P 5-P8), which are quite similar to those of the equal mass m ergers. This shows that the properties of the rem nants in the projections of the fundam ental plane are not very sensitive to the mass ratio of the merging galaxies (at least for relatively major mergers).

W e can gain an analytical understanding of F ig. 3 and Table 2 by investigating how in the R_e M relation varies with the energy and structural parameters and f in equation (7). A ssum ing that the stellar m ass doubles in equal m ass m ergers (i.e. M $_{ff} = 2M$ $_{fi}$, a very good approximation to the simulations) and that the stellar e ective radius scales as R_e / M upon m erging, equation (7) relates the exponent to and f:

We therefore expect = 1 if a merger is on a parabolic orbit with negligible energy transfer (= $f_{orb} + f_t = 0$) and unchanged structural parameters ($f_f = f_i$). By contrast, if the merger orbit initially has signi cant angular

m om entum (at distances R_i), the bulges will spiral inward and dynam ical friction will tend to make the orbits circular at sm all radii; in this case, 0:5 by the virial theorem and 0:58 if $f_f = f_i$. In the actual simulations, Table 2 shows there is always nonzero energy transfer from stars to dark matter (i.e. $f_t > 0$), which decreases for the head-on orbits, whereas the merged bulge always has a larger structural param eter (i.e. $f_f = f_i > 1$), which increases . Together the variations in and f explain the behavior and range of (0:7 to 1.3) shown in Fig.3.

The fact that $f_f > f_i$ (by up to 40%) rejects the

varying central dark m atter content of the rem nants, though in general it is non-trivial to quantitatively relate $f_{\rm f}=f_{\rm i}$ to the change in dark m atter fraction w ithin $R_{\rm e}$ because equation (8) involves a radial integral over the stellar density pro $\,$ le and dynam icalm ass. How ever, from equation (8), we see that for a given distribution of stars (xed $R_{\rm e}$ and $\,$), increasing the am ount of dark m atter inside the bulge (i.e. increasing M $_{\rm dyn})$ increases $f_{\rm f}$, which is why $f_{\rm f} > f_{\rm i}$ in the simulations.

The analytical energy conservation model given in equations (7) and (9) can easily be extended to unequal m ass m ergers. Fig. 4 shows the general dependence of on the mass ratio of the merging bulges for dierent values of , assuming for simplicity parabolic orbits and $f_f = f_i$. As argued above, is expected to decrease 0:5 for orbits with substantial angular m om enfrom 0 for nearly parabolic head-on orbits. Corretum to spondingly, increases from 0:58 to 1. This trend of increasing with decreasing orbital circularity (or rperi) is consistent with that shown in Fig. 3 for the simulations, although we do not expect the values of in the m odel and simulations to match exactly due to sim plifying assumptions made in the model (e.g. $f_f = f_i$). Fig. 4 also shows that the dependence of on the mass ratio $M_1 = M_2$ is quite weak for 0.01 M₁=M₂ 1:0, indicating that the results in Fig. 3 can be extended to very m inor m ergers. This analytic result is consistent with the fact that our 0.33:1 m ergers and equalm assm ergers show a similar dependence of and on merger orbit.

4. DISCUSSION AND IMPLICATIONS

4.1. The Fundam ental P lane and its P rojections

The results of Section 3.1 show that the fundam ental plane is preserved during dissipationless mergers for a wide range of orbits, a result of virial equilibrium with a slight tilt due to an increasing central dark matter fraction. On the other hand, the results of Section 3.2 show that the projections of the fundam ental plane are quite sensitive to the am ount of energy transferred from the bulges to the dark matter haloes during the merger, which is determined in large part by the merger orbit. If gas-poor mergers help build up the massive end of the red sequence, as several current observations and models suggest, then our results indicate that the projections of the fundam ental plane { but not necessarily the plane itself { provide a powerful way of investigating the assem bly history of massive elliptical galaxies.

W hile a sample of 43 BCGs has been reported to lie on the fundam entalplane (O egerle & H oessel1991), they appear to have di erent fundam ental plane projections from those of low er-m ass elliptical galaxies. The correlation between e ective radius and lum inosity is steeper for these BCGs (R_e / $L^{1:25}$) than for all early-type galaxies (R_e / $L^{0:6}$) and the BCG velocity dispersions lie substantially lower than the extrapolation of the Faber-Jackson relation to higher lum inosity (O egerle & H oessel 1991). O ther properties of BCGs are notably di erent from those of norm alellipticals as well, such as their high incidence of secondary nuclei (Schneider et al. 1983), their more prolate shapes (Ryden et al. 1993), the sm all dispersion in theirm etric lum inosities (Postman & Lauer 1995), and the large and relatively constant (out to 0:4) lum inosity gap between BCGs and second-Ζ ranked cluster galaxies (Loh & Strauss 2006).

The results presented in this paper suggest that these di erences are all signatures of how massive elliptical galaxies were assembled. In particular, dissipationless m erging of elliptical galaxies provides a natural mechanism for steepening both the Faber-Jackson and R L relations and preserving the overall fundamental plane, provided that merger orbits become preferentially more radial for the most massive galaxies (Fig. 3).

There is, in fact, support for this possibility in the literature. Observationally, it is well-established that BCGs are aligned with both their host clusters and the surrounding large scale structure (e.g. Binggeli 1982; Fuller et al. 1999; W est & B lakeslee 2000). Num erical simulations show that an isotropic merging is natural in CDM models (Dubinski 1998; Zentner et al. 2005) and preferentially radialm erging along lam ents can produce m any of the observed properties of clusters and BCGs (W est 1994; W est et al. 1995; D ubinski 1998). These lines of reasoning favour radialm ergers during BCG formation and point to a strong connection between the characteristics of the mergers that form BCGs and the origin of observed BCG properties (and the di erences between BCGs and norm al ellipticals). In addition, the most lum inous ellipticals in the Virgo cluster all seem to lie on a lament (West & Blakeslee 2000), which likely m eans that an isotropic m erging is also im portant for lum inous ellipticals that are not BCGs.

A coording to our calculations, projections of the fundam ental plane provide independent information about the assembly history of massive ellipticals. A nalysis of a large spectroscopic sample of massive galaxies would provide signi cantly stronger constraints on changes in the fundam entalplane projections at the highest m asses; we expect that the indications of deviations seen in current samples will become m ore apparent with additional data.

4.2. Superm assive black holes

Any departure from the canonical Faber-Jackson relation in massive galaxies would also have signi cant in plications for the dem ography of supermassive black holes. In particular, under the assumption that black holes coalesce following a gas-poorm erger (which is not quaranteed; see M erritt & M ilosavlievic 2004 for a review), the black hole mass should increase roughly in proportion to the galaxy m ass since the am ount of m assenergy carried away in gravitational waves is likely to be quite small (e.g., Baker et al. 2004). We therefore expect that dissipationless mergers will maintain a linear M relation. Any steepening of the L Мвн _ re− lation for lum inous ellipticals, however, should then be re ected in a corresponding steepening in the M $_{\rm BH}$ relation for massive black holes. W yithe (2006) has argued that just such a steepening is present in the current sam ple of black hole m asses, but the statistics are rather poor and a larger sample is needed in order to make de nitive statem ents. If correct, black hole masses for very lum inous galaxies based on the canonical M BH

e relation (Gebhardt et al. 2000; Ferrarese & Merritt 2000; Trem aine et al. 2002) would system atically underpredict the true black hole mass (see also Lauer et al. 2006, in prep.).

4.3. Further discussion

Several issues can be investigated in more detail to test our suggestion that preferentially radial merging is responsible form any of the morphological and kinem atical properties of BCGs. One promising possibility is to study the shapes of BCGs. Porter et al. (1991) nd that the outer regions of BCG s are generally prolate, with the inner regions being rounder. Ryden et al. (1993) nd that the distribution of BCG ellipticities has a similar mean value to that of all ellipticals but with a smaller dispersion and a tendency to be slightly more prolate. For com parison, we nd that the rem nants of 1:1 m ergers on low angular momentum orbits are prolate with a tendency toward triaxiality: generally a bc 1.8:1:1 -1.7:1.1:1. By contrast, the runs with signi cant angular momentum have a b:c 1.7:1.3:1. However, the main di erence between our equalm ass and 0.33:1 m ergers is that the 0.33:1 rem nants are notably rounder than their 1:1 counterparts, an e ect also seen by V illum sen (1982). Unequalm ass major mergers thus lead to the same overall trends we see in the fundam ental plane and its projections while producing more spherical rem nants. U sing shapes to quantitatively test the predictions of our models will thus require detailed in form ation about the orbits and m ass ratios of the m ergers that form ed BCGs.

The above considerations highlight the need to move

beyond non-cosm ological major merger simulations of spherical and isotropic galaxies that have been the focus of this paper as well as many earlier papers. Indeed, the relaxation and virialization of a cluster generally involves several massive galaxies with a range of masses (Dubinski 1998). The hierarchical build-up of clusters and BCGs also likely depends on the cluster mass (e.g. Brough et al. 2005; Loh & Strauss 2006). In addition, the shapes of cluster-m ass dark m atter haloes in dark matter-only cosm ological simulations are typically quite prolate at form ation but then becom e rounder (but still triaxial) as time goes on (Hopkins et al. 2005; A llgood et al. 2005) due to a transition from lam entary to spherical accretion (Allgood et al. 2005). Clearly, high resolution two-component (stars and dark matter) sim ulations in a cosm ological context with full form ation histories are necessary for making detailed predictions about the properties of m assive ellipticals. W e are currently working on such simulations. A lthough we expect that our basic conclusions about the fundam ental plane and its projections will rem ain unchanged, repeated m ajor and m inor m erging on realistic cosm ological orbits will signi cantly in uence the shapes and kinem atics of the rem nant galaxies.

As one nal implication of the non-spherical nature of our m erger rem nants, we note that the m easured velocity dispersions can change by more than 15% with viewing angle for a given remnant. For the most massive galaxies, this could be signi cant: a galaxy that has 350 km /s from most viewing angles (typical for a BCG) could have $_{\rm e}$ > 400 km/s in certain rare con gurations (we nd that the observed velocity dispersion is 15% higher than the mode 3% of the time for the rem nants of relatively radial m ergers). These objects, which are prolate m erger rem nants viewed down them a praxis, also have sm allere ective radii than m ost viewing angles of rem nants with the same stellar mass. Bemardiet al. (2005) have recently reported the detection of a population of lum inous galaxies with these properties. A simple test of our explanation for these galaxies is to look at their projected shapes: our calculations predict these galaxies should appear statistically rounder than other galaxies of com parable lum inosity. This view ing angle e ect would also be a source of scatter in the e and Faber-Jackson relations. Мвн
