## A STUDY OF COMPACT OBJECT MERGERS AS SHORT GAMMA-RAY BURST PROGENITORS

### ABSTRACT

W e present a theoretical study of double com pact objects as potential short/hard gam m a-ray burst (GRB) progenitors. An updated population synthesis code StarTrack is used to calculate properties of double neutron stars and black-hole neutron star binaries. We obtain their form ation rates, estim ate m erger times and nally predict their most likely merger locations and afterglow properties for di erent types of host galaxies. Our results serve for a direct comparison with the recent HETE-II and SW IFT observations of several short bursts, for which afterglows and host galaxies were detected. We also discuss the possible constraints these observations put on the evolutionary models of double compact object form ation. We emphasize that our double compact object models can successfully reproduce at the sametimeshortGRBswithin both young, star-forming galaxies (e.g., GRB 050709 and GRB 051221A), as well as within old, elliptical hosts (e.g., GRB 050724 and probably GRB 050509B).

#### 1. INTRODUCTION

The recent detections of afterglows for short/hard GRBs have made possible a breakthrough in the study of this class of bursts. Swift (Gehrels et al. 2005; Barthelm y et al. 2005) and HETE-II (Villasenor et al. 2005) observations led to precise localizations of several short GRBs, and subsequent follow -up optical observations allow ed for tentative connections with their host galaxies and a measurement of their redshifts. GRB 050509B was found to lie in the vicinity of a large elliptical galaxy, with no current star form ation and at a redshift of 0.225 (Gehrels et al. 2005). GRB 050709 was found in the outskirts of a dwarf irregular galaxy with ongoing star form ation at redshift 0.1606 (H jorth et al. 2005; Fox et al. 2005; Covino et al. 2006), as was GRB 051221A (Soderberg and Berger 2005, Berger and Soderberg 2005) at redshift 0.5465. GRB 050724 was found within a small elliptical galaxy with no current star form ation at a redshift of 0.258 (Berger et al. 2005a). GRB 050813 was found close to a cluster of galaxies at redshift 1.7-1.9 (Berger 2005b), but no host galaxy has been proposed.

C om pact object m ergers from double neutron star (NS-NS) and black hole neutron star (BH-NS) binaries have been proposed for the rst time by Paczynski (1986) and then further discussed as the central engines of short GRBs by number of authors (e.g., Eichler et al. 1989; Narayan, Paczynski & Piran 1992). Observational constraints on these populations may be obtained only for NS-NS systems since only such binaries are currently observed as binary pulsars. Merger rates derived from the observed

sam ple of a handful of G alactic relativistic NS-NS binaries have been presented by K alogera et al. (2004 and references therein). Double compact objects with both neutron stars and black holes can be studied via population synthesism ethods (e.g., Lipunov, Postnov & Prokhorov 1997; Portegies Zwart & Yungelson 1998; Belczynski, Kalogera & Bulik 2002c) There were several early population synthesis studies in the context of potential GRB progenitors (e.g., Bloom, Sigurdsson & Pols 1999; Belczynski & Bulik 1999; Fryer, W oosley & Hartmann 1999). In particular, it was found that NS-NS and BH-NS mergers are expected to take place outside host galaxies with long delay times. However, it has only recently been recognized that the population of the double com pact objects m ay be m ore diverse than was previously believed (Belczynski & Kalogera 2001; Belczynski, Bulik & Rudak 2002b; Pema & Belczynski2002; Belczynski, Bulik & Kalogera 2002a). In addition to classical well-recognized channels, these newly recognized form ation channels lead to the form ation of tighter double com pact objects, with short lifetim es and therefore possible prom ptm ergers within hosts. The new form ation scenarios were independently con med by detailed evolutionary calculations (Ivanova et al. 2003; Dewi& Pols 2003).

In this study we perform an updated analysis of double com pact object m ergers using population synthesis m ethods. Over the last several years and since our previous studies, the StarTrack population synthesis code has undergone major revisions and updates, many of which are guided and tested through com parisons with either observations or detailed evolutionary calculations (see Belczynskiet al. 2005). A dditionally, this new study is motivated by the recent short G RB observations and their likely connection with double compact object mergers. In x2 we present the overview of our claculations. In x3 the double compact object form ation, merger rates, locations and their afferglow properties are presented. Finally, in x4 we discuss our results in context of the recent short-G RB observations.

# 2. BINARY COMPACT OBJECT MODELS

Binary Population Synthesis. The StarTrack population synthesis code was initially developed for the study of double compact object m ergers in the context of GRB progenitors (Belczynski et al. 2002b) and gravitationalwave inspiral sources (Belczynskiet al. 2002c). In recent years StarTrack has undergone major updates and revisions in the physical treatment of various binary evolution phases. The new version has already been tested against observations and detailed evolutionary calculations (Belczynski et al. 2005), and has been used in various applications (e.g., Belczynski & Taam 2004; Belczynski et al. 2004a; Belczynski, Sadowski & Rasio 2004b). The most im portant updates for com pact ob ject form ation and evolution include: a full num erical approach to binary evolution due to tidal interactions and coupling calibrated using high mass X-ray binaries and open cluster observations, a detailed treatm ent of m ass transfer episodes fully calibrated against detailed calculations with a stellar evolution code, updated stellar winds form assive stars, and the latest determ ination of natal kick velocity distribution for neutron stars (Hobbs et al. 2005). In the helium star evolution, which is of a crucial importance for the form ation of new classes of double com pact objects (e.g., Ivanova et al. 2003), we have applied a conservative treatm ent m atching closely the results of detailed evolutionary calculations. The NS-NS progenitors are followed and checked for any potential Roche lobe over ow (RLOF). While in the mass transfer phase, system s are exam ined for potential development of dynamical instability, in which case the system s are evolved through a comm on envelope phase. W e treat com m on envelope events through the energy form alism (Webbink 1984; Belczynski et al. 2002), where the binding energy of the envelope is determ ined from the set of He starm odels calculated with the detailed evolutionary code by Ivanova et al. (2003). For som e system s we observe, as before, extra orbital decay leading to the formation of very tight short lived double compact object binaries. However, since the progenitor evolution and the

nalRLOF episodes are now followed in much greater detail, we note signi cant di erences from our earlier studies. For a detailed description of the revised code we refer the reader to Belczynskiet al. (2005).

<u>G alaxy P otential M odels</u>. To investigate the m otion of binary compact objects in their host galaxies and study the m erger locations we consider a set of typical gravitational potential m odels for di erent types of galaxies. O ur m odel spiral galaxy is identical to the one used in B elczynski et al. (2002b). It consists of a disk, bulge, described by a M iyam acto & N agai (1975) type potential and a hab with the dark m atter density of  $= {}_{\rm c} [1 + {\rm r}={\rm r_c}^2]^{-1}$ . We consider: a large spiral similar to the M ilky W ay, with

a disk and bulge mass of 10<sup>11</sup> M and a massive halo of 10<sup>12</sup> M extending out to 100kpc; and a sm allspiraldow nscaled by a factor of 10<sup>3</sup> in m ass and of 10 in size (constant density). We place the binaries on circular orbits in the disk of a spiral galaxy. B in arries with the full range of delay times (i.e., time from the formation of a double compact object binary until the merger) are used here since spirals consists of both old and young populations due to a roughly continuous star form ation history. W e also consider elliptical host galaxies. The model potential of an elliptical galaxy consists of two components: the bulge and the halo. The bulge is described by the Hemquist (1990) potential:  $(r) = GM_e(r + a_e)^{-1}$ , where  $M_e$  the m ass of the bulge and  $a_e$  is a measure of its size. For the halo we use the same model as in the case of spiral galaxies described above. The Hemquist potential has a simple analytical form and it reproduces the brightness pro le observed typically in ellipticals. We consider two extreme cases: a large elliptical with  $M_e = 5 \ 10^{11} M$ , and  $a_e = 5$ kpc, and a sm allelliptical with m ass 10<sup>3</sup> tim es sm aller and size 10 tim es sm aller. The mass and dimension of the halo are scaled identically as the bulge. The binaries are placed on circular orbits with a random angular momentum direction in the bulge with a mass density corresponding to the Hemquist potential (r) =  $(M_e=2)a_er^1(a_e + r)^3$ . Only binaries with delay tim es greater than 1 G yr are considered for ellipticals, since these galaxies contain only old populations. For starburst galaxies we use the same potentialm odel as for spirals, although starbursts are mostly irregular. We consider a large and a small starburst modeled by the large and sm all spiral galaxies. Only binaries with delay times shorter than 1 Gyr are considered since starbursts are young, star-form ing galaxies.

A flerglow Calculations. We use the mass density proles corresponding to the galactic potentials for the model galaxies described above to predict the lum inosity distribution of the afterglows. The baryonic fraction is assumed to be 20% for the disk, and 0.04% for the bulge and halo (e.g. Fukugita, Hogan & Peebles 1998). We compute the expected lum inosities of the afterglows in the [2-10] keV energy band using the standard synchrotron m odel (Sari, Piran & Narayan 1998). The bursts energy is assumed to be  $E = 5 \quad 10^{49}$  erg, given the observed values of 5  $10^{48}$  erg or less (e.g. Fox et al. 2005), and Ε for a typical e ciency of conversion of total energy into -ravs 0:1. O ther afterglow parameters are drawn from random distributions within their typical ranges (see Perna & Belczynski 2002 for details).

## 3. RESULTS

In what follows we present and discuss our results obtained from our reference population synthesis model, as described in great detail in Belczynski et al. 2005. A ssum ptions regarding prim ordial binary characteristics and binary evolution treatment are typical of what is widely used in the literature. Variations of these assumptions (for these too see Belczynski et al. 2005) do of course lead to quantitative di erences in the results; how ever our goal in this study is to concentrate on the robust characteristics of double com pact ob jects in the context of the recent short GRB observations. <u>D</u>ouble Compact Object Formation. Double compact objects form from massive progenitor systems. The more massive primary star evolves o the main sequence and eventually lls its Roche lobe initiating the rst mass transfer (MT) episode. The MT is dynamically stable (due to binary components of comparable mass), and leads to moderate orbital tightening. The primary loses its envelope and forms a Helium star, which soon afterwords explodes in a Type Ib supernova (SN) forming the rst compact object. Later on, the secondary evolves o the main sequence, and lls its Roche lobe while on the red giant branch, initiating a second MT episode. M ost com m only, due to the extrem emass ratio (rst compact object:

1~2~M for neutron stars, secondary 8~15~M) the M T is dynam ically unstable and the system enters a com – m on envelope phase. The envelope of the secondary is ejected at the cost of orbital energy, and the system separation is typically reduced by 1~2~orders of m agnitude. The system energes as a close binary consisting of the

rst com pact object and a naked helium star (the core of the original secondary). At this point the evolution may follow two qualitatively di erent paths.

Classical formation channel: The helium star evolves and never lls its Roche lobe. The evolution stops at the point where the helium star explodes in a Type Ib SN forming the second compact object. Provided that the SN explosion does not disrupt the binary, a double compact object is formed on a rather wide orbit (e.g., Bhattacharya & van den Heuvel 1991).

New form ation channel: If the helium star has low m ass (< 3 4 M ), it is known to expand at the later stages of its evolution (e.g., see Belczynski & Kalogera 2001 for a discussion and references). Since the binary is rather tight (after the common envelope phase) the Helium star at some point over lls its Roche lobe and initiates a third M T episode. Form any cases this M T is dynam ically stable (Ivanova et al. 2003; Dew i & Pols 2003) and the orbital separation decreases further, until the helium star explodes in a Type Ib/c SN form ing the second com pact ob ject. A double com pact ob ject is then form ed with a very tight (ultracom pact) orbit (e.g., Belczynski & Kalogera 2001; Belczynski et al. 2002a,c; Ivanova et al. 2003).

M erger T im es. There are two characteristic times related to the form ation and the subsequent evolution of double compact object binaries. First, there is an evolutionary time: the time required for the initial progenitor binary (two components on Zero Age M ain Sequence) to form a binary with two compact objects. Second, there is a m erger time, which is set by the orbital decay of a double compact object binary due to the em ission of gravitational radiation. The delay time (sum of the evolutionary time and m erger time) as well as m erger time distributions for NS-NS and BH-NS binaries are shown in Figure 1.

It can be seen that merger time distributions are bim odal. The very tight binaries ( $t_{m\,er}$  0:001 0:1 M yr) originate from the new form ation channel described above. They involve progenitors which experience an extra M T episode, that leads to additional orbital decay and thus the form ation of systems with very tight orbits. Long-lived binaries (with  $t_{m\,er}$  100 M yr { 15 G yr) are form ed through classical channels. On the other hand, delay time distributions in a range of 10 M yr { 15 G yr are rather

at, with prom inent peaks at  $g_{el}$  20 M yr. Evolutionary times of double compact objects are of the order of 10{20 M yr, therefore the systems with very short merger times are shifted in the delay time distribution toward higher values, and in particular they form the peak around 20 M yr. The at plateau is created by long-lived binaries. In the model presented here (our \standard" model), we have adopted a maximum NS mass of 2 M . Compared to our standard model, for a maximum NS mass of 3 M , approximately 90% of the BH-NS become NS-NS and the remaining BH-NS binaries (10%) are wide binaries form ed through the classical channels. The highest NS mass estimate is 2:1 0:2 M for a millisecond pulsar in PSR J0751+1807; a relativistic binary with helium white dwarf secondary (N ice et. al. 2005).

<u>M erger Rates</u>. Throughout the paper, we adopt a at  $\cos m \operatorname{ology}(m = 0.3, = 0.7 \operatorname{and} H_0 = 70 \operatorname{km} \operatorname{s}^{-1}$ M pc<sup>-1</sup>, and use the star-form ation history (corrected for extinction) presented by Strolger et al. (2004). We should how everpoint out that, in general, the star form ation rate is expected to be rather di erent in ellipticals and in spirals, since most ellipticals were assembled before z -2 and they are no longer forming stars, while spirals and starbursts galaxies have an on-going and active star form ation (see Sm ith et al. 2005 for a discussion). We defer this whole issue of the study of the relative contribution of the two types of galaxies to another paper (O 'Shaughnessy et al. in preparation).

The merger rates of NS-NS and BH-NS binaries as a function of redshift are shown in Figure 2. We obtain delay times (time to form ation of double compact object plusm ergertime) and mass formation e ciency from population synthesis (for details see Belczynski et al. 2002b). The predicted m erger rates as a function of redshift are a convolution of the adopted star form ation rate history and the delay times characteristic for NS-NS and BH-NS m ergers: The longer the delay times, the greater is the shift of m erger events to low er redshifts. W ith the m odel distributions of delay times, the peak of NS-NS mergers appears at redshift 1 instead of 3 of the star formation curve (Figure 2). The absolute normalization of the merger rates in Figure 2 is arbitrary, since its value is subject to large uncertainties (1{2 orders of m agnitude) due to the som e poorly constrained population synthesis m odelparam eters (e.g., Belczynskiet al. 2002c).

Merger Locations. We present the distributions of merger locations for di erent host galaxies in Figure 3. In starburst galaxies, the double com pact object population is dom inated by new system swith short-m ergertimes, and therefore m ost of the m ergers are expected to be found within hosts (m ore so for m assive galaxies). A sm all fraction (10-30%, depending on host mass) of mergers takes place outside hosts and these are m ergers of classical system swith merger times 10 1000 Myrs, which are allowed in the model populations due to our rather long adopted age of starburst (1 G yr). In elliptical galaxies, a substantial fraction of m ergers takes place outside hosts 80% and at present. In particular, 30% ofNS-NS and BH-NS m ergers m ay take place outside of sm all and large host, respectively. However, we note that even for smallhosts we nd a smallbut signi cant fraction ( 20-30%) of m ergers within several kpc from the host center.

Spiral galaxies hosting both young and old stellar populations represent the interm ediate case between starburst and ellipticals.

A flerglows. Figure 4 shows the distribution of the ISM num ber density in the merger sites, and the corresponding afterglow lum inosity in the [2-10] keV band, for the cases of a starburst and an elliptical of sm all and large dim ension and mass. In ellipticals, especially small ones, most m ergers occur at rather low densities, therefore resulting in generally dimmer afterglows, a fraction of which could rem ain undetectable. Such a case of a "naked" burst m ight be GRB 050911 (Page et al. 2005). For massive ellipticals the majority of mergers take place inside hosts and produces generally detectable afterglows. In large starbursts, m ergers take place within the hosts and give rise to rather bright afterglows (due to high typical ISM densities). In small starbursts, the dom inant short-lived double com pact object population m erges within hosts and produces detectable afterglows. However, due to our rather high adopted age of the starburst (1 G yr) som e system s have longer delay times and some can escape from their hosts, producing very dim afterglows. These dim afterglows are not expected for very young starbursts (10{100 M yr).

## 4. DISCUSSION

We nd two distinct populations of binary compact objects in term s of their binary-orbit characteristics and associated m ergertimes due to dierences in their evolutionary history. One is a classical population of rather wide, long-lived systems, with m ergertimes of 100 15;000 Myr, and the other consists of tight, short-lived systems with m ergertimes of 0:001 02 Myr. In a typical binary evolution m odel, there are roughly similar num bers of short-and long-lived NS-NS systems, while there are 20% and

80% of short- and long-lived BH-NS systems, respectively. The four known G alactic double neutron stars belong to the long-lived classical systems (see Fig. 1), and, given the small number of NS-NS systems, we do not expect to see the short-lived systems, since they merge very soon after their form ation.

We nd that most of the double compact binaries (> 80%) that are formed in large galaxies merge within them, independent of the galaxy type. For small galax-20%, 50%, 70% m ergers take place ies, we nd that within elliptical, spiral and starburst hosts respectively (see Fig. 3). The combination of binary compact object lifetimes and their merger locations leads to a testable prediction for the location of mergers in relation to the host galaxies. For starburst galaxies (which on average have sm allm asses) where stellar populations are young, we expect m ergers from short-lived double com pact ob jects. These are expected to take place inside or in the vicinity of their hosts. It is worth noting that such locations, and m ore importantly, the m ere existence of double com pact object m ergers associated with star-form ing, young galaxies, is not predicted by any of the previous studies that considered only classical formation scenarios (longdelayed m ergers). If it is shown that the star-form ing host galaxy of GRB 050709 does not contain a dom inant old underlying stellar population, this association will stand as the \sm oking gun" evidence for the new short-lived double com pact object form ation channel, originally identied by Belczynski & Kalogera (2001) and Belczynski et al. (2002a,c).

In elliptical galaxies, which have little or no ongoing star form ation, we expect to nd mergers of long-lived double com pact objects at present. For massive hosts, most m ergers should occur within the hosts, while for smaller galaxies outside the hosts. GRB 050509B was tentatively associated with a large elliptical galaxy, and its error circle indicates that this burst took place either within or in the outskirts of the host, in agreement with our ndings. GRB 050911 appears to be a case of a \naked" burst (Page et al. 2005). It could possibly be explained by our models with a double compact object binary originating from a small elliptical galaxy and merging far outside the host without any detectable afterglow. On the other hand GRB 050724 was found inside a sm allelliptical. Ourm odels are consistent with this observation, since 20% of m ergers are predicted to occur within 5 kpc of the center for sm all ellipticals.

However, if more short GRBs are found at such intragalactic locations, a number of new possibilities may be favored: BH-NS mergers with small or zero BH kicks, or in general small kicks for both NS and BH (e.g., Podsiadlow ski et al. 2004; Dew i et al. 2005). Such alternative models would then have to be investigated. We note that, at present, the necessity of imparting such small kicks to the majority of NS is an open question (c.f., Willems et al. 2004; Chaurasia & Bailes 2005; Ihm et al. 2005). This, combined with our results for the locations of the mergers, indicates that short GRBs in the outskirts of galaxies need not be associated with globular clusters, as recently claim ed by Grindlay et al. (2006).

We nd that short GRB progenitors originate most probably from a diverse population of compact objects which are formed in old but also in young stellar environments. A lithough the absolute form ation rates and redshift distributions in plied by a mixture of galaxy types must be investigated and compared with theoretical predictions in more detail (O'Shaughnessy et al., in preparation), at present we are able to account for the origin (and associated delay times) of several recently observed short GRBs.

Some of the recent work (e.g., Nakar, Gal-Yam & Fox 2005) stands in apparent contradiction with our ndings, presenting claim s that the current m odels of double com pact objects cannot explain the new short GRB observations. A lso, long delay times ( 6 G yr) are inferred from the associations of short GRBs with old elliptical galaxies (Nakar et al. 2005). We note that at present these should be considered with caution. First, they are based on the analysis of a very sm all num ber of bursts and m ay su er from smallnum ber statistics; a signi cant fraction of short delay bursts cannot be ruled out with high statistical signi cance. The comparison in Nakar et al. (2005) has been perform ed using som e trial functions of delays, which do not necessarily correspond to the actual delays obtained in detailed population synthesis calculations. Second, their analysis neglects the inform ation about the types of individual short GRB host galaxies and their particular star form ation histories. Third, the models of Nakar et al. (2005) cannot explain the observed Galactic population of relativistic double neutron stars, with m erger times of

3000 M yr, that are consistent with our models 100 (see Fig. 1). Finally, the estim ate of the delays may be complicated by evolutionary e ects. We do know that the population of long GRBs is a ected by cosm ological evolutionary e ects, for example, related with the m etallicity evolution of the Universe, and som ay be the population of short GRBs. Thus a direct com parison with the total star form ation rate as perform ed by Nakar et al. (2005) may be misleading. The in uence of such evolutionary e ects and of the contribution of di erent types of galaxies and their star form ation history will be exam ined in detail in O'Shaughnessy et al. (2006).

Additionally, the ndings of Nakar et al. (2005) should be weighted by the observations of GRB 050724 and GRB 051221A in young star form ing environm ent, as well as the detection of GRB 050813 at z=1.7-1.9 where there ought be no short GRBs, if the delays are as long as they claim. If more short GRBs are found at high redshifts (z > 1), this will provide further support for delay times, that at least for som e short GRBs, are shorter than 6 Gyr. It has also been suggested that there is an observational bias against detecting short GRBs at high redshifts with SW IFT; the minimum ux for detection is apparently smaller in the observed sample than for GRBs with

secure redshift determ ination, and therefore it favors redshift determ inations for closest (low redshift) bursts (Hopm an et al. 2006). If this is the case, then it is clear that the observed redshift distribution leads to an overestim ate in delay times in the analysis of Nakar et al. (2005).

W e conclude that the current observations point tow ard a short-hard GRB progenitor population that is diverse in term s of m erger tim es and locations, as suggested by our models. Soon, with more observations of short GRBs, we will be able to critically test the population synthesism odels. Speci cally, we will investigate e ects of low metallicity, binary populations dom inated by roughly equalm ass binaries as suggested by Pinsonneault & Stanek (2006) and low natalkicks proposed by P fahlet al. (2002) on progenitors of double neutron star system s, and their relevance for both short GRB and gravitational-wave observations (Belczynskiet al. 2006, in preparation).
