GRB 051221A and Tests of Lorentz Sym m etry

A bstract

Various approaches to quantum gravity suggest the possibility of violation of Lorentz symmetry at very high energies. In these cases we expect a modi cation at low energies of the dispersion relation of photons that contains extra powers of the momentum suppressed by a high energy scale. These terms break boost invariance and can be tested even at relatively low energies. We use the light curves of the very bright short G am m a-R ay Burst G R B 051221A and com pare the arrival times of photons at di erent energies with the expected time delay due to a modi ed dispersion relation. As no time delay was observed, we set a low er bound of 0.0066E pl 0.66 10^7 G eV on the scale of Lorentz invariance violation.

1 Introduction

Various quantum gravity theories suggest that Lorentz symmetry is broken ormodied at very high energies [1]. In most of these models the low energy limit of the photon dispersion relation is deformed by an addition of extra powers of the particle momentum. These modications are suppressed by a high energy scale, beyond which Lorentz symmetry is broken. Among other implications, such terms cause the photon speed to depend on the energy and to dier from the classical speed of light, c [2].

Am elino-C am elia et al. [3] proposed to use the arrival times of photons from cosm ological G am m a Ray Bursts (G RBs) to set experimental bounds on the energy scale of Lorentz invariance violation. The idea was pursued by several groups which obtained observational bounds using ensembles of bursts with known redsh ts [4, 5], or using a single very powerful and atypical burst G R B 021206 [6]. In this paper we use the very bright short burst G R B 051221A to test Lorentz sym m etry and set a new bound on the possible scale of Lorentz sym m etry violation.

2 Lorentz V iolation and T im e D elay

Following [7], we consider deform ations of the dispersion relation of photons which break boost invariance but keep rotational and translational symmetry:

The non-standard term is suppressed by the high energy scale, E_{pl}, where

is a dimensionless parameter and $E_{\rm pl}$ is the P lanck energy. This expression can be thought as a low energy expansion (compared with $E_{\rm pl}$) of a quantum – gravity H am iltonian. W e will focus on n = 1 and n = 2 in the following.

Eq. 1 causes the speed of photons to depend on their energy. Two photons em itted simultaneously with di erent energies, arrive on Earth with a time delay t_{del} . By comparing this time delay (or the lack of it) with the time resolution of the observing detector we can set bounds on the Lorentz violation parameter, . The time delay between two photons with energies E_1 and E_2 em itted simultaneously from a source at a redshift z is given by [8]:

W e use in the following the \standard" cosm ological parameters H_0 , m and [9].

3 GRB 051221A

GRB 051221A was a very powerful bright short burst located in a star form ing galaxy at a redshift of z = 0.5465 [11]. It was observed in the gam m a ray regime by three dierent satellites: Swift-BAT, Suzaku-WAM and Konus-Wind. Swift-BAT and Konus-Wind have comparable instrumental time resolutions, 4 m sec and 2 m sec respectively. The time resolution of Suzaku-WAM is, on the other hand, signi cantly lower: 30 m sec. Since we need the highest time resolution for for our purposes [8], we only analyze the light curves of Swift-BAT and Konus-Wind which provide the strongest bounds.

3.1 The Swift-BAT data

The BAT light curve [10, 12, 13] is depicted at Fig. 1. It shows several bright short peaks with a duration of 10 15 m sec each. A pproximately a second later a second smaller and softer peak followed lasting 3 sec.

The overall time resolution of a telescope is determ ined by the intrinsic detector m inim al time resolution, 4 m sec for the Sw iff-BAT data, and the photon arrival rate [8]. For GRB 051221A, the resolution associated with the photon arrival rate in the keV range is smaller than the instrum ental resolution, $4m \sec$. At the higher energy band, (300-350) keV, the photon arrival rate becom es too small and we need to sw itch to the un litered data. O verall, the instrum ental resolution is setting the limiting resolution.

To constrain the parameter we compare the light-curves covering the (15, 35), (50, 150) keV, (100, 150) and (300, 350) keV energy bands. We have measured the time positions of the fourmain peaks in Fig. 1 (measured

in 4 m sectime bins) :

In the light curve in the 15 -35 keV band, the fourth peak is composed of three sub-peaks. The time given in the table corresponds to the middle sub-peak. Notice that the rst sub-peak is simultaneous with the peak in the 300 -350 keV band.

At 4 m sectime bin resolution we do not appreciate any time delay between the dierent peaks in all three energy bands. This lack of temporal shift is compared now with the theoretical times delays expected from Eq. 1:

As the photon ux decreases with energy, we consider in each energy band the lowest energy as the relevant one for the calculation of t. This conservative estimate lowers slightly the limit we obtain on . Since no time delay was observed, we can infer the following bounds:

* The background signal has not been subtracted in the energy band 300-350 keV to keep an acceptable photon arrival rate.

3.2 The Konus-W ind data

The K onus-W ind light curve [14] consists of a soft weak precursor and the main episode with ve $15 \text{ m} \approx \text{cpeaks}$. The rst peak is substantially softer than the others (there is no em ission in the 380–1160 keV energy range). A fter $0.250 \approx \text{c}$ a weak soft em ission is marginally seen only in the 18–70 keV range up to $1 \approx \text{c} (\sec \text{Fig. 2})$.

The light curve of K onus-W ind is given at 2 m sec resolution, corresponding to the intrinsic resolution of the telescope. As in the Sw ift analysis, the resolution is dictated by the instrum ental resolution, even though the inverse photon rate is close to the limiting resolution of the detector. At the high energy band there are only a few photons per tem poralbin. The light curve in the 18 - 1160 keV regime has been subdivided in three energy intervals : 18 - 70 keV, 70 - 300 keV and 300 - 1160 keV. The time positions of the four main peaks are :

The second peak in the energy band 18 - 70 keV is subdivided into two peaks. W e give the position of the second sub-peak where most of the photons were detected.

The expected time delays are:

Again, no time delays are observed and, hence, the following bounds emerge

These bounds are slightly better than the bounds obtained from the Sw ift data. This improvement is simply due to the better intrinsic time resolution, 2 m sec of K onus \mathbb{W} ind versus 4 m sec in Sw ift.

4 Conclusions

W e set new bounds on the possible energy scale of Lorentz invariance violation. To do so, we used the simultaneity of peak emission times in the light curves in dimension energy bands observed by Swift-BAT and Konus-W ind for GRB 051221A. The order of magnitude of the bounds depends on how the photon dispersion relation is deformed. In the models where a cubic term in the momentum is added (n = 1) the best bound we obtained is 0.0066 E_{pl}. W hen a quartic term is added (n = 2) the e ect is much smaller and the corresponding best bound is 5:1 $10^{13} E_{pl}$.

The present work complements previous studies which found bounds of similar order of magnitude. Ellis et al. [4, 5] performed a statistical analysis in an ensemble of bursts with known redshifts (to correct for intrinsic time delays), nding the bounds $_1 > 5:6 \quad 10^4$ and $_2 > 2:4 \quad 10^{13}$ at a 95% of condence level. In general, intrinsic delays render di cult to constrain Lorentz violations using a single burst, but we can still extract lower limits if there is simultaneity in the peak emissions. In our study, since no time delays are observed in the light curves with 2 m sec bins, we can assume that, at that resolution, all photons were emitted simultaneously. This is, of course, an assumption. We cannot rule out the possibility in which intrinsic spectral temporal shifts are exactly compensated by the time delays produced by the modi ed dispersion relation, Eq. 1. While, in principle, this is possible, we believe it to be extremely unlikely.

Boggs et al. [6] considered an unique extrem ely bright burst GRB 021206 observed by RHESSI. This burst has an alm ost at spectrum in the band 1 - 17 M eV, which allowed estimates of the time delay up to 17 M eV. The redshift of GRB 021206 is not known as no host galaxy was detected. A ssum ing a redshift of z ' 0:3 and using the simultaneity of the peaks at di erent

energies, Boggs et al., [6] obtained the bounds $_1 > 0.015$ and $_2 > 4.5 \quad 10^{12}$ for n = 1;2. These lower bounds are higher than ours by factors of 2.5 and 9 respectively. However, the redshift of this burst was not measured, but only estimated from the spectral and temporal properties of the burst. From this point of view, the present estimate, which is based on a burst with a known redshift, is more robust.
