A SUCCESSFUL TARGETED SEARCH FOR HYPERVELOCITY STARS

ABSTRACT

H ypervelocity stars (HVSs) travelw ith velocities so extrem e that dynam ical ejection from a massive black hole is their only suggested origin. Following the discovery of the rst HVS by Brown and collaborators, we have undertaken a dedicated survey form ore HVSs in the G alactic halo and present here the resulting discovery of two new HVSs: SDSS J091301.0+ 305120 and SDSS J091759.5+ 672238, traveling with G alactic rest-fram e velocities at least + 558 12 and + 638 12 km s¹, respectively. A ssum ing the HVSs are B8 main sequence stars, they are at distances 75 and 55 kpc, respectively, and have traveltimes from the G alactic C enter consistent with their lifetimes. The existence of two B8 HVSs in our 1900 deg² survey, com bined with the Yu & Trem aine HVS rate estimates, is consistent with HVSs drawn from a standard initial mass function but inconsistent with HVS drawn from a truncated mass function like the one in the top-heavy Arches cluster. The travel times of the ve currently known HVSs provide no evidence for a burst of HVSs from a major in-fall event at the G alactic C enter in the last 160 M yr.

1. INTRODUCTION

All galaxies with bulges probably host massive black holes (MBHs) in their centers. Hills (1988) rst showed that a three-body interaction involving a MBH and a stellar binary can eject one member of the binary with > 1,000 km s¹ velocity. Hills called stars ejected with > 1,000 km s¹ velocities \hypervelocity stars." Hypervelocity stars (HVSs) are thus a natural consequence of the presence of a massive black hole in a dense stellar environment.

Brown et al. (2005) reported the nst discovery of a $HVS:a~g^0 = 19.8$ late-B type star, 110 kpc distant in the G alactic halo, traveling with a G alactic rest-fram e velocity of at least + 709 12 km s¹ (heliocentric radial velocity + 853 km s¹). Photom etric follow -up revealed that the object is a slow ly pulsating B main sequence star (Fuentes et al. 2006). On ly interaction with a M BH can plausibly accelerate a 3 M main sequence B star to such an extrem e velocity.

O ur HVS discovery inspired a wealth of work from both observers and theorists. E delm ann et al. (2005) report a 8 M main sequence B star, 60 kpc distant, traveling with a G alactic rest-fram e velocity of at least + 548 km s¹ that may be a HVS ejected from the LMC. Hirsch et al. (2005) report a helium -rich sublum inous O star,

20 kpc distant, traveling with a G alactic rest-fram evelocity of at least + 717 km s¹ that is probably a HVS ejected from the G alactic Center. Holley-Bockelm ann et al. (2006) suggest that outliers in the velocity distribution of intracluster planetary nebulae around M 87 m ay be HVSs. In this paper, we report the discovery of two m ore HVSs from our ongoing HVS survey.

W ith HVSs now an observed class of objects, it is important to de ne true HVSs. Run-away B stars located m any kpc above the G alactic plane have long been known, but their velocities are typically . 200 km s¹ and they are very probably bound to the G alaxy. HVSs, on the other hand, are unbound. M ore in portantly, the classical supernova ejection (B laauw 1961) and dynam - ical ejection (P oveda et al. 1967) m echanism s that explain run-awayB stars cannot produce ejection velocities which exceed 300 km s¹ (Leonard 1993; G ualandris et al. 2005). Thus we de ne a HVS as an unbound star with an extrem e velocity that can be explained so far only by dynam ical ejection associated with a MBH.

HVSs are important tools for understanding the nature and environs of MBHs: Holley-Bockelm ann et al. (2006) predict that a thin torus of ejected HVSs is the signature of two M BHs form ing a tight binary. G insburg & Loeb (2006) suggest that the stars on highly eccentric orbits around SgrA may be the form er com panion stars to HVSs ejected by the MBH. Levin (2005) shows that an intermediate mass black hole (IMBH) on a circular in-spiral into the Galactic Center produces an isotropic burst of HVSs; an IMBH on an eccentric in-spiral produces broad jets of HVSs. Gualandris et al. (2005) nd that HVSs produced from stellar binary encounters with single M BHs have higher ejection velocities than HVSs from binary MBHs. Gnedin et al. (2005) show that the distance and full space motion of HVSs can provide signi cant constraints on the shape and orientation of the Galactic dark matter halo. Yu & Tremaine (2003) expand Hill's original analysis and show that single star encounters with binary MBHs produce 10 times more HVSs than stellar binary encounters with single MBHs.

O ur paper is organized as follows. In x2 we describe our survey target selection and observations. In x3 we present the new HVSs. We conclude in x4 by discussing what the observed set of HVSs im plies about their origin and the nature of the G alactic C enter.

2. DATA

HVSs ought to be rare: Yu & Trem aine (2003) predict there should be 10^3 HVSs in the entire Galaxy. Thus, in any search for HVSs, survey volume is important. Solar neighborhood surveys have not discovered HVSs because, even if they were perfectly complete to a depth of d = 1 kpc, there is a 0.1% chance of nding a HVS in such a sm all volume. Finding a new HVS among the Galaxy's 10¹¹ stars also requires selection of targets with a high probability of being HVSs. Our observational strategy is two-fold. Because the density of stars in the Galactic halo drops o as approxim ately r^3 , and the density of HVSs drops o as r^2 (if they are produced at a constant rate), we target distant stars where the contrast between the density of HVSs and indigenous stars is as large as possible. Secondly, the stellar halo contains mostly old, late-type stars. Thus we target faint B-type stars, stars with lifetim es consistent with traveltim es from the Galactic center but which are not a normally expected stellar halo population. This strategy makes sense because 90% of the K < 16 stars in the central 0.5⁰⁰ of the G alactic C enter are in fact norm al main sequence B stars (Eisenhauer et al. 2005).

We use SDSS photom etry to select candidate B stars by color. To illustrate the color selection, Fig. 1 shows a color-color diagram of every star with 17:5 < g_0^0 < 18:5 and B - and A -type colors in the SDSS DR4 (A delm an-M cC arthy et al. 2006). We use de-reddened colors com puted from E (B V) values obtained from Schlegelet al. (1998). The dashed box indicates the selection region used by Yanny et al. (2000) to identify BHB candidates. Interestingly, there is a faint group of stars with late B type colors extending up the stellar sequence towards the ensemble of white dwarfs with ($u^0 g^0$)₀ . 0.5. We select candidate B stars inside the solid parallelogram de ned by: 0.42 < ($g^0 r^0$)₀ < 0.27 and 2.67 ($g^0 r^0$)₀ + 1.33 < ($u^0 g^0$)₀ < 2.67 ($g^0 r^0$)₀ + 2.0.

W e observed a complete sam ple of 79 candidate B stars in the 1900 deg² region of the SD SS DR4 bounded by $7^{h}40^{m}$ < RA < $10^{h}50^{m}$ and Dec > 15. Figure 2 displays the locations of the objects on the sky. The H irsch et al. (2005) HVS is located in this region on the sky, but it is not a part of our survey because its photom etric colors lie far outside of our selection box. Our sam ple of candidate B stars is 100% complete in the magnitude range $17.0 < g_0^0 < 19.5$.

2.2. Spectroscopic Observations

O bservations were obtained 2005 D ecem ber 3-5 with the B lue C hannel spectrograph on the 6.5m M M T telescope. The spectrograph was operated with the 832 line/m m grating in second order, providing 1.2 A spectral resolution and wavelength coverage 3660 A to 4500 A.Exposure times ranged from 5 to 30 m inutes and were chosen to yield S=N = 15 in the continuum at 4000 A. C om parison lam p exposures were after obtained after every exposure.

Radial velocities were measured using the crosscorrelation package RVSAO (Kurtz & M ink 1998). The average uncertainty is 12 km s¹. We correct the heliocentric velocities to the local standard of rest (Hogg et al. 2005) and rem ove the 220 km s¹ solar re ex m otion. Thus all velocities reported here are in the G alactic rest fram e, indicated $v_{\rm R\,F}$. The velocities of the candi-

date B stars are indicated by color in Fig. 2.

2.3. Selection E ciency and Unusual Objects

O ur sam ple of 79 targets is com posed of 61 late B-type stars, 16 faint DA white dwarfs, and 2 low -z galaxies. We derive spectral types of the late B -type stars based on line indices described in B rown et al. (2003); the types range from B 6 to A 1. Thus our target selection is 77% e cient for selecting stars of late B spectral type. Changing the color selection edge from $(g^0 r^0)_0 = 0.42$ to 0.38 would eliminate m ore than half of the white dwarfs and one of the galaxies, and would increase the target selection e ciency for late B -type stars to 90%. We plan to publish the faint white dwarfs and other unusual objects in a future paper describing the HVS survey as a whole.

3. HYPERVELOCITY STARS

Our targeted search for HVSs uncovered two new HVSs, SDSS J091301.0+305120 (hereafter HVS4) and SDSS J091759.5+672238 (hereafter HVS5). Figure 3 plots a histogram of Galactic rest-fram e radial velocity for the 61 late B-type stars in our sample. Ignoring the HVSs, our sample has a velocity dispersion of

114 km s¹ consistent with a G alactic halo population. HVS4 and HVS5 are traveling with $v_{R\,F}$ = +558 12 and +638 12 km s¹ (heliocentric radial velocities + 603 and +543 km s¹), respectively, and are 5- outliers from this distribution. The escape velocity of the G alaxy is approximately 300 km s¹ at 50 kpc (W ilkinson & E vans 1999); thus HVS4 and HVS5 are clearly unbound to the G alaxy.

The new HVSs are not physically associated with any other LocalG roup galaxy. HVS4 and HVS5 are located

at (1;b) = (194:8;42:6) and (146:3;38:7), respectively (see Fig.2). HVS4 is separated from Leo A by 10 on the sky, but the galaxy is in the distant background 800 kpc away (Dolphin et al. 2002). Even if HVS4 were a $M_V = 6$ supergiant at the distance of Leo A, the star's radial velocity di ers from Leo A by 575 km s¹. The closest galaxy to HVS5 is the U rsa M inor dw arf 31 away, yet the velocity di erence is even m ore extrem e at 730 km s¹.

Both HVS4 and HVS5 have spectral types consistent with B8, how ever our low -resolution spectra do not allow us to determ ine exact stellar parameters. Stars of this spectral type are likely blue horizontal branch (BHB) stars or main sequence B stars/blue stragglers. Two of the three previously reported HVSs are main sequence B stars (Fuentes et al. 2006; Edelm ann et al. 2005). W e note that the Balmer line widths of HVS4 and HVS5 are too broad to be consistent with those of B I supergiants. If we assume the HVSs are BHB stars rather than B stars, their blue colors means they are hot, extrem e BHB stars and thus they are intrinsically very faint. The M $_{\rm V}$ (B H B) relation of C lew ley et al. (2002) yields M_V (BHB) ' + 2:0 and + 1:5 and heliocentric distance estimates d_{BHB} '20 and 18 kpc for HVS4 and HVS5, respectively. In the BHB interpretation, the volume we e ectively survey is much smaller than in the B star interpretation. Thus the BHB interpretation requires more than an order of magnitude larger production rate for HVSs. Because two of the previous HVS are B stars and because the B star interpretation in plies a lower production rate probably consistent with Yu & Trem aine (2003), we assume that HVS4 and HVS are B stars for the purpose of discussion. The ultim ate discrim inant will com e from higher resolution, higher signal-tonoise spectroscopy.

We estimate the luminosity of a B8 star from the Schaller et al. (1992) stellar evolution tracks for a 4 M star with Z = 0.02. Such a star spends 160 M yr on the main sequence and produces 400 L at T_{eff} 13;000.

This lum inosity corresponds to M $_{\rm V}$ (B 8) ' 0:9 (using bolom etric correction 0:80 (K enyon & H artm ann 1995)) and heliocentric distances d_{B 8} ' 75 and 55 kpc for H V S4 and H V S5, respectively. A ssum ing the Sun is 8 kpc distant from the G alactic center, the G alacto-centric distances of H V S4 and H V S5 are thus r' 80 and 60 kpc, respectively.

If H V S4 and H V S5 originate from the G alactic C enter, the travel times to their present locations are approxim ately 140 and 90 M yr, respectively, consistent with the 160 M yr main sequence lifetime of a 4 M star. If the H V Ss are B H B s or blue stragglers, their lifetimes are considerably longer and the traveltime constraint is relaxed.

O ur radial velocities provide only a bwer lim it to the HVS's true space velocities. HVS4 and HVS5 have bright apparentm agnitudes ($g^0 = 18.40$ and 17.93, respectively) and are present in the USNOB1 (M onet et al. 2003) and GSC2.3 (B.M cLean, 2006 private communication) catalogs. However, the HVSs are listed with no m easurable propermotions, consistent with the estim ated distances.

Table 1 sum marizes the properties of all ve known HVSs. The columns include HVS number, G alactic coordinates (l;b), apparent magnitude g^0 , m inim um G alactic rest-fram e velocity v_{RF} (not a full space velocity), heliocentric distance estimated, travel time estimate from the G alactic C enter t_{GC} , and catalog identication. We note that the B9 M_V estimate was incorrect in Brown et al. (2005) and should be M_V (B9) = 0.3. Thus the correct distance and travel time estimates to HVS1 are d 110 kpc and t_{GC} 160 Myr, as indicated.

4. DISCUSSION

The very existence of the HVSs places interesting \lim its on the stellar mass function of HVSs, the origin of massive stars in the Galactic Center, and the history of stellar interactions with the MBH. Interestingly, all ve known HVSs are moving with positive radial velocity, consistent with the picture of a Galactic Center origin.

In principle, we can constrain the stellar population from which the HVSs originate by combining predictions of HVS rates with the results of our survey. Yu & Trem aine (2003) predict a HVS rate of 10^{-5} yr¹ ejected by a single M BH at the Galactic Center. A HVS m oving 600 km s⁻¹ travels 120 kpc in 200 M yr, thus the Yu & Trem aine (2003) rate in plies 2000 HVSs of all types to a depth of 120 kpc. O ur $g_0^0 < 19.5$ m agnitudelim ited survey reaches the same depth d = 120 kpc for B8 stars and we nd two B8 HVSs over our 1900 deg² region, in plying 43 31 B8 HVSs over the entire sky. We ask whether this number of B stars is consistent with the number expected from a standard initial mass function (MF). A Salpeter IMF (Salpeter 1955), integrated over the mass range 0.2-100 M and norm alized to 2000 stars, contains 26 stars between 3 and 5 M . A Scalo IMF (Scalo 1986), sin ilarly calculated, contains 13 stars between 3 and 5 M . The IMF predictions are system atically lower than the observed frequency in plied by the two B stars in our survey, but because of sm all number statistics there is no signi cant inconsistency.

In the G alactic center, there is some indication that the IM F is top heavy. For example, Stolte et al. (2005) study the mass-segregated A rches cluster and argue for truncation at masses less than 6 M . Integrating the Stolte et al. (2005) mass function = 0.86 over the mass range 3-100 M and normalizing it to 2000 stars results in 750 3-5 M stars, an order of magnitude m ore late-B HVSs than implied by our observations. Thus our observations already indicate that the HVS parent population is not composed entirely of clusters like A rches or the Yu & Tremaine (2003) HVS rate is an underestimate.

 $\rm HVS$ travel times from the Galactic Center constrain the history of stellar interactions with the MBH. A ssum – ing the new HVSs are B stars, travel time estimates for the known HVSs are spread rather uniform ly between 30 and 160 M yr. Thus there is as yet no evidence for a burst of HVSs from major in-fall event at the Galactic Center in the last 160 M yr. The current constraints are less clear if HVS4 or HVS5 are not B stars. If new discoveries of HVSs continue to show no evidence for coherent bursts of HVSs, theories of in-falling massive star clusters

(Gerhard 2001; K in & M orris 2003) possibly containing an IM BH (Hansen & M ilosavljevic 2003) to transport B stars near the M BH m ay not be applicable to the G alaxy. It is interesting that the northern HVSs all have sim -

ilar b 40 (see Fig. 2). An in-spiraling binary black hole produces an unique distribution of HVSs on the sky (Levin 2005; Holley-Bockelm ann et al. 2006). Detailed theoretical predictions of the distribution of HVSs on the sky ejected by a single MBH at the Galactic Centerwould be an important testbed for future HVS observations.

HVSs are becom ing in portant tools for understanding MBHs. D iscovering additional HVSs in a well-de ned volum e will provide better constraints on the origin of HVSs and the nature of the G alactic C enter. P roperm otion m easurem ents of HVSs, m easured with the Hubble Space Telescope, the G bbal A strom etric Interferom eter for A strophysics, or the Space Interferom etry M ission, m ay provide signi cant constraints on the shape of the G alaxy's dark m atterpotential (G nedin et al. 2005). The distribution of HVSs in velocity and space m ay constrain the history of stellar interactions with the MBH. Identifying HVSs around other galaxies (Holley-Bockelm ann et al. 2006) is also an exciting prospect. W e are continuing our radial velocity survey of every late B-type star in the SD SS.
