On the CMB large-scale angular correlations

Abstract. We study the large-scale angular correlation signatures of the Cosm ic M icrow ave Background (CMB) tem perature uctuations from W M AP data in several spherical cap regions of the celestial sphere, outside the K p0 or K p2 cut-sky m asks. We applied a recently proposed m ethod to CMB tem perature m aps, which perm its an accurate analysis of their angular correlations in the celestial sphere through the use of norm alized histogram s of the num ber of pairs of such objects with a given angular separation versus their angular separation. The m ethod allows for a better com parison of the results from observational data with the expected CMB angular correlations of a statistically isotropic Universe, com puted from M onte C arb m aps according to the W M AP best-t CDM m odel. We found that the, already known, anom alous lack of large-scale power in full-sky CMB m aps are m ainly due to m issing angular correlations of quadrupole-like signature. This result is robust with respect to frequency CMB m aps and cut-sky m asks. M oreover, we also con m previous results regarding the unevenly distribution in the sky of the large-scale power of W M AP data. In a bin-to-bin correlations analyses, m easured by the full covariance m atrix ² statistic, we found that the angular correlations signatures in opposite G alactic hem ispheres are anam alous at the 98% {99% con dence level.

1. Introduction

In recent years, after the COBE m ission, experiments of observational cosm ology evolved both in the accuracy and in the angular resolution of the Cosm ic M icrow ave Background (CMB) m easurements (see, e.g. Bersanelli et al. 2002 and references therein). How ever, such experiments were designed to m ap sm all patches of the celestial sphere and therefore the study of its properties concerning the large-scale angular correlations was not possible.

This situation changed with the W ilkinson M icrowave Anisotropy Probe (WMAP), which produced full-sky CMB maps in ve frequency bands (term ed K, Ka, Q, V, and W maps), although containing di erent am ounts of contam inations from our galaxy (Bennett et al. 2003a). This superb quality data set motivated a number of detailed studies concerning the CMB properties. As a result, several recent works have reported claims regarding som e anom alies found in these data. These anom alies include the low-orderm ultipole values (Bennett et al. 2003a; E fstathiou 2004; Tegm ark et al. 2003; Gaztaraga et al. 2003; Slozar et al. 2004; O'Dwyer et al. 2004), the alignment of some low-order multipoles (Tegm ark et al. 2003; de O liveira-Costa et al. 2004; E riksen et al. 2004b; B ielew icz et al. 2005; Land and M agueijo 2005), and an unexpected asymmetric distribution on the sky of the large-scale power of CMB data (Eriksen et al. 2004a, 2005a; H ansen et al. 2004a, 2004b, 2004c; Ja e et al. 2005; Schwarz et al. 2004; Copiet al. 2005).

In this work we focus on the study of the large-scale angular correlations (hereafter term ed Angular Correlations Signatures ACS) of the CMB temperature maps from W MAP data. Since the vast majority of the cosm ological information is contained in the two-point temperature correlation function, it seems natural to study the ACS by looking at such function (actually, an equivalent of it). O ur analyses of the ACS in CMB maps, for data outside the region de ned by the Kp0 or Kp2 W MAP masks, allow to perform a close inspection of two interesting issues. First, we investigate {through a full-sky map analysis{ the large-scale power in W MAP data, and its connection with the low quadrupole moment issue. Second, we study

{through a partial-sky coverage analysis{ the possible uneven distribution on the celestial sphere of the CM B largescale power. The signi cance of our results are evaluated by comparing these results against those obtained from M onte C arb CM B m aps produced with the W M A P besttting C D M m odel properties (H inshaw et al. 2003b). F inally, using a ² statistics we assess the con dence level of the N orth/South asymmetry in W M A P data compared to 1000 M onte C arb realizations of CM B skies.

2.Analyses method

Recently, Bernui & Villela (2006) introduced a new method to study the large-scale ACS in the distribution of cosm ic objects in the sky. This method, called the Pair Angular Separation Histogram (PASH) method, consists in rst calculating the angular distances between all pairs of cosm ic objects, listed in a catalog, and then constructing the norm alized histogram of the number of pairs with a given angular separation versus their angular separation. A catalog with a large number of objects can be divided in a number (say K) of comparable sub-catalogs (i.e. ensem bles of iso-num ber of objects sharing analogous physical properties). A fler that, one com putes a PASH with each one of these sub-catalogs and average them to obtain the Mean-PASH (MPASH). The dierence between the M PASH, caculated using a observational catalog, and the Expected-PASH (EPASH), obtained assuming the statistical isotropy hypothesis (hereafter the M PA SH -m inus-EPASH function), shows the ACS of the cosm ic objects in such a catalog.

In the CMB tem perature m aps the celestial sphere is partitioned in a set of equal-area pixels, where to each pixel is assigned a weighted CMB tem perature. To obtain the ACS of a given map, one divides the set of pixels in K = 2 sub-m aps, one for the negative CMB tem perature uctuations and the other for the positive ones, and proceeds as before averaging (K =) 2 PASHs. If, for com putational problem s, the num ber of pixels in these sub-m aps is too large, one can divide them in, say K and K_{\perp} . sub-maps (with iso-number of pixels of analogous tem peratures), and proceeds to compute the MPASH averaging the $K = K + K_+$ PASHs, and nally, one plots the M PA SH-m inus-E PA SH function. It can be shown (see Bemui 2005) that the MPASH-m inus-EPASH function is independent of the number of sub-m aps K 1 and 1 in which the original CMB map is divided. Κ +

The PASH method is also applicable to incomplete sky maps, including disconnected regions such as those resulting from the application of the W MAP masks. This method is similar in philosophy to the two-point temperature correlation function, except that the PASH method has zero mean, because the MPASH and EPASH are each one normalized histogram s. This simple fact allows us to achieve a deeper study of the ACS in CMB temperature maps, like: the intensity of all their relative mimim a and maxim a and their corresponding angular scales, their intersections with the horizontal axis (i.e. the zeros of the function), etc; it also leads to calculate the variance 2 of the M PASH -m inus-EPASH function f_{i} (which has zero mean, i.e., $P_{i=1}^{P N \text{ bins}} f_{i} = 0$)

3.CM B data analyses

In this section we present the ACS of the W MAP data. For these analyses, we used six CM B m aps: the individual Q-, V-, and W-band data produced from the (Q_1, Q_2) , (V_1, V_2) , and (W_1, W_2, W_3, W_4) dierential assemblies (DA), respectively, as provided on LAM BDA $^{1}\,$ (Bennett et al. 2003b), the Coadded W M AP map (which com bines the eight DA in the Q-,V-, and W -bands using the inverse-variance noise weights as described by H inshaw et al. (2003b)), the cleaned CMB map (Tegmark et al. 2003, hereafter the TOH map), and the Lagrange Internal Linear Combination (Eriksen et al. 2004b, hereafter the LILC map). It is known that the last two maps are not fully reliable for quantitative analysis because still have problem swith residual foregrounds (Eriksen et al. 2005b); here we use them just as a supporting evidence. A fter applying the Kp0 or Kp2 W MAP masks in all these six m aps, we rem ove their residual m onopole and dipole com ponents, and correct them for the dynam ic quadrupole.

The exam ination of the W M A P data perform ed here com prehends two types of sky analyses.W e want to rem ark that in both cases we consider data outside the region dened by the K p0 or the K p2 m ask, to avoid from the beginning residual foreground contam inations (Bennett et al. 2003b; E riksen et al. 2004b, 2005b; B ielew icz et al. 2004). The rst type is the full-sky analysis, and the second one is the partial-sky analysis carry out through antipodal spherical caps of 45, 60, and 90 of aberture (this m eans that the m axim um angular separation between pixels in each case is tw ice these angle values).

W e use CM B m apswith HEALP ix (G orskiet al.2005) resolution N_{side} = 128, which amounts to 196608 pixels. In the following gures we consider the bin width as 0.45, and the number of bins as N_{bins} = 400; m oreover, the shaded areas correspond to 1-sigm a con dence regions.

3.1. Full-sky analyses (outside Kp2 or Kp0 m asks)

In this subsection we shall discuss the ACS of the W MAP m aps, analysing the CM B data outside the regions de ned by the Kp2 and Kp0 m asks. The objective of such analysis is to investigate previous claims regarding the lack of power in the large-scale angular correlations in full-sky data (see Bennett et al. 2003a; E fstathiou 2004; Slosar et al. 2004) and its relationship to the low-order multipole values.

First we show the ACS of the W MAP data using the Kp2 mask. In fact, the suitability of using each W MAP mask is well known in the literature, and many works claim that the less severe cut-sky Kp2 could be enough for cosm ological purposes (large angular scales).We have computed the ACS for both masks, although we only show the ACS for the Kp2 mask case, and for all maps under investigation to assert the robustness of our results under di erent sky cuts.

The results are reported in Figure 1. In the top panel ofFig.1we show the ACS from the six CMB m apshere investigated, considering data outside the region determ ined by the K p2 m ask.For com parison we also plot, as a dashed line, the average of 1000 M PA SH -m inus-EPA SH functions (term ed the expected function) obtained from the same number of M onte Carlo CMB maps. These realizations were produced using an input power spectrum generated by the cmbfast code (Seljak & Zaldarriaga 1996) considering the W M A P best-tting CDM m odel properties. Them apswere produced using them ap-m aking code synfast from HEALP ix. The disagreem ent observed between the observational data from WMAP and the expected angular correlation function is better appreciated in the bottom panel of Fig. 1, where we plotted the di erence of such expected function minus each one of the MPASHminus-EPASH functions from the six CMB maps. W hat is revealed in these di erence plots is that the ACS m issing in CMB data at large-angular scales correspond to a quadrupole-like angular correlation signature (see, e.g., Bernui 2005). To assess this, we plot the angular correlation function of a quadrupole (corrected for the K p2 m ask) with moment C_2 ' 670 K². Since these curves (bottom panelFig.1) represent them issing ACS in W MAP data to t the expected function, where $C_2^{CDM} = 870 \text{ K}^2$, one nds C_2^{WMAP} / 190 30 K^2 , that are in good agreement with Bielewicz et al. (2004) who obtained $C_2 =$ 165 34;216 42;229 44;191 38 K², for the Q, V, W, and Coadded m aps, respectively). This result, which appears to be robust with respect to the frequency CMB map and to cut-sky mask (we also perform ed analyses with the K p0 m ask obtaining sim ilar results), proves that the lack of angular power previously found in the two-point tem perature correlation function of WMAP data is mainly due to the low quadrupole moment (Efstathiou 2004; Gaztanaga et al. 2003; Slosar et al. 2004).

Furtherm ore, to con rm this result we remove the quadrupole component, after applying the Kp2 m ask, and compute the ACS in these maps. The result is shown in Figure 2 where we also plot for comparison the expected function for the case of zero quadrupole compoment. Again this result is robust with respect to the frequency CMB m ap analyzed.

32. Partial-sky analyses

The basic idea is to investigate di erent regions of the celestial sphere, namely spherical caps of various sizes, whose

vertices point in the direction of the N orth G alactic Pole (NGP) and the South G alactic Pole (SGP), with respect to the G alactic coordinate system .C om parison of the ACS in antipodal caps of 45, 60, and 90 of aberture allows a quantitative assessment of the claim ed asymmetry in the distribution of the CMB power between the northern and southern hem ispheres (E riksen et al. 2004b).

The resulting ACS are shown in Figures 3 and 4, where the expected functions result from data on the same patch of the sky from M onte Carlo CMB m aps. In Figure 3 we present four plots: panels (a) and (b) reveal the ACS in the 45 NGP-cap and SGP-cap, respectively; while in panels (c) and (d) we show the ACS in the 60 NGPcap and SGP-cap, respectively. In Figure 4, we also show four plots: panels (a) and (b) reveal the ACS in the 90 cap, outside the Kp2 m ask, in the N orthern and Southern

G alactic hem ispheres (NGH, SGH), respectively; panels (c) and (d) show the ACS in the 90 -cap, outside the Kp2 m ask, in the NGH and SGH, respectively, but this time we rem oved the quadrupole com ponent of the CMB m aps.

Some interesting features in these plots are evident. The rst noticeable result is that, in each one of these qures the ACS corresponding to the three frequency maps Q, V, and W are practically indistinguishable. It is well known (see Bennett et al. 2003b) that foregrounds have a frequency-band dependence, thus when incorrectly subtracted it is expected to show up at a di erent level in the frequency m aps Q, V, and W. To investigate the robustness of our results with respect to a di erent sky cut, we computed the ACS for the NGH and SGH (not shown here) for data outside the more severe galactic cut given by the W M A P K p0 m ask (it cuts 25% of the total data, while the Kp2 mask cuts 15%), where we found sim ilar results. Thus, one concludes that the ACS found in these m aps are rem arkably stable with respect to both frequency bands and sky cuts, and seem unlikely to be com prom ised by residual foregrounds.

The second interesting fact is the net asymmetry between the 90 -caps in NGH and SGH: the Northern hem isphere is almost structureless (the variance's square-root for this ACS is h_N^Q,^V,^W i = 0:0054 while Expected = 0:012 0:006), instead the ACS in the Southern hem isphere are relatively intense (h_S^Q,^V,^W i = 0:016 while Expected = 0:015 0:008). In this form, the South/N orth ratio $_{S=N}$ $_{S} = _{N}$ = 2:97 quantiles the evident SGH/NGH asymmetry observed in the plots of gure 4. The statistical signi cance of this result are evaluated in the next section, by means of the M onte C arb m aps, in term s of the standard covariance matrix ² statistic.

Finally, in order to check the possibility that the low value of the quadrupole m om ent could be responsible for this peculiar ACS behavior, we rem oved the quadrupole component, after applying the Kp2 mask, in all the six maps, and then compute again the MPASH-m inus-EPASH for data in the 90 -caps in the NGH and SGH.

O ur results can be seen in the Figures 4c and 4d, where this time h $_{\rm N}^{Q,V,W}$ i = 0.0065 in the NGH, and h $_{\rm S}^{Q,V,W}$ i = 0.019 in the SGH. The large value now obtained for the ratio $_{\rm S=N}$ = 2.96, con rm s that the North/South asymmetry is not related to the low quadrupole value.

A natural question concerns the frequency that such a ratio is $_{S=N}$ ' 3 ($_{S=N} = 32$ if data from Coadded m ap is included in the average) is present in the ensem – ble of M onte C arlo m aps. A nalysing the M PASH -m inus-EPASH functions for sim ilar NGH and SGH 90 -caps in 1000 M onte C arlo m aps, we found that the corresponding values of $_{S=N} 2$ [02;5:4], with m ean $_{S=N}^{m ean} = 1:1$ 0:7. A close inspection of the values in such interval results in that less than 2% of them satis es $_{S=N} > 3$.

4. Statistical analyses

In this section we present the statistical analysis of the ACS obtained from WMAP data against analogous results derived from the 1000 M onte C arb CMB m aps. The degree of agreem ent between the simulations and the observations are quantiled in terms of a standard covariance m atrix 2 statistic, including all bin-to-bin correlations,

where h_{ii} is the mean of the MPASH-m inus-EPASH functions as determ ined by the M onte C arlo m aps, and M_{ij} $h_{ii}f_{ji}$ $h_{f_i}ih_{ji}$ is the covariance m atrix. The results from these computations, divided in three groups for the 45 -, 60 -, and 90 -caps, respectively, are reported in Table 1. The rst column indicates the CMB m ap investigated, the second and third ones indicate the frequencies of M onte C arlo simulations with a lower ² value than the W M AP data for the NGH and SGH, respectively. The last column indicates the frequency of simulations with a smaller $^2_{SGP} = ^2_{NGP}$. These results determ ine a parameter, the ratio of the ² values for the NGH and SGH, that is used to quantify the degree of asymmetry between both hem ispheres (E riksen et al. 2004a, 2005a).

The results reported in Table 1 are as follows. In all the cases, the NGH and SGH show, indepedently, acceptable values of probability (frequency of simulated maps, given the model, where the MPASH-minus-EPASH function of such m aps has a low er 2 value than the W M A P data). However, data in the third column says that the antipodal 90 -caps are marginally consistent internally (when considered simultaneously one as opposite to the other): for the Q,V,W, and Coadded m aps the mean of the $\frac{2}{S=N}$ values is > 0:98, or equivalently $\frac{2}{N=S}$ < 0:02, which m eans that < 2% of the simulations have a smaller ratio of 2 . It is worth to notice that these results appearing in the 90 -caps are shown to be robust with respect to frequency (the same result for Q, V, W, and C oadded CM B m aps). Therefore, we conclude that there is a signi cant discrepancy, at the > 98% CL, between WMAP data and the ACS expected in a statistically isotropic Universe.

5.Conclusions

Here we have shown through the full-sky analyses of the ACS of the W MAP data (outside the KpO or Kp2 sky cuts) that the 'anom alous' lack of power at large angular scales is mainly explained by the low quadrupole-moment value (see E fstathiou 2004, G aztanaga et al. 2003, and Slosar et al. 2004 for more detailed discussions; see also B ielew icz et al. 2004 for com plete calculations, in particular in similar band m aps as here). We con rm ed this result by analysing also the W MAP data after removing the quadrupole com ponent, obtaining a better (but not exactly) agreem ent with what is expected in a CDM m odel with zero quadrupole.

W e also perform ed partial-sky coverage analyses and show ed that there is signi cative evidence, at the 98% 99% CL, of an anom alous distribution of the CM B power in opposite G alactic hem ispheres. In fact, in less than 2% of the M onte C arlo CM B m aps analyzed, data in opposite hem ispheres present analogous bin-to-bin correlations as those shown by the 90 -caps with W M A P data. M ore interestingly, the excess of correlations in the com parison of opposite antipodal caps is m anifestly observed in the South/N orth 90 -caps, but it is not seen neither in the exam ination of the antipodal 45 - or 60 -caps.

The fact that the South/N orth asym m etry persists at a signi cant level in several frequency bands (the Q, V, and W CMB m aps) and with di erent sky cuts (the K p0 and K p2 m asks) excludes a simple explanation based on sys-

tem atic e ects and foregrounds (see H inshaw et al. 2003a; E riksen et al. 2004a, 2004b; H ansen et al. 2004b).
